City accepting Community Funding Program applications

The City of Beacon announced it will begin accepting grant applications for its 2022 Community Funding Program. The mini-grant program is open to Beacon-based not-for-profit and community-based organizations to support projects or initiatives which enhance the City's quality of place and/or address critical community needs.

The funding for this grant program was included in the City's 2022 Operating Budget, which authorized the expenditure of \$20,000 for the Community Funding Program. In December 2021, the City Council allocated this funding to provide support for local groups that offer programs and services to Beacon youth and residents in the areas of arts, culture, heritage, recreation, environment, health, public safety, and other human services. Grant requests between \$1,000 and \$10,000 per organization will be considered for funding.

Mayor Lee Kyriacou said, "The City Council added this funding to the 2022 budget to help local organizations continue and expand the critical programs and services they offer to our community. We hope this funding will help to support the incredible work that so many of our community-based organizations do on behalf of our residents."

HV Ukrainian community watches, prays as war explodes

The Ukrainian American Community in the Hudson Valley is watching events unfold in Ukraine with horror and individuals are working to provide support to the victims. The community has come together like never before, sharing information about events, about family members, and about ways to help.

The situation is frightening - and galvanizing the community. Many are trying to understand how it could have been allowed to happen.

Ukraine has a long history and its people have a national identity that stretches through the Kieven Rus back to the Ninth Century. The Ukrainians have been fighting for or protecting their independence from Russia for centuries.

Father Ivan Kaszczak, the pastor of the St. John the Baptist Ukrainian Catholic Church in Hunter and also of Holy Trinity Ukrainian Catholic Church in Kerhonkson, is busy looking after his flock and looking to communicate with their families, whether they be in Ukraine or already refugees somewhere else.

"People are worried about family and friends back there," he says. "One of my friends was working in Kyiv, but has managed to get to Hungary with his wife and two kids."

"We, here, are ready to sponsor refugees to come to USA when that can happen. Right now, though, most of the wives don't want to leave their husbands, who are staying and fighting. We will be ready when the time comes."

"This whole thing is surreal," Father Kaszczak says. "Putin has said that he is doing this to protect the Russian speakers in Eastern Ukraine. Yet, his troops are destroying Kharkiv, one of the largest Russian speaking cities in the world. (Kharkiv is third behind Moscow and St. Petersburg -2017 census data). If they are 'our brothers,' why are they killing us?"

Father Kaszczak continues, noting that "Putin talks of 'de-nazification.' I only know of two countries in the world where both the president and the prime minister were Jewish. One is Israel and the other, up until recently, is Ukraine. This truly is surreal."

Orest Temnysky, first generation Ukrainian American and a trustee of the St. John the Baptist Ukrainian Catholic Church in Hunter, has been active in helping to coordinate aid and has been in close touch with family still in Western Ukraine. Most are elderly relations.

"They worry about the shelling," he says. "My aunt is in her 80s and lives on the 14th floor of her building. She doesn't think she can get down to shelter in the basement in time."

"If it comes," she says, "I'll just be closer to God here."

He says his family isn't leaving yet. "The line at the border is so very long and they are in their 80s. They can't sit in a car for three days waiting. They're stuck."

"There's got to be more that can be done," remarks Temnysky. "We are watching in slow motion the murder of thousands of people. I don't see how he (Putin) is going to stop."

Luba Fedun, a Ukrainian American, laments, "I've been to Ukraine so many times since the break up of the Soviet Union and at last count, I had 176 relatives still there. I've been in touch with an elderly aunt. Her father was killed by the Nazis just before she was born, and when the Soviets returned after driving out the Nazis, they exiled her mother. My aunt was only three months old, so her mother handed her to her own sister to look after her as she couldn't survive the exile with a tiny baby."

The aunt lives in the Kherson Oblast (district) in southern Ukraine. Kherson was the first major city to fall to the Russians recently. "I was in touch with her until the Russians

came," Fedun said, "And now there is no more communication with anyone there. She's elderly and we're all worried."

The area community, represented by the Mountain Top Interfaith Community, hosted an interfaith prayer service at the Ukrainian church in Hunter on this past Sunday afternoon. The better part of 200 people packed the facility. Father Kaszczak led the service with help from the interfaith council. The whole community joined in praying for peace and for the safety of the Ukrainians but also for the Russian soldiers.

"We wish no one any harm," Kaszczak reminded everyone. "We simply pray that the Russian soldiers will find it in their

hearts to stop the fighting."

While donations for humanitarian aid to Ukraine were being accepted at the church on Sunday, Father Kaszczak announced that, on a larger scale, humanitarian aid donations are being coordinated through the Church by the Ukrainian Catholic Church's Metropolitan in Philadelphia.

"They, like Catholic Relief Services, (CRS) have very little overhead and most of the donations will go directly to those in Ukraine or refugees, who have gotten out," he said.

The Ukrainian Catholic Archdiocese of Philadelphia (215-627-0143) has a Humanitarian Aid Fund for Ukraine. One may mail a check to the Ukrainian Catholic Archdiocese of Philadelphia and send it to the office at: 810 North Franklin Street, Philadelphia PA 19123.

People are asked to write on the check "Humanitarian Aid Fund for Ukraine."

Local residents: War in Ukraine is replica of past

For Esther Kando Odescalchi, this has an all-too-familiar – and sad, and frightening, and frustrating – feeling.

When Russia's invasion of Ukraine went from rumor to reality on February 24, Odescalchi was flooded with the searing memories from her childhood when, as a teenager, she and her family escaped from Hungary in 1956 after the former Soviet Union invaded the country to quell a rebellion.

"What's happening in Ukraine right now is the exact replica of what happened in Hungary," said Odescalchi, a Pleasant Valley resident for nearly 50 years now. Like other area residents with ties to Ukraine, she is keeping a keen eye on the current developments.

"In 1956 we had enough of the Iron Curtain," she said of Communist rule. "The revolution was winning, but the west, just like now, was doing nothing. I remember as a young person, the Russian tanks coming in and bombarding my city and crushing the Revolution."

Most of her memories are sad and poignant.

Most of them.

"I remember when the Russian tanks were coming into Budapest and we were just outside of the city," she recalled with a laugh. "One of the soldiers asked me and a bunch of children which way it was to Budapest. We all pointed and told them it was the opposite direction of the way they were going and they turned around and actually headed away from Budapest! Even the smallest children did something to defend their country."

Odescalchi is, quite literally, standing with her Ukrainian friends, helping to organize donations to help the people affected by the war. There's a kinship there – Ukraine actually used to be a part of Hungary more than a century ago and Hungary was the first country in the world to recognize Ukraine's sovereignty when it declared independence in 1991.

"I am proud," she says, "that Hungary is welcoming so many refugees from Ukraine right now."

Much as Austria welcomed Odescalchi and her family in 1956. Not long after a harrowing escape from Hungary, she wrote a book called "My Escape – Memoirs of a Hungarian Teenage Freedom Fighter."

Odescalchi chronicled the escape, including getting lost in a swamp and being unsure if her family was traveling toward Austria or back into the arms of Soviet soldiers. But they made it to the border nation and, in 1957, she came to the United States as a refugee.

She completed her education in the United States, earning a MS in library science and a Ph.D. in communications from Columbia University. After a career as a librarian, she met her husband – who was employed by IBM in Poughkeepsie – and she too joined IBM and worked in executive communications. She lectures and conducts workshops at colleges, universities, national and international organizations in the United States and abroad.

"When Russia came to Hungary, they kicked my father out of his job, they made us move from our house to a one-room place. The pipes were always frozen. We went

hungry," she said. "To this day, I still appreciate that my heat turns on when I get cold, that I can take a hot shower, and that I don't want for food. The United States is still the greatest country in the world, even at this exact moment, and anybody who thinks otherwise can go to hell."

Ulana Salewycz

For Ulana Salewycz, her memories are similar.

Salewycz is a Poughkeepsie resident whose parents left Ukraine as refugees after World War II, escaping the murderous regime of Soviet Chairman Josef Stalin.

"This is not the first time this has happened in our history," Salewycz said. "In fact, it's probably the fourth or fifth time. But before (the 1986 nuclear reactor accident in) Chernobyl hit, most people didn't know that much about Ukraine. Now people know."

After her family settled in America, Salewycz was born and raised in a heavily Ukrainian area in Passaic, New Jersey. She and her siblings learned Ukrainian and lived in a three-level home with her grandparents on the top floor, her own family in the middle and her sister and her family on the bottom floor.

"Ukrainians are like mushrooms. You meet one and you see there are a lot of us in different parts," she joked.

Salewycz is active in the Hudson Valley's biggest Ukrainian community in Kerhonkson in Ulster County, including the Ukrainian Women's League of America and

the Ukrainian Holy Trinity Church. She still has cousins currently living in Ukraine, and her aunt gives the family updates as often as possible. So far, one in Lviv and one in Kyiv, are safe.

She said the current invasion does not surprise her.

"The Orange Revolution has been going on for eight years," she said. "Putin wants the old Soviet Union back. He's going to keep going. (Former Russian president Mikael) Gorbachev was friendly to the Ukrainians, but most of the Russian leaders are not to be trusted."

Local legend Brian Giorgis to retire from coaching next year

It's funny now to think about, but the most successful girls and women's basketball coach that Dutchess County has ever known had his doubts.

At least twice, in fact.

In 1987, Brian Giorgis led the Our Lady of Lourdes High School girls team to the New York State Public High School Athletic Association tournament for the third time. He lost in his previous two trips, but the Warriors won the state title this time.

A relieved Giorgis was asked after the game how he felt and said, "I was feeling like Bud Grant, like I was never going to win this thing," he said of the Minnesota Vikings football coach, who reached the Super Bowl four times without winning.

After winning nine state high school titles, Giorgis was courted by Marist College, just a few miles up the road from Lourdes in the town of Poughkeepsie, to become its new coach. Yet he still had his doubts and, in fact, he went to the Lourdes administration and said, "If this doesn't work out, can I come back?"

There was no going back.

Giorgis continued his success at the collegiate level and, last week, decided that next year, the 2022-23 season, will be his last on a basketball sideline as he has decided to retire.

He will be replaced by his former player and longtime assistant coach, Erin Doughty.

"It's been an incredible ride, but it's time," Giorgis said. "As sad as I am to see the light at the end of the tunnel, I am extremely excited for the future of Marist women's basketball. Marist could not have made a better choice than Coach Erin Doughty to continue the legacy of Marist women's basketball. She brings the enthusiasm, knowledge, and spirit of what the program has been about for the last 20 years, and I am confident that Erin can bring the program to even greater heights. I thank Tim Murray, Deb DiCaprio, Dennis Murray, and Kevin Weinman for one of the most incredible journeys that a coach could ever have, and I thank them for having the vision to see that Coach Doughty can take the program even further."

Giorgis is currently in his 20th season as head coach of the Red Foxes. He has the best track record of champi-

onship success of any coach in the 40-year history of Metro Atlantic Athletic Conference women's basketball. Giorgis led the Red Foxes to their first MAAC championship in 2004, won nine straight conference crowns from 2006 through 2014, and most recently captured the title in 2021. His total of 11 MAAC championships is the most in conference history.

And he remains the only coach in conference history, men or women, to take a MAAC team to the NCAA Tournament Sweet 16 after accomplishing the feat in 2007.

"What an incredible coaching career!" Marist Director of Athletics Tim Murray said. "Brian's successes over the past 20 years here at Marist have exceeded everyone's expectations. He recruited, developed and won with terrific basketball players, but more importantly, with amazing young women that captivated both the Marist community and the fans throughout the greater Hudson Valley. He established Marist women's basketball as one of the top mid-major programs in the country."

Giorgis has won five NCAA Tournament games in his tenure, as he also led the Red Foxes to first-round victories in 2008, 2011, and 2012. That total is also the most of any coach in MAAC history.

Giorgis' current record stands at 451-183 overall. He was 450-44 in 19 years at Lourdes.

Giorgis' coaching prowess has extended to the international stage. In 2013, he served as an assistant coach for Team USA at the World University Games in Russia. Team USA earned the gold medal and won all six of its contests.

Doughty will take over as head coach on April 1, 2023.

"Brian's incredible record of wins on the court speaks for itself, but is only a fraction of his amazing story," said Marist College President Kevin Weinman. "For decades, he has developed student-athletes on and off the court, as well as the next generation of women's basketball coaches. Over the next year, we look forward to celebrating Brian's accomplishments and contributions to Marist, and to welcoming Erin Doughty to her well-deserved appointment to be Marist's next head coach."

Disagrees with Hardisty on good cause eviction law

To the Editor:

What gall.

Paul Hardisty (in his letter in the Beacon Free Press from March 2) speaks for real estate agents; owners and managers of rental residential properties.

His letter is a buffoonish rhetorical mouthpiece for landlords. He claims to speak for a rainbow coalition - including tenants - and asserts no need for "just cause" eviction due to some imagined protective set of laws for tenants. This sub-par ill-reasoned "Letter to the Editor" is a transparent reactionary apologia for maintaining the status quo allowing easy evictions - and, ultimately, the full gentrification of Beacon.

Have you read the leases lately that landlords foist on tenants - 80-90 percent of whom cannot afford counsel and given limited rental stock have to "take it or leave it?" Most of the restrictive clauses in those leases I have signed in town since 2017 had patently "illegal clauses" taking full advantage of those not versed in the law and rights tenants have.

I was in the NYC trenches of Landlord / Tenant Court for six years in the 1990s. New York State has never had a level playing field in this particular venue and "just cause" evictions (like "just cause" termination of at-will workers) is a long time in coming.

Discovering Ann Blake: The challenges of recovering women's voices from the past

For historians, genealogists, and other researchers, the challenges of recovering stories from the past on anyone other than elite men are well known. The further back one goes in time, the more those remnants of other voices are filtered through the perspectives of those elite men, sometimes to the point where the original tone and words are lost. That is, in part, why we have the discipline of history, with specific methods for addressing bias in the historical record, and themed months, to encourage people to think more widely.

It seems fairly obvious and easy to accept that the experiences, attitudes, and ideas of women living in the seventeenth, eighteenth, and even the first half of the nineteenth century would be difficult to recover. We must not lose site of the fact, however, that this obscurity of women's voices extends into our modern era of living memory. Readers born since the 1980s, and particularly those whose lives began in the twenty-first century may find this idea difficult to imagine, but women's individual identities were hidden behind the mantles of their husbands well into the 20th century.

Back in 2013, when I was conducting the research for the Dutchess County Government exhibit that still hangs on the 6th floor of the Dutchess County Office Building at 22 Market Street, I thought I knew all about the difficulties of seeing through the haze of old customs to access

the details of women's lives.

Pride cometh before a fall, as the old expression goes, and I was in for a wake-up call. In reviewing the press coverage from the Poughkeepsie Journal archives and sifting through the layers of government reports, I repeatedly encountered one woman (the only woman) on the Charter Commission.

The writers of these sources always referred to her as Mrs. Edwin T. Blake. For those readers of a more recent vintage, this custom of referring to married women by their husband's name carries back well before the foundation of Dutchess County in 1683. Usually, there are ways to work around that issue, but not in this case. Try as I might, I could not locate a single written source recording this individual's given first name.

An accident of fate that you can experience for yourself today offered the solution to this puzzle. Following in the footsteps of many historians, and perhaps drawing from a few too many detective novels, I returned to the scene of the event, in this case the Dutchess County Legislative Chambers. During the debates of 1965-1967, this room belonged to the Dutchess County Board of Supervisors. A small bronze plaque located to the right of the entrance to the chambers commemorates the "vision, wisdom, perseverance and continued untiring effort" of the Charter Committee of the Dutchess County Board of Supervisors and the Dutchess


County Charter Commission. Located below this inspiring proclamation, dated April 17, 1967, are the names of the members of the committee and the commission. Tucked between W. Carlton Bernard and Joseph MacAvery is Ann Blake. Finally, an answer to a months-old question.

Additional research quickly revealed that Ann Blake, the mysterious Mrs. Edwin T. Blake, was a key member and one-time president of the League of Women Voters of Greater Poughkeepsie. A Native of Litchfield, Connecticut, she earned her BA from Smith College and MA from Vassar College, and chaired the League's County Charter and Reapportionment Committee before joining the County Charter Commission in 1966.

She served in many other civic capacities, including the Model City Advisory Council during the years of peak Urban Renewal in Poughkeepsie and the building committee for the LaGrange Town Hall. Unfortunately, additional details on her life and experience remain elusive, offering yet another reminder of how challenging research can be. For those interested in learning more about the challenges of recovering women's voices from the past, the Dutchess County Historical Society has a great opportunity for you. On Thursday, March 10 at 7:30 p.m., I will be presenting a program on how historians use court records to reveal details of women's experiences in the past. My analysis will focus on data drawn from eighteenth and early nineteenth century cases preserved in the Dutchess County Ancient Documents Collection, which the County Clerk's Office both preserves and makes accessible via the online search portal at dutchessny.gov/ancientdocuments.

Attendees will hear tales ranging from Elisabeth Hitchcock's lawsuit against Robert Howe for failing to marry her to Elizabeth Ryherth's unfortunate and violent encounter with the Reverend Johann Christofells Hartwick in Rhinebeck. We

will discover how court records can be wonderful for preserving moments and experiences that would otherwise be lost to time, while also being a source of extraordinary frustration due to the absence of "the rest of the story," as Paul Harvey put it. Thursday's program is free and accessible via the world wide web: visit dchsny.org/march10 to sign up.

In the meantime, I advise readers to think carefully about their experiences and those of their friends, family, and loved ones can be recorded for posterity. The 1960s were an especially vital time for Dutchess County, a decade that seems a lot closer than it actually is to 2022. When going through old photographs or speaking to folks with memories of that era, give some thought to preserving those stories for future generations.

'No incarcerated individuals remaining' at Downstate facility

It is reported that Downstate Correctional Facility will close on March 10.

State officials made the announcement toward the end of last year.

In a statement to Beacon Free Press, DOCCS (Department of Corrections and Community Supervision) stated, "As of March 7, 2022, Downstate Correctional Facility (Dutchess County), a maximum security institu-

tion, has a current staff of 282, with no incarcerated individuals remaining in the facility. The transfer of incarcerated individuals to other facilities began shortly after the closure announcement and gradually decreased the facility's population. Incarcerated individuals were transferred to other facilities based on their security classification, as well as medical and mental health needs."







Six-string showcase

Bruce Molsky's return to The Stissing Center will highlight his first all-guitar album.

"Guitar was my first instrument," says Bruce Molsky. Though he's best known as a fiddler and banjo player, "the guitar is the one [instrument] that has accompanied me, whether mentally or physically, to the most places."

Molsky recently got around to realizing a dream of more than two decades when he released "Everywhere You Go," his first all-guitar album (2022, Tiki Parlour Recordings). Eleven tunes span a lifetime of musical and cultural influences and partnerships, coalescing around guitar and, on some tracks, vocals.

"Every piece on the CD represents a different experience, kind of like a memoir," Molsky says. "I've been doing this for a long time."

Selections from the CD will be the centerpiece of a performance at The Stissing Center in Pine Plains this Saturday.

"I'll be doing a bunch of guitar stuff, but [also] bringing my fiddle and banjo," says Molsky. "I hope for it to be a well balanced show. Half the show is songs, half instrumental pieces."

The March 12 performance will be Molsky's third at The Stissing Center, a renovated historic building that serves as a center for diversity, culture and civic life in Pine

Plains. His first performance there was with his Americana trio, Molsky's Mountain Drifters; the second one, a sold-out event that took place this past December, featured Molsky and famed banjo master Tony Trischka.

"[The show with Trischka] was great. We've been friends since dinosaurs roamed the earth," Molsky says.

"I love The Stissing Center," he says, adding that the Executive Director Brian Keeler's "heart is in the right place." Keeler has been the driving force behind The Stissing Center, nurturing it from a germ of an idea to reality over several years.

Molsky's new release contains the cream of the crop from a wish list that's at least 20 years old.

"Back in the days when we used to burn CDs, I burned a CD of ideas for a guitar CD," he says. "Not too many made it to [this album]."

In determining which ones made the final cut, Molsky considered the track sequence and diversity – there are tunes here reflecting cultures as diverse as Nordic, Celtic, South American, Appalachian and the American South.

"A common thread between the songs is important," says Molsky, calling the CD "kind of a world tour. ... I picked the ones I

thought would work well together."

Although it is a solo album, there are a few guest artists such as Darol Anger (David Grisman Quintet), Swedish folk violinist Ellika Frisell & singer and kora player Solo Cissokho, and Scottish singer Mary Ann Kennedy.

"The track with Mary Ann Kennedy, that was the only track that wasn't recorded recently," says Molsky. "We've been friends forever, and she and her husband have a beautiful studio up in the Highlands. That's been the track I've been saving for the right type of presentation."

Darol Anger appears on three tracks.

"We've also been close friends for a lot of years; he's a musical inspiration to a lot of people," says Molsky. "He's just a brilliant musician, a brilliant thinker. It was also an excuse to visit with him and spend a few days in the studio together."

From self-described "street kid from the Bronx" who taught himself how to play guitar at age 10, to world-renowned multi-instrumentalist and visiting scholar at Berklee College of Music, Molsky's musical journey is admirably encapsulated in "Everywhere You Go."

He writes in the CD's liner notes, "Recently I heard another artist talk about wanting to 'write my younger self a letter.' That made so much sense to me. So here's my letter to my younger self and, of course, to you. I hope you like it."
