"This holiday season Mount Gulian will be beautifully decorated in different era's fashions: opulent Victorian style décor adorning the dining room; simple, rustic décor in the study; contemporary holiday displays embellishing the home's main room. Our staff and volunteers always go to great lengths to transport our guests back to an earlier time, when there was more

calm, more time with family and no social media," said Elaine Hayes, Executive Director of Mount Gulian.

Hayes remarked, "As in the past, we will be giving House Tours about the history of Mount Gulian, with a special emphasis this year on how the Verplancks celebrated the holidays here for over a century. The home was a central meeting place for many of the well-established families in the area, and the Verplancks had holiday parties here every year."

Admission is \$12 adult; \$10 senior; \$6 children 6-18. Admission is free for children under 6 and Mount Gulian members. Membership is open to the public. Local employers wrestle with 'crazy' labor market

Last week, New York Gov. Kathy Hochul announced a new state-wide initiative to help connect job seekers with employers.

It's a noble effort considering the world is still very much in the midst of the COVID-19 pandemic, especially with the news that, at press time, the state of New York had confirmed eight positive cases of the Omicron variant.

But as far as local business owners are concerned – particularly restaurateurs and manufacturers where employees can't work remotely and need to be onsite – Hochul's project is a moot point.

"We are severely understaffed," said Luigi Coppola, owner of the Coppola's Italian American Bistro that he and his brothers run in Hyde Park. "I've never seen anything like it in all my years in the business. We are basically hiring anyone with a pulse, and once people are hired, they don't last."

There has been a sea change, employers say, ever since the pandemic hit in early 2020. And "sea change" is a polite description. In actuality there has been a seismic shift in attitude due to a variety of reasons.

To wit:

 Some people have been content with simply taking unemployment benefits, even though the extra benefits finally ran out in September.

- Some have decided to retire early.
- Some accepted buyouts.
- Some have shifted career perspectives and moved on to other fields.

• Still others have used the time to go back to school and/or learn a new trade. Nationwide, unemployment figures continue to drop incrementally, but the number of workers is also less. In essence, the labor market is upside down.

"The numbers just don't add up," said Sandra Jackson, who owns the Poughkeepsie office of Express Employment Professionals, a staffing agency and career counseling service.

Jackson's business caters to both employers looking to fill positions, and potential employees looking for jobs.

Jackson called it a "talent war." Employers are having to re-think the packages they offer to prospective employees, including wages - and workers are holding out for the best deals. Where Jackson was once able to place people at jobs paying a \$14 or \$15 hourly wage, she now says people won't even talk to her unless a position has a starting pay of \$18 an hour.

"The labor market is crazy," she said. "In September after the unemployment benefits expired, we thought we were going to have an influx of people. We didn't. There's been a big uptick in early retirement. Then, we have another group who were re-assessing their jobs. Some went back to school, some took up another trade. Then we have the childcare issue. The uncertainty is big there. Someone has to be home to take of their kids. And then you have COVID, which is not over. A lot of people are looking to still work remotely and workers are waiting it out. And frankly, they can be a little selective.

Coppola knows that all too well.

Simply put, a restaurant offers no remote option. You can't serve Tortellini Alfredo via a computer screen.

"We've tried everything we can think of," Coppola said. "We are hiring fulltime and part-time, and we've tried to become very flexible with schedules. We have found that people are filling out applications in order to fulfill their unemployment requirements, but not wanting to work. People are either afraid, lazy or both."

Coppola said he is one of the lucky ones, with brothers and other family members who have picked up the slack on a family-run business.

But not everybody can do that, hence Hochul's plan.

The initiative will build upon extensive efforts already underway by the New York State Department of Labor to connect job seekers to the record 220,000-plus available jobs in the state through tools and training resources.

"After the hardship New York's workforce has experienced as a result of
COVID-19, it is crucial that we connect
individuals looking for jobs with businesses looking to hire," she said in a
statement. "Streamlining the recruitment process benefits everyone
involved, as well as the state as a whole.
I look forward to seeing the good that
will stem from this initiative as we build
New York back better and stronger than
it's ever been before."

The Department of Labor will expand

existing services to collaborate with additional community partners across the state to educate New Yorkers about no-cost resources available to connect them with jobs.

The Department of Labor will also partner with Community Based Organizations, including those who assisted New Yorkers through the Emergency Rental Assistance Program (ERAP) to connect those in need to jobs, training and other resources.

Department State Commissioner Roberta Reardon said, "The COVID-19 pandemic has created a massive shift, not only in the type of jobs that are available, but also who is looking for work -- when, where, and how -- and the systems and programs needed to assist them. We have to reimagine how we connect job seekers to these jobs while also meeting the needs of our employers and we need all of our partners, from workforce development to our local community organizations, to help us educate New Yorkers about these critical resources."

It sounds good in theory, but employers remain skeptical when it comes to putting in practice given what they've seen in the recent past.

"We have been trying to fill out our staff for over a year now. It is very, very difficult," Coppola said. "I have friends who own restaurants who have had to close altogether or have closed two days a week because they can't find staff."

Count fellow restaurateur Paul Iannucci among them.

Iannucci owns two successful businesses – Nooch's Pub and Grill in the village of Millbrook and the Fireside

BBQ & Grill in Salt Point. Both places are now closed on Mondays and Tuesdays, and Iannucci is desperately seeking two hostesses and a cook at Fireside.

"It's a complete nightmare. It's been 20 months of a nightmare," he said. "I've never seen anything like it in the 20-plus years I've been in the business. Finding front-of-the-house staff used to be easy. Now it's hard. And back of the house? Forget it."

Iannucci agreed with Jackson as to the reasons why there is such a staffing shortage – flexibility, the ability to work remotely, wages.

Especially wages, he said, noting that chain restaurants owned by corporations have deeper resources and are offering far more money than he can.

As far as restaurants go, Iannucci also has another theory.

"The pandemic is uncharted territory. A lot of people just don't want to deal with the public," he said. "There are a lot of triggered and entitled people out there."

Jackson said there needs to be a happy medium between what employers can offer and what employees will accept.

"People are demanding flexibility and work-life integration. So people are looking at time-off policies, vacation, career development, training, and wellness programs," she said.

For some, that might be a lot to ask for.

But Jackson said she thinks it will resolve itself.

"This too will pass," she said. "It's cyclical. It's not going to stay the way it is "



County Legislature's Minority leader: Republican Majority 'rubber stamp' for County Exec

To the Editor:

At a recent meeting of the Dutchess County legislature I said, "This legislature is doing nothing." A letter to your newspapers last week questioning that statement provides a welcome opportunity to explain.

The work of a normal (County) legislature - such as Ulster County's - centers on standing committees, small bipartisan groups who research and develop policy in discussion with key staff. In the Dutchess County Legislature, standing committees don't do that. They just meet briefly to rubber-stamp whatever the (County) Executive sends over. In 2020, the Family and Human Services Committee deliberated for less than 30 minutes total, during the year, and the Environmental Committee for less than 18 minutes.

Our (Democratic) caucus has proposed three dozen bills on a range of topics, from extending line-of-duty benefits to probation officers, to setting fossil-fuel reduction targets. The Chair blocked almost all from being discussed. In response to the hardships brought by COVID-19, our caucus proposed funding for a Poughkeepsie non-profit that was expanding free WiFi access for schoolchildren. The Republican caucus asked for revisions to the bill, which we promptly provided, but at meeting time they hadn't read the revised bill, so they voted it down.

Many appointments on community task forces have lapsed. The Airport Committee, on which I serve, has met once in four years. Republican legislators appointed to the Criminal Justice Council and Police Reform Task Force, among other special committees, rarely attend. (The claim that no Democratic legislators attended a recent budget meeting, by the way, is false. At least two, and up to eight, lawmakers in our caucus attended each budget meeting. On several occasions recently, legislators who were in quarantine requested that a remote-participation option be restored, as permitted under New York emergency orders; the Chair denied those requests.)

In July 2020, when we discussed cost-effective community-based alternatives to incarceration, the Chair promised to appoint a bipartisan committee to research options. We are still waiting. In 2021, the Chair never bothered to ask the legislature to adopt rules for the year.

Republican legislators have raised no substantive questions about the 2022 budget, which sharply increases spending and engineers a "dip" in debt service for 2022, kicking repayment down the road until the current Executive is out of office. (Debt service—including on the exorbitant new jail, by far the county's largest current investment--will now peak at over \$37 million in 2027, more than triple the amount in 2010.)

All these things seem to indicate a legislature that is doing nothing.

It's possible that the Republican majority is having extensive policy debates. If that's the case, they are doing so behind closed doors, holed up in their caucus room with the Executive. That is worse than doing nothing. It's secret decision-making that is not accountable to voters. That's not how democracy should work.

Any member of the public can watch the online meeting videos and decide for themselves: Is this legislature doing nothing? Or is the Republican majority pre-arranging everything secretly with the Executive, on a partisan basis, before voting in lockstep? Whichever it is, Dutchess residents deserve better.

Resident responds to Molinaro, Pulver

To the Editor:

I am responding to County Executive Marc Molinaro and Legislature Chairman Gregg Pulver and their criticisms regarding the low attendance of the Democratic legislators. I was going to attend last Monday's meeting until I learned that the Republican legislators do not wear masks, in spite of a "masks required" sign on the county building. Perhaps those absent legislators are considering the health risks these maskless meetings pose. A good solution would be to make these meetings virtual during COVID times so that all can attend safely and participate in the democratic process.

I was curious about the Dutchess County jail project in Poughkeepsie. Incarcerations have declined and the State of New York is closing prisons, including the Downstate Correctional Facility in Fishkill. This new jail is the most expensive project in county history, with a debt lasting into the 2040's. I also question the increase in the County Executive's Office budget which has nearly doubled since he was elected in 2012. The main additions in cost have been for public relations staff and aides.

Mr. Molinaro is touting his "historic" one year \$5 million dollar tax break in 2022 (his office sent a mailer to Dutchess County households about this, to the tune of \$40,000 in taxpayers' money.) This is a "short term" dip in debt service that will leave a much higher debt service due in 2025, which will require additional revenue to be generated or county programs to be cut.

Molinaro has announced that he is running for Congressman Antonio Delgado's seat next November. A good public relations budget and the announcement of a big tax break are certainly beneficial for his campaign, but maybe not for the future of Dutchess County.

COVID-19 update

Omicron officially arrives in NY; Dutchess active cases jump

Gov. Kathy Hochul announced the inevitable arrival of the Omicron variant to New York last week. An individual from Minnesota who attended a conference at the Javits Center in Manhattan tested positive in their home state, and the Minnesota Department of Health notified New York of the result.

"The information is still evolving, but we understand that this individual, while they were vaccinated, they have very mild symptoms. And in fact, those symptoms have already resolved," Hochul said at a press conference on Dec. 2.

Hochul advised the public not to be unduly alarmed by the news.

"It's not unexpected," she said. "It was literally six days ago when I instituted an executive order to give me the powers I would need to deal with the current situation, but also a future situation, which could arise if Omicron ended up showing up in the state of New York."

Unsurprisingly, more cases have been confirmed throughout the state.

"I want all New Yorkers to know that their state government, in collaboration with our local governments, our cities and our counties, are prepared for this," said Hochul, adding that the state has ordered one million tests to be distributed to local health departments (giving priority to those in school environments), plans to launch 40 new vaccination pop-up sites by the end of the year, and has developed new marketing efforts to promote boosters and vaccines (see sidebar to learn about one of these).

Hochul encouraged anyone who attended a conference at the Javits Center between Nov. 18 and 22 to get tested. The state also has been contacting individuals who were known to attend the conference.

"We're not overreacting to this, but I want New Yorkers to have the confidence to know that we are ready to a deal to deal with this," she said. "Continue wearing your masks. We encourage everyone to wear their masks when they're out. Get those shots, get your children vaccinated."

During the Dec. 2 press conference, Hochul introduced Dr. Mary Bassett, the state's new health commissioner. Formerly, Dr. Bassett served as New York City's health commissioner, where she said "I encountered more microbes than I ever would have predicted."

She added, "In three decades of public health work, I've learned the impact of truth-telling. ... I'll tell the governor what we know, what we don't know and what our best judgment is. And I'll tell long proven eff washing your h mask-wearing, c ed; and, if you'r isolate yourself.

the public the same thing."

Hochul closed the press conference on a positive note.

"We know how to do this. The answers are right before us. We've done it before. We'll do it again," she said. "And we're going to do everything we can to keep New Yorkers safe and keep our economy open."

Cases spike in Dutchess

On Dec. 2, Dutchess County Executive Marc Molinaro held a brief Facebook event to update residents about COVID-19 data. On that day, there were 628 active cases in the county; that number has since risen to 922 by the weekend. The seven-day rolling average for infection rate was 5.31 percent.

Molinaro said the latest rise was "similar to the middle of October" and is part of the "seasonality we're experiencing," adding that he expects to see increases over the next two to three weeks as a result of holiday gatherings.

The largest number of new cases are among the 30-39 age group (17 percent). Of those interviewed, 69 percent were either unvaccinated or not fully vaccinated

The "number we want to watch," said Molinaro, is hospitalizations, which are a lagging indicator.

"Those cases in hospitals are more severe." he said.

Over the last 14 day, 72 percent of those hospitalized have been either partially or unvaccinated, wth 28 percent being fully vaccinated. Molinaro said, "Those numbers have pretty much held steady over time."

A little more than 71 percent of Dutchess residents have had at least one dose of a vaccine, with just over 63 percent being fully vaccinated. More than 80 percent of adults (18 and older) have had at least one dose, with the highest percent being 55 and older.

Sixteen percent of children ages 5-11 have had one or more doses; that number is 63 percent for ages 12-17.

Molinaro maintains his belief that vaccination is a choice, and for children it's a "decision to be made between parents, children and medical providers."

Briefly addressing Omicron, Molinaro said currently there is no data suggesting the variant is any more severe than other variants and recommended residents continue the mitigation steps that have long proven effective in reducing risk: washing your hands, social distancing, mask-wearing, choosing to be vaccinated; and, if you're not feeling well, try to isolate yourself.

Legislature adopts 2022 County Budget

The 2022 Dutchess County Budget was adopted with bipartisan approval of the Dutchess County Legislature on Thursday, Dec. 2, with more than \$20 million in annual tax relief, including the largest property tax decrease in county history, as well as the elimination of sales tax on clothing and footwear items up to \$110.

Several legislative amendments were made to County Executive Marc Molinaro's Proposed County Budget to further increase grant program funding, including not-for-profit infrastructure projects, Fire and Safety equipment for local emergency services as well as the popular Learn, Play, Create: Supporting Our Kids grant program.

As previously announced, the 2022 County Budget expands and enhances county services and programs that residents rely on. The budget includes new initiatives addressing mental health and substance use, among others, while continuing critical programs for children, families, seniors and veterans, as well as funding for County parks and other vital programming.

Legislative Amendments to the 2022 County Budget include:

- \$1 million increase to the Department of Planning and Development's Agency Partnership Grant Program (APG) for not-for-profit infrastructure projects.

- \$2 million increase to the Department of Planning and Development's Municipal Innovation Grant Program (MIG), including:

Expanded Fire/Safety grant opportunities focused on one-time equipment and capital investments.

Additional grant opportunities for community projects

- \$500,000 increase to the popular Learn, Play, Create grant program to provide opportunities for youth in sports, libraries and arts.

- \$500,000 increase to the Department of Community & Family Services Youth Services Division focused on youth violence in schools.

- \$88,000 increase to the Department of Behavioral & Community Health for additional recovery coaches.

- \$50,000 increase to the Department of Community & Family Services to create new competitive grant program to assist destinations with improving access and experience for those with special needs.

- \$50,000 increase to Division of Veterans' Services to expand the HERO program for housing, employment and events for Dutchess County veterans.

The above amendments, as well as additional staffing support to the Legislature, were funded with appropriations from the county's General Fund Balance. The county's unassigned fund balance increased more than \$3 million to just over \$60 million in the 2020 year-end audited financial statement and, because Molinaro's proposed budget did not appropriate any fund balance, the amended appropriations will have little impact, keeping Dutchess County's fiscal foundation solid for the future.

The adoption of the 2022 Dutchess County Budget followed several town hall forums, including a countywide telephone town hall, during which residents had the opportunity to speak with Molinaro to learn about the details of the budget, ask questions and share their feedback.

The budget, with amendments, will now be forwarded to Molinaro for review and signature. The final step in the 2022 Dutchess County Budget process – override consideration of any amendment vetoes by the County Executive and the adoption of the tax levy – will be on Monday, Dec. 13, at the Dutchess County Legislature's Board meeting.

56 firearms turned in during gun buyback



gun violence and protect New Yorkers throughout the state. In 2021, Attorney General James recovered nearly 2,100 guns from 18 buyback events and other measures that were held throughout the entire state. To date, Attorney General James has taken nearly 2,700 firearms out of communities through gun buyback events and other efforts since taking office in 2019.

Last week's community gun buyback resulted in the collection of 56 guns, including 15 handguns, 33 shotguns and rifles, 6 assault rifles, and 2 non-working guns. Since 2013, the OAG has hosted gun buyback events throughout New York state and has successfully collected nearly 4,700 firearms.

In exchange for the firearms, the OAG offered monetary compensation, in the form of prepaid gift cards, when an unloaded gun was received and secured by an officer on site.




Newburgh Symphony to present 'All is Bright' holiday concert

Now in his fifth season of GNSO leadership, Ger has led the orchestra to new attendance records and artistic heights.








