Beacon's history 'a constant growth' and commitment

Denise Doring VanBuren is the president of the Beacon Historical Society.

'Change is a constant, and decades of growth and commitment have made Beacon the community we know today because it has always been evolving. But the pace of change now is greater than ever before -- streetscapes are changing, the "small town" feel is evaporating and the magic that makes Beacon "Beacon" will dissipate if we don't preserve and promote what made this community so very special," said Doring VanBuren in an email. "From the Mount Beacon Incline Railway and the Newburgh Beacon Ferry, to our hat-making industry and our local families, we have a fascinating shared past. We want to be sure that the chapters that made Beacon's story so compelling (that resulted in this city of ours) are not lost on those who have only now "discovered" us. Knowing what made this community so wonderful is the key to keeping it wonderful."

Asked what the most interesting story item she has come across, Doring VanBuren, who is also an author, said, "We have thousands of items in our collection -newspapers, photographs, products made in Beacon, scrapbooks, ephemera, etc. I joined the Historical Society in 1988 -- and I have been fascinated ever since by the breadth of items that families have entrusted to us -picking a most interesting or favorite item from our collection would be like trying to pick your favorite child (i.e. impossible!).

"BUT I will share a chapter that I learned only recently -- something that I think few people realize," Doring

VanBuren said.

The following is what Doring VanBuren relayed.

"Howard Ashman rented a house in 1989 at 791 Slocum Road in Beacon for two years while he was waiting construction of his home in Cold Spring - regrettably he died in March 1991 and never got to see that new home.

Who was he? A prolific musical lyricist and producer who first came to prominence in 1982 with a work that he conceived, wrote and directed with music

by Alan Menken called "Little Shop of Horrors." Ashman was soon pivotal in the renaissance of Disney-animated musicals and in the development of "The Little Mermaid" (Producer and Lyrics), "Beauty and the Beast" (Executive Producer and Lyrics) and "Aladdin" (Lyrics), all with music by Alan Menken.

While living here in Beacon during production of "The Little Mermaid," he continued to work, helping to give life to

Yankees select **Nick Ortiz** as Renegades manager for '24

The Hudson Valley Renegades will have a new field manager for the 2024 season.

The New York Yankees, parent club of the Renegades, have named Nick Ortiz will take over as the manager of the Hudson Valley Renegades, the Yankees High-A affiliate.

The Renegades will be in their 30th season in the Hudson Valley in 2024. Ortiz becomes the 19th manager in team history, and fourth in four years during the Yankees era. He is joined on the field staff by Pitching Coach Spencer Medick (2nd season), Hitting Coach Rick Guarno (1st season), and Defensive Coaches Derek Woodley (2nd season) and Zak Wasserman (1st season).

"I'm very excited to be given the opportunity to manage the Hudson Valley Renegades this year, and I'm really looking forward to connecting with all our fans," Ortiz said in a statement. "We are going to present tremendous talent on the field and I hope that you could all join us in what should be a fun and exciting

Ortiz is returning for a second stint with the Yankees organization after spending the past four seasons as the Quality Assurance Coach for the San Francisco Giants. Before serving on Gabe Kapler's staff in San Francisco, Ortiz served a dual role for four seasons in the Yankees system, serving as an Amateur Scout covering Puerto Rico and a Minor League coach.

He has previously served as a minor league baseball manager.

In addition to his Major and Minor League coaching experience, Ortiz has coached and managed in the prestigious Puerto Rican Winter League for the Gigantes de Carolina and the Cangrejeros de Santurce, a league in which he played in for 16 seasons and was a six-time All-Star.

Ortiz comes to the Hudson Valley with a connection to the Renegades, having served on the Giants staff for four years former Renegades manager Craig Albernaz, who guided the Gades to the 2017 New York-Penn League Championship.

Hudson Valley now plays in the South Atlantic League.

Sabellico's introduces new farm-harvest CSA program

Matt Sabellico and his staff at Sabellico's Greenhouses and Florist, Inc. in Hopewell Junction are entering a new chapter. Come spring, they will be producing a wide variety of vegetables and other local products as part of their own CSA (Community Supported Agriculture) program.

The Sabellico family has run the farm/business for over 70 years and Mom, Diane said her son, Matt, is the impetus behind the CSA idea.

"He was growing organic produce here at Sabellico's for a few years before COVID. He had a non-commitment CSA where he packed up the week's haul from the garden in boxes and sold them to whoever showed up," said Diane. They survived the uncertainty of the COVID era by concentrating on their core business of selling vegetable plants and flowers, because she said, "No one knew how things were going to shake out."

Diane pointed out that Matt "learned a lot from his first go around with produce - what worked well and what did not. It has taken him up til now to get reorganized to try growing produce again." He is also trying to involve other area agricultural businesses in this endeavor. Right now, Dan Moon from Sunnyvale Farm (formerly Secor's Strawberries) and Nicole Harris from Tiny Green Farms (microgreens) are involved in the CSA.

Matt is also trying to get other providers with eggs, meat, honey, maple syrup etc. involved as add-ons to the CSA. He feels that these partnerships can benefit all involved. He was chairman of the Dutchess County Agricultural Advisory Board for seven years and is now Chair of the Dutchess County Agriculture & Farmland Protection Board.

"We are very excited about the oppor-

tunity to offer more programs like this to our community. I am deeply passionate about our agricultural communities here at home and across these beautiful lands," said Matt. "I believe that optimal health and nutrition begins on farms, both for the lands and the people they feed. The Hudson Valley is one of the most beautiful and fertile lands that we have left in this country and needs to treated with care and consideration."

He added, "We have a diverse and unique farming community here in Dutchess, imbued with passion and respect. It is important that we work to preserve and restore the respect of our lands and their ecological and agricultural value."

Matt said he believes that "farming and the principals it teaches us can help lead us to a simpler, more connected way of life. I dream of a day when instead of lush green lawns, the neighborhoods we have built have dedicated areas for gardens, orchards, greenhouses and animal pastures."

He also believes that if the agricultural health land is preserved, it will continue to achieve optimal health for all.

The new "Goddess Garden" carries that name after Matt's daughters, who are named after goddesses Freya and Artemis.

Funding for Inspiration Field at the Robinson Lane Baseball Complex was recently unanimously approved by the Wappinger Town Board. The field will be used by the Wappinger Challenger League, which was founded by Bettina Briccetti in 2005.

"Beauty and the Beast" - here, in Beacon, NY! Disney set up a special studio workspace for his coworkers in a conference room in the [former] Residence Inn in Fishkill. The rest of his team, which included Menken, flew into town and went to work creating some of the most beloved and most recognizable Disney music ever recorded. The musical team was so impressed by the level of customer service they all received at the hotel that they wrote the song "Be Our Guest" in honor of that hotel. His coworkers dedicated "Beauty and the Beast" in his memory: "To our friend Howard, who gave a mermaid her voice and a beast his soul. He will be forever missed."

And he wrote it all here in BEACON!

- The Mount Beacon Incline was the

steepest in the world and attracted 3 million people to the top

- Beacon was the hat-making capital of New York -- second nationally only to

- Many famous people have lived here, including Peter Seeger, Melio Bettina, Digger Phelps, Robert Montgomery and even author James Patterson. Many other important people have visited (e.g. George Washington, Gloria Swanson, D.W. Griffith, etc.).

- Beacon had MANY fine estates, thriving businesses and exceptional local athletes.

Beacon was a center for ground-breaking treatments for the mentally ill, with sites including Matteawan State Hospital, the Riverview Sanitarium, Craig House and the Moreno Institute.

Historical society is 'incredibly important' in East Fishkill

ller is the site director for the Brinckerhoff Historical Site on North Kensington Rd. in East Fishkill. There one can see a one-room schoolhouse, a blacksmith shop, the Brinckerhoff-Pudney House, an icehouse and a carriage house.



"Our local and state historical societies are incredibly important as we are the keepers of the documents and items from the past that help us navigate the future. We don't know where we are going if we don't know where we came from. Without our historical societies the past would be lost forever, stated Soedler.

"All history is interesting" to him, Soedler remarked.

"I just recently learned that during WWll, [British Prime Minister Sir] Winston Churchill visited the Morgenthau family of East Fishkill with President Franklin Roosevelt. That intrigued me," he stated.

Henry Morgenthau Jr. served as treasury secretary during the FDR administration. His son, Robert, was the District Attorney for New York County for more than three decades. Josh Morgenthau, a son of Robert, now runs Fishkill Farms in East Fishkill. Soedler noted, "The most rewarding

aspect is being able to help an individual with family research. Not all information is available in one place but being connected with other local societies we all work together to find the missing pieces of the puzzle for many families. Preserving the structures on our site in East Fishkill and being able to teach the public about them is also incredibly rewarding.

We have just added a student membership fee of \$10 for high school or college students interested in supporting what we do. We also have volunteer opportunities for those students who are looking to build their resumes or fulfill their school community service hours," said Soedler.

Wappingers Falls Historical Society to 'help future generations'

"A historical society is an organization dedicated to preserving, collecting, researching, and interpreting historical information or items. They are an important part of the local community because they help future generations understand their heritage,' said Beth Devine, who is president of the Wappingers Historical Society. "The Wappingers Historical Society was founded on April 12, 1967, by local resident John Ferris and is dedicated to preserving and promoting the history of the Town of Wappinger, the Village of Wappingers Falls and neighboring communities. The mission of the society is to preserve and share local artifacts, documents, photographs, and maps that pertain to the village, town, and surrounding areas; to preserve the Mesier Homestead; and to serve as a source of historical information for the community.'

Devine joined the WHS 14 years ago. What was described as "one of the most touching and memorable for her (Devine)" was the recognition of James Cruse, a WWI

soldier from Wappingers Falls.

Devine recalled, "James was listed on a huge memorial billboard in Poughkeepsie, which recognized the area's fallen heroes in WWI. Our archivist noticed that James wasn't listed on the bronze WW1 memorial plaque on the front of Mesier Homestead.

We began to investigate his story.' The following was relayed to Southern Dutchess News: "Cruse came to Wappingers Falls from down South in the years before WWI to work at the Aniline Dye Company plant. When the U.S. intervened in WWI in 1917, Cruse answered Uncle Sam's call and enlisted. He went to France as a member of the New York volunteers, better known as the Harlem Hellfighters. Private Cruse was involved in fierce fighting on the Western Front where the Germans had put a big dent in the Allied

lines called the St. Mihiel Salient (Meuse-Argone Offensive). James died of wounds on October 14, 1918 while fighting to reduce the Salient and was buried at the St. Mihiel American Cemetery in Thiaucourt, France."

Devine stated, "While on a trip to France

in 2017, my husband and I visited the cemetery, which is similar to the one we visited in Normandy. Of the 4,153 WWI soldiers buried there, 380 were members of the Harlem Hellfighters. We were met by a US Army Ranger who led us to James's grave, where I placed flowers and the American and French flags at the base of the cross, while listening to the doleful sound of Taps reverberating throughout the cemetery. Later that year, the WHS held a ceremony and placed a bronze plaque recognizing James Cruse beneath the one on the front of Mesier Homestead. Among those at the ceremony were representatives from the New York National Guard, members from the Bethel Baptist Church and a small choral group singing WWI songs. "I was so proud that the WHS corrected the overlooked service of a young man who paid the ultimate sacrifice for his country.

Stories such as this illustrate the importance of preserving, protecting, interpreting and sharing historical records, it was stated. One may support the mission of the Wappingers Historical Society by becoming a member. Fishkill has 'many legacies and stories' throughout its history

Amy Mack is a member of the Fishkill

Historical Society.

When people learn the history of where they are, those in that space, regardless of time and their perceived differences, suddenly have something in common. That's a powerful tool to encourage fellowship in a community. Sharing the story of how a place relates with the region, country, and even the world provides a service that gives a community a common sense of place," stated Mack, who has been in the FHS for more

than two decades. There are many legacies and stories throughout Fishkill's history that need to be remembered and shared, including such aspects as the Wappinger people, colonial life, Fishkill's role in the Revolutionary War, prominent people in Fishkill, and Fishkill industries through time. The nation's 250th anniversary is fast approaching. I hope that the community can come together to make the Semiquincentennial in 2026 as great as what was done in Fishkill in 1976 for the Bicentennial. I can't wait to be able to share the story," she said.

Mack told of a story she encountered as a

member of the FHS.

"Probably the most significant story that the Fishkill Historical Society must share is the fact that George Washington's Fishkill Supply Depot was in Fishkill. The site and building that houses the Van Wyck Homestead Museum was the officer's headquarters for the Continental Army base. To better describe the role of the museum building, I tell visitors that it was the supply depot's administrative office building. The supply depot was a logistically critical installation that served the Northern Department of the Continental Army during the majority of the Revolutionary War. The depot served as a central location for storing and distributing essential materials for the army, including food, clothing, weapons, and medicine. The depot's role expanded beyond mere storage. It became a site for repairing equipment, manufacturing supplies, and providing medical care to wounded soldiers. The Fishkill Supply Depot was a bustling hub of activity, with soldiers, workers, and supplies constantly moving in and out. There were barracks to house 2,000 soldiers and support staff year-round, and up to 2,000 soldiers camped in Fishkill in the warmer months for training. There were about 100 outdoor bread ovens in Fishkill, like the small demonstration clay oven at the museum, to bake bread for all of the personnel. Can you imagine how good all that baking bread smelled? Fishkill's strategic location in the Hudson Highlands at the junction of ancient roads, today's Routes 9 and 52, and so near to the Hudson River, made the depot defendable and provided easy transport of goods and people over land and on the river. The rebel system of signal fires along the ridge tops to alert defenders of intruders was so effective that the British didn't attempt to invade the supply depot! There's no doubt that the Fishkill Supply Depot was integral to the success of our war for independence from Britain," Mack explained.

How can one join the Fishkill Historical Society?

The Fishkill Historical Society is a 100% volunteer led not for profit private organization since its founding in 1962 when the plans for constructing Interstate 84 called for removing the "abandoned old farmhouse" and the founding members, led by the late Fishkill Town Historian Willa Skinner, saved the house from demolition, said Mack.

Volunteering or becoming a member of the Fishkill Historical Society is easy. Volunteers earn their memberships with their time spent helping out. There are many ways to use your talents to volunteer, from keeping the Van Wyck Homestead Museum's building and grounds up to being a museum docent," said Mack. One can also choose to support the historical society by becoming dues-paying members. "There's a membership level to fit everyone's budget, from \$10 a year for seniors and students to a one-time \$500 donation to become a lifetime member. Please see our website at fishkillhistoricalsociety.com or stop by when we are open on weekends from June through October for more details about volunteering or becoming a member,"she said.

Failing to support Ukraine now will make the world a much more dangerous and expensive place

To the Editor:

For everyone who has taken any action in support of Ukraine – whether flying a flag, lawn sign, attending an event, making a donation – and especially for those who have made significant efforts of time or money organizing drives for winter clothing, emergency equipment, fundraisers - these are difficult times.

Never has something so urgent and clear as the benefits we Americans reap from Ukraine's victory and supporting her through it been held hostage by one of our political parties in Washington. For months, we have been told that without a deal on controlling immigration on our southern border, there can be no funding for either Ukraine or Israel.

This week, such a deal has been reached supported by the Senators of both parties, The White House, and the Democrats in the House - only to have the House Republican Leadership declare it dead on arrival there.

We in the Hudson Valley have elected a bi-partisan delegation to the house. Many of your readers know Marc Molinaro. Some will know Mike Lawler or Pat Ryan. We urge you to call and write to them and ask them to support the deal which strengthens these pillars of our security: Support for Ukraine, Israel, and securing the southern border as it is essential we staunch the undocumented and illegal flow across it.

The facts are clear and bleak: Without US ammunition and weapons, Putin will win. Russia's victory in Ukraine will lead to larger conflicts with NATO states - putting our troops in harm's way. Russian victory will embolden China, destabilizing the Pacific rim and putting our allies Taiwan, Japan and South Korea in danger.

Veterans notified of potential limited information disclosure

The Veterans Health Administration (VHA) announced on Jan 25 that the administration is sending letters to 46,677 Veterans notifying them of the potential disclosure of limited information that may have been sent to another VA patient. The Veteran Integrated Services Network (VISN) 1 had 22,351 letters mailed and VISN 2 had 24,326 letters mailed. No Social Security numbers or other identifying information were divulged in the mixup, caused when Xerox Corporation, under contract to VA, experienced a printing error in December 2023, stated the VHA press release.

The appointment notification postcards were generated by an application that converts information in a patient's electronic health record to an easy-to-read format, then prints, seals, and mails the postcards. The event was reported on December 11, 2023, according to VHA. The event involved reminder notifications for appointments scheduled between December 11, 2023,

through December 15, 2023.

VHA stated: "The application printed postcards addressed to patients that contained appointment scheduling and reminders for other patients. This was due to a misalignment, or improper match, of the content with the name and address of the appointment postcard recipient."

VHA emphasized that "no Social Security number or other identifying information was disclosed." Veterans affected will receive a Privacy HIPAA (Health Insurance Portability and Accountability Act) Notification Letter, according to VHA.

Veterans who have questions or concerns about whether their personal information may have been involved can call and leave a message at 1-844-838-5433 between the hours of 8 a.m. – 4:30 p.m., Monday through Friday. Calls will be returned by the Privacy Officers at the local Medical Centers within two business days.

Central Hudson announces first two Customer Open Houses in Kingston, Newburgh

Hochul announces Excelsior Scholarship application open for new applicants for Spring 2024

Governor Kathy Hochul recently announced that the application for the Excelsior Scholarship for new applicants for the Spring 2024 term is now open here. Students eligible for the Excelsior Scholarship under the Senator José Peralta New York State DREAM Act can apply here. The Excelsior Scholarship, in combination with other student financial aid, allows eligible full-time students to attend a SUNY or CUNY two-year or four-year college tuition-free.

"The Excelsior Scholarship is a game changer for students across New York State who might not have the financial means to pursue higher education," Governor Hochul said. "This program is making college more affordable and accessible for low- and middle-income families, giving them the opportunity to obtain their college degree. By investing in our future workforce, we are investing in our economy and ensuring a strong and prosperous future for all New Yorkers."

Students from households with federal adjusted gross incomes up to \$125,000 are eligible for a Spring Excelsior Scholarship award. Students must also:

- Plan to attend a SUNY or CUNY two- or four-year college;

- Complete 30 credits per year towards their program of study (including summer and winter terms); and

- Be on track to graduate with an associate degree in two years or a bachelor's degree in four years

The Spring 2024 Excelsior Scholarship application is open to first-time students entering college in the Spring 2024 term and current college students who have never received the Excelsior Scholarship. Students currently receiving an Excelsior Scholarship do not need to complete this application to receive continued award payments.

New York's generous investment in student financial aid, including TAP and Excelsior Scholarships, helped over 180,000 New York State residents. Fifty eight percent of full-time resident undergraduate students attended SUNY and CUNY tuition-free in 2022, including 53 percent at SUNY State-operated campuses and 67 percent at CUNY colleges.

Applications will be accepted through Feb. 2.

Jacobson: Cuts to education, environment will not stand

Expressing outrage and promising action against the cuts in Governor Kathy Hochul's proposed budget in school aid and environmental protection, Assemblymember Jonathan Jacobson vowed, "These cuts will not stand!" on January 24 in a statement.

Jacobson, who represents five full school districts and parts of three others, said the Poughkeepsie, Highland and Beacon school districts are slated for cuts. These cuts are primarily due to the Governor's changes in aid calculation, as well as the Governor's proposed elimination of the "save harmless" provision, which ensures that no school district receives less Foundation Aid than it did in the previous year, he said. Foundation Aid represents the largest share of education funding that school districts receive from the state, according to Jacobson.

"Governor Hochul is reneging on her

promise to fully fund Foundation Aid to our schools," Jacobson said. "Not only will this mean less money, but school districts will be unable to plan their budgets."

Jacobson also noted the proposed budget's lack of commitment to the environment. Though money is available from the Clean Water Act, the Governor's budget would allocate \$250 million for New York's Clean Water Infrastructure Act, according to the assemblyman. Since 2019, the State has provided \$500 million each year for water infrastructure, so this proposal represents a 50% decrease in funding. "Unfortunately," Jacobson said, "the costs have not gone down."

"This is first step in the budget dance in Albany. The Assembly and Senate majorities will produce their own budgets, and then begin negotiations with the Governor," Jacobson continued. "I am confident that these cuts will be restored."

Poughkeepsie Day School announces launch of HS Navigator Institute

There's going to be a new high school in Duchess County.

Or, at least a revamp of an existing one. Following the news in June that Poughkeepsie Day School (PDS) is continuing on its Boardman Road site, the school has announced the launch of its new high school program, the Navigator Institute.

The Navigator Institute will maintain the rigorous program of study that has long been a hallmark of the PDS high school experience, but with a renewed focus on three central tenets: service, engagement, and self-efficacy.

Faculty are developing curricula to support these tenets alongside trademarks of Poughkeepsie Day School, like the weekly day-long central study, where students specialize in an intensive study. The school will continue the tradition of being one of the Northeast's only gradeless high schools, where students receive quarterly narrative reports instead of graded report cards.

"Today, more than ever, colleges are looking beyond basic number or letter scores in their acceptance decisions. Because narrative reports provide more contextualized, detailed, and credible information about student performance, they often receive extra attention from college admissions offices," said Tammy Reilly, Director of Admissions.

Established in 1934 by Vassar College faculty, PDS launched its high school in 1970. Since reopening in 2021, PDS has maintained a small high school, primarily consisting of former students who returned to complete their pre-college careers at the school.

With the launch of the Navigator Institute, PDS enters a new chapter. Head of School Spiro Gouras said, "Our intent is to remain close to our long-term mission of graduating students that will make the world a better place while being responsive to each individual student's educational needs."

Relocation of utility poles on Route 9D for Hudson Highlands Fjord Trail

Utility poles on the west side of Route 9D in the Town of Fishkill, north of the Breakneck tunnel, will be relocated to the east side by Central Hudson Electric & Gas. The project will begin in the coming months, according to an announcement from Hudson Highlands Fjord Trail, Inc. (HHFT).

"The utility relocation project will eliminate utility poles and wires from the viewshed of the river in this section of the Route 9D Scenic Byway," said Lori Moss, the communications director for the Hudson Highlands Fjord Trail.

As for why this is a necessary part of the project, Moss replied, "The relocation of the utility poles to the east side of Route 9D will make way for new improvements, including restrooms, improved parking, the bridge across the Metro-North railroad tracks, enhanced crosswalks, and wayfinding signage."

So how will this 'transform' that section of 9D?

Moss responded, "This work is the first phase of a multi-year construction project that will transform the Breakneck/Route 9D corridor. Central Hudson's work in the spring will be followed by the New York State Department of Transportation's planned improvements to the Breakneck tunnel during the summer, then construction of the Breakneck Connector &

Bridge, beginning in the fall."

The Breakneck Connector & Bridge project will make this section of the Route 9D corridor "a first-class recreational amenity – one that is more beautiful and safer," said Moss. "It will include newly configured parking areas (on only the west side of Route 9D, not on both sides), a totally upgraded Metro-North Station at Breakneck Ridge, a safe, off-road trail connecting the station to the Breakneck trailhead, restroom facilities, beautiful native landscaping and seating, and trail improvements."

According to information from the HHFT, a comprehensive tree survey conducted by national environmental consulting firm Great Ecology, nearly 80% of the trees that will be removed for the utility relocation are either invasive species or are native trees in "Poor" or "Dead" condition. "Ultimately, these will be replaced with 2,080 shrubs, 430 trees, and thousands of additional native plants to foster more early successional forest, dense shrub, and grassland habitat, which will better serve native wildlife," it was stated by HHFT.

Moss noted, "In addition, a bridge will provide hikers and cyclists with a safe passage over the railroad tracks to the water's edge, reconnecting visitors with the Hudson River."

A spokesperson from Central Hudson did not respond to an inquiry regarding the project.

Town of Poughkeepsie Police Department to create new Community Policing Unit

Congressman Pat Ryan has announced that he secured \$375,000 for the Town of Poughkeepsie Police Department to create a new Community Policing Unit dedicated to community outreach, addressing chronic crime issues like larceny, and remediating quality of life issues within the community. Three new officers will be hired and dedicated solely to the new unit, which will also build the capacity of the Department's current 83 officers for emergency response and crime prevention

"Our local law enforcement officers work tirelessly to keep our communities safe, and I'm pushing every day to get them the support they need. The new Community Policing Unit will bolster the department's ability to address chronic crime, increase community out-

reach, and significantly strengthen public safety in Poughkeepsie," said Ryan. "Too often, our smaller police departments don't get the resources they need – so we are fixing that here today. And I'll keep fighting to deliver for law enforcement across the Hudson Valley."

The new Community Policing Unit will allow three new officers to respond directly to community needs and quality of life concerns, conduct comprehensive community outreach, address chronic crimes issues such as larceny, implement evidence based community policing methods, and focus enforcement on the Town's Main Street corridor. The hiring of the three new officers will also build the capacity of the Department's current 83 officers for emergency response and crime prevention

"This is going to be a tremendous impact for the entire Town of Poughkeepsie community to have these dedicated officers to concentrate on finding solutions to recurrent problems within the town and building better relationships with the community," said Town of Poughkeepsie Police Chief Joseph Cavaliere. "This funding will create additional positions in our department, boost our ability to thoroughly respond to community needs, concentrate enforcement on areas that have increased crime, and help us really connect with community members. I'm looking forward to continuing to work with Congressman Ryan to deliver for our officers and to the residents and visitors of the Town Poughkeepsie.'

"This funding is evidence of

Congressman Ryan's strong commitment to public safety, and will go a long way towards helping law enforcement deal with the many issues facing our communities today," said Dutchess County Sheriff Kirk Imperati. "I would

like to take this time to thank Congressman Ryan not only for this, but for all of his efforts in support of law enforcement and community safety."

According to the Sheriff's Office, at this time Vance has been charged in Dutchess County as a fugitive from justice, and after being processed she was arraigned before the Town of Hyde Park Court and remanded to the Dutchess County Jail pending extradition proceedings.

Questions about the homicide charge itself and/or the details of that case should be directed to the Neshoba County Sheriff's Office in Mississippi at 601-656-1414.

As with any criminal case, the charge described above is merely an accusation and Vance is presumed innocent until proven guilty in a court of law.

Beulah Gay Jackson August 3, 1930 - January 15, 2024 Beulah Beatrice Gay Jackson, 93, from Beacon, New York, passed away due to natural causes on January 15th, 2024. Beulah was born to Richard Gay and

Beulah was born to Richard Gay and Mamie Jones Gay in Surrey, Virginia. As a young child, her family moved to Poughkeepsie, New York, where she attended local schools and churches. During her high school career, Beulah learned bookkeeping which served her well after graduation and throughout her life. She made history shortly after graduating high school by becoming the first Black person to be employed as a bookkeeper in the city of Poughkeepsie, securing a position at United Cleaners. Additionally, she offered tax preparation services for individuals and small busi-

nesses

Beulah married Virgil Jackson on May 11th, 1951 and moved to Beacon, New York. Thereafter, she gave birth to six children: Patricia Ann, Valerie Brenda, Virgil Brent Jr., Sheryl Lynn, Carla Jean, and Lynette Denisia. They fostered one child, Lori Beth Shank Wilson. As a young mother Beulah babysat in her home to dozens of children whose parents relied on her services so that they could earn a living. It's estimated that Beulah babysat well over 200 children over a span of 20 years! As a caregiver, she was a firm and structured teacher. To the parents she was an adept listener, encourager, confidant and friend

A church goer and devoted civic servant leader, Beulah and her family were amongst several Black families who attended and integrated St. Andrew's Episcopal Church in Beacon. She joined the women's guild and participated in planning events, church celebrations and was politically active there. Beulah later became a member of Star of Bethlehem Baptist Church and joined many committees such as the Missionaries and Pastor's Aide Ministry, the Pastor's Anniversary Committee, the Church Anniversary Committee, Birthday Tea Committee. She was a Financial Secretary and Sunday School Teacher.

She was a lifetime member of the Beacon-Fishkill Branch of the N.A.A.C.P. where she was president for 9 years. She was a member of the Les Soeurs Amiable Civic Club and devoted close to 60 years of her life to the Empire State Federation of Women's Clubs, which is an affiliate of the National Association of Colored Women's Clubs, Inc. Over the years she held many positions within these organizations including President, Vice President, Treasurer, Secretary, and Financial Secretary. She was active in the Beacon City School District as a Classroom Mother and also a past President of the Sargent School PTA where she worked to transition Black children from the Forrestal Heights housing development into the newly opened Sargent School

housing development into the newly opened Sargent School.

Together, Beulah and Virgil served their community through their involvement in organizations and civic work. They attended Beacon City Council meetings and brought back information to the community. They pushed back when they learned that federally funded Urban Renewal would eliminate the Black community in the West End of Beacon. Beulah was gifted with foresight and perception and understood the politics surrounding community decisions. She used her gift of communication to enlighten her neighbors as to what was going on. Amongst other initiatives, they were involved in voter registration drives and networked with organizations to help youth in Beacon. Together, Beulah and Virgil helped young adults start their careers by providing information for jobs and handing out job applications. Beulah sat on several boards including the Magnet School Committee, the Board of Education's Health and Wellness Committee, Martin Luther King Community Center, Planned Parenthood of Dutchess/Ulster Counties, Beacon Youth Board of Appeals, Human Relations Committee, Chairperson of Advisory Board of Multi-Services Center and the Mid Day Meal programs for Senior Citizens

of Multi-Services Center and the Mid Day Meal programs for Senior Citizens.

Beulah served as the Director for the Office of Economic Opportunity (O.E.O.) which served Dutchess County. It was established during the administration of President Lyndon B. Johnson to serve impoverished American citizens in cities and rural areas. They helped people learn new skills and acquire jobs and was affiliated with Job Corps and Vista, now Americarp. It was abolished under President Reagan. Under Beulah's direction the Beacon Head Start Program was started. Proudly, it's still in existence and throughout the wars has served many, many children.

years has served many, many children.

Beulah is predeceased by her husband, Virgil Jackson, Sr., and her son, Virgil Jackson, Jr., sisters Margaret Hargrove and Edith Branch and brother Arbie Gay. The updated identity will allow the organization to expand its outreach and add new project areas, all while continuing to grow its ECHO Autism Anderson: Education program, which has been building capacity for schools since 2022.

Executives at Anderson report that the online learning opportunities through ECHO Autism Anderson will now be even more accessible to people from all over the world - and that Anderson Center for Autism is better positioned to promote Project ECHO's work to support inclusive, equitable education and lifelong learning, which are among the United Nations' Sustainable Development goals.

ECHO Autism Anderson offers online sessions on a number of topics throughout the year to professionals looking to learn, collaborate, have cases reviewed, or discover ways to deliver evidence-based practices. All sessions are conducted virtually, and attendees can have questions answered in real time, regardless of their location.

Patrick Paul, CEO/Executive Director of Anderson Center for Autism, said "ECHO Autism Anderson: Education has been very well-received and successful in supporting colleagues in the field. It allows professionals from all over the world to continue refining their teaching methodologies by engaging in critically important dialogue with experts from Anderson. And by harnessing the power of the iECHO platform, our team can remotely train people from districts that cannot afford to hire the specialists needed to support the unique needs of their autistic students. That said, we are really doing more than offering professional development opportunities; we are helping to address disparities that exist in society, and supporting students, teachers, school personnel, and families worldwide. Kristin Sohl MD, FAAP, Executive Director of ECHO Autism, expanded that initial ECHO® model to the autism community. The pediatrician, who has extensive experience in neurodevelopmental disorders, serves as site principal investigator for the Autism Intervention Research for Physical Health/Autism Treatment Network (AIRP/ATN) and is the founder of ECHO Autism. Since inception, fifteen states and five countries have partnered with ECHO Autism to build capacity in order to better care for autistic individuals in their communities.

According to ECHO Autism's website, "ECHO Autism takes the principles of ECHO and adds the components of interdisciplinary expertise, including the integration of parent expertise. Our interdisciplinary team advises providers across the country and even internationally to support best practices in autism care for medical, behavioral and education concerns. This innovative system allows professionals and caregivers to increase their confidence in identifying and treating autism and expand their knowledge about treatments and solutions."

ECHO Autism Anderson: Education sessions are all run by a 'HUB Team', which includes specialists such as a licensed psychologist/behavior analyst, a speech and language pathologist with feeding expertise; a licensed clinical social worker, and others who share very specific experiences and insights. During each session, school personnel present cases that are reviewed by the HUB team, and participants can pose questions that will help them better understand how to apply best practices in the context of their individual situations. Future project areas would likely follow a similar model to

this ECHO education program.

Anderson Center for Autism will fund twelve ECHO Autism Anderson sessions in 2024.

DiNapoli: State must do more to address nursing home pandemic issues

The state Department of Health (DOH) has made limited progress in addressing the widespread failures identified in a March 2022 audit of the state's response to the COVID-19 outbreak in nursing homes, according to a follow up report released today by New York State Comptroller Thomas P. DiNapoli.

The initial audit found the state was unprepared to respond to infectious disease outbreaks at nursing homes, even before the pandemic, under the previous administration. Also, the state's persistent underinvestment in public health over the past decade may have limited DOH's ability to prepare and respond in the most effective way. If DOH had better data, accurate information systems, and an established system of proactive infection control for facilities prior to the pandemic, it could have helped facilities be better prepared. Auditors also determined that DOH gave the public inaccurate COVID-19 death tallies and undercounted those deaths as the Executive took control of public updates on the pandemic.

"The COVID-19 pandemic devastated families and left many whose loved ones contracted the virus in nursing homes with unanswered questions," said DiNapoli. "Last year, my office examined the extent to which residents in New York's nursing homes were not adequately protected and the state's shortfalls in managing the outbreak. Our follow-up review shows limited progress in fixing all that went wrong.

Much more work must be done to address problems that still exist to this day. We have to learn from past mistakes, or we risk repeating them."

Of the four recommendations to DOH in the initial audit, one was fully implemented, one was partially implemented, two others were unaddressed, and one recommendation to the Governor was partially implemented.

The initial audit recommended:

 DOH expand its use of infection control data to identify patterns and find ways to improve infection control practices and nursing home surveys, among other recommendations. Status: Partially implemented. Auditors found that some improvements in data quality were made. They compared DOH's publicly reported nursing home resident deaths from COVID-19 as of May 16, 2023, to its internal documentation and determined the data sets matched, which was not the case for nearly the entire scope of the initial audit. However, due to data limitations auditors were unable to test the completeness or accuracy of the data. Moreover, DOH has yet to fully use infection control data to detect or identify emerging infectious diseases to shape policies or develop an outbreak management system. Officials said they were strengthening their collection, use and analysis of data but did not provide specifics. DOH also did not provide supporting documentation, such as meeting minutes, to show it has strengthened communication and coordination with localit ies and epidemiologists.

• DOH help facilities understand how to correctly submit information into the Nosocomial Outbreak Reporting Application (NORA) and maintain support for data submitted on Health Electronic Response Data System (HERDS) surveys to improve data quality, consistency and accountability. Status: Not implemented. DOH has not provided any new guidance to facilities on NORA submissions or support for data submitted on HERDS surveys. Because the initial audit found infections and outbreaks were significantly underreported in NORA, and inaccuracies in nondeath COVID-19 data in HERDS, auditors urged DOH to guide facilities on submitting data. DOH's failure to act on this recommendation means it is likely still collecting, reporting and analyzing data that is inaccurate, inconsistent, and incomplete.

• DOH should improve controls over additions and deletions from the Centers for Medicaid & Medicare (CMS) database and determine if publicly reported nursing home survey data is reliable. Status: Not implemented. Auditors tested data in the initial audit and the follow-up and found a significant number of discrepancies, which means that not all publicly reported data is reliable. The reliability of this data is critical because it is used


by the public to make decisions about nursing homes.

• DOH evaluate and request resources as necessary to adequately address public health emergencies. Status: Implemented. DOH conducted a needs assessment and requested 74 new staff positions. 55 are currently filled.

 The Governor should assess and document the adequacy of the internal control environment at DOH and the Executive Chamber and take steps to fix it. Status: Partially implemented. According to the Executive Chamber, it has required state agencies to develop transparency plans and post data online. It is working with health providers to collect operational information and has encouraged DOH to improve communication with stakeholders to address concerns about public disclosure of COVID-19 information. It has appointed a new leadership team at DOH. who have restructured the flow of information. However, the Executive Chamber did not provide detailed information to support that it had assessed the internal control environment.

A separate independent review is under way at the direction of the Executive. The review, conducted by an outside contractor, is evaluating the state's response to the COVID-19 pandemic. Once public, this review may also give families more answers and help improve accountability.


There is a Blacksmith Shop on the Brinckerhoff House Historic Site off North Kensington Road in East Fishkill. The shop recently had renovations completed.

All the masonry work was done by a local resident, Jeff Boalt. Boalt is a third-generation mason, said Soedler.

"We used reclaimed bricks that were donated by the Reverend Doug Leonard of the Hopewell Reformed Church. The roofing was installed by Bob Patrick of Sunset Construction," he remerked

Sunset Construction," he remarked. Soedler explained, "Blacksmiths were one of the most important trades during the early days of our country up until the early 1900s." He continued, "Anything that was made of iron was made by and repaired by a blacksmith. When the Industrial Revolution began, the Blacksmith was still an important part of any community. Especially as settlers went west. Blacksmiths also made and repaired carriages and wagons."

County to offer free rabies clinic

The Dutchess County Department of Behavioral & Community Health (DBCH) is partnering with the Dutchess County SPCA to host a free rabies vaccination clinic for pets on Feb. 24, from 8 a.m. to noon, at the Dutchess County SPCA, located at 636 Violet Avenue in Hyde Park. This clinic is open to dogs, cats, and domestic ferrets 3 months of age and older. Advance registration is required and \ opened on Wednesday, Jan. 24. Residents can register at DCSPCA.org or by calling the DCSPCA at 845-452-7722, ext. 425.

The clinic is free for Dutchess County residents; non-residents will be charged a fee of \$10 per pet vaccinated. All dogs must be on leash, and cats and domestic ferrets must be in carriers. Vaccinations will be good for three years for pets with proper proof of a prior immunization. For those without proof, the vaccination will be good for one year.

Rabies vaccinations are required by New York State law for all cats, dogs, and domestic ferrets by the age of four months of age. Pet owners are required to revaccinate on a regular schedule to keep the animal properly immunized against the rabies virus.

DBCH diligently investigates and monitors rabies exposure cases

throughout the county. In 2023, 95 animal specimens were tested, 729 people were evaluated for rabies exposure with 109 people treated with post exposure prophylaxis.

The County offers three to four clinics each year. In 2023, more than 400 pets were vaccinated through these clinics and DCBH's community partnerships.

DBCH is available 24/7 to assist with any questions or concerns regarding potential rabies exposure to people or domestic animals. Pet owners should report to DCBH any incident in which their pet has been bitten by or has an open wound exposed to the saliva or nervous tissue of a domestic or wild animal. Staff will investigate and advise the pet owner of any necessary steps they should take to ensure the safety of their animal.

Residents who see an animal acting strangely are advised to contact their local police agency. If a person has been bitten, or a domestic pet is bitten or is in contact, with any animal, they're to contact DBCH immediately at 845-486-3404 Monday through Friday 9 a.m. to 5 p.m.; or 845- 431-6465 on nights and weekends.

Chicken Pot Pie

Puff pastry makes this version flaky, in the very best sense of the word.

I love cooking when it's cold outside. I think it has a fair bit to do with being in hibernation mode and finding comfort in all things home and cozy but, for me at least, there's more to it than that. There's a certain soul-soothing quality in the rhythms of cooking like stirring, kneading, measuring and dicing, especially when it's chilly, damp and dark outside.

I've been cooking a lot lately and it's hardly a chore. Long before I started writing this column, I had fallen in love with all aspects of preparing food, from planning menus and creating recipes to plating and serving. Admittedly, as time went by, I started taking it for granted and some of the passion I had for it got lost in the shuffle of balancing a busy life. Because it happened gradually, I didn't really notice what was going on. What I did notice was that cooking was becoming less of a creative outlet and more of a necessity I didn't always carve out enough time for. Crazy work schedules were not conducive to set routines, and so food became almost an afterthought.

Over the past year, changes in our work lives and schedules made it necessary for all the planning, shopping and cooking to fall to me and I realized how I'd let the joy of it all slip away and how much I'd missed it. But now I'm back in the groove of planning meals for the week, challenging myself to

come up with new takes on old favorites and making the most of every bit of food I buy, and it's rewarding and fun.

I am happy to say I fell back into it easily, so maybe it never really left me. Life has a funny way of diverting us away from the things that matter, the little things that bring us joy and feed our creativity. Just as it was once upon a time, now while I'm cooking I have no sense of time in the best of ways because, before I know it, I'm done and have something delicious in front of me with little memory of the process.

Such was the case the other night when I found myself in the kitchen ready to make a dinner I'd planned. On the menu was a comforting favorite – chicken pot pie – but I was suddenly inspired to change up what I usually do. I had enough things on hand to adapt my usual recipe. I was about to make the classic pie crust I always use when I suddenly remembered the puff pastry I had in the freezer, and before I knew it, I was pulling a new version out of the oven. It was a last-minute decision that had me over the moon and anxious to share.

INDIVIDUAL CHICKEN POT PIES

I've made pot pie in both casserole form with biscuits on top and the classic two-crust version. The decision to use puff pastry rather than pie crust lent itself to making individual pies in bowls, and this is my new

favorite. There's no bottom crust to get soggy, just a flaky top crust over the rich, creamy filling, which is made easier with pre-cooked pulled rotisserie chicken and frozen mixed vegetables, saving time without sacrificing flavor.

You will need ramekins or oven-safe bowls – I used 2 bowls, one for each pastry sheet, and had enough filling and pastry scraps left for one 14oz ramekin, too.

INGREDIENTS

- 1 package frozen puff pastry (I used Pepperidge Farm), thawed to almost room temperature
 - 5 tablespoons butter
- 1 medium onion, chopped
- 2 cloves garlic, minced
- 1/3 cup flour (plus more for rolling out the pastry)
- 2 1/2 cups chicken broth or stock
- 1 (10oz) package mixed frozen vegetables (like carrots, green beans and corn)

1/4 cup cognac or dry white wine (optional) Salt and freshly ground pepper to taste (start with 1/2 teaspoon each)

1 tablespoon dried oregano and/or thyme 1/2 cup heavy cream

1 egg (for wash)

METHOD

Preheat oven to 425 degrees. Line a baking sheet with foil and set aside.

Dust work surface with flour and unfold one sheet puff pastry on top. Dust pastry with more flour and roll to about 1/8" thick, smoothing out creases from the folds. Invert bowl or ramekins on pastry and use a knife to cut rounds 2 inches wider than their circumference. (The bowls I used only allowed one per sheet, but I saved and rolled out the scraps for an extra, 14oz ramekin. Bonus!) Place rounds on foil or parchment and pop in the fridge while you make the filling.

Melt butter in a large skillet over medium heat. Add chopped onion and garlic and sauté until onions are golden, about 8 minutes, stirring occasionally. Add frozen vegetables and flour and cook, stirring constantly, until mixture is coated, about

2 minutes.

Add broth, cognac or wine (if using) and salt and pepper. Stir to combine and bring to a boil. Reduce heat and simmer until thickened, 4-5 minutes more.

Remove from heat and stir in cream, herbs and chicken. Give it a taste and add more salt and pepper, if needed.

Take pastry out of the fridge. In a small bowl, whisk together egg and 1 tablespoon water. Ladle filling into bowls/ramekins (about 3/4 full). Brush rims of bowls with egg wash and place pastry rounds on top, pinching edges all around to secure. Brush pastry tops with egg wash. Cut slits in the pastry to vent steam (I cut 3 around the edges and an "x" in the center).

Place bowls on prepared baking sheet and bake until tops are puffed up and golden brown, 20-25 minutes (check after 20). Eat with a spoon and be sure to tear off any overhanging crust, adding it to the filling so you don't waste a single buttery bite!

The night I made these I was recovering from a nasty cold and wasn't overly hungry. I hadn't eaten much while I was sick, but once these were out of the oven, the look and aroma had me digging in and before I knew it, I'd downed the whole bowl, curled up in my comfy chair with a soft blanket as an icy rain pelted the windows. It made me feel better inside and out, in equal measure because it tasted good and warmed me up just as it reminded me how much better things are when we infuse them with love and passion, truly food for the soul. Enjoy!

Why Uruguay?

It's the safest bet for visitors to South America who don't speak Portuguese.

Every January, Sue and I try to visit South America. It's getting harder these days, with unrest returning to Colombia, Ecuador, Chile and Peru. Argentina is a mess, Bolivia is too high (I get altitude sickness), and forget about Venezuela. Brazil is ranked as one of the world's safest countries, but we don't speak Portuguese. That leaves Uruguay, for our ninth trip south of the equator.

Sue picked a quaint town called Piriapolis, an hour's bus ride east from the capital of Motevideo. The idea was to relax on the beach. Sue was afraid I'd get bored, with nobody trying to rob us, and no weird foods to eat, although I did get to try bunuelos de algas – deep fried seaweed. We rented a Hobie sailboat, rode bicycles along the boardwalk, climbed a 2,000-foot mountain and swam in the ocean.

One morning we walked five miles along the beach to SOS Rescate de Fauna Marina, Uruguay's premier marine animal rescue and rehabilitation center. Over the past several decades, dead penguins have been washing up on the shores of southern Uruguay and Brazil. Ricardo Tesore founded the nonprofit SOS in 1990 to help the penguins that were still clinging to life. Evidently they've been starving, brought about by over-fishing and climate change.

Last summer, an outfit called Science Alert counted more than 2,000 dead penguins, mostly juveniles, that had no fat reserves and empty stomachs. Unfortunately, little action has been taken to ensure the sustainability of the Magellanic Penguins' main food sources of anchovies and sardines.

Ricardo's son Diego Tesore, who's been volunteering at the family-run operation pretty much since the day he was born, showed us around. A sea lion was in rehab, recovering from a run-in with a group of delinquent kids who pelted him with rocks. Sea turtles were in holding pens, soon to be released in a remote area. It seems that tourists are always throwing them back into the ocean, not realizing that the turtles have crawled on to the beach to warm up.

By the way, the tourists in Piriapolis are from Buenos Aires, Argentina, where there are zero beach resorts and a shattered economy.

To lighten the mood, Diego entertained the six people in our group with a few trivia questions:

• Name the twelve countries with native penguins, all in the southern hemisphere: Argentina, Chile, Uruguay, South Africa, Namibia, Australia, New Zealand, Brazil, Ecuador (the Galapagos Islands), Angola, Mozambique and Peru. I mentioned the Falkland Islands, but Diego claims it's part of Argentina. And Antarctica is not a country.

• What is earth's oldest living animal? Elephants and tortoises are not even close. Sue guessed "coral," which turns out to be number 3. I said "sponge," which is number 2 at 10,000 years old. Hydra and Jellyfish are the oldest; in fact, according to Diego, they never die.

The next day, Sue and I visited Estacion de Cria de Fauna y Flora Autoctona (Native breeding center). A nature path led us through native woodlands of erythrina and imported eucalyptus. (80% of Uruguay's land is covered in prairie grass.) The most recognizable native animal is the cabybara, the world's largest rodent. We also saw wild tegu lizards, the ostrich-like rhea birds and flocks of Monk's parakeets.

Back in Motevideo the day before our 15-hour flight home, we stopped at the sprawling indoor mercado for thick Uruguayan steaks grilled on the parilla. And of course the obligatory visit to the Hard Rock Cafe, curiously devoid of patrons on a Friday afternoon.

Don't miss Sue's seminar, "What Do Your Flowers Say Today?" at Paula's Runway Cafe, 2 p.m., Sunday, February 11. Sue will be giving flower readings after a brief discussion of her book.

Also, I will be performing at the 16th



National Park Service invites public comment on proposed entrance fee increase at Hyde Park national historic sites

The National Park Service (NPS) is proposing to increase the entrance fee at the Home of Franklin D. Roosevelt National Historic Site and Vanderbilt Mansion National Historic Site to support projects that benefit visitors and protect park resources.

The increased fee revenue will allow the parks to address preservation needs of the homes, which is critical to ensuring the conposal, the current entrance fee of \$10 per Comments must be submitted online adopt this fee increase to maintain consis-

individual 16 years and older would increase to \$15 person. Those 15 years old and younger would still enter for free.

The proposal also includes a new yearly park specific pass for both the Home of FDR and Vanderbilt Mansion for \$45. The new entrance fee would go into effect in May 2024 and be required year-round for entrance into the historic houses. The NPS is requesting feedback on the entrance fee

through the NPS Planning, Environment, and Public Comment website at https://parkplan ning.nps.gov/hyde parkfeeincrease.

The proposed increase would make the Home of FDR and Vanderbilt Mansion national historic sites' entrance fees consistent with historic sites, museums, and other cultural institutions in the Hudson Valley. The Franklin D. Roosevelt tinued enjoyment and long-term preserva- increase during a 30-day public comment Presidential Library and Museum, operattion of these significant sites. Under the properiod that will be open through Feb. 16. ed by the National Archives, also plans to tent fees at the FDR sites.

This fee increase would occur in concert with an increase at Sagamore Hill National Historic Site in Oyster Bay, N.Y. The previous entrance fee increase at the Home of FDR was \$1 in 2018. The previous entrance fee increase at Vanderbilt Mansion was from \$8 to \$10 in 2013.


Both national parks in Hyde Park retain 96.5% of their entrance fee revenue which, by law, must be expended on improving, preserving, and maintaining park resources and programs that directly benefit park visitors.


Over the past five years entrance fee dollars have funded trail maintenance, the preservation of historic structures, gardens and landscapes, and the care and conservation of historic furnishings in the homes. The National Park Service cares for special places saved by the American people so that all may experience our heritage.

The entrance fee increase would not change the National Parks and Federal Recreational Lands Passes that are valid for entry at national parks, including the Annual, Senior, Access, 4th Grade, Military

Annual, and Military Lifetime passes. More than 20,000 National Park Service employees care for America's 428 national parks and work with communities across the nation to help preserve local history and create close-tohome recreational opportunities. Celebrate Black History Month at the Poughkeepsie Public Library District with one of the many events honoring and exploring Black history and culture! There will be interesting and fun events celebrating music and literature, and discussions of Black history and modern political issues.

On February 3 at 2:30 p.m. at the Cunneen-Hackett Arts Center, the Souls United Choir of the Hudson Valley, an interfaith gospel choir, will perform music from their repertoire consisting of Christian, Bahá'í, and other faith traditions reflected by the choir's membership. No registration is required for this event.

Take in the history of the Black Civil Rights movement on February 8 at 10:30 a.m. or 2:30 p.m. at the Franklin D. Roosevelt Presidential Library & Museum. Join the museum curator for the "Meet the Curator Exhibit Tour: Black Americans, Civil Rights, and the Roosevelts." Developed in collaboration with a distinguished committee of scholars, it centers the historical voices of many Black community leaders, wartime service members, and ordinary citizens who engaged the Roosevelt administration directly and pushed for progress.

Teachers often face challenges when discussing race in an educational setting, which will be explored in a talk by Michael Reyes Salas, an Assistant Professor of Africana Studies at Vassar College. "International Demands for Educational Reparations: Memory Laws and Black History," on February 8 at 6:30 p.m. at Adriance Memorial Library, explores how elected officials have manipulated academic programming of the Black Studies curriculum to suit their political agendas. Explore the coming-of-age stories of Black women on February 8 at 7 p.m. for a virtual book club featuring Hot Comb by Ebony Flowers, a look at Black women's lives through a hair salon, with stories covering experiences such as a girl's first perm and the stress of being the only Black player on an otherwise white softball team.

He will explore the story of the Black pilots who, though once devalued by the World War II effort, proved they could take down enemy aircraft abroad and racial barriers at home.

Understand the tradition of Hoodoo Medicine on February 15 at 6:30 p.m. with "Root Doctors & Hoodoo Medicine," a virtual program led by Dr. Yvonne Chireau. She will discuss stories of Hoodoo medicine, illnesses, and healing traditions that abound in Black history. These stories reveal the knowledge and ancestral wisdom of Black people in poignant and powerful ways. Dr. Chireau will share historical accounts of Hoodoo and rootworking as forms of traditional healing that were utilized to give meaning to bodily suffering for African American people with rituals, material formulations, and the skilled repertoire of practitioners in enslaved communities.

Join the Books & Brews book club on February 21 at 7 p.m. at Juan Murphy's Pub in Poughkeepsie to discuss "All About Love: New Visions" by bell hooks. hooks writes about a proactive new ethic for a society bereft with lovelessness, a lack of care, compassion, and unity. No registration is required for this event.

For kids, there is a scavenger hunt that runs through February 29 at Sadie Peterson Delaney African Roots Branch Library, where kids can have fun looking for nine innovations created or improved upon by Black inventors that are hidden around the library, while also learning about each of those inventors.
