The Wappinger community will have a chance to celebrate the Town's sesquicentennial throughout 2025. The year-long celebration will commemorate the 150th anniversary of the founding of the town.

"Wappinger150 will be a year-long celebration, filled with exciting monthly events and activities that highlight the rich history, vibrant community, and future of our town. We invite all of our residents to join in this special celebration and take part in what promises to be a memorable year for all," said Town of Wappinger Supervisor Joseph Cavaccini.

The kickoff event was S'mores Fest, which was held at Brexel-Schlathaus Park, though it had to be postponed for a week due to the weather. The family-friendly event featured a variety of s'mores, a bonfire, live music and hot cocoa on Jan. 31.

### Castle Point temporarily closes Acute Inpatient Unit

Earlier this month, the Castle Point VA Medical Center temporarily closed a portion of the facility.

"Beginning February 1, Castle Point VA Medical Center in Wappingers Falls closed a section of its facility – the acute inpatient unit – for 120 days as part of an effort to re-evaluate staffing needs. Patients with acute medical conditions will continue to be treated in urgent care, and those requiring hospitalization will be sent to the nearest community or VA medical facility," stated David Marshall, LCSW, Executive Assistant to the Director at VA Hudson Valley Health Care System, via email to Southern Dutchess News on Feb. 4.

"This is outrageous, and a fundamental breach of the sacred duty we have to care for our veterans who've put their lives on the line for our country," said Congressman Pat Ryan in a press release on Feb. 4, which included local, state and federal leaders' statements. "Our community has always taken up the call to have our veterans' backs, including just a few years ago when Castle Point was under threat of complete closure. Now is the time for all of us to stand up and FIGHT alongside our veterans with urgency again. We need to be loud, we need to be strong, and we need to be direct: this unit must be reopened immediately."

Congressman Mike Lawler also commented in a statement. His partial statement reads: "Our veterans didn't make the incredible sacrifices they did to be short-changed in services here at home." Lawler added, "I'm proud to join a bipartisan group of elected officials demanding that this facility stay open - anything less is unacceptable."

Dutchess County Executive Sue Serino said in the release that she was "deeply disturbed" by the temporary closure.

Serino noted, "It isn't just a facility; it's a lifeline for our veterans between Albany and the Bronx, especially for those here in Dutchess County. I know firsthand that this unit saves lives, providing critical inpatient care and preparing veterans for rehabilitation. With so many already facing barriers to mental health support, this decision puts our heroes at even greater risk."

Then in 1957, Tony began working for Central Hudson Gas & Electric Corp. Later, Lucy began working for Central Hudson too. It was there that they met and went to the company's Christmas party.

"I tell him that was his lucky day," Lucy said laughing.

Their first date was to see a movie at the movie theater in Poughkeepsie.

"No, I didn't think I was going to marry her," said Tony, and then he added, "I had an idea though."

"I didn't think I was going to marry him either," remarked Lucy.

Tony did return to Italy for a short while.

Lucy added, while smiling, "When he came back, he knew there was no one better than me."

"That's right," replied Tony.

They had approximately 150 people in attendance at their 1965 wedding. The wedding ceremony took place at St. James Roman Catholic Church in Milton, in Orange County. The reception took place in Hyde Park. "We had a good crowd," said Tony, who was 31 years old when he got married.

"Oh, it was a sunny day," said Lucy, who was 24 on her wedding day.

Tony noted it was drizzling the morning of their wedding.

After the reception, the newlyweds left by train to New York City. They then took a flight the next morning to Florida for their honeymoon.

"I got a terrible sunburn," said Lucy, who noted Tony's skin tans and does not sunburn.

The couple have two sons, Anthony and Joseph "Joe." Anthony is a doctor and lives in Seattle with his wife, Megan. He is a graduate of the University of Notre Dame. Joe is an Audit & Insurance partner at a leading accounting firm. He also graduated from Notre Dame. Their grandson Nicholas, who is a Syracuse University graduate, works and lives in New York City.

Tony and Lucy both said they wanted to have their children graduate from college. "Anthony always wanted to be a doctor," said Tony.

"We're proud of both of them. They did very well," said Lucy.

They still live in their Wappingers Falls house Tony built for them. Tony retired after 39 years with Central Hudson. Lucy still works part-time for a local auditing company. "They treat me so well. I can't leave; that's the problem," she remarked.

"I wouldn't change him for anything. If I had to do it all over – I wouldn't change a thing," said Lucy.

Tony agreed, "I wouldn't change it either."

Lucy said her advice to couples getting married this year is to "love each other but respect each other. And to pretty much have the same values – that's very important." She continued, "I know there's going to be arguments, but you should make peace before you go to bed." One's faith is also important, she said.

"Despite the cold, our community came out of hibernation to see friends and enjoy some wintertime socialization!" said Cavaccini. "Great work to our Parks and Recreation team as well as our volunteers from the New Hackensack Fire Company for helping us make tonight a memorable one!"

Next up will be the Wedding Vow & Renewal Ceremony on Valentine's Day, Friday, Feb. 14, at the Wappinger Senior Center, from 10-11:30 a.m. Cavaccini will lead the couples in the ceremony. visit [TownOfWappingerNY.gov](#) to RSVP or call 845-297-2744.

Cavaccini said about the formation of the Wappinger, "We actually succeeded from the Town of Fishkill." The Town of Fishkill, said Cavaccini, was geographically larger at the time and everyone "came around by horse and buggy," which created long distances between Point A and Point B. Wappinger was incorporated in 1875.

At the time, they then created "our form of government," said the supervisor. "It was a number of individuals involved," he said.

The first Wappinger Town

Supervisor was James A. Seward. Cavaccini is the 30th supervisor of Wappinger. He is using the desk of former supervisor Louis Diehl. Seward was elected to office in 1876.


"It was just 5,000 people in the town back then. Now, it is one of the most populous towns in the county," remarked Cavaccini.

According to the Town of Wappinger website, "Wappinger takes its name from the Wappinger or Wappani Native Americans who lived along the east side of the Hudson. The Town is home to 28.5 square miles of quiet neighborhoods, [five-star] dining, premier shopping amenities, breathtaking natural sites, fascinating history, exceptional schools, and so much more. Made up of the non-incorporated hamlets of Chelsea, Hughsonville, New Hackensack, Swartwoutville, Myers Corners, Middlebush, Diddell, and Fowler House; and ¾ of the incorporated Village of Wappingers Falls; the Town of Wappinger has a distinct character based off of its rich and unique past."

"In 1659, Wappinger became the first settled geographical area in Dutchess County, when Christian settlers from the Massachusetts Bay Colony came here in hopes to seek religious freedom. The locality of the first projected settlement in the county was at the mouth of the Wappinger creek in the year 1659..."

Wappinger Councilman Al Casella told Southern Dutchess News, "I chose to move to the Town of Wappinger in 1991 because it was a great place to start a family. I've been here ever since and am very proud to represent the 4th Ward as its councilman. Wappinger has a rich heritage, and it is with much pride that we celebrate 150 years of this wonderful town."

According to the Town of Wappinger website, "In 1939, Dutchess County resident and President Franklin Delano Roosevelt launched his New Deal and created commissions to get the nation out of the Great Depression. He used Dutchess County as his "guinea pig" for many of his Works Progress

Administration projects some of which are located here in Wappinger. The Village of Wappingers Falls police station was originally built in 1940 as a post office personally designed and approved by FDR himself." President John F. Kennedy and President Donald Trump each visited while on the campaign trail in 1960 and 2016 respectively. Both landed at what is now the Hudson Valley

Regional Airport.

"We're very excited to celebrate the sesquicentennial year of the Town of Wappinger. The idea was to offer an entire year of activities," said Cavaccini.

In May, there will be the Unity Day—where community organizations will come together. The summer months will see a Music Festival and a new stage at the Brexel-Schlathaus Park. The events set for autumn will be announced closer to the event dates.

"On May 20th, the day the town was founded, Town Hall will be opened to recreate the [organizing] of the town," said Cavaccini.

The first time capsule for the Town of Wappinger will be buried during the year-long celebration. Residents and community members can use a "passport" to visit different parks and historic sites, that they can pick up one at Wappinger Town Hall.

Casella noted, "We continue to make major improvements to our parks to increase the town's beauty & quality of life."

Cavaccini said he hopes the town continues to grow. "Not in the sense of development, but in the sense of pride for the town we live in." He added: "I hope that what we build over the course of this administration will be felt for decades."

### Why does the Town of Fishkill need a police commissioner when there is a police chief?

**To the Editor:**

Approximately 5 years ago, the Fishkill Town Board, under the "leadership" of Supervisor Albra, rewrote a local law, to add the position of Police Commissioner, in addition to already paying for a Chief of Police. It seemed like overkill at the time. Why employ a Police Chief with a \$35,000 salary and then add another \$40,000 salary for a Police Commissioner? It was obvious there was a communication issue between Ozzy and the former Chief and the two could not get along. So, who does Ozzy appoint to this newly created position? A person who helped Ozzy win an Independence Party Primary and ultimately the November election for Supervisor.

Fortunately, following the 2021 election, after Brian Wrye, Carmine Istvan and I were first elected to the Fishkill Town Board, our first order of business was to eliminate this unnecessary position and wasteful expense. Fast forward to February 2025. Having won a November election, Ozzy's new team on the Town Board, once again rewrote our local law, and once again, created the position of Police Commissioner. But this time I am puzzled, because there shouldn't be any communication issues between the Supervisor and the new Police Chief. A person Ozzy recently promoted to Police Chief. (A person who I voted in favor of). So why the need for another Police Commissioner?

Ozzy's new Police Commissioner was recently on the November ballot as a candidate for the Town Board. A third-party candidate, basically giving the Democrat candidate a victory in the November election. This result gives Ozzy a 3-2 majority on the Town Board.

Ozzy and his new majority, passed over a highly qualified candidate (Louise Daniele). Louise is retired from the NYSP and recently served on the Fishkill Town Board for a 4-year term. Louise, Councilman Wyre and I all agree appointing a Police Commissioner at a salary of \$35,000 is a complete waste of taxpayer money. Louise offered to take on this responsibility at no charge. Unfortunately, Ozzy and his new majority did not agree. The "hiring process" has been called into question. Because Ozzy unceremoniously dismissed our former Director of Human Resources, the town does not have the ability to properly advertise for job openings. When Elon and DOGE complete their work in DC - they oughta make a pitstop here in the town of Fishkill.

### Town of Fishkill Police Commissioner position is 'redundant'

**To the Editor:**

I am deeply concerned about the direction of Fishkill under Supervisor Azem Albra, and other residents should be as well.

At the Town Board meeting on Feb. 5, a vote on a Police Commissioner was taken. This position is redundant, because we already have a Police Chief. Out of six candidates, only one was given serious consideration. Mr. Albra made a resolution at this meeting to have the law changed specifically to create this position. The other candidate present (Louise Danielle) not only offered to do the job for free but has a distinguished background in law enforcement as a retired State Trooper. Instead, the vote was cast by the Supervisor in favor of another candidate at a cost of \$35,000 to the Fishkill taxpayers per year.

Mr. Albra actually removed one of the three Lieutenants of the Fishkill Police Department command to create this position, leaving "boots on the ground" with one less active commanding officer, in an FPD already suffering from retention issues.

Of concern as well was the departure of the Fishkill HR director, who had to take the extraordinary measure of coming to a recent Town Hall meeting and was rebuffed because Mr. Albra refused to meet with her about her concerns. (source: Town Hall video feed). She was replaced with a legislative aide with no prior experience in human resources or set duties at a cost of \$50,000 to the taxpayers.

Mr. Albra has also been pushing the creation of a total unnecessary ward system, which would add two additional seats on the council as a cost of \$30,000 a year, plus the expensive cost to the taxpayers of holding a special vote for it. In fact, only 15 Towns in NYS have a ward system.

I greatly fear Fishkill is progressing to an autocracy under Mr. Albra, plus I feel overall he is staffing positions on nepotism factors instead of merit and creating a "good old boys" atmosphere.

# DC Sheriff's Office warns of money scams

The Dutchess County Sheriff's Office warns residents of Dutchess County and surrounding areas about scams that once again seem to be on the rise.

Scams are ways in which criminals will attempt to get money from people by contacting them and making up elaborate stories. In some cases the perpetrators have tried, sometimes successfully, to use the victim's emotions about a loved one in trouble to get money. It's common for the perpetrators of these scams to try to get money by telling people that one of their relatives has been seriously hurt or is in jail, and that they need money right away. In many cases they will pose as a law enforcement official or another relative to try and convince the victim that it's legitimate.

In the latest scam the perpetrators contact

the victim and tell them that their grandchild has been hurt or is in jail, and needs money right away. The victim then makes a hasty decision based on emotion to pay the money, then later finds out that their relative is fine and the money is gone.

The Sheriff's Office would like to offer the following tips to help people avoid these scams:

- If you're contacted by someone you don't know asking for money, for any reason, it's very likely a scam.

- If you receive correspondence from someone that you don't know and they instruct you to keep the matter confidential and not tell anyone about it, it's most likely a scam.

- Legitimate law enforcement would not attempt to satisfy a warrant or make promises.

es to avoid prosecution by soliciting money.

- If you receive an email about an order you haven't placed or asking you to send money call the company using a legitimate number. DO NOT follow the instructions in the email, click on any links in the email, or call the number provided in the email.

- If someone asks you to purchase merchandise, transfer money, provide bank information, provide remote computer access or enter a code given to you by them use caution as it is likely a scam.

- Do not meet up with someone that you don't know; if you're asked to do this it is surely a scam, and it is very dangerous as well.

- If someone calls you and tells you that a relative has been hurt or is in jail, confirm it first before sending any money. Call other relatives or a legitimate law enforcement agency for confirmation before any money is sent. If they're posing as a relative, try and contact that relative for confirmation.

- Sending money overseas is especially risky; use extreme caution.

- Ask the person for their call back number and ask to speak to their supervisor to confirm the info; if it's a scam they will most likely hang up at this point and the number they give you will be bogus.

- If a loved one has recently passed

away be wary; in some cases perpetrators have even preyed on victims by searching through the obituaries and calling surviving loved ones. If you get calls from people you don't know soon after someone passes away, be careful and confirm it before you send any money.

- In some cases someone will call and tell the victim that they've won money, but to "process the claim" they need to first send money. Beware this is most definitely a scam and don't send any money – you should never have to pay money to claim a prize. If it seems too good to be true, it most likely is.

If there's any doubt about a phone call/email/letter you've received contact the Sheriff's Office before sending any money.

Scams tend to increase during the holiday season, so be especially alert for them during those times.

It is very important not to send any money to anyone that you don't know until you've confirmed the situation through an independent source and feel comfortable with it. If it's a scam once the money is sent it's very difficult, and most times impossible, to get it back. If anyone thinks they may have been the victim of a scam they are encouraged to contact the Sheriff's Office at 845-486-3800 or via the tipline at 845-605-CLUE or dcsotips@gmail.com.

# Award-winning author to discuss WW II photograph, book at DCC

The Dutchess Community College Foundation (DCCF) will host an illuminating lecture by renowned historian Dr. Wendy Lower, supported by the Greenspan Trust-Handel Foundation Endowed Chair in Holocaust and Genocide Studies. The event will take place on Thursday, Feb. 13, at 7 p.m. in the James & Betty Hall Theatre.

Dr. Lower, the John K. Roth professor at Claremont McKenna College and director of the Mgrublian Center for Human Rights, will share insights from her 10-year investigation into a rare photograph that captured a harrowing moment in history—a family's murder in Ukraine during the Holocaust. Her research revealed the identities of the individuals in the image and uncovered new details about the atrocities of the Nazi regime, open-air massacres and efforts toward postwar justice.

Her findings, chronicled in the award-winning book "The Ravine: A Family, a

Photograph, a Holocaust Massacre Revealed," delve into the role of family and ideology in history. Dr. Lower is also the author of "Hitler's Furies: German Women in the Nazi Killing Fields," a finalist for the National Book Award.

It is facilitated by Dr. Werner Steger, DCC professor of history and recipient of the Greenspan Trust-Handel Foundation Endowed Chair in Holocaust and Genocide Studies. ## Two county men among park police graduates; Specialized units remain understaffed on state level

The Police Benevolent Association of New York State (PBANYS) member units ushered in 2025 with the addition of 64 new specialized police officers who recently graduated from the state's Environmental Conservation Officer, Forest Ranger, and Park Police Officer Academies.

However, New York's specialized state police units remain understaffed by more than 200 officers.

Local graduates of the programs include Scott Maynard of Pawling in the Environmental Conservation Officers 24th Basic School and John Menconeri of Wappingers Falls in the Office of Parks, Recreation and Historic Preservation Park Police 19th Basic School.

"We are extremely pleased that three of our member units recently graduated academy classes to help bolster the number of specialized police protecting New York's residents and natural resources, unfortunately 64 officers when you need hundreds more is just not enough," said PBA of NYS president Jim McCartney. "While the addition of 26 Environmental Conservation Officers, 29 Park Police Officers, and 9

Forest Rangers might seem like a lot, it is not enough to offset the losses in personnel experienced over the past decade from the state's failure to provide a competitive compensation and retirement plan for our members. As we explained to the state legislature during budget hearings, none of our academy classes were full, and even if they were, and graduated every candidate, we would still be below authorized staffing levels for our agencies."

Matt Krug, PBANYS vice-president, added, "The qualifications for Environmental Conservation Officers, Forest Rangers, and Park Police Officers are unique and stringent, making the pool of candidates we recruit from smaller than other state and local agencies. To ensure that New York State can recruit the most qualified and capable candidates it is essential that these highly specialized law enforcement roles be compensated with competitive pay and benefits including the standard 20-year retirement package offered to nearly every law enforcement officer in the state. Otherwise, we will continue to lose candidates and highly trained officers to agencies who recognize and respect their unique capabilities and

compensate accordingly."

Krug further observed, "While New York has made great strides in acquiring millions of acres of land to protect and passed some of the strictest environmental laws, they have not made a similar commitment to protecting these natural resources by investing in enough Environmental Conservation Officers, Forest Rangers, and Park Police Officers."

Current Environmental Conservation Officer staffing sits at 283 ECOs, with an authorized strength of 342, and there are currently 117 State Forest Ranger 1's in service while authorization exists for 129. Similarly, New York State currently has 243 Park Police Officers with a full authorized strength of 387. This translates to a total of 214 officers below authorized strength across the three units. When one considers the millions of acres of public lands, the hundreds of state historic sites and parks, and the tens of millions of visitors PBANYS members are asked to protect each year, these numbers are clearly inadequate to the task at hand and in some cases have remained

unchanged for decades.

The recent deployment of 10 New York State Forest Rangers to assist California in battling their wildfires underscores the critical need for these specialized officers. New York shares many of the same conditions and concerns regarding wildfires and we cannot afford to allow vacancies to continue. Our forests, and the safety of countless New Yorkers depend upon a fully staffed Division of Forest Protection.

The PBA of New York State welcomes the following officers to their new agencies with hopes that New York State will make the necessary investment in their careers to ensure their longevity and continued protection of our state's citizens and precious natural resources.

# Black History Month program to explore Economic Diversity of Dutchess County's Black Community in the 19th Century

In honor of Black History Month, Dutchess County joins the nationwide celebration of Black Americans' contributions. County Executive Sue Serino announced today the County's Division of History is sponsoring a free virtual event, hosted by the Dutchess County Historical Society (DCHS), on Thursday, Feb. 20 at 7 p.m. This presentation will discuss major new findings that reveal the economic diversity of the local Black community in the 19th Century.

Dutchess County Executive Sue Serino said, "The Black community has played an important part of Dutchess County's history, and we are proud to honor the community's ongoing achievements. This virtual educational event will talk about the economic differences in the local Black community during the 1800s – from the success of capitalist barons to the struggles of free

Blacks in the Civil War era. I encourage all residents to sign up for this insightful online presentation and explore how the local Black community helped shape Dutchess County."

Led by DCHS Executive Director Bill Jeffway, the virtual event, entitled "Navigating Wealth & Poverty: The Economic Diversity of Dutchess County's 19th Century Black Community," will explain how global trade and a Wall Street aristocrat intersected with local merchants and the working class through the tumultuous period of the 19th Century and U.S. Civil War. Through never-before-published diaries, virtual attendees will hear firsthand observations of the post-Civil War Black communities in Dover and eastern Dutchess County, in particular, where resourcefulness and adaptability played a crucial role in managing everyday challenges.

Registration for this free event is available at [dchsn.org/feb20](http://dchsn.org/feb20), and registrants will receive a Zoom link to join the event.

Among the local Blacks who will be discussed in the virtual presentation:

Jeremiah Hamilton, known as the "Black Baron of Wall Street" and the nation's wealthiest Black, made significant investments in Poughkeepsie, including Mansion Square and Union Landing, through his relationship with the Improvement Party.

Paul Cuffee was a celebrated and successful whaling captain with an all-Black crew. Recently discovered records detail his trading in a rare Brazilian wood for use at Poughkeepsie's dye factories.

Uriah Boston, who emerged as a member of the very successful and high profile Black middle class. A popular and successful barber, Boston invested

in his own local property, acquiring political gains as a result.

The Dutchess County Department of History works to preserve, study and promote the stories from Dutchess County's past; coordinate the Dutchess County Historical Community; and support other government offices and partner organizations in the continuing development of our county.

County Historian William P. Tatum III said, "The indelible mark that Blacks have made on Dutchess County and our history is both astounding and ever-evolving, and we are proud to recognize these contributions."

## Applications for Youth Opportunity Union (YOU) Drop-In Center Grants due by Feb. 28

Dutchess County Executive Sue Serino announced last week that applications are now open for the County's newly established Youth Opportunity Union (YOU) Drop-In Center Grants. First introduced in her 2025 Executive Budget presentation, this \$250,000 initiative will provide funding to create and enhance safe, welcoming spaces where young people can gather, access resources, and build supportive relationships.

"For so many young people, having a welcoming place to go outside of school — somewhere they can feel safe, build friendships, and access support — can make all the difference in their lives," said Dutchess County Executive Sue Serino. "These grants will help create and enhance spaces where kids can explore their interests, develop new skills, and form positive connections with mentors and peers. By investing in these opportunities, we're not just funding programs — we're fostering an environment where every child in Dutchess County can thrive."

The YOU Drop-In Center Grants are a one-time capital funding opportunity available to community-based organizations, local libraries, and other youth-serving nonprofits with a primary mission aligns with providing a service or administering a program consistent with one or more of the County's Path to Promise Domains. Eligible applicants can request between \$10,000 and \$75,000 for expenses that help establish or enhance drop-in centers where youth can engage in positive activities outside of school hours.

"We know that positive, enriching environments can have a profound impact on a young person's development," said Karmen Smallwood, Assistant Commissioner for

Youth Services. "The YOU Drop-In Center Grants give local organizations the resources they need to create safe, engaging spaces where youth feel supported and encouraged to reach their full potential. By investing in these centers, we are strengthening our community's ability to provide meaningful resources and connections that help shape a brighter future for our young people."

Eligible expenses include:

**Furniture and equipment** – Tables, chairs, couches, desks, bookshelves, and recreational equipment to make drop-in centers comfortable and functional.

**Technology and supplies** – Computers, tablets, printers, internet equipment, art and music supplies, board games, and other interactive materials that support youth engagement.

**Sports and fitness equipment** – Athletic uniforms, balls, weights, and other fitness-related gear to promote physical health.

**Theater and creative arts resources** – Stage lighting, sound equipment, costumes, and instruments that allow youth to explore creative outlets.

**Transportation assistance** – Funding to help youth access drop-in centers, ensuring they remain an accessible resources for all.

Organizations may not use grant funding for salaries, operational costs, fundraising efforts, or scholarships.

Applications are due by Feb. 28, at 4 p.m. and must be submitted through the Dutchess County Grant Portal. Awards will be announced in April, and grant funds must be expended by Dec. 31.

## Astor Services expands home-based crisis intervention program



Adam Roche, Director of Dutchess County Office of Veteran Affairs commented in the release. A portion of his statement stated, "This is absolutely unacceptable."

"As a Veteran who utilizes Castle Point services, and an advocate for Veterans in Dutchess County who are receiving services, I wholeheartedly disagree with this decision and the secretive nature around it," said Alyssa Carrion, Veterans Program Director, Veterans Services, MHA Ulster County, Pleasant Valley.


"This would be a disastrous decision for the thousands of veterans in the Hudson Valley who depend on the VA for healthcare. Our veterans desperately need more healthcare options, not less. They earned it. We can all agree our veterans have made incredible sacrifices for our nation, yet they are being given cutbacks and empty promises in return," said Tommy Zurhellen, Former Commander,

VFW Post 170 and Founder of VetZero, a veteran service program in Poughkeepsie, in the release.

"I'm very concerned about the recent decision to temporarily close the Acute Inpatient Unit at Castle Point VA Medical Center. This unit provides critical, lifesaving care to our veterans that is vital in preparing them for the next phase of treatment and rehabilitation," said Peter Maraday, Hudson Valley Regional Manager, Clear Path for Veterans, said in the release.

"Once again, we see Veterans living in rural communities subjected to potential cuts and closures at Castle Point. Directly affecting their healthcare and quality of life by reducing access to critical services. These cuts not only impact the Veteran, they impact the Hudson Valley," said Kevin Keaveny, President of the Hudson Valley Center for Veteran Reintegration.

Marshall stated, "This will not affect any of the other services provided to our Veterans, who will still be able to receive primary care, specialty care, outpatient



— in a world where their mission has grown more challenging and complex. On behalf of all New Yorkers, I want to thank the graduates for their hard work and perseverance — and welcome them to the long gray line."

## Sheriff Imperati announces Blue Envelope Program

Dutchess County Sheriff Kirk Imperati, in conjunction with the New York State Sheriff's Association, announced that the Dutchess County Sheriff's Office is adopting the Blue Envelope Program. This new initiative is an important safety program for drivers and other vehicle occupants, including children, with autism.

Sheriff Imperati said "There are many county families who are living with autism. Some of these residents drive our roads, so it is important for us as law enforcement to be able to better serve them. As law enforcement we should recognize that a driver's physical movements or verbal responses, which would normally be appropriate during a traffic stop, may be beyond an autistic driver's control. Without proper training and awareness there could be interactions where the officer could misinterpret an autistic driver's actions or their failure to appropriately respond to requests or directions. These are instances we want to avoid, helping to keep everyone safe."

To address this problem, law enforce-

ment agencies around the country have begun adopting the Blue Envelope Program. These agencies are encouraging drivers with autism to obtain a Blue Envelope to store all the relevant documents that a Deputy would request during a traffic stop — such as their license, registration, and insurance card. In this way, when the Deputy Sheriff sees the Blue Envelope, they are alerted to the driver's autism and can adjust their own actions or reactions to fit that situation.

The New York State Sheriffs' Association is promoting this program statewide and many Sheriff's Offices are rolling out the program, including the Dutchess County Sheriff's Office.

The Sheriff is encouraging his Deputies and other law enforcement officers in the county to be aware of the significance of the Blue Envelope if one is presented by a driver during a traffic stop.

# Law enforcement, local stakeholders learn how to identify human trafficking and prevent abuse

The Dutchess County Department of Community and Family Services (DCFS) last week hosted its second annual Human Trafficking Awareness Forum at Dutchess Community College's (DCC) James and Betty Hall Theatre in Poughkeepsie. More than 100 attendees, representing law enforcement, medical professionals, social service providers and community groups, attended this highly impactful event, which raised awareness of this national epidemic, discussed strategies to identify trafficking in all forms and connected attendees with resources.

Dutchess County Executive Sue Serino said, "Many people think trafficking only happens in big cities, but sadly, it can happen anywhere, even in our own community. Dutchess County remains vigilant and continues to raise awareness and protect victims of all ages, especially children. Today's forum, and efforts like it, help spread awareness and can save lives. I appreciate everyone who joined us today, and Dutchess County looks forward to continuing our work with these dedicated partners."

The Dutchess County Task Force Against Human Trafficking is a diverse team of professionals dedicated to combating human trafficking by collaborating to increase awareness, identify potential victims and deliver comprehensive, trauma-informed support. The task force's initiatives include educational programs on trafficking prevention for youth and a variety of resources for the community, such as resource guides, hotline numbers, service directories and fact sheets debunking common trafficking myths.

Human trafficking, defined as the unlawful trade of individuals through force, fraud, or coercion for exploitative purposes, includes crimes such as forced labor, sexual exploitation and involuntary servitude. The International Labour Organization estimates more than 40 million people worldwide are victims of human trafficking. In 2024, the Dutchess County Task Force Against Human Trafficking received 31 local referrals of suspected trafficking cases – including referrals received from probation officers, youth service providers and staff at shelters for runaway and homeless youth.

This year's forum presented attendees with a variety of offerings regarding human trafficking in all its forms, how to identify it and how to prevent it, including:

- a discussion with two adult female trafficking survivors, who shared their personal stories;
- a presentation by Homeland Security Investigations, which plays an integral role in combating human trafficking by working with its law enforcement partners to deter, disrupt and dismantle the criminal networks that engage in it;
- a presentation from Special Agent Pao Mei Fisher with the FBI's Hudson Valley Safe Streets Task Force; and
- a case study presentation from DCC Professor Matthew Greenstein, a retired Connecticut detective and member of Dutchess County's Human Trafficking Task Force.

## Two incarcerated individuals charged with violating court orders

The Dutchess County Sheriff's Office reports the arrests of John L. Papadopoulos, 31, and Anthony Pressley, 37, in connection with separate incidents at the Dutchess County Justice and Transition Center. Both were incarcerated at the time of the incidents and arrests, and remain there at the time of this writing.

Both defendants are accused of violating orders of protection by contacting protected parties, and have been charged with

Aggravated Family Offense (felony) and Criminal Contempt 2nd degree (Misd). Papadopoulos was arrested on Feb. 3 and was due to appear before the City of Poughkeepsie Court on Feb. 10, and Pressley was arrested on Feb. 4 and was due in court on Feb. 12.

As with any criminal case, the charges described above are merely accusations and both defendants are presumed innocent until proven guilty in a court of law.

# Local eggs

The bird flu epidemic has raised awareness of the 'buy local' egg movement

Kinga and Kristian Terepka moved from Brooklyn to Lagrangeville right after the Covid pandemic, fixed up an abandoned house on 11 acres and started farming. They figured it would be a better environment for their two little daughters, Olivia and Emily. Now their 11 Kettle Farm is on the front line of the "buy local" egg movement.

In the midst of skyrocketing egg prices and the bird flu epidemic, people are wondering where their eggs come from and how they are produced. This is not a new phenomenon. Nobody wants egg-laying hens to be squashed into tiny cages where they can't even turn around. In 2022, California outlawed the sale of eggs from hens held in individual cages. Nine other states have followed suit. Bills in the N.Y. Senate and Assembly would require, and define "free range" and "cage free" egg productions.

On its website, 11 Kettle Farm boasts that the chickens "roam freely on vibrant pastures, enjoying the simple pleasures of life." During my recent visit, 50 hens were indeed roaming freely, but I didn't observe any "vibrant pastures" in early February. Their shelter is a large coop on wheels, which Kristian assured me is hauled around the property to provide fresh pasture once the grass starts to grow. In the meantime they're fed organic grain from Stone House Farm in Hudson. 11 Kettle Farm is "dedicated to organic agriculture," but not certified organic. I've noted that many of the farms that sell locally don't bother with the cost and hassle of a federal organic certification, because they know their customers trust them, with good reason. I can't imagine Kinga and Kristian spraying chemicals. The eggs, by the way, are delicious, as advertised. Check the website for availability.

I asked about the blue eggs in my package. They're from black hens which are included in the flock. It seems that hawks are scared of black hens because they look like crows. I don't know - I always thought hawks had pretty good eyesight.

Here are some labels you might see on your egg cartons:

- Local** – The USDA defines "local" as food produced within 400 miles of its final destination. I personally limit "local" to the Hudson Valley, or maybe also the Rondout Valley, or even the Wallkill Valley.

- Organic** – The federal government certifies a product as organic if it meets strict standards, often disputed by traditional farmers who consider themselves organic. The "USDA Organic" label is important for

organic farmers selling to distributors or big supermarkets.

- Cage free** – The N.Y. senate bill under consideration defines "cage free" as an environment where a hen is "free to roam unrestricted except by exterior walls."

- N.Y. Grown and Certified** – Eggs produced in N.Y. state, from a farm meeting department of health regulations and participating in an Agricultural Environmental Management Program.

- Vegetarian Fed** – The hens are fed a vegetarian diet. This is tough for pasture-raised hens, because chickens are naturally omnivorous, eating worms and bugs.

- Pasture raised** – The crop and its outdoor enclosure are moved around the property to fresh pastures of grass.

- Free Range** – The hens have access to the outdoors and natural daylight.

Why did the chicken cross the road? Because it was a "free range" chicken!



# Beacon's Rheyen Cader inducted into Eastern New York Hall of Fame

The Eastern New York Youth Soccer Association (ENYYSA) is pleased to announce that Beacon's Rheyen Cader has been inducted into the Eastern New York Hall of Fame. The induction ceremony took place at the Hall of Fame Banquet on Saturday, Jan. 25 at Marina del Rey in the Bronx.

As a kid growing up in Zimbabwe, Rhey played soccer for Arcadia United and Prince Edward Academy plus the Zimbabwe Youth National Team before emigrating to New York in 1998.

Rhey then started coaching his oldest son's intramural team in the Beacon Soccer Club, quickly moving them to travel and eventually a State Cup championship. He has continued coaching travel teams for nearly three decades, long after his own children aged out. He recently started coaching a Boys-Under-10 squad that had no coach so that the team did not have to disband.

The good people of the Beacon Soccer Club saw Rhey's potential early on and recruited him to volunteer on the Board of Directors and he soon became President, a position that he has held for the past 15 years. Rhey revitalized the club and has grown registrations to nearly 700 children.

Rhey created an Angel Fund to provide financial assistance to those who would otherwise not be able to play and he started Volunteer Recognition Awards plus a Beacon Hall of Fame which has contributed significantly to increasing volunteerism. He leads by example and can often be found lining fields, working the snack bar and negotiating with vendors. He is a very much respected volunteer in the Hudson Valley soccer community.

Additionally, Rhey was honored as Eastern New York's Personality of the Month in October 2015 and inducted into the Hudson Valley Youth Soccer League (HVYSL) Hall of Fame in 2019 for his many contributions to youth soccer.


