Route 9D building with 'structural deficiencies' torn down in Wappinger

Moratorium on large-scale housing developments passed

The members of the Wappinger Town Board recently approved the purchase of 2513 Route 9D, which was said to have structural deficiencies. Wappinger Supervisor Joseph Cavaccini signed an executive order that had the structure torn down on March 18.

The Wappinger Town Board adopted a resolution for a moratorium at a recent meeting held at Wappinger Town Hall. The moratorium, according to town officials, is on construction of large-scale multi-family housing developments in the

town. A public hearing was held before the law was unanimously passed.

Structure torn down

According to town officials, structural deficiencies in the former residence on Route 9D were uncovered. The structural deficiencies, according to the officials, posed "an immediate danger to motorists traveling on Route 9D." Cavaccini issued an Executive Order to demolish the structure. The structure, which was torn down earlier this month, abuts the Reese Park Town Nature Preserve.

Families of premature babies give back for 'miraculous' births

Marial Drivas vividly remembers the date and time.

It was just before Christmas of 2012 and she had just given birth a few days earlier to a premature baby. It was 4:30 in the morning. Her son had stopped breathing. The doctors and nurses in the Neonatal Intensive Care Unit (NICU) at Vassar Brothers Medical Center sprang into action.

Her son Sotirios was revived and today is a thriving young man. But at the time, he still had to be intubated. For nine days. In retrospect, it might seem like a small amount of time, but it was a lifetime to Marial and her family.

Drivas leans heavily on her faith and calls it "miraculous."

"He was so tiny he could fit in the palm of my hand," she said.

That's why she and the Kimisis Greek Orthodox Church have a place in their hearts for the doctors and nurses at the NICU. And as Easter approaches, she is especially grateful and the group is just coming off an event in which they made 48 Build-a-Bear stuffed animals for children at the hospital and made a special financial donation to the NICU.

For Drivas and other mothers of premature babies, it's just their way of giving back and showing their love and appreciation to the doctors and nurses at the NICU, where her son spent the first 71 days of his life.

Route 9D building with 'structural deficiencies' torn down in Wappinger

It was stated that the purchase of the Route 9D property "marks the first expansion of the Wappinger Town public parks system in nearly 25 years following the purchase of Carnwath Farms Historic Site & Park."

"When there is a clear and present danger to our residents, it is our job to act. This is a change in philosophy that we will not wait or allow for problems to linger. The swift removal of this dangerous structure ensures the safety of our neighbors and will allow the Reese Park expansion project to move forward ahead of schedule. I am eager to work with our community to develop this site for the benefit of our Town and Village residents," Cavaccini said in a statement.

"The acquisition and demolition of the property at 2513 Route 9D was a long time coming. This was a safety issue and an eyesore in our community," Councilman Al Casella, who represents Ward 4, said in the statement. "This was welcomed by many and will be a place to eventually connect with Reese Park for all to enjoy the walking trails, as well as the peace and quiet of this beautiful property. I was personally there this morning with Town Supervisor Cavaccini, Councilmen [Chris] Phillips & [William] Beale, and Councilwoman [Angela] Bettina as the demolition took place. The company that took down the building was quick, efficient, and careful not to disturb the neighbors' properties or Route 9D."

According to Town information, The Reese family, of Hughsonville, donated the 40-acres of Reese Park Town Nature Preserve, which is adjacent to the Wappinger Creek.

Beale remarked in the statement, "The deteriorating structural integrity of the existing buildings on this site required immediate demolition to protect public health and safety. This step gives the Town a unique opportunity to create a vision with a 'blank canvas.' I look forward to collaborating with our Town and Village partners in the months ahead."

Moratorium passed unanimously

"The Town has seen a considerable number of conceptual proposals that would call for the development of high-density multifamily housing in single-family zoned areas. It is our responsibility to look out for our neighbors and ensure that the future of our beautiful Town of Wappinger is secure," said Cavaccini. "In adopting Local Law 1, we are looking to identify areas to preserve, limit further congestion and overcrowding, as well as foster new development in places that are innovative and that make the most sense for our community."

This action does not limit or stop all projects and applications from proceeding within the Town, it was stated, as it is limited to the proposed large-scale housing development.

Cavaccini noted, "This pause is crucial to ensuring that we do not contribute to traffic, crowd our schools, and overburden our police, ambulance, or volunteer fire companies."

Casella stated, "The adoption of Local Law 1 was needed for the town to re-assess our comprehensive plan and where we want to be as a Town. This is a pause that will allow us time to do our due diligence in re-evaluating our water and sewer capability. In addition, this will also require research, studies, public hearings, and updates to

our town codes to potentially help us create a new comprehensive plan. This is something the town has needed for some time now and that's why I support this initiative."

During this pause, said Cavaccini, town officials will consider changing the Town Code to match the Town's Comprehensive Plan and look closely at the numbers concerning the Town.

"The fact is that at 28 square miles, the Town of Wappinger is the smallest geographical town in Dutchess County and yet the second most densely populated town and our current housing ratio is 60% single family and 40% multi family. We need to be educated and innovative when it comes to doing business in our Town, not hurting our neighbors," Cavaccini said.

For Drivas and other mothers of premature babies, it's just their way of giving back and showing their love and appreciation to the doctors and nurses at the NICU, where her son spent the first 71 days of his life.

Drivas is not alone. Several other mothers in the church have given birth to premature babies and they have a special bond and camaraderie.

"My son is 11 now. I wanted to do something to give back to the hospital where he was born," Drivas said. "It's something we'd like to do every year."

The church also donates bags of goodies and supplies to the homeless shelter every November and adopts a family for Christmas.

Drivas knows the frustrating and hopeless feelings.

"Oh man, it was tough," she said. "I mean, you're a first-time mom, and you don't even know if your child is going to make it. You want to take care of him. We even had an oscillator in the house that turned the outside air into oxygen. It was a different experience, to say the least. It was very scary."

She uses her own example and her faith and the openness of her church to guide her.

"Maybe they would want to come to our church and know that there are people out there who have been through the same thing as they are going through," Drivas said. "Maybe we can help them and guide them through a really dark time."

It's a bond and a community forged by difficult circumstances. The uniqueness of the situation has forged lifelong friendships, she said. It's like having a whole other family. In fact, the nurses still check in on her and her son through social media.

That's why, as Easter approaches, she is grateful for the support from friends and family and church members. They donated what they could. It turned out to be quite a bit; the church put on a brunch a couple of months ago that ended up paying for the whole Build-a-Bear event.

"We're blessed," she said.

Susan Browning, President of Vassar Brothers Medical Center, commented, "We're incredibly thankful to the Greek Orthodox Church families in Poughkeepsie. Their fundraiser for our NICU at Vassar Brothers Medical Center

There are 13 actors, 3 musicians, 1 narrator, 8 people working on the scenes (lighting, costumes, wigs, make-up) that night, not including the director.

Asked why people should attend, Diana replied, "The Living Last Supper" is more than a repetition of the Biblical betrayal story or a reenactment of it. In the play, you hear the thoughts of each of the Apostles at that fateful moment, including those who remain silent in the Bible story. They speak of concerns, fears, and questions that people of faith continue to have even today."

Bob Gensler portrays Judas, one of the 12 disciples of Jesus who betrayed him for 30 pieces of silver.

"By putting myself in the place of one of the Twelve [Apostles], this becomes more than just a lifeless passage of Scripture. I have to care about my character, even though he might be the most despised man in history. I have to understand what motivated him to do what he did. As I try to understand him, I find that the questions that he has are not so much different from

mine when I see the world in its current state: couldn't the Messiah have talked less and acted more, couldn't the Savior have taken a more active role in defeating evil? This has caused me to reexamine my faith, my belief in who Jesus is and what his purpose truly was, and what my role in my faith should be. I now see that I am the one who needs to take a more active role, using my faith to guide my actions," Bob said.

Bob explained, "I used to see this story only for its symbolism: the establishment of the Communion sacrament and the beginning of the events that led to the Resurrection. I now find it to be far more significant. This is where the church was handed over to humanity, whether humanity was ready to receive it or not. Today, as back then, none of us are ready at first. We need to take on our faith and grow into it, just as the Apostles needed to do."

Bob recalled when he first started taking part in the "The Living Last Supper."

"When I started in this play back in 2006, I was offered a couple of available roles. Most people avoided taking the part of Judas, maybe afraid of being associated with history's greatest traitor, but I jumped at the chance. I knew that his part would be important, and that whoever did it needed to treat it with integrity. I felt that I could do that, and I thought it would be fun to play the villain. I found that the part had been written to portray Judas not as a money-hungry opportunist nor as someone of weak faith. Once I saw him in a new light, it was easy to find that integrity," said Bob.

Diana stated how seeing the Last Supper live is different than just hearing and reading about it.

"We can get numb to this Scripture story by hearing the same words read every year. The lesson becomes predictable, the outcome is known, the words lose their impact to inspire or to invite personal reflection. By bringing the scene to life, by hearing the voices of other Apostles who remain silent in the Bible story, the play invites you to reconsider the meaning of the Last Supper, to find the humanity in the story beyond the historical account, to ask yourself how you

would feel and how you would act were you there, and what does this moment from our faith mean to you," said Diana. She noted, "This play is different from the usual telling of the Last Supper because, unlike the Biblical accounts, Jesus is silent. Only the Apostles speak. They talk about more than just the impact that Jesus has had on their lives. They speak of questions that they still have, even after following Jesus for years. Those in the audience may find that at least one of the Apostles might voice a question or

concern that they themselves have, showing that, like us, even the Apostles did not have all the answers. And, like us, those answers would come with time and reflection."

The church is at 70 Hooker Ave. in Poughkeepsie. There will be a free will offering taken.

County to offer free rabies clinic on April 7

The Dutchess County Department of Behavioral & Community Health (DBCH) and the Dutchess County SPCA continue their partnership hosting their next free rabies vaccination clinic on Sunday, April 7, at the Red Hook Town Hall located at 7340 South Broadway, in the town of Red Hook, from 8 a.m. to noon. This clinic is open to dogs, cats, and domestic ferrets 3 months of age and older. Pre-registration is required and will open on Wednesday, March 20th. Residents can register at DCSPCA.org or by calling the DCSPCA at 845-452-7722 extension 425.

The clinic is free for Dutchess County residents; non-residents will be charged a fee of \$10 per pet vaccinated. All dogs must be on leash, and cats and domestic ferrets must be in carriers. Vaccinations will be good for three years for pets with proper proof of a prior immunization. For those without proof, the vaccination will be good for one year.

Rabies vaccinations are required by New York State law for all cats, dogs, and domes-

tic ferrets by the age of four months of age. Pet owners are required to revaccinate on a regular schedule to keep the animal properly immunized against the rabies virus.

DBCH is available 24/7 to assist with any questions or concerns regarding potential rabies exposure to people or domestic animals. Pet owners should report to DCBH any incident in which their pet has been bitten by or has an open wound exposed to the saliva or nervous tissue of a domestic or wild animal. Staff will investigate and advise the pet owner of any necessary steps they should take to ensure the safety of their animal.

Residents who see an animal acting strangely are advised to contact their local police agency. If a person has been bitten, or a domestic pet is bitten or is in contact, with any animal, they're to contact DBCH immediately at 845-486-3404 Monday through Friday 9 a.m. to 5 p.m., or 845-431-6465 on nights and weekends.

Lawler, Ryan, Molinaro back Hudson River Protection Act

The Hudson River Protection Act introduced by Representatives Lawler, Ryan, and Molinaro passed through the House Transportation and Infrastructure Committee as part of the Coast Guard Reauthorization Act, teeing up the bill for a vote on the House floor in the coming months. This legislation would amend the 2020 Elijah E. Cummings Coast Guard Authorization Act, removing any uncertainty related to geographic definitions (such as the Port of New York) and banning additional anchorages once and for all.

"The Hudson River Protection Act will go a long way to preserving the natural beauty of our Hudson Valley communities - something that has been a top priority of mine from day one," said Lawler (NY-17). "I was glad to see the Hudson River Protection Act pass the House Transportation and Infrastructure Committee as part of the Coast Guard Reauthorization Act. I'm going to continue working with my Hudson Valley neighbors and colleagues Pat Ryan and Marc Molinaro to make sure our crucial legislation becomes law."

"Getting anything through this Congress is not easy. But we owe it to our kids, our seniors, and future generations to fight tooth and nail to protect our Hudson River and get this bill across the finish line," said Pat Ryan (NY-18). "Never again will big corporations be able to turn our Hudson River into a parking lot for dangerous barges. This victory proves that when our community stands up with one voice to demand change, we can accomplish anything."

"I'm a conservationist and over the span of several decades have championed causes

to clean up the Hudson alongside Congressman Pat Ryan, Riverkeeper, Scenic Hudson, and other local partners," said Congressman Molinaro (NY-19), former county executive of Dutchess County. "With this bipartisan bill, we are taking another step to protect the Hudson and ensuring we are not doing anything that could erase the progress we've made."

"Riverkeeper is thrilled to see the inclusion of the Hudson River Protection Act within the U.S. Coast Guard Reauthorization. This crucial legislation reflects a significant step forward in safeguarding the Hudson River from the risks of increased anchoring by large vessels in critical habitat areas," said Drew Gamilis, Riverkeeper Staff Attorney. "We thank Congressmen Ryan, Molinaro, and Lawler for prioritizing the concerns of Hudson Valley communities."

"We are grateful to Congressmen Pat Ryan, Marcus Molinaro, and Michael Lawler for their leadership in including the Hudson River Protection Act in the Coast Guard Reauthorization bill," said Ned Sullivan, President of Scenic Hudson. "This critical legislation will protect the inspirational beauty, health, and safety of the Hudson and communities along the river. We remain committed to working with our Congressional delegation and Riverkeeper to safeguard the Hudson Valley's drinking water, wildlife, and people now and for generations to come."

The legislation introduced alongside Congressmen Ryan and Molinaro amends the 2020 Elijah E. Cummings Coast Guard Authorization Act, effectively banning additional anchorages on the Hudson once and for all.

Jacobson fights for funding to be restored to budget

Assemblymember Jonathan Jacobson (D-104) scored victories in the Assembly one-house budget, restoring cuts from the Governor Hochul's budget to public schools, highway funding and clean water infrastructure, including the replacement of lead water lines. Jacobson also had additional money added for the county boards of elections.

"I worked with my colleagues to reverse the unnecessary cuts to our public schools. No school district should be forced to have a surprise cut in their State funding," said Jacobson.

In Jacobson's district, Poughkeepsie, Highland and Beacon schools would be slated for Foundation Aid cuts in Hochul's proposed budget. He also requested an increase in the reimbursement rate for Career and Technical Education (CTE) instructors in the state's Board of Cooperative Education Services (BOCES) programs to ensure that students can access valuable career training. These priorities were reflected in the Assembly budget, which provides a \$1.3-billion increase in Foundation Aid over last year and a minimum increase of three percent for each school district. The budget also proposes to increase the salary cap aid for BOCES CTE instructors from \$30,000 to \$40,000, resulting in an additional \$31 million for this budget.

"Road conditions have long been a priority of mine, from my time on the Newburgh City Council through my tenure in the Assembly. Every municipality in my district relies on these vital State programs so that they can afford to take care of their roads. I was able to restore cuts and even increase aid," said Jacobson.

The Assembly budget increases funding for highway repair programs, including \$598 million for the Consolidated Local Street and Highway Improvement Program (CHIPS), which restores \$60 million in cuts; \$210 million for PAVE-NY, with an increase of \$60 million; \$150 million for Extreme Weather Recovery, with a \$50-million increase; and \$4.9 billion for the State Road and Bridge program, which is an increase of \$400 million over the Governor's budget.

Jacobson also fought for full funding of New York's Clean Water Infrastructure Act (CWIA), as well funding to replace lead-contaminated water lines — a problem that plagues the cities of Newburgh and Poughkeepsie. The Assembly budget restores the Governor's 50% cut of \$250 million, to match the \$500 million in last year's budget. From that sum, \$100 million is allocated to lead service line replacement.

"There is no safe level of lead in drinking water," said Jacobson.

Jacobson was also successful in getting an extra \$10 million for the County Board of Elections to implement sweeping voting reforms the Legislature has made over the past five years, including early voting, the ability to cure mistakes in absentee ballots, and the on-time counting of early voting and absentee ballots received prior to election day.

After the Governor proposed her budget in January, the Democratic majorities in the Assembly and Senate produced their own budgets. Both houses of the Legislature are now negotiating with the Governor to produce a final budget, due on April 1.

Local man used art to assist in recovery from stroke

Scott Garrity, a Beacon resident, has his artwork on exhibit at the Grinnell Library in Wappingers Falls throughout this month.

"I always had a love of art growing up as a young boy. I enjoyed drawing but never did it a lot because I felt I wasn't very good," Garrity said via email.

Garrity suffered a health crisis in 1991—the day before his 20th birthday.

"After my stroke I was in a coma for a month. When I woke up everything had changed. I had difficulty moving and talking. I started to draw because drawing was easier than talking and less frustrating," Garrity, who is 52 now, recalled about that time of his life.

"After my stroke, my parents were told I would probably never walk or talk again. They were afraid that if I woke up, I would be a vegetable because of brain damage. After a month in the hospital, I was sent to live at a rehabilitation center in upstate New York that specializes in traumatic brain injury and stroke recovery. Because I had problems speaking, I turned to art, teaching myself to use my non-dominant hand," explained Garrity. "At first it was very difficult but over time I noticed that my art had improved, and I was developing some talent in this area. Drawing and creating art woke up my right brain. Because the right brain has control of the left side of the body, I am able to use my left hand to draw and paint."

A new 'voice' through art

Garrity described himself as "an introvert" and "loner" before he had a stroke.

"I kept to myself a lot. In rehab I learned to interact with others and meet new people. I learned about the healing power of art because it gave me a voice when it was truly hard to communicate. I

became a totally different person," relayed Garrity.

When Garrity was able to go home after his rehab stay, he began to take art classes. Even though the classes were difficult, said Garrity, he enjoyed them.

"To this day I still have problems speaking and talking and in a way art has become my voice and my way of giving back to the world. I realize that all of us need each other. Ten years after my stroke I was able to get a job at Hudson Valley Community Service. I worked with people who were "exceptionally abled" (a term for someone with special needs). I loved that job. Because of what I had gone through I could understand the people I worked with and their frustrations at what they were going through," com-

mented Garrity.

Artwork on display at Grinnell Library

There was a reception for Garrity's artwork on March 9th, but he was unable to attend.

"I have done several craft shows in the past but nothing like this. I am honored and proud of myself. My dream is to open a center where other "exceptionally abled" people can come to learn and experience the healing power of art. I want others to have the opportunity for that same experience," Garrity said.

Regarding art and health, Garrity said, "When you create art in any form you are in a safe zone. Anxiety lessens, your heartbeat slows down, and for a while you stop think-

ing about all the things that are bothering you. It's like a respite. Do something you like as art. Also, it is important to exercise, and live a balanced life. We need to play as much as we work so life can be balanced. When we experience too much busyness and [are] overwhelm[ed], we become ill at ease with our body and that's when disease happens."

Garrity advised, "Just do art! It will change your life. I love art. It is fun to do, and art has given me a purpose in life. The completely unexpected challenge of the need to recover from a disabling stroke was the means to discover my passion in life!"

Probation Director to retire after 46-year career in Dutchess County

Still is the longest-tenured active department head in Dutchess County Government, having served as Probation Director for more than 22 years.

Throughout her career, Still has been a champion of community engagement and collaboration, forging strong partnerships with local organizations, law-enforcement agencies and community leaders to develop practical and effective solutions. She has actively worked to create a holistic approach to pretrial services and probation supervision – emphasizing rehabilitation, support and the reintegration of individuals back into society.

She has been a trusted leader throughout New York State with Governor Kathy Hochul appointing her in 2022 to serve as Commissioner on the State Probation Commission to advise and consult on all matters relating to probation in New York State.

Serino said, "Mary Ellen Still has dedicated her professional life to Dutchess County's Office of Probation and Community Corrections, ensuring public safety through her innovative solutions – in the process, becoming an esteemed national authority on restorative justice. Mary Ellen has been a driving force in the transformation of our county's probation and community corrections programs, implementing effective strategies that prioritize rehabilitation, public safety and community well-being, including our highly successful alternatives to incarceration. Dutchess County is grateful to Mary Ellen for her decades of services, and we wish her every success in her next chapter."

Still began her tenure in County government as a Probation Officer trainee in 1978, eventually serving every function in the Office of Probation and Community Corrections, being promoted to Senior Probation Officer, Supervisor and Deputy Director, respectively, before then-County Executive William R. Steinhaus tapped her as Director in 2002.

As Director, Still has led the Office of Probation and Community Corrections, overseeing nearly 50 employees who protect the community through intervention in the lives of those under supervision, facilitating compliance with court orders and serving as a catalyst for positive change. Still's department promotes public safety through effective supervision of some 2,000 defendants and probationers placed on commun-

ity supervision by the courts, through evidence-based probation and diversion programs. Among others, those programs include the successful interagency collaborative in-jail transition program known as RESTART (Re-Entry Stabilization Transition and Reintegration Track) in partnership with Project M.O.R.E. and Family Services, as well as RECHARGE (Re-Entry Community Housing and Resource Guided Empowerment) to provide justice-involved people with supportive housing and services in partnership with Project M.O.R.E. to increase participants' success once they return to their community.

She has been involved with a multitude of efforts to help individuals who encounter the criminal justice system,


including the development of specialized courts for veterans and substance-users and the creation of college credit classes at the Dutchess County Jail and through EXODUS Transitional Community.

Still has also been instrumental in navigating the evolving New York State bail reform legislation that first passed in 2019 and has undergone various revisions, significantly impacting the criminal justice system process throughout the state.

Still shared the news of her impending retirement Tuesday at the Dutchess County Criminal Justice Council. Still has been involved with the CJC since its original formation in 1993 and currently serves as CJC Chair. The Dutchess County's Criminal Justice Council has been an innovative, national model for working in a collaborative process of information-sharing to maximize resources for an enhanced criminal justice process, utilizing research-based practices to ensure community safety through the promotion and support of intervention for at-risk youth and adults, addressing victims' needs and reduction of recidivism.

Still is also the current Chair of Training and Qualifications Committee for New York State Council of Probation Administrators; Chair of New York State Council of Probation Administrators Area III; as well as being a member of the New York State Probation Commission and the Dutchess County Police Chiefs Association. She was a past member of the Dutchess County Universal Response to Domestic Violence, and she previously served as a member of the New York State Domestic Violence Fatality Review Board.

Dr. Gary Christensen, President of Justice Solutions, Inc., who served for many years as the Dutchess County Jail Administrator, as well as Chair of CJC, said, "Mary Ellen Still is a true legend-committed to ensuring a strong, fair and efficient criminal justice system that is

focused on reform, rehabilitation and restorative justice. She stands alone at the forefront of progressive efforts to affect positive change in criminal justice practice both within Dutchess County and beyond, throughout the field of evidence-based criminal justice practice. I have been honored to work with her over the past 45 years and, due to her efforts and teachings, we will all continue to benefit for many years to come—her work has truly made a difference in people's lives."

In 2017, the National Resource Center on Justice Involved Women and American Jail Association invited Still to speak at its national summit in Washington, D.C., where she presented on the development and current use of the Inventory of Needs instrument – a pretrial and screening tool for justice-involved women used to create unique case plans based on women's needs, resulting in better pretrial and supervision outcomes. Ms. Still has also worked with the Center for Effective Public Policy; engaged in a collaborative project with researchers from the University of Cincinnati and the

University of Houston on gender-responsive strategies; and, in partnership with the New York State Division of Criminal Justice Services (NYS DCJS), worked with the Robert F. Kennedy National Resource Center for Juvenile Justice on a comprehensive review of the probation and juvenile justice system to enhance system practices, resulting in development of trauma assessment and interventions for young people.

Still has received numerous local, state and national awards and citations, including the Arlington Rotary's Recognition of Service in 1995; the Van Bramer Award from Mental Health Association in 2005; New York State Division of Criminal Justice Services' Sara Tullar Fasoldt Leadership and Humanitarian Award in 2011; recognition by the New York State Coalition Against Domestic Violence for Outstanding Contributions to Victims in 2003; and Project M.O.R.E.'s 2015 Distinguished Service Award, among others. Still graduated from the U.S. Department of Justice's National Institute of Corrections Executive Excellence Program in 2000, as well as Sam Houston University's Executive Orientation Program in 2002.

Long active in her community, Still has served on various boards and committees, including the County's Mental Hygiene Board, Family Services Board, the Coalition Against Domestic Violence and Sexual Assault. She has also served on various workgroups and committees of NYS DCJS, including Staff Development, Revision of Rules and Regulations Governing Probation, Domestic Violence Workgroup.

Still said, "Over my career, I have witnessed a transformative journey of rehabilitation and growth in the criminal justice system. I have been a proud proponent for restorative justice because I've seen, firsthand, the power of second chances and the resilience of the human spirit. I carry with me the belief that compassion and understanding can reshape lives. This hasn't been a career for me; it's a testament to the possibility of transforming lives and the enduring pursuit of a better tomorrow."

'Move Over' Law expands to include all stopped vehicles on highways

As of today, March 27, drivers must slow down or move over to avoid a crash with any disabled or stopped vehicle. New York's Move Over Law was first enacted in 2010 to protect emergency vehicles that were stopped on the highway. It has since been expanded several times to include hazard vehicles, highway worker vehicles, and tow trucks. Last year, Gov. Kathy Hochul signed a bill to further strengthen the law by including this protection for all vehicles stopped on the roadway.

Under the law, when a driver is approaching a vehicle stopped along either shoulder of the road, they should:

- change into a lane not immediately adjacent to the vehicle, or
- slow down to a reasonable speed if unable to safely make a lane change.

"The safety of all New Yorkers is my top priority, especially those pulled over to the side of the road," Hochul said. "If you see that you are approaching a disabled vehicle, slow down and move over as best you can to give them some space."

According to state data, from 2016 to 2020, 37 individuals were killed outside disabled vehicles in New York. Nationally, nearly 300 drivers are struck and killed roadside every year. The Move Over Law was enacted to prevent those tragedies and make New York's roadways safer for all.

Last week, the Governor's Traffic Safety Committee launched a public awareness campaign using radio, social media and other out-of-home elements to remind people they will need to "Slow Down, Move Over" as best they can when they come upon someone stopped on the side of the road or in a driving lane.

According to the National Highway Traffic Safety Administration, all 50 states have "Move Over" laws to protect law enforcement officers and other first responders, yet one-third of Americans are not aware of these laws.

"We are excited about the new legislation because the safety of the officers, road crews and tow truck operators are very important to us," said Hyde Park Police Chief Robert Benson. "There are many close calls on the Route 9 corridor from East Market Street to Marist where vehicles are traveling a higher speed past the patrol officers conducting traffic stops and helping motorists with disabled vehicles."

Chief Benson added, "We will have officers working overtime details in the near future that coincide with the New York State 'click it or ticket' and selective enforcement patrols. These patrols will be looking for compliance with the Move Over Law while trying to reduce injuries and accidents with these enforcement details."

Troop K Commander Major Kathryn M. Rohde said, "Every day the members of

Troop K work hard to make our roadways safer. It is our duty to continue to educate drivers and enforce the law in furtherance of that goal." She advised drivers to "slow down to a reasonable speed even if you are on the opposite side of the roadway. Move over for any stopped or standing vehicle in the roadway or on the shoulder. We want everyone to reach their destination."

DMV Commissioner and Chair of the Governor's Traffic Safety Committee Mark J.F. Schroeder said, "The expansion of the Move Over Law is another example of New York State's commitment to making this state a safe place to live, work, and travel. You never know when you may need to pull over, but when you do, we want to make sure you can do so without putting yourself or others in harm's way. Each of us is responsible for doing our part to prevent tragedies on our roadways, so please follow the law. Slow down and move over when you see another vehicle stopped."

Thruway Authority Acting Executive Director Frank G. Hoare, Esq. said, "Strengthening the Move Over Law by expanding the protection to all vehicles that are stopped on the side of the road will help save lives. The law is meant to protect motorists, emergency responders, Thruway personnel and others assisting disabled vehicles. When you see any vehicle pulled over, slow down and safely

move over. We thank our partners at New York State Police Troop T for their work patrolling the Thruway and keeping motorists safe."

Department of Transportation Commissioner Marie Therese Dominguez said, "The expansion of New York's Move Over Law to include disabled and stopped vehicles in the roadway is critical to achieving the goal of eliminating fatalities on the roadways. With 37 individuals killed outside of disabled vehicles on New York's roadways from 2016 – 2020, Governor Hochul's actions to expand the Move Over law will fundamentally save lives by putting safety first."

New York State Police Acting Superintendent Steven G. James said, "The New York State Police remains committed to keeping our roadways safe - for those who travel them, and for those who work on them. By expanding the Move Over Law and vigorously enforcing its provisions, we will be able to further improve safety for all who utilize our roads throughout the state. I thank Governor Hochul for her shared dedication and steadfast commitment to enhancing safety on New York's roadways."

The Dutchess County Department of Planning and Development has launched a new Natural Resources Inventory (NRI) website and an accompanying Environmental Mapper application to help guide land-use decisions and natural resource protection. The NRI website, nri.dutchessenvironment.com, represents a significant advancement from the County's previous NRI document, offering residents, municipalities, developers and County staff innovative tools to explore local natural resources and environmental datasets. The County's new Environmental Mapper can be accessed at gis.dutchessny.gov/nri.

NRIs serve as comprehensive repositories detailing the physical and biological attributes of an area, aiding in the creation and implementation of conservation strategies. With a focus on data and mapping, modern NRIs often incorporate online resource mappers to offer advanced visualization capabilities. The County's new Environmental Mapper exemplifies this technological approach, empowering users to identify conservation priorities and integrate them into local land-use planning initiatives.

The new NRI offers residents, environmental groups and educators the opportunity to:

- Gain insights into physical and water resources, habitats and biodiversity, and land use patterns that are integrated within their local communities; and

- Understand the potential impacts of climate and climate change on local natural resources.

Meanwhile, municipalities, developers and County Planning and Development staff can leverage the app to:

- Serve as a dynamic reference for environmental-related discussions or actions;
- Assist Conservation Advisory Councils and Boards in advising on environmental policy, delivering education programs, implementing stewardship projects and disseminating information;
- Inform future planning endeavors, such as open space plans, climate vulnerability studies and action plans and municipal comprehensive plans; and
- Facilitate individual conservation planning projects.

County Executive Sue Serino said, "Dutchess County boasts an abundance of incredible natural resources which make our community ecologically vital. The valuable collaborations between County departments and our State and community partners have made these two new tools possible. I thank everyone involved in their creation, and I encourage residents to explore these new applications to examine the natural resources that make our environment unique."

During her State of the County Address on March 14, County Executive Serino discussed the importance of Dutchess County remaining committed to our climate to ensure future genera-

tions of local children grow up with clean air and clean water. Later this year, Dutchess County will apply for Silver Certification under New York State's Climate Smart Communities (CSC) program, a statewide network of communities with common environmental goals, including increased energy efficiency, increased use of renewable energy, and reduction of greenhouse gas emissions. Having received its Bronze CSC certification in September 2019, Dutchess has continued to take steps to be certified as a Silver CSC community, including the addition of these two new online resources. Currently, only 10 New York communities, including just four counties, have earned that Silver-level distinction.

The new NRI website and Environmental Mapper application were made possible, in part, by a grant from the New York State Environmental Protection Fund through the Hudson River Estuary Program of the New York State Department of Environmental Conservation. The content for these products were jointly developed between the County Department of Planning and Development and Cornell Cooperative Extension of Dutchess County, with the County's Office of Central and Information Services providing development support for both online products.

Dutchess County Environmental Program Director Devin Rigolino said,

"County residents recognize that the abundant environmental resources found in the Hudson Valley are what make Dutchess such a special place to live, work, and visit. These two products – the NRI website, paired with our new Environmental Mapper – will enhance our communities' comprehension and stewardship of the natural resources that enable Dutchess County to flourish."

Dutchess County Planning Board Member Edie Greenwood said, "This exciting new application will be a benefit to all of us who care about community planning and environmental conservation. The new mapper allows all users easy access to important datasets relating to our natural world. I commend Dutchess County on completing this innovative project. It allows residents the ability to research what natural resources exist across their communities as well as at the level of individual parcels."

The Dutchess County Department of Planning and Development is involved in many programs and projects related to understanding and improving our natural environment. Ongoing initiatives include preparing a County operations government greenhouse gas emissions inventory, developing a climate action plan and compiling a comprehensive annual report on the County's climate actions. 
On February 8, 1977, he married Carole Clifton in Beekman, NY. Carole survives at home.

Puff the Magic Pastry

These creamy delights are an elegant dessert for Easter or any special occasion.

As seems to be the case more and more, time is flying and I got a late start on planning this year's Easter menu. I took over Easter some forty years ago (yikes!) and with a lot of menus and tested recipes to choose from, I hardly need to reinvent the wheel. Still, I try to mix it up each year with different combinations and bring new recipes into the mix whenever I can.

I love planning a big meal. Choosing the menu, making shopping and to-do lists and getting the timing and plating just right is always a satisfying accomplishment. Over the years I've learned a trick or two and know how to combine dishes with the same cooking times and temperatures, most that can be made a day or two ahead, and the value of time-saving shortcuts. My Easter recipe binder has become sort of a some-from-column-A-some-from-column-B reference for menu building with everything from appetizers to desserts. Only recipes that checked all the right boxes for success made the final cut, so I know they work. I don't recommend trying a new recipe for the first time when the pressure's on. You can trust me on that! Although I have done it, it hasn't always been successful, so it's always best to try it out beforehand

when you can.

This year, though, I haven't left myself much time to do that, so I'll be relying on some favorite go-to recipes. I did want to add something new to the mix, though, so that's what's going on in this article. To be fair, it's a simple dessert recipe using elements I've made before with mostly store-bought ingredients to save time, but with one added component I can make ahead. The dessert is a take on cream puffs; the store-bought element is frozen puff pastry, which will replace the typical pate a choux, and the make-ahead factor is Italian pastry cream. Yes, it's a bit of a cheat, but one that saves time and is pretty easy while impressive enough that no one will know, so I won't tell if you won't!

And now a word or two about working with frozen puff pastry. First, a huge part of the appeal of puff pastry is its crisp, airy flakiness. One key to that is keeping the dough as cold as possible while working with it and, very importantly, re-chilling the finished product for 15-30 minutes before baking for the flakiest layers and highest puff. Second, and most obvious, it's frozen and you can't work with it that way, so ideally you should let it thaw in the

fridge overnight first. You want to just be able to unfold it without cracking, lightly roll out the fold seams without rolling over the edges (pressing too hard and thinning the edges will not result in the best puff) and cut it as needed without it getting sticky-soft, warm and hard to transfer to the baking sheet intact.

If you're in a pinch, leave it on the counter and check it often until it's right, rechilling a bit if you miss that magic moment. I actually prefer this method because it gives me a bit more control over the all-important chill factor. One added tidbit you may not know: many brands of frozen puff pastry are not made the traditional way with butter. Butter is better, not gonna lie, and I've made puff pastry from scratch, but the alternatives are really fine and certainly convenient, and I've used them many times with great results when I followed these steps.

The Italian pastry cream is a lemon-kissed custard perfect for spring desserts. I love lemon for Easter, and the simple addition of some fresh zest to the custard is a nice touch that makes this special and distinctive. While pretty simple, it takes a little finesse to get it to the right consistency. It can be made days ahead too, perfect for spreading out the workload. The puffs should be baked the day you plan to serve them. Just let them cool, cut in half and assemble before plating.

ITALIAN CREAM-FILLED PASTRY PUFFS

Another great thing about this recipe is that you custom-cut the pastry to any size. I've made 6-8 large (4-5-inch) individual desserts or, as I did here for buffet-style, about 40 (2-3-inch). I have a set of graduated biscuit cutters, which are perfect. Their varied sizes and sharp cutting edges make for clean, easily customizable puffs, which should be cut and re-chilled the day of. They only take 15 minutes to bake but will need to cool completely before cutting in half to fill, so plan accordingly. The cream can be made in advance and kept chilled. You can serve them with fresh berries or a spoonful of your favorite jam for extra flavor and color.

YOU WILL NEED powdered sugar to dust on top. Fresh berries, too, if you like.

ITALIAN PASTRY CREAM – As I said, this seems more custard than cream, but it's how the Italians do it and I'm sure not going to argue. When done right, it's silky smooth and firm enough to stand up well as a filling. You can use it in lots of ways – to top fresh berries, in crepes, slathered on brioche or in layer cakes – so it's a good recipe to master.

INGREDIENTS for cream

2 cups whole milk
1/2 teaspoon pure vanilla extract
Fresh lemon zest (from about half a lemon)
4 egg yolks (preferably room temperature)

1/2 cup sugar
A pinch of salt
1/3 cup cornstarch

METHOD for cream

Place a small stainless steel bowl in the freezer. Alternatively, set the bowl in a larger bowl half filled with ice and set aside.

In a small saucepan, warm milk on low heat, 1-2 minutes. Stir in vanilla and zest, raise to medium heat and cook until small bubbles start to form around the edges. Do not let it boil! Remove from heat.

While milk heats (keep an eye on it), whip egg yolks and sugar in a medium bowl until pale yellow and fluffy-smooth, 4-5 minutes with an electric mixer. Add salt and sift in the cornstarch. Stir with a wooden spoon briefly before mixing to avoid a flurry of cornstarch. (You're welcome!) Mix until smooth, 1-2 minutes more. It will be pretty thick.

Add the egg mixture to the hot milk (a ladle might work best) a little at a time, whisking constantly to prevent lumps and keep it silky. Return the pan to low heat, still whisking, and simmer – again, don't let it boil – for 4-5 minutes until it starts to thicken. If you start to see bubbles, lower the heat or remove it for a few seconds before replacing. (Yes, this is the finesse part!) It's done when smooth and thick enough to stick to the back of our friend, the wooden spoon, without dripping off. Transfer to the chilled stainless bowl immediately to prevent over-cooking. Let cool a few minutes, then cover with plastic wrap that comes in contact with the surface to prevent it forming a skin. Refrigerate until set, at least 3 hours. Can be made 2-3 days in advance.

PASTRY PUFFS – You will need to chill the pastry rounds once cut, so make room in the fridge to accommodate a baking sheet as this step is crucial.

INGREDIENTS

1 package frozen puff pastry (see previous tips on thawing/handling)

METHOD for puffs

Preheat oven to 400 degrees. Have baking sheet ready.

Place 1 unfolded, thawed but still cold, pastry sheet, fold creases smoothed out (see previous tips) on parchment-covered work surface. Cleanly cut out shapes with firm pressure. Remove

The \$64 Tomato – For Real!

Mark weighs the pros and cons of growing one's own food.

Not yet, but soon, a tomato might cost \$64. That was a joke back in 2007, when Bill Alexander wrote a book called "The \$64 Tomato: How One Man Nearly Lost His Sanity, Spent a Fortune, and Endured an Existential Crisis in the Quest for the Perfect Garden."

Nobody's laughing now. Food prices keep climbing, so it might be a good time to revisit that "existential question" - can you save money by growing your own food?

My answer would be – it depends. If you are an investment banker who has to call in sick when the beans are ready to pick, maybe not. If you choose to eat only organic produce, possibly. If you love delicious fresh vegetables that the whole family can have fun growing, then YES!

At the supermarket, I checked a few prices. Here are some vegetables you can grow to save money:

- **Herbs in containers** – A one-ounce package of thyme costs \$1.99 – that's \$32 a pound! If you need a pinch of thyme for an occasional meal (the dried stuff just doesn't cut it), it sure pays to have some growing right outside the kitchen door. One plant will do, and it's a hardy perennial. The same goes for basil, oregano, parsley, and especially chives, which will never die. Cilantro can be cut back so it won't bolt up to seed, but if it does, you have coriander.

- **Onions** – Why are onions so expensive? According to Siri, "unprecedented demand and rapidly declining supply have me wondering if onion prices are defining a new nor-

mal." Large Spanish onions in the supermarket, at 99 cents per pound, or about 80 cents each, doesn't seem so bad. But how many times have you been forced to drive to the store for one onion to complete a recipe? In the garden, onions stay in the ground for months, and are never bothered by pests.

- **Lettuce** – Wow! \$2.99 for a head of lettuce. Or how about those instant salads in the plastic clam shells that cost \$16 a pound? (Do the math. A 4-ounce package is \$3.99). A single row or container with three or four different colors and flavors will save you big bucks, and it's easy to grow from seed.

- **Spinach** – I admit it's not all that easy to grow spinach, because it is at risk for soil-borne diseases, especially fusarium. But it grows quickly, and costs a small fortune in the supermarket, if you can find it. Spinach does better in sweet soil, so I add lime to keep the soil less acidic.

- **Red Peppers** – They cost more than the green ones, but if you wait long enough, green peppers naturally turn red. Bell peppers are not the easiest crop to grow. Even with prices of about \$1.25 per pepper, you might not save money. You'll need to buy the started plant for maybe \$5 dollars, so you'd need to get four peppers off each plant. Frying peppers like Cubanelle or Gypsy, or hot peppers, will give a much higher yield and a bigger bang for the buck.

- **Saffron** – This spice could be the most expensive item in the grocery store, at \$300 per pound. It's not that hard to grow your own, from crocus sativus that cost \$7.49 for

a bag of 12 bulbs. The saffron fibers are the stamens in the flowers. Harvesting them is labor intensive, but a lot of fun when you think how much money you're saving.

- **Tomatoes** – Not \$64 yet, but a hefty brandywine tomato at a farmers market can cost up to \$8. More typical is \$2.19 for an organic tomato shipped from Mexico that Sue bought at Acme Supermarket. Plenty of people who rarely garden grow a tomato plant in a five-gallon bucket – don't forget to

cut drainage holes. A cherry tomato, especially Sungold, or a compact variety like Patio or Better Bush, will give you an entire summer of fresh delicious treats.

At least start practicing your gardening skills, so you'll be ready when a \$64 tomato looks like a bargain.

excess pastry. Carefully transfer parchment to the baking sheet and chill for 15-30 minutes.

Bake until puffed up and golden brown, about 15 minutes.

Cool completely.

ASSEMBLY

When ready to serve, cut pastry puffs in half to create a top and bottom. Place a dollop of chilled pastry cream on the bottom of each, and fresh berries if using, add tops and lightly dust with powdered sugar. Serve immediately.

Amount depends on the size of the cutter you use.
