Schumer, state & local officials defend Castle Point against possible closure

Veterans, along with NYS Senator Charles “Chuck” Schumer stood together by the Castle Point VA Medical Center campus sign to call attention to a recent Veterans Affairs report. One of the recommendations was the possible closure of the Castle Point campus and having another facility possibly in the Fishkill area.

“To close the Castle Point VA Medical Center with no clear plan in place for the thousands of veterans who use this facility for their healthcare is unacceptable and won’t become a reality. Our brave service members fought to protect our freedom, and to suggest ripping away their local VAMC as we finally see the light at the end of the tunnel from the pandemic cannot pass,” said Schumer. “On top of that, the fact that many of our veterans and community leaders who work nonstop to help them were not consulted throughout this process cannot continue. That is why I am here in Dutchess County today (March 25) standing with our brave Hudson Valley veterans to call on the VA to rework their recommendations and keep tried and true local healthcare options open so our veterans can continue to receive the lifesaving care they need and deserve. Rest assured, I will fight to make sure that these recommendations as written will not make it across the finish line and that the community is involved every step of the way.”

State Senator Sue Serino, Assemblyman Jonathan Jacobson, County Executive Marc Molinaro, some members of the Dutchess County Legislature, and the town boards of Fishkill, East Fishkill and Wappinger also sent a letter to VA Sec. McDonough stating they are against the possible closure.

The Department of Veterans Affairs released its Asset and Infrastructure

Review report, released earlier this month, recommends possibly closing Castle Point VA Medical Center (VAMC) for the purpose of making upgrades. It will submit its own recommendations in 2023 to the president for further review. The AIR Commission must conduct public hearings first.

“The current infrastructure and layout do not meet modern health care standards, and the existing facility requires significant capital investment. FCA deficiencies total approximately \$115.5M, and annual operations and maintenance costs total an estimated \$7.6M. There are 4,998 beds within a 60-minute drive time

of the VAMC with an average occupancy rate of 76.1%. With the declining population, low demand, substantial maintenance cost, and high-quality community partners for inpatient care nearby, Veterans can sustainably receive care in the community,” states the report.

“VA came to these recommendations by asking ourselves one question above all else: what’s best for the Veterans we serve? Because that is our number one goal, today and every day. That’s what our Asset and Infrastructure Review recommendations are all about,” said VA

Renegades set staff for 2022 season

With their 28th season in Wappingers Falls on deck starting next week, the Hudson Valley Renegades minor league baseball team – a High Class-A affiliate of the New York Yankees – unveiled its field staff this week.

Hudson Valley’s season begins with an 11-game road trip on April 8. The Renegades open at home on at Dutchess Stadium on April 19.

Tyson Blaser will take over as the manager of the team, the 17th in team history and the second since the Renegades became a Yankees’ farm team last year.

He is joined on the coaching staff by Pitching Coach Spencer Medick (1st season), Hitting Coach Rob Benjamin (1st season) and Defensive Coach Jose Javier (first season). They will be joined by Athletic Trainer Jonathan Becker (first season), Strength Coach Danny Smith (second season), Clubhouse Manager Ryan Shute (second season), Video Manager Sullivan Lyons (first season) and Advance Scouting Analyst Steven Dimaria (first season).

After a four-year playing career as a catcher and first baseman in the Yankees organization, Blaser begins his sixth season with Yankees Player Development. He spent the 2021 season as the manager of the Florida Complex League (FCL) Yankees, who finished with a 36-16 record, the best in the FCL North Division and second-best in the 18-team Florida Complex League.

Prior to his being named as the skipper of the FCL squad, Blaser served as an assistant coach in the organization with Triple-A Scranton/Wilkes-Barre (2017), the GCL Yankees (2018) and the Short Season-A Staten Island (2019). He was set to manage the Rookie-level Pulaski Yankees in 2020 before the season was canceled because of the COVID-19 pandemic.

Blaser was an All-Big Ten and a four-time Academic All-Big Ten honoree at the University of Iowa, where he earned a degree in history and secondary education. After his playing career and before joining Yankees Player Development, he was

The donor is MacKenzie Scott, an American author and philanthropist. Scott, a billionaire and the former wife of Amazon founder Jeff Bezos, recently donated

a baseball coach and history teacher at United Township High School in East Moline, Illinois.

Medick begins his first season in the Yankees organization in 2022 and makes his professional coaching debut with Hudson Valley. He previously served as a throwing trainer at Driveline Baseball, a data-driven baseball player development

center in Kent, Washington from 2019-22. Before joining Driveline, he was the lead throwing trainer at Prime Sports Performance, and athletic training facility in Glen Arm, Maryland from 2018-19.

He began working at Prime Sports Performance after finishing a four-year professional career as a left-handed pitcher. Medick pitched for the AZL Diamondbacks in 2014, going 3-0 with a 1.17 ERA (30.2IP/4ER) and 32K in 15 relief appearances. He then spent three

seasons playing independent baseball in the Frontier League with the Southern Illinois Miners (2015), Joliet Slammers (2015-16, 18) and Evansville Otters (2018).

He embarked on his professional career after pitching collegiately at Hampden-Sydney College (2010), Polk State College (Fla.) (2011), and Elon University (2012, 13). He graduated from Elon with a bachelor's degree in business administration and management.

Secretary Denis McDonough in a press release when the report was released. "We've spent the last several weeks and months communicating about this with VA employees, union partners, state partners, Veteran service organizations, Congress, and more. I'm continuing to consult with our unions, and will do so moving forward, because I so appreciate the strong partnership we have with them." Earlier this month a spokesperson for Castle Point VAMC said there have been no decision or announcement of Castle Point closing.

Schumer called on the VA to immediately begin to work with local leaders who would be able to provide a more complete picture for the care and needs of the local veterans population. Senator Schumer wrote to the Secretary McDonough. The letter highlighted the mentioned concerns. The senator urged the VA to rework its recommendations to keep the Castle Point open to the benefit veterans across the state.

Celebrating 45 years of community at Stony Kill Farm

Stony Kill Farm Environmental Education Center is celebrating its 45th anniversary this year. Earlier this month a celebration was held to recognize this milestone.

"I often hear folks talk about how Stony Kill is a hidden gem," said Erik Fyfe, Executive Director of Stony Kill.

The 1,000-acre farm, which according to the Stony Kill website, stonykill.org, is the former homesite of the Verplanck family, is located off of Route 9D in the towns of Wappinger and Fishkill. The site is owned by the NYS Department of Environmental Education (DEC). Volunteers with the Stony Kill Foundation operate it.

Stony Kill is where one "can enjoy the historic atmosphere of the place," said Fyfe.

According to Stony Kill historical information, The Stony Kill Foundation, Inc. was chartered in 1977 as a not-for-profit 501(c)(3) organization originally formed as a friends group to support the work of DEC.

Around 2009 and 2010, Fyfe said there was a chance "that Stony Kill would shut down all together" because DEC had to significantly reduce its operations.

The Foundation did what it could to keep Stony Kill open, said Fyfe. It entered an agreement with the DEC to manage the daily operations of the facility.

For the past dozen years, the Foundation has kept Stony Kill going by holding numerous activities, events and programs. Stony Kill is also home to livestock, which includes cows, sheep and chickens. Volunteers are there on the weekends so visitors can stop by during Open Barn hours and visit the

animals. It was in 1980 that the farm was placed on the National Register of Historic Places.

On its website, the Foundation lists its mission, which is to "educate the public and cultivate environmental stewardship through interpretation of the rich historical, environmental and agricultural heritage of Stony Kill Farm."

Stony Kill Foundation's Goals:

1. Provide educational programs that connect people of all ages to sound agricultural practices and environmental stewardship.

2. Interpret the rich cultural history of agriculture in the Hudson Valley.

3. Connect people to the outdoors and appreciate the natural environment of Stony Kill Farm.

Ed Cigna, Vice President of the Stony Kill Foundation, said, "It's a unique experience. Some think of it as a step back but I think of it as a step forward in time and what we should be doing and what's important."

Celebrating the 45th anniversary "recognizes the efforts of so many people for so long who work to keep the Stony Kill Foundation going," remarked Cigna. He said he is very proud of their efforts to keep the farm going.

Tim Stanley, President of the Stony Kill Foundation, said Stony Kill is "that connection to the land and agriculture." He noted the recently formed 4-H group at Stony Kill, Stony Ground.

"These are kids that wouldn't have access to agriculture," said Stanley.

"What Stony Kill Foundation does is integral to the community, as what agriculture does," he said.

Stony Kill is open from dawn to dusk.

\$436 million to Habitat for Humanity International and 83 U.S. Habitat affiliate organizations.

"When I spoke with Mackenzie's representative, I truly was speechless. First by the individual and then by the amount," explained Lashlee.

According to a press release, "This transformational donation will substantially help further Habitat's vision of a world where everyone has equitable access to a safe, decent and financially sustainable place to call home."

In 2019, Scott, who is now married to Seattle school teacher Dan Jewett, wrote in a portion of her Giving Pledge letter, "We each come by the gifts we have to offer by an infinite series of influences and lucky breaks we can never fully understand. In addition to whatever assets life has nurtured in me, I have a disproportionate amount of money to share. My approach to philanthropy will continue to be thoughtful. It will take time and effort and care. But I won't wait. And I will keep at it until the safe is empty."

In a portion of a letter from December 2021, Scott stated, "It's also why I'm not

including here any amounts of money I've donated since my prior posts. I want to let each of these incredible teams speak for themselves first if they choose to, with the hope that when they do, media focuses on their contributions instead of mine."

A representative for Scott could not be reached for comment. When Scott and Bezos divorced, according to reports, she received 4 percent stake in Amazon.

Donation a 'shock' to Habitat Dutchess

"As you can imagine this was a shock to us all in a good way. While there are no restrictions on how we use the gift we want to be good stewards of this opportunity. Habitat Dutchess and our Board is committed to reducing and eliminating the racial bias families of color experience when accessing credit or purchasing a home," Lashlee said. She added, "When housing isn't affordable and secure, families suffer. With Mackenzie's gift we will advance our work to secure access to credit for housing for families of Color long denied an equitable path to homeownership."

Habitat for Humanity International calls donation 'incredible gift'

"This incredibly generous gift will allow us to dramatically increase capacity

and implement programs that will have a multi-generational impact on communities around the U.S. and our global mission for many years to come," said Jonathan Reckford, CEO of Habitat for Humanity International said in a statement on the Habitat website. "With this donation, Habitat is well-positioned to meaningfully advocate for the systemic and societal changes needed to improve equitable access to affordable housing."

According to the statement, "Habitat International will use its \$25 million portion of the donation to prioritize advocacy and programmatic efforts designed to dismantle systemic racism in housing. Specifically, the donation will allow Habitat to advocate for policy proposals and legislation that enable millions of people access affordable housing through its Cost of Home advocacy campaign; increase Black homeownership in the U.S. by targeting current systemic barriers through a new initiative that will launch this summer; and leverage innovative capital investments that service communities of color."

"How many ways are there to say thank you? MacKenzie was quoted as saying that she gives because she has been given

great opportunity in her life and wants to share that. I really want her to know that every family that is able to purchase a home due to her generosity will forever be a testament to her belief that we all deserve a hand up," said Lashlee.

Ode to old time religion

To the Editor:

Thank you, Southern Dutchess News, for printing my late husband's obituary in the February 23, 2022, edition. I unforgivably omitted Michael J. Hirkala, Jr.'s, deep religious affiliation at St. Nicholas of Myra Eastern Rite Catholic Church in Yonkers, NY. It was the fulcrum of his younger lifetime. In fact, one of his grandparents helped found that Yonkers Slovakian neighborhood church.

Michael & I met there after his stint in the Korean conflict and married there in 1969. Finding the home of our dreams did not happen though in Westchester County, NY, but in southern Dutchess County. Travelling during the work week to/from Westchester was fine but commuting there also on Sundays was untenable even when St. Nicholas left its roots in Yonkers and built a church farther north in White Plains, NY.

Total immersion into Dutchess County's lifestyle, including boating and civic duties, prevailed. Not as an excuse, but these views from Rt. 84 overlooking the old IBM East Fishkill and from on high over Amenia on Rt. 44 in Millbrook kind of took the place of organized religion. While growing up in the Eastern Catholic Rite at the Yonkers church was a definitive chapter of his life, as well as ending his last 15 years in the surrounds of Florida waters, the wonder of God's natural world seen from numerous vantage points in Dutchess County was a spiritual experience in and of itself.

Molinaro, Pulver propose resolution on County sales tax on gas, diesel fuel

Dutchess County Executive Marc Molinaro and County Legislature Chairman Gregg Pulver are proposing a resolution to the County Legislature to temporarily amend the County's sales tax calculation on retail sales of motor fuel and diesel motor fuel, capping the amount of sales tax the County collects and offering residents much-needed relief as fuel costs spike due to worldwide pricing forces.

Molinaro is proposing Dutchess County change its sales tax calculation for retail motor fuel and diesel motor fuel purchases to provide the maximum benefit for consumers allowed under State law. The County Executive's proposal would cap the amount of county sales tax collected on each gallon of retail motor fuel at \$.08. Under the current sales tax methodology, consumers pay 3.75 percent county sales tax on their total motor fuel purchase, in addition to a myriad of other State and federally imposed taxes and fees.

Molinaro said, "As the price at the pump skyrockets, I propose Dutchess County do all it can, under New York State law, to ease the pain for local motorists. We recognize this relief is limited, but we must do what we can to help as families, farmers and small businesses are crushed by rising costs. By cutting and capping the county tax on gas - we can provide some assistance and I encourage my colleagues to adopt this proposal."

New York State law imposes strict parameters on how counties tax motor fuel purchases. Counties have two options for calculating the sales tax on motor fuel - a percentage rate method on the total purchase or a cents-per-gallon methodology, calculated at a cents-per-gallon rate which, when applied to the county's sales tax percentage of 3.75 percent, equals either \$2 per gallon or \$3 per gallon. Counties do not have an option to exempt retail gasoline or diesel fuel purchases from local sales tax under State law.

As does nearly every county in New York State, Dutchess County currently uses a percentage rate method whereby the County receives sales tax totaling 3.75 percent of all motor fuel sales in the County; if a gallon of gas costs \$4.25 for example, the County receives \$.16 per gallon in sales tax. Under Molinaro's proposal, the County would implement a cents-per-gallon methodology, rather than a percentage of a climbing price, with county sales tax charged only on

the first \$2 of the per-gallon gasoline price, or a total of \$.08 per gallon.

Pulver said, "Our nation is currently experiencing inflation the likes of which we haven't seen in some 40 years, including recent spikes at the pump. County Executive Molinaro and I feel strongly about cutting and capping the County's tax on motor fuel to help families throughout Dutchess County during these difficult economic times, and I urge my fellow legislators to approve this measure to bring relief to residents."

The County Legislature will vote on the resolution to cut and cap the local county sales tax on retail motor fuel purchases at its April 11th board meeting, and the new sales tax cap would be effective June 1, 2022, pending approval of the New York State Commissioner of Taxation and Finance, and it would expire on December 1, 2022. New

York State law states local sales tax enactments of this kind can take effect only on March, June, September or December 1st of any year and a certified copy of the local enacted resolution must be transmitted to the State at least 90 days prior to the effective date. The New York State Commissioner of Taxation and Finance may reduce the 90-day notice requirement period to not less than 30 days - Dutchess County will request this waiver.

Legislator Yvette Valdés Smith, Minority Leader of the Dutchess County Legislature, said, "Skyrocketing gas prices have affected every single resident of Dutchess County. As a working mom, I know how difficult it is to make ends meet, so I am proud to partner with my colleagues in the Legislature and the County Executive to cap the gas tax and help ease the financial strain that our communities are experiencing. We recognize that this is a first small but important measure and are committed to continue looking for ways to help the residents we serve."

Legislator Will Truitt, Majority Leader of the Dutchess County Legislature, said, "Unlike the failings of leaders at other levels of government that have led to the exponential increase in gas and diesel prices recently, locally we continue to take action to provide relief. I fully support County Executive Molinaro's and Chairman Pulver's resolution to provide savings at the pump with this tax cut and cap and I look forward to its enactment so our neighbors throughout the County can keep more of their hard-earned dollars."

The county dashboard doesn't include data on boosters; however, according to the CDC, 51 percent of the county's fully vaccinated population has received a booster, up slightly from 50.9 percent on March 20.

Currently, the CDC classifies Dutchess as a *low-risk* county.

Lawsuit against Town of Fishkill discontinued

A lawsuit filed against Town of Fishkill Supervisor Ozzy Albra and the Fishkill town board was recently discontinued, according to a town document. Late in 2021, the town board passed a resolution authorizing reimbursement of some of Albra's legal fees stemming from another lawsuit, which was filed in Westchester County after Albra took office as supervisor. The judge dismissed that case on a Motion to Dismiss. The town board

passed a resolution authorizing reimbursement of some of those legal fees at its Nov. 17, 2021 meeting. Albra recused himself from the discussion and abstained from the vote.

The recently discontinued lawsuit sought to prevent the resolution of legal reimbursement from being carried out.

"I'm thankful for that the court sided with me in both instances," said Albra.

Veterans Financial Health Seminar Series to kick off April 12

We often talk about how mental health is a big part of a veteran's overall health, and rightfully so. When our mental health suffers, our overall health will suffer, too. Luckily, we have great organizations right here in Dutchess County that directly address the mental health of our heroes, like MHA Dutchess Vet 2 Vet. But what about a veteran's financial health? I think sometimes we forget how dealing with our finances – or the lack thereof – can really add stress and strain to our lives.

When veterans are discharged from their military service, there is no class or seminar to help them transition into civilian life. Many times, our veterans struggle with the adjustment to the real world. I know, because I certainly did when I left the Navy in 1997. No one teaches you the basic things you'll need such as managing your credit score, applying for a home loan, or starting your own business. County to host training addressing Mental Health of Autistic Adults

The Dutchess County Department of Behavioral & Community Health (DBCH) will host a special training, virtually via Microsoft Teams on Friday, April 8 from 9:30 a.m. to 4 p.m.

The workshop will be led by psychologist Dr. Valerie Gaus, PHD, who will offer insight on how to formulate and deliver appropriate treatment or support plans and explain how to conceptualize Cognitive Behavior Therapies for adult individuals living on the autism spectrum. Registration is required in advance and is available online at dutchessny.gov/DrGaus.

The day-long workshop's programming has been designed for an interdisciplinary audience, including mental health and rehab clinicians, educators, administrators, and advanced direct support workers, but the training is open to all who are interested in learning more. This training is part of the County's continued effort to ThinkDIFFERENTLY, the initiative started in 2015 by County Executive Marc Molinaro, which seeks to change the way individuals, businesses, organizations, and communities relate to their neighbors of all abilities.

Molinaro said, "Mental health practitioners around the County are increasingly seeing adults in their therapy settings who have autism spectrum disorder (ASD), in addition to the anxiety or mood disorder for which they sought treatment. It is important that all providers are aware of how to treat such patients and give them equal care. Dr. Gaus is a great resource regarding treatment of individu-

als on the spectrum, and I am confident those attending will receive vital information to help them properly treat people of all abilities."

Topics to be discussed throughout the day include:

- The variety of ways autism spectrum disorder symptoms can appear in more cognitively able, independent adults;
- Typical problems seen in adults with ASD who seek a variety of clinical or support services;
- Considerations in formulating an individualized treatment or support plan for an adult with ASD as well as stress or mental health problem; and
- Practical applications of Cognitive Behavioral Therapies for clients with ASD, with and without modifications.

Dr. Gaus, a psychotherapist of 28 years, has three published books on working with individuals with autism. She will lead the workshop and discuss how the definition of autism spectrum disorder (ASD) has broadened over the last 20 years, which has contributed to the growing number of diagnosed adults who are bright, verbal and functioning independently in many areas which makes a need for such discussion necessary. Her presentation will discuss best practices on guidelines and how to formulate and deliver appropriate treatment or support plans for individuals with ASD.

New website contains resources in NYS to help Ukrainian people

Governor Kathy Hochul announced the launch of a new website containing resources offered by New York State and its partners to help Ukrainian people and their friends and allies here in New York. This follows the Governor's announcement warning consumers about scams and cybersecurity threats amid Russia's invasion of Ukraine. In an additional show of support, the Governor also announced the Ukrainian flag was flown on the Capitol building, the Executive Mansion, and the Division of Homeland Security and Emergency Services headquarters.

"Ukraine's resilience against Vladimir Putin's tyranny is an inspiration to the rest of the world, and many New Yorkers are already doing their part to support humanitarian efforts," Governor Hochul said. "In moments like these, New Yorkers always stand together to support those in need. We are proud to provide trusted resources for those who want to lend a helping hand for our Ukrainian brothers and sisters here in New York."

This directive comes amid Governor Hochul's ongoing efforts to support Ukraine. Last week, the Governor announced an Executive Order to prohibit state agencies and authorities from contracting with entities that continue to do business in Russia. In early March, Governor Hochul announced actions to strengthen the Department of Financial Services' (DFS) enforcement of sanctions against Russia, including the expedited procurement of additional blockchain analytics technology. In February, Governor Hochul ordered all state agencies and authorities to divest public funds from Russia and stop doing business with Russian companies.

Support Services

The Office for New Americans (ONA) provides a variety of free support services to all immigrants and refugees in New York State, regardless of status, such as:

- Access to free legal support including asylum applications and deportation defense through its network of legal service providers
- English language courses through its network of Opportunity Centers
- Access to mental health support groups through its Golden Door Program
- Workforce readiness tools including resume writing, digital literacy skills, and credentialing evaluation
- Support to access developmental disability services through the ONA Ramirez June Initiative

Visit the Office of New Americans website or contact their hotline at 1-800-566-7636. The NYS New Americans Hotline connects immigrants and refugees to free services across the state. The Hotline operates from 9 a.m. to 8 p.m., Monday through Friday, except holidays. All calls are confidential. Assistance is available in over 200 languages, including

Ukrainian and Russian.

If one is a U.S. citizen in Ukraine, the U.S. State Department has resources for those wishing to depart. They also offer travel conditions and land border guidance for surrounding countries including Poland, Romania, Hungary, Slovakia, and Moldova.

U.S. citizens in Ukraine should complete this online form so that the State Department can communicate with you. U.S. citizens seeking to depart Ukraine can also call 1-833-741-2777 (in the United States) or 1-606-260-4379 (from overseas) for immediate assistance. One can also visit the Ukraine Crisis page on the State Department's website.

The Consulate General of Ukraine in New York is currently providing consular services. However, all consular services which require receiving documents from Ukraine, including issuance of new passports and visa services, have been suspended until further notice.

If one has visa or passport questions, contact the Consulate General by emailing gc_usn@mfa.gov.ua or calling either 212-371-6965 or 212-371-5690.

Ukrainians in New York and who are experiencing an emergency situation (e.g. detention), can call the Consulate's hotline number at 917-325-1444 for assistance.

Immigration Assistance

Protections may be available for eligible Ukrainians already present in the U.S. As a result of the Russian military invasion, the Department of Homeland Security announced the designation of Temporary Protected Status (TPS) for Ukraine for 18 months. Individuals eligible for TPS under this designation must have continuously resided in the United States since March 1. Ukrainians eligible for TPS can contact the NYS New Americans Hotline for free legal assistance at 1-800-566-7636.

If one has recently been granted asylum, the Office of Temporary and Disability Assistance, through contracted providers, offers free services to asylees across New York State.

Visit a provider in one's area that can assist you with:

- Finding employment
- Free health screening and immunizations
- Accessing other support services

Emotional Support

users: The national Disaster Distress Helpline (DDH) is now offering direct crisis counseling and support for Deaf or hard of hearing American Sign Language users via a dedicated videophone option. Disaster survivors and responders can connect with trained DDH crisis workers fluent in ASL by dialing 1-800-985-5990 from a videophone-enabled device or via an "ASL Now" link which can be accessed at DisasterDistress.samhsa.gov.

Humanitarian Aid

Avoid donation scams. Anytime disasters occur, scam artists prey on the heartstrings of individuals looking to help. The invasion of Ukraine provides an opportunity for fraudsters to set up fake charities or pose as compelling war victims. Others design websites to mimic a legitimate charity's official site to steal unsuspecting donors' money and/or personal information.

To prevent donation money from falling into the wrong hands, the New York State Division of Consumer Protection recommends taking the following precautions:

- Verify the request. Scammers are more frequently posing as friends, family or romantic interests on social media and requesting donations. If you receive an unsolicited request for donation relief online, even if it appears to be someone one knows, connect with the person directly through a different communication link to verify the request. Do not click on any links or complete forms before verifying the source. If the request is coming from someone you only recently met online, it is most likely a scam and one should be especially wary.

- Research the charity. Don't rely on a charity website alone. Search online before donating to any charity using the name of the group plus search terms like "review" and "scam". The Federal Trade Commission recommends checking with give.org, charitynavigator.org, charitywatch.org, or candid.org to see reports and ratings for charities. One can also check with the Internal Revenue Service (IRS) for verification that a charity is registered. The Office of the Attorney General also recommends reviewing the Charities Registry for financial reports

prior to donating to ensure the charity is fiscally sound.

- Resist high-pressure tactics. While the situation is urgent, consumers should resist being pressured to donate immediately. Scammers often pressure one to donate immediately, causing you to overlook red flags in their story. Beware of direct e-mails from "victims" and solicitors who employ heart-wrenching stories, insisting that you donate immediately. Do not give money over the phone to unsolicited telemarketers; instead, ask the caller to send written materials about the charity and where to donate, if one chooses.

- Keep personal information private. Never give one's Social Security number, credit card or debit card number, or other personal identifying information in response to an unsolicited charitable request. If donating online, ensure that one's internet connection is secure before following through on donation requests.

- Ask how your money will be spent. Consumers want to know that their money is going directly to the victims. A genuine charity should be able to let you know how much of your donation will go directly to the program as opposed to administrative fees.

- Donate by check or credit card. Never give money using cash, gift cards, crypto currency, or any tender that would be difficult to trace. Give your contribution by check or credit card to ensure that you have a record of the donation. Make checks out to the charity, not to an individual. If you choose to donate via a charity's website, check that the website is secure and that your computer is equipped with the latest anti-virus protection.

If one suspects that one has encountered a fraudulent attempt to receive donations, one can file a complaint with the New York State Division of Consumer Protection.

Notes from the Town of Wappinger Supervisor

Contingency and Assistance Planning in 2022

As we enter the last couple days of March “madness” (basketball, weather, and back-breaking yard work in preparation for spring plantings), we also begin a period of spiritual hope, redemption and social outreach. I also hope that it will begin a period of healing and renewal.

During the next few weeks of April, collectively through our various faiths and beliefs, we will experience a number of important observances, including: Easter (Eastern Orthodox and Christian), Ramadan, Passover, Vaisakhi, Ridván, Qingming Festival, and a few others I apologize for omitting. During each of these events diverse peoples will seek a recharging of their: energy; faith; and, hopefully, assistance to our fellow mankind. It is also a time for mental, physical, and moral healing. More important, this year it must be a period of forgiveness and caring, not just today, but in the months and years ahead.

During the near-term future, humanity will, unfortunately, encounter many new threats and challenges, most of which both my and my children’s generations have never experienced. And, most definitely, such that we have never experienced at the same time. Whether it is: post-pandemic illnesses (mental and physical); war and anarchy; inflation and recession; racism and intolerance; and

political schisms, the challenges to be placed before each and all of us may be immeasurable and very painful.

As I have noted in the past, the Wappinger Community is truly blessed by nearly 40 different faith communities with strong roots throughout our Town, Village, and Hamlets. - Keeping our taxes low including minimizing unreasonable increases in property tax levy/assessments and town-controlled taxes. For example, I believe that the tax levy should be capped well-below 10% during this assessment year (most specially for our seniors/retires, disabled, veterans, and single parent families);
- Working with the various faith, and also our other community organizations such as Rotary, Knights of Columbus, VFW, CAPE, DC Stabilization Center, Grace Smith House, etc., to provide more

opportunities for assistance to our less fortunate, especially as inflation hits us all hard;

- Assisting with community-wide efforts on opioid abuse; discrimination; bullying and abuse, to name a few;
 - The Town Board will implement “contingency planning” for its revenue, expenses and budget -- just as we did in 2019;
 - Maintaining limits on Town staff wage increases to try to minimize the wage-price inflation spiral;
 - Improving community services by finalizing the renovation of Spookhill Park and initiating new projects at Carnwath (to create a new recreation and senior center with several thousand square feet buildout). Also, reactivating our Carnwath kitchen and completing our Carnwath community garden plans to be used to enhance community outreach;
 - Expanding our support for youth activities, both town recreation department-sponsored and those of youth organizations such as baseball, softball, and soccer. we will continue to improve upon youth fields and facilities;
 - Further building out of basic infrastructure, especially water and sewer services; and
- These and other initiatives will be dis-

cussed at Town Board meetings during the months ahead.

In closing, I also pray for the Ukrainian people, who are experiencing war and deaths. Bless their and our leaders with wisdom, to build together a world of justice, and to break down walls of hostility. Until soon, please stay safe and remain well.

County opens Municipal Investment Grant application process

Dutchess County Marc Molinaro announced the County’s Department of Planning and Development has opened the application process for the 2022 Municipal Investment Grant (MIG) Program, with approximately \$4 million available through a competitive grant process to entities which have taxing authority, including cities, towns, villages, fire districts, and water and wastewater public authorities, prioritizing projects that partner with other municipalities and taxing authorities, develop shared services, align with the County’s priorities and needs, and create savings for taxpayers.

In addition to providing funding for traditional MIG municipal projects, this year’s MIG program is prioritizing fire and rescue agencies, including municipal,

non-profit and established fire districts, as highlighted by County Executive Molinaro in his 2022 Executive Budget. This year’s MIG program also focuses on two additional areas:

General Shared Services: Transformative municipal cooperative activities that result in fiscal and operational efficiencies and/or cost savings, while optimizing municipal resources and providing an equal or better level of service. Priority will be given to entities that identify and demonstrate best practices that will result in immediate savings, shared services, efficiencies, or an increase to the municipal tax base, while demonstrating a long-lasting community impact, including a reduction of the property tax levy.

Community Development: Projects that improve the quality of life for residents and strengthen and develop communities. Eligible projects include public facilities and improvements, water and wastewater, and environmental sustainability.

Molinaro said, “The safety and well-being of Dutchess County residents is a top priority, and providing critical funding for local fire districts to enhance their ability to respond to emergencies is an important step in protecting our residents, hence the focus on these life-saving agencies in this year’s Municipal Investment Grant Program. I encourage communities and other eligible bodies, including fire districts, to develop innovative applications and pursue this funding opportunity to better serve all those who live, work

and raise a family in Dutchess County.”

Through the MIG program, Dutchess County will continue to fund general shared services that result in cost savings, with a focus on redevelopment and improvements to existing municipal parks and recreation areas, Americans with Disabilities Act (ADA) accessibility improvements at public facilities, construction of new sidewalks and connector trails, and critical improvements to infrastructure and facilities.

Additional information, application instructions and guidance about the 2022 MIG Program is available online. Applications will be accepted via an online portal through May 4th at 3 p.m., and awards will be announced in summer 2022.

Sheriff’s Office to conduct boat safety courses

Dutchess County Acting Sheriff Kirk A. Imperati announces that over the next several months, marine patrol deputies will be conducting boating safety courses to educate boaters and to encourage safe and lawful operation of vessels in compliance with Brianna’s Law.

Sheriff Imperati said, “I’m pleased to welcome the public back into the Sheriff’s Office Law Enforcement Center and have our marine patrol deputies instruct the New York State Boater Safety Course. The interaction that our deputies have with boaters in the classroom promotes positive conversations about safe boating, compliance with the law, and recognition of hazards on the waterways. We want boaters to enjoy their time on the water and reduce the risk of accidents.”

Brianna’s Law is named after Brianna Lieneck, an 11-year-old girl from Long Island, New York, who was killed in a boating accident in 2005. This law phases in mandatory boater safety education for individuals who operate motorized vessels. Failure to comply with this law could result in a fine of between \$100 and \$250.

- Those born on or after Jan. 1, 1993 needed a boating safety certificate beginning in 2020.

- Those born on or after Jan. 1, 1988 will need a boating safety certificate beginning in 2022.

- Those born on or after Jan. 1, 1983 will need a boating safety certificate beginning in 2023.

- Those born on or after Jan. 1, 1978 will need a boating safety certificate beginning in 2024.

All motorboat operators, regardless of age, will need a boating safety certificate beginning in 2025.

Each boater safety course offered by the Sheriff’s Office will be conducted on a Friday evening and Saturday morning. Attendees must attend both days of the course. Courses will be held in the Dutchess County Sheriff’s Office Law Enforcement Center Community Room as follows:

Saturday, April 2, from 8 a.m. - noon

Students evaluate math techniques at Pi Day Recognition event

On Pi Day, March 14, 2022, students from Wappingers Central School Districts (WCSD), Spackenkill, Arlington and Tuxedo Park were recognized for their outstanding effort in learning math at more than 5 grades above their grade level. The math enrichment program developed at the Math & Physics Exploration was able to integrate the best of the pedagogical techniques for teaching math so that the students could better understand math and solve problems well beyond what they were taught.

County Executive Marc Molinaro, WCSD Superintendent Dwight Bonk, Assistant Superintendent Michelle Cardwell, Congressman Antonio Delgado, Congressman Sean Patrick Maloney, State Senator Sue Serino, Chairman of the County Legislature Gregg Pulver and Assemblyman Kieran Lalor signed certificates of recognition and/or made speeches praising the students for their mathematical accomplishments.

Town Supervisors Alan Bell of LaGrange, Jon Baisley of Poughkeepsie, Nicholas D'Alessandro of East Fishkill, Richard Thurston of Wappingers, and Ozzy Albra of Fishkill also signed signed certificates and/or gave speeches to praise the students.

Dr. Bonk and Dr. Cardwell kicked off the ceremony with praise of principals, teachers and students involved with the math enrichment program.

Several students and their parents were selected to write speeches and give presentations on the impact that this enriched math program had on them. The Eisley family was very special in that the older son Nathaniel in Van Wyck had taken the program for two years and their younger son Bennett in Fishkill Plains took the program this year.

Nathaniel commented: "Some of the things I took away included confidence, the ability to present to people and answer questions with a lot less doubt in my answers, and a love for math and how math works." His math teacher was so impressed with Nathaniel that he recommend that he become a math teacher.

Bennett said, "The Enriched Math course helped me a lot in my regular math class. Without it, I feel like it would be a lot more difficult to figure out problems and I probably wouldn't be at the top of my class in math. It has

been a great year."

Their mother Andrea said, "I have been an Enriched Math parent over the past three years, and have only positive things to say of it! Bennett has grown in his confidence this year with the class and loves to ask me if I can do some of the complicated problems he has worked on."

Eleanor from the Oak Grove school compared the techniques for doing multiplication in the enriched math program to those she learned in school. She explained the shortcomings of these techniques by doing an 18 x 18 digit multiplication in which she discovered that in doing it the normal way it would be impossible to get the correct answer, even if you could complete the problem. She was able to complete the problem with the Math & Physics Exploration approach in about 10 minutes with ease. Her parents are so proud of her accomplishments, particularly since math was not their favorite subject when they went to school.

Aanya says, "I use to think my skills were good, but now that I learned all these tricks my skills have improved to a more advanced level. I can also do multiplication in a snap, I also checked my work and I have reduced the number of mistakes I have made. After all my years of school, I have never been taught or have seen the Miller method until now. I thought it would just take the same amount of time and work and just reduce it by 5 minutes. But I was wrong, the Miller method narrowed my time and digits from 30 min, and 324 digits, to 15 min and around 60 digits

(that's a lot better)! After joining the math enrichment program, my work has begun to be neater and much cleaner from mistakes. Since I now check my work to make it clear, I make sure my numbers line up because if I move a digit wrong I can add up wrong and the whole problem could be a disaster!"

Gabrielle also from Oak Grove commented, "As I completed the problem for the first time, I was getting frustrated as I was comparing my answer to the correct answer. So I gave up. As I reached the end for the second time, I never checked it at all! But, before I started this essay, I checked my work finally with the correct answer. And, I had only made one silly mistake. I now realize that as I did the problem again, I was becoming a bit more fluid than how I was during the first attempt. All and all, my reactions for the equation were a bit mixed, but that tells me that if I ever need to do the equation again, I will be ready for it."

Veda from Brinkerhoff said that ever since she joined the program, she noticed a new surge of confidence. Doing the 18 x 18 digit multiplication, she felt it was as easy as doing one plus one. Using these math tricks makes her overflow with pride, because she is learning something that many adults struggle to do.

Zaynab from Brinkerhoff said that "your studying habits effect your learning and understanding of any subject. Dr. Miller teaches us the proper way to study, a method that does not waste your time. What shocked me the most is that studying math does not mean staring at a piece of paper, it's more of doing."

Lawmakers lead push for Lyme Disease funding in final state budget

With zero new dollars included in either the NYS Assembly or Senate One-House Budget Proposals to combat the spread of Lyme and tick-borne diseases (TBDs), Senators Sue Serino, Daphne Jordan, and Alexis Weik joined researchers, patients, and advocates from across New York in a virtual press conference on Monday to urge legislative leaders to invest in research, education and prevention initiatives in this year's State Budget. The coalition is pushing for at least \$1.5 million to be included in the final enacted budget that is slated to pass by April 1.

"As the number of Lyme and tick-borne disease cases continues to climb, and the state sits on a significant budget surplus, now is the time to make meaningful investments in research, education, and prevention initiatives that can protect New Yorkers from the spread of Lyme and TBDs for generations to come," said Senator Serino. "Not including any funding to help prevent the spread of these diseases that impact thousands of New Yorkers each year defies logic. With only days to go before a final budget is expected to be voted on, we are asking our colleagues to do the right thing, ensure that the voices of New Yorkers who live with these devastating diseases are heard, and include significant funding to help put an end to the Lyme and tick-borne disease epidemic in the final state budget."

With New York being home to the second highest number of confirmed Lyme disease cases in the nation, presenters argued that the number of ticks and the diseases they transmit are increasing across the state. According to the Centers for Disease Control and Prevention (CDC), among the infections that can be transmitted to humans through the bite of a tick, Lyme disease makes up over 80 percent of the cases reported to the agency. The CDC also estimates that there are nearly a half million new cases of Lyme disease in the US each year, which makes Lyme the third most common bacterial infectious disease in America. However, due to inaccurate diagnostic testing, the actual number of cases remains illusive.

Piscine pleasures

Four creative ways to enjoy fish

If I had to venture a guess, I'd say more people are eating fish now, both for health reasons and because it's Lent. Maybe it's a holdover from the fish sticks of our youth or the fact that we don't live by the ocean, but a lot of people opt for fish and chips in these here parts this time of year. And while that's tempting and tasty, frying up a cod fillet isn't the only – or healthiest – way to go. If you're stumped or just in a rut when it comes to fish recipes, you're not alone. But if you want to include more fish in your diet I'm here to help.

Unlike other proteins, most fish doesn't require long cooking times and there are lots of methods other than frying to try. Fresh fish is also versatile when it comes to seasoning and pairing. That means you can have a light, healthy meal in minutes. Sound good? Read on!

A quick note before we get to it: you can substitute any type of fresh white fish for these recipes. All of these happen to use wine but that can be swapped out for another liquid if you prefer, such as chicken stock, water or apple juice.

PECAN-CRUSTED HALIBUT Rich, delicious and good enough for company! INGREDIENTS

- Olive oil
- 1 leek, rinsed and sliced (white part only)
- 1-2 shallots, peeled and finely chopped
- 2 cloves garlic, minced
- 1/4 cup cooking sherry or dry white wine
- 1/2 cup chopped pecans
- 4 (6oz) halibut fillets
- Salt, pepper and fresh lemon

METHOD

Preheat oven to 350 degrees. Line a baking sheet with foil, coat with olive oil and

set aside.

Heat 1 tablespoon of olive oil in a skillet over medium-high heat. Add leek, shallots and garlic and saute until tender, about 5 minutes. Remove from heat and set aside.

In a separate skillet, combine sherry and pecans and cook over medium heat, stirring occasionally to prevent burning or sticking, until liquid evaporates, about 10 minutes. Set aside.

Place fish fillets on prepared baking sheet and season with salt and pepper and a squeeze of lemon. Top each fillet with the leek mixture and pecans and bake 8-10 minutes. Serves 4.

BAKED ORANGE FLOUNDER FILLETS over mushrooms

Flounder works well in this delectable dish. The orange/white wine sauce adds lovely flavor while sandwiching the fish between the mushroom layers keeps it succulent and moist.

INGREDIENTS

- Olive oil
- 3 cups fresh sliced cremini or white mushrooms (10-12)
- 6 scallions, chopped
- Salt and pepper to taste
- 2 flounder fillets
- Fresh oregano and parsley, chopped
- 1/2 cup dry white wine
- 1/4 cup fresh squeezed orange juice
- 2 tablespoons olive oil

METHOD

Preheat oven to 350 degrees. Lightly coat a baking dish with olive oil or cooking spray. Spread half of the mushrooms and scallions evenly over the bottom of the prepared baking dish. Sprinkle with black pepper. Place 2 (flounder) fillets on top of mushrooms, season with salt and pepper and fresh

chopped oregano and parsley. Cover with remaining mushrooms and scallions.

In a small bowl, whisk together wine, orange juice, and olive oil. Pour over fish, cover with foil and bake 30-40 minutes. Sprinkle with chopped fresh parsley. Serves 2.

COD FILLETS with GREEN OLIVES IN WINE

Started in a skillet and finished in the oven in a baking dish, this easy entrée is as elegant as it is flavorful, and all in about 30 minutes.

INGREDIENTS

- 4 (1 1/4 inch thick) cod fillets
- Olive oil
- Salt and pepper to taste
- Fresh lemon juice
- 1/2 cup dry white wine
- 1/2 cup pitted green olives, sliced or halved

METHOD

Preheat oven to 450 degrees. Heat 1 tablespoon of olive oil in a skillet. Season fish with salt and pepper and sear until golden brown on both sides (3-4 minutes). Transfer fillets to a baking dish. Squeeze a little fresh lemon juice over fish and set aside.

Add wine to the skillet to deglaze it, scraping up any browned bits. Bring to a boil and continue to cook for 20 minutes more. Pour over fish, add green olives and bake uncovered until just cooked through, about 10 minutes. Transfer fish to a platter. Add a little more fresh lemon juice and 2 tablespoons olive oil to the wine left in the baking dish and whisk to blend. Season with more salt and pepper and spoon over fish. Serves 4.

HADDOCK BAKED IN FOIL

Many fish fillets can make a light meal in themselves, especially when baked with

vegetables in foil. Everything in the packets adds flavor while they cook.

INGREDIENTS

- 2 haddock fillets
- 4 cups fresh spinach or arugula
- Olive oil
- White wine
- Fresh lemon juice
- Salt and pepper to taste
- 1 cup diced tomatoes
- 1 medium red onion, thinly sliced
- Fresh thyme and/or parsley

METHOD

Preheat oven to 400 degrees. Lay 2 large pieces of foil on a flat surface. Divide spinach or arugula evenly between the center of each foil piece. Place fish fillets on top and sprinkle with olive oil, lemon juice and white wine. Add tomatoes, onion and fresh herbs. Season with salt and pepper, then fold and seal foil to make packets. Place packets on a baking sheet and bake for about 10 minutes. Open packets carefully as steam will billow out. Serve alone or with rice.

So there are four very different recipes to try next time you find yourself in a fresh fish rut. I'm hoping I've inspired you to eat fish more often, with or without chips. Enjoy!

Our Greenhouse

Forty local Cornell University alumni visited Adams Greenhouse, Inc. last Saturday. The wholesale growing area, located behind Adams Fairacre Farms Poughkeepsie store, was set up in 1978, as a separate business owned by me and Sue Adams. (Sue is a Cornell alumna; I dropped out).

Together with 35 team members, we produce millions of flower and vegetable plants in five acres of greenhouses, sold to local garden centers, but mostly to the four – soon to be five – Adams retail stores, which are now owned by my cousin Patrick Adams.

Our greenhouses are not open to the public, so the tour participants were eager to see what goes on “behind the scenes.” Sue and I answered a lot of questions:

Q: How did you get into the business?

A: When Adams was a vegetable farm, we grew transplants to set out into the field, in a small greenhouse. One year we had some tomato plants left over, so we potted them up and sold them at the store, which back then was just a roadside stand. They were so popular that we built more greenhouses to grow “garden plants,” including flowers. Eventually, the greenhouse operation overshadowed the farm, and I asked my dad if I could run it as my own business. As Adams Fairacre Farms retail expanded, I had to keep up. Fortunately my wife Sue, the Cornell graduate with a degree in economics, joined in, along with an amazing crew of horticulturists, production managers, growers and drivers.

Q: How do you decide what to grow?

A: Sue and I, but mainly Sue, visit flower trials all over the world to check out new varieties. Last summer Sue visited trials in North Carolina, Pennsylvania, New Jersey, New Hampshire and Cornell University. We also have our own trial garden, and conduct an online survey where we post new varieties of flowers that we grow from transplants sent to us by breeders. This year's winner of the online survey was Delosperma (Iceplant) Ocean Orange Glow. In my vegetable garden, I try new crops. That's how I discov-

ered my favorite tomato – Big Beef. This year I am trialling the radish “Red King” and lettuce “Cherokee.” Also, this is our first year growing the new downy mildew resistant basil “Prospera,” developed at Rutgers University.

Q: Do you grow genetically modified crops (GMO's)?

A: No. It just so happens that garden plants sold to homeowners are not genetically modified. The companies working on genetic modification are going after big dollar crops like soybeans, corn, cotton, and canola (used for vegetable oil). I've heard about a genetically modified petunia. We don't grow it.

Q: Are the plants you produce certified organic?

A: No. We use water-soluble chemical fertilizers (Jack's, which is similar to Miracle Grow). We practice Integrated Pest Management (IPM), where any sprays are applied only if problems appear. I am a certified pesticide applicator, and of course follow all label directions. We have to be sure we sell clean plants.

Q: Do you manipulate day length to change bloom times?

A: That was one of the surprisingly technical questions I got. We do pull black cloth over hardy chrysanthemums so they will bloom a week or two earlier than normal. It seems that people want to buy them in early September instead of October, flowering, not just with tags. I light pansies so they bloom earlier, which was a mistake this year, since I have thousands of pansies in full bloom, and it's too cold to plant them outside.

Q: Do you have alarms that call you when the heat goes off?

A: I have two alarms. The first one triggers at 42 degrees, with a voice message that says “temperature problem in the greenhouse.” That gives me enough time to get dressed, and get up to the greenhouse to fix the furnace before the plants freeze. The second alarm triggers at 28 degrees, with the message “the plants are frozen. Go back to bed.”


