Autism Supportive Training: Here's how to help and 'make a difference'

Noise is simply a nuisance for some people. To those on the Autism spectrum, over-stimulation can create discomfort in unfamiliar environ ments. Autism Acceptance Month in Dutchess County shows an increased commitment to our autistic neighbors, as more organizations are equipped with tools and education to support inclusion.

Autism-supportive employment and events promote safe spaces for everyone to spend time doing what they love, whether it's work, play, or community engagement. Anderson Center for Autism's Consulting and Training Team (ACCT) has for years provided community organizations with the education to best support autistic customers, employees and neighbors.

As of 2020, about 1 in 36 U.S. children are diagnosed with autism. From 2011 to 2022, autism incidence rates rose 175%, according to the American Medical Association's JAMA Network.

Director of Anderson's ACCT Program Services, Kathleen Marshall, says that inclusion takes a willingness to understand someone's challenges. Individuals may fear saying the wrong things to an individual on the Autism spectrum, but all they need to do is ask. "Approach with humility," Marshall explained. "Say, 'I want to welcome you. Is there anything you want to share with me that would help to provide a better experience?'

Employment is one way that anyone can contribute to their community. Many individuals on the Autism spectrum find belonging in taking full or part-time work, enrolling in college, or joining interest groups. Though autistic employees represent a small percentage of the workforce, said Marshall, simple training and accommodations can help businesses

welcome more neurodivergent employees into the workforce.

The Village of Rhinebeck Autism Supportive Community Committee was created to designate an entire Autism Supportive community. This organization

empowers businesses to welcome neurodivergent customers and to hire individuals on the Autism spectrum.



Ribbon-cutting ceremony for Zion **Episcopal Church** renovations set for April 5

Zion Episcopal Church in
Wappingers Falls has been undergoing renovations. The Wappingers
Falls Business and Professional Association will host a ribbon-cutting ceremony Saturday, April 5.

"The major masonry and renovation projects at Zion began in the spring of 2023, but the current project, the restoration of the front facade and bell tower, began in the summer of 2024. The front entrance of the church has been closed since February 2024, due to safety concerns, so it has been over a year since the front doors of the church have been open to the public," explained Father Alex Herasimtschuk. According to him, parishioners have said the last remodel to the front of the church was done in the 1960s, under the leadership of Father Whistler.

As for the cost, Herasimtschuk said, "All of the front restoration work, which includes masonry repair and repointing, bell tower louver replacement, carpentry and painting, plus the demolition and installation of our new stairway, cost \$250,000. In May of 2024, we received a \$215,000 Bedell Fund Property Grant from St. Matthew's Church in Bedford, which is the sole reason we were able to afford such extensive and costly restorations. The Bedell Fund Committee and St. Matthew's Vestry will be present at the ribbon cutting."

Jackie Muller, president of the WFBPA said, "The Wappingers Falls Business and Professional Association (WFBPA) is proud to celebrate the unveiling of the newly renovated façade of the historic Zion Church. This event honors the church's deep roots in our community and its ongoing commitment to service, history,

What makes the entrance at Zion Episcopal Church historic?

"Whenever people ask me where I serve as a Priest, I tell them "at the large stone Church on Main Street," and everyone knows what I am talking about. As a historic landmark, Zion, along with the Grinnell Library and Mesier Homestead, is a centerpiece of the Village of Wappingers Falls that everyone seems to recognize," explained Herasimtschuk. "The basic appearance of the front of Zion Church has remained largely unchanged since it was first constructed in 1834, so the people of Zion understand how important it is that we preserve the overall appearance and beauty of this familiar historic structure, which we call our spiritual home."

String of successes highlighted in Poughkeepsie Mayor's State of the City Address

City of Poughkeepsie Mayor Yvonne Flowers delivered the State of the City Address Friday night at the Bardavon 1869 Opera House, citing a string of funding and project successes in her first year in office that have continued into 2025.

Flowers' speech came after the recent announcement by the state of a \$10 million grant to the city through the Downtown Revitalization Initiative program. That money can go to various development projects, streetscape improvements, facade renovations and much more in the downtown area.

"We've made tremendous strides in first 15 months – ending a longstanding budget deficit, securing the DRI grant, helping to create a Business Improvement District, obtaining money for housing initiatives and lead pipe replacements, upgrading several parks and so much more," Mayor Flowers said.

The Flowers administration has focused on working with partners on housing options addressing the homeless issue, spurring economic development and seeking more grants for the city, securing approximately \$40 million in state and federal funding in her first 15 months office.

"We have completed years of work by approving a new comprehensive plan – the blueprint for how we want the city to grow – and making citywide updates to the zoning code. This has ended a hodgepodge of regulations, modernizing the code and specifically showing residents and developers what is permissible under the law," Flowers said.

"This came after heaps of public outreach and meetings. Now is the time for those who have been sitting on the sidelines waiting for the city to act to recognize the measures that are in place, the cohesion is there, to undertake projects that provide additional housing opportunities in the city and create new businesses that can employ our residents and help us grow our tax base."

The mayor also thanked the Common Council for moving these key initiatives forward and for their cooperative efforts with the administration, citing this week's approval of the Businesses Improvement District. In this geographic area — which will include parts of Main Street and neighboring streets — property owners are willing to do their part, to be charged a special assessment to help promote and improve the business landscape. The BID will decide what avenues to pursue, whether they be focusing on street beautification, enhancing public safety, and/or organizing events that bring people to the district.

Further focusing on the city's downtown, the mayor said, "We have cleaned up several vacant lots on Main Street, including right across the street from the Public Safety Building and are working with property owners and community partners to improve the area. We have removed trees and carted away volumes of debris from these sites so they can longer be easily used as encampments by our unhoused population."

She cited the work of Police and Public Works Departments and city partners, including Dutchess County, Hudson River Housing, Mental Health America of Dutchess County and other nonprofit agencies for helping to make improvements to these areas and to coordinate services, particularly for the unhoused and those in need of drug rehabilitation and mental health services.

She also noted the city has gathered these key stakeholders and others for monthly meetings to ensure they are in sync on strategies and to discuss and analyze what is working and what needs improving.

The mayor also pointed to the administration's excellent start by being named one of the state's first "Pro-Housing Communities," giving it priority consideration over New York localities not in the program. Several projects have received a total of nearly \$10

million from the state as a result of the city's designation.

"I will continue to push for more pathways to homeownership and opportunities to create generational wealth," she said.

The city also has been awarded a \$500,000 planning grant by the U.S. Department of Housing and Urban Development to develop a community-driven transformation plan for the city's Northside neighborhood. This will focus on revitalizing the Thurgood Marshall Terrace and Martin Luther King, Jr., Garden Apartments in partnership with residents and the Poughkeepsie Housing Authority.

"I'm elated to say Poughkeepsie was selected as one of only 13 communities across the country to be awarded the planning grant – and the only one in New York State."

The city, in partnership with PHA, will work with the residents, local organizations, service providers, city departments, Poughkeepsie City School District, the Poughkeepsie Children's Cabinet Dutchess County Government and more to develop the plan.

The city has about two years to complete the transformation blueprint and be eligible for additional funding for implementation.

Turning her attention to waterfront issues, the mayor said her administration was going to "reignite the process" of getting a development deal at the DeLaval site, the last parcel with undeveloped acres on the city's waterfront. The site offers beautiful views of the Hudson River and the Highland bluffs of Franny Reese Park, and the mayor said the city will put out a Request for Proposals later this year for the DeLaval parcel.

The city is looking for compatible riverside uses — including water-related recreational activities, an amphitheater, restaurants, stores, docks — to create more destinations on the southern waterfront.

"We have no doubt that redeveloping the DeLaval site will infuse the city with more income, helping to keep our finances strong after years of struggling," she said. "Gone are the days of a \$13.2 million general fund deficit, replaced now by a balanced budget and with movement toward creating a fund balance that we would need to nurture and grow over time."

Summing up the work of first responders, the mayor pointed to the Police Department's continued use of new technology, the Fire Department going after grants to secure new equipment, and the service provided through a contract with Empress Ambulance Service that has reduced mutual aid calls, response times and delays in transport.

"I am proud to report today that the city is now performing as one of the best municipalities in the county when it comes to Emergency Medical Services," she said.

The mayor said the city will soon announce the recipients of more than \$300,000 in Youth Activities & Opportunities Grant funds that go to athletic clubs, art activities, education and workforce programs.

And, following last year's successful completion of the Pulaski Pool House project, Mayor Flowers announced major renovations will be made to the Spratt Park Pool House in the fall, after the pool season is over to cause as few disruptions as possible.

So, how can you join the many local businesses and organizations, including Vassar Brothers Medical Center, Metro-North Railroad and Coppola's Restaurant and Bistro, in supporting autistic employees and customers?

Dutchess County has a zero-cost opportunity to receive Autism Supportive training and consultation from ACCT. It simply requires a few hours. Staff are trained in autism education and accommodation, and ACCT identifies and suggests supportive practices to businesses, first responders, and healthcare settings. The program works with organizations through the implementation stage, developing modifications for supportive practices.

Coppola family leads way

Coppola's Restaurant and Bistro in Hyde Park was actually the first business in the county to take the training program and receive an Autism Supportive Environment plaque from Anderson.

Luigi Coppola commented, "The Coppola Family has been an advocate for Autism support from the very beginning. We sat in on many a meeting, sharing ideas and concepts in order to foster a very inclusive environment for families with children on the spectrum at our business and other businesses in the area."

He added, "My brothers John and Vincent and I, are proud of the methods we use to make these remarkable families feel comfortable and wanted. From special tables, private dining areas and safe spaces to dimmable lighting and quick service, our family takes extra care in order to give them the at-home family experience they want.

"We are honored to serve our Anderson families and look forward to many years of continued service."

Recommended supportive practices vary by business needs. A few examples of ACCT training in practice include: communication boards; visual pain diagrams at doctors' offices; accessible quiet spaces; and visual depictions of using ATMs.

ACCT empowers all organizations to


welcome neurodivergent individuals, so they may enjoy spaces that unite the community. Organizations can be designated as "Autism Supportive" if training is completed by 80% of their customer-facing employees, and they have a supportive practice in place. If a business changes hands, the new ownership will need to complete the training to keep the designation.

Marahall said Autism Acceptance Month tells us that differences don't have to divide us. Humans' level of comfort is directly tied to their environment. Ask questions. Find out how you may best support them in the future. Ask customers about their experience in your store. Should we dim the lights? Is the ambient music a notch too loud?

Marshall notes that new environments may cause anxiety. Not knowing what to expect from an experience wracks nerves. Autism supportive spaces offer kindness and respect to all who enter. There is room to make any business, home, and place of employment more accessible, especially for the estimated 2.78% of Dutchess County residents who are on the Autism spectrum.

The grocery store's senior citizen shopping hours help older populations to avoid busy hours. Images of products, menus, and ambiance draw prospective diners to local restaurants. And carnival noise and sounds don't need to deflate a day at the Dutchess County Fair, because sensory-sensitive hours on thinkDIFFERENTLY Thursday mean summer fun for everyone.

This is what community looks like. Dutchess County has everything to gain from taking steps toward inclusion, and the support is free of charge. Why not start today?

Are we destined to return to a time when only the wealthy can provide for their children?

To the Editor:

One of the most famous children with a disability of all times, luckily, had a father able to afford to hire a teacher, pay her salary, transportation and housing so his daughter could become a world-famous author and speaker. How many children, without Capt. Keller's wealth were confined to a life of silence, darkness and solitude?

Prior to 1975, school districts could deny children with disabilities from attending school claiming the school had no program for the child. The passage of The Education of All Handicapped Children Act in 1975 assured that all children with disabilities would be given a free and appropriate public education. Since that time, we have been able to close the institutions that housed the disabled, and through "Child Find" identify children with disabilities in our communities not attending school.

Now, fifty years after the law's passage, are we destined to return to a time when only the wealthy can provide for their children? The U.S. Department of Education was for years the enforcement arm for educating children with disabilities. School districts not in compliance with the law could be investigated and charged with Civil Rights Violations. The Department of Education provided billions of dollars to states, which was funneled to local school districts to provide services, equipment and transportation for children with disabilities. Without the guidance, enforcement and funds provided by the Department of Education, children with disabilities throughout our country will lose the ground that has been gained over the last fifty years.

I don't think anyone yearning to "Make America Great Again" truly wants to deprive our children of a free and appropriate education. Please write to your congresspersons and demand that the Department of Education be reinstated and that our children receive the education they deserve.

Editor's note: Wappingers Central School District Superintendent Dr. Dwight Bonk sent the following letter to NYS Senate and Assembly members telling of his support for proposed legislation (6597) that authorizes the imposition of bail for certain offenses involving violent threats against a school district, school, school staff or a student.

WCSD Superintendent Bonk: Support for proposed legislation (6597) authorizing the imposition of bail for certain offenses

To Members of the New York State Senate and Assembly:

As Superintendent of Schools in the Wappingers Central School District, which is the 9th largest in New York State, and largest in Dutchess County with over 10,000 students and 15 school buildings, I am writing this letter of correspondence, along with other school leaders, staff, and families throughout New York State, in support of the proposed legislation S.6366 (Oberacker} A.6597 (Kay). This bill would allow judicial discretion in whether to require bail when a defendant is accused of making threats of violence against a school district, school, staff, or students and is necessary to raise the level of accountability for those who make such threats and face appropriate legal consequences.

Unfortunately, these threats of violence directed at schools, or individuals within, have occurred throughout our District and have resulted in a substantial disruption to teaching and learning in both our elementary and secondary schools. In some cases, these threats have resulted in school delays, early dismissals, or school closings. In addition, as a result of the threats of violence that we have experienced, our District continues to spend over 2 million dollars per year to provide the necessary support by hiring additional mental health professionals and additional support from our local law enforcement to foster a safe school environment and work hand in hand with our families of students who suffer from anxiety.

In closing, I strongly urge you and your colleagues to advance this critical legislation and am pleased that it has bipartisan support in the state legislature. I believe that we can all agree that all of our students and staff deserve a safe school environment that allows for all to learn, grow, and reach their highest academic, social, and emotional potential. Thank you for considering this request and please do not hesitate to contact me if I can provide further support on this important matter.

Beephan opposes any proposed tax increase to fund MTA

The people of New York deserve transparency, responsible financial stewardship and a government that works for them—not against them."

Britos Martial Arts students gain 'Black Belt' honors

Into the Dojo located in Wingdale filled with spectators to witness a four-hour test of four students for the rank of Black Belt, karate's highest honor in late March. The test was the culmination of as many as eight years of hard work and dedication for the candidates.

The four candidates were Damian Lyman, 30, Cordero Winch, 17, and twin siblings Kaitlyn and Matthew Enes, 13. The Enes twins were among the first line-up of students when Britos Martial Arts opened in 2017.

Also tested was Diego Brito, 18, who was seeking a second degree on his black belt. He had achieved this rank in 2021 after seven years of hard training.

The test exhibited the candidates' synchronization and memory of 18 barehanded and armed katas, which are a sequence of movements simulating combat. Additionally each candidate had to spar for ten minutes straight, with a fresh opponent every minute, which tested each candidate's stamina to the utmost.

Between the katas and sparring, the candidates delivered short speeches expressing gratitude to those who had supported them through the long years of training and recounting their experiences with the sport of karate.

A panel of judges consisting of Britos Martial Arts' founder Sensei Luis Brito, Sensei Mark Wellansky, and Sensei Cesar Sagastume, evaluated the candidates. Wellansky and Mejia had travelled from Fusion Martial Arts in Hawthorne, NY, to offer another layer of objectivity in the evaluation

In March 1960, East Fishkill Town Historian Mrs. Charlotte Cunningham-Finkel convened a meeting of a group of citizens interested in local history. At a second meeting, in April of that year, the group decided to form an association to be known as the East Fishkill Historical Society (EFHS). The first formal meeting took place on May 11, 1960 at the East Fishkill Town Hall, where meetings were held until 1975, when local developer Gustav Fink donated what today is known as the Brinckerhoff-Pudney-Palen House for the association's use.

Over the years, EFHS members donated both time and money to restore the beautiful mid-18th to early 19th-century house to its former glory, a completed accomplishment all of its members can now point to with pride. The house is located on the Brinckerhoff House Historic Site on North Kensington Drive, alongside a colonial period farmhouse, a circa 1826 one-room schoolhouse, a carriage barn, a blacksmith shop and an ice house.

This month, the EFHS will celebrate

its 65th anniversary. The community is invited to join us for a spring fundraiser on April 5 at The Barn at Hopeland, located at 641 Hortontown Road in Hopewell Junction. In addition to dinner, drinks and an array of silent auction items, attendees will enjoy a special visit by Dr. Benjamin Franklin of Philadelphia. He will regale us with tales of his nine years living in Paris, France during the American Revolution as he worked to convince the French monarchy to support the colonists' fight for independence from Great Britain.

Senator Rolison demands action on exposures, risks in NYS Correctional Facilities

New York State Senator Rob Rolison, Ranking Member of the Senate's Crime Victims, Crime, and Correction Committee, is leading an effort to address the alarming rise in the number of exposure incidents in New York State correctional facilities.

Senator Rolison and Senate Republicans Colleagues, including committee member, Senator Dean Murray (SD-3), on March 28, sent a letter to the State Commission of Correction, urging a formal investigation into the prevalence and impact of exposure incidents within Department of Corrections and Community Supervision (DOCCS) facilities. The letter calls for comprehensive data collection on these incidents and an analysis of the substances found that may be

directly related to these exposure incidents.

As a result of these incidents, individuals have been transported to local hospitals for evaluation and treatment. We need to know what type of substances are being found and that are posing this serious risk to correctional officers, civilian employees, incarcerated individuals, and now, National Guard personnel who are serving in our correctional facilities across the State.

"Those working in our correctional facilities—officers, civilian staff, and medical personnel—deserve to be protected from dangerous exposure while doing their jobs," said Senator Rolison. "A comprehensive investigation is a crucial step in finding out what is happening in our correctional facilities. By

getting the State Commission of Correction involved, we are taking the necessary steps to examine this issue on a statewide level and push for real solutions."

In addition to the letter, Senator Rolison recently amended his fentanyl exposure bill, S989-A, to strengthen protections against exposure. The bill, which establishes the offense of aggravated reckless endangerment for individuals who knowingly possess fentanyl or fentanyl derivatives and recklessly expose first responders or correction officers, now includes civilian employees of correctional facilities along with military personnel as protected individuals, including active military personnel who are serving in correctional facilities.

"This amendment ensures we are holding individuals accountable who are recklessly possessing substances that are injuring correction officers and civilian staff," Rolison added. "By expanding this legislation to include active-duty military personnel, such as National Guard members working in these facilities, we are taking a stronger stance to deter reckless endangerment and protect those who serve our state."

TOWN OF PLEAS-ANT VALLEY PROPOSED LOCAL LAW G OF 2025 A LOCAL LAW CRE-ATING A NEW **CHAPTER 75 OF** THE TOWN CODE **TITLED "SHORT-TERM RENTALS**" **AND AMENDING** CHAPTER 98, "ZONING"

BE IT ENACTED by the Town Board of the Town of Pleasant Valley as follows: **Title**

Section 1 This Local Lawshallbeknownas "A Local Law creating a new Chapter 75 of the Town Code titled 'Short-Term Rentals' and Amending Chapter 98, 'Zoning'.' Section 2 Au-

thority This Local Law is enacted pursuant to the authority of the Municipal Home Rule Section 10.

Section 3 Findings; Purpose

The Town Board finds that residential homes are beingrented outfor short terms, that short-term rentals have the potential to be incompatible with surrounding residential uses, and thatspecialregulation isnecessarytoensure thatshort-termrentals will be safe and compatible with surrounding uses and will not harm the neighborhoods in which they are located.

The Town Board finds that in the Town of Pleasant Valley, short-term rentals hosted by an on-site property owner provide valuable tourist accommodations and tend not to cause conflicts if properly man-The Town aged. Board finds that, in contrast, when a house is rented to transient visitors with no owner present, there is less oversight and more potential for conflict with neighbors. This type of use alsoremoveshousing from the market for long-term tenancy.

The purpose of this law is to establishasetofregulations for hosted short-term rentals of residential property. Transient accommodations where a host is not present shall be deemed lodging facilities and regulated accordingly. These regulationsareinaddition to all other provisions of the Town Code.

Section 4 Enactment of Chapter

A new Chapter 75 of the Town Code Shall be enacted as follows:

CHAPTER 75 SHORT-TERM **RENTALS**

§ 75-1. Definitions. As used in this chapter, the following terms shall have the mean-

ing indicated:

CODE ENFORCE-MENT OFFICER -Includes the Building Inspector, the Zoning Administrator, the Code Enforcement Officer and any other person charged with enforcing the Code or local laws of the Town and any applicable Building, Fire and Residential Codes of New York State.

OWNER or OWNERS —Includes the person or people actually owning real property, a person or people holding membership interests in a limited-liabilitycompany, aperson or people holding a partnership interest in a partnership or limited liability partnership, the trustee or trustees of a trust, or a person or people owning shares in a corporation, when any such an entity owns the real property.

SHOŘT-TERM RENTAL — Any portion of a dwelling unit or housing unit (as definedinanyapplicable NYS Fire, Building or Residential Code) rented for compensation in exchange for lodging for a period of fewerthan 30 consecutive days, while the Owner is present on the property. Short-Term Rentals accommodations may be located in a primary structure or a permanent accessory structure but may not be located in campsites, tent platforms, or other temporary structures on the parcel. For the purpose of this chapter, the term "Short-Term Rental" shall not include a bed-and-breakfast, boardinghouse/lodging house, hotel, motel, or ongoing month-

to-month tenancies. §75-2. Required permit; limitations on **Short-Term Rental** permits.

Short-Term Rentals are allowed anywhereintheTown, regardless of the zoningdistrict, if they meet all the requirements of thissectionandobtain

a permit. Short-Term Rentals require the Owner of the property to be on site overnight throughout the Short-Term Rental period. Any rental for fewer than 30 days in which the Owner is not on site shall not be deemed a Short-Term Rental but may seek approval as a lodging facility or other appropriate use in accordance with the Zoning Code

C. Owners shall not advertise or use their property as a Short-Term Rental without obtaining a revocable Short-Term Rental permit in advance. Short-Term Rental permits shall be limited to one permit for

anyOwner(s)foreach one-year cycle. Only an Owner or Owners of the property can obtain a Short-Term Rental permit.

D. A Short-Term

Rental permit shall be valid for one year and must be renewed 60 days prior to expiration of current permit if the premises are to continuetooperateas a Short-Term Rental. E. The Short-Term Rental permit is not transferable to a new owner. The new owner of the premises subject to a Short-Term Rental permit must file a new permit application.

F. The Town Board may establish by resolution the number of short-term rental permits that may be issued at any time. The initial number of such permits shall be 50. As permits expire they will become available to others if the maximum has been reached.

G. Permits for Short-Term Rentals are a privilege that can be revoked pursuant to these regulations.

H. Notwithstanding the foregoing, those properties with shortterm rental commitments existing on the date this chapter takes effect shall be permitted to honor such existing commitments and continue to make commitments for short-term rentals, but owners must submit a complete permit application within 90 days of this chapter's effective date if they wish to make future short-term rental commitments. In the event such application is denied, all commitmentsshallbecan-

celled. § 75-3. Short-Term Rental permit applirequirecation ments.

A.Applications and application forms for a Short-Term Rental permit may be obtained at the Town of Pleasant Valley Town Hall or Town website, and fully completed applications shall be submitted to the Code Enforcement Officer, accompanied by payment of a nonrefundable application fee to be determined from time to time by resolutionoftheTownBoard. The application shall include the following: (1)The signatures of all property owners or their designated agents.

(2)A statement authorizingthe Code Enforcement Officer or his designee to inspect the property to ensure compliance with all requirements and standards contained within this

chapter. (3)An acknowledgment of present and ongoing compliance

with the Short-Term Rental standards as defined in this chapter. (4)A list of each property owner and the name of any manager, management agency managing the property, or other party responsible for maintaining the property in the owner's absence, including names, addresses, telephone numbers and email addresses of each individual.

(5)The name, adtelephone dress. number and email addressofalocalcontact person, who shall be responsible for and authorized to act on the owner's behalf to promptly remedy any violation of the standards outlined in this chapter. The contact person may be an owner, or an agent designated by the owner(s) to serve as a contact person, and shall respond to any correspondence or concern from the Town Code Enforcement Officer within 24

hours. (6)An accurate, suitablefloorplanforeach level of the dwelling that can be occupied measuring at least 8.5 inches by 11 inches, and a plot plan, both drawn to scale and certified by the applicant. The floor plan and plot plan do not need to be prepared by a professional, but must include the fol-

lowing: (a)The location of buildings, septic systems, wells, required parking spaces, any swimming pools, hot tubs and spas.

(b)For each floor (including basement and/or attic): all rooms, including bedrooms, windows, exits and any heating/cooling units, as well as location of house utilities

(c)All rooms that are not included in the Short-Term Rental must also be shown. (7)A statement that none of the owners of the subject property have had a Short-TermRentalpermitrevoked within the previous year for any rental properties owned individually or together with others.

(8)If access to the property is by way of a private road or shared driveway, proof that the owner has the legal right to use the road or driveway for access to a Short-Term Rental.

(9)Current Dutchess County Hotel Occupancy Tax Certificate. B.All completed applications are subject to afloorplanreviewand plot plan review and approval by the Code Enforcement Officer. § 75-4. Short-Term

Rental standards. A.Property requirements.

(1)Property comply and meet all applicable NYS Uniform Building Codes and the Code of the Town of Pleasant Valley, including all Zoning requirements.

Short-Term Rental must be located within a legal dwelling unit, and there may be no more than one Short-Term Rental per property. (3)There shall be one workingsmokedetector in each sleeping room and one additional smoke detector on each floor. Carbon monoxide detectors shallbeinstalledasrequired by the New York State Uniform Fire Prevention and Building Code.

(4)Evacuation procedures must be posted in each sleeping room to be followed in the eventofafireorsmoke condition or upon activation of a fire or smoke-detecting or other alarm device.

(5)There shall be an ABC fire extinguisher oneachfloorandinthe kitchen. Fire extinquishers shall be inspected prior to a renter occupying the property and no less than monthly by the permit holder(s) to ensure each contains a full charge. Arecord of the date inspected initialed by the permit holder shall be maintained and made available to the Code **Enforcement Officer** upon request.

(6)The house number shall be located both at the road and on the dwelling unit so that the house number is clearly visible from both the road and the

driveway. (7)Exteriordoorsshall be operational and all passageways to exterior doors shall be clear and unobstructed.

(8)Electrical systems shall be in good operating condition, labeled, unobstructed and shall be visible for the Code Enforcement Officer during the permitting process. Any defects found shall be corrected prior to permit issuance.

(9)AII fireplaces, woodstoves, pellet stoves and similar heating devices shall comply with all applicablelawsandregulations.

(10)The property must have a minimum of one off-road parking space for every bedroom shown on the floor plan. (11) Vehicle access to

the Short-Term Rental must meet current New York State Fire Code requirements. (12)Maximum occupancy for each Short-Term Rental unit shall notexceedtwopeople per bedroom shown on the floor plan. The

of a short-term rental unit shall not exceed sixteen people.

(13)In the event that the property has a septic system, the maximum occupancy shall be limited by the maximumandverified capabilities of the septic system, but in no event shall overnight occupancy for any short-term rental unit exceed sixteen people total.

(14)Asepticsystemat the property must meet all state and county requirements with supporting documentation.

(15)The septic system must have a satisfactoryinspectionbya qualified septic disposal firm within 90 days prior to the initial application. Once a Short-Term Rental permit is issued, the septicsystemmustbe pumped and inspected every two vears.

(16)The water supply to the property must meet all state and county requirements. (17)For properties which include a swimming pool, there must be water safety equipment on the property including a long-handled hook or a buoy or flotation device with an attached line, in plain view and within 10 feet of the edges of the swimming pool, and must meet all relevant codes.

B.An informational posting within the rental area shall be required, including: (1)Maximum occu-

pancy limit (2)Location of parking spaces

(3)Any conditions imposed by the Zoning Board of Appeals and/or Code Enforcement Officer

(4)The phone numbers for local emergency services (e.g., fire, police, EMT) (5)Quiet hours

C.Insurance standards. All applicants and permit holders must provide evidence of property insurance and a certificate of liability insurance indicating the premises are rated as a Short-Term Rental and maintain such insurance throughout the term of the Short-Term Rental permit.

D.Wasteremovalprovisions shall be made forweeklygarbageremoval during rental periods. Garbage containers shall be secured with tight fitting covers at all times to prevent leakage, spilling, or odors, and placed where they are not clearly visible from the road except at approximate pickup time.

E.It shall be unlawful for a Short-Term Rental to be used for any gathering involving more people than the maximum occu-

pancy of the rental.

F.Short-Term Rental applicants and permit holders must have a rental contract, which includes the following:

(1)Maximum property occupancy;

(2)Maximum on-site parking provided; and (3)Good neighbor statement, stating: (a)The Short-Term

Rental renters should be considerate of the residents in neighboring homes:

(b)Guests are requested to observe quiet hours from 8:00 p.m. to 8:00 a.m.;

(c)All renters will be subject to New York PenalLaw§240.20 or any successor statute regarding disorderly conduct:

(d)Littering is illegal; (e)Recreational campfires must be attended at all times, and the property Owner must advise renters when burn bans are active:

(f)Hunting, the dischargeoffirearms, pyrotechnics, motorcycles, motocross and off-road vehicles shall notbepermittedoroperated on the property which is subject to a Short-Term Rental.

§ 75-5. Procedure upon filing application.

A.Short-Term Rental permit applications shall be filed with the Town of Pleasant Valley Planning, Building and Zoning Office with all supporting documentation and the nonrefundable permit fee. Only completed applications will be accepted by the Town's Code Enforcement Officer. The Code Enforcement Officer may decline to accept an application for consideration for any of the following reasons: (1)The application documentation required by this chapter was not included or the full permit fee was

not paid. (2)Apreviouslyissued Short-Term Rental permit was revoked within the past year and defects and/or violations have not beencorrected and inspected by the Code Enforcement Officer. B.Upon the Code Enforcement Officer's acceptance of the completed permit application, including all documents and information required by this chapter and the permit fee, the Code **Enforcement Officer** shall have 30 days to conduct a property inspection to certify and approve that all Short-Term Rental requirements have been met. C.Upon approval of the Short-Term Rental application by the Code Enforcement Officer, a Short-Term

Rental permit will be issued for a period of one year.

§ 75-6. Permit compliance required.

Short-Term Rental permits are subject to continued compliance with the requirements of this chapter. A.Ifthe Code EnforcementOfficerhasprobable cause to believe that the homeowner is not in compliance with the provisions of this chapter, the Code Enforcement Officer may request permission from the Short-Term Rental permit holder to enter the premises and to conduct an inspection of theShort-TermRental property for purposes of ensuring compliance with this section. If the permit holder refuses to permit the Code Enforcement Officer to inspect the property, the permit will be revoked. If an inspection authorized herein is conducted, the Code Enforcement Officer shall use the results of such inspection in determining whether to revoke the permit.

B The Short-Term Rental permit holder shall ensure that current and accurate information is provided to the Code Enforcement Officer and that the Code EnforcementOfficerisnotified immediately of any changeintheinformation displayed on the permit. If, based on such changes, the Code Enforcement Officer issues an amended Short-Term Rental permit, the owner(s) must immediately post the amended permit inside and near the front entrance of the Short-Term Rental.

§ 75-7. Application for renewal of permit.

Renewal permits will begranted for an additional one-year term if the following conditions are met:

A.Application for renewal of the Short-Term Rental permit shall be made 60 days prior to expiration of current permit and requires payment of renewal fee.

B.At the time of application for renewal, the owner or designated agent must present thepreviouspermitfor Short-Term Rental.

C.The property must undergo re-inspection performed by the Code Enforcement Officer.

D.Any violations, whether previously issued or observed during the reinspection, must be remedied prior to renewal of a permit for Short-Term Rental.

D.Any violation of the Penal Code of the State of New York has occurred at, or related to the occupancy of, Short-Term the Rental.

E.Any conduct on the premises, which disturbs the health, safety, peace or comfort of the neighborhood or which otherwise creates a public nuisance.

F.Removal or disrepair of any safety devices, such as, but not limited to, smoke and carbon monoxide detectors, fire extinguishers, and egresses.

§ 75-9. Penalties for offenses. A.Ifthe Code Enforce-

ment Officer either witnesses or receives a written complaint (unless the suspected violation is of life, health or safety matters, in which case the Code Enforcement Officerisauthorizedto act on an oral complaint)ofanallegedviolation of this chapter or of any Short-Term Rental permit issued pursuant to this chapter, the Code Enforcement Officer shall properly record such complaint and immediately investigate the report thereon. If the Code Enforcement Officer determines there is a violation of this Code or this chapter, the owners shall benotifiedinwritingby certified or registered mail, or personal service, of said violations, and the Code Enforcement Officer may take any or all of the following actions: (1)Attach conditions to the existing Short-Term Rental permit. (2)Suspend Short-Term Rental permit. The notice of suspension shall be provided to a property owner and a copy filed with the Town Clerk. (3)Require corrective action that remedies the violation(s). The corrective action must be completed and approved within 30 days

Rental Short-Term permit. (4)Issue a court appearance ticket for violation of law.

The Code Enforcement Officer shall send a notices of revocation to property owner(s) and shall file a copy with the Town Clerk.

ing. B.The foregoing presumptions may be rebutted by evidence presented to the Code **Enforcement Officer** that the premises are not operated as a Short-Term Rental. C.Permitted Short-Term Rentals shall make clear in their advertising that the Owner will be present on the property during the rental period. Advertising indicating that an entire dwelling unit is for rent without an owner on the property shall create a presumption that the accommodation is not functioningasaShort-Term Rental in conformance with this chap-

§75-11. Appeals and hearings.

The property owner is entitled to appeal the Code Enforcement Officer's determina-

tion to the Zoning Board of Appeals when a property owner's application for a Short-Term Rental permit or a Short-Term Rental permit renewal is denied or a Short-Term Rental permit is revoked. Map reveals pivotal time for nation and local woman

As we leave Women's History Month and approach the 250th anniversary of the 1776 American Revolution, let's look at one Revolutionary War era woman in particular. And let's do so through the lens of a 1780 map that DCHS is in the process of acquiring with the support of the Rhinebeck Chapter of the Daughters of the American Revolution and others.

As background, we recall that John Adams' wife famously wrote to him in 1776 as they crafted the new nation saying, "I long to hear that you have declared an independency -- and by the way in the new code of laws which I suppose it will be necessary for you to make I desire you would remember the ladies, and be more generous and favourable to them than your ancestors. Do not put such unlimited power into the hands of the husbands. Remember all men would be tyrants if they could. If particular care and attention is not paid to the ladies we are determined to foment a rebellion, and will not hold ourselves bound by any laws in which we have no voice, or representation.'

Of course women would not gain the right to vote nationally until 1920. They gained the right to vote in New York State in local school elections (only) in 1880. They gained the right to vote in New York State in 1917. But the fulfillment of national ambition took until 1920. But that doesn't mean that women at the time were without agency, especially landowners. One such local woman was Janet Livingston Montgomery, which provides us with one of the earliest local connections to the Revolutionary War. Rhinebeck's General Richard Montgomery was killed in the battle of Quebec on December 31, 1775 - the 250th anniversary will be at the end of

The Rhinebeck Chapter of the Daughters of the American Revolution

is located in the small house that General Montgomery and his new wife, Janet Livingston Montgomery, first settled in while planning on building a larger estate in Rhinebeck. But this modest initial foothold was simply a stepping stone to the larger Grasmere Estate they had commenced building and is reflected in the map.


The strategic importance, and therefore the great value of this property lies in the fact that it includes land around the Landsmankill that belonged to Montgomery which was the site of storage buildings and mills, a major engine of local economic growth. All along the east side of the large lot of 379 acres runs the Albany Post Road, connecting New York City and Albany. And near the mills we find a westbound road that leads to the Rhinecliff landing at the Hudson River. Between the mills on the smaller river, the global transportation reach of the Hudson River, and the Post Road, the land is set up well to become increasingly valuable.

We can learn a lot not just from the map itself, but by both zooming out to see it in larger context, and by zooming in to identify small indicators that have a larger message.

When Montogomery's lot is superimposed on the larger 1802 map of the area known as Wurtemburg, we can see that by that time land ownership had evolved beyond the Livingstons (although they owned a significant amount of the best land) and we see a mix of older Dutch names, and more recently arrived German Palatines who were making the transition from tenant farmer to farm owner.

When we zoom in for a close up, we can see things like the depiction of the Dutch style hay barrack which tells us that this was an area for agriculture, and that the Dutch tradition of using a "barrack" whose roof can be raised and lowered using pegs in the holes in the vertical poles was in use. General Montgomery had declared that he would prefer a farmer's life and that if he should be lucky enough to live through the war (which of course he did not) he would want to spend his time farming and innovating in agriculture.





It is telling that ultimately (by 1805) Janet Livingston Montgomery had abandoned Grasemere for the beautiful Montgomery Place, which is today owned by Bard College. It sits on the banks of the Hudson with a powerful view of the river. This 1780 map, prepared when the United States was just four years old, depicts the unfulfilled dream of General and Janet L. Montgomery, reminding us that the price for the American Revolution included the loss of many lives, of both ordinary citizens, and its elite leadership. We are also reminded that the journeys toward equal-

ity that Jane Adams implored in 1776 when writing could involve many steps, and many generations of persistence.

Scrat, Rocky and P'nut can't, but Nutkin can

For those of you who need a brush-up on bygone celebrity icons of the animated and zoological variety, Scrat is the saber-toothed rat-squirrel from the "Ice Age" franchise; Rocky the Flying Squirrel was Bullwinkle's buddy in several cartoon series; P'nut was the most famous northern grey squirrel on Instagram; and Nutkin was the cheeky red squirrel created by Beatrix Potter. Red squirrels, like Nutkin, have an undesirable quality: they are reservoirs for Hansen's Disease.

Hansen's Disease, as it is now called, was a name change in honor of the physician who discovered Mycobacterium leprae. For millennia, the zoonotic affliction had been more memorably known as leprosy. Dr. Hansen's contribution disproved the belief that the condition was hereditary. It is curable with antibiotic therapy.

Red Squirrels

Red squirrels can be reservoirs for the leprosy bacteria. This means that M. Leprae can live and multiply within the tiny mammals. Although there have been no reported cases of humans catching leprosy from red squirrels in modern times, humans and red squirrels shared a bacterial strain of leprosy in medieval England. This suggests that leprosy was transmitted between the two species, likely due to the fur trade and humans keeping the squirrels as pets.

Leprosy

Leprosy is one of the oldest known infectious diseases, causing significant physical disfigurement, and leading to severe social stigma and isolation for those affected, often being ostracized from their communities throughout history.

It is a disease that has been around a long time. Scientists believe that leprosy originated 100,000 years ago in East Africa. From there it seems to have migrated eastward and westward (through colonization and slave trade), developing one distinct subtype in Asia and another subtype in Europe and North Africa. In western Africa, yet another distinct subtype developed. Leprosy was brought to the Americas by European colonists and western African slaves.

Dreaded and misunderstood, for centuries the disease was treated ineffectively and sometimes barbarically. In ancient Europe, Egypt and China, blood was administered--either as a beverage or as a bath. Sometimes the blood of virgins was required for ritualistic purity. The "therapeutic" use of venom from snakes, bees, scorpions and frogs were other treatments. Some of the afflicted

were scarred with irritants, including arsenic, or even endured castration!

Leprosy attacks peripheral nerves and results in acute pain. People with the disease were demonized and thought to be highly contagious. Civilizations around the world saw "lepers" as threats to the general welfare and, as a result, they were ostracized and confined to colonies to live out a lifetime of isolation. Like many other diseases, leprosy was believed to be divine punishment for worldly sins.

The disease thrived in areas with overcrowding, poor sanitation and malnutrition. Incidence was high in Europe from about 500-1500 CE. Leprosy saw a decline in incidence in the 16th century, after the Middle Ages, with improved socioeconomic conditions and hygiene.

Nine-Banded Armadillos

Nine-banded armadillos can be vectors for leprosy. This means that M. Leprae can be transmitted to humans through contact with their infected tissues. Nine-Banded Armadillos are found in the mid- and south-eastern United States, as well as more southern areas. Their range has expanded northward into Missouri, Illinois and Nebraska.

Very few people in the US are diagnosed with Hansen's Disease, according to the CDC website. An even smaller number of those folks may have come in contact with infected armadillos in this country. It is true that warming temperatures are a driving force behind the animals migrating northward, but the chances of them making it as far north as Dutchess County, NY are limited by our temperatures. Nine-banded armadillos can't hibernate and don't have much body fat, so they can't conserve heat well. They can't establish stable colonies

where the average January temperature is below 28 degrees F.

Don't worry about Nutkin and other Red Squirrels

Even though Nutkin and other Reds can be carriers for Hansen's Disease, you are probably naturally immune! Only about 5 percent of people are genetically susceptible to getting leprosy, if exposed. And, unlike previously believed, the disease is not highly contagious and can't be spread through casual contact, like shaking hands. Transmission of leprosy requires prolonged close contact with an infected organism (including a person) who has not been treated. But, once antibiotic therapy is begun, the disease is not contagious.

Obviously, it is best to avoid contact with bodily fluids from-- and rashes on-- infected people. And, by all means, avoid contact with the official Texas Small Mammal and Beatrix Potter's Nutkin!



§ 162-3 Prohibition of evictions without good cause.

A. All applicable provisions set forth in Article 6-a of the New York State Real Property Law, and any amendments thereto, areherebyadopted by the Town of Pleasant Valley and incorporated herein by reference.

B. Pursuant to § 213(2)(a) of Article 6-aofthe New York State Real Property Law, for the purposes of this chapter, any unit within a housing accommodation shall be exempt from the provisions of this chapter if such unit has a monthly rent above three hundred forty-

fair market rent, as

published by the

United States Department of Housing and Urban Development and as shall be published for the County of Dutchess by the New York State Division of Housing and Community Renewal. Pursuant to § 213(2)(b) of Article 6aofthe New York State Real Property Law, for the purposes of this chapter, a "small landlord" is defined as a landlord of no more than one (1) housing accommodation anywhere in the State of New York, provided that owner-occupied housing accommodations or otherwise exempt housing accommodations shall not be considered in calculating the numberofhousing accommodationsownedbya landlord.

§ 162-4 Automatic Sunset of this Chapter.

Pursuant to § 7(b) of Chapter 56, Part HH, oftheLawsoftheState of New York of 2024, this chapter shall automatically expire and be repealed on June 15, 2034, unless Article6-a of the New York State Real Property Law is extended or otherwise amended to remain in force and effect by the State of New York prior to such automatic repeal date.

SEVERABILITY

If any clause, sentence, paragraph, word, section or part of this local law shall be judged by any court of competent jurisdiction to be unconstitutional, illegal or invalid, such judgment shall not affect, impair or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, word, section or part thereof directly involved in the controversy in which judgment shall have been rendered. A LOCAL LAW OF THE TOWN OF PLEASANT VALLEY, DUTCHESS COUNTY, NEW YORK, AMENDING CHAPTER 86, TAXATION TO PROVIDE A NEW ARTICLE VII THEREOF ENTITLED: "EXEMPTION FOR PERSONS WITH DISABILITIES AND LIMITED INCOME"

BE IT ENACTED by the Town Board of the Town of Pleasant Valley as follows:

SECTION 1.

This Local Law shall be known, and may be cited as, "A Local Law of the Town of Pleasant Valley, Dutchess County, New York, Amending Chapter 86, Taxation to Provide a New Article VII Thereof Entitled: 'Exemption for Persons with Disabilities and Limited Income'

SECTION 2. Chapter 86, Taxation, of the Town of Pleasant Valley Code is hereby amended to provide a new Article VII, which shall read as follows:

§86-19. Purpose, Statutory Authority.

This article is enacted pursuant to the provisions of §459-c of the Real Property Tax Law of the State of New York to grant a partial exemption from Town taxation to certain resident property owners of the Town of Pleasant Valley with disabilities who have limited incomes.

§86-20 Definitions.

As used in this article, the following terms shall have the meanings indicated: **INCOME TAX YEAR**

The twelve-month period for which the owner or owners filed a federal personal income tax return, or if no such return is filed, the calendar year. PERSON WITH A DISABILITY

A. One who has a physical or mental impairment, not due to current use of alcohol or illegal drugs, which substantially limits such person's ability to engage in one or more major life activities, such as caring for one's self, performing manual tasks, walking, seeing, hearing, speaking, breathing, learning and working, and who:

(1) Is certified to receive Social Security Disability Insurance (SSDI) or Supplemental Security Income (SSI) benefits under the Federal Social Security Act; or

(2) Is certified to receive Railroad Retirement Disability benefits under the Federal Railroad Retirement Act: or

(3) Has received a certificate from the State Commission for the Blind stating that such person is legally blind; or

(4) Is certified to receive a United States Postal Service disability pension; or (5) Is certified to receive a United States Department of Veterans Affairs disability pension pursuant to 38 U.S.C. §1521.

B. An award letter from the Social Security Administration or the Railroad Retirement Board or a certificate from the State Commission or an award letter from the United States Postal Service, or an award letter from United States Department of Veterans Affairs shall be submitted as proof of disability.

SIBLING

A brother or a sister, whether related through blood, whole blood or adoption.

Exemption Granted; Amount; Limitations.

A. Real property situate within the Town of Pleasant Valley, owned by husband, wife or both, or by siblings, at least one of whom has a disability, or real property owned by one or more persons, some of whom qualify under Real Property Tax Law §459-c and the others of whom qualify under Real Property Tax Law §467, or real property owned by a cooperative apartment corporation in which a tenant-stockholder of such corporation resides, and which is represented by his share or shares of stock in such corporation as determined by its or their proportional relationship to the total outstanding stock of the corporation, including that owned by the corporation, which for purposes of this article shall be deemed vested in the tenant-stockholder, and whose income, as hereinafter defined, is limited by reason of such disability, shall be exempt from taxation for real estate taxes to be levied by the Town for the year 2025 and thereafter by the percentage of exemptions hereinafter specified for the annual income ranges listed below to the extent of 50% of the assessed valuation thereof. Such exemption shall be based upon and be computed after all other partial exemptions allowed by law have

B. No exemption shall be granted:

(1) If the income of the owner or the combined income of the owners of the property for the income tax year immediately preceding the date of making application for exemption exceeds \$43,400. Where title is vested in either the husband or the wife, their combined income may not exceed such sum, except where the husband or wife, or ex-husband or ex-wife, is absent from the property due to divorce, legal separation or abandonment, then only the income of the spouse or ex-spouse residing on the property shall be considered and may not exceed such sum. Such income shall include social security and retirement benefits, interest, dividends, total gain from the sale or exchange of a capital asset, which may be offset by a loss from the sale or exchange of a capital asset in the same income tax year, net rental income, salary or earnings, and net income from self-employment, but shall not include a return of capital, gifts or inheritances or monies earned through employment in the federal foster grandparent program. In computing net rental income and net income from self-employment, no depreciation deduction shall be allowed for the exhaustion, wear and tear of real or personal property held for the production of income.

(2)Unlesstheproperty is used exclusively for residential purposes; provided, however, that in the event that any portion of such property is not so used exclusively for residential purposes but is used for other purposes, such portion shall be subject to taxation and the remaining portion only shall be entitled to the exemption provided by this article.

(3) Unless the real property is the legal residence of and is occupied in whole or in part by the disabled person, except where the disabled person is absent from the residence while receiving heal-related care as an inpatient or a

residential health care facility, as defined in §2801 of the Public Health Law, and provided that any income accruing to that person shall be considered income for the purposes of this article only to the extent that it exceeds the amount paid by such person or spouse, or sibling or such person for care in the facility

A. No parcel may receive an exemption for the same municipal tax purpose pursuant to both this article and Article I of this chapter, Senior Citizens Partial Exemption, as amended, pursuant to Real Property Tax Law §467. B. Notwithstanding any other provision of law to the contrary, the provisions of this article shall apply to real property held in trust solely for the benefit of a person or persons who would otherwise be eligible for a real property tax exemption, pursuant to this article, were such person or persons the owner or owners of such real property.

Application for Exemption.

A. Application for such exemption must be made annually by the owner or all of the owners of the property on forms to be provided by the New York State Department of Taxation and Finance, Office of Real Property Tax Services through the Assessor's office. Such applications shall furnish the information and the forms are to be executed in the manner required or prescribed in such forms and shall be filed in the Assessor's office on or before taxable status date; provided, however, that proof of a permanent disability need be submitted only in the year exemption pursuant to this article is first sought or the disability is first determined to be permanent.

B. At least 60 days prior to the appropriate taxable status date, the Assessor shall mail to each person who was granted exemption pursuant to this article on the latest completed assessment roll an application form and a notice that such application must be filed on or before the taxable status date and be approved in order for the exemption to be granted. Failure to mail any such application form or notices or the failure of such person to receive any of the same shall not prevent the levy, collection and enforcement of the payment of the taxes on property owned by such person.



And with that the deal was struck. It felt like the scene from "The Godfather" when the five families negotiated the peace.

Anyway, enjoy the recipe of Zucchini Parmagiana.

Zucchini Parmagiana **Ingredients**

3 large zucchini, sliced into strips about 1/4-inch thickness

1 tbsp. extra-virgin olive oil

1/2 cup Parmesan cheese, grated and divided in half

1/4 cup Italian breadcrumbs

1 cup Coppola's marinara sauce

1/2 cup mozzarella cheese, grated

1/2 cup ricotta impastata salt & freshly ground pepper to taste

Directions

Preheat oven to 450 degrees F. Coat a large baking sheet with non-stick cooking spray.

Place zucchini in a medium bowl and drizzle with olive oil, turning to coat each piece. In a separate bowl, combine half the Parmesan, bread crumbs, salt and pepper.

Dip each zucchini coin into the Parmesan mixture, turning to coat and pressing the breading slightly to ensure it sticks. Place breaded zucchini in one even layer on prepared baking sheet. Bake for 25 minutes or until browned and crisp.

Reduce the oven temperature to 400 degrees F. Coat the bottom of a small baking dish with marinara sauce. Layer one third of the crisp zucchini over marinara, overlapping if necessary. Add dollops of ricotta, leaving sizable gaps between each dollop. Sprinkle the layer with mozzarella and the remaining Parmesan. Repeat the layers until the zucchini is gone. Cover your top layer with sauce and mozzarella and cover with aluminum foil.

Bake for 10-15 minutes or until the cheese is melted and the sauce is bubbling. Cool for 5 minutes before serving.

Luigi Coppola is one of five brothers born to Francesca and Antonio Coppola. The Coppola family came to America from Naples, Italy in 1954. Antonio and his brothers opened their first restaurant in Poughkeepsie in 1961. Friends of the Walkway announce seasonal return of tram, elevator, events and more at Walkway Over the Hudson

Beginning Saturday, April 5, Friends of the Walkway—the nonprofit partner of New York State Parks—will officially reopen its seasonal amenities at Walkway Over the Hudson State Historic Park. This includes the return of the merchandise and information pavilions and operation of its 11-passenger ADA-accessible electric tram. The Walkway's 21-story glass enclosed elevator at Upper Landing Park in Poughkeepsie will also resume operation, weather permitting.

Pavilions re-open; Volunteers return to the Bridge

Located at the East Gate Plaza in Poughkeepsie and just outside the west gate in Highland, the Walkway's merchandise and information pavilions give visitors the opportunity to shop for branded merchandise, learn about membership, and receive helpful information about the park and surrounding area. Each pavilion is staffed by red-vested Walkway Ambassadors—specially trained volunteers who serve as greeters, tour guides, and safety stewards, enhancing the overall visitor experience.

Ambassadors also assist with events, share the history of the bridge, and offer recommendations on local dining, lodging, and attractions. Since the bridge opened in 2009, Ambassadors have played a vital role in welcoming more than seven million visitors and supporting both Walkway's New York State Office of Parks, Recreation, and Historic Preservation team and community nonprofit events held in the park throughout the year.

Pavilions are open Saturdays and Sundays from 11 a.m. to 3 p.m. through May 24, with expanded hours beginning Memorial Day weekend.
