Renegades set to start 2nd season as Yankees affiliate



Packing Dutchess Stadium with enthusiastic minor league baseball fans has become tradition in the Hudson Valley. The Renegades start their 28th season Friday. It will be their second season as an affiliate of the New York Yankees.

For the 28th year – it should be 29 but, well, let's not get into what that whole global pandemic thing did to our lives in 2020 and, really, into 2021 – professional baseball will be played in Dutchess County

The Hudson Valley Renegades begin their season on Friday night, April 7, in Greenville, South Carolina in the opening game of the 2022 season against the Drive. It will be the first of a nine-game road trip before the Renegades return to Dutchess Stadium on Tuesday, April 19, to host the Brooklyn Cyclones.

Here's a primer for the upcoming season.

Who are the Renegades affiliated with this year?

The Renegades will begin their second season as the High Class A farm team of the New York Yankees. The franchise started out moving to Hudson Valley from

Erie, Pa., in 1994 as a short-season affiliate of the Texas Rangers before switching to the Tampa Bay Rays a year later.

It was a fruitful partnership, but Major League Baseball decided to contract several dozen minor league franchises last year and try to make the relationships between the big clubs and the farm teams more geographically tenable. The Renegades, who long have been one of minor league baseball's most consistent teams in terms of how many fans it draws to Dutchess Stadium, were an obvious choice for the Yankees.

What league will the Renegades play in?

Thankfully, minor league baseball did away with the unwieldy league names from a year ago. And while it might not be geographically friendly, Hudson Valley will play in the legendary South Atlantic League. The South Atlantic League was established in 1903 and some of the players who spent time in the league might ring a bell – Derek Jeter, Hank Aaron, Mariano Rivera, Nolan Ryan, Ty Cobb, Steve Carlton, Bob Gibson, Ryne Sandberg you know, if you just want to throw around a few Hall of Famers.

The league will be comprised of the North Division and the South. Joining Hudson Valley in the North will be the Aberdeen IronBirds (Baltimore Orioles), Brooklyn

Cyclones (New York Mets), Jersey Shore BlueClaws (Philadelphia Phillies) and Wilmington Blue Rocks (Washington Nationals).

In the South Division, it's the Asheville Tourists (Houston Astros), Bowling Green Hot Rods (Tampa Bay Rays), Greensboro Grasshoppers (Pittsburgh

Nonprofits balance mission, safety in remote work trend

The nature of work – whether paid or voluntary, "essential" or not – has been transformed by the pandemic. Previous articles in this newspaper have examined how for-profit businesses such as restaurants, retail shops and wedding-service providers (photographers, DJs, etc.) have creatively addressed the challenges that began two years ago, and how they are adapting to long-term trends that have arisen during that time. Working remotely, for those whose jobs allow it, is one such trend.

Nonprofit organizations are also businesses, but they often have to navigate a more nuanced work landscape: one that adheres to their particular mission while prioritizing the safety of their employees and clients.

The pandemic "definitely changed everything" at the Bardavon in Poughkeepsie, said Executive Director Chris Silva.

Being a nonprofit entertainment venue, the Bardavon was subject to the same lengthy closure mandate as for-profit event facilities; but the staff worked throughout.

"We started doing our weekly staff and production meetings on Zoom in March of 2020 and have continued them to this day," said Silva. "Same with our board meetings, which results in better attendance."

Virtual meetings and working from home "truly allows for a better use of people's time and energy," Silva said, "and because many of us have been together for decades our efficiency has actually increased."

Now, when a show is happening, "It's still 'all hands-on deck' ... but 'office hours' are [still] very flexible," said Silva.

Some organizations didn't have the ability to work remotely, such as the Dutchess County SPCA (DCSPCA).

"Since we had animals to care for, remote working just wasn't an option," said Penny Schouten, DCSPCAMarketing/Communications/Community Resource Director. "The staff were divided into teams which worked alternatively in order to avoid spreading potential illness. The admin team also worked in animal care when needed and also alternated days in the office."

Schouten said, "One of the hardest things was we missed our teammates. We didn't see each other as often, as we were working on alternate days. We couldn't have lunch together or gather in groups. Our daily team briefing was kept short, held in our large lobby with everyone socially distanced. Maintaining the camaraderie, we had built was very difficult, although with smaller teams, some ties grew stronger."

VBMC reopens pediatric unit with CT Children's alliance

When children need to be hospitalized, parents want only safe, high-quality care for them that is close to home. The skilled, caring pediatric team at Vassar Brothers Medical Center (VBMC) wants the same.

That wish became a reality on Monday, April 4, with the grand reopening of VBMC pediatric unit, thanks to an alliance with New York Children's Medical Providers Services, P.C., an affiliate of the nationally ranked health system, Connecticut Children's.

A ribbon-cutting event was held on Thursday, March 31. "Vassar is now bringing an unprecedented level of specialized pediatric and neonatology care to our community by forming an alliance with Connecticut Children's, the only health system in Connecticut dedicated exclusively to the care of children," said Peter Kelly, president of VBMC in the City of Poughkeepsie.

For several months, the DCSPCA facility, located on Route 9G in Hyde Park, wasn't open to the public and staff weren't able to directly interact with the community. During that time, Schouten said, "we ramped up our social media activities to stay connected with our supporters and keep them engaged with our mission. This included lots of photos/videos of our available pets, a 'pet pawtrait' contest where the public submitted photos of their pets then volunteers and staff painted or drew their portrait, and foster family recruitment."

The DCSPCA's main fundraising event of the year was changed to a virtual gala.

When the pandemic hit, the DCSPCA administrative team was fairly new, Schouten said, and were in the process of moving to a community-centered shelter

"When everything shut down, we had to implement some of the plan immediately. This included moving as many pets as possible out of the shelter into foster care, providing more support to pet owners to keep pets in their homes and supporting both Hospice and Grace Smith House clients who might need temporary pet housing/care while they recovered or moved to safe housing," said Schouten. "Our foster program went from a handful of foster families to 400 new applicants in just two weeks. We sent pet food to regular food pantries for families struggling to feed their animals. With so many people being hospitalized and passing away from COVID, we were consistently taking in animals in need of safety net housing.

Despite the challenges, the organization was able to maintain the number of adoptions throughout 2020.

We did our dog meets outside in our play yards; or if a pet was in foster, arrangements were made to meet in a local park or at the shelter," Schouten said. "For cats, we did virtual meets with the foster and the adopters where possible.

In March 2020, when many businesses were forced to close as a result of emergency orders, the nonprofit Dutchess County Regional Chamber of Commerce (DCR-COC) became a source of assistance to not only its members, but to the general business community, all who were eager for information to help them survive closures and loss of revenue. During that time, the staff at DCR-COC worked remotely, said Frank Castella Jr., President & CEO.

"We were deemed non-essential despite

the great need for the COVID supportive services we provided to the business community," Castella said.

Weekly discussions open to the business community were held virtually to discuss disaster loan programs offered by the federal Small Business Administration, and business owners were invited to submit questions.

"The Chamber maintained some level of in-person events immediately after the threemonth government-mandated shutdown,' said Castella. "Even when capacity limitations were implemented on the number of people that could be held at an event, we either held to the maximum or composed events such as the Hudson Valley's Top Forty Under 40 Mover and Shaker Awards at the Hyde Park Drive-In Theatre and the Hudson Valley Hot-Air Balloon Festival drive-in style. Revel 32 and the Poughkeepsie Grand Hotel were both mandated to only hold 100 people for an event, so we held our annual black-tie Gala and creatively connected the two venues via Zoom, and those that didn't want to attend in-person were offered a takehome food option and to attend via Zoom. It worked well, but was a logistical challenge."

While remote work is a long-term trend for some, Castella said it's "not an option for the type of work that we provide," because an important part of the Chamber's mission is "growing relationships and connecting

"When you don't have face-to-face conversations around the water cooler, the camaraderie doesn't exist," he said. "While Zoom is good to have meetings on an occasion, we value the bonds that are built when we have in-person meetings.

Castella said some members have told him they'll keep some or all meetings online to save time, but he added, "I believe you will see people coming back to in-person meetings over time. The conversations that happen before and after our board and committee meetings are sometimes just as important as what happens in the formal meeting.

One would expect an organization built around creativity would have creative solutions to challenges. Staff at The Art Effect were not only able to work remotely, but also transitioned to virtual programs with success.

"If the country shutting down during the pandemic taught us anything about our work environment, it is that remote or hybrid remote work gives our staff more flexibility and promotes a better work/home life balsaid Executive Director Nicole Fenichel-Hewitt. "Although we were not together in-person throughout the pandemic, our team was working harder than ever from their living rooms, bedrooms and home

She added, "The ability to be flexible during uncertain and stressful times allows us to focus more on what's most important, our students and community. Despite working from home on and off the past two years, The Art Effect has continued to play a crucial role as a motivator that engages youth and promotes positive growth such as improved social skills, respect for one another, and a greater understanding of diversity and cul-

Fenichel-Hewitt noted that The Art Effect quickly pivoted to virtual classes, programs and events, "and what we found was an expanded reach and an unexpected connectivity within our community," she said.

Going forward, Fenichel-Hewitt said The Art Effect will continue to offer a more balanced workplace for its employees, and consider "out-of-the-box" idea that were harnessed by remote work.

"We are keeping some of the benefits of new comfort with remote interactions by live streaming our exhibitions and events, virtually connecting with guest artists from around the world, and continuing to offer alternative ways for students to attend program meetings and events such as our upcoming virtual Reel Exposure Teen Film & Photography Festival on May 4-6," she said.
At United Way of the Dutchess-Orange

Region (UWDOR), greater needs arising from the pandemic required many staff and

volunteers to step up in-person contact.

Melissa Clark, UWDOR's Senior Director of Community Impact, said, "We have seen so much hard work and altruism on the part of our local essential workers and volunteers. As need increased in the community our volunteers were on the front lines to help their neighbors receive, food, support and other basic essentials. At the same time many older

volunteers especially those who were immunocompromised did need to take some time off until the vaccines were widely available. Fortunately, our nonprofit sector is tremendous, and staff and volunteers stepped in to ensure people's everyday needs were

Clark noted, "As many nonprofit staff work on the front lines to secure households food, housing, mental health services and other critical needs, many have worked in a hybrid model throughout the pandemic. Hybrid work has allowed community coalitions and community members to convene safely and collaborate on strategies to help our community including providing services

and community wide vaccination strategies."
She added, "Remote work has also allowed nonprofits working regionally or nationally to work more seamlessly and has reduced transportation barriers. Of course, the downside has been not being able to attend events in person and celebrate one another's accomplishments.

'At United Way, many of us began working remotely two years ago at the beginning of the pandemic, however our physical office always remained open with a skeleton staff,' said Emily Darrow, Senior Director of Marketing & Communications. "Now, we all are working a hybrid model. To easily keep in touch with one another, we have an instant messaging platform that also shows when someone is at lunch, on a short break, etc. We utilized this pre-pandemic, but it became a lifeline during our remote work.

Darrow said many meetings are still conducted virtually, to cut down on travel time and allow greater participation.

"I know that like may offices, some of our greatest ideas are developed in seemingly casual conversation with one another, and we missed that," she said. "Melissa set up a weekly informal weekly remote discussion so that aspect of office life was able to go forward throughout the pandemic. For me, I find I am able to get far more work completed on my remote work days; but for others, remote work was more challenging. But I think all of us now have home offices and we probably will be using them now and into the future.'

Sarah Olivieri, a nonprofit business strategist based in Ulster County, said having remote work as an option "really adds value to employees, jut like anybody in any business" and tailoring jobs to people's needs allows employees to make a bigger impact.

Olivieri works with different types of nonprofits in the region.

'One thing I've notice that's affected local mental health organizations – that service providers have often struggled with in the past – is access," she said, with many clients also having transportation challenges. While the lack of in-person contact has created issues, Olivieri said, "One kind of opportunity the pandemic created [is that it] normalized remote access.

Pirates), Greenville Drive (Boston Red Sox), Hickory Crawdads (Texas Rangers), Rome Braves (Atlanta Braves) and Winston-Salem Dash (Chicago White Sox).

How many games will the Renegades play?

Hudson Valley will play 132 regularseason games – 66 at Dutchess Stadium and 66 on the road. All teams will play the same type of schedule from Tuesday through Sunday every week, using

Monday as a travel/rest day. That holds true except for the first week of July when all teams will play on Monday, July 4, and take off on Tuesday, July 5.

Is seeing a game at Dutchess Stadium still inexpensive?

Yep. Minor league baseball is still one of the best entertainment values for the dollar that you can get. The most expensive ticket for the best seats in the house is \$20, and they go down from there. And, really, in a facility that seats 5,000 there isn't a bad seat in

Renegades roster features talented nucleus of players

The Hudson Valley Renegades feature a prospect-laden roster as they return for their second season as the High-A affiliate of the New York Yankees in 2022. The Renegades roster will feature six of the Yankees top 30 prospects when the season gets underway on Friday.


Hudson Valley's roster is highlighted by six prospects ranked in the top 30 of MLB Pipeline's annual organizational prospect rankings. Catcher Austin Wells (No. 4) and infielder Trey Sweeney (No. 5) are joined by outfielder Everson Pereira (No. 11), pitchers T.J. Sikkema (No. 20) and Beck Way (No. 22), and infielder Cooper Bowman (No. 25) to give the Renegades a talented nucleus. Wells is also ranked by MLB Pipeline as the No. 96 prospect in all of baseball.

Wells impressed at the plate in his first professional season in 2021, batting .264/.390/.476 and clubbing 16 home runs in 103 games between Single-A Tampa and Hudson Valley. After the season, he played for the Surprise Saguaros in the prestigious Arizona Fall League and was named an All-Star. He is joined by fellow catchers and returners Carlos Narvaez, who hit .304 in 16 games with the Renegades in 2021 and Saul

Torres, a solid veteran defensive backstop.

The Yankees first round pick in 2021, Sweeney will hold down the starting shortstop spot after showing offensive promise by hitting seven home runs in 33 games between the Florida Complex League and Tampa in his pro debut. He is joined on the infield by fellow 2021 draftees Bowman (4th round) and Tyler Hardman (5th round). Spencer Henson, T.J. Rumfield, and returner Eduardo Torrealba provide versatility and depth on the infield.

Pereira brings his powerful bat back to the Renegades outfield after hitting 14 home runs in 27 games in Hudson Valley during the 2021 season. His signature game with the 'Gades was his three homer, six RBI performance on September 5 at Greensboro. Pereira is joined by returner Pat DeMarco

and newcomers Aaron Palensky and Aldenis Sanchez. Palensky spent the entire 2021 season with Double-A Somerset, playing 37 games, while Sanchez hit .413 in 23 games

Not to be outdone by the bats, the pitching staff promises to be one of the best and deepest in the South Atlantic League in 2022 as well. Highlighted by Sikkema and Way, the staff features returners Nelson Alvarez, Edgar Barclay, Nelvin Correa, Tanner Myatt, and Matt Sauer. New to the Renegades staff will be Blane Abeyta, Bryan Blanton, Blas Castano, Carson Coleman, Wellington Diaz, Michael Giacone, Rodney Hutchison, Alex Mauricio, Jhonatan Munoz, and Will Warren.

Overall, the Renegades have 12 players who spent time in Hudson Valley last year. The team also features 10 players who were selected in the first 10 rounds of the MLB Draft, including the last three Yankees first round picks (Sikkema, 2019; Wells, 2020; Sweeney, 2021).

Guiding the Renegades will be Tyson Blaser, spending his first season as the manager in Hudson Valley. He is joined on the field staff by pitching coach Spencer Medick, hitting coach Rob Benjamin and defensive coach Jose Javier.

VBMC reopens pediatric unit with CT Children's alliance

Closing the pediatric unit due to the COVID-19 pandemic allowed Vassar Brothers to take a closer look at the needs of the pediatric community. The unit now includes nine private rooms decorated in a Hudson Valley theme, including colorful fish, boats and soothing blue waves to optimize the healing environment for Vassar Brothers' pediatric patients.

Through the alliance with New York Children's Medical Providers Services, children who need to be hospitalized will be cared for by pediatric hospitalists with years of specialized training - in addition to pediatric nurses, respiratory therapists and others.

"This means your child's medical care will be supervised by doctors who are trained and experts at advanced pediatric healthcare," said Dr. Beth Natt, healthcare," said Dr. Beth Natt, Connecticut Children's Regional Clinical Director and VBMC's Pediatric Medical Director. "Our team will stay connected to the most advanced innovations and therapies to get your child well."

Vassar Brothers remodeled a designated wing on the fourth floor of its legacy building with close access to the neonatal intensive care and maternity units.

Children — newborn to age 18 be admitted to the pediatric unit through the emergency room, where New York Children's Medical Providers Services and Vassar Brothers also offer pediatric emergency medicine. Or children can be admitted directly by their community pediatrician without being seen in the emergency department.

"The pediatric medical community is thrilled Vassar Brothers once again has inpatient pediatric services and we have a trusted partner in the care of our pediatric patients," said Dr. Marc Habert, chair of Respiratory illnesses, including flu and COVID-19, post-surgical care, cellulitis, severe dehydration, broken bones and infusions are some of the

most common issues for which children would be admitted to the unit, which is fitted with pediatric vital sign monitoring, oxygen and tailored medication support.

The pediatric unit will adopt a familycentered care approach, which means the doctors and nurses will include parents as they round on their patients. They will also give frequent updates to parents and

caregivers on health conditions. Parents or guardians are able to stay by the bedside as long as they wish.

Most importantly, pediatric patients will remain at Vassar Brothers unless a higher level of care is needed, such as a pediatric intensive care unit or PICU. If that is the case, they can be transferred to a hospital of the parents' choice and will have easy access to Connecticut Children's main campus in Hartford, Conn.

bringing the expertise of Connecticut Children's to the mid-Hudson Valley, we are able to have the benefits of a major pediatric health system right here in our community hospital,' Kelly said.

Alternative High School students moving to Salt Point campus

Due to ongoing facilities difficulties at the Dutchess BOCES Alternative High School (AHS), students will be moving to schools at the Salt Point campus after Spring Break. AHS students will be attending remote classes until after Spring Break through April 19 and returning to in-person instruction at the 5 BOCES Road location on Wednesday, April 20.

"The health and safety of our students and staff is always, and will always be, our highest priority," said Deputy Superintendent Jodi Delucia. "We know this is a big move in a short time, but it is necessary and in the best interest of our students.'

Additionally, all students from Salt

Point Center and the Career and Technical Institute will be remote on Tuesday, April 19 to allow for a smooth transition.

The AHS is located in a rented facility at 900 Dutchess Turnpike that is occupied by manufacturing businesses in addition to the school building. The building is not meeting the needs and expectations of BOCES for a positive learning environment. As a renter, BOCES is unable to control the systems that are causing concern.

Currently, the capital project to build the new high school on the Salt Point campus is in full swing. The grand opening of the new building is anticipated in the fall of the 2022-2023 school year.

"Right now, the best thing for students is to return to in-person learning. While the new construction is not yet complete, we have identified spaces that may be used on the Salt Point campus temporarily to make in person learning a reality for our Alternative High School students,'

"Our number one priority is to provide all students in our care a safe, healthy, and positive learning environment," District Superintendent Jason Schetelick.

This temporary consolidation plan includes moving some professional employees to remote work to accommodate space needs, as well as relocating some classes within the Salt Point Center and the Career and Technical Institute.

Dutchess BOCES will continue to work with school districts, transportation, and support service providers to make the transition as smooth as possible. BOCES will communicate regularly with our community stakeholders.

Quick facts – Dutchess County (as of April 3)

It should be noted that active cases and community transmission rates are increasing across New York State and in Dutchess County - not dramatically at this point, but steadily. However, the CDC still rates Dutchess as a county with a low risk of transmission for fully vaccinated individuals.

Hospitalizations are up slightly; and for the first week in recent memory, there have been no deaths related to COVID-19.

Active cases: 174 (up from 125 on March 27)

Community transmission: 13.96 per 100,000 (up from 12.94 on March 27) **Hospitalizations due to COVID-19**: 4 (up from 3 on March 27)

Hospitalizations of individuals with COVID-19: 9 (up from 5 on March 27) Total deaths: 655 (unchanged from March 27)

% population 18+ with at least one dose of vaccine: 85.31 (slightly up from March 27, when it was 85.26)

% of total county population with at least one dose of vaccine: 76.85 (slightly up from 76.8 on March 27)

% of total county population that has completed their vaccine series: 69.27 (slightly up from 69.18 on March 27)

The county dashboard doesn't include data on boosters; however, according to the CDC, 51.2 percent of the county's fully vaccinated population has received a booster, up slightly from 51 percent on March 27.

Dora Chomiak, President of Razom for

we have a trusted network of partners on the ground that can tell us specifically what's needed most, and where. We've built and fostered these relationships since our founding in 2014 after the Revolution of Dignity." A couple of things, according to Chomiak, that Razom has been able to do:

• Over \$4-million+ has been spent on tactical medicine supplies (out of the \$10-million Razom has spent towards its Emergency Response Project). This number continues to grow each day.

• Razom is averaging procuring 10,000 tourniquets per week (worth over \$250,000/week) from the most reputable suppliers buying CAT, SOF-T and/or SAM brands. These single-use devices continue to be the most sought-after and requested across Ukraine as they play a huge role in life-or-death situations by stopping arterial bleeding

arterial bleeding.

"We hope that people will know how much this affects each and every person in the world, and that now is the time to come together to help our fellow humans. The level of suffering that is happening over there is unimaginable, we have been in a relatively peaceful time in the world, the only thing we can do to help is love and donate," said Malenke.

Tori noted, "Music is the language of all people, and certainly during these unprecedented times of COVID-19, coming together (now that we can) and sharing time in person, enjoying music while simultaneously helping those who are suffering from this humanitarian crisis is part of why I do what I do! 



Finding treasures and exploring shopping in colonial Dutchess County

The scenario is almost like something out of a treasure-hunting adventure.

Some years back, an unnamed individual dropped a tattered leather-bound volume off at the dump in the Town of Washington. An eagle-eyed observer picked up the book, saw that it was quite old, and brought it to the Millbrook Historical Society. Last summer, the Millbrook Historical Society loaned the volume to the Dutchess County Clerk's Office as part of County Clerk Brad

Kendall's Archival Imaging İnitiative.
Through this program, Dutchess County produces high quality digital copies of rare and vital historical manuscripts, ensuring that the information contained within them is preserved and made available to the public.

The tattered volume in question was just such a treasure: It preserved lists of goods purchased from Samuel Mabbett's store in 1773 and 1774. The store stood close by the Nine Partners Meeting House, which still stands today along Route 343 near the Village of Millbrook, though the current two-story brick building post-dates Mabbett's original store. Kept by his son Joseph Mabbett, the several hundred pages of scrawled handwriting preserve the names of Dutchess County residents as far afield as modern Dover and Stanford.

As if hinting that imperial tensions were reaching a boiling point even in central Dutchess, Joseph inscribed the following line just inside the cover: "God save the King, and Bless the Land; In plenty Joy and peace, God grant henceforth that foul debates twixt Noble men may sease.'

While Mabbett's wish for harmony was years away from fulfillment, concerns over potential war do not appear to have severely affected the family business. Between July

1-7, 1773, Joseph recorded 292 transactions. While that might not sound like a huge number for a week's worth of business, shopping in eighteenth-century Dutchess County was a little more involved than a dash down Route 9 is today.

Consider that customers had to either walk, ride a horse, or travel in a wagon to reach the Mabbett store, with travel times probably adding up to the better part of a full day. Once on site, shoppers had to navigate a different approach to the shopping experience. Instead of wandering through aisles choosing products, customers would likely have placed an order at a front counter with store staff, who fetched the items for them, probably from secure storage.

Paying for merchandise was both different and similar to today's shopping: practically everything was purchased on credit. However, where we use credit cards today, customers in 1773 used store credit, settling their accounts in-kind with items brought from their farms and business to pay off their bills. Dutchess County, New York, and the rest of British North America was light on hard cash, on purpose: Aauthorities in London did not want their colonists purchased goods from Dutch, French, or Spanish merchants. Severely restricting the gold and silver supply ensured that Dutchess County residents were confined within the British imperial system, but also made credit a necessity and settling debts a complicated business

So what makes the Mabbett Store Ledger especially valuable?

Most the ledgers recording store purchases in this period did not preserve much detail on what customers purchased. Instead, storekeepers emphasized the math involved in tracking debt and credit transactions. Most

books were divided with a record of the debt (purchases) on the left page and credit (usually bartered goods) on the right page. The goal was for the math to add up to the same number in each column, which signaled a balanced account.

Recording what a customer purchased was incidental to the process, so many of the surviving store ledgers simply show numbers or such helpful descriptions as "sundrys" in the debit column. In contrast, the Mabbett Store Ledger only lists what was purchased: it was probably kept on the spot at the front counter to record transactions at these happened, with the data being entered into a formal doubleentry ledger later.

So what were the most popular purchases in early July 1773 in central Dutchess? Textiles and related items (like pins and thread) topped the list at 27 percent of all transactions. The most popular item within that set was fabric sold by the yard, especially linen, which would have been used for men's shirts and women's shifts, the underwear of the day. Liquor was next on the list of popular purchases, with rum leading the pack: 45 out of the 52 liquor purchases were for rum.

And we are not speaking of small quantities here: Joseph Mabbett was selling rum at a minimum quantity of a half-gallon, with many purchases in multiple gallons. One must note that contemporary people used rum to preserve certain parts of the harvest, particularly fruit, but some approaches to consuming alcohol have not changed much over time. Customers also purchased brandy and wine, but there are no indications of whisky sales for those who might prefer a good single malt today.

Manufactured goods and prepared foods accounted for the remaining transactions. The main idea of the British colonial system was to extract raw materials (like iron from eastern Dutchess), bring those materials back to Great Britain, turn them into finished products, and then sell them back to the colonies.

The presence of iron furnaces and blacksmiths in Dutchess County from an early

period complicated that story and it may well be that some of the items purchased from the Mabbetts were made locally. Scythes and sickles, which accounted for 26 out of the 45 transactions, could certainly be made by a local blacksmith. Cast-iron kettles, settles of tableware (specifically knives and forks), tea pots, and teacups were more likely to be imported from abroad.

The prepared foods similarly reflected items that could not be produced onsite in Dutchess, with tea and sugar topping the chart. There was neither a Harney's, nor even a

Millerton, for the residents of 1773 to visit. Customers also purchased ink horns for writing, spelling books for school, and a

While the data contained within the Mabbett Store Ledger may not be surprising for historians, it is nevertheless vital for the study of our shared past, particularly in light of the approaching 250th anniversary of the Revolution. The ledger offers us a rare view into daily life, one with which we can find many parallels today.

We certainly visit the grocery store more frequently than our predecessors, but we probably all buy sugar, salt, and tea at some point. Practically all of the manufactured goods purchased today are produced far from Dutchess, New York, and even the United States. The realities of a global economy are nothing new: The denizens of 1773 knew the consequences of its rises and falls well. Most of all, the Mabbett Store Ledger reminds us to be careful with those rare survivals from our local past. It is not uncommon to encounter mystery items in garages, attics, basements, and laundry rooms. If you encounter a weird old book or other potentially historic item, run it by your local historical society or me before consigning it to the trash heap. Thank you to all the eagle-eyed observers who, like our friend at the dump, have saved rare survivals of our past for future generations to study

Legislature to vote on purchase of **Camp Nooteeming in Pleasant Valley**

Dutchess County Executive Molinaro announced he has sent a resolution to the County Legislature for the purchase of Camp Nooteeming, a 272-acre camp in the Town of Pleasant Valley, from Boy Scouts of America (BSA). The County plans to partner with Pathfinder FC (Football Club) for the management and operation of the camp, including coordination of youth camp programs and facility rentals, creating a sustainable operational model with no annual operating costs to the County. Once approved, camp programs for local non-profit organizations are expected to be operational for this summer. Camp programs will be part of an array of youth and community programs offered in coordination with the County's Path to Promise (P2P) initiative.

Once approved by the Legislature's

Public Works and Capital Projects Committee, the full County Legislature will vote on the property purchase at its board

meeting on Monday, April 11th. The resolution, which the Legislature's Public Works and Capital Projects Committee will consider at their April 7th meeting, will authorize a \$4.8 million appropriation from the County's General Fund balance. The \$4.8 million includes the purchase of the camp property for \$4 million, which was appraised at over \$5.2 million, as well as \$200,000 for all the existing maintenance and camp equipment such as canoes, row boats, archery equipment, bunk beds, tents, tables and chairs, mowers, tractors, and more; and an additional \$600,000 for the Department of Public Works (DPW) to make safety and ADA compliance improvements.

Archery and rifle ranges

Commercial kitchen



The County conducted a Request for Expressions of Interest (RFEI) process for a facility operator for Camp Nooteeming earlier this year to ensure summer camp programs could occur for the upcoming summer season following the property purchase. Pathfinder FC, who currently has a lease on the property for soccer facilities, was chosen as the camp operator.

The organization will be responsible for expanding programming at the camp to support the County's Path to Promise (P2P) initiative among other metrics for success.

Everything is opening up and we are moving forward

After two long years of bad news in the Travel industry, there recently has been some very good news. With the mask mandates dropped, people are sensing a touch of freedom and are itching to travel to take a vacation or to visit with loved ones.

All local and national travel agencies are reporting daily bookings in amounts not seen since prior to the start of the Pandemic. Airplanes are once again flying with full planes and cruise ships are sailing at capacity. The numbers of passengers moving through Transit Security Administration (TSA) checkpoints have increased exponentially. Caribbean resorts and cruise ships are welcoming guests on a daily basis and Europe is experiencing a similar uptick in visitors from the states.

According to Travel & Leisure, a comparison of the number of passengers from 2019 to 2021 shows that we are progressing from a positive standpoint.

In 2019, 2,730,800 plus passengers boarded planes. Those numbers plummeted in 2020 to 239,244 passengers. Many pilots and all affiliated staff were either furloughed, offered early retirement, or sought work outside of the travel industry. According to Bloomburg, 400,000 airline workers were let go. Many senior staff, both pilots and flight attendants either took early retirement or were offered a furlough package.

If anyone was traveling via a plane during the eye of the pandemic, it was mostly for work or to be with family. Very few passengers were traveling for pleasure. Even if passengers were comfortable flying, the majority of desirable destinations and resorts or theme parks were closed due to COVID-19.

We finally started to see a rise in the number of passengers again in 2021, reaching a high count of 1,164,964 passengers.

We attribute that to, what became known as, COVID fatigue. In addition to those who were traveling for work, we started to see passengers who were desperate to take a vacation.

Our office received many requests to go "somewhere" where they could "feel normal", relax and forget about COVID for a week. Some of the more poignant bookings we facilitated were for people who just wanted to "go home" to see their loved ones. The requirements to travel safely were laborious but the majority of returning passengers indicated that it was worth the effort. Even if someone was willing and wanting to travel, they faced additional challenges.

they faced additional challenges.

The rising costs of flights were a deterrent.

The loss of senior flight attendants resulted in a shortage of staff. Planes were still grounded often due to pilots taking furlough, thus leaving the industry, and some were recruited to positions as private pilots. Less popular non-stop routes were dropped resulting in more connecting flights.

ing in more connecting flights.

With the arrival of 2022 also came the unofficial declaration of the end of the pandemic. "We the People" were done with COVID and collectively decided to take back our freedom and reclaim our lives as we knew them.

As of press time, the State of New York no longer enforces the mask mandate. However, the Transportation Security Administration (TSA) has "extended its federal transportation mask mandate through at least April 18, requiring face coverings to be worn on planes, in airports, buses, trains and on other public modes of transportation."

So, how do you move forward and take the first steps?




