## Parking issues abound for Walkway this season

Very limited parking on east side; new cost on west side

One of the top tourist attractions in Dutchess County and the entire Hudson Valley, the Walkway Over the Hudson State Park, will have very limited parking on the east side of the Hudson River for tourists or local citizens for most of this year and into the next. Parking on the Ulster County side is now no longer free. There will be no state-provided parking on either side of the river until the spring of 2026 at the earliest.

The issue of park access is mainly due to two simultaneous construction projects on the Dutchess side: One by Scenic Hudson, creating a new headquarters; and another by the New York State Office of Parks, Recreation and Historic Preservation, building a new maintenance facility. The two projects have shut down both of the parking lots traditionally used by tourists and by local citizens hoping to experience the park and to learn about the Hudson River. The situation is coming to the fore as the Valley moves into the warm days of the spring and summer seasons.

Parking on the Ulster side of the river on spaces owned by the Town of Lloyd should continue to be available. It will require paying the toll at the Mid-Hudson Bridge plus \$5.25 via credit card for parking, either in the lot or anywhere on Haviland Road. The Town of Lloyd recently instituted the pay system.

Traditionally, the primary (i.e. most used) parking lot on the Dutchess side of the park was a large dirt area. Though privately held, that parking was made available year-round to park-goers. That area, which held well over 100 cars, was recently purchased by the non-governmental organization Scenic Hudson, along with the old Standard Gage factory

complex across the street on Parker Avenue. The factory is being rehabilitated into a new headquarters complex for Scenic Hudson.

Scenic Hudson notified the public, mostly via signs put up on the periphery of the lot, that they would close this parking area down in December 2023 to support construction at the new site. At that time, the signs promised the reopening of the lot for the public on weekends and evenings only, starting in the spring of 2025. Scenic Hudson didn't actually close the parking to the public until late spring or early summer of 2024. A sign

previewing a spring of 2025 opening remained until recently.

When the incongruity of the sign was pointed out to Scenic Hudson officials in an initial interview, their project manager commented that "signage is expensive." Subsequently, black tape was placed over the word "spring." A month or so later, while leaving the old sign in place, Scenic Hudson officials added a new sign suggesting the opening would be in the summer of 2025. Ned Sullivan, president of Scenic Hudson, now predicts "late summer or early autumn."

As for the trip to Texas, Veda is looking forward to "compet[ing] with other teams and to see how we place."

During the 4-day tournament, the Jaybots will go up against 256 other teams from 30 countries.

Nicole Lillo joined the Jaybots because of really liking STEM (Science, Technology, Engineering, Math) and



## Judge hands down decision in Wappingers Falls mayoral race

Huber to serve another term

Dutchess County State Supreme Court Judge Christi Acker handed down a decision regarding the Village of Wappingers Falls mayoral election, which took place on March 18. The race was between current Mayor Kevin Huber, a former village Trustee Jennifer Niznik and a former police commissioner Charles Ferry. Acker also stated regarding Village Clerk John Karge, "There is no indication that he failed to comply with the law nor is there any evidence of fraud."

"Quite simply, there is no proof that the Village Respondents failed to follow the Election Law," reads Acker's decision.

"Based upon the foregoing, the Court finds that [Niznik] failed to carry her burden to show that the Village Election Inspectors did not comply with the Election Law and the Impound Proceeding is dismissed in its entirety," stated Acker.

Acker said that after hearing the testimony of a witness, "the Court concludes that voters were identified pursuant to the Election Law."

According to Acker's decision, "In fact, [Niznik] called only one of the six election inspectors and [Niznik] herself did not testify at the hearing. Given that she was a candidate for Mayor, it is a safe assumption that she voted in the election. As [Niznik] alleges "stunning irregularities" in the conduct of the election, the absence of her own testimony is notable." Acker also states that there was not one "single instance" identified "in which a prospective voter's signature was not checked, nor any instances in which an individual's signatures did not match." She continued, "Moreover, this Court is precluded from "uncounting" any of the absentee or early mail ballots that were cast."

Niznik posted to social media on April 5, "I want to extend my heartfelt gratitude to everyone who stood by me throughout this challenging election. Your dedication, hard work, and unwavering support have been truly inspiring. Whether you volunteered your time, spread the word, or simply showed up to vote, you played a crucial role in ensuring that every voice in our community was heard." She continued, "A special congratulations to our newly elected trustees, Rosemarie Vanca and Ryan Chiumento. Your victories are well deserved, and I have no doubt that you will serve the people of Wappingers Falls with integrity and dedication. We look forward to the positive changes you will bring to our village."

On Huber's re-election social media, a post posted from his team last week, stated, "Judge Acker's decision speaks for itself, feel free to read the decision and understand

# Parking issues abound for Walkway this season

This project is moving forward with funding provided through the New York State Office of Parks, Recreation and Historic Preservation (OPRHP).

In December 2024, the state-provided parking on the Walkway's east side was closed in order to facilitate a building project. Several years ago, the park's offices and maintenance building on the corner of Parker Avenue and Washington Street burned down. OPRHP is now building a new and larger facility on the eastern end of the state's parking area. When closing the area, the state put up signs that the parking area was closing, but would be reopened in January 2026. The opening indication on those signs has since been taped over.

Currently, parking recommendations from both Scenic Hudson and the State Park management indicate that parking can be found at Pulaski Park, a few blocks away, or on Brookside Street, some distance to the south. Directions to these two alternates is provided by signage near the Walkway entrance on Parker Avenue. Reading the signs requires exiting a vehicle in order to read them; however, there is nearly no parking close by to allow this to happen.

Pulaski Park's lot is limited to roughly 40 spaces. The park, itself, features a City of Poughkeepsie swimming pool that is very heavily used in the summer time. Access to the pool is limited to pass holders, who regularly fill the park to capacity.

Brookside on-street parking has some capacity but, depending on how far up the street one finds a space, the walk to the park could approach half a mile. The sidewalk condition there is also far from perfect.

In the case of both of these suggestions, the actual access to the park is via the Washington Street staircase. The staircase is steep, and has a significant 90-degree turn before one reaches the top. It is not handicapped-accessible, nor is it easy for families with young children in strollers to utilize.

Attorney Fred Schaeffer, credited by many as the "Father of the Walkway," spent the better part of 13 years helping bring the dream of the park to reality. He reports that the situation has him "very concerned."

Currently suffering from some physical ailments, Schaeffer was still able to enjoy his bicycle on the Walkway.

"I can't physically carry my bicycle up those stairs anymore, though," he notes. "I'm hoping they can find me a place to keep the bike up there."

Except for the elevator, there is currently no handicapped access to the park from the Dutchess County (eastern) side. The park staff recommends that those who are physically challenged go to the other side of the river. However, there is no sign to that effect near the park, and no directions for tourists on how to find the other side's parking.

Linda Cooper, OPRHP's regional director, commented on the situation at the Walkway recently. She said that, in spite of the fact that the dirt parking area had been the one used by most park-goers over the years, the primary parking lot was the state-provided pay parking at the top of the hill behind this area. That pay area was not as large as the dirt lot, but was free to senior citizens during the week.

Cooper noted that the new, larger maintenance facility would allow for the storage of more equipment, including the Friends of the Walkway's summer tram. Asked why it was not possible to rebuild the maintenance facility on the same footprint as the one that had burned – the park had used that site since 2009 – Cooper said that some of their vehicles were not legal to drive up the street to the park's entrance. In spite of having kept those vehicles in the old site and used them for many years, she reiterated that "we have to be legal."

In a discussion of the larger parking lot having been purchased by Scenic Hudson, Cooper was asked why the state didn't purchase it instead. She responded, "We thought about it, but I guess Scenic Hudson gave them a better offer."

Cooper denied any possible relationship with the Scenic Hudson project across the street from the park.

"We have nothing to do with that," she said.

When reminded that the sign on the front of the Scenic Hudson headquarters project indicated the participation of the OPRHP in the project, she reiterated that there is no relationship between OPRHP and Scenic Hudson on this project. The sign was removed from the Scenic Hudson project later on the same day as our interview.

In fact, the Scenic Hudson project relies heavily on State and Federal Rehabilitation Tax Credits that are administered for this project by OPRHP. A Taconic Park Region commissioner who asked not to be identified confirmed that the money and project are closely monitored by OPRHP for this project and others throughout the state.

Cooper agreed that handicapped access to the park from the Dutchess County end could be problematic. She noted that the Town of Lloyd, which owns the Walkway parking on the western side, has provided handicapped spaces in their parking lot. There is no indication of this on the Dutchess County side, nor any information about how to get to that lot.

As to the possible shortage of parking at Pulaski Park when the swimming pool is in use, Cooper said, "We are not in competition

with the swimming pool, because most of our visitors will come to the Walkway in the 'shoulder' season, in spring and fall." She did not address the question of families with children coming on school vacations in the summer, nor of the many hundreds of people who take part in fundraising walks that raise awareness for various causes. The first, the Walk for Heart Health, is currently scheduled for April 26. Their current advertising indicates that they expect to gather at both ends of the bridge.

Melaine Rottkamp, the president and CEO of Dutchess Tourism, recently named the Walkway first when asked for the most important attractions in Dutchess County. Rottkamp agrees that the lack of parking on the Dutchess County side of the park is problematic, but notes that those coming to the area on the train could take a short walk to the park's elevator, when the elevator is working. There is currently no signage at the train station to indicate the way to the elevator.

State Senator Rob Rolison is monitoring the situation. He notes that "the Walkway Over the Hudson State Park is a treasure of Dutchess County and an economic driver for the county and for the City of Poughkeepsie." He is now conferring with the "various stakeholders with an eye to mitigating as much as possible, particularly for the handicapped."

Dutchess County Executive Sue Serino

says: "The Walkway Over the Hudson is one of Dutchess County's most iconic destinations, and it plays a major role in driving tourism and supporting our local economy. Each year, it draws hundreds of thousands of visitors who don't just come for the breathtaking views – they also explore our downtowns, dine in local restaurants, and stay in our hotels. It's a powerful example of how investing in our natural and historic assets can create real economic opportunity for our community."

What might it all mean? The Heart Walk and other annual activities could certainly be impacted. All of these issues have been brought to the attention of the State OPRHP and to Scenic Hudson. Both are looking at them.

If nothing changes, there will be no state-provided parking for the Walkway Over the Hudson State Park for the next year. The part-time availability of parking on the plot now owned by Scenic Hudson will be limited to evenings and weekends.

The Friends of the Walkway organization is planning to have off-site parking organized for their volunteers and for Walkway Ambassadors. They are also outlining some shuttle services to be available from other parking lots in Poughkeepsie for their major events, like the popular annual 4th of July Fireworks event. For the Fireworks event, usually about 1,800 of the 3,000 patrons enter the Walkway from the Dutchess County side.

Friends of the Walkway Executive Director Lori Robertson said, "Friends of the Walkway is working closely with our partners to provide as much access to parking as possible while lots near the park are under construction."

She noted, "During special events like the July 4th Fireworks, we routinely utilize several parking areas located less than 0.7 miles from our entrance to accommodate our guests. Information about general parking availability can be found at walkway.org/visit, while special event parking options, including handicapped parking, are communicated through our specific event webpages and emails sent directly to registered attendees. Carpooling is always encouraged."

What to expect for the summer? Parking will be a significant issue for at least the next year. If coming to the Walkway, look at the various websites to acquire the latest parking information.

## Potential Waterfront Project in Town of Fishkill

### To the Editor:

At the recent April 2, 2025 Town of Fishkill Board meeting, Supervisor Albra and Council Member Bardini mentioned that they were working on a project for the Fishkill waterfront. I reminded that the board had already heard from that developer, Thomas Perna, RPA Associates. He came before the Board to ask, and we consented, to endorsing his efforts to request the MTA allow him to build a bridge over the tracks to this parcel of land on the river.

After that recent Board meeting, I reviewed the potential scope of this project, all conceptual at this point, by reading Mr. Perna's 10-23-23 letter to the Fishkill Planning Board where he described this project. Maybe it has altered since then, but at that point it consisted of a road system, a bridge over the MTA railroad tracks, 116 residential units in four buildings, a waterfront park, commercial development and a public boat launch ramp. Supervisor Albra indicated last night that the Town Board should be the lead agency on this development and that he wanted to fast track it.

That initially sounded interesting, except for the fast-tracking part, but John Forman and I strongly believe the Planning Board has the training and staff to be the lead agency. We are writing this letter to the editor to basically let everyone know including the Town Board that the Planning Board needs to do what it is they are exquisitely trained to do. They have the time and the skill to review such complicated projects therefore they must be lead on this project should it ever get to a point where there are formal plans. This whole project sounds like a win for the Town of Fishkill, but let's put its review through the appropriate process, via the Planning Board.

## CSEA: Cuts to NIOSH would put millions of workers at risk

### To the Editor:

The CSEA (Civil Service Employees Association) is expressing concern about deep staffing cuts at the National Institute of Occupational Safety and Health (NIOSH) as part of a restructuring ordered by U.S. Department of Health and Human Services (HHS) Secretary Robert F. Kennedy Jr.

The cuts would eliminate nearly 900 jobs, or two-thirds of the workforce, as well as entire divisions at the agency, which conducts research on workplace safety and health and making recommendations to prevent work-related injuries and illness. NIOSH has provided lifesaving work since Congress created it in 1970.

These ill-advised cuts to NIOSH will potentially endanger millions of workers. This is not just a budget cut - it's a rollback of decades of worker safety progress putting millions of workers at risk. One of CSEA's top priorities is to ensure that our union members can do their jobs as safely as possible so they can get home to their loved ones. CSEA will continue to monitor the situation and act accordingly.

Here is what NIOSH does for workers:

1. Tests and Certifies Respirators – NIOSH ensures that respirators protect workers from deadly hazards like asbestos, silica, and infectious diseases.
2. Develops Lifesaving Workplace Standards – Many of OSHA's protections (e.g., noise limits, chemical exposure rules) are based on NIOSH research.
3. Investigates Worker Deaths and Hazards – NIOSH runs the Fatality Assessment and Control Evaluation (FACE) Program, which investigates worker deaths to prevent future tragedies.

4. Studies Dangerous Chemicals and Diseases – NIOSH identifies workplace carcinogens and toxic chemicals before they cause widespread harm. Their research has led to protections against lead poisoning, silica, and PFAS chemicals.

5. Protects First Responders and Health Care Workers – NIOSH developed PPE standards for firefighters, paramedics, and nurses. Their research helped protect workers during COVID-19, Ebola, and 9/11 cleanup efforts.

6. Improves Safety for High-Risk Jobs – NIOSH studies injuries and deaths in dangerous jobs like construction, mining, trucking, and agriculture. Their work leads to safer equipment, training, and practices that prevent thousands of injuries every year.

7. Advances Workplace Mental Health and Violence Prevention – NIOSH studies workplace stress, burnout, and violence—especially for social workers, nurses, and teachers. This research helps create solutions to protect workers from assault and mental health crises.

Without NIOSH, workers would lose these essential protections and put millions of workers at risk for injury and death. These cuts will only benefit billionaires who want to create more profits by gutting worker protections.

## Release the kids from Ukraine

We had the opportunity this weekend to attend a screening at The Moviehouse in Millerton of two very moving short films focusing on the impact of Russia's barbaric war upon children — "Sunflower Field" and "Once Upon a Time in Ukraine" — followed by a panel discussion with Polina Buchak, who directed Sunflower Field, and Anastasia Rab, Chief Advancement Officer for Razom.

In the panel discussion, Ms. Rab highlighted the plight of the 19,546 known children abducted and held by Russia. You see, Russia is not content with destroying Ukraine and its' past, it is intent on destroying her future as well by abducting her children. One simple action is to call, email, and or write your representatives including the President to demand that release of all abducted children be written in as a RED LINE to any ceasefire and peace agreement supported by this country.

While doing so, please also let your representatives know that you demand America supports a Just Peace for Ukraine consistent with our values with full territorial integrity rather than just any peace which leaves Ukraine and Europe exposed to the next round of Russian terror.

# BluePath celebrates recent graduates

BluePath Service Dogs, a nonprofit organization that provides autism service dogs, celebrates the placement of three new service dog teams, offering newfound hope and freedom to children with autism and their families.

"Graduation day is a milestone that never loses its magic," said Michelle Brier, BluePath's Chief Executive Officer. "It's the moment we see the impact of our collective efforts - the culmination of years of dedication, love, and belief in something bigger than ourselves. We don't just celebrate new service dog teams; we celebrate possibility, transformation, and the power of community."

The demand for BluePath dogs is greater than ever before; one in every 36 children born today will develop an autism spectrum disorder (Center for Disease Control and Prevention). The propensity to wander or bolt is a hallmark behavior of autism and poses a significant threat to the well-being of children affected. Even the most routine trips outside the home can quickly transform into life-threatening experiences. To avoid disruption and risk, children and their families often retreat into the safer environments of their homes and experience significant social isolation as a result.

Juan Alvarez and Lisbeth Quispe, from

Danbury, CT, are the proud recipients of BluePath Ginny for their seven-year-old son, Eliam.

"Eliam has had many challenges," said Juan Alvarez. "He is very sensitive to loud noises and if there is something he doesn't like or gets frustrated, he instantly bolts without measuring the danger that can be."

Service dogs are the only effective intervention to elopement in children with autism. BluePath is committed to serving children with autism and their families by providing high quality service dogs that offer safety, companionship, and independence – free of charge.

"Our first weekend with Ginny was spectacular. We went to our favorite restaurant, and for the first time in a long time, we had a family dinner without worrying that Eliam would run off or get frustrated," said Alvarez. "Seeing Eliam with Ginny gave us a sense of peace we hadn't known before."

Since its inception in late 2016, BluePath has matched 57 service dogs with individuals on the autism spectrum and their families. ## Cary Institute ecologist finds getting hit by lightning is good for some tropical trees

Getting zapped with millions of volts of electricity may not sound like a healthy activity, but for some trees, it is. A new study, published in *New Phytologist*, reports that some tropical tree species are not only able to tolerate lightning strikes, but benefit from them. The trees may have even evolved to act as lightning rods. The research was led by Evan Gora, a forest ecologist at Cary Institute of Ecosystem Studies. Gora studies how lightning impacts biodiversity and carbon storage in Panama's tropical forests. Lightning kills hundreds of millions of trees per year. But in 2015, while working in Panama, Gora and his colleagues came across a Dipteryx oleifera tree that had survived a strike with little damage — even though the jolt had been strong enough to blast a parasitic vine out of its crown and kill more than a dozen neighboring trees. "Seeing that there are trees that get struck by lightning and they're fine was just mind-blowing," Gora recalled. Over time, the team encountered

other Dipteryx oleifera trees thriving after getting hit, so they decided to take a closer look. Scientists had previously suspected that some trees evolved to tolerate lightning, but evidence to back it up was lacking. In 2022, Gora and colleagues demonstrated for the first time that trees differ in their ability to survive getting hit by lightning. Their new paper, published Wednesday, is the first to show that trees can benefit from these electric jolts.

Using a unique lightning location system, the team tracked the outcomes of 93 trees that had been struck by lightning in Barro Colorado Nature Monument in central Panama. For two to six years after the strike, the team measured tree survival rates, crown and trunk condition, number of parasitic vines or lianas, and neighboring tree mortality. The study included nine directly struck Dipteryx oleifera trees, and compared them with 84 other trees that had been struck.

All nine Dipteryx trees survived direct light-

ning strikes with only minor damage. In contrast, directly struck trees of other species were badly damaged, losing 5.7 times more leaves from their crowns, and 64% died within two years.

When each Dipteryx tree was zapped, an average of 9.2 neighboring trees were killed as the electricity traveled between adjoining vines and touching branches, or jumped across small gaps between trees. Lightning strikes also reduced Dipteryx liana infestations by 78%, freeing trees from some of the pressure these parasitic vines have on light and nutrient availability.

These patterns also bore out across the broader population. The team found that Dipteryx trees tend to have fewer lianas. Analyzing trends in tree death over the past 40 years, the researchers found that the trees neighboring Dipteryx trees were 48% more apt to die than other trees in the forest, likely because of lightning.

Using drones, Gora and colleagues created 3D models of canopy height, which showed that Dipteryx trees tend to be about four meters taller than their nearest neighbors, likely because lightning killed their taller neighbors, giving them an advantage in competing for light and space.

"These data provide the first evidence that some trees benefit from being struck by lightning," the authors write. Or, as Gora puts it, "It's better off for a Dipteryx oleifera tree to be struck than not."

Because of all these benefits, Dipteryx oleifera trees may be specially adapted to attract lightning. With their distinctive height and unusually wide crowns, they may be up to 68% more likely to get electrocuted than other trees with average height and crowns, according to the team's calculations.

## Congressman Ryan releases results of Optum inquiry, submits data report to FTC, Department of Justice

Last week, Congressman Pat Ryan released the results of his community inquiry regarding the quality and accessibility of care at Optum-owned Hudson Valley medical practices. Over 1,800 responses from Optum patients illuminated a pattern surrounding Optum's care quality, accessibility, and billing practices.

Several providers also responded to the inquiry, citing how treatment of staff has suffered from the switch to Optum, further contributing to a general decline in the quality of care administered. Ryan is now submitting the full dataset to the Department of Justice, Department of Health and Human Services, and Federal Trade Commission for further investigation and imminent action.

"The volume of responses, the specificity of issues, and the frankly heartbreaking stories involved are unlike anything I've seen in my time in Congress. I've heard from disabled children unable to get treatment. Mothers waiting almost a year for a cancer diagnosis. Families sent into debt because of over-charges for treatments never even received. All so the largest health care company in the world can continue to make record breaking profits," said Congressman Pat Ryan. "I've already been in touch with Optum to get folks help on an individual basis in the short term,

but that's just a band-aid. Today I'm formally submitting every single piece of data to the Department of Justice, the Department of Health and Human Services, and the Federal Trade Commission for further investigation. And I will be pushing around the clock for further action. For anyone not convinced urgent change is needed, read every damn story below. When our Hudson Valley community stands up with one voice, anything is possible."

Over 36% of Optum patients who responded to the inquiry said they've experienced serious customer service issues that have interfered with their care, which many say has only worsened since Optum took over. Most commonly, they cited intense difficulty with Optum's phone system, which no longer allows patients to call their doctor's office directly – meaning, for example, that someone can't ask a nurse a question about their medication or a receptionist about sending medical documents to their employer or kid's school. Instead, patients are sent to a call center with wait times that can extend up to several hours, with no guarantee that their message will be read or responded to. In addition to causing significant frustration for patients, this has led some to miss out on critical medications.

## DC Comptroller's office launches online tool for reporting loss of federal funds or jobs

The Dutchess County Comptroller's Office has released a survey form for Dutchess County residents and organizations who have lost federal jobs or funding, directly or indirectly. This information will be collected, verified, and ultimately provided to all local, state, and federal leadership as a means of better supporting the needs of the community and to help focus economic planning.

This tool follows the release of the Comptroller's Office special report on the County's 2021-2023 receipt of federal funds and the interest it generated.

"The national conversation around federal funding can be confusing and alarming," said Comptroller Dan Aymar-Blair. "Being well-informed is the antidote to anxiety, and the Comptroller's Office is happy to collect any data that better informs policy makers and the public."

Congressman Pat Ryan's (NY-18) office has been trying to navigate the new presidential administration's priorities and policy changes since January, working to keep the district informed as to whether these might have a tangible impact on the community. Congressman Ryan's office has encouraged local municipalities to alert them to any cuts affecting their day-to-day operations.

The Comptroller's Office has identified

nearly \$35 million in lost federal investment in Dutchess County, including a loss of \$2.4 million in earmarks for Dutchess County's real time crime center and public safety radio system, but which is primarily for renovations and improvements to fire stations and wastewater treatment facilities.

Said Town of North East Supervisor Christopher Kennan, "The Village of Millerton and the Town of North East have been working hard on plans for a wastewater system to serve both municipalities. These improvements are sorely needed to reduce our dependence on old, and in some cases, broken septic systems. A reliable wastewater system is crucial to improving our economy—more businesses, more jobs, and more housing! The \$3 million in federal funding allocated for this project by Senators Gillibrand and Schumer was just yanked—this will be devastating to jobs and housing critical for our future."

The information collected through the new "Loss of Federal Funds/Jobs Survey" will contribute to this growing data set. "Tracking how much federal investment in Dutchess County is being lost gives us perspective for future economic development, future sales tax revenue, and more," said Aymar-Blair. The newly created intake form can be accessed on the County's website.

## Judge hands down decision in Wappingers Falls mayoral race

the challenges we faced and understand that our election system has been challenged at a hefty cost to the hard-working residents of our community. Thank you so much for your vote of confidence."

The post continued, "For the last 3 weeks our Village's government has been left in limbo. It has been a stressful time for many of us ... all of your positive thoughts and prayers have come through." The election results have given Huber another two years as mayor.

Acker, in her decision, stated that "...the Court need not reach the issue of whether [Niznik] failed to name a necessary party. Nevertheless, as the "error" that [Niznik] seeks to rectify, is that of the Village Election Inspectors' alleged failure to verify the signatures of prospective voters, the Election Inspectors are clearly necessary parties and [Niznik's] failure to join them was jurisdictionally fatal."

"On March 19, 2025, Village Clerk Karge requested that the Board of Elections recanvass the votes cast. The Board of Elections sent a team to collect records from the clerk.

The team twice visited the village hall to collect records and Village Clerk Karge hand-delivered voter registration books. The recanvass was completed on March 24, 2025," according to court documents. Acker noted that hearings were held before the Court on March 31 and April 1 and "[f]our witnesses testified and various documents were introduced into evidence, including voter lists, registration cards and poll logs."

"Consistent with Election Law § 15-126(3), the Dutchess County Board of Elections completed a recanvass of the Village Election on March 24, 2025. While the Recanvass was pending, any further action by, or on behalf of, the village clerk [John Karge] was stayed "with regard to further election procedures required by this section." ... Similarly, although the Board of Elections was permitted to advise the Village Clerk of the result of the recanvass, the village Clerk was statutorily stayed from notifying the persons elected as a result of the recanvass," reads the Decision.

The Dutchess County Board of Elections took possession of the ballots on March 20.

A recanvass of the votes was done, according to Dutchess County Republican Elections Commissioner Erik Haight and Democratic Commissioner Lisa Jessup.

According to Acker's Decision, "Village clerk Karge testified first. He is the chief election officer for the village of Wappingers Falls and has been involved in village elections for 23 years." He testified about proceedings for the election, a court document states.

"Unfortunately, this election was overshadowed by serious concerns regarding this administration. The actions of the Village Clerk have cast a cloud over the process, leading to confusion and distrust. Elections should be free, fair, and transparent—yet what we witnessed was a mishandled process that left our community questioning the results," Niznik said in her social media post. "To restore confidence in our elections, it is clear that future village elections must be conducted by the Dutchess County Board of Elections. The integrity of our democratic process depends on it. No candidate, voter, or public official should ever have

to question whether ballots were properly counted or whether election procedures were followed correctly."

Acker's Decision states: "The Court had the ability to observe Village Clerk Karge and finds that his testimony was credible. While his testimony may have been confusing on occasion, this was rare and he ultimately explained any nuances. Karge impresses as a long-time public servant who works hard to be knowledgeable and to run these village elections in a lawful manner."

Acker ordered "that the Board of Elections and Village Respondents shall proceed with their statutory duties in relation to the completed recanvass."

Huber told Southern Dutchess News that he was just "glad it's over."

Karge told Southern Dutchess News it is the way democracy works and offered thanks to the Dutchess County Board of Elections for their work.

Niznik stated earlier this week: "I am not going anywhere, and I will continue to be present and push the administration to do what's right for the village of Wappingers Falls."

## Vassar College to honor legacy of Grace Hopper '28

### Known as America's 'Queen of Code'

Grace Hopper, America's "Queen of Code," will be celebrated with an event at The Vassar Institute for the Liberal Arts on April 10, from 5-7 p.m., 165 College Avenue, Poughkeepsie. Hopper, Vassar Class of 1928, arrived at the college as a student a century ago. # Loving lemon

A sweet-tart treat that's perfect for spring

When it comes to flavors that exemplify spring, lemon always tops my list. True, lemons aren't exactly local produce in our part of the world, but their bright, zesty freshness has the ability to wake things up, and that's about as vernal as it gets. I use lemons all year long in lots of wonderful ways, which is why I've written about them many times; but in spring they really seem to shine. That's why they always have a place on my Easter table in dishes both savory and sweet, and also why I'm featuring them yet again.

This year they'll grace a light luscious dessert that's a perfect fit for a spring celebration. With just a few ingredients that you probably already have, it comes together quickly and separates magically into layers as it bakes: a custard-like pudding on the bottom and an airy cakey layer on top. Its sweetness is just right and the tartness is refreshing even after a big meal.

And now for a little breakdown of the magic. Eggs play an important role here. We're separating them with good reason. The yolks add a little richness and help keep it moist and firm, while the whites lighten it up and make it fluffier, helping it rise. Beaten egg whites also float to the top as the cake bakes, forming the spongey cake layer. The denser yolks take their place at the bottom for the pudding

layer and, presto! Pudding cake!

### LEMON PUDDING CAKE

I must admit, I don't love the name. It just doesn't quite do it justice. Technically, though, it's correct in the baking world because it does, as previously stated, separate as it bakes to form a pudding-like bottom layer. I used a spring-form pan, which I recommend since it puffs up as it bakes in souffle-like fashion. It will fall a bit as it cools, but that's perfectly fine. A simple dusting of confectioner's sugar and a few fresh berries or spring flowers on top make a pretty presentation. Serve with a dollop of sweet whipped cream on the side and watch it magically disappear.

Helpful hints: Zesting the lemons before juicing them is much easier. Strain the juice before adding to the batter to eliminate pulp and any seeds.

For the fluffiest egg whites, start with a clean, dry bowl and clean beaters. Make sure there are no traces of yolk when you separate the eggs. Gently fold the whites into the batter to avoid over-mixing to keep it fluffy: Place whites on top and carefully use a spatula in a vertical swirling motion to roll them into the heavier batter just to combine.

### INGREDIENTS

4 tablespoons butter, softened (I prefer salted, which brings out the flavor)

1/2c sugar (add a little more, 1-2 tablespoons, if you prefer a slightly sweeter cake)

4 eggs, room temperature, separated  
1c flour (sifted)  
1/3c fresh lemon juice (~ 2 lemons)  
1 tablespoon lemon zest  
A pinch of salt  
2 1/2c (preferably whole) milk  
Confectioner's sugar for dusting  
Whipped cream for serving (optional)

### METHOD

Lightly grease a spring-form pan. You can place the pan on foil and crimp it up the sides to seal the bottom edges to prevent leaking if you like. (Alternatively, place it on a baking sheet to bake.) Move oven rack to the center position. Preheat oven to 350 degrees.

In a large bowl, cream together the butter and sugar until combined and smooth. Add egg yolks one at a time, then flour, mixing well after each addition. Mix in lemon juice and zest, salt and milk. Beat until smooth and almost doubled in volume.

In a separate clean bowl, beat egg whites until glossy and stiff, about 4 minutes. Gently fold whites into the yolk mixture until just combined. DO NOT over-mix.

Pour into spring-form pan and bake until lightly golden brown and cake jiggles only slightly when the pan is gently shaken, about 40 minutes (but no more

than 45). Transfer pan to a rack to cool.

When ready to serve, remove sides of the spring-form pan, place on a cake plate (with the pan bottom) and generously dust with confectioner's sugar. A sieve works well for this. Add some fresh berries or spring flowers if you like. Serve, warm or cool, with a dollop of whipped cream.

You can make this a day ahead; just don't top with the confectioner's sugar until serving since it will absorb into the cake.

Lemons, in all their sunny brightness, are the perfect homage to spring, and desserts like this one illustrate that deliciously. The simplicity of this pudding cake – in ingredients and presentation – make it an elegant recipe to enjoy anytime but, if you ask me, serving it this time of year is especially perfect. It will bring a little magic to your table while celebrating the miracle of spring. Enjoy!







**TOWN OF PLEASANT VALLEY PROPOSED LOCAL LAW OF THE YEAR 2025 A LOCAL LAW AMENDING THE TOWN CODE OF THE TOWN OF PLEASANT VALLEY BY ENACTING A NEW CHAPTER 72 ENTITLED "RESIDENTIAL RENTALS"**

BE IT ENACTED by the Town Board of the Town of Pleasant Valley as follows:

**SECTION 1. PURPOSE**

The purpose of this Local Law is to promote the public health, safety and welfare by opting in to the

New York State Good Cause Eviction Law (RPL Article 6-a), as permitted by Real Property Law § 213, and amending the Town Code of the Town of Pleasant Valley to enact a new Chapter 72 entitled "Residential Rentals," with Article I entitled "Prohibition on Eviction Without Good Cause," to implement the provisions of the New York State Good Cause Eviction Law in the Town of Pleasant Valley.

**SECTION 2. AUTHORITY AND SUPERSESSION**

This law is adopted pursuant to the provisions of the Municipal Home Rule Law 10(1)(ii)(a)(12) which grants local governments the authority to enact local laws regarding the public health, safety and welfare, and pursuant to the provisions of Real Property Law Article 6-a. To the extent the provisions of this Local Law conflict with State law, the Town Board hereby asserts its intention to supersede same pursuant to the Municipal Home Rule Law.

**SECTION 3. AMENDMENT OF TOWN CODE**

The Town Code of the Town of Pleasant Valley is hereby amended to add a new Chapter 72 entitled "Residential Rentals," which shall read as follows:

**CHAPTER 72 Residential Rentals Article I: Prohibition on Eviction Without Good Cause**

**§ 162-1 Purpose.**

The purpose of this article is to make the provisions of Article 6-a of the New York State Real Property Law regarding rental property and prohibiting certain evictions without good cause effective and binding law in the Town of Pleasant Valley.

**§ 162-2 Opt-in to New York State Real Property Law Article 6-a.**

As authorized by New York State Real Property Law Section 213, the Town of Pleasant Valley does hereby opt-in to the provisions of New York State Real Property Law Article 6-a.

**§ 162-3 Prohibition of evictions without good cause.**

A. All applicable provisions set forth in Article 6-a of the New York State Real Property Law, and any amendments thereto, are hereby adopted by the Town of Pleasant Valley and incorporated herein by reference.

B. Pursuant to § 213(2)(a) of Article 6-a of the New York State Real Property Law, for the purposes of this

chapter, any unit within a housing accommodation shall be exempt from the provisions of this chapter if such unit has a monthly rent above three hundred forty-five percent (345%) of fair market rent, as published by the United States Department of Housing and Urban Development and as shall be published for the County of Dutchess by the New York State Division of Housing and Community Renewal.

C. Pursuant to § 213(2)(b) of Article 6-a of the New York State Real Property Law, for the purposes of this chapter, a "small landlord" is defined as a landlord of no more than one (1) housing accommodation anywhere in the State of New York, provided that owner-occupied housing accommodations or otherwise exempt housing accommodations shall not be considered in calculating the number of housing accommodations owned by a landlord.

**§ 162-4 Automatic Sunset of this Chapter.**

Pursuant to § 7(b) of Chapter 56, Part HH, of the Laws of the State of New York of 2024, this chapter shall automatically expire and be repealed on June 15, 2034, unless Article 6-a of the New York State Real Property Law is extended or otherwise amended to remain in force and effect by the State of New York prior to such automatic repeal date.

# get growing!



My bees died.

Last November 16, I wrote in my garden journal "Another beautiful day. Bees still active at beehive. What are they feeding on?" Then on March 10, "Nice day. Heard first peepers tonight." The bees should have been out, searching for blossoms on the maple trees. But they weren't.

Meanwhile, lots of chatter about honeybees has been popping up on my internet home page, because I always click on "accept all cookies." Evidently, it's been an unusually perilous season for bees, even considering the perennial challenge from colony collapse syndrome. So maybe I'm not alone.

I've always kept one beehive, to help pollinate the flower and vegetable garden, and not intentionally, to pollinate the invasive porcelain vine obscuring my back fence. I'm no expert, and I have lost beehives over the years. I've also witnessed a few swarms, when a new queen takes off with her entourage. I once ran directly into a big swarm while I was mowing under a weeping cherry tree, which is how I found out that swarming bees have no interest in stinging anybody.

Honeybees are not native to North America. Before the advent of colony collapse syndrome (20 years ago), some people worried that honeybees would pose a threat to the 450 species of native bees in New York state. But nowadays the focus seems to be keeping honeybees alive, period. Fungus, diseases, pesticides and mites are all conspiring to kill bees. (Just this year, New York

banned the use of systemic neonicotinoid pesticides for outdoor use).

Instead of relying on the internet to find out what happened to my bees, I decided to visit our local beekeeper (or "honeybee steward") extraordinaire Dennis Remsburger. Dennis manages 450 honeybee colonies, home to upwards of 20 million bees, creating products ranging from honey and glycerin soap, beeswax lip balm, candles, pollen, up to jars and bottles of pure Hudson Valley honey. A specialty is a garlic infused honey, made from homegrown garlic, available at the farmers market in Brooklyn's Grand Army Plaza, where Dennis spends his Saturdays. You can also find Remsburger honey products at local farm stands like Meadowbrook Farm, Quattro's, and Barton Orchards. The hives provide pollination services to nine commercial orchards, where the bees spend a few weeks among local apple, peach and apricot blossoms.

Looking over his dominion, Dennis points out a couple of hives that didn't make it through the winter. I asked why.

"We had a real winter," Dennis replied, referring to the prolonged cold spell last January. I told him my bees were doing great right up until the end of November, flying out of the hive.

"Those bees were going to die," he said. At Dennis' urging, I had opened the hive just before I went to see him. It was almost empty, except for a handful of dead bees at the bottom. It seemed to be a case of Nosema fungus, the most widespread of the plethora

of bee diseases. The other all too common honeybee plague is varroa mite, which I had anticipated and tried to prevent by applying formic acid strips.

Cornell University's pollinator network advises beekeepers to monitor their hives every two weeks, or at least several times per season, since most problems can be resolved if they're discovered early. Dennis is vigilant. Amidst all these challenges, he stays upbeat about his honey empire, and he loves his "ladies," the female worker bees, each one producing a twelfth of a teaspoon of honey during its six week lifespan. (That statistic alone makes me want to stop eating honey).

Fifteen years ago, my little granddaughter Priya started drinking out of a jar of honey we'd bought at the Rhinebeck Farmers Market.

"You're not supposed to drink that!" I yelled at her.

"Then what are you supposed to do with it?" she shot back.

Good question.

I haven't decided whether I'll get a new hive this year.

The lecture is free and will take place at the Beacon Sloop Club, 2 Red Flynn Dr., in Beacon.



## 'From Haverstraw to Beacon' new exhibit highlights city's brickyards

The public is encouraged to attend the Beacon Historical Society's newest exhibit on at its headquarters, 61 Leonard Street. "From Haverstraw to Beacon: Inside the Brickyards that Built New York City" focuses on the rich history of the numerous brickyards that once lined the Hudson River. The exhibition, which is presented through a partnership with the Haverstraw Brick Museum, will remain on display through July 19 and will be open to the public free of charge (with plenty of parking) on Thursdays 10-noon and Saturdays 1-3 p.m.

"While many recognize names such as the Dennings Point or Brockway yards, in 1900 there were 38 brickyards lining the six-mile span between Chelsea and Dutchess Junction. Over the course of decades, the Budd, Aldridge, Van Buren, Hammond and all these other yards used the river's rich clay to produce millions of bricks," said Diane Lapis, the Society's Director of Special Projects.

For one example, brickmaking started at Denning's Point in 1881, but its heyday was in the late 1920s, when 145 men were

employed, and 300,000 bricks were produced daily. The 1925-1926 modernization of the Denning's plant introduced an electric train and shovel that made the yard one of the most productive along the Hudson River. In 1926, 60 million bricks were produced, and because of the ever-burgeoning demand of the New York City market for brick, the 1927 forecast was for 100 million bricks.

The exhibition was curated by Rachel Whitlow, Executive Director of the Haverstraw Brick Museum.

The all-volunteer Beacon Historical Society was founded in 1976 to collect and promote the history of Beacon. With approximately 400 members, it is one of the largest in the Hudson River Valley.
