

SCHOOL DISTRICTS TO HOLD ELECTIONS

BCSD voters to decide on budget, 3 propositions



Voters in the Beacon City School District will vote on the budget, candidates for the Board of Education and three propositions on May 21.

Beacon City School District voters will head to the polls regarding the 2024-25 budget on May 21. Polls are open from 6 a.m.-9 p.m. Voters who live within the City of Beacon boundaries vote at Beacon High School, 101 Matteawan Rd., in Beacon. Registered voters who live within the towns of Fishkill and Wappinger boundaries will vote at Glenham Elementary School, 20 Chase Dr., in Fishkill.


The proposed budget is \$83,855,000

and increase of 3.09% from the 2023-24 budget, said Beacon City School District Superintendent Dr. Matthew Landahl. There are no new hires in this budget and no layoffs either, he noted.

What can an average household expect to increase or decrease if the vote is passed?

"If the budget passes, a homeowner with a median valued home will pay an average of \$100 more per year," according to the





Find One's Polling Location

Check the address label affixed to the back page of the *Wappingers Budget Newsletter*, which is mailed to homes during the first week of May.

Enter your home address in the Voter Information Portal to find your location.

A voter must be: permanent resident of the district for at least 30 days immediately prior to the vote; 18 years of age or older; a U.S. citizen; and registered with the school district or the Dutchess/Putnam County Board of Elections (depending on county of residence).

"We are very pleased to present this budget to the taxpayers. Our community expects—and deserves—two things: a top-quality education and school system, and a school budget that is mindful of the burden on taxpayers. We are proud to offer both!" said WCSD Superintendent of Schools Dr. Dwight Bonk. "This student-centered budget allows ALL students to reach their highest academic, social, and emotional potential; it not only maintains services, but adds additional support in a variety of areas including school safety, student opportunities, career and technical education, academic intervention and enrichment programs, and the continued focus on the enhancement of the delivery of programs and services throughout our District in an effective and efficient manner."

Bonk explained, "It is my belief that this budget is fiscally responsible: through thoughtful and intentional planning, we have been able to continuously provide quality programs and services while staying below the tax cap. The 2024-2025 school district budget is \$305,851,033. This is a 3.26% levy-to-levy increase, which is 1.39% below the maximum allowable tax cap. This is the third year in a row that the District has been able to offer a budget below the tax cap by utilizing grants, savings from fund balance, and State Aid to offset the cost to the taxpayer."

After a careful review of programs and services, we are taking the initiative to spend \$7.9 M[illion] of our fund balance, to be responsive to the needs of the taxpayers while still maximizing services to students.

The 2024-2025 general fund budget includes the addition of approximately 9 positions, including a school counselor, teachers, school security officers, and an athletic trainer," said Bonk. It was also noted by the superintendent, "There are no personnel reductions in the 2024-2025 budget."

If the budget fails, the Board of Education has three options:

- Adopt a contingency budget
- Revote the same budget
- Revote a revised budget

The date for a budget revote is June 18.

What a contingency budget would do:

A contingency budget removes all expenses that are not ordinary and contingent (i.e., equipment), said Bonk. This equates to a \$13,915,427 reduction from the current proposed budget.

Board of Education candidates

There are four candidates seeking three vacancies on the WCSD Board of Education.

The candidates are:

- Virgil Capollari
- Christopher Costabile
- Michael McFarland
- John S. Morgan

Current board member James Spencer is not seeking re-election, according to the WCSD Clerk.

Bus proposition on the ballot

"The voters will also get to vote on a bus purchase proposition in the amount of \$2,668,863. The proposal would include a replacement of 8 large buses and the purchase of 15 vans. The District uses 5-year revolving bond anticipation notes (BAN) to finance the purchase of school vehicles," said Bonk.

Adding a bus purchase proposition annually to the ballot allows for consistency in budgeting for the related bus BAN principle payments in the General Fund – as only the change in proposition amount is adjusted in the General Fund budget, he said.

The bus proposition expense is aidable annually.

The 2024-2025 bus purchase proposition would result in a net cost of approximately \$74,365 starting in the 2025-2026 school year – which is approximately \$3,276 more than 2023-2024 for Bus BAN payments.

years to be aligned with the transportation state aid we receive."

The proposition states the following: "Shall the bond resolution authorizing the purchase of school buses at a maximum cost of \$485,000; authorizing the issuance of up to \$485,000 bonds (5 year maximum maturity) and, with respect to such bonds, providing for a tax levy therefor in annual installments; pledging the District's faith and credit for debt service; delegating powers with respect to bonds and notes; and providing for an estoppel procedure?"

Voters will also decide on a \$49,950,000 Capital Project.

The following is what the proposition states: "Shall the bond resolution authorizing a School District Improvement Program at a maximum cost of \$49,950,000; authorizing the use of \$500,000 capital reserve funds, the issuance of up to \$49,450,000 bonds (30 year maximum maturity) and, with respect to such bonds, providing for a tax levy therefor in annual installments; pledging the District's faith and credit for debt service; delegating powers with respect to bonds and notes; and providing for an estoppel procedure, be approved?"

Choose 3 of 4 candidates

Voters will choose three members to the Board of Education. Two of the terms commence July 1 and expire June 30, 2027. One term will begin right away, to finish the term of former board member John Galloway Jr.

The candidates are: LaVonne McNair, Flora Stadler, Megan Phillips and Christopher Lewine. Stadler is currently on the board. Stadler is the vice president of the BOE. Yunice Heath, a current board member, is not seeking re-election.

Jacobson: Central Hudson rate recommendation increase to PSC 'unaffordable insult'

Assemblymember Jonathan Jacobson (D-104) blasted the Central Hudson rate increase recommended to the Public Service Commission (PSC) of 16.7% for electric and 21.8% for gas as "an unaffordable insult to every Central Hudson customer."

Central Hudson and the PSC have been in litigation since January over the embattled utility's petition to increase electric delivery revenue by 27.5% and gas delivery revenue by 33.2%. Two Administrative Law Judges who were assigned to the case made the recommendation to the PSC.

"While this is much less than Central Hudson's original request, the amount is way too high," Jacobson said. "The original request was merely a bargaining chip and was never a serious proposal, so this recommendation is not a win for consumers."

Central Hudson had announced the new rate plan proposal just days after it entered into an agreement with the state to end estimated billing and hire an independent monitor. The current rate expires in June.

"Central Hudson's request for a rate increase is an insult to its customers, considering the service they've received," said Jacobson, adding, "The recommended increase is well beyond the current inflation rate of about 3.2%. And to make matters worse, this increase is for a year only. We all

know that Central Hudson will be asking for more next year."

Jacobson was among the first legislators to confront the utility company for faulty billing practices that left customers overwhelmed with bills that were often hundreds or even tens of thousands of dollars more than expected.

The PSC is expected to decide on the rate increase later this summer. In the meantime, no public hearings on the issue have been announced yet.

"I'm calling for a new round of public hearings both in person and online before the final decision is made," Jacobson said. "As I said when I testified last October against this increase: 'Because of the recent billing fiasco, customers have learned not to trust Central Hudson's numbers, and neither should the PSC.'"

Governor Hochul recently signed the Assemblymember's bill (A.4055/S.4234) to end chronic late billing by Central Hudson and other utility companies. Utilities will no longer be able to backbill if a bill is more than three months late. The new law will also require utilities to provide 13 months of prior usage data for the customer's address with each bill, to help customers determine if they are being overcharged.

Assemblyman Anil Beephan opposes proposed OSHA regulations, says threat to volunteer firefighters

Assemblyman Anil Beephan Jr. submitted formal public comment on April 23rd opposing the proposed OSHA-2007-0073-0788 regulations, highlighting the potential detrimental effects they could have on volunteer firefighters in emergency services across the State of New York.

The Association of Fire Districts in conjunction with the Firefighters Association for New York (FASNY), has approached Beephan, he stated, expressing grave concerns about the adverse consequences that the proposed regulations may impose on volunteer firefighters who are already operating under strain.

If enacted, these additional obligations, ranging from heightened administrative costs to intensified training requirements, equipment inspections, and facility renovations, would place an unwarranted strain on already stretched resources, many of which need to grapple with resource deficiencies,

according to the assemblyman.

Drawing from his firsthand experience as a former volunteer firefighter, Beephan and his team have submitted a formal letter of opposition to OSHA, urging the agency to collaborate closely with local organizations to strike a balance between safety and the practicality of implementing new regulations.

Beephan emphasized, "Having served as a volunteer firefighter myself, I understand the challenges and sacrifices that these brave men and women make to keep our communities safe. It is imperative that any regulatory changes take into account the unique circumstances faced by volunteer firefighters and work in partnership with local organizations to develop solutions that prioritize both safety and operational feasibility."

A formal letter of opposition was submitted by Beephan's office, along with a letter addressed to members of the New York delegation of Congress.

Seven receive cars as part of 'Way to Work' program

Kiyon works each day to balance work and family. Due to his lack of reliable transportation, though, he often misses opportunities for advancement at his workplace. Just as importantly, having insufficient personal transportation has also limited his quality time with family.

Kiyon needed a hand up to improve his career progress at his job and spend more time with his children. He, and six other Dutchess County residents, got that hand up on April 23rd.

Kiyon was one of seven recipients who completed the "Way to Work" employment empowerment program – a partnership between Dutchess County's Department of Community & Family Services (DCFS) and the Dutchess County Workforce Investment Board (DCWIB) that assists residents receiving, or eligible to receive, public assistance address their transportation challenges. The program participants earned a gently used vehicle to help them obtain and retain employment; acquire jobs with more hours or higher pay; gain access to higher education; increase their wage potential or take their children to and from school. In addition to Kiyon, today's recipients included several single mothers, as well as a local young woman about to age out of the foster care system.

Dutchess County Executive Sue Serino, who presented each recipient with the keys to their vehicle, said, "For parents to be successful and raise healthy families, reliable transportation is key – whether it's to get to and from work, to take their children to medical appointments or to other school or family commitments. Each of today's seven recipients have earned the vehicle they'll drive away in. They have each invested time and effort to the commitment of making a better life for their families and themselves. Dutchess County is proud to give these families an opportunity to flourish."

Established in 2001, the program, formerly known as "Wheels to Work," is designed to help low-income Dutchess County residents get and keep a job, providing them reliable transportation to and from work. Qualified participants must come from a family that receives TANF or whose family income is less than 200 percent of the poverty level.

"Way to Work" is dedicated to empowering program participants with transportation solutions. Program recipients are chosen based on their work-related need for transportation, have a temporary need of assistance and other specific program guidelines. In addition, they must display the perseverance and the commitment necessary to take steps towards financial independence. The program offers various components, including connections to public transit options, financial literacy and car care literacy seminars, a financial bootcamp workshop, a credit score workshop, vehicle registration services and vehicle insurance services.

DCFS's approach to help transition residents to work and off TANF is a multi-faceted one that includes work skills training, daycare subsidies for eligible families, and the "Way to Work" program provided under contract by the DCWIB. "Way to Work" provides vehicles from local used car dealers to eligible individuals and provides participants training – such as car care and defensive driving – as well as assistance in obtaining a learner's permit or driver's license.

The recipients who earned vehicles today were chosen based on specific program guidelines, including their work-related need for transportation. In addition, they have all displayed the perseverance and commitment necessary to continually move forward toward financial independence. For every family that earns a car and no longer needs temporary assistance, Dutchess County

saves \$1,614 a month. Within a year, that savings equals the cost of a used car. Since the program's inception, 90 percent of vehicle recipients have remained independent from temporary assistance.

DCFS Commissioner Sabrina Jaar Marzouka said, "Dutchess County residents who are looking for a better life – and who commit to making it a reality – have found success through 'Way to Work' for more than 20 years. Our department is so proud of the program and the families it has empowered, as they're examples of the lives DFCS enhances each day."

The program has benefited more than 3,500 families since 2001, providing 927 cars, along with registration and car insurance deposits. Additionally, 318 County residents have gained their New York State learner's permit; 1,082 people participated in driving experience classes; 523 individuals completed the five-hour, pre-licensing class;

497 passed their state road test and earned a driver's license; and 776 vehicle repairs were approved on behalf of program participants.

DCWIB Executive Director Louise McLoughlin said, "Building on more than two decades of success, 'Way to Work' continues to connect participants willing to commit to the program and take the steps necessary to become successful. The Workforce Investment Board is proud of our partnership with Dutchess County, providing reliable transportation to residents seeking self-sufficiency, and we're eager to see the program continue to make a real impact on so many lives."

Roster moves at the Class A level of minor league baseball are not uncommon. But one month into the season, the Hudson Valley Renegades have already made nearly a dozen roster changes.

Just this past week, in fact, the Renegades swapped right-handed pitchers. Leonardo Pestana was transferred to Double-A Somerset and Steven Fulgencio was promoted from the Single-A Tampa Tarpons.

"It's the nature of the game," Fulgencio said.

He then paused and laughed a little.

"You just hope it's good news when that phone rings."

Renegades win two, lose two; no movement in standings

WILMINGTON, DE – Two teams battling for the South Atlantic League North Division first-half title ... got nowhere.

Heading into a Sunday doubleheader necessitated by a rain-out on Saturday, the Hudson Valley Renegades and Wilmington Blue Rocks were still tied for first place thanks to splitting the first four games of their series.

Meaning there was no movement in the standings.

The 'Gades won the first two games.

Wilmington is an affiliate of the Philadelphia Phillies and the Renegades, of course, are the High Class A farm team of the New York Yankees.

The opener was a 12-2 romp for the Renegades at Frawley Stadium. In an historic offensive performance in the seventh, the Renegades tallied nine runs on 10 hits to turn the game into a blowout. It was just the third time since 2005 that Hudson Valley had collected 10 hits in an inning, with the last occurrence coming on Sept. 5, 2021 at Greensboro. Jace Avina led the way for the Renegades, finishing 3-for-6 with a run scored, two doubles, a home run and two RBIs. His solo homer to center in the third off Bryan Caceres was his second of the season and proved to be the winning run in the blowout.

After Wilmington cut the deficit to 3-2

with a rally in the bottom of the fifth, the Hudson Valley offense broke out with its seventh-inning extravaganza. The Renegades sent 13 batters to the plate,

collecting 10 hits including seven extra-base hits, setting a new franchise record for most extra-base hits in an inning.

One night later it was still a slugfest, as

Hudson Valley posted a 13-10 victory.

Jared Serna starred at the plate, finishing 3-for-7 with three home runs, six RBIs and three runs scored.

Serna put the Renegades on the board in the top of the third with his first home run of the night. He sliced an opposite-field two-run home run down the right field line to give Hudson Valley a 2-0 lead. The blast came off Blue Rocks starter Luke Young, who had not allowed a run across his previous 14 innings pitched.

Wilmington answered with two runs in the bottom of the third against Jackson Fristoe, and took a 4-2 lead in the bottom of the fifth when T.J. White connected for a two-run home run off Trent Sellers and it was clear that both teams had their hitting shoes on.

The Renegades tied the game in the top of the sixth when Jesus Rodriguez and Omar Martinez clobbered back-to-back home runs to start the inning against Brendan Collins. It was the first time this season that the 'Gades hit back-to back homers. They regained the lead on Serna's second two-run homer of the night in the top of the seventh.

Tied at 10-10 in the 11th inning, the Renegades struck for three runs. That included two runs that scored on bases loaded walks.

Customer experience is key goal

Editor's note: The Hudson Valley Renegades have a new general manager in Zach Betkowski. He sits down with reporter Rich Thomaselli every week to express his thoughts on the Renegades and on minor league baseball in general.

Did you see any issues from the first homestand that need to be addressed?

You know, I think for us, we're perfectionists. I think it's the mantra that we have across the staff is that we're obsessed with the customer experience.

So, while to the naked eye, maybe there's some things on the surface that fans didn't notice as much. We certainly did. So, we actually have in our office right now posted, it's called an improvements list; and there's probably, I don't know, 20 or so items that are, you know, mostly minor in stature, but our motivation is to make sure that those things are improved when we come back on May 14th.

Please talk about the numerous roster changes and let fans know that this

is the Yankees and not you making those calls.

Yeah, it's funny. It's one of the most common misconceptions about my job. I think a lot of fans will get angry when a player is called up or released or traded, and they think I have any sort of hand in that. I can't emphasize enough I have so little to do with that side of the business. Quite honestly, the only interaction I really have with it is just getting a courtesy copy email from the Yankees minor league development

staff, just letting us know what the transactions actually are, so that we can communicate it outwardly. I have literally zero say in those.

The team is again flirting with first place in the division. How much does that help?

It certainly doesn't hurt, but we're here for the entertainment. At the end of the day, we want people to leave not thinking about the final score, but thinking about how good a time they had.

Wappingers Falls board adopts budget

The Village of Wappingers Falls adopted its budget for the next fiscal year.

"In so far as the adopted budget, I abstained from the vote for the following reasons: I worked tirelessly with the Treasurer for the past 2 months trying to account for all expenditures and scrutinize revenues," said Village of Wappingers Falls Mayor Kevin Huber in an email to Southern Dutchess News. "Along with that, [myself and the treasurer] met with every department head and committee during the month of March to account for any considerations as well as contractual obligations."

It was explained by Huber, "The tentative budget brought in a very high tax increase, which we knew would not be well received in the community as taxpayers just can't afford anymore. Each time we presented a new budget for workshop, our tax increase was still not complimentary to the community we serve." The budget was adopted on April 29th.

Village of Wappingers Falls treasurer Lori Jiava released a memo for village residents regarding the 2025 Budget during the budget process last month.

Jiava, who is a former president of the Wappingers Central School District Board of Education and a former supervisor the Town of Wappinger, stated "...it's critical to confront the significant financial challenges and obligations confronting the Village. This memo highlights essential considerations that must be addressed as part of the budgeting process." Jiava noted late last month that better accountability has been put in place for department heads and she gives monthly reports to the Village officials, which was not occurring previously, she said.

"Finally, the treasurer and I reconvened for 5 hours after the last workshop on the 17th (of April) and took into consideration over an hour and a half worth of comments from the public," the mayor said.

Jiava explained last month, "Over the past seven years, previous administrations borrowed funds and applied for grants which in many instances required matches by the Village for several projects, including the boathouse, Clinton Dam, Franny Reese Park, and the water quality project, which have imposed a significant debt service, complicating financial planning going forward." She also claimed, "Moreover, and most critically, matches required by the Village were not budgeted for and in some cases, the borrowed funds were not fully spent for their intended purpose and were diverted to cover everyday obligations, which exacerbated the debt burden by creating significant budget shortfalls since 2021. This masked the fact that past budgets were not accurate and unsustainable."

According to Jiava, "The 2023-2024 budget was forecasted as best as it could have been based on the tangible information presented but was derailed by significant expense over-

runs in a couple departments and complete disregard for outstanding bills from past budgets. In addition, unforeseen costs, including a \$165,000 shortfall in an infrastructure project at Dutchess Plaza, have further burdened the Village's finances." There was also the gas explosion in November 2023 that added to the Village costs for overtime and assistance from area departments.

Huber remarked, "The public demanded that each trustee take into consideration the taxpayers and be mindful of our taxes. They demanded us to think outside the box and to make serious cuts were necessary." He added, "The last budget that was presented was at 3.45%. It addressed our contractual obligations, took into consideration decreased revenues and ensured that our obligations would be met."

Jiava called for "fiscal prudence" to be embraced and "put an end to maintain[ing] the status quo." She recently said, "[the budget] gets us through. I set out a plan and disclosure with the Board."

The mayor noted: "Some of the cuts were challenging and hard to make. Our board made the necessary cuts but increased the tax rate to create a contingency line so that if we have an infrastructure failure or an issue, we could fund it appropriately. And while I agree with the compromise of the necessary cuts to staff and spending, I still stand behind the fact that we have senior citizens and residents on fixed incomes."

"Engaging in these conversations with openness and a forward-looking perspective is essential for navigating our current financial landscape," the treasurer said.

Village residents were able to address their concerns regarding the proposed budget with Jiava on April 16, 22 and 23. Less than a dozen residents came to all three meetings, she stated.

Trustee John Tyliszczak told Southern Dutchess News via email, "We passed an austere budget that included a sizable tax increase. Nobody likes having to do this, but it was necessary to address our current situation. Hard decisions had to be made and more may come." Other board members did not respond to a request for comment.

Board members Walter Masch, Joseph Nicholas, Michael Ruffen, Tyliszczak, and Jeff Smith voted to adopt the budget. Board member Robert Marshall voted 'Nay.'

"In all the years I have been on the Village Board," commented Huber, "I can say that that this budget process was eye-opening. I gained a different perspective than I ever have before. I truly was honored to be a part of the budget we put forth at 3.45%. It was long and exhausting, but I was able to offer shared decision making with the community at workshops and I was able to see firsthand some of the expenses and obligations are Village has."

"It is a true honor to serve this community," said Huber.

Vicki takes a piquant trip down Memory Lane with this classic Italian dish.

Among the things I've accumulated over the years are, perhaps not surprisingly, recipes. I have 2 vintage recipe boxes which were originally intended for all my go-tos but were so quickly filled that I also have binders overflowing with them, in addition to tons of cookbooks, plus all the recipes from the articles I've written. That's a lot to go through but, while somewhat daunting, it's a task that's long overdue, brings back fond memories and is great inspiration for new articles.

It's been fun rediscovering old recipes and I've already dusted some off recently to share with you, something you should expect a lot more of. Whenever I scroll through my article archives to see what

I've done so as not to repeat, I sometimes get discouraged, feeling as though there's nothing I haven't written about, but now I realize how ridiculous that is. Not only do I still have a hunger to keep playing with food and developing new recipes, but I also have a treasure trove of memory-inducing old ones to share, so with your kind indulgence, that's just what I'll continue to do.

Because food has always been a big part of my life's journey, every recipe has a story to tell, and being reunited with them is like visiting an old friend. Many of the ones I come across take me back to a particular place and time, much the way hearing a song from my teenage years does, and it feeds my soul every time it happens. That means there are plenty of stories yet to tell. I should have done this years ago!

Which brings us to today's share, Chicken Piccata. I lived in Florida in the very early '80s and had my first food service job in an Italian restaurant. Lacking experience, I was first placed in the take-out section, which was separate from the main restaurant, had its own entrance and was connected by the kitchen. Hungry to learn everything I could, I observed, asked a lot of questions and did my best to try every aspect of the business I could. I learned how to run the

dishwasher, make salad dressings from scratch, plate desserts and mix cocktails. The hard work paid off because I eventually became a waitress and a bartender in addition to working take-out, all of which I loved. Between the lunch and dinner shifts when there was a lull, I'd watch the chefs make dishes, and they were all very gracious when I asked about the recipes and methods used.

One of the first dishes I made from the restaurant was Chicken Piccata. As wait staff we were always well fed, the chefs making us lunch or dinner, and this was one of my favorites. I can picture walking through the grocery store with my Walkman on, shopping for the ingredients from the carefully written recipe. I also distinctly remember prepping them in the kitchen of the condo my roommate and I shared while she was at work to surprise her when she got home with what I hoped would be a lovely meal. I felt very grownup and independent and knew I'd found a niche I would never fall out of love with.

CHICKEN PICCATA

As it turns out, I chose a great recipe as my first to try. I had cooked when I still lived at home, but this was a different level. Lucky for me it came together quickly – just about 30 minutes – and went off without a hitch. Pan-fried thin chicken cutlets are served in a buttery sauce with the bright tartness of lemon and a briny pop of capers that's somehow both rich and light. Serve it with rice or pasta and a side of steamed vegetables or a salad. My favorite? Caesar salad, also a recipe from the restaurant.

INGREDIENTS

4-6 thin-sliced chicken cutlets (or you can cut chicken breast in half lengthwise and pound them to 1/4-inch thickness)
Flour for dredging (about 3/4 cup)
Salt and pepper (about 1/2 teaspoon of each)

1/4 cup freshly grated Parmesan
1/4 cup olive oil
6 tablespoons butter, divided
1/2 cup chicken stock
1/2 cup dry white wine (you can omit and double the stock)
2 tablespoons fresh lemon juice
1/4 cup capers, drained
Fresh chopped parsley

METHOD

Heat olive oil and 3 tablespoons butter in a large skillet over medium-high heat.

In a shallow bowl, whisk together flour, salt, pepper and Parmesan. Dredge chicken cutlets through the flour mixture to coat evenly on both sides. Add chicken to the skillet. You may need to do this in 2 batches since you don't want to overcrowd the skillet. Cook until brown on both sides, about 4 minutes per side. Transfer cooked cutlets to a plate.

Add chicken stock and white wine, stirring with a wooden spoon to scrape up all the tasty, browned bits. Reduce heat and simmer 4-5 minutes. Whisk in lemon juice, capers and remaining 3 tablespoons of butter. Simmer for 1 minute.

Plate chicken, pour sauce over the top and sprinkle with chopped parsley. Serve immediately.

And just like that, I'm 21 again, just starting my cooking adventure and eager to share the results. It's a comfort to know some things will never change. Enjoy!

Can a cockroach love you?

Local students create some impressive projects for their BOCES agriculture class.

Bryanna Coakley loves Madagascar hissing cockroaches, but can they love her back? That was the issue Bryanna was researching with her senior project for the BOCES agriculture class.

Rebecca Cossa is the agriculture teacher and FFA adviser at the Dutchess BOCES (Board of Cooperative Educational Services) Career and Technical Institute. FFA is the premier youth organization preparing members for leadership and careers in the science, business, and technology of agriculture. Each of the seven seniors in Rebecca's class created and ran a year-long research project based on an issue in the agriculture industry:

- Lucy Mann - "The Effects of Isolation on Rats." While working at a dog boarding facility, Lucy noticed that after a few days, the dogs lost their appetite and became loud and aggressive. She decided to test two groups of rats, one with the rats in individual cages, and the other group in a communal environment that she called "home." By weighing the rats after 8 weeks, Lucy concluded that the "home" environment was healthier. The dog boarding industry is catching on, because nowadays you can board your dog in a "dog spa" or even a dog resort, with swimming pools, aroma therapy, and a visiting canine psychologist.

- Ashley Keek - "The Effects of Various Salts on Grass." - Ashley noticed the detrimental effect of road salt on adjacent vegetation. She experimented with different salts – sodium chloride, calcium chloride, and magnesium chloride – dosing the grass that she grew in trays. Ashley found out that magnesium chloride actu-


ally has a beneficial effect on surrounding vegetation. Next question – can highway departments afford it?

- Maleah Bishop - "The Effects of Radio frequency Radiation on Brown Mustard Plants." We've all heard the stories about radiation from cell phone towers, microwave ovens (that's why they have that screen over the front glass) and glow-in-the-dark toys causing health issues. Maleah grew some mustard plants next to a Wi-Fi hotspot, and some others at various distances away. Results were "inconclusive," showing no detectable differences. Good news for screen-addicted teenagers.

- Jaden Hanks - "Rats Reaction to Repeated Exposure to a Deterrent Scent." By exposing rats to cotton balls soaked with peppermint oil, Jaden saw that they avoided the cotton balls, but their behavior – eating, sleeping, exploring – was otherwise unaffected. So the scent could be used as a harmless deterrent.

- Arianna Ranello - "The Effects of Different Fan Speeds on Lettuce Plants." Since fans are used in greenhouses to reduce humidity, Arianna wanted to determine the optimal wind speed and distance from the plants. She found out that the highest speed and closest distance, a few inches from the fan, damaged the plants. A 4-foot distance and low speed seemed ideal.

- Maya Marrs - "The Effects of Horse Skin Color on Fly Landings." During her work with horses, Maya observed that some horses were bothered by flies more than others. Could it have to do with their skin color? She used suede patches to show that flies preferred the color pink

over brown, explaining why her pink pony is especially besieged by horseflies.

- Bryanna Coakley - "The Effects of Human Affection on Cockroach Racing Speed." Bryanna interacted with one group of cockroaches and ignored the other group, then raced them, hoping to show that the one she showed affection to would win. (How do the cockroaches know she wanted them to win?) Alas, there was no detectable difference. She did notice that the loved ones became more docile.

All of Rebecca's students are planning

to continue their education, some at Dutchess Community College, or at the state university at Cobleskill. Jaden will attend Morgan State University in Baltimore, majoring in Biology. Ashley wants to pursue a career as a conservation enforcement officer. For Lucy – anthropology. Lots of options for these talented, enthusiastic scholars.

Corn and Roasted Pepper Frittata

Ingredients

3 teaspoons olive oil

2 tablespoons finely chopped onion
1 cup fresh corn kernels
1 roasted red pepper, cut into strips
4 eggs, lightly beaten
Salt and pepper
4 ounces Mozzarella cheese, shredded

Method

Heat the oil and in a 10-inch skillet over medium heat. Add the onions and corn. Sauté for 2-3 minutes. Add the red pepper strips; cook for 1 minute.

Add the eggs, salt and pepper and Mozzarella. Cook over medium heat, stirring in order to blend all the ingredients, for 3-4 minutes until the edges start to dry. Place under the preheated broiler and cook for 2-3 minutes until lightly golden. Serve warm or at room temperature.

Luigi Coppola is one of five brothers born to Francesca and Antonio Coppola. The Coppola family came to America from Naples, Italy in 1954. Antonio and his brothers opened their first restaurant in Poughkeepsie in 1961. Advice on Spongy Moth: 'Let nature run its course'

The Town of Clinton Conservation Advisory Council (CAC) notes that Spongy Moth caterpillars recently emerged. The larvae of Spongy Moths (formerly known as the Gypsy Moth) are notorious for defoliating trees as they feed.

The Clinton CAC stated, "In 2023, the Town of Clinton and areas in adjacent towns experienced a severe outbreak of Spongy Moth caterpillars that defoliated (ate all the leaves on the trees) in early spring. In June, the trees looked as bare as winter, and if you took a walk in the woods the sound of caterpillars pooping sounded like rain."

What should homeowners do to prevent a repeat this year? Based on scientific research, the Clinton CAC says, "The short answer: while it may be hard to watch, the scientists suggest the best option is to let nature run its course. A naturally occurring virus is likely to knock back the population this year, so most homeowners don't need to spend the money on treatments that are generally not very effective and can have negative effects on other insects and our water supply."

The CAC added, "We are lucky to have the Cary Institute for Ecosystem Studies (IES) as our neighbor in the Town of Washington. Scientists from IES have been studying the Spongy Moth (formerly

known as the Gypsy Moth), for decades."

In January, IES hosted a virtual webinar to discuss what's in store this year with the infestation and what to do about it in your yard.

"Because the infestation is so large and the caterpillars drift through the air on web-like silky strings, the treatments that typically come to mind are not effective," according to the CAC. "Scraping the egg sacks off your trees, using sticky tape or burlap bands around the tree, and spraying trees with pesticides will not help in most situations. More caterpillars will just swoop in and start munching away."

Cary Institute scientist Clive Jones discusses some exceptions to this in his talk, but says the best (and most cost-effective) approach is to let nature run its course. A naturally occurring virus and fungus will likely kill the caterpillars and should bring the population back into balance either this year or next at the latest.

Jones explains, "So the best guess for Cary is that in 2024 we will have an NPV [virus]-induced collapse, plus or minus the fungus depending on the weather. Whether or not there'll be a lot or a little defoliation will really depend on how fast the virus moves through the population. If it moves slowly, there'll be complete defoliation. If it goes through fast, there'll be incomplete defoliation. And if that

doesn't happen, and the density continues to rise or stays at the level it is, then a viral collapse in 2025 has a much higher probability, because by then food limitation

and stress will be kicking in."






