## WCSD, law enforcement announce increase in school safety collaboration

Town of Wappinger Supervisor Richard Thurston, Wappingers Central School District Superintendent of Schools Dr. Dwight Bonk and Dutchess County Sheriff Kirk Imperati offered a school safety announcement on May 12 at Wappinger Town Hall. The leaders announced an agreement between the Dutchess County Sheriff's Office and the Town of Wappinger would increase Sheriff's and Town Patrols at all elementary schools in the Town. It was announced patrols will be at Evans and Myers Corners elementary schools.

"We are here today (May 12) about our children. Our children mean the world to us," Thurston said during the opening remarks.

"Today, we all stand here united for the safety of our community and the safety of our children," remarked WCSD Superintendent of School Dr. Dwight Bonk. He added, "I can stand here before you today and communicate that the safety of our students and staff is our top priority."

"The primary responsibility of all levels of government is to provide for the health and welfare of its citizens," said William "Bill" Beale, who is the deputy

supervisor for the Town of Wappinger. Beale said the Town benefits from the Sheriff's Office's security checks and responses to emergencies "all across the Town day and night."

Beale, who is the director for emergency management for Dutchess County, added thanks to the New York State Police, whose Wappinger barracks is co-located on the Town of Wappinger campus on Middlebush Rd., who provide "security to visitors and residents of the Town each day."

In recent months, he said, there have

**Renegades snap losing streak with key wins over Aberdeen**

Traditionally, the Hudson Valley Renegades have not had great success against Aberdeen, dating back to the two teams competing against each other more than 20 years in the rookie ball New York-Penn League.

Maybe Friday night's late burst of magic will help to change that mode.

The Renegades outlasted the Aberdeen IronBirds 9-7 on Friday night at Leidos Field at Ripken Stadium. The win snapped Hudson Valley's four-game losing streak.

They also defeated the IronBirds on Saturday and Sunday to improve to 21-12 on the season.

The Renegades scored all nine of their runs after the sixth inning.

Hudson Valley's Juan Carela began his outing retiring the first nine batters before running into trouble in the fourth. Max Wagner reached base with a walk, and Frederick Bencosme singled to place runners at first and second. Wagner stole third and scored on a Carela balk, and Silas Ardoine singled home Bencosme later in the frame to extend the lead to 2-0.

With one out in the bottom of the fifth, Luis Valdez pushed a bunt down the third base line and reached second when Carela's throw went wild down the right field line. Bailey Dees replaced Carela after that and uncorked a wild pitch in the frame that allowed Valdez to score, padding the IronBirds advantage to 3-0.

After only recording one hit in the first five innings against IronBirds starter Alex Pham, the Renegades offense came to life in the sixth. Spencer Jones crushed a one-out double to left-center and scored on a Spencer Henson single.

That opened the floodgates.

The Renegades took the lead with a four spot against Kyle Virbitsky in the top of the seventh. The inning started with a walk to Aaron Palensky and a single by Grant Richardson. A fielder's choice placed Ben Cowles at first and Palensky at third base for Luis Santos, who delivered a two-out single to score Palensky to cut the Aberdeen lead to 3-2. Jones belted a three-run home run over the left field wall to complete the four-run inning, his sixth blast of the season. After missing three games, Jones returned

Do you know a dog who has a good "nose" at finding things? Then Top Notch Dog Training, in Wappingers Falls, has the answer – the nose work programs.


"We are constantly adding new classes to our schedule," said Patricia "Pat" Tetrault, co-owner of Top Notch Dog Training.



been reminders each week "the evil that exists in our country." The recent shooting that killed three educators and three nine-year-old students at a school in Nashville was mentioned by Beale.

"Thoughts and prayers continue but thoughts and prayers are simply not enough," said Beale, who continued that he and Thurston have discussed for weeks security and preparation.

Beale said the agreement that was announced has the backing of the entire Wappinger Town Board.

"The Town will remain fully committed to this program," he said.

The announcement allows "for consistency among the WCSD's 11 elementary schools throughout the seven municipalities we serve. As you may be aware our Secondary Schools are assigned a School Resource Officer through either the Dutchess County Sheriff's Office or local law enforcement agency. The District, our Town(s), County Government, and our local law enforcement agencies will continue to collaborate on this need as well as continue to work with our Mental Health Professionals. It is important to note that we have seen first-hand how these individuals have been very proactive in

developing positive relationships with students, staff, and families, as well as utilizing their skilled training to respond to a student in crisis," said Bonk.

Bonk noted that May is National Mental Health Month. He said the WCSD has hired 12 mental health professionals in the past years.

"We at the Sheriff's Office have always had a presence in the schools and commit to help keep the children safe," Imperati stated during his remarks.

Town of Fishkill Supervisor Ozzy Albra, who was in attendance, said the Town of Fishkill earlier this year committed the same to Brinckerhoff Elementary School and the Village of Fishkill with Fishkill Elementary School.

"May we be reminded that our children are a gift from God. We want them to have a long life," said Thurston.

Imperati stated, "We are dedicated to the safety and security of our students, schools and families."

Bonk noted that WCSD spends \$1.8 million dollars annually on School Safety and Mental Health Services and he continues to implore Federal Representatives to recognize the need to provide additional targeted funding for both School Safety and increased Mental Health Services for the schools.

Sheriff Kirk Imperati announced that the annual Dutchess County Sheriff's Office memorial service will be held at the Law Enforcement Center on Parker Ave in Poughkeepsie on May 25, at 10 a.m. Because of the logistics involved with the ceremony, on May 25 the Sheriff's Office lobby will be closed to the public until noon.

Members of both the Law Enforcement

and Corrections Divisions will be in full dress uniform for the ceremony, and local dignitaries will be recognized as well. During the ceremony fallen law enforcement officers who have made the ultimate sacrifice, former Sheriff's Office members who have passed away, and the brave men and women who keep our nation safe will all be honored.



### **O'Neil writes Schumer about Title 42 expiration concerns**

The following is a letter County Executive William F.X. O'Neil wrote to Senator Charles Schumer on May 10.

**To Senator Schumer:**

With New York City Mayor Eric Adams' announcement that he plans to shelter asylum seekers in Hudson Valley counties, it is with grave concern that Dutchess County requests your advocacy in communicating our dismay with President Biden and demand the Biden Administration conceive a comprehensive immigration policy to address how to stem the flow of the thousands of people who are, on a daily basis, crossing the nation's southern border with no plans for food, shelter, or security. With the expiration of Title 42 tomorrow, this situation will exponentially worsen without a comprehensive federal strategy. When the New York City Mayor, the leader of a declared "sanctuary city", is shipping hundreds of people OUT of his city, without adequately communicating with neighboring communities, it is clear there is no strategy.

The news of Mayor Adams' unilateral decision has been met with both concern and outrage throughout the Hudson Valley region, as local communities received little or no notice of these plans and there has been no coordination or information about the specifics of these individuals including duration of their stay, healthcare, security, employment, and a myriad of other issues. Here in Dutchess County, following the nationwide coverage of Mayor

Adams' plan, we have been inundated with questions and concerns from our residents, and yet we have received no information to answer their questions or address concerns.

There is good cause for concern, and those concerns are shared by our local elected officials. Dutchess County, and its local villages, towns, and cities, is already facing housing issues for our existing residents, with the lack of affordable housing reaching crisis levels in many communities. There is no capacity for an influx of hundreds of additional people seeking emergency/transitional housing. Additionally, Dutchess' health and social services systems remain strained, particularly in the wake of the COVID-19 pandemic. The expectation of counties providing wrap-around support services to hundreds of additional people without resources or funding is ludicrous.

Simply housing people en masse in local hotels is not a solution – it creates far more problems than it solves, overburdening local communities that do not have the necessary infrastructure or resources to meet people's needs. Without connections or support in the community, these transplanted individuals are at great risk for exploitation, trafficking, or criminal involvement. This is not a humane or logical solution.

This crisis must be addressed, and it must be addressed at the federal level. Once again, the Biden Administration's lack of planning has put communities throughout New York State in this perilous position. As such, we call on our federal delegation to demand President Biden finally take action and enact an immigration action that ends the chaos currently being felt throughout our state and our nation.

As Title 42 expires, we call on the Biden Administration to:

- Close the southern border until a logical, comprehensive plan is in place to address the hundreds of thousands of asylum seekers who are already here, in limbo, in the United States;
- Expedite the asylum review process, including the establishment of courts. Individuals should not have to languish for months, often years, without a clear pathway forward; and communities should not be put in the quandary of having to provide them services while they wait
- Facilitate a coordinated decompression strategy for the cities currently sheltering thousands of migrants;
- Federal financial resources should be made available, upfront, to communities across the nation who can willingly welcome, accommodate and support these asylum seekers.

The President's inaction is crippling our communities and endangering the residents you represent. In everyone's best interest, Dutchess County urges you to bring your constituents' concerns to the President and demand the aforementioned actions.

### **Rolison, Weber send letter to Hochul asking about plan for migrants**

*The following letter was sent to Gov. Kathy Hochul from New York State Senators Rob Rolison and Bill Weber on May 13.*

**To Gov. Hochul:**

Your Friday, May 12 request to federal officials for additional resources to manage the ongoing humanitarian emergency in the Hudson Valley was a welcome sign that federal, state, and local officials may still be able to resolve this crisis before it gets worse.

We represent thousands of individuals, families and businesses in Rockland and Orange counties directly in the path of the migrant arrivals. Currently there are dozens of migrants, mostly men, occupying hotel stock in Orange, with an indeterminate number scheduled to be bused in from New York City to seek housing and other services in the coming days and weeks. With the Centers for Disease Control's Title 42 directive [which ended] on Thursday, May 11, U.S. customs officials expect a tsunami of asylum seekers and migrants along the southern border at places other than established ports of entry. In our view, a lack of effective federal planning and communication together with New York City's dramatically short-sighted relocation policy have pushed local governments to the edge.

The U.S. immigration system is broken. If we ever hope to salvage from its ashes a viable alternative that supports a common-sense policy while protecting the rights of Americans who already live here, we need a more transparent system, full stop. To have New York City, state, and federal officials talking past each other is unacceptable and raises the odds of a humanitarian disaster involving hundreds, perhaps thousands, of human beings seeking opportunity and a better life. As of this writing, neither of our offices has received a briefing from your staff nor any state office associated with refugee resettlement or immigration. This lack of transparency erodes our constituents' trust in their state government and its ability to safeguard local communities in a fast-moving emergency.

If New York City has indeed, as you write, "exceeded capacity in its shelter system," why wasn't additional aid made available to Upstate governments earlier to manage the migrant overflow? What is the short-and long-term plan to shelter the approximately 20 homeless U.S. veterans who were displaced from their housing to accommodate the migrants? When will our counties be provided with an actionable timeline of services and resources flowing to the affected Upstate communities?

Lastly, what assurances do Rockland and Orange counties have from your administration and the NYS Mayor's Office that their local governments will not be forced to subsidize police services and other relocation costs after potentially hundreds of migrants exceed their four-month period of temporary housing in these communities without acquiring a work-authorization permit or equivalent labor certification? In a transparent decision-making setting, these questions and more would have already been addressed; sadly, we are not acting within that system -- yet.

Thank you for your urgent attention to this humanitarian crisis. For the sake and well-being of all involved, we have to get this right. We are ready to work with our State and Federal partners to ensure a timely resolution to the unfolding events in the Hudson Valley.

## Layers of Dutchess County history are exposed in a rare personal setting

### Awards ceremony set on June 3

A rare weaving together of the varied and rich threads of Dutchess County history will come together at the historic 1840 Collins Estate, a private home in Union Vale, on Saturday, June 3. While the main purpose of the event focuses on the three traditional Dutchess County Historical Society (DCHS) Awards for 2023, the site, and the site's family history, is extraordinary in and of itself.

A direct descendant of the Collins family that built the home, Fredrika Groff, will attend with two daughters from her home in Colorado. Groff is central to the cohesiveness of the varied and intricate threads that reveal our county's distinct history. Her careful distribution of items among the DCHS, the Adriance Memorial Library, the Loeb at Vassar College, and the current owners and stewards of the home, Frank and Jennifer Castella, is a model of historic preservation. This preservation involves the home, family histories and genealogy, and objects that range from fine art to photographs and diaries to furniture.

The builder of the home was George Collins (1788-1848) and wife Elizabeth Borden Campbell (1795 to 1865). One of the interesting dynamics of the story is the tension caused by the Quaker insistence on simplicity while the couple and their descendants became increasingly successful in business and society.

A family fascination with growing things, and manufacturing things, is reflected in a diary entry of Fredrika Groff's grandmother, Elizabeth Borden Campbell (DCHS Collections). When she attended the US Centennial Exhibition in Philadelphia she spent the first day in the Horticultural Hall and Machinery Hall. On Friday, June 16, 1876, she wrote, "One large machine runs all the machinery in the building," and goes on to list all the things she saw, like silk wallpaper, "made entirely by machinery." A respect for the integrity and importance of agriculture, while developing and embracing revolutionary

technologies, is a major thread in the family story. Campbell's husband, Albert Adriance Simpson, was a descendant of the well-known Adriance family.

Elizabeth Borden Campbell's sister, Ada, also married into the Adriance family. She married Isaac Reynolds Adriance who was involved in the Adriance, Platt & Co. and Moline Plow Company that at one time employed 1,500 people in Poughkeepsie. We may underestimate

today how profound an impact a new type of farm plow could have. Adriance led the effort among his siblings to create Adriance Memorial Library.

The Loeb will have on display for the month of June, the portrait by Rembrandt Peale of Elizabeth Borden Campbell, the first resident of the house. It was gift of Fredrika Groff. That portrait, along with its companion of husband George Collins, also by Peale, will be featured as reproductions at the June 3rd event.


#### The Awards

## Fishkill Town Board passes resolution objecting to use of hotels to house migrants

The Fishkill Town Board passed a resolution which objects to New York City relocating undocumented migrants and "authoring commencement of criminal proceedings and civil litigation to prevent illegal use of local hotels as migrant shelters or dormitory facilities" during a special meeting on May 12 at the Fishkill Town Hall. The resolution passed unanimously.

The resolution states: "the City of New York does not appear to have a plan for supervising, processing, and relocating the individuals that is transporting to Hudson Valley hotels...the City of New York has not offered to provide, nor has it provided, funds or assistance to Hudson Valley communities to defray the additional central services costs they will incur due to the use of local hotels as shelters or dormitory facilities for hundreds of undocumented migrants, such as fire protection, EMS services, hospital facilities, etc." and it continues, "the Town of Fishkill lacks the facilities, services capacity, and funds to provide adequate shelter, assistance, and basic necessities to hundreds of dependent migrants that New York City is bussing into the Hudson Valley" New York City officials have bused migrants to a hotel in Orange County.

"I need to protect the citizens of Fishkill," said Ozzy Albra, Town of Fishkill Supervisor and a first-generation American. The resolution states the Town has an

"enacted a Zoning Code to promote and preserve the health, safety, and welfare of the Town's residents and property owners" and "under the Town's Zoning Code hotels are commercial enterprises in which a building and related facilities are used to provide short term transient boarding to paying guests." It continues: "the use of hotels in the Town of Fishkill as migrant shelters or dormitory facilities is a violation of the Town of Fishkill Zoning Code."

The Town Board "authorizes the Town Supervisor, the Town Building Inspector, and the Town's attorneys to commence civil and/or criminal actions against any property owner who illegally uses property as a migrant shelter or dormitory facility, including an application for a temporary restraining order and injunctive relief."

According to the resolution, a copy of it, "along with a letter demanding action to put a stop to New York City's illegal housing of undocumented immigrants in the Hudson Valley," will be sent to New York City Mayor Eric Adams, the Town's representatives in the New York State Legislature, and Governor Kathy Hochul and hotels in Fishkill.

The letter to the hotels, according to the resolution, will advise "the hotel owners that use of their hotel facilities as a shelter or dormitory facility is illegal and will subject them to criminal prosecution and civil liability."



to the lineup Friday and finished 2-for-4 with three runs scored, a double, a home run, and three RBIs.

It was a welcome sight after the Renegades scored just three runs in the previous two games. The team lost 1-0 on Thursday night and 3-2 in ten innings on Wednesday.

In Saturday's game, the Renegades overpowered Aberdeen 6-2. Hudson Valley jumped ahead early with a run in the first inning. After Spencer Jones led off the game with a double against Cooper Chandler (1-2), Jones advanced to third on a flyout to left field by Alexander Vargas. The next batter, Antonio Gómez, hit a deep fly ball to center field to score Jones from third and give the Renegades a 1-0 advantage.

The lead didn't last for long as the IronBirds capitalized on a defensive error to plate two runs in the bottom half of the frame and then took a 2-1 lead in the next inning.

Both pitching staffs excelled after that until the middle innings when the

Renegades pounced on a defensive miscue by Aberdeen. After Eduardo Torrealba singled to begin the fifth, Aldenis Sánchez laced a line drive to left field that glanced off the glove of Issac Bellony and rolled to the wall. Torrealba raced around from first base to score, while

Sánchez settled at second base. He would later advance to third on a wild pitch thrown by Chandler.

With the infield in on the grass and Sánchez at third, Jones hit a line drive off the turf and chest of Bencosme at second base. The recovery throw home by Bencosme was too late for Sánchez, and the run gave the Renegades a 3-2 lead.

This set Hampton up for his first professional win, as he struck out nine batters in five innings of work. Over his last three starts, the 2022 sixth-round pick out of Texas Tech has struck out 28 hitters in 14.2 innings of work. Danny Watson followed Hampton and hurled a scoreless three innings in relief while striking out two.

# Renegades' Sanchez reaches crossroads in minor league career

For Aldenis "Aldini" Sanchez, the smile and the easygoing attitude belie the reality.

Sanchez, an outfielder with the Hudson Valley Renegades, is like hundreds of other minor league baseball players. He has come to a crossroads in his pursuit of his lifelong dream.

"I know this is a make-or-break year for me," he said. "I know I have to produce when given the opportunity."

So far, the parent club New York Yankees have given him that opportunity. Acquired in a 2017 trade with the Tampa Bay Rays, Sanchez has had more than 1,000 at-bats in the minor leagues. He is third on the Renegades having appeared in 20 games this season. But he is batting only .231 with one home run.

"He has the talent," manager Sergio Santos said. "Now is the time for him to produce."

Time is also working against Sanchez. He will be 27 just after the season ends in September.

"I have to treat every at bat like it's a personal battle," he said.

Sanchez hails from the Dominican Republic, where, like many players, he started his career as an infielder. But with a glut of infielders in the Yankees organization, he quickly became an outfitter. He called it the right path for him, but now the Yankees have a glut of outfielders in the organization, including two of the top three prospects in Spencer Jones and Aaron Pawlensky. The Yankees are high on the former, while the latter leads the South Atlantic League in home runs.

At 6-foot, 165 pounds, Sanchez has done well for himself defensively.

"The bottom line to this game is hitting. That's what you are judged on," Sanchez said. "I know I have to produce."



## TYSON'S TIDBITS!

### Preparations at the Park and using tools to build a fan base



Each week, writer Rich Thomaselli and Hudson Valley Renegades General Manager Tyson Jeffers sit down to talk about the Renegades in particular and minor league baseball in general.

**What are the things you want to get done when team is on the road? Or does it change from week to week?**

It changes from week to week. Like right now, I am at the ballpark because we are hosting the cupcake festival.

There's lots to prep for here at the park. There is high school baseball, travel baseball, there are a lot of things going on besides the Renegades. There's a lot going on here, almost every single day.

Everyone has a different role here, and everyone is on top of their game, especially the operations people. We stay very focused here, even when the team is on the road.

**We've talked about this before. It has to do with people's perception of your title of general manager. What about the players? Do the players and the manager ever come to you and ask you to do something that is out of your purview?**

I don't have a lot of interaction with the players, but I do talk to Sergio and the coaches all the time, and I do talk to our clubhouse manager quite a bit. The players know that if there's a problem, they go

to the Yankees. I do talk to someone on the coaching staff, or someone affiliated with the Yankees, almost on a daily basis.

There are some things that are the responsibility of the Renegades, and there are some things that are responsibility of the Yankees. Sometimes I step in, where I have to, or when I'm needed. But our goal is just to be a good affiliate of the Yankees.

**How do you think you are perceived by the public? I mean, do people come to you and tell you that they follow the team, like they would a major league team?**

Yeah, I think you want to build that

awareness. A lot of people tell me they listen to the radio broadcast when the team is on the road, or even at home. We have streaming, we have video highlights, and I think a lot of people are surprised by that. I think minor league baseball does a lot to try to build a connection between the fans and the major league team.

We have tried to educate our fans about all these options so they can follow their hometown team. I think one day, very soon, you will see a stipulation that all minor league teams have a broadcast and some sort of streaming services.

## Legislature passes increases to county property tax exemptions

Members of the Dutchess County Legislature passed two local laws at the May board meeting that would increase the income limits to receive two County property tax exemptions - the Senior Citizens Exemption and Persons with Disabilities Exemption.

The measures will increase the income limit to \$41,600 to receive the full 50 percent County Property Tax Exemption and as the income gradually rises the exemption percentage decreases, ultimately ending at \$49,999 with receiving a 5% exemption. The previous law set the 50 percent exemption income limit as \$24,000. The laws will now go to the County Executive's desk for consideration.

"At a time where every dollar counts, the Dutchess County Legislature is proud to offer measures that will provide meaningful relief to our neighbors, especially those on a fixed income like our senior citizens and disabled population," said Legislature Chairman Gregg Pulver. "This increase will work to help offset the burden of rising costs by allowing more residents the opportunity to receive the County property tax exemption, while also ensuring that the County stays within its means. Under new State authority, we are raising the income limit by \$17,600 (73 percent which matches inflation from the time of the last increase, and we are also giving the opportunity to examine how this affects the County's finances to recommend further increases in the future."

Legislator Michael Polasek (LaGrange), Chairman of the Budget and Finance Committee said, "The Dutchess County Legislature has voted to lower the County property tax rate every year since 2014, which has provided relief to not only those living on a fixed income like our seniors and disabled population, but to each homeowner in Dutchess County. The intent of this legislation was to raise the income eligibility behind these property tax exemp-

tions to match inflation and ensure that each individual is receiving a worthwhile benefit. By raising it to \$41,600 a year for the full 50% County property tax exemption with a sliding scale down to a 5 percent exemption with a \$49,999 income, it is our hope that this will offer meaningful relief to our low-income residents." Last year, Governor Kathy Hochul signed into law legislation that raised the maximum income property owners over the age of 65 and people with disabilities would be able to earn in order to receive the County Property Tax Exemption, allowing municipalities to amend their local laws to also reflect the increase.

The intent of the legislation allowed for Counties to increase the maximum income threshold stated in their justification that "New York State has a growing number of low-income seniors on fixed incomes and persons with disabilities who have limited income who are faced with ever increasing property taxes..." Dutchess County has not increased the property tax rate in over ten years.

The income proposal of \$41,600 is above the federal standard of 200 percent of the Federal Poverty Level for a two-person household which is \$34,850 and the eligibility to receive the New York State Home Energy Assistance Program (HEAP) is \$34,250, both well-established "low-income" standards. The Dutchess County Legislature unanimously passed a Volunteer Firefighters and Ambulance Service Members County Property Tax Exemption Law at their February Board Meeting and amended their local law to increase the income eligibility for the Veterans Property Tax Exemption in 2022.

The new laws will go into effect for the 2025 Tax Rolls.

The first resolution proclaimed May 2023 as "Older Americans Month" and the second recognizing May as Mental Health Month throughout our Town and community. In my last column, I discussed our focus on our senior citizens. Today, let's also remember that many Americans are facing increasing levels of physical and mental stress, often resulting in some form of mental illness.

The National Institutes of Health (NIH) estimate that more than one in five U.S. adults aged 18 or older live with any mental illness (AMI). The degree of severity ranges from mild to moderate to severe. The disorders include mental, behavioral or emotional impairments. According to the NIH, AMI is more prevalent in females (27.2%) than males (18.1%) and young adults aged 18-25 years (33.7%) compared to adults aged 26-49 (28.1%) and aged 50 and older (15.0%). As we have discussed at previous Board Meetings our veterans are also increasingly afflicted. Our municipal government works closely with the National Alliance on Mental Illness (NAMI), which annually attaches white ribbons on our pillars and trees at Town Hall.

Please remember that if you suffer some degree of AMI or you know someone who does, You/They are not alone! Not only will NAMI assist you, but Dutchess County also provides assistance at its walk-in Stabilization Center (230 North Road, Poughkeepsie, 845-486-2849). The County offers a HELPLINE – 845-485-9700 24 hours a day. Dutchess County Sheriff Kirk Imperati has made a cornerstone of his Department in addressing mental health through its jail-based behavioral health program as well as through its professional, trained staff.

Dutchess County also offers a program for children through its Children's single Point of Access (CSPOA) that helps to identify Dutchess County residents between the ages of 5 and 21 who are at the greatest risk of being placed outside their homes due to serious mental health or emotional issues. The CSPOA helps to connect parents to a wide variety of supports, services and programs based on the identified needs of the child or adolescent, and the family. In addition to regular focus on many

societal issues, I and the Town Board at every meeting address key issues of vital importance to our community and you our residents and businesses. The May 8th Board meeting is a good case in point. Among the many key issues that I and fellow board members placed on the agenda and moved forward include the following summary. I will discuss these topics in greater detail in my future columns:

- I announced that Congressman has nominated the Town of Wappinger for a \$3.5million grant that will be the catalyst for expanding water and also sewer services south of Adams along Route 9 and laterally out to the neighboring communities

- The Board approved additional funding for the installation of additional playground equipment at Spookhill Park for our Phase 2 expansion. The Town is finalizing its plans for Phases 3, 4, and 5

- We passed a proclamation designating May as Asian American and Pacific Islander Heritage Month

- We announced the safety and security program for our two elementary schools that is subject to a larger article in this edition of the Southern Dutchess News

- The Board continued to address the protection of our drinking water sources by requesting additional service of our advisory committee. The Town will discuss and hopefully adopt the plan and resolution at a June workshop; and

- The Town passed a \$2.7million bond resolution to fund 2023 and 2024 paving of Town roadways

Many more important topics were discussed during the May 8th meeting. Stay tuned for further discussion and announcements. Together, Wappinger continues to be a great place to live, work, study and play.

# Dutchess County prepares to mark Memorial Day

Serving in the United States Marine Corps was the honor of a lifetime. My military service, including deployments to Iraq and Afghanistan, was the most rewarding experience of my life – serving along my brothers and sisters in defense of this great country and working to spread freedom across the globe. I made lifelong relationships and learned lessons I'll never forget; chief among them: honor, courage and commitment.

Upon my return honorable discharge from the military, I still felt compelled to serve and led the critical work of Mental Health America (MHA) of Dutchess County's PFC Joseph Dwyer PTSD Veterans Support Program – you might know it as Vet2Vet – connecting veterans in crisis resources to successfully reacclimate into their community.

Almost three full years ago, I embarked on a new mission – luckily not nearly as grueling as my time as an active Marine, but just as rewarding – serving our local heroes as the Director of the Dutchess County Division of Veterans' Services. Though my manner of service has changed, my mission has not. I remain here at my current post to protect the brave men and women of Dutchess County who have safeguarded our liberty, working to ensure they receive the benefits they've rightly earned through their military service.

Part of this vital mission is communicating to our veterans in various ways – be it in person at our Veterans' Services office within the MHA Veterans One Stop in Pleasant Valley, traveling to meet our heroes and their families where they are or through traditional and social media. That brings me to this new endeavor, a monthly column in the Southern Dutchess News family of publications, highlighting the news and issues that impact our veterans and their loved ones. I hope you find this new undertaking worthwhile, as we in Dutchess County continue to serve those who gave so much to keep us safe and free.

As Memorial Day approaches, our office and those we partner with are working to ensure Dutchess County residents hear a clear message concerning the rightful meaning of this sacred holiday.

The debate over whether the Memorial Day observance on the last Monday of May each year has been overshadowed by the country's focus on the beginning of summer and Americans' future vacation plans has been well documented. Some have even gone so far as to say that to properly recognize those who gave their lives in battle on this date has become somewhat of a lost cause. The thousands of veterans who call Dutchess County home would disagree.

They say recognizing the "ultimate sacrifice" of their brothers and sisters who died defending their country can never be overshadowed by the calendar or the fast pace of life. They say their souls fully embrace the emotion that rises up inside them every time they hear a gun fired and see a wreath laid during a Memorial Day service paying tribute to those who served.

"Memorial Day hits me very personally,"

says Mental Health America of Dutchess County's Suicide Prevention Program Manager, Alyssa Carrion, herself a veteran. "Every year, I specifically remember those in my unit who I worked so closely with who have since died, either in combat or from suicide. Even now, it's still sometimes hard to talk about."

This profound depth of feeling for the significance of Memorial Day has deep roots in Dutchess County. One, because of the scores of organizations that exist in the county for the sole purpose of serving veterans; but also, through the historical and heart-wrenching "Last Letter Home," written by Wappingers Falls resident J. Morris Goring more than a century ago.

In the letter – written to his mother and family amidst non-stop machine gun fire, little food and vermin crawling through the trenches – Goring poignantly tries to prepare his loved ones for his possible death, as he and others from the Hudson Valley geared up for a battle against entrenched and formidable German positions known as the Hindenburg line. Historians say the confrontation was a crucial piece to ending World War I six weeks later, on November 11, 1918.

Goring wrote, in part, "...For the one who dies it is easy, it is those who are left we worry about. ... If I should get picked off, I would die happy. We are sure it isn't the end. ... You know it is only a change and in what better way can a man make that change than over here fighting for home, country, civilization, his mother, sister and sweetheart."

Those words ring just as loudly today, as the fight for freedom and a just civilization continues over a hundred years later. The many veterans we spoke to agree and say they will always make Memorial Day observances and ceremonies a priority, both in their hearts and in their attendance. They say they cannot forget all those who have made that ultimate sacrifice, and they encourage County residents to consider attending one of the many ceremonies that will be taking place throughout Dutchess County this Memorial Day.

Army veteran and County Executive William F.X. O'Neil and I invite all residents to join us at the Dutchess County War Memorial in Poughkeepsie on Monday, May 29, at 11 a.m. for the County's annual Memorial Day remembrance. Joined by local veterans, municipal leaders and a grateful county paying its respect, we will lay wreaths at the memorial while the Poughkeepsie High School JROTC presents the colors and Navy Seal Alex Othmer offers keynote remarks – all to honor those souls who gave everything in the name of their country.

Dutchess County will always remember its veterans and their valiant sacrifices – not just on Memorial Day, but every day.

## Nose work training for dogs builds confidence

As far as the feedback Tetrault and others at Top Notch Dog Training have received from previous participants in the program, she said, "Everyone (especially the dogs) loves the program! It's great for all sizes/shapes of dogs and all sizes and abilities of their humans."

Brynn Holic, a resident of Holmes, had her two-year-old dog Lenny, a miniature dachshund, in the program.

"I enjoy this program at Top Notch Dog Training very much. Lenny is my third dog to have started in Nose Work. It's great for young to older dogs and they all love it," commented Holic.

Regarding how the program helped Lenny, Holic stated, "The difference I see in Lenny from when we first started to now is amazing. He's a more-shy dog and is very attached to me. Since starting Nose Work class, he now has more confidence and works independently without me being right there in his shadow. We are becoming a great team together and look forward to continuing this class and even competing at trials."

So, how does nose work assist with a dog's emotional and physical well-being?

"Nose work helps a dog build confidence," Tetrault explained. "It wears out energetic dogs but is non-physical enough for almost any dog to do it. I have seen everything from chihuahuas to Great Danes compete with tremendous joy and accuracy."

Stefanie Mount, a resident of the Town of Kent in Putnam County, also had her dogs take part in one of the nose work programs.

"Nose work classes were recommended to me to help build confidence in my dog with fear based behavioral issues. Top Notch was mentioned. We signed up and never looked back," said Mount, who has Miller, a six-year-old German shepherd and Buster, a 19-month-old German shepherd.

Mount stated, "The program is great. I came for a class in 2018 and never looked back. Nose work, particularly with this methodology, opens a whole new world and relationship for dogs and their humans."

According to Mount, "For my dog Miller, I can honestly say Nose Work saved his life. He had such confidence issues that manifested in inappropriate behaviors. He is so much more balanced and gets to exercise his brain in a sport he loves."

One caveat though for the program is there is a limit to the number of participants that can be in a class.

"In order to give the dogs and handlers proper attention, the average class is limited to 6 teams per class," said Tetrault. The program is offered at Top Notch Dog Training's training center in Wappingers Falls.

Holic said, the program "really helps with confidence for shy timid dogs or even for mental stimulation for more active dogs." She added, "It's so rewarding to watch your dog succeed and grow as a team together."

Mount said, "In nose work, your dog is the lead, and you are the supporting cast. It is amazing to watch them problem solve and work out scent puzzles. I loved it so much. I went through the instructor certification program and now get to share my passion for nose work with student teams."

## Courtyard Marriott case concludes with Murder 2 conviction

Dutchess County Chief Assistant District Attorney Matthew A. Weishaupt announced on Friday, May 12, that Roy Johnson was convicted by a Dutchess County jury of the crimes of Murder in the Second Degree, for the murder of Paul Kutz that occurred at the Courtyard Marriott on October 2, 2022. Johnson was also convicted of three counts of Criminal Possession of a Weapon in the Second Degree, Criminal Possession of a Weapon in the Third Degree, and Reckless Endangerment in the First Degree.

Johnson was acquitted of the Attempted Murder charge related to the worker in the Bistro area of the hotel lobby.

The trial took two weeks and the jury deliberated for approximately a day and a half before returning the verdict. Weishaupt said "The Kutz family has been devastated in a way that we cannot comprehend nor change, but we hope this verdict will in some small way provide the family with the ability to move forward. The family remains in our prayers."

Weishaupt praised the cooperation and work of the law enforcement agencies involved from the outset: The Town of Poughkeepsie Police, which headed the investigation and worked seamlessly with the Troop K State Police Forensic Investigations Unit; the Dutchess County Sheriff's Office; the Safe Streets Task Force; City of Poughkeepsie Police; the United States Attorney's Office for the Southern District of New York, other responding law enforcement agencies, and members of Dutchess County's District Attorney's

Office, both at the scene and in the months that followed.

Weishaupt further stated, "It is this collaborative team effort that led to this verdict. This effort never waned despite outside pressures. Everyone involved in this case deserves a great deal of credit for remaining focused on the task at hand; it was truly an outstanding job."

Weishaupt praised Bureau Chiefs Kristine Whelan and Robert Knapp, Deputy Bureau Chief Angela Lopane, Crime Analyst Andrea Tegtmeier and the team of Assistant District Attorneys, Investigators, and support staff for their dedicated and exceptional work in preparing this case for Grand Jury and Trial. The Discovery process involved in this case was unprecedented and took more than six months to fully compile and turn over as required by law. All the personnel involved in the Discovery process and case preparation should be commended for doing an outstanding job, Weishaupt stated.

Judge McLoughlin continued the remand of the defendant without bail and has set sentencing in this matter for June 26. The defendant, Roy Johnson, faces 40 years to life in prison following his conviction on the charges set forth above. Weishaupt said, "The egregious facts of this case speak for themselves, and we will recommend the maximum penalty allowed by law."

Johnson still faces felony Murder and Robbery charges in the August 9, 2022, murder of Darren J. Villani in the City of Poughkeepsie.

attendees will learn about the history of Clinton Point and the Italian immigrant community once known as Stoneco.


DiDomizio will present on the history of Clinton Point and Stoneco covering the time period from 1609 to 1919, as well as

WHEREAS, said capital project, as proposed, has been determined to be a Type II Action pursuant to the regulations of the New York State Department of Environmental Conservation promulgated pursuant to the State Environmental Quality Review Act, which regulations state that Type II Actions will not have any significant adverse impact on the environment; and

WHEREAS, by Resolution No. 2016282, a resolution dated September 12, 2016, duly adopted on said date, the County Legislature of the County of Dutchess, New York, authorized the appropriation of \$425,000 monies of said County to pay the cost of certain improvements to the Fallkill Dam, located at Fallkill Park on Creek Road in the Town of Poughkeepsie, including incidental improvements and expenses in connection therewith, in and for said County, and

WHEREAS, it is now desired to authorize the issuance of \$2,525,000 bonds of said County for such specific object or purpose; NOW, THEREFORE,

**BE IT RESOLVED**, by the affirmative vote of not less than two-thirds of the total voting strength of the County Legislature of the County of Dutchess, New York, as follows:

Section 1.  
The reconstruction of the Fallkill Dam, located at Fallkill Park on Creek Road in the Town of Poughkeepsie, including incidental improvements and expenses in connection therewith, in and for said County of Dutchess, New York, is hereby authorized at a revised maximum

estimated cost of \$2,950,000.

Section 2.  
It is hereby determined that the revised plan for the financing of said specific object or purpose at said revised maximum estimated cost is as follows:

a. by the appropriation of \$425,000 monies of said County authorized to be issued pursuant to a resolution dated and duly adopted September 12, 2016 as described in the preambles hereof;

b. by the issuance of \$2,525,000 serial bonds of said County hereby authorized to be issued therefor pursuant to the provisions of the Local Finance Law.

Section 3.  
It is hereby determined that the period of probable usefulness of the aforesaid specific object or purpose is 30 years, pursuant to subdivision 22(a) of paragraph a of Section 11.00 of the Local Finance Law, calculated from the date of issuance of the first serial bonds/bond anticipation notes for said specific object or purpose.

Section 4.  
The faith and credit of said County of Dutchess, New York, are hereby irrevocably pledged for the payment of the principal of and interest on such bonds as the same respectively become due and payable. An annual appropriation shall be made in each year sufficient to pay the principal of and interest on such bonds becoming due and payable in such year. There shall annually be levied on all the taxable real property of said County a tax sufficient to pay the principal of and interest on such bonds as the same become due and payable.

New York, by the manual or facsimile signature of the Commissioner of Finance and a facsimile of its corporate seal shall be imprinted or impressed thereon and may be attested by the manual or facsimile signature of the County Clerk.

Section 7.  
The powers and duties of advertising such bonds for sale, conducting the sale and awarding the bonds are hereby delegated to the Commissioner of Finance, who shall advertise such bonds for sale, conduct the sale, and award the bonds in such manner as she shall deem best for the interests of the County; provided, however, that in the exercise of these delegated powers, she shall comply fully with the provisions of the Local Finance Law and any order or rule of the State Comptroller applicable to the sale of municipal bonds.

The receipt of the Commissioner of Finance shall be a full acquittance to the purchaser of such bonds, who shall not be obliged to see to the application of the purchase money.

Section 8.  
All other matters, except as provided herein relating to such bonds including determining whether to issue such bonds having substantially level or declining annual debt service and all matters related thereto, prescribing whether manual or facsimile signatures shall appear on said bonds, prescribing the method for the recording of ownership of said bonds, appointing the fiscal agent or agents for said bonds, providing for the printing and delivery of said bonds (and if said bonds are to be executed in the name of the County by the facsimile signature of the Commissioner of Finance, providing for the manual countersignature of a fiscal agent or designee of the County), the date, denominations, maturities and interest payment dates, place or places of payment, and also including the consolidation with other issues, shall be determined by the Commissioner of Finance.

Section 9.  
This resolution shall constitute a statement of official intent for purposes of Treasury Regulations Section 1.150 - 2. Other than as specified in this resolution, no monies are, or are reasonably expected to be, reserved, allocated on a long-term basis or otherwise set aside with respect to the on a long-term basis, or

or otherwise set aside with respect to the permanent funding of the object or purpose described herein.

Section 10.  
The validity of such bonds and bond anticipation notes may be contested only if:

1) Such obligations are authorized for an object or purpose for which said County is not authorized to expend money, or

2) The provisions of law which should be complied with at the date of publication of this resolution are not substantially complied with, and an action, suit or proceeding contesting such validity is commenced within twenty days after the date of such publication, or

3) Such obligations are authorized in violation of the provisions of the Constitution.

Section 11.  
This resolution, which takes effect immediately, shall be published in full in The Poughkeepsie Journal and the Southern Dutchess News, the official newspapers of said County, together with a notice of the Clerk of the County Legislature in substantially the form provided in Section 81.00 of the Local Finance Law.



The object of the game is to fill all the blank squares with the correct numbers.


Each row of 9 numbers must include all digits 1 through 9 in any order.


