### Local veteran's death in WWII commemorated on 80th anniversary East Fishkill veteran 'Manny' Bacon honored

Members of American Legion Post 1758 in Hopewell Junction traveled to the Pinelawn National Cemetery in Farmingdale, on Long Island, to commemorate the 80th anniversary of the post's namesake, Charles P. "Manny" Bacon. The seven Post 1758 members recognized Bacon, who was killed in action (KIA) in North Africa during World War II. Pfc. Bacon was the first East Fishkill resident to die in that war, and fifteen others also gave their lives in service to our country, according to Post 1758.

Jim Reynolds is the commander of Post 1758's.

"Our American Legion Post is named after Manny Bacon and in 2022 Post Historian Bill Kriebel brought to our attention that 2023 would make the 80th anniversary of Manny being killed in action. We discussed how we should honor Manny and decided to visit his grave on that anniversary," Reynolds explained earlier this month.

Charles Peter "Manny" Bacon was born November 29, 1919 the oldest child of Lewis and Marcella Bacon, remarked Reynolds.

"Manny grew up in Hopewell Junction with his siblings Margaret, Lewis Jr. and

### A Window on the American Revolution

#### Veeder's work on abandoned cemetery reveals historic information

An abandoned cemetery in the Netherwood area of Pleasant Valley has reminded the community of the role of Dutchess County people in the American Revolution.

Former Pleasant Valley Town Supervisor Gary Veeder tells how he and his wife, Pam, would drive by the small old and overgrown cemetery and he'd say to her, "Somebody ought to clean that up and make it nice again." One day, after years of that reaction, and driving by, he said to her, "I'm somebody; maybe I should do it."

Thus began a multi-year effort of historic research that isn't done yet. It has also been a serious project of clearing the overgrowth, finding the collapsed headstones and repairing and putting them back where they belonged. Veeder is not done yet, but the old cemetery is regaining some of its dignity.



### Renegades struggle in losses to Wilmington and Brooklyn

It's official. They are slumping.

The Hudson Valley Renegades lost to the Brooklyn Cyclones, 6-1, on Friday night, for their third loss in four games.

It was also the sixth loss in the last eight games for the Renegades. The lone bright spot of the week came in the second game of a doubleheader on Sunday night when the Renegades grabbed a 3-2 extra-inning walkoff win over Brooklyn. They are struggling to hold on to first place in the North Division of the South Atlantic League.

The team was scheduled to start a sixth-game trip to Wilmington on Tuesday.

On Friday, the Renegades just could not come up with the clutch hit.

After Juan Carela (1-2) stranded a pair of Cyclones in the first inning, Hudson Valley nearly jumped on the board in the second. After Yoander Suárez (1-2) issued a one-out walk to Aaron Palensky, Grant Richardson singled to center to put runners on the corners with one out. However, Suárez induced Eduardo Torreable to hit into an inning-ending double play to keep the Renegades scoreless.

The game remained scoreless until the bottom of the fifth when Richardson led off with a solo home run to left-center to put Hudson Valley up 1-0. It was the third round-tripper of the season for Richardson, who finished 2-for-4 with a home run, an RBI and a run scored.

Brooklyn scored the final six runs of the game.

Up 2-1 in the top of the seventh, Mateo Gil hit an RBI double off Enrique Santana and scored on a wild pitch thrown by Harrison Cohen. Parada capped off the three-run frame with an RBI single as the Cyclones extended their lead to 5-1. Brooklyn plated their final run with an RBI single in the ninth by Chase Estep off Ryan Anderson.

In Tuesday's series opener, the Renegades led from start to finish and beat Brooklyn 9-6.

Jones sparked the Renegades offense early with a leadoff home run in the bottom of the first off Jeffrey Colón. In the bottom of the second, Palensky hit a one-out solo home run off Colón (0-2), his league-leading

# Local veteran's death in WWII commemorated on 80th anniversary

James. He attended elementary school in a three-room schoolhouse on Beekman Road and entered Beacon High School in January 1934. After leaving school, he went to work for the maintenance division of the New York, New Haven and Hartford Railroad in Hopewell Junction. Manny was also a Lieutenant of the Hopewell Hose Volunteer Fire Department," Reynolds said.

It was on May 21, 1942, said Reynolds, that Bacon received his induction notice and was inducted into the U.S. Army at Fort Jay in New York.

"After basic training, he was shipped to Ireland and was part of the invasion forces to hit North Africa in November of 1942 as a member of the 9th Recon Troop. On May 19, 1943, Mr. and Mrs. Bacon were notified that Manny was missing in action (MIA) and two weeks later, another War Department telegram informed them that he had been killed in action April 20, 1943," stated Reynolds.

"Manny was the first of 16 men from Hopewell Junction and East Fishkill that were killed in World War II. The population of East Fishkill in 1940 was just over 2000 residents," Reynolds explained.

Manny was first interred in the American Cemetery Beja, Tunisia and after the war, his remains were returned to

the United States and he was buried here at Pinelawn, stated Reynolds. "At the time of his death, he was survived by his parents Lewis who died in 1966 and Marcella who passed away in 1994. He was also survived by his sister, Margaret who died in 1991, his brothers Lewis Jr. and James who died in 1987 and 2002 respectively. His sister Margaret had a daughter Renate that still lives in Hopewell Junction. In 1949, American Legion Post 1758 was created in Hopewell Junction and named in honor of Manny," he said.

As for why the veterans took the trip to Long Island to Pinelawn Cemetery, Reynolds said, "To show the families of those killed while in the military that their loved ones are not forgotten and to teach further generations the true meaning of patriotism and ultimate sacrifice. By showing people that these veterans are not obscure names from somewhere else, but that Manny Bacon was a local young man from East Fishkill and Dutchess County would give his life to protect our country."

One of those on who made the trip to remember Bacon was Bill Kriebel, a member of the Post, "Our Post regularly decorates the graves of local veterans every Memorial Day and we perform honor guard ceremonies for the funerals of local veterans who have passed on. But as our Post's historian, I

could not find any record of the Post honoring the grave of our Post's namesake, Charles P. "Manny" Bacon, and I thought it would be a good idea to do it on the 80th anniversary of when he was killed in action. Seeing all the grave markers in that cemetery was a stark reminder to us of all the people who gave their lives so that we could live in a free country. I'm really glad we went."

Reynolds said, "More than one-million American veterans have made the supreme sacrifice to protect the things they loved –

God, country, and family. Brave men and women have always stepped forward to take the oath of allegiance as members of America's armed forces, willing to fight and if necessary, die for the sake of freedom. They have always been and will continue to be the ones who protect and preserve our way of life."

Reynolds noted, "It's unfortunate that all issues cannot be settled with talk and negotiations. Sometimes it's necessary to use force to protect our freedoms."

# A Window on the American Revolution

In the course of his research, Veeder learned that the cemetery had been established on a quarter of an acre by one Anthony Badgley. There are several generations of his family there, but Badgley, himself, was the key to looking back into the American Revolution.

His headstone had been knocked over, but not broken. Upon setting it back up and cleaning it, the inscription came to light. It states: "In memory of Anthony Badgley who died October 12, 1810 Age 89 y. 3 Mo. 10 d."

Who was this man, Veeder wondered? And thus began further research to learn more about him.

Anthony Badgley had acquired the property, which was at that time still part of the Town of Clinton. (Pleasant Valley and Hyde Park were created in 1831 when the Town of Clinton was subdivided.) He owned a considerable amount of land in Clinton and set aside one quarter of an acre to be used as a

cemetery where he, his wife, Sarah, and many descendants are buried. The quarter acre came to be known as "The Badgley Ground."

It appears that many old family cemeteries are referred to by the family name and the word "ground." Thus there might be the "Haight Ground," or the "McCann Ground" had those families created a family cemetery on their properties.

There are generations of Anthony Badgley's family buried in this cemetery in the Netherwood area, likely over 40 graves. Badgley's wife and at least one son are near his grave. Others are scattered across the entire quarter acre.

Their tombstones, in some cases, tell a little about them. Perhaps the most sad is a small white marble stone that reads: "Our Little Mary Ella, dau. of George R. & Alletta E. Vail. Died Feb 21, 1861. Aged 5 yrs 5 m's 6 d's." Above the inscription a small flower has been engraved. Veeder has cleaned this one carefully. It's white marble now, almost as pure as it was 160 years ago.

Anthony Badgley's story is slowly coming back to life. He was born in Flushing, Queens and was orphaned before he was 10 years old. He was raised by a cousin and her husband, who moved with him to Dutchess County. By 1769, he had become a landowner in Clinton with extensive holdings.

When the revolution began, Anthony Badgley pledged his life and his goods to the cause of independence and took up arms. Research indicates that he was an officer, a Captain with the Dutchess County Militia, Fourth Regiment. The Dutchess County Militia could refer to one of two different units.

There was a local Militia unit that defended the area, guarded military supplies and, among other engagements, fought in the Battle of White Plains. They deterred foraging British troops coming north to steal food and supplies to feed an ever more isolated New York City. They were also critical to the task of keeping the British from moving north from New York City in the attempt to

conquer the entire Hudson Valley and cut off New England from the rest of the colonies. This British effort came to an end with their defeat at Saratoga. But their need to secure supplies for New York City continued.

There is another 4th Regiment of Militia often identified as Dutchess. In 1775, the New York Assembly authorized the creation of a Militia. The 4th Regiment of the State Militia was raised in Dutchess County and was referred to for some time as the 4th (Dutchess) Regiment. Some of the Dutchess men could have easily served in that unit as well as doing a short stint in the more local militia.

The 4th Regiment, with one of its 10 companies coming from Dutchess County, went north in the late spring of 1775 after Ticonderoga had been taken from the British. They were a part of the forces led by Brigadier Richard Montgomery, another Dutchess County resident, who lived in Rhinebeck with his wife, Janet Livingston.

The Irish-born Montgomery was an experienced and respected officer of the British Army. When he married Miss Livingston and settled in Dutchess County, he came to share the political feelings of her family that the colonies were being ill-treated by Parliament and, like his in-laws, he came to favor independence.

When George Washington was forming a Continental Army, the Congress asked New York to name two Generals to help lead it and specifically to lead the New Yorkers who would form a part of it. The New York

Assembly nominated Philip Schuyler as Major General and Richard Montgomery as Brigadier. In June of that year they headed north to garrison Ticonderoga, lest the British return and to hold the northern approaches to the Hudson Valley. Schuyler, an older man, became ill; and Montgomery, his much more experienced second in command, ensured the success of their assignment both logically and militarily.

Late in the summer, Schuyler and Montgomery were ordered north to try and deal with the British in Canada. Many had assumed the Canadians would join their cousins to the south in seeking independence. Schuyler took ill and Montgomery assumed command.

The men of Dutchess County served as an important part of his army. They took Montreal, but failed in the attempt to take Quebec. Montgomery fell leading his troops in the assault along with many of the Dutchess County troops. The army fell back to New York State. Montgomery, still respected by his former comrades of the British Army, was buried with honor in Quebec. The New Yorkers reformed the unit and went on to fight at Saratoga, and other battles up to the final victory.

Where exactly did Captain Anthony Badgley serve? That question is still being studied. Whichever role he played, local militia leader or Captain in the larger New York Militia, his grave in the old "Badgley Ground" is being restored to the honor that his memory deserves.

*Editor's note: The issue of bussing migrants/asylum seekers from New York City to Dutchess County brought the following responses last week – from Dutchess County Executive William F.X. O'Neil and Dutchess County Democrats. On Monday, May 22, it was revealed that a number of migrants were in Dutchess County at the Red Roof Inn in the Town of Poughkeepsie. See the update at the end of this article for more information.*

### **O'Neil files State of Emergency, two Executive Orders**

"Continuing our ongoing efforts to protect the residents of Dutchess County, I have executed and filed a State of Emergency and two Executive Orders in relation to New York City's imminent, forced relocation of migrants and/or asylum seekers to Dutchess County. These measures will, to the best of the County's ability, preserve our rights and safeguard the well-being of our residents and our community by enforcing various established codes and regulations – a pre-emptive step necessitated by the haphazard efforts of New York City to randomly disperse individuals throughout New York State. Though the City has failed to give Dutchess County a definitive timeframe of when, nor how many individuals could be expected, I am making this proactive move to ensure law and order throughout our County, as well as provide for the safety of our nearly 300,000 residents."

"The County of Dutchess is also exploring its options to commence civil action against the City of New York, and any property owner of a hotel, motel or short-term occupancy rental property who uses or causes to be used, converts or authorizes the use of such hotel, motel or short-term rental property as an emergency shelter, homeless shelter or long-term overnight dormitory, including, but not limited to, seeking injunctive relief and a temporary restraining order."

"While Dutchess County and our residents empathize with the plight of the individuals being inhumanely shuttled out of New York City by Mayor Eric Adams, Dutchess County is already grappling with housing challenges for our residents, and our County does not have the resources to adequately address the myriad needs these individuals will undoubtedly require during their stay. For New York City to simply dump these vulnerable souls into a community that cannot provide for their needs is unconscionable and a further example of Mayor Adams' failure to create and communicate a well thought-out plan with Hudson Valley counties."

"This crisis is the direct result of the Biden Administration's continued failing, inability or unwillingness to conceive and adopt an immigration policy that protects both this country's citizens and those looking to engage in a legal process to make a life here. We in Dutchess County government refuse to be enablers of this incompetent and ineffective administration, and we urge every Dutchess County resident to contact their federal representatives and ask they demand the White House to swiftly act."

### **Dutchess County Democrats decry lies about bused immigrants displacing homeless veterans**

In response to the growing number of Republican-led counties quickly declaring States of Emergency based on not necessarily reliable tales of immigrants being bused from New York City, Dutchess County Democrats demand its elected leaders organize for solutions not punishment.

Dutchess County Comptroller Robin Lois said, "Treating vulnerable populations as an emergent threat stops any kind of meaningful solutions in their tracks. This is not a state of emergency, it is a call to action. We can work together - government, community organizations, and individuals - to figure out how to help those who need it."

One catalyst for this rush, a widely reported claim by Sharon Toney-Finch, herself a veteran and founder of the nonprofit YIT, that 20 homeless veterans had been displaced and evicted from the Crossroads Hotel in Newburgh turned out to be a hoax.

Dutchess County Democratic Chair Michael Dupree said, "Over the last week, Toney-Finch's shameful and false claims spread by Assemblymember Brian Maher and NYS Senator Rob Rolison, took off like wildfire, spread by right-wing news outlets like the New York Post and Fox News. Today, the Albany Times Union reports that Crossroads staff have been threatened with violence and another report notes that Toney-Finch has admitted to hiring homeless men in Poughkeepsie to pretend to be the evicted veterans, by offering them food and alcohol."

Such stoking of embers seems to have led to the explosion of local Republicans acting hastily, though Maher for one has expressed remorse.

"I am in full agreement that NYC Mayor Eric Adams bungled what could have (been) a full-throated effort to organize an area-wide response to any immigrant surge," said Milan resident Russell Frehling. "Adams should have convened a panel of all the Hudson Valley County Executives, heads of area churches and the many volunteer groups we have who are already organizing and in one case, making asylum seeker kits," Frehling continued, "but he didn't; however, our leaders should not have reacted so hysterically either. Using such phrases as 'protect our citizens' to justify hasty declarations of emergencies is just jumping to conclusions and tossing gas on flames."

Orange, Green, Sullivan and Dutchess counties have now joined Rockland in exploring emergency laws to prevent hotel and motel owners from accepting contracts to house immigrants, who as Dutchess County Legislator Kris Munn noted, "Are here legally, because they are seeking asylum." He continued, "Title 42, a Trump-era policy allowing the U.S. to ship asylum-seekers back to Mexico while awaiting a date with customs, ended along with covid restrictions."

Yvette Valdés Smith, Minority Leader in the Dutchess County Legislature said, "Our Democratic caucus recognizes that we are a family of free people from all walks of life. If we cannot assist those who need us most, what does that say about our ability to help neighbors here when they are most in need? Our caucus also recognizes the need for more resources, if we are going to join together to find humane solutions. We stand with state and federal leaders, Assemblymember Jonathan Jacobson and Representative Pat Ryan in calling for more aid for Dutchess County."

Heidi Tucci, Worship Chair at Trinity United Methodist Church, and member of the Union Vale Democrats, agreed, "Our local churches began addressing the needs of asylum seekers in New York when Florida Governor DeSantis first cruelly bused immigrants to the city as though they were cattle. We are now working on Asylum Seeker Kits, with essentials included, and stand ready to assist if and when people in need are placed in Dutchess County."

**UPDATE:**

On Monday, May 22, as this paper was going to press, Dutchess County Executive William F.X. O'Neil issued a statement on the arrival of asylum seekers transported to Dutchess County by New York City:

"Despite repeated requests, Dutchess County has not received any information about individuals, legally in NYC's custodial care, who have been transported by NYC to Dutchess County. Yesterday, Town of Poughkeepsie police reported two buses arrived at the Red Roof Inn in the Town of Poughkeepsie. Again, despite requests to NYC for information, the County has no information about these individuals, including their identities, how long they'll be in our community, or the total number of people. While the County does not have a confirmed number of individuals that arrived yesterday, it is estimated that as many as 60 to 80 individuals arrived based on police observations and media reports. The owner of the Red Roof Inn and other local hotels, Sam Patel, has also been silent and uncooperative in sharing information. This silence has forced Dutchess County to seek the required information through legal means."

NYC Mayor Eric Adams assured counties that advance notice would be provided of any arrivals – that did not happen. New York City has shown no willingness to coordinate or collaborate with Dutchess County, and New York State has been complicit in exacerbating the issue by taking no action, other than providing New York City with millions of state taxpayer dollars to shelter asylum seekers, yet requiring no coordination, communication or transparency."

# WCSD voters approve 2023-24 Budget


Registered voters in the Wappingers Central School District voted for the 2023-24 Budget. The election was held on May 16.

The following are preliminary results. The Budget vote was 2,652 Yes votes to 1,084 No votes.

On May 17, Dr. Dwight Bonk, WCSD Superintendent of Schools, stated to Southern Dutchess News, "The District is very grateful to the Wappingers CSD community for their continued support of our Budget, Schools, and District!"

The 2023-2024 school budget, in the amount of \$287,091,282, was a budget-to-budget increase of \$21,377,260, of which \$15,331,672 is New York State Aid increase and the use of \$1,701,914 in Fund Balance, it was previously noted by Bonk. The budget is below the allowable tax cap (2.05 percent), at 1.67 percent, according to the superintendent.

The Bus proposition also passed. The vote

was 2,595 Yes votes to 1,136 No votes.

John Lumia, Peggy Kelland and Keith Odums were reelected to the WCSD Board of Education. Lumia, who is the

president of the current board, received 3071 votes. Kelland received 3016 votes. Odums received 2909 votes. Anthony Ciro Dilullo, who also was on the ballot

for one of the three board seats, received 919 votes.

The three seats are three-year terms from July 1 – June 30, 2026.

# Low-key Palensky comes up big in terms of home runs and hitting

"You just go out there and play and try to do your job," he said, "and be ready to produce if you are fortunate to have your name placed into the lineup."

### What are the moments like before a rainout?

Yeah, rainy days are a little more stressful than normal days. We are on the phone with everybody. We pay for some apps that allow us to talk to meteorologists. I mean, sometimes the team is in the dugout and looking at the Weather Channel app and ours are a little more in-depth and sophisticated.

There are a lot of things to consider. What the other team thinks, what the next

day is going to be like weather-wise, if this is the last time in the year you're going to see this team, or you can squeeze in a makeup date on a future date. There is a lot of communication going on.


I am in touch with the meteorologist, with the opposing team, with our groundskeepers, and with the configuration and what the opposing manager tells us. We ask him how long he thinks it will take to get his players, and especially his pitchers, ready. Plus, there's a business aspect as well. Maybe we know we have 4,000 or 5,000 people who are coming to the ballpark and we are not so quick to call for a rain out. But, we also want them to have a good experience and sitting through a rain delay is not

Explain to people that there is no staff for this. It's all hands on deck. Even you, as the general manager, get down to the field and help.

I am communicating with 20-plus people and asking them to disseminate information. Then I have to make sure our social media. He's communicating the right message to all the people who are still planning on coming to the ballpark. In one form or another, everybody has a job to do on a rainy day.

### Is there any way that a rain out, followed by a doubleheader, is beneficial?

Yeah, the only time that it truly is beneficial is when you're able to look at the forecast in your it's 100 percent chance of



rain every single hour for the day, and you're able to make the decision well in advance, where there's really, like, no arguments from any parties, the fans understand. Uh, the teams understand everyone's in agreement that like, we're not going to play baseball today, so let's don't try. That gives us a chance to call it off with no regrets or second thoughts, and to not call-in extra staff and save some expenses on the day.

## O'Neil releases 2022 year-end financial report

Dutchess County Executive William F.X. O'Neil announced the County's 2022 year-end financial report has been submitted, as required, to the New York State Office of the Comptroller. Thanks to the County's continued responsible and conservative fiscal management, in 2022, Dutchess County Government was able to utilize historic fund balance reserves to deliver tax relief to residents and businesses. Additionally, the County paid down debt and avoided new debt by utilizing fund balance for several significant capital projects. As outlined in the year-end report, the County's current fund balance totals a healthy \$72.5 million, providing some ability to mitigate negative economic impacts or new cost shifts from the state or federal government.

O'Neil said, "I am grateful to our dedicated, steadfast fiscal management team who guide our policies, strategies, cash flow and budget. Together with the County Legislature, we have built a solid fiscal foundation for Dutchess County's future with smart choices and careful, conservative management. We need to be ever vigilant as we know how quickly conditions can change, particularly as New York State seeks to push down more costs on to county taxpayers in the 2023-24 State Budget."

General fund balance is an important measurement of the County's fiscal stability, as it serves as a "rainy day" fund to help insulate the County from the impact of unforeseen economic downturns or unexpected costs. The County adheres to a fund balance management policy of maintaining 1-2 months of operating expenditures, or approximately \$49 to \$97 million. If general unassigned fund balance exceeds two months of operating expenditures, the policy states the County will use general fund balance to:

- Pay down debt;
- Avoid new indebtedness; and/or
- Provide property tax relief through offsetting current year operating expenses.
- In 2022, with fund balance reserves totaling \$119.5 million, the County did all three – cut taxes, paid down debt and funded critical projects with cash rather than financing through bonds.

2022 fund balance use highlights include:

- Dutchess County's property taxes were reduced in both the 2022 and 2023 Adopted Budgets. The County property tax levy is the lowest levy in 14 years and the property tax rate has been reduced 32% since 2015.
- Sales tax on clothing and footwear items less than \$110 was eliminated. Dutchess County is one of the only counties in the
- Hudson Valley region to offer this clothing and footwear savings.
- All eligible, callable debt was paid off.
- Capital projects that normally would be financed through bonds were paid uti-

lizing fund balance including:

- Emergency Response vehicles (\$2.1 million)
- Countywide interoperability 2-way emergency response radio project (\$3.4 million)
- Camp Nooteeming property purchase and improvements (\$4.8 million)
- Replacement of County roofs (\$2 million)
- County building improvements (\$3.5 million)
- Northside Line trail funding (\$2.5 million)
- ADA Accessibility projects (\$1.5 million)
- Network infrastructure, Board of Elections printers, capital vehicles and equipment (\$2 million)
- Capital projects for Enterprise funds (\$1 million)

Additionally, the County established the Housing Trust Fund with \$12.3 million in unassigned fund balance set aside in a restricted reserve. \$9.3 million of the Housing Trust Fund will come from federal American Rescue Plan (ARP) funds, and as the funds are spent and ARP revenue can be realized, those dollars will be returned to the unassigned fund balance over the next three years.

Looking ahead, as the Governor and State Legislature work to finalize the 2023-24 New York State budget, Dutchess County Government faces multi-million dollar impacts as the State seeks to take back funding and add new costs for county governments. Although the State Budget agreement has been reached, specific details have not yet been released. Dutchess County is facing new annual costs totaling nearly \$10 million, including \$5-6 million as the State pulls back federal Medicaid funding intended for counties. Additionally, it is believed the State will also renege on \$25 to \$30 million due to the County for prior year Medicaid expenses.

O'Neil highlighted the County's concerns about the Medicaid funding shortage and other unfunded mandates in a letter to New York State Governor Hochul earlier this week.

"With new costs coming down from the State, maintaining a solid fund balance is critical to managing and adjusting to external financial impacts on the County budget and finances. We will continue to carefully monitor the County's expenses and adjust to changing circumstances as necessary. We may be facing tough decisions ahead as New York State's fiscal climate is uncertain, and history has shown that the State often resorts to foisting its costs on to local governments, without regard to the impact on local taxpayers," O'Neil concluded.

## Applications being accepted for \$150 million Mid-Hudson Momentum Fund grants

Governor Kathy Hochul announced on May 17th the opening of the \$150 million Mid-Hudson Momentum Fund grant application for mixed-use housing and infrastructure projects throughout the Mid-Hudson Region. The fund implemented by Empire State Development represents a major commitment to increase the housing supply to meet growing demand and invest in key infrastructure projects in the region. Governor Hochul previously announced the Mid-Hudson Momentum Fund in February 2023.

"With its rich history, natural beauty, and cultural treasures, the Mid-Hudson region has long been a crown jewel for our state that has welcomed new residents and visitors for years," Governor Hochul said. "As the region continues to see an increase in population and visitors alike, the Mid-Hudson Momentum Fund will help communities address critical needs such as affordable and equitable housing and growing local infrastructure to make sure this region can continue to serve as a destination for families, workers, businesses and tourists."

Empire State Development President, CEO and Commissioner Hope Knight said, "It is imperative that we strategically address the growing demand for housing and infrastructure improvements throughout the Mid-Hudson Region. With informed input from our Mid-Hudson Regional Economic Development Council, this program will help to address and accommodate the surge of interest in this amazing area and help to sustain the region's growth well into the future."

Mid-Hudson Regional Economic Development Council Co-Chairs Dr. Marsha Gordon, President & CEO of The Business Council of Westchester and Dr. Kristine Young, president of SUNY Orange said, "Since the pandemic, we have welcomed thousands of new residents to our region which has exacerbated the demand for housing and upgrades to the existing

local infrastructure. The Mid-Hudson Momentum Fund will help address these needs and we look forward to ensuring approved projects are consistent with the goals and priorities of the region."

The Mid-Hudson Region has become a top destination for both tourists and new permanent residents, with more than 33,000 new residents moving to the region over the past two years alone. With regional housing stock availability of less than one percent last year, there is a pressing need for new development to support the influx of residents. The Mid-Hudson Momentum Fund will support mixed-use housing and infrastructure projects that will have lasting impacts in the region and that are consistent with the strategic goals and priorities of the Mid-Hudson Regional Economic Development Council's strategic plan. This includes projects that have garnered community support, will result in increased affordable housing, leverage non-state investment, are financially sound, and can begin quickly.

The \$150 million will be available for specific projects over a period of five years and will be split evenly between mixed-use housing projects and infrastructure projects. Awards will range from \$2.5 million to \$10 million per project and a minimum match of 50 percent will be required from non-state funding sources. Funds can be used for construction, expansion, and the rehabilitation of facilities, equipment and machinery, infrastructure and site development, and design and engineering related to construction. Eligible applicants include not-for-profits, municipalities, public benefit corporations including IDAs and LDCs and for-profit companies.

Submissions are due to ESD by July 28 at 4 p.m. to be reviewed by the Mid-Hudson Regional Economic Development Council shortly thereafter. Applications that are received after July 28 will be reviewed by the Mid-Hudson Regional Economic Development Council on a quarterly basis.

I think it was last year about this time that I shared one such sandwich that I made to take on our annual Mother's Day weekend trip. Well, I did it again, this time for a Mother's Day picnic by the river for the whole family and had enough to feed us all with leftovers. It all packed and traveled really well, and was tailored to accommo-

date everyone's tastes. Assembling the night before was not only easier but also allowed all the flavors to come together just in time to serve al fresco.

It's quite possible that you know by now that I love and adore picnics. I have them every chance I get and have for decades, so I can honestly say I know a thing or two about what to pack. While cheeses and charcuterie top my list, the sandwiches I sometimes opt for often reflect that preference, basically being all the things I love to nibble rolled into one handheld package. I still love grazing on a carefully put together cheese board with all the accompaniments, but more and more I like the ease of crafting a gourmet sandwich to take along instead.

If you're not sure what will work for packing perfection, taking a cue from charcuterie boards is a great place to start. Most things you'll find on one hold up well to travel, aren't overly messy to eat, and the flavors and textures complement each other. Think cured meats, pickled and fresh vegetables, coarse-grained mustard, spreadable and hard cheeses, fig jam, olives, roasted peppers. With these you get a variety of flavors and textures that play beautifully together so you really can't go wrong. In short, there are endless possibilities!

I find that making BIG sandwiches works best, as opposed to individual ones for each person. They assemble more quickly, the flavors marry better, and you just wrap up the whole thing to cut once you get to your destination. Trust me, it's just easier and better. Just make sure you pack the knife and cutting board.

If you're not sure what people's tastes are, it's best to make a few options to cover all

bases; but not to worry — this is easy too! For the last picnic I made two versions of one of the sandwiches. One had no onions, arugula, or tomatoes, three things I happened to know were not favorites for everyone but tend to be a pretty safe bet to omit even without this insight. I even substituted a few things for what I took out. Having two options (well, three with the exclusion version), meant everyone had a choice, and so most tried both, which was easy enough to do since they could also cut any size pieces they wanted.

The bread you choose is up to you, of course, but it also depends on what you're putting inside. Tomatoes and grilled mushrooms, for example, give off a lot of moisture as they sit, and oil-heavy dressings seep into soft bread for soggy results that can be hard to hold or, worse yet, hold together. For these situations I favor firmer, chewier focaccia, baguette or ciabatta and recommend putting a good layer of mayo (I like mixing it with pesto) on at least the side of the bread that will touch wetter ingredients. It acts as a barrier that will likely be enough to prevent a mess in the time before you're ready to eat. Another trick is to make sure any juicy stuff is in the middle so it doesn't touch the bread. And in case I didn't make it clear, you'll be using whole loaves, which makes the whole layering thing even easier. Even so, for any wetter ingredients it's best to use firmer bread. If you can't find any, you can always offer those ingredients that tend to be mess makers on the side or make your sandwiches only a few hours ahead. See? There's always a solution!

So my "messy" sandwich consisted of, in order of layering, pesto mayo (literally just pesto mixed with mayo), fresh mozzarella, black pepper salami, grilled portobello mushrooms, baby arugula, balsamic glaze, roasted red peppers, red onions, tomatoes, salt, and freshly ground pepper. The mushrooms gave off a LOT of moisture, coming from the sides of the sandwich and puddling a bit underneath, but this was easily remedied by wiping off the bottom before placing it on the cutting board to serve. Thanks to the ciabatta being so robust the bottom crust was absolutely fine — no sog and no one was any the wiser, but most importantly, it wasn't overly messy to eat at all. I promise!

As for the other crowd-pleaser, I went more old school-traditional: a good, old-fashioned mixed combo. This time I went with a big Italian loaf since none of the fillings would pose the moisture problem. The layers: mayo on both pieces (but just enough to make that barrier we talked about), ham, provolone, red onions, salami, turkey, tomatoes, shaved lettuce, salt, pepper and Greek salad dressing. You kinda can't go wrong!

Oh, and don't be afraid to pile on those toppings or even repeat layers! There's a good amount of bread to balance out, so as long as you can fit it in your mouth, you're good to go! It's also a good idea to bring along some extra condiments just in case. I brought the balsamic glaze, the Greek dressing and more pesto mayonnaise, as well as some mozzarella, tomatoes and roasted pep-

pers. We didn't end up using any of it but better safe than sorry, dry and flat in flavor!

Before assembling your sandwiches, I recommend centering the cut loaf on a piece of parchment atop a big piece of foil. These will wrap it all up and it's much easier this way than to heft those bad boys onto them after they're assembled. I like the parchment layer because things tend not to stick to it. And, if I'm feeling fancy, I'll tie some twine around it to try to elicit some ooohs as I transfer it to the cutting board (almost never happens but it still looks pretty). Once they are assembled, press down on the top crust to condense the whole thing a bit, checking for any stray fillings, especially helpful if you've piled them high, then wrap it as tightly as you can in the parchment before doing the same with the foil. My sandwiches were too big for one measly piece of foil, though, so it took a few to make sure all was secure. Then in the cooler they went and we were off!

And yes, these can be a meal in themselves, especially if you really load them up with a lot of good stuff. But feel free to serve salads alongside — fruit, pasta and/or green — or whatever else your heart desires. Just remember that you have to carry everything and that includes the plates and utensils you'll need. In a pinch, or if you just want to take it real easy but still eat well, I'd say all you really need is a sandwich, something to sip and someone to share it all with. I think that's a perfect recipe for good eating and a good time anywhere you happen to find yourself this soon-to-be hot summer. Enjoy!

# In search of lost bees

Mark looks up and discovers a pollen source that is the 'bee's knees.'

My friend Joe was worried. I was sitting with Joe at an open mic night at La Puerta Azul restaurant, and for some reason we started talking about honeybees. Joe has a couple of hives – I have one – and he's telling me he hasn't seen any of his bees on blossoms in his yard. No bees on dandelions, clover, buttercups, daisy fleabane, or any of the random weeds that bloom this time of year.

"Are the bees coming and going from the hive?" I asked.

"Yes," Joe answered, as somebody strummed a Simon and Garfunkel song in the background, "but I'm afraid they're not finding any nectar, so they might get hungry enough to abandon the hive."

That can happen. I was intrigued, so decided to check on my bees the very next morning.

The typical backyard honeybee hive is home to 50,000 female "worker" bees, a few hundred male "drones" (which don't do any work) and a queen bee. The workers travel up to two miles in search of nectar, used to make honey, and pollen, to feed the next brood of workers. As they forage, the bees pollinate the flowers, wearing themselves out in as little as 30 days. It takes 12 bees their entire lifetime to make one teaspoon of honey. Think about that the next time you sit down to a bowl of Honey Nut Cheerios.

Of course, honeybees are not native to the Hudson Valley. Neither are dandelions or clover.


There was a time a few years back when people were worried that feral honeybees would overpower our 400 species of native bees. And that dandelions would take over our front yards. (The "No-Mow-May" movement is designed to help pollinators. I embrace it wholeheartedly).

So late Friday morning, I went out to check my dandelions for bees. Honeybees come out when the temperature is above 55 degrees. It was a cool morning, and the bumble bees came out earlier. They like dandelions, and especially clover. But as the honeybees emerged, they flew right past those flowers and off into the distance. Later in the day I could see them returning with their pollen sacks full, (located on their hind legs) so I figured they must be having success.

Two miles – that's quite a distance to cover, but I couldn't let Joe down. I just had to find out where those bees were dining. Off I went into the neighborhood. Honeybees love apple blossoms, crab apple, Japanese cherry, and lots of other spring blooming trees. But they were all out of bloom by mid-May. And the summer favorites like daisies, coneflowers, lavender, zinnias and sunflowers, not to mention fall blooming asters and goldenrod, were nowhere in sight. As I traipsed down the road, waving to the neighbors as I inspected their gardens – "Just looking for bees!" I struck out on the roses, irises, even the baptisia, which is supposed to be a favorite. A few azaleas were still in

bloom, but I've heard they're poisonous to bees.

At last I saw a few honeybees, on garden sage and catmint, two of the most incredible pollinator flowers. But how could these few plants in my neighbor's garden support 50,000 bees? Each bee visits up to 100 flowers a day. Do the math.

Then I looked up. A towering black locust tree was looming overhead, dripping with broodingnagian panicles of scrumptious blossoms. Then I looked down the street, and into the forest beyond. Dozens of black locust trees were swarming with honeybees. I hadn't

noticed because I'd been looking close to the ground. Evidently, the bees were ignoring the dandelions and clover only because they prefer the black locust blossoms.

I couldn't wait to tell Joe. Next night at the open mic I yelled over the din of somebody playing a Def Leppard song, "Hey, Joe! Are there any black locust trees growing within two miles of your house?"

# that's italian!



I can remember when I was young, many members of my family had funny names. I did not realize until much later in life that these names were not their given names, but rather nicknames. In Italian-American culture nicknames, even though to others they may seem harsh and cruel, are given with love.

There were many people that my father did business with that had nicknames. Naturally, many were Italian. One man in particular was a glassmaker. His name was "Mimi mangia fico" which means "Dominic who eats figs." Another man, from whom we would buy seafood for the restaurant, was named "Cimitero," which means cemetery or gravedigger. I never knew what his real name was.

To "Medi-gans" (Americans), use of nicknames may bring to mind organized crime due to negative media portrayal. Names such as "Scarface" Capone and "Fat" Tony Salerno denote a certain type of gangster. From my personal experience, I can say that within the Italian-American culture nicknames have a much sweeter significance.

Nicknames served a very good purpose. In Italian culture, there are very strict traditions for naming children. The first-born son is to be named after his paternal grandfather, and the second-born son is to be named after his maternal grandfather. Likewise, the first-born daughter is to be named after her paternal grandmother, and the second-born daughter is to be named after her maternal grandmother. The children that follow, "Lord willing," are to be named after their godparents, not to mention the naming of children after patron saints.

Now, you do the math. With everyone in a town having at least one Anthony in their family, every family will have a first-born Anthony. Obviously this leads to tremendous confusion when families and communities are gathered and talking to and about one another. "Hey did you talk to Anthony?" I asked Anthony. "Which one?" Anthony asked, and so on.

Therefore, there is actually a desperate need for nicknames.

The most basic form of nickname assignment is the tag of "Big" and "Little" added to the oldest and youngest carriers of a name. Although, since most Italian families are so large, this isn't always sufficient, so nicknames have to rely on other characteristics. My oldest brother is named Nick. My oldest male cousins are also named Nick. Now, all three Nicks are the same age, same last name and went to the same school. How are they differentiated? Easy: "Big" Nick, "Little" Nick and "Middle" Nick.

When it comes to how certain nicknames are chosen for people, there are different sources and reasons. The most common categories that nicknames form out of are: a prominent physical feature, a unique behavioral trait, an interesting habit, an occupation, a place of origin, a favorite food, or a past

memorable incident that pertains to the person being nicknamed.

There are deeper explanations as to why and how people are nicknamed. My nickname is "Vacca," which means "cow." When I was younger I was, and still am, chubby. The name stuck and still sticks today. Some other nicknames that I have run into are Piezzuccio (the One-eyed), and Scugnato (the Toothless).

The occupation that a person has is another efficient way to identify them. Some old professions that made good nicknames for the times were Suararo (Corkmaker) and, of course, Cimitero (Grave Digger).

The use of nicknames runs deep in my family. We affectionately call each other nicknames, and we refer to others by using nicknames that we assign to them. It is not necessarily that our nicknames are derogatory, but it is more that we feel that most people don't understand our innocent tradition, and they might even think we are crazy.

The people outside of our family that know us well, and that we feel comfortable with, are well aware of our nicknaming fetish. We are actually well known for this practice. We nickname our pets and even other people's pets!

This crazy nickname obsession can't help but spill over into our "beyond family and friends" worlds. At college all of my friends point out that I had a nickname for everyone and everything. We even use nicknames for our food. "Scharole" is a nickname for escarole but also for money. Capicola, which is an Italian spicy ham, is called "Gabbagool." A cucumber is a "Chidrool" which also means someone who isn't the smartest.

It is pretty obvious that in the Italian-American culture, the tradition of nicknaming misses nobody. Even the historically infamous former Mayor of New York, Fiorello La Guardia, had multiple nicknames: The Little Flower, Little Napoleon, The Great Infallible, Midget Mussolini and, last but not least, the nickname that, years later, has been applied to another former New York mayor, Rudolph Giuliani: Il Sacro Terrore (The Holy Terror).

Nicknaming is just another way for Italians and Italian-Americans to show love.

And what do they do better? For me it is just another heartwarming answer to why I am the way I am. I am just glad that we could share this warm, unifying custom with the rest of the world. So while you think of different ways to nickname the people of your family, enjoy this recipe of Escarole Soup, otherwise nicknamed "Italian Wedding Soup."

Buono Appetito! Ciao!

### Ingredients

#### Meatballs:

- 1 small onion, grated
- 1/3 cup chopped fresh Italian parsley
- 1 large egg

# Nicknames

1 teaspoon minced garlic  
1 teaspoon salt  
1 slice fresh white bread, crust trimmed, bread torn into small pieces  
1/2 cup grated Parmesan  
8 ounces ground beef  
8 ounces ground pork  
Freshly ground black pepper

#### Soup:

12 cups low-sodium chicken broth  
1-pound curly endive, coarsely chopped  
(1 pound of escarole would be a good substitution)  
2 large eggs  
2 tablespoon freshly grated Parmesan, plus extra for garnish  
Salt and freshly ground black pepper  
1 lb of tubetini pasta

#### Directions

To make the meatballs: Stir the first 6 ingredients in a large bowl to blend. Stir in the cheese, beef and pork. Using 1 1/2 teaspoons for each, shape the meat mixture into 1-inch-diameter meatballs. Place on a baking sheet. Bake meatballs for 20 minutes at 350 degrees.

To make the soup: Bring the broth to a boil in a large pot over medium-high heat. Add the meatballs and curly endive and simmer until the meatballs are cooked through and the curly endive is tender, about 8 minutes. Add the pasta and allow to cook for 6 minutes or until the pasta is tender. Whisk the eggs and cheese in a medium bowl to blend. Stir the soup in a circular motion. Gradually drizzle the egg mixture into the moving broth, stirring gently with a fork to form thin stands of egg, about 1 minute. Season the soup to taste with salt and pepper. Add in your hot meatballs.

Ladle the soup into bowls and serve. Finish soup with Parmesan cheese, if desired.

The night continued to emphasize togetherness through its fundraising efforts. The combination of sponsorships, tickets, silent


and live auction, and a mission moment that received one hundred percent participation, raised over \$173,000 for the organization, becoming the most successful CPCA event in recent history.

## Registration is now open for free rabies clinic June 4 in East Fishkill

The Dutchess County Department of Behavioral & Community Health (DBCH) will partner with the Dutchess County SPCA to host a free rabies vaccine clinic for pets on Sunday, June 4th at the Town Center Park Pavilion at 71 Town Center Blvd in East Fishkill from 8 a.m. to noon. Free parking is available on-site. Registration is required, walk-ins will not be accommodated. Registration will open on Wednesday, May 17th at DCSPCA.org. Registrations can also be made by calling the DCSPCA at 845-452-7722, ext. 425.

The clinic will offer Dutchess County residents the opportunity to obtain rabies shots free of charge for their dogs, cats, and domestic ferrets 3 months of age and older. Proof of residency is required. Non-

residents will be charged a fee of \$10 per each pet vaccinated. All dogs must be on a leash, and cats and domestic ferrets must be in carriers. Vaccinations will be good for three years for pets with proper proof of prior immunization. For those without proof, the vaccination will be good for one year.

Rabies vaccines are required for all cats, dogs, and domestic ferrets by the age of four months by New York State law. Animals must always remain up to date on rabies shots. Vaccination is required on a regular schedule to keep the animal properly immunized against the rabies virus. Owners can be fined up to \$200 if they fail to get their pets vaccinated and keep them up to date.

Rabies vaccinations are important for

protecting the health and well-being of a pet. If an animal that is unvaccinated or not up to date on its rabies vaccination fights with a rabid or suspect-rabid animal, the pet must be promptly destroyed or placed in quarantine for six months to protect other animals and people in case the pet develops rabies. These mandates do not apply to a vaccinated pet in the same situation. In such cases, only a booster dose of rabies vaccine would be given within five days to treat the pet.

The Dutchess County Department of Behavioral & Community Health is available 24/7 to assist with any questions or concerns regarding potential rabies exposure to people or domestic animals. Pet owners should report to DCBH with any

incident in which their pet has been bitten by or has an open wound exposed to the saliva or nervous tissue of a domestic or wild animal. Staff will investigate and advise the pet owner of any necessary steps they should take to ensure the safety of their animal.

DBCH ask residents that see an animal acting strangely to contact their local police agency. If a person has been bitten, or a domestic pet is bitten or is in contact with any animal, contact DBCH immediately at 845-486-3404 Monday through Friday 9 a.m. – 5 p.m., or 845-431-6465 on nights and weekends.






