Memorial Day gives one time to reflect on the sacrifices made by veterans who made the ultimate sacrifice. It is also a time to remember the Gold Star Families and what they have sacrificed for this country.

“Memorial Day is important to all of us because we all make sacrifices, but some more than others. And we all need to be

cognizant of that,” remarked Kevin Hathorn, president of the Wappinger Town Veterans Advisory Group.

Hathorn served in the U.S. Navy from Jan. 1968 to April 1972. He was in the Aviation Navy, in VA37 attached to the USS Saratoga, aircraft carrier.

“I was a plane captain, reaching the rank of E5,” said Hathorn. He noted that the Wappinger Veterans Advisory Group

is celebrating the day with the Town of Wappinger family at Schlathaus Park.

“Memorial Day is important for the community to gather to remember the ultimate sacrifices made by our Veterans and not to celebrate the ‘Memorial Day Sales Event.’ Veterans take an oath to protect and serve our great Country from all her enemies whomsoever. The oath some

## WCSD voters approve 2022-23 budget, choose BOE members

The registered voters in the Wappingers Central School District (WCSD) approved the 2022-23 school year budget. The vote was held on May 17. WCSD Board of Education members Marie Johnson and Eddy Slosower were re-elected to another term. Cheryl Migatz was also elected to the board.

“We are very grateful to the Wappingers CSD community for supporting all four of our propositions which will provide our students with the necessary programs and services to reach their highest potential,” said Dr. Dwight Bonk, WCSD Superintendent. “The additions made in the areas of safety, student mental health and wellness, expanded opportunities for academic intervention services and increased student activities that were included in the 2022-23 School Budget will be most beneficial to our students and faculty.”

Voters voted 3,924 Yes to 2,204 No regarding Proposition 1, the budget. According to the District’s budget information, the budget remained within the tax cap at \$265,714,022.

According to Bonk, some of what the budget provides for is:

- Additional 14.4 positions to support health and wellness for students and staff (i.e.: social workers), ENL teachers, special education, counselors, nurses, office staff, and Safety and Security Officer (SSO) at WJHS (Wappingers Junior High School) and VWJHS (Van Wyck Junior High School)
- School Resource Officer (SRO) at WJHS and VWJHS
- Additional 4 custodial positions for District buildings as well as overtime for activities and event coverage
- Boys volleyball and Girls modified lacrosse teams added (coach, supplies, etc.)
- Marching band at RCK (Roy C. Ketcham High School) and JJHS (John Jay High School) (stipends, supplies, etc.)

Proposition 2 was also approved by the voters. Proposition 2 was regarding the Capital project. It passed 4,080 Yes to 2,065 No.

“The approval of the Capital Improvement project will enable the District to complete necessary work throughout our 15 buildings in the areas of safety, infrastructure and other necessary upgrades,” said the superintendent.

666 in Beacon.

Delamater stated, “I proudly served in the United States Marine Corps from 1970-1974 and was stationed in Nam Phong, Thailand for twelve months during the Vietnam War. We built the combat air base which was code-named Rose Garden because of the austere conditions. During that time, we lost several aircrews in combat.”

Hathorn remarked, “Not only younger generations, but older Americans need to understand the meaning of the word “sacrifice” when a person agrees to defend our country whenever told to.” He will be reading the names of veterans buried in the Town of Wappinger cemeteries during the Ceremony at Schlathaus.

VFW Post 666 will join with the American Legion Post 203, Marine Corps League Det 861, Nam Knights MC and Guardian Revival on Monday, May 30 for Memorial Day services. The first service

will be 10 a.m. at the E. Main St. bridge to honor service members lost at sea. There will then be a ceremony at 11 a.m. at the Veterans Memorial Building, 413 Main St. in Beacon.

“The younger generations sometimes have a relative or friend serving in the Armed Forces both past or present. We try to make the conversation personal and tell folks exactly what the service person’s job entails and what it is like to travel the world at the government’s expense. Depending on the person’s age we will show photos and personal gear of service members. We stress the sacrifices made and the rewards gleaned – freedom,” said Delamater.

“This Memorial Day I will remember the air crews lost (KIA/MIA) while flying combat missions from the Rose Garden during the Vietnam War. They are never forgotten,” said Delamater.

# Johnson, Migatz, Sloslower voted to BOE

Proposition 3, which was the Bus proposition, passed 3,940 Yes to 2,214 No. The \$2.2 million is to replace 22 buses. The twenty-two buses being replaced have over 134,000 miles or are 11 years of age, according to district officials. By law, every five years, the school district must audit its facilities Bonk previously stated.

“As we have the largest District-owned and operated Transportation Department in New York State, the support of the Bus Replacement Purchase will allow us to maintain a fleet that is safe and serves the students of our District on a daily basis,” remarked Bonk.

Proposition 4, the Givens Lane lease, was passed 4,558 Yes to 1,530 No. The Wappingers Central School District owns two parcels of land at Givens Lane in the Village of Fishkill. In 2001, the District determined that the property was not useful for school district purposes, and has since leased the property to the Village for \$1 a year. The property is currently a public parking lot behind Fishkill Tire, providing 32 parking spots in a congested area. The Village maintains and insures the lot at no cost to the District,” Bonk explained previously. He added: “The lease approval for Givens Lane is of mutual benefit to the Village of Fishkill, our community as a whole, and is an

example of the collaboration and leverage of resources that exist between our District and local municipalities.”

Migatz received 3,545 votes. Sloslower had 3,393 votes. Johnson received 3,243 votes. The other candidates received the following number of votes: Keri Cahill, 2,185; Virgil Capollari 2,057; Daniel Pena 1,723; Anthony Ciro Dilullo 1,182 and Ariana Dingman 752.

“I would like to thank everyone in the WCSD community for their support in re-electing me to the school board. We still have much to do in helping all students navigate through these difficult times, but I am confident that working together we can get past this. Moving forward I also hope that all stakeholders can work together as we face challenges ahead in education, improving our infrastructure and the burden this may cause to taxpay-

ers,” emailed Sloslower after the election. “I am confident that this community has the ability to rise up and support the needs of our students and all residents.”

Sloslower added: “Again, thank you for your confidence in me as board trustee.”

Johnson and Migatz did not respond to an inquiry for comment on the election results.

The results are preliminary results.

## Dutchess to participate in statewide STOP-DWI Memorial Day crackdown

Dutchess County Executive Marc Molinaro announced police agencies throughout Dutchess County will participate in a special enforcement effort to crack down on impaired driving during Memorial Day weekend. The special enforcement began on Friday, May 27, and will conclude on Tuesday, May 31. The Dutchess County Sheriff’s Office, New York State Police and municipal law enforcement agencies will join agencies across the state and will be out in force in this coordinated effort to aggressively target those who put lives in danger.

Research shows high visibility community engagement campaigns can reduce impaired driving fatalities by as much as 20 percent. Sobriety checkpoints play a key part in raising awareness about the problem. Law enforcement agencies throughout Dutchess County and the state will be out in force in this coordinated effort to reduce the number of alcohol-related injuries and deaths.

The Memorial Day crackdown is one of many statewide high visibility community engagement campaigns promoted by the New York State STOP-DWI Association. The statewide STOP-DWI engagement campaigns also target Labor Day, the Super Bowl, St. Patrick’s Day, Halloween, Thanksgiving and the national holiday season in December.

While STOP-DWI efforts across New York have led to significant reductions in the numbers of alcohol and drug related fatalities, still too many lives are being lost because of crashes caused by drunk or impaired drivers. Highly visible, highly publicized efforts like the STOP-DWI High Visibility Community Engagement Campaign aim to further reduce the incidence of drunk and impaired driving.

## Remembering those who served

### To the Editor:

December 7, 1941, changed the face of America as never before or since. Just recovering from a devastating depression and facing a long recovery, we were at war! All men between the ages of 18 and 25 were required to register for the Draft, or Selective Service. They were called to serve their country and participate in a brutal war. The draftees were chosen by lottery and when called to service were placed in the United States Army... many stepped up and volunteered to serve other branches of the military. Our young men signed up in droves, brothers, cousins, friends and classmates joined. It has been said that the village of Wappingers Falls sent more men to war per capita than any other village of comparable size in this country.

Franklindale Ave. alone sent more than 22 men into service of America. Many families sent two of their sons to fight into this indescribable war effort. Some had never left Dutchess County and were leaving home for the first time in their lives. Some had never been on a train, definitely not an ocean liner or airplane! Those families with men serving proudly displayed a small flag (about 8"x10") with a blue star for each military member. Sadly, the stars changed to gold as their beloved sons were killed in action. My grandmother proudly displayed her flag with one blue star and one gold star. Her two sons, Sergeant Carmine Di Domizio and Major Francis Di Domizio were both in the Air Force. Carmine was killed on a bombing mission over Germany and Fran was captured when the plane he was piloting was shot down over Yugoslavia. He remained a prisoner of war until his camp was liberated by General Patton's army at the end of the war.

As Charles Dickens said in "The Tale of Two Cities," "It was the best of times, it was the worst of times." The face of America changed, patriotism flourished, and so did compassion, unity and generosity! There were jobs to be done at home to support our troops! Some, too young or too old to join the military, women and even schoolchildren joined forces to support our troops and provide them with all the necessities need-

ed along with love and moral support. Our local factories changed production lines to fill military orders. Beacon factories made flotation jackets, Air Force leather jackets and Army blankets. Sweet Orr produced Navy uniforms. Boy and Girl Scouts collected aluminum foil, tin cans and bought savings bonds at school, \$0.25 cents at a time!

America was at its greatest and proud. We were "one nation under God. Indivisible with liberty and justice for all."

## Anderson Center for Autism introduces Anderson Early Learning Academy

Months after opening its first preschool in Stanfordville at Cold Spring Elementary School (September, 2021), Anderson Center for Autism has finalized a name and brand for the early childhood program: Anderson Early Learning Academy. Along with officially naming its preschool, the executive leadership team at Anderson also unveiled a logo for the Academy.

"Anderson Early Learning Academy's brand is the result of a very deliberate process that involved many of our team members. We think it captures the heart of our efforts to provide an exceptional learning experience for children in a warm, nurturing atmosphere," said Patrick Paul, CEO/Executive Director of Anderson Center for Autism.

Paul explained that Anderson Learning Academy serves children ages 3-5 with behavioral characteristics of autism and related disorders.

Rooted in the principles of Applied Behavior Analysis, Anderson Early Learning Academy incorporates occupational therapy, speech therapy, and physical therapy, along with special education, into its evidence-based program. The classrooms include a self-contained special education room as well as an integrated setting. Both offer learning and therapeutic experiences customized to the needs of each individual child. Families of enrollees participate in regular team meetings and also have opportunities for

in-home education and support to ensure that the skills being taught can be generalized to each student's home environment.

Added Dr. Tina Covington, Chief Operating Officer at Anderson Center for Autism, "We developed the idea for an early learning program as our response to a tremendous need that had existed for far too long in the Mid-Hudson Valley. The early childhood years are a critical time during which proper education and interventions can maximize long-term potential for success. This is true not only for neurotypical children, but especially for the neurodivergent population. We are so proud of what we have created at Anderson Early Learning Academy, and look forward to expanding our efforts in the years to come."

Anderson Center for Autism, which is a nonprofit organization, also offers educational, vocational, and residential services to people with Autism Spectrum Disorder on its Staatsburg campus and offsite throughout Dutchess, Orange, and Ulster Counties.

Noted Paul, "Anderson Early Learning Academy reflects a broader organizational goal of providing a continuum of service across an individual's lifespan. We want to do all we can to enrich life for people impacted by autism and their families - at every age and stage." # Veteran biker events coming up in June

The weather is certainly turning warmer, and it feels like summer is right around the corner, doesn't it? That means we will see a lot more motorcycles on the roads, especially on the weekends. I'm a biker myself, and I know the unique pleasure of getting out on the open road for the first time in a season.

Did you know motorcycle culture in the United States was actually started by veterans? It's true. After World War II ended, thousands of surplus military bikes were shipped back home from Europe. Veterans returning from war took these surplus bikes – some complete, some needing parts – and started their own motorcycle clubs across America, creating custom bikes from all the surplus spare parts available. These clubs came up with colorful names that mimicked the names of different fighter squadrons that became infamous during the war; for example, in 1948, a veteran named Otto Friedli started a club in Fontana, California called the Hell's Angels, whom you may have heard of.

These clubs started out as a way for war veterans to stay connected and share their experiences with other veterans. Of course, since those early days, motorcycle clubs have sometimes been given a nasty reputation, thanks to movies and TV. # DC Office for the Aging's Senior Picnics back in-person

After adapting in 2020 and 2021 to serve thousands of local residents at drive-through picnics throughout Dutchess County, the County's Office for the Aging's (OFA) Summer Picnic Series returns for its 30th year with traditional sit-down events that will serve thousands of residents throughout this summer.

The OFA will host 12 picnics in communities throughout the county, beginning June 1st at Thomas Boyce Park in Wingdale. Picnics take place on Wednesdays through Aug. 31st – each picnic begins at noon – and the full schedule of picnics is available online at [dutchessny.gov/ofapicnics](http://dutchessny.gov/ofapicnics).

OFA staff is sending thousands of

reminder cards to residents 60 years of age and older, encouraging them to attend the free event in their local community. OFA staff continues to mail reminder postcards to older adults throughout the county, though the postcard is not required to make a reservation.

Proof of residency and advance reservations are both required, and space is limited; walk-ins cannot be accommodated. There is a \$8 charge for each non-resident guest and those 59 or younger. Space is limited at each picnic, and residents who wish to reserve their space at the picnic are encouraged to call 866-486-2555 during office hours.

In addition to providing picnic atten-

dees a complimentary, nutritious meal and live music, volunteer members of the Medical Reserve Corps (MRC) of Dutchess County provide attendees information about safety and preparedness, and attendees can also meet representatives from other Dutchess County Government departments and divisions that serve them. MRC members will also assist representatives from the Dutchess County Sheriff's Office and the Dutchess County Traffic Safety Board in collecting attendees' unwanted or unneeded medications for safe disposal. In 2021, the County 412 pounds of unwanted/unused medication at the OFA's 12 picnics.

Each of the past two years, the OFA's

drive-through picnic model served more than 4,000 residents – more than ever in the decades-long history of the Summer Picnic Series.

The OFA plans, coordinates and provides an array of community-based services to older adults and persons who require assistance in the long-term care system, in an effort to promote independence, dignity and quality of life. OFA offers an array of programming that provides socialization, recreation and fitness opportunities for older adults to remain active and energized. ### Renegades drop series-ending doubleheader

The Hudson Valley Renegades were swept by the Brooklyn Cyclones in a Sunday afternoon doubleheader at Maimonides Park, losing the opener 5-4 and the nightcap 3-1.

The Renegades are now 17-21 overall.

# An inside look at the variety of staff duties

Every week, Hudson Valley Renegades President Steve Gliner sits down with reporter Rich Thomaselli to discuss the team in particular, and minor league baseball in general.

**Steve, are there any issues that you find yourself and the staff needing to address – from a team perspective or even minor league baseball as a whole – when the team goes on the road?**

That's a great question. Let's put it this way – even on days when we don't have a home game, from the time I get in until the time I leave, there are some days I don't even go for lunch. To narrow it down, when the team goes on the road it's a lot of catch-up on things that just don't get attended to on game days.

For instance, we have surveys from Major League Baseball that they hit us with that we have to fill out and get back to them. There are a lot of emails, a lot of ticket requests. We have to get information out to the visiting team and the umpiring crew who are coming in for the next homestand. We're looking at marketing strategies and how we can improve and how we can promote the team. For instance, we're starting a big billboard campaign this week. An off-day at the

Stadium is when I'm home before 7 o'clock. If we don't have a game at night and I'm home for dinner, that's a triumph (laughs). There's just a lot of moving parts.

**So I'm guessing that makes Michelle (Steve's wife) a saint then.**

(Laughs) Oh gosh. And you know the interesting thing is, she's a teacher, so our schedules are really opposite. She's off during the summer and I work nights. But she loves to be around people so she actually comes to Dutchess Stadium and works the beer garden on Fridays, Saturdays and Sundays. Plus the kids are grown now and adults, so it's a little easier from that standpoint as well. She's been incredibly supportive over the years of my career. It's not easy when you work the large number of hours that we do. When I did spring training in Fort Myers (with the Minnesota Twins) and then a full season of minor league baseball right after that, we did that for 13 years when the kids were younger. I'm very lucky that my family has been so supportive of my career.

**Especially during the week when the team is on the road, does the staff still meet on a regular basis to discuss what went right and what needs to be**



**addressed?**

Oh yeah, we actually circle back quite often. We do production meetings every Tuesday and Friday for homestands. We use that as an opportunity to say we need to pay more attention to this or that. It's not criticism, because our staff is amazing. It's more of a reminder than anything of here's what's

important to stay ahead of. We also do nightly production meetings with video staff, with game-day staff. There's a lot of gears spinning and it's important to know what's coming. It's important to communicate. I think most people would be incredibly surprised at how many moving parts there are with our

operation. Some people think we show up a month before the season and just open the gates. You have to be prepared for what's ahead because it comes at you fast.

**And you have the people in place for that, I assume?**

Oh, we increased our front office staff from eight last year to 19 this year. Honestly, I'm not sure how we made it through last year with just eight. We are really staffed up to where we should be now. From a game-day perspective, food and beverage alone is 100 employees. Not all 100 are on duty every single game but there's 100 on the roster to work. Then you have ushers, ticket takers, parking attendants, and there's about 60 on that roster. We're pushing close to 200 employees combined between fulltime and part-time. There are a lot of different departments that have to be covered and covered properly.




One of the observation posts for the Ground Observer Corps (GOC) was on the Village of Fishkill and Town of Fishkill border.

According to the groundobserver corps.com, "While the Ground Observer Corps officially started in 1951, the Air Force began running test operations in

1950s." The Ground Observer Corps was the local contact for any UFO reports and other unusual activity, according to the site. They worked with the Air Force's 4602nd squadron to locate downed aircraft and other unidentified aircraft, it states.

"They had binoculars, little pictures of

every plane to identify them and a hotline phone to some government location," recalled Town of Fishkill Deputy Supervisor Hal Brilliant. "A lot of volunteers signed up to do their duty." Brilliant recalled his grandmother, Lenore Hay, taking him there.

According to groundobserver

corps.com, "[T]he Air Force launched Operation Skywatch to expand the program and get more recruits. An integral part of civil defense, the GOC comprised of an estimated 800,000 members who volunteered for shifts at local observation posts and filter centers that tracked aircraft reports."

# Sandwich solutions

Bring these on a picnic or hike for a satisfying meal on the go.

It feels like forever since I last wrote due, in part, to a bout with COVID, but that's all behind me now and I'm just fine. Originally I had a mind to write about food in the time of pandemic, but since I've moved on from that I'll just let it rest and write about getting back to normal and the fine art of living.

By the time you read this I will have returned from an annual mother/daughters trip to Brimfield, Massachusetts, a tradition that began ten years ago. It's always an adventure and a lot of fun, but that has less to do with the town-wide flea market that is Brimfield and everything to do with quality time spent with my mother and sister, something we don't get to nearly enough.

Stealing away with my two favorite women is a special treat. We leave early in the morning, stopping for coffee and breakfast and arriving at our final destination before 10am, plenty of time to enjoy browsing the many vendors of collectibles and vintage wares before checking in to our hotel.

Also, part of the tradition is a nosh of cheese to accompany martinis before we go to a nice dinner. We've been doing this long enough that we've had a lot of culinary adventures, some great and some not so good, but all have been fun. It's all in

how you see it and we're just so glad to be together that we can make the most of anything. Perspective + quality time = a good time had by all!

Lunch breaks while in the throes of our shopping has often been a stop at one of the very crowded food vendors, but we've found a way around that, and that's what this is really about. Last year we went back to the car and made a lunch of the cheese and charcuterie usually reserved for our pre-dinner tradition. It turned out to be the perfect thing to do. We got to rest in the shade, change shoes, rehydrate and avoid the crowds for a while. It was pretty much bliss, especially since we had an early dinner out of town, and so not filling up beforehand worked out beautifully.

So, this year I made sandwiches to fill that particular need. I wanted to share them with you because they are perfect for all the outdoor living, you're sure to do this time of year. From picnics to hikes, these fit the bill. Made ahead of time and without anything overly perishable, they pack well and are better if made the day before. They're also pretty healthy and will satisfy without leaving you so stuffed that you need a nap. You'll get flavor and the energy you need to fuel adventures of your own. They are, quite possibly, the perfect take-along meal.

### PERFECT PICNIC SANDWICHES

These are infinitely customizable. You can make them vegetarian if that's what you prefer and add whatever you like. I also love omitting the salami and replacing the arugula with sauteed broccoli rabe. Pesto is great on these, too. This is my favorite combination and well-suited to an active day of treasure hunting. They're best made a day ahead, which gives the flavors a chance to marry, and the limited dressing - in this case good quality olive oil and thick, sweet, rich balsamic glaze - time to soak into the bread without making for a soggy handful.

### INGREDIENTS

- 1 baguette
- Olive oil
- Red peppers
- Fresh mozzarella, sliced
- Portobello mushrooms, sliced
- Fresh basil leaves
- Salami (I use pre-sliced)
- Baby arugula
- Balsamic glaze
- Salt and freshly ground pepper

### METHOD

The next two steps can be done 1 day ahead.

### ROAST THE PEPPERS:

With the oven rack in the highest position, preheat the broiler. Line a baking sheet with foil.

Place red peppers (I used 4) upright on a cutting board. Cut each one from the top down around the stem. Most peppers will yield 4 pieces and you'll avoid the seeds this way. Cut away any white membrane inside each piece and place, inside-down, on the baking sheet. Broil until skins blacken, turning the baking sheet for even roasting. When blackened, remove from oven and place pieces in a plastic bag. The steam will loosen the skin so that, when cool enough to handle, they'll come off easily with your fingers.

### SAUTE THE MUSHROOMS:

Preheat a (preferably cast iron) skillet.

Place sliced mushrooms in the hot pan and cook over medium-high heat until they start to release liquid. Flip and continue cooking until soft and slightly brown. Set aside.

### ASSEMBLE THE SANDWICHES

Cut the ends off the baguette, then cut the loaf into 3-4 equal pieces. Slice each piece in half and drizzle with olive oil.

Lay roasted red pepper pieces on bread. Add a layer of mozzarella, then basil, mushrooms, salami, and arugula. Sprinkle generously with salt and pepper.

### WRAP 'EM UP:

This part is key. Lay a piece of foil on the counter. Add a piece of parchment and place one sandwich on top. Wrap sandwich very tightly in parchment. (If you want to be extra fancy, tie with a piece of twine.) Then wrap tightly in foil, crimping the ends to tightly seal. Refrigerate.

When you're ready to hit the road, place wrapped sandwiches in a cooler and let your adventure begin!

For your next outing, give this a try. I think you'll find, as we did, that it's your new go-to for picnics, a day at the beach or for any time you want something easy, delicious and truly satisfying. You're going to have plenty of fun outdoors so make sure you're well fueled for whatever you do with those you love best. Now get out there and start living! Enjoy!

## You'll love dude ranches, kayaking and hiking

While travelers are eager to get back out there in the travel universe, we're still hearing concerns about overcrowding.

Sure, if you're going to a major theme park or a large beach resort, you must expect that there will be a lot of other travelers.
