For many children and teens, summer months mean camp. The Fresh Air Fund (The Fund), according to the youth development organization's information, "provides life-changing summer experiences for children from underserved communities in New York City. Each summer, thousands of children attend camp to

explore nature, enjoy the outdoors, and build valuable interpersonal skills." The Fresh Air Fund's Sharpe Reservation, a 2,000-acre property in Fishkill, is the location for five of The Fresh Air Fund's six camps, states the organization. Sharpe Reservation opened in 1949.

It was at Sharpe Reservation where a trail rededication ceremony for the Sharpe

Audubon Senior Services (SASS) Wilderness Trail was held recently. There was a time to remember Gloria Hanrahan, who died in 2019, who led the project for the SASS Wilderness Trail.

Timothy "Tim" Stanley is the Director of Sharpe Reservation.

HV Nurses Honor Guard: A passion for caring Local chapter seeks new members

Karin Graham, an operating room nurse at Northern Dutchess Hospital in Rhinebeck, remembers a poignant moment. She had just lost a dear friend and colleague and members of the Hudson Valley Nurses Honor Guard were on hand at the wake to provide a moving tribute.

"It was so touching. I was immediately taken, it was so beautiful," she said. "I wanted to be part of that group. This would be my way to honor and respect my colleagues in the nursing profession."

The Hudson Valley Nurses Honor Guard is a group of volunteer nurses who honor and pay tribute to other nurses. They note that



WCSD voters approve budget

Wappingers Central School District (WCSD) voters approved the 2025-26 budget. The election for the proposed budget and Board of Education trustees took place on May 20.

"We are very grateful for your continued support of our budget and propositions," WCSD Superintendent Dr. Dwight Bonk stated on the school district's website.

The following are the unofficial results from the WCSD.

Budget Vote outcome

Yes 2,048

No 832

Bonk stated before the election, "The 2025-26 budget will have one of the lowest tax levy increases in our region at 1.3%. For the fourth consecutive year, the budget will also be below the tax cap, which is 1.57% for our District. The 2025-26 budget continues to support the programs and services that our students need and deserve, while remaining fiscally responsible to our taxpayers."

Votes for Capital Project

Yes 1,934

No 973

"I am also very excited to share information on the Capital Project Proposition. As I shared in my presentation to the Board of Education on February 10th, approval of this project will allow the District to meet the evolving needs of our families. An addition to our middle schools will both increase opportunities for our 6th graders and create room in our elementary schools for improved Academic Intervention Services, Special Education, ELL (English Language Learners), and so much more. The Proposition also includes essential upgrades to our buildings and athletic fields, which will benefit our students and community," commented Bonk before the election.

"The SASS Wilderness Trail is an 8-mile loop that circumnavigates the 1,800-acre perimeter of Sharpe Reservation. Originally constructed by the Suffolk County Girl Scouts and completed in 1969, the project was led by Gloria Hanrahan and involved more than 100 Scouts over the course of its development," explained Stanley. "The Girl Scouts fully funded the initiative through grants."

Stanley was asked when did the work begin on trail improvements? "Trail improvements are done annually as the trail has been in continuous use for 55 years since its construction," he responded.

How has the new trailhead been improved?

"The new trailhead has a brand-new sign dedicated to the memory of Gloria who later became the Camp Director at Anita Bliss Coler (ABC) for many years," replied Stanley. The sign allows visitors to know it is the SASS Wilderness Trail and when it was constructed.

Hanrahan's daughters (Amy Hanrahan Lehner, Sally Scialabba, Kathleen Hanrahan James, and Mary Buchanan) and granddaughter Katie Kolesieke attended the ceremony earlier this month.

The sisters noted their late sister Joan Hanrahan Falconer (who they say was "watching from above") worked on the trail with Beverly McEntarfer.

"Bev recalled with such zeal that phone call more than 50 years ago from Gloria, inviting her to join her team at ABC, and she's built her own legacy as [a former] camp director at The Fund, and her camp for homeless girls for decades. Having Tim with us, you could say, the 'godfather of the land,' along with his apprentice was a privilege. We saw remnants of her original yellow markings on the trees," the sisters remarked via email to Southern Dutchess News.

The new sign includes the following dedication: "In Loving Memory of Gloria Hanrahan and the Suffolk County Girl Scouts – May all who walk this path find peace, purpose, and a deeper connection with nature."

"Mom did things out of love and joy, involving as many others as she could, to share these same experiences. She was a nature lover who relished a challenge; diligent in providing an opportunity for hundreds of Long Island Girl Scouts and adult volunteers, including our Dad, Raymond Hanrahan, to test their strength and resolve, to create a trail and ultimately a conservation endeavor for an eternity. The strength,

resilience and enthusiasm evoked by the mission was spectacular," explained Hanrahan's daughters.

"Some of the Scouts held competitions for the most trees cut in a weekend! [They slept] under tarps in the open air, on rocky terrain," it was stated. The sisters remarked that Sally recalled

holding onto a tree all night in order not to slide down the hill they were assigned to work.

"In one set of meeting minutes it mentions that a professional surveyor's assessment of the trail project was met with a resounding recommendation: "DON'T DO IT. Through rain and snow, in the rockiest terrain, they were still singing all the way home on the bus to Long Island. Knowing that the trail would be a gift, especially to the countless The Fund's campers, these Scouts gave it their all with grace and joy," stated the Hanrahan sisters.

Stanley remarked, "We are deeply grateful for Gloria's leadership in this monumental effort, which has had a profound impact on generations of The Fresh Air Fund campers who have hiked the trail over the years."

What do Hanrahan's daughters think she would say about the sign that is now on the trail in her honor?

Her daughters replied, "She would say, 'Work towards your own sign. Rise above your level, seek out opportunities that will enhance your work's significance to yourself and to others. Collaborate and create. Share your glow.'"

any individual can request services to honor their nurse. Their mission is - "Nurses honoring nurses, to ensure no nurse is forgotten."

And they're on mission to recruit new members. But it's a humble pitch.

Nurses understand – it's not about them. They learn that point early in their training and everyday in their careers. They have witnessed life and its' beauty and loss of life more times than they want to remember—but remembering and honoring is what the Nurses Honor Guard is all about.

"Our reward is to honor and help others. It is a true calling of caring - for our patients and each other," says Brenda Taylor, president of the Hudson Valley chapter. "It isn't about the Honor Guard team as individuals. It is about all of us and our profession. What we do is about those we honor, the families we support and offer comfort to. It's about community – the communities we live in and of the community in nursing."

The Nurses Honor Guard was first organized in 2003 by the Kansas State Nurses Association and there are over 300 chapters worldwide. Taylor founded the Hudson Valley chapter in 2022 as an all-volunteer non-profit organization.

A recently retired emergency room nurse, Taylor worked at Montefiore St. Luke's Cornwall Hospital in Newburgh for many years.

She adds, "I believe nursing is a calling and this mission that we are serving is a different kind of calling. It's a shared mission inspired by nurses we knew as colleagues, as friends and who became family - nurses we admired, respected and mourned. It is a privilege to honor our legacies, both living and deceased. I believe nurses have earned the highest honor, respect and appreciation we can provide."

Taylor says she had wanted to start the

local chapter for a number of years. "I lost a couple of good friends who were nurses and I was saddened by the fact that there were no formal honor services for nurses," she said. "I had always been impressed by the services for members of the military and police and fire organizations. But what about nurses?"

So she founded the Hudson Valley chapter and has been leading a growing group of nurses for three years.

The Memorial Service includes a formal standing honor guard with a presentation of the Florence Nightingale Lamp, a commemorative coin, a rose and members recite a nurse's prayer.

They also take part in a variety of public functions and community events, serving as ambassadors for nursing professions and are present for "send offs and welcomes" for Veteran's Honor Flights to Washington DC.

The following are testimonials from four members of the Hudson Valley Nurses Honor Guard.

• Kathleen Tappen retired after a 48-year career at St. Francis and St. Luke Hospitals with a concentration in oncology and hospice care. She recalls seeing many patients pass and losing many fellow nurses over the years.

"As a nurse, to fulfill the wants of a dying patient is such an honor - touched by a nurse."

In regard to the Honor Guard she commented, "This is my way to honor nurses I knew and those I never met - who dedicated their lives for care of others. I am so thrilled to be part of the tributes to remember these wonderful individuals. It's such an honor to provide a sense of comfort and peace to families and friends."

• Karin Graham has worked as a nurse for 34 years. She remembers losing a co-worker to blood cancer who was only 32. "I remember the first time I witnessed the

Florence Nightingale tribute. We stood there holding hands together. It's something that sticks with you forever."

She said the Nurses Honor Guard provides "a different level of reverence," and adds "You face so many sacrifices as a nurse, missing activities with your kids and family. You don't expect a lot of thanks as a nurse, but when it comes, it means everything."

• Cathy Colon retired after 35 years as a nurse to care for mother and is now back working in Pediatric Intensive Care Unit at Stonybrook University Hospital, Maria Ferrari Children's Hospital and the New Center for Discovery in Harris, Sullivan County.

"I spent lot of time with patients and families. It was an honor to care for them at the time when patients were passing. It's also an honor to care of our own. One of my co-workers, a nurse, passed in 2008. I wish we had this group for her. That's why I want to spread the word and

help recruit for the Nurses Honor Guard."

• Kate Czajka has worked in the nursing profession for 47 years in intensive care, post-cardiac care, orthopedics, endoscopy and ambulatory surgery. She was involved in informal Nightingale Tributes while working at Benedictine Hospital in Kingston.

"The tributes were so impressive," she said. "These were our contributions, honoring their professionalism and caring."

The Nurses Honor Guard members also wear the original nurses uniforms during tributes. "This is what we wore for so many years. The uniform feels like coming home again. We worked so hard to earn our stripes," said Czajka.

The Hudson Valley Nurses Honor Guard serves in six counties to include Dutchess, Putnam, Westchester, Orange, Ulster and Sullivan. For more information, write to nurseshonorguard@gmail.com.

County hosts housing professionals at Housing Trust Fund Applicant Workshop

Dutchess County's commitment to affordable housing took another step forward this month as developers of all sizes, consultants, real estate agents and contractors gathered at the Dutchess County Housing Trust Fund (HTF) Applicant Workshop, hosted by the County's Department of Planning & Development at the Dutchess Farm and Home Center in Millbrook, to learn how to apply for the second round of HTF funding, which includes up to \$3 million for the creation or preservation of affordable housing, including smaller-scale projects in rural areas.

Dutchess County Executive Sue Serino said, "The strong attendance at our workshop shows that local developers want to help solve the housing shortage that has affected communities throughout the nation, like ours. Affordable housing is important for the health of our community and economy, and our Housing Trust Fund helps us do more than build homes. It helps people build better lives. We appreciate the developers who attended for contributing to Dutchess County's ongoing efforts to create, improve and maintain affordable housing, helping ensure that all individuals and families have safe and stable places to live and grow."

A flexible funding source aimed at creating and preserving affordable

housing options, the HTF is one of Dutchess County's tools for addressing housing challenges. This initiative is part of the County's broader strategy to tackle housing affordability and availability issues, ensuring that residents have access to safe and affordable living options. Applications are now open for local developers of all sizes to apply for funding; application instructions and guidance are available online. The application is available through Dutchess County's online grant portal, and the deadline for applying is Monday, June 9.

Hosted by the County's Department of Planning & Development, the recent applicant workshop provided developers an opportunity to learn more about the HTF's objectives and the application process, offering valuable insight into this second round of HTF funding. Attendees received an overview of available funding options, examples of projects eligible for support and direct guidance from Planning & Development staff on the application process.

The HTF helps create and preserve affordable housing units across Dutchess County, addressing a challenge that continues to affect low- and moderate-income families, both locally and nationwide. This second round of HTF funding focuses on the program's

Housing Creation and Preservation (HCP) component, which supports affordable rental housing through new construction, rehabilitation, adaptive reuse, property acquisition and preservation of existing units.

Dutchess County welcomes proposals from a wide range of developers, from large firms to first-time applicants, as it

seeks to support innovative and sustainable housing solutions. Developers who were unable to attend the workshop are encouraged to visit the Department of Planning & Development's website, where they can find detailed information about project eligibility, application requirements and examples of past funded developments.

Jacobson secures \$150,000 for South Ave. Park in Beacon

Assemblymember Jonathan Jacobson (D-Beacon) has secured \$150,000 for a major rehabilitation of South Avenue Park in Beacon.

Work is already underway at South Avenue Park, a shady park with athletic courts and a playground nestled between the Beacon Recreation Department and the main thoroughfare of 9D.

"This park is so important to the residents of Beacon, and there are kids playing every time I come here," Jacobson said during his remarks at the construction site. "I'm excited to bring this special funding to Beacon. The city always pulls together to make the most of any extra money I bring back from Albany."

Jacobson joined Beacon Mayor Lee Kyriacou, City Administrator Chris White, and Recreation Director Mark

Price, along with members of the City Council and project contractors, for the groundbreaking ceremony.

"Our summer basketball league that serves 200+ kids starts in early July, so the goal is to be ready for basketball season," Price said. "When it's done, it'll look like a brand-new park."

Price laid out details of the ambitious project, which include restoration of the basketball and tennis courts, energy-efficient LED lighting, a permanent restroom facility, regrading and drainage work, and landscaping.

"As Jonathan well knows, the trick to making the city work is finding funds other than the property tax dollars of our city," said Kyriacou. "The Assemblyman has been exceptional in helping us get those dollars — whether it's for this park or others, our Fire Department, or solar panels. We're

immensely grateful for that."

Jacobson secured \$150,000 of the

approximately \$890,000 needed for the park's rehabilitation.

DMV, unpaid tolls are latest scams; here are tips

The Dutchess County Sheriff's Office would like to take this opportunity to warn the residents of Dutchess County and surrounding areas about scams that once again seem to be on the rise.

Scams are ways in which criminals will attempt to get money from people by contacting them and making up elaborate stories. In some cases the perpetrators have tried, sometimes successfully, to use the victim's emotions about a loved one in trouble to get money. It's common for the perpetrators of these scams to try to get money by telling people that one of their relatives has been seriously hurt or is in jail, and that they need money right away. In many cases they will pose as a law enforcement official or another relative to try and convince the victim that it's legitimate.

In the latest scam the perpetrators pose as the Department of Motor Vehicles (DMV) and send the victim a text or email. The text/email tells the victim that they have unpaid tolls, and that if the tolls aren't paid by the next day their vehicle's registration will be suspended. A link is then provided, which when clicked will re-direct the person to a fraudulent DMV website.

The Sheriff's Office would like to offer the following general tips to help people avoid these scams:

- If you're contacted by someone you don't know asking for money, for any reason, it's very likely a scam.

- If you receive correspondence from someone that you don't know and they instruct you to keep the matter confidential and not tell anyone about it, it's most likely a scam.

- Emails or text messages that contain misspelled words, grammatical errors, don't make sense, or are sent at odd hours - for example the middle of the night - are most likely scams.

- Legitimate law enforcement would not attempt to satisfy a warrant or make promises to avoid prosecution by soliciting money.

- If you receive an email or text about an order you didn't place or asking you to send money call the company using a legitimate number. DO NOT follow the instructions in the email, click on any links in the email, or call the number provided in the email.

- If someone you don't know asks you to purchase merchandise, transfer money,

provide bank information, provide remote computer access, enter a code, or click on a link given to you by them use caution as it is likely a scam.

- Do not meet up with someone that you don't know; if you're asked to do this it is surely a scam, and it is very dangerous as well.

- If someone calls you and tells you that a relative has been hurt or is in jail, confirm it first before sending any money. Call other relatives or a legitimate law enforcement agency for confirmation before any money is sent. If they're posing as a relative, try and contact that relative for confirmation.

- Sending money overseas is especially risky; use extreme caution.

- Ask the person for their call back number and ask to speak to their supervisor to confirm the info; if it's a scam they will most likely hang up at this point and the number they give you will be bogus.

- If a loved one has recently passed away be wary; in some cases perpetrators have even preyed on victims by searching through the obituaries and calling surviving loved ones. If

you get calls from people you don't know soon after someone passes away, be careful and confirm it before you send any money.

- In some cases someone will call and tell the victim that they've won money, but to "process the claim" they need to first send money. Beware this is most definitely a scam and don't send any money - you should never have to pay money to claim a prize. If it seems too good to be true, it most likely is.

- If there's any doubt about a phone call/email/letter you've received contact the Sheriff's Office before sending any money.

- Scams tend to increase during the holiday season, so be especially alert for them during those times.

It is very important to not send any money to anyone that you don't know until you've confirmed the situation through an independent source and feel comfortable with it. If it's a scam once the money is sent it's very difficult, and most times impossible, to get it back. If anyone thinks they may have been the victim of a scam they are encouraged to contact the Sheriff's Office at 845-486-3800 or via the tipline at 845-605-CLUE or dcsotips@gmail.com.





Renegades rebound vs. Dash; Prepare for homestand

In a shortened edition of the usual Hudson Valley Renegades recap, three key weekday matchups highlight the season's sole series in Winston-Salem. In this inter-division matchup, the Dash ran away with the first two games before the Renegades finally made a stand on Thursday night.

Single run support

Kyle Carr started game 1 and was given a similar result to the season. Six unanswered Dash runs dropped Carr's record to 0-2, in his second straight start allowing 4 runs.

In 30.1 Carr innings this year, the Renegades have scored just 8 runs to back up their starter.

Josh Moylan continued his recent hot hitting streak, saving his team from being shut out on the road. Moylan's RBI double put Hudson Valley ahead in the second, a lead that couldn't stick around past the fourth inning. Final: Dash 6, Renegades 1.

They took two, too.

On May 21, Hudson Valley couldn't hold on to an early 2-0 lead once Carlos Lagrange submitted to a four-run bottom of the first inning. After 6 earned runs by Lagrange, the Renegades knotted it at six, then

took a 8-6 lead on a Roc Riggio home run. Renegades relief pitching gave up 5 runs in the final three home frames to put the Dash ahead 11-8.

Third time's the charm?

The Renegades finally prevailed on May 22. With 13 runs, Hudson Valley outscored the previous games' performances combined. Winston-Salem's 1-0 lead was negated by Riggio's fourth home run of the series, and the 'Gades were off. Hudson Valley took 4-2 lead through the seventh, where the offense broke the game open. With 9 runs in the final third of the game, the Renegades turned the tables from Wednesday's back-inning blowout, capturing the series' first win in their own offensive masterpiece.

Coby Morales also joined the hitting heroics, going 4-5 with a home run (4), two doubles, plus three RBI. A triple away from the cycle, Morales was marvelous. Riggio, Parks Harber and Jackson Castillo drove in a pair of runs each. Bryce Warrecker sent the Dash out quietly in the bottom of the ninth, as Benn Hess improved to 4-2 on the year.

The Renegades are at home this week with games against Wilmington at Heritage Financial Park.

Roc Riggio excites Renegades fans with running, hitting



Since returning from injury on May 6, infielder Roc Riggio has reminded fans what he means to the Hudson Valley Renegades.

Continuing last year's efficiency on the base paths, Riggio stole two bags from the Winston-Salem Dash on May 21, bringing his season total to 3. What he lacks in physical speed, Riggio makes up for in his ability to make quick reads and advance 90 feet. In 2024, he led the team with 27 stolen bases, ten ahead of the team's second-most total (Garrett Martin, 17). Riggio also led the team in hits (88), doubles (27), and triples (5).

Beginning the season as MLB.com's 27th ranked prospect in the Yankees organization, Riggio has jumped three spots in the season's first month. With the sight of a rocking ballpark, Renegades fans have welcomed their second baseman - and his bat - with open arms.

Riggio was originally drafted by Milwaukee in 2021, but was committed to play collegiately at Oklahoma State University. As a Cowboy, Riggio was described as a spark plug for the dugout, especially during their magical College World Series run in 2022. Riggio caught the attention of the Yankees, who took him in the fourth round the following year. Before his pro career began, Riggio

The case for what could be MLB's newest city

Editor's note: Writer Morgan E. Maier takes a detailed look at expansion plans in Major League Baseball.

A sports movement is brewing in Raleigh, NC. Just 90 minutes east of where the Winston-Salem Dash play their High-A home games, baseball fans and government officials are pushing a new sports product. As commissioner Rob Manfred fields calls to expand the league before 2029, Major League Baseball has one prime spot for the newest club: North Carolina's Research Triangle.

Though the Durham Bulls (née Tobacconists) have ruled the Raleigh-Durham-Chapel Hill baseball scene for over a century, a grassroots movement calls on MLB to join them. Bring MLB to Raleigh (MLB Raleigh) is a nonprofit community endeavor.

As expansion grows in popularity, fans expect that the MLB's newest teams will be placed on the continental coasts. Alongside Nashville and Montreal, Raleigh has emerged as a frontrunner for the East.

Montreal just isn't the fit for this moment. As shown by the Toronto Blue Jays' plummet down the American League East standings, one baseball team is enough for Canada. And Nashville, the rapidly growing destination for bachelorette parties and musicians, may not be the answer either.

According to MLB Raleigh data, the Triangle's metro population of 2,100,000+ sits in line with established major league markets. With three points of population in a single commuter area, college students, families, and scientists alike can enjoy America's pastime at the major league level. While Little League participation flourishes in Raleigh, North Carolina's professional teams in Charlotte are slipping from fan interest. And with the closest MLB team four hours away, across state lines, why not Raleigh?

Cities with existing hockey fan bases are likely to capture the expansion MLB team.

With nearly opposite seasons of baseball, hockey fans waiting for October's return could catch a ballgame. While many North American cities have fallen short of a franchise for a lack of necessary financial backing, Raleigh has a start.

MLB Raleigh has steadfast support from Tom Dundon, the owner of the Carolina Hurricanes in the National Hockey League. The Hurricanes are four wins from a Stanley Cup Finals appearance, which could bode well for Dundon's future sports venture.

In Carolina's September press conference introducing new CEO Brian Fork, the Hurricanes publicly announced plans to support an MLB contender. "Tom (Dundon) is very serious about pursuing that opportunity, bringing it (MLB) here to Raleigh, and we'll be taking a lead, helping him on the corporate side and business side," Fork said.

In his first five months as North Carolina's governor, Josh Stein has inherited the MLB bug from his predecessor,

Roy Cooper. Cooper was the first to call legislative attention to the movement, for the good of the state, the growth of the region. And for the prosperity of the city.

"[W]e've talked with folks at the Hurricanes, and I've talked with Tom Dundon. I'm thrilled at the possibility. I'm a baseball fan and would love to have a major league team here," Stein told the Triangle Business Journal.

In the wake of Hurricane Helene's devastation across the state, MLB Raleigh has potential to continue the growing North Carolina economy. The midsized city of Raleigh continues to grow in population, but not in metro appeal. And though Dundon was once estimated to be a billionaire, he cannot be the sole shareholder or investor in such a project. The lack of Fortune 500 companies in the Triangle is a deep concern in establishing a team.

As one of the NHL's most hands-on owners according to the Sports Business Journal, it's not surprising Dundon is taking the same approach with Raleigh's

baseball movement. With the rights to develop around the Hurricanes' home arena, Dundon could build a small market sports park to rival the four-sport cities. Think Philadelphia, Detroit, Chicago.

MLB hasn't established a team since the Tampa Bay (Devil) Rays in 1998. Yet the emergence of St. Petersburg's hometown ball club took 20 years. The idea took flight in the 1970s, then stadium construction began in the '80s. The city had patience and persistence on its side. After an entire decade or two, a couple years' wait means little.

MLB has a larger issue at hand than expansion. The Athletics, awaiting relocation to Las Vegas, are playing in Sacramento's Triple-A stadium. And until Tropicana Field's damages from Hurricane Milton are repaired, the Rays are leasing the Yankees' minor league field in Tampa.

Until 30 teams have 30 major league parks to call home, Raleigh waits to play ball.

played at the international level from the age of 11, winning gold as a member of Team USA's U15 squad in 2017.

Now in his second full High-A Hudson Valley season, second baseman Riggio still fits in with the crowd. Fans, teammates, and Facebook comments alike praise Roc's achievements in his young career.

Though a hand injury kept him off the

field until May 6, Riggio's bat has the remarkable pop from last season. Since returning from a two-game rehab stint in the rookie league, Riggio has a respectable .295/.456/.750 split in 44 at-bats. He's hit five balls out of the park since returning to High-A, with 14 RBI on 13 hits. Riggio continues reaching milestones, notching his first career multi-home run game at home against the Aberdeen IronBirds on May 17.

Also, a talented lead-off hitter, Riggio has a knack for getting on base. And crushing the baseball. In addition to the thievery of May 21, he reached base five times, going 2-2 with a home run and four scored runs. After working 71 walks in 106 games in 2024, Riggio has continued to establish discipline at the plate. A mainstay at the top of the batting order, Riggio posts a 1.206 OPS (on-base plus slugging percentage). In

all, he's constantly conjuring momentum for the eight hitters behind him.

His first minor league defensive coach compared him to Brett Gardner, gritty outfielder who was the last man standing from the Yankees' 2009 title team. Others see in Riggio a striking resemblance to Boston's beloved Dustin Pedroia.

Just 22 years old, Roc's fit to blaze his own trail to the pros. For now, the Valley is rocking with Riggio.

A Mass of Christian Burial was held at St. John the Evangelist Church on May 26 followed by a graveside service at St. Joachim's Cemetery.



Senator Rolison's bill requiring public hearings on utility rate increases advances in New York State Senate

Legislation sponsored by Senator Rob Rolison (SD-39) that would require public hearings before utility companies raise rates has advanced through the Senate Energy and Telecommunications Committee and was referred to the Consumer Protection Committee last week.

Senate bill S980 mandates that in any case where the Public Service Commission (PSC) is considering an increase in rates, fees, or charges imposed by a utility company, a public hearing must be held within the affected region at least 90 days prior to a final decision. The hearing must allow for public comment and include an opportunity for community members to ask questions of both the commission and the utility company.

"As the Hudson Valley continues to struggle with rising costs, utility rate hikes should never be decided behind closed doors," said Rolison. "This legislation ensures that families and small businesses have a voice when decisions

are being made about the bills they pay every month. We need to strengthen public oversight and give our residents a seat at the table when their cost of living is on the line."

The bill's advancement comes at a critical time, as Central Hudson, one of the Hudson Valley's primary energy suppliers, has applied for another delivery rate increase plan. Under the proposal, the average electric customer's bill would rise by \$5.43 per month (a 3.12% increase) in the first year, while natural gas customers would see an increase of \$7.73 per month (a 5.19% hike). If approved by the State Public Service Commission, the new rates could take effect as soon as the first of the month following the commission's decision.

Rolison, an advocate for transparency and affordability, emphasized the need for public accountability in utility regulation. Senate Bill S980 now awaits further consideration in the Senate Consumer Protection Committee.

A grassroots art festival born in the heart of the Village of Wappingers Falls is poised to grow beyond its borders. 



Three intriguing Dutchess County names

I have been intrigued by several location names since moving to Dutchess County. People who've lived here their whole lives might not think much about the labels. But I was compelled to investigate and find out why were they so christened.

Local historians are valuable resources who have spent years investigating bygone times in this area. My contribution with this column is merely as a recent arrival interested in some of the more unique names and how the backstories of those monikers can be employed in education. Learning about the derivation of area names in a community can be a great conversation starter and helpful when teachable moments present themselves.

New York has lots of historic places
New York has 270 National Historic Landmarks, the most of any state. Nearly half of those landmarks are in Dutchess County! I found it helpful to review the history of Dutchess County within the larger state of New York before delving into specific location names.

Before there was a Dutchess County
The first peoples to live in present-day New York are estimated to have arrived in 10,000 BC. Around AD 800, the Iroquois' ancestors moved into the area from the Appalachians. The predecessors of the Algonquian peoples also lived in the region. By around 1100, the Iroquoian-speaking and Algonquian-speaking cultures that would eventually be encountered by Europeans had developed.

The Age of Exploration brought Europeans to the Americas. The land that includes present-day New York was a Dutch Colony known as New Netherland from 1614-1674. When the British conquered New Netherland, the colony and major city were renamed New York, in honor of the Duke of York.

The British considered the King to be the only source of legal title. Therefore, previous land purchases made from the Indians were invalidated. Large tracts of land in Dutchess County were divided among men of money and influence. Those land "patents" were granted to them by the British crown. The "proprietors" of those patents then conveyed smaller land allotments to others. Over time, towns developed.

The names of the land patents are reflected in Dutchess locations today. They include Rombout, Nine Partners', Rhinebeck, Beekman, and Oblong. Beyond those historical names, there are others that are quite unique, such as Crum Elbow, Shekomeko, and Spackenkill. But, here are the three most intriguing

Dutchess names, in the view of the HV Naturalist.

#3: Fiddlers Bridge Road

The road connecting Pleasant Plains to Schultzville commemorates a rather macabre event. According to legend, in 1808, a fiddler, who played at local dances, was murdered. His body was abandoned on a bridge, which has since been removed—but the road's name refers to its former presence.

#2: Amenia

The Latin word *amoena* means "beautiful." This name was coined by Thomas Young in 1762 when the precinct was formed. Young was a physician, poet, a writer of political pamphlets, and a Latin scholar, who also gave the State of Vermont its name: for the Green ("vert") Mountains ("mont") within the state. He also participated in the Boston Tea Party.

#1: Cricket Hill Road

Cricket Hill, at Buena Park in Chicago, is an artificial hill, built in 1948. It is 45 feet high. One explanation for the hill's moniker is that the location was formerly a cricket field. Another fun, if morbid, possibility, is that three elephants were killed in a circus train collision in the 1800s. One of the elephants is buried beneath the hill.

New York State Route 22 connects with Old Route 22 by way of Cricket Hill Road in Dover. The hill is 538 feet high, nearly twelve times the size of the hill in Chicago. Ergo, the other two circus elephants are probably buried in Dover. (All of the elephants performed under the stage name Cricket.)

But, seriously...


Documenting locations near where you live can help you understand the area better. It certainly did for me. Check out the places near you and learn how they came to be a part of your home. Maybe they've experienced some changes. There are probably aspects about them that remain unchanged. Explore how and why your geography exists as it does today!



Wild Mushrooms and Pasta

Ingredients

8 ounces bow tie pasta

3 tablespoons extra virgin olive oil

3 tablespoons butter

3 tablespoons pine nuts

10 ounces fresh chanterelle mushrooms

1/2 teaspoon black pepper

1/2 teaspoon dried red pepper flakes

3 ounces shaved Parmigiano-Reggiano

1 tablespoon minced onions

Directions

Cook the pasta in salted water and boil for 5-6 minutes for al-dente.

While the pasta is cooking, heat the

pine nuts in a dry 10-inch skillet over medium heat. Toast the pine nuts, shaking and stirring frequently, until golden brown (about 5 to 7 minutes). Transfer the pine nuts to a small bowl and set aside.

Return the skillet to the stove and adjust the heat to medium-high. Melt the butter in the pan, then add the mushrooms, garlic and minced onions and sauté for 3 to 5 minutes, until browned.

Drain the pasta, making sure you leave the pasta generously wet, and add it to the skillet. Toss well and season with extra virgin olive oil, black pepper and red pepper flakes. Transfer to a serving dish and garnish with the toasted pine nuts, and shaved Parmigiana-Reggiano.

Serve at once with a loaf of crusty Italian bread and nice Chianti.






