A special project that combines the exceptional talents and efforts of many local individuals and a working-together community spirit is "blooming" into a variety of colorful planter boxes at the Dutchess County Fairgrounds.

This all revolves around the ever-evolving ThinkDifferently efforts of individuals representing the Fair, Dutchess County government and the local business community. On the organizing end, Vicki Imperati of the Fair is teaming with Dana M. Hopkins, County All Abilities Program Director and Tony Capalbo from Phantom Gardener Nursery in Rhinebeck.

"Last year we implemented a ThinkDifferently Recycled Garden Art class in the Horticulture Department,

which was well received," said Imperati. "We had a brainstorming meeting in February with those that were involved and came up with the idea of having various agencies for those with a disability to participate by offering them the opportunity to come in and plant some of the planter boxes throughout our grounds."

Hopkins noted that the flower boxes are pre-existing boxes that have been previously used at the Fairgrounds. Capalbo prepped the boxes with soil and had the plants ready to go. Each individual attending received at least a 2'x2' section to create their planter box design with flowers. She said they had 16 individuals participate on May 22 and 18 are registered for May 29.

### Annual community event set for June 1 in Wappingers Falls

The 8th annual Festival at the Falls is set for June 1, from noon – 6 p.m. The community event will take place at Mesier Park in the Village of Wappingers Falls and is organized by the Wappingers Falls Business and Professional Association (WFBPA).

## Band concert at Depot Park in Hopewell on June 2

Experience the Hudson Valley Council Band in concert on June 2 at the Depot Park in East Fishkill.

"Enjoy great band music with many popular songs! The concert is from 3-5 p.m., at Depot Park, 36 Railroad Av., Hopewell Junction, right off the William R. Steinhause Dutchess County Rail Trail," said Joseph Sullivan, a member of the Hopewell Depot Restoration Corp.

"While there, take a tour of Dutchess County railroad history in the museum and see our new addition of a 1916 wooden caboose," added Sullivan.

Dave Pfirman is the president of the Hopewell

Depot Restoration Corp. "Visitors, young and old, love the caboose. It is the one element of Depot Park that all visitors agree confirms in their minds that railroads ran through Hopewell Junction. Many take selfies in front of it. Bike tours love to document their trip with group photos. When the Museum is open we allow visitors to stand on the end platform and get that old time political campaign rally 'whistle stop' photo. Children, many of whom have never seen a railroad car, are in awe of the size and apparent weight of the caboose. Old timers tell us about their experiences with railroads. The unique history of this caboose sets it apart from others. Everyone is pleased with how well the restoration is going. We can't wait to finish."



# *Remembering the 'heart and soul' of the Howland Cultural Center*

Florence Northcutt 1927-2024

Florence Northcutt, Howland Cultural Center (HCC) president emeritus, died on May 17. Northcutt was 97 years old. She was born on March 26, 1927. Northcutt Hall, located in HCC, was dedicated in her honor in 2022.

"Florence Northcutt was the heart and soul of the Howland Cultural Center," stated Beacon Mayor Lee Kyriacou during the City Council meeting on May 20.

Theresa Kraft, the current president of the HCC told the Council during the meeting, "Florence will be remembered as a visionary and a generous leader."

Northcutt "cherished the ideals of cultivating an artistic, thriving cultural community," said Kraft. "Her leadership and volunteer spirit greatly enriched our community, especially through her work at the Howland Cultural Center over the past 38 years.

"We - and those she served [at the HCC] - are tremendously grateful for the extraordinary impact Florence had made in the lives of children, adults and families," remarked Kraft.

"It is with a heavy heart that we share this news," she said.

On October 30, 2022, Northcutt was honored during a dedication ceremony at the HCC on Main St. in Beacon. The main gallery in the HCC since that time, has been known as Northcutt Hall.

During an interview with Southern Dutchess News at that time, Northcutt said, "I was speechless. It was one of those moments that was jaw dropping;

you can't do anything. I was so surprised. I didn't know what to say initially."

Northcutt recalled during that 2022 interview, after moving to Beacon, she wanted to get involved in the community and was seeking a place where she could volunteer. A friend told her about the HCC on Main St., which was designed by one of the country's great architects, Richard Morris Hunt (who designed the Great Hall of the Metropolitan Museum of Art and the pedestal of the Statue of Liberty). "The moment I walked into that beautiful building, I loved it," remarked Northcutt, who was president of the HCC from 1996-2017.

Northcutt was also honored by the Dutchess Arts Council with the Dutchess County Executive Arts Award for Special Citation in 2001.

Denise Doring VanBuren, president of the Beacon Historical Society, said via email, "Florence became an institution in Beacon. She will be long remembered for her devotion to our city and to the arts, as she was absolutely vital to our community's rebirth into a cultural destination. When researchers and residents alike look back on the transformational era that revitalized Beacon, the name of Florence Northcutt will loom large indeed. But beyond that lasting civic contribution, she was a gracious, kind and witty woman whose sweet disposition was unforgettable. We will miss her."

Kraft stated that Northcutt did not

want any services. A future day to celebrate Northcutt's life will be announced. The ceremony will be held at the HCC, said Kraft.

"The work of the Center is never done,

and we will follow in her footsteps," concluded Kraft.

Kraft noted that Northcutt's family asks that donations in Northcutt's name be made to the HCC.

# BCSD voters approve 2024-25 Budget

## Lewine, McNair, Stadler elected to BCSD board

Registered voters in the Beacon City School District (BCSD) voted to approve the 2024-25 Budget on May 21. The other three propositions on the ballot also passed. Current Beacon City School District Board of Education member Flora Stadler was reelected to office. LaVonne McNair and Christopher Lewine were also elected to seats on the BOE.

The Budget vote was 720 'Yes' to 244 'No.' BCSD Superintendent of Schools Dr. Matthew Landahl told Southern Dutchess News before the election that "[i]f the budget passes, a homeowner with a median valued home will pay an average of \$100 more per year."

Landahl stated on the BCSD website the day after the election, "I want to thank the community for supporting our budget work this year. We are very excited to move forward!"

Proposition #2 was regarding the purchase of an electric-powered bus. The proposition read: "Voters will vote on the following proposition, which reads as follows: 'Shall the bond resolution authorizing the purchase of two zero-emission school buses at a maximum cost of \$990,000 (\$495,000 per bus), but only if the District receives subsidies of at least \$400,000 (\$200,000 per bus); authorizing the issuance of up to \$990,000 bonds (5 year maximum maturity) and, with respect to such bonds, providing for a tax levy therefor in annual installments; pledging the District's faith and credit for debt service; delegating powers with respect to bonds and notes; and providing for an estoppel procedure, be approved?'

The results were 595 'Yes' to 364 'No.'

Proposition #3 was to purchase three 72 passenger gas buses.

The proposition stated the following:

respect to bonds and notes; and providing for an estoppel procedure, be approved?"

### 3 elected to BOE seats

Four candidates were seeking three seats on the BOE. The candidates were Stadler, McNair, Lewine and Megan Phillips. Stadler received 695 votes. Her term begins right away to finish the term of former BOE member John Galloway Jr.

McNair received 657 votes. Lewine had 596 votes. Phillips received 514 votes. McNair and Lewine's terms will be from July 1 and expire June 30, 2027.

Stadler told Southern Dutchess News in an email, "I'm grateful that I have the opportunity to keep doing this important work."

"I'm very grateful to the voters for giving me an opportunity to serve Beacon schools," Lewine said in an email to Southern Dutchess News on May 23. "I'm looking forward to working with the Board to continue their great progress. I commit to prioritizing student wellbeing, rich instruction in our classrooms, and building a close partnership

with the community. It takes all of us working together to provide a wonderful education for our children."

McNair did not respond to a request for comment.

Phillips said in an email on May 23, "I decided to run for School Board on a whim. My experience in education and teaching made this seem like a logical next step but this was also new and in many ways uncomfortable for me. I am humbled by and grateful for the support I have received. I truly love living here and know I will find a way to give back to the community who welcomed my grieving family with open arms less than two years ago. I am still finding my way in this new life and uncertain what the future holds. If it works out next time, I would definitely run again. Congratulations to the newly seated Board members!"

Landahl said, "Thank you to Vickie Jackson, the Clerk of the Board of Education, for coordinating the election and to all of our election workers for helping things run smoothly."

## Capollari, McFarland, Morgan win seats on WCSD BOE

### 2024-25 Budget passes

Registered voters in the Wappingers Central School District (WCSD) voted to pass the 2024-25 Budget on May 21. The bus proposition on the ballot also passed. Board of Education candidates Michael McFarland, Virgil Capollari and John S. Morgan were elected to seats on the BOE.

The Budget vote was 2,009 'Yes' to 794 'No.' WCSD Superintendent of Schools Dr. Dwight Bonk told Southern Dutchess News the day after the election "We are very grateful to the entire Wappingers CSD community for their continued support of our District!"

Proposition #2, which was the Bus Proposition, passed with a vote of 1,954 'Yes' to 846 'No.'

The proposition was for a bus purchase in the amount of \$2,668,863. The proposal would include a replacement of 8 large buses and the purchase of 15 vans. "The District uses 5-year revolving bond anticipation notes (BAN) to finance the purchase of school vehicles," said Bonk before the election.

#### BOE election results

McFarland received 2,143 votes. Capollari had 2,026 votes. Morgan received 2,082 votes. Christopher Costabile received 959 votes.

"Last night's victory (May 21) for the Wappingers School Board is truly a testament to the hard work and dedication of the entire Board of Education Trustees and WCSD staff. Over the past two years, it has been a real privilege to serve alongside

them on the Capital Improvement, School-wide Safety and Security Committees," stated Capollari in an email to Southern Dutchess News on May 22. "Through my involvement in these committees, I have gained a deeper understanding and appreciation for the inner workings of the District. It is reassuring to witness the commitment to putting our children and WCSD stakeholders at the forefront of all decision-making processes."

Capollari said, "Our children deserve nothing but the best opportunities for their education, and I am excited to continue working collaboratively towards achieving this goal. Together, we will strive to

create an environment that supports the growth and success of every student.

"I would like to extend my gratitude to the community for their unwavering support throughout this journey. It is through our collective efforts that we can make a difference in the lives of our children and contribute to the continued success of the Wappingers Central School District."

On May 24, Morgan stated, "I certainly am appreciative for the confidence that the community has placed in me once again."

He noted that he was "most pleased with the overwhelming support" for the passage of the budget.

"The mission at Hopewell Depot Museum is to provide a historic museum and park for the education and recreation of the community of Hopewell Junction, the town of East Fishkill, and Dutchess County. Explore the rich history of the area through our interactive museum and through the restorations of the Depot, Tower and...Caboose," it states on the Depot website, [hopewelldepotmuseum.org](http://hopewelldepotmuseum.org).

The Depot was built in 1873. An arsonist fire, in the 1980s, caused extensive damage to the Depot. The fire was started by a firefighter, according to the Depot website, who was eventually caught. Then in 1996, the Hopewell Depot Restoration Corp. was formed, and volunteers began the long task of renovating the Depot. In 2012, the Visitors Center was opened.

"The Depot Concert series is a fun way to relax and spend a Sunday afternoon with family. We bring in good musicians

that cater to a wide audience. The venue is very attractive, includes tours of the Museum and Signal Tower and we will open the caboose to the public when it is complete. It is also a fundraising event for the Depot. We sell merchandise and usually hold a 50/50 raffle for fun. It's an opportunity to share the experience with trail users and others interested in music and local history," remarked Pfirman.

The Hopewell Depot Museum is open on Saturdays from 10 a.m. to 2 p.m.

"Check out our website for additional events, bike tours and concerts through the summer," noted Sullivan.

## VA grants more than 23,656 claims for New York Veterans, survivors

WASHINGTON — The Department of Veterans Affairs expects to grant its 1 millionth PACT Act-related disability compensation claims to Veterans and survivors since President Biden signed the bill into law on Aug. 10, 2022 — including 23,656 claims to Veterans and survivors in New York. The grant rate for these 1 million claims is 75% — a sharp increase from pre-PACT levels — and VA has delivered more than \$156,351,904 in earned benefits to New York Veterans and survivors. Additionally, since the PACT Act was signed into law, more than 16,473 New York Veterans have signed up for VA health care.

The PACT Act expanded VA health care and benefits to millions of Veterans, including adding "presumptive" service connection for hundreds of conditions linked to burn pits, agent orange, and other hazards while serving our country. Presumptions such as these lower the burden of proof required to receive disability benefits, helping Veterans get the benefits they deserve as quickly as possible. The average nationwide service connection rate for Veterans with these granted claims is 70%, meaning that they receive more than \$20,000 in earned benefits payments from VA each year.

VA encourages all Veterans to visit [VA.gov/PACT](http://VA.gov/PACT) to learn more and apply for the care and benefits they deserve.

VA Secretary Denis McDonough said, "Whenever a Veteran gets a claim granted, it means life-changing monthly payments and access to no-cost VA health care for that condition. We're proud that we've granted 1 million PACT Act-related claims for Veterans and survivors, but we won't rest until every Veteran and every survivor gets the VA health care and benefits they deserve."

"Thanks to the PACT Act, VA is delivering more benefits to more Veterans than ever before," said Under Secretary for Benefits Joshua Jacobs. "We encourage all toxic-exposed Veterans and their survivors to apply today for care and benefits at [VA.gov/PACT](http://VA.gov/PACT). When you apply, we will stop at nothing to get you the benefits you've earned."

Through the PACT Act, VA has been able to help millions of Veterans get the health care and benefits they deserve. Key impacts include:

- More Veterans are enrolling in health care: More than 400,000 Veterans have enrolled in VA health care over the past year, a 30% increase year-over-year. This is critical because Veterans who come to VA are proven to have better or equal

health outcomes, higher satisfaction scores, and trust VA outpatient care at 91.8%.

- More than 5.4 million Veterans have been screened by VA for toxic exposures: These screenings are a critical step to detecting, understanding, and treating potentially life-threatening health conditions. Of the 5.4 million Veterans who have received the screening, 44% reported at least one potential exposure.

- Veterans are applying for benefits at all-time record rates: Thanks to the largest outreach campaign in VA history, Veterans and survivors submitted 2,433,729 claims applications in 2023 — an all-time record and 39% more than in 2022. Veterans and survivors are on pace to break this record again in 2024.

- Veterans exposed to toxins and other environmental hazards are now eligible for VA health care: In March, as directed by President Biden, VA announced that all Veterans who meet eligibility requirements and were exposed to toxins and other hazards while serving in the military — at home or abroad — had become eligible to enroll directly in VA health care. This expansion eliminated the phased-in approach called for by the PACT Act — meaning that millions of Veterans are becoming eligible for VA health care up to eight years earlier than written into law.

The 1 million granted PACT Act-related claims are claims from more than 888,000 Veterans and survivors that included a PACT Act condition where at least one condition from the claim was granted, regardless of whether the granted condition is one of the PACT-specific conditions noted above. In total, VA has received 1.6 million PACT Act-related claims and completed more than 1.3 million since August 2022. More information and data on the impact of the PACT Act can be found in VA's biweekly PACT Act Dashboard.

VA is currently processing Veteran benefits claims at the fastest rate in history, delivering more benefits, more quickly, to more Veterans than ever before. As a result of this record pace, Veteran claims pending over 125 days — known as the backlog — has decreased by more than 100,000 claims since December.

Moving forward, VA will continue to aggressively reach out to Veterans to encourage them to come to VA. VA encourages all Veterans, family members, caregivers, and survivors to learn more about VA and apply for their world-class health care and earned benefits.

# City of Poughkeepsie Police Chief Pape retires after more than 4 decades in law enforcement

## Rich Wilson selected as Interim Police Chief

City of Poughkeepsie Mayor Yvonne Flowers announced that after more than four decades of serving the Police Department in various capacities, Police Chief Tom Pape retired effective May 24.

The mayor also announced that Rich Wilson, who has served with the Police Department for more than three decades, has been named Interim Police Chief.

"I want to thank Chief Pape for his unyielding service and steady handling of the Police Department for these many years. Chief Pape epitomizes the best in police professionalism, and he has served this city with great distinction," said Flowers. "I also have the utmost confidence Rich Wilson will do excellent work as our interim Police Chief, considering his vast knowledge of the city and the operations of the Police Department."

Pape attended Dutchess Community College and SUNY College of Technology at Utica and rose up the ranks in the department beginning as a Patrol Officer in 1983. He served in the Detective Bureau and continued in various capacities as a Commanding Officer before being named chief by then-Mayor Rob Rolison in January 2016.

Under Pape's leadership, the department has made significant investments in body cameras to provide more transparency about how officers operate in the field — and about the situations to which they respond. The department also enhanced its complaint process by improving accessibility and by developing a new easy-to-use online reporting tool. Forms can be used to file civilian complaints and for commendations for the actions of officers.

The department has completed Procedural Justice training, which focuses on the way police interact with the public, and it established the Procedural Justice Committee which includes police officers, other city officials and community members.

Procedural Justice emphasizes that treating people with dignity and respect and giving citizens a voice during encounters promotes community trust. City Police also have undertaken implicit bias training, which addresses the automatic association people tend to make between

groups of people and stereotypes about those groups.

With the assistance of the Command Staff, Pape has developed new policies and is currently taking the necessary steps to have the department recognized as accredited through the State of New York.

"It's been my privilege to serve the city over these decades, and it was particularly an honor to serve as Police Chief these last eight years. I am proud of the work, the civic duty, the department has carried out -- and continues to carry out on a day-to-day basis. Our officers greatly care about this community, and that shows throughout every shift aimed at keeping the city safe," said Pape.

### Wilson selected as Interim Chief

Wilson is a graduate of Our Lady of Lourdes High School, attended Dutchess Community College where he studied business administration and holds a bachelor's degree in Public Affairs from Empire State University. He joined the department in 1994 as a Police Dispatcher and worked his way up through the ranks. He was promoted to Sergeant in 2001 and served in Community Policing and then the Neighborhood Recovery Unit before being named a Police Lieutenant.

He has served as Police Captain since 2016, tasked, in part, with oversight of the Patrol and Detective Divisions, the Neighborhood Recovery Unit, the Community Policing Unit, and the Traffic Safety & School Resource Detective. Wilson also serves as the Commanding Officer of the Emergency Services Unit.

Wilson was the lead department official in the development and implementation of the City of Poughkeepsie Police Department Police Reform & Modernization Collaborative in compliance with then-Governor Andrew Cuomo's Executive Order and in the re-writing of the department's policy manual.

Wilson volunteers for the City of Poughkeepsie Police Athletic League and Vassar Warner Home and is a board member for the McCann-Caven Golf Courses Inc.

"I appreciate the opportunity Mayor Flowers is giving to me to lead this department," Wilson said. "I want to com-

mend Chief Pape for his tremendous service, and the wisdom he has demonstrated over the years. I am confident that with the experience I bring and with my knowledge of the city, this will be a stable

and seamless transition."

Flowers said she would soon begin the search to fill the Police Chief position and is also awaiting the results of an administered police chief test.

## Drug Task Force: City of Poughkeepsie man arrested for sale of narcotics

The Dutchess County District Attorney's Office Drug Task Force has been investigating the sale of crack cocaine and other dangerous drugs in the area of Main Street between Hamilton and Clinton streets in the City of Poughkeepsie. This investigation began after the Drug Task Force received complaints from residents regarding subjects selling narcotics in that area at all hours of the day, according to law enforcement. The Drug Task Force also received a complaint from a City of Poughkeepsie official alleging drug activity in that area as well. The Drug Task Force Agents began purchasing cocaine from an individual on multiple occasions in that area and identified him as the subject responsible for the narcotics sales alleged in the numerous complaints received by the Drug Task Force. This individual was identified as Ronald Davis, 47, from the City of Poughkeepsie.

Drug Task Force Agents apprehended Davis on Main Street and subsequently executed a search warrant at his residence resulting in the alleged seizure of a large quantity of crack cocaine packaged and ready for sale on May 22.

Davis has multiple charges pending related to this investigation including

Criminal Possession of a Controlled Substance with intent to sell in the Third Degree, a Class B felony, according to law enforcement. Davis was arraigned in the City of Poughkeepsie Court and he was remanded to the Justice and Transition Center with no bail.

The Drug Task Force was assisted by the District Attorney's Violent Crime and Dangerous Drug Bureau during this investigation.

The Dutchess County District Attorney's Office Drug Task Force warns the public that cocaine is often mixed with fentanyl, a dangerous drug that is the leading cause of overdose deaths in Dutchess County.

As with any criminal case, the charges described above are merely an accusation and those individuals named in this release are presumed innocent until proven guilty in a court of law.

## Figlia appointed new police chief in Beacon

The Beacon City Council unanimously voted to appoint Lt. Thomas Figlia as the City's new police chief. Chief Sands Frost is retiring, and his last day will be June 14, it was stated during the Council meeting on May 20.

City Administrator Chris White said "there will be some overlap" as Figlia will begin on June 10 and Frost's last day will be four days later. There will be a public swearing-in ceremony for Figlia and other new hires on June 17, it was stated.

Mayor Lee Kyriacou said, "We all did our interviews" and that Figlia was "well received."

"This time in line of succession, it was Tom," said the mayor.

Frost said he "grew up in the city" and still has family and friends in Beacon. Even though he is retiring, Frost said, he still "wants the best" for Beacon.

"[Figlia] shares a lot of the feelings I have" for the City, said the current chief.

Figlia, according to Frost, was the chief's "right hand man."

"No one knows the policies better than Tom," Frost, who is retiring after almost 41 years, remarked.

Figlia joined the Beacon force in the early 2000's. In 2015, Figlia was promoted to Patrol Sergeant. According to Frost,

Figlia began supervising patrol shifts and taking on more training responsibilities, including for use-of-force policy instruction and sexual harassment prevention. He was given responsibility for maintenance of the Department's in-car camera systems and oversaw the body-worn camera pilot program, it was noted.

Figlia was promoted to the rank of Lieutenant in 2018 and was tasked with assisting in supervising and evaluating Patrol Sergeants and Detective Sergeant, it was stated. He also reviewed and tracked all Departmental use-of-force incidents to ensure compliance with policy and law, for managing full implementation of the body-worn camera program, and overseeing all Department training programs.

Figlia, who moved to Beacon with his family in 1989, is the son of former Howland Public Library Children's Librarian Ginny Figlia, "Miss Ginny."

Figlia said he graduated from Beacon public schools.

When this opportunity came forward, "I put my name forth," said Figlia. He said he wants to see "the strides made" in the community continue.

"I have an investment in the community," said Figlia.

"I think he is the best choice," said Frost.



### 'On road again...' and impact by Jace Avina

**TIME AWAY:** The Renegades returned to the road last week in Brooklyn for a six-game series with the Cyclones, as they continue a stretch where they play 16 of 22 games away from home. After a two-week road trip to Aberdeen and Wilmington, Hudson Valley hosted Jersey Shore last week.

**MIDWEST REINFORCEMENT:** Jace Avina debuted with the Renegades on April 17 after being traded to New York for Jake Bauers in November from Milwaukee. The 20-year-old has quickly made a big impact for the Renegades. Avina had a 23-game on-base streak snapped last week. That streak is the second-longest in the South Atlantic League this season behind Kristian Campbell of Greenville.

**NYC ARRIVAL:** For the first time this season, the Renegades travel to Coney Island to face the Brooklyn Cyclones. The former NY-Penn League foes will play 24 times in the regular season, including 15 games at Maimonides Park. Brooklyn and Hudson Valley faced off 24 times in

2023 as well, with the Cyclones taking 14 of 24 matchups from the Renegades.

**RAIN, RAIN, GO AWAY PLEASE:** Because of rain, Hudson Valley will now play eight games in six days vs. Wilmington from June 4-9.

The Renegades have played only 36 games, three less games than Brooklyn, Jersey Shore, and Aberdeen, their fellow South Atlantic League North Division foes.

**OFFENSIVE ASSISTANCE:** Rafael Flores has made an instant impact for the Renegades since being reinstated off the IL on May 10. He has boosted his average from .200 on May 10th to .278, and his OPS has jumped from .676 to .825.

**INTERNATIONAL OUREACH:** The Hudson Valley Renegades and the Bhutan Baseball & Softball Association have partnered to present Bhutan Night on August 20 at Heritage Financial Park. The team is currently fundraising to bring over several Bhutanese baseball players for baseball and cultural enrichment tour of the Hudson Valley and New York.

#### Renegades split games with Brooklyn with Major Leaguer LeMahieu in lineup

As Yankees infielder DJ LeMahieu made two rehab appearances with the Hudson Valley Renegades last week the team split the games with the Brooklyn Cyclones at Maimonides Park, losing 7-1 and winning 16-3. LeMahieu had one hit in each game.

LeMahieu is the fifth Major League rehabber in the Yankees era for the Renegades, and the first since Carlos Rodon in 2023.

On Tuesday, playing five innings at third base for Hudson Valley, LeMahieu was 1-for-3 in the game, with an RBI single in the sixth inning for the Renegades' lone run.

After three scoreless innings each from starters Cam Schlittler and Jonah Tong, the

Cyclones got on the board in the fourth. Mateo Gil and Christopher Suero both walked. A throwing error by Rafael Flores on a groundball allowed Gil to score. Suero came home later in the inning, after an error by Omar Martinez on a pickoff attempt following a strikeout. In the fifth, William Lugo reached on an error and a two-run home run by Wilfredo Lara off Hueston Morrill extended the lead to 4-0.

In the sixth, the Renegades got on the board. Cole Gabrielson notched a triple to right, and came around to score on the LeMahieu RBI single up the middle. Hudson Valley had just five hits in the game, but four went for extra bases.

It didn't get much better a day later.

While it is difficult to have an afternoon start after a night game, try this one on for size – an 11 a.m. start because of a special promotion. The Cyclones won in a low-scoring affair, 3-1.

The Renegades jumped out to an early lead in the top of the first with Jesus Rodriguez kicking off a two-out rally with a single. After a Tyler Hardman walk, Jace Avina drove in Rodriguez with a single for his 19th RBI of the season to put the 'Gades in front 1-0. Brooklyn struck back in the top of the third against Jackson Fristoe when Karel Paz singled with one out and stole second base. Nick Morabito brought Paz home with an RBI single, and a throwing error by Fristoe (0-2) allowed Morabito to

reach third. Fristoe then walked the next three batters to force in another run and put the Cyclones ahead 2-1.

In LeMahieu's second rehab game on Thursday night, the offense exploded for 18 hits in the 16-3 victory over the Cyclones. The team's 18 hits was the second-highest tally for the Renegades in a game this season.

LeMahieu went 1-for-4 with a double and run scored, getting a five-run first inning started for the Renegades. Minor League rehabber Jorbit Vivas had five hits and drove in five runs, while Omar Martinez was 2-for-5 with a two-run home run and five RBIs. Four Renegades had multi-hit games.

Results from the rest of the series were not available due to early holiday deadlines.

## General Manager Q&A

### Summer mindset and handling opportunities of a split-season

*Editor's note: Each week reporter Rich Thomaselli speaks with Hudson Valley Renegades General Manager Zach Betkowski to discuss thoughts on the Renegades and on minor league baseball in general.*

**Summer is unofficially here, so does the mindset and mentality of the front office change at all?**

Not really. We have a mindset here that it's always opening day. It's always somebody's opening day. So we give an A+ effort, whether there's 500 people in the stands or

5,000. Plus, we still have to train the marketplace because for 25 years they were used to being a short-season team and the season started at Father's Day. But I still think we've done the best job we have ever done in getting more people out to the ballpark. As far as the staff goes, we'll be ready.

**What does it mean to the franchise to have a major league player do his rehab assignment here? Are you able to use it in some of your marketing strategies?**

Of course. (DJ LeMahieu of the Yankees played for the Renegades last week in a reha-

bilitation assignment but the game was at Brooklyn.) But I would be remiss to say that I didn't wish the game was at home because we would have got a nice little ticket bump. But I think it does a lot for the franchise in that the Yankees know we have the proper accommodations for them. And they have a lot of trust in us. We take a lot of pride in that trust. But I think we still get a nice bump from a Facebook post or a tweet. While we might not have been able to monetize that because DJ wasn't physically here, it's still a nice piece of content that we can put out there to our fan base.



**What are the benefits and the drawbacks of the split season?**

Well, the benefits are, if you're a first-half winner, which we were last year, we have essentially two to three months to promote the playoffs, which is tremendous. There really aren't any drawbacks because it does give a lot of teams a fresh start. Maybe they sign their draft picks and have a chance at the playoffs and clinching the playoffs in the second half. It's like it's a completely new team. I guess one drawback would be as if it doesn't work out in the second half. But I really like the way Minor League Baseball is set up.

"We had tremendous interest from our partner agencies – within hours of sending out the email that the planter box workshops were ready for registrants - the dates were filled," said Hopkins, noting that the idea was a great fit for agencies and residents. "Most of the agencies are involved in gardening to some degree, whether it is in their day program or their residence."

Hopkins pointed out that the Fair is "a showcase of talents for so many people in our community. These flowerboxes add to the vibrancy of the Fair and highlight how people of all abilities contribute to the fun and beauty of the Fair for everyone to enjoy."

"The guys and ladies who participated were so proud of their work. They wanted to learn, even if they hadn't planted before. One person said they had bad hands, but still they were determined to do the plantings and they did it!"

Capalbo said, "I really enjoyed seeing all of the individuals smile and get excited to plant flowers. One of the biggest reasons I started working in the horticulture field was because of the enjoyment I get every time I'm outside planting and working with the plants and the soil. It was awesome to share some of that with the individuals. At Phantom Gardener, we work really hard to show people from all walks of life and abilities how enjoyable it can be to plant flowers and be outside and this was another avenue to continue that message."

## Applications being accepted for county's veterans microgrants program

The Dutchess County Division of Veterans Services is now accepting applications for its Veterans Microgrant Program, a competitive grant program that offers one-time grants to local non-profit organizations or municipalities to enhance activities and programming that address veterans' needs and recognize the service of local veterans. Grant applications are now available online via Dutchess County's online grant portal and will be accepted on a rolling basis while funds are available.

Grant awards of up to \$15,000 per organization or municipality can be used for purchases or needs, including equipment, resources or other one-time expenses to help enhance program offerings, as well as make the program more accessible for veterans. Dutchess County's 2024 Budget includes \$100,000 for the Veterans Microgrant Program.

Veterans Services Director Adam Roche said, "I am grateful County Executive Sue Serino and the Dutchess County Legislature have continued the microgrant program, which not only helps our veterans but also all the organizations throughout Dutchess County that work daily to serve our vets. The grant clearly acknowledges the value of our veterans and ensures they are being cared for in a manner worthy of their service to our country."

Nonprofit organizations or municipalities that currently offer specific programs to and for the benefit of veterans of the United States Armed Forces in Dutchess County are encouraged to apply. Priority will be given to entities that do not already contract with Dutchess County to provide services to veterans. Organizations or municipalities which received funds from Dutchess County through its 2022 or 2023 Veterans Microgrant programs are not eligible to apply for this latest opportunity.

Examples of possible funding awards include:

- Enhancement, expansion of a program or service currently offered to veterans;
- New programming for veterans provided by an agency that already provides services to veterans;
- Purchase plaques, banners or monuments to honor veterans;
- Expenses associated with an event (picnic, holiday party) to honor veterans; and
- General capital infrastructure to facilities, including physical structures (roof, windows, doors, etc.), HVAC, plumbing, electrical, security, furniture, fixtures and equipment; the structure's primary purpose must be for veterans' services.

An example of projects funded through the County's previous Veterans Microgrant programs: The Veterans of Foreign Wars Post 666 in Beacon received a \$14,000 microgrant in 2022 to purchase new appliances for its kitchen, which is used to prepare meals for veterans during meetings for various veteran organizations within the group's Veterans Memorial Building; to upgrade lighting and provide counter-top space for food preparation and cabinet space for storage; to replace the floor to enable better cleaning; to purchase a stainless steel sink to accommodate large pots; and replace water-damaged ceiling tiles.

Only one application per organization will be accepted. Funding should be utilized within one year of award. The complete list of Veterans Microgrant instructions and guidance is available online.

## Melanie's Law passes in the Assembly

Melanie Chianese was a resident of Dutchess County who fell victim to a loophole in order of protection laws. Chianese's mother's ex-boyfriend — who was previously barred from visiting Chianese's mother and son — killed Chianese. She was mourned within the community, and through the partnership of Assemblyman Anil Beephan, Assemblyman Brian Cunningham, and Sens. Rob Rolison and Michelle Hinchey, a bill to close that loophole and provide equal orders of protection to all members of a family has been approved by both legislative bodies. The bill, Melanie's Law, now makes its way to Gov. Kathy Hochul's desk.

Senator Rolison (39th District) said in a statement, "This is a great day for New Yorkers and one step closer to the goal of protecting domestic violence victims and families across our state. Melanie's Law is bipartisan legislation that will close a

dangerous legal loophole and empower survivors. Now Democrats and Republicans alike must come together to urge Governor Hochul to sign this critical bill into law as soon as possible."

"This could not have happened without bipartisan support, which is why I want to thank my colleague in the Assembly, Assemblyman Cunningham, and my colleagues in the Senate, Senators Hinchey and Rolison, for their unwavering support and dedication to this important issue," Beephan said.

"I want to thank Cheryl, Melanie's mother, for sharing her story and bringing awareness to this issue. I feel incredibly honored to have been part of this body of advocates and legislators to enact real change that will protect people in the future. The best of government is people coming together to solve problems, and in Melanie's memory, I was glad we could do that here," Beephan concluded.

# County Public Safety Dispatchers recognized for accomplishments with EMS Awards

The Dutchess County Emergency Medical Services (EMS) Council hosted its annual EMS Awards Ceremony on May 22, which was during EMS Week, at the Dinsmore Golf Club in Staatsburg, to recognize dedicated EMS providers, agencies and local hospital staff. Several Dutchess County Department of Emergency Response 9-1-1 Public Safety Dispatchers were among the honorees recognized for their work and dedication in the field. Public safety dispatchers have a critical, behind-the-scenes role in EMS, particularly during recent high stress incidents that have included suicide attempts, explosions, and other life-threatening situations.

County Executive Sue Serino said, "As we continue to highlight the importance of EMS as an essential service, we are thrilled to celebrate the accomplishments of so many dedicated people who are serving in the EMS field, helping to save lives every day, including our own Dutchess County Public Safety Dispatchers. When people call 9-1-1 for help, they have the expectation of getting help quickly. We are grateful to all those who are diligently working every day to ensure that happens. We recognize the challenges facing the EMS profession across the nation, and we are committed to developing solutions to ensure this essential service continues to be available to anyone who needs it."

Erin Downing was honored with the EMS Communications Specialist of the Year Award. Downing began her career with Dutchess County's 9-1-1 Center in 2021 and was promoted to Public Safety Dispatcher in October 2023. In her role, she has taken numerous calls from individuals, or those whose family members were experiencing significant medical emergencies or mental health crisis, including suicide attempts. Downing handles these intense and sensitive calls with compassion, empathy and professionalism, remaining on the line with the caller until first responders arrive on the scene, and has been a critical part of saving lives. This is the second time Downing has received the EMS Communications Specialist of the Year Award.

Public Safety Dispatchers Peggy Mulligan, Linda Polinsky, Kerry Vittone, Joe Dingee, Doug Eighmy, Dan Emery, Andrew Ludwig, Catherine Larkin and Brian Labulis, who comprised the Dutchess County 9-1-1 Center's "Group Three" team were all honored with the Excellence in EMS Quality and Safety Award, given to EMS personnel who have made a significant contribution to enhance the focus on the delivery of EMS in the community, leading to a measurable and sustainable improvement in EMS safety, patient care quality

and/or the efficiency of response or resource development. Group Three was recognized for its speed, accuracy and compassion in taking calls during crises, including the November 2023 gas explosion and house fire in the Village of Wappingers Falls and the June 2023 tractor trailer rollover accident into a body of water in the Village of Millerton. During incidents such as these, dispatchers must manage a rapid influx of calls, dispatch hundreds of units and assist with essential communications, all while handling other 9-1-1 calls from throughout the rest of the county. Despite the stress and intense nature of such emergencies, the dispatchers remained focused, working together and in collaboration with first responders, both on the radio and the phone.

In 2023, public safety dispatchers at the Dutchess County 9-1-1 Center answered more than 210,000 individual phone calls and dispatched assistance to over 118,000 individual incidents through the 9-1-1 Computer Aided Dispatch system.

Director of Dutchess County 9-1-1 Timothy Darcy said, "Our 9-1-1 Center Dispatchers handle every call with a consistent level of calm professionalism. Whether coordinating resources during significant emergencies, helping individuals in mental health crisis or answering accidental 9-1-1 calls, our dispatchers treat each caller with the same calm empathy and skill, while helping ensure first responders receive relevant information. We are proud to celebrate these

individuals' dedication to their work and the wellbeing of our community."

Our staff at the 9-1-1 Center are committed to helping save lives and make a difference in our community, and we are grateful for their professionalism and compassion for callers and first responders alike."

# Young Engineers Empowerment Program participants have a passion for 'engineering, science'

Ten students from area high schools had the opportunity to participate in a pilot program, Young Engineers Empowerment Program. Program participants met for two hours on consecutive Saturdays (since April 27th) at Peach Hill Park in the town of Poughkeepsie.

Lora Schilling is a licensed professional engineer who is based in Beacon.

"The program [went] very well, which is especially exciting as it is our pilot program. We have such a brilliant group of students, each one with a passion [for] engineering and science. After finishing our design session last fall, we are working through the construction session this spring to bring the students' design to life," Schilling, who is on the Dutchess County Environmental Management Council, explained recently.

"In the fall session, the students learned valuable STEM (Science, Technology, Engineering, Math) skills that go into engineering and stormwater management design, including watershed delineation, water quality volume calculations, soil investigation and infiltration testing, landscape architecture design, and engineering plan drawing development," said Schilling. "In this spring session, the students learned how to survey the area using theodolite equipment, stake out the project area, protect downstream environmental resources, install erosion control, and build the actual rain garden. One student (with the winning design) even presented her design to the Board at Peach Hill, which was a great learning experience as well."

Students that signed up for the program are sophomores, juniors and seniors in local high schools.

Briana, one of the program participants

stated, "The program [went] really well! I [learned] a lot about the implementation of engineering practices, watershed delineation, the importance of native plants, soil testing, and the role the soil type plays when calculating infiltration rates. We were each tasked with creating our own designs for the garden, and then voted on which one we liked the best. My design won the vote, and I presented the program and our rain garden idea to the Peach Hill Board, which was a great experience. It's also really cool to see my design come to life!"

Schilling said, "The rain garden the students have designed and built serves the purpose of treating stormwater runoff at Peach Hill Park. The students learned about the flooding issues at Peach Hill, as well as the need to protect the resources in the park from pollution, and came together to solve the problem. When it comes down to it, engineering is real life problem solving." Schilling continued, "As engineers, we get to solve problems all the time, which can be a fun and rewarding challenge. This project was developed by the Environmental Management Council to help students learn what engineering is and be able to engage in the entire process that goes into an engineering project. I teamed up with Maribel Pregnall Mueller, President of Peach Hill Park, to develop a program that could help the community while also teaching students valuable engineering skills. Many of my colleagues at HVEA Engineers were instrumental in the program as well. Everyone has been incredible in dedicating time to the program and educating us on their expertise. This rain garden is an example for the community of how easy it can be for them to design and build rain gardens in their own back-

yard. We hope to continue the program in the future for other real-world applications within our community."

Briana is expected to graduate from Arlington High School in the Arlington Central School District in June and plans on attending Rensselaer Polytechnic Institute, in Troy, to study civil engineering.

"I wanted to join the program to experience different fields of engineering like agricultural or civil," said Krystell, another program participant. Krystell said the

program was went well and the participants "were making progress."

Briana added, "... I enjoy engineering and problem solving, and I wanted to help out my community using those two things. I knew that the Peach Hill program would be a good learning experience for me, and gave me exposure to what engineering is really like when you are solving real life issues."

"I hope to become a civil engineer in the future, and help innovate and improve our world!" said Briana.

Join the Clinton Historical Society's self-guided Historic Landmarks Driving Tour on Saturday, June 15. Docents posted at twelve landmark Clinton properties will offer exterior tours and historical information from 11 a.m. to 3 p.m., followed by an After-Party in the gardens at Mole Manor.

The Town of Clinton is a Dutchess County gem remarkable for its rich tapestry of historic homes and well-preserved rural landscape.

"Clinton has an extraordinary number – 338, in fact – of historically significant properties," said Cynthia Koch, Clinton

Historical Society president. "This is almost 50 percent of the 777 structures in our town built before 1965, which shows how little the landscape has changed."

The tour takes participants at their own pace through the hamlets of Clinton Corners, Schultsville, Hibernia, and to visit old farm and mill houses nearby. A keepsake tour map includes suggested lunch spots along the route.

The Clinton Historical Landmarks Driving Tour is a follow-on of the Society's successful 2019 Driving Tour and seeks to raise awareness of the rich architectural assets of Clinton. Further, as Koch notes, "This is a major fundraiser to help support the \$1.5 million restoration of our 1777 Quaker stone meeting house,

known as the Creek Meeting House, where the tour will begin. Listed on the National Register, the meeting house, which was built during the American Revolution, requires major restoration, including structural, safety, and HVAC improvements to keep it preserved for future generations.

"Just this year," she continued, "we completed Phase I, which installed ADA-accessible parking, entrance, and restroom."

Other highlights of the event include a Silent Auction, where donated items include watercolors by artist Olin Dows (1904-1981), a ski week in Vail, Colorado, a week's working stay at Primrose Hill Farm, a researched historic

house history, a piece of jewelry from Zimmer Brothers, chef's services for dinner for 10, and more. Visitors can test their knowledge of vintage farm tools and antiques in "What Is It?" contests along the tour.

Registration and tour maps may be obtained at the Creek Meeting House, 2433 Salt Point Turnpike, Clinton Corners beginning at 11 a.m. Registration is \$50 for Clinton Historical Society members, \$60 for non-members, and \$40 for Garden After-Party only. 

# Italian slang

A handy guide to watching some popular shows...

Many of you have watched "The Sopranos." Some others have watched the "Jersey Housewives" or "The Jersey Shore." I have heard many times that the slang Italian terms that were used in these shows were very confusing. So in today's column, I will translate these terms and use them in sentences for you. -beep- ming-` Pronounced ming'. Often used instead of madon. It is a slang for dang.

-beep- stunad- Pronounced stew-nad'. It is a slang term to refer to someone who is not intelligent or thick-skulled.

-beep- friggan- pronounced fri-gan'. An adjective used to emphasize the next word. Most similar to freaking.

-beep- Tony will now use ming, stunad and friggan in a sentence:

Ming! Can you believe that stunad! He almost ran in to me with his friggan car!

-beep- agita – Pronounced AA-jih-tuh. It is slang for acidita. Its literal meaning is heartburn or indigestion.

-beep- boombots –Pronounced boom-BAATS. It is a slang nickname for an idiot; as in "Vinnie Boombots."

-beep- braggiol' – Pronounced BRAA-JH-oel. It is slang for bracciole, which is a stuffed rolled meat and sauce.

-beep- Frankie will now use agita,

boombats, and braggiol in a sentence.

Can you believe that boombots! He burned the friggan braggiole. Ming! Now I got agita.

-beep- chefai? –Pronounced ke-FYE. It is slang for che cosa fai? Which means "what are you doing?"

-beep- facciabruitt' –Pronounced FA-chuh-broot. It is slang for faccia brutta or ugly face.

-beep- fugazi – pronounced fu-GAEZIE. It is slang for fake and is likely English in origin.

-beep- Tony will now use chefail, facciabruitt, and fugazi in a sentence.

Hey facciabruitt. Chefai? That watch you sold me is fugazi.

-beep- pasta vasul' – Pronounced pasta-faa-ZOOL. It is slang for pasta fagioli, which is an Italian soup made with beans and pasta.

-beep- guppin' – Pronounced goo-PEEN. It is slang for coppino, which is Italian for ladle.

-beep- gavone – Pronounced gaa-VOAN. It is slang for cafone, which in Italian means gluttonous eater.

-beep- Frankie will now use pasta vasul, guppin and gavone in a sentence.

Ming, what a gavon. We all took one guppin of pasta fasul and he took two.

-beep- fudeddaboudit – pronounced fa-gedda- BAWDIT. It is slang for forget about and is English in origin.

-beep- gidrul' – pronounced jih-DROOL. It is slang for cetriolo, which literally means cucumber but also refers to a stupid person.

-beep- scharol'/scarol – pronounced shkaa-ROAL. It is slang for scarola, which literally means escarole but also refers to money.

-beep- Tony will now use fuggedaboudit, gidrul, and scharol in a sentence.

Fugeddaboudit. That gidrul will never make any real scharol.

-beep- how'ya doin? – prnounced how-ya-DOOin. It is slang for "how are you doing?" It is English in origin.

-beep- paesan' – pronounced pai-ZAAN. It is slang for paesano, which means fellow Italian countryman.

-beep- musciad – pronounced moo-SHYAAD. It is slang for musciata or ammosciato, which literally means mushy.

-beep- Frankie will now use use how'ya doin?, paesan' and musciad in a sentence.

Hey paesan. How'ya doin? Can you bring this pasta back to the kitchen and have them cook it al dente. It's friggan musciad.

-beep- And now Tony and Frank will use all the above terms in a paragraph.

**Tony:** I think I got agita from Rita's macaroni. Marone that was friggan musciad.

**Frankie:** Yeah it was musciad, but ming, that braggiol was beautiful. She put a nice guppin' of gravy on it it.

**Tony:** Fugeddaboutit. Did you see that gidrul Johnny. He ate like a friggan gavon. He had tree bowls of pasta vusul and a loaf of bread.

**Frankie:** What a facciabruitt'. When it came time to pay the friggan check, you think he would have thrown in some scatole? Nope he just sat there. He thinks he's a paesan'. He's not. He's just a fugazi Italian.

**Tony:** Marone I'm still hungry. What do you say we stop by Gristides and pick up some gabbagool and some proshut?

**Frankie:** Your such a boombots. I still got agita from the macaroni! Stunad!

I hope these that these terms and translations will help you the next time you watch your favorite show. While you study them and decide how to use them in your everyday language, please enjoy the following recipe for braciola.

Buon Appetito!

### Beef Braciola Ingredients

1 tablespoon olive oil  
4 tablespoons of chopped parsley  
1 medium red pepper, diced  
1 medium onion, diced  
1/2 cup plain dry bread crumbs  
8 tablespoons of grated parmagiana cheese  
8 thin slices top round beef for braciola (about 2 oz. each)  
10 oz. red wine  
1 32oz. jar of Coppola's Tuscan sauce

### Directions

Heat half the oil in a 10-inch skillet over medium heat. Add the parsley, pepper and onion and cook until the vegetables are tender, stirring occasionally. Stir in the bread crumbs. Stir in the cheese. Remove the skillet from the heat.


Spread 1/2 cup vegetable mixture onto each beef slice. Roll up the beef around the filling and secure with toothpicks. Roll each braciola in flour.

Heat the remaining oil in the skillet over medium-high heat. Add the beef rolls and cook until well browned on all sides. Stir in the sauce, scraping up the browned bits from the bottom of the skillet. Reduce the heat to low. Cook for 20 minutes or until the beef is fork-tender.

Serve over a heart pasta such as rigatoni.

# Hummingbirds: A lot in a little package

I have a little buddy that sips nectar from my petunias in the summer. She zips about from flower to flower, and then she is gone in a flash! She is a Ruby Throated Hummingbird. Diminutive hummingbirds can illustrate several abstract biological concepts.

**Co-evolution:** The hand-in-glove match of narrowly shaped, nectar-bearing flowers to slender nectar-sipping hummingbird beaks is evidence that hummingbirds were shaped by co-evolution. Most flowering plants need pollinators. Some plants are pollinated by bees or bats. But flowers with long nectaries require specialized pollinators. Hummingbirds fill that niche.

**Survival of the Fittest & Sexual Selection:** Even the smallest hummingbirds can be quite aggressive against much larger birds. Their extraordinary mobility allows hummingbirds to successfully chase away potential predators like hawks and crows. Hummingbirds are also aggressive against other hummingbirds! This can result in fights over good feeding territories.

Evolution has acted not only to make flower and beak shapes complementary, but also to make some beaks weapon-like. Two examples of fierce hummingbird beaks are found on swordbill and tooth-billed hummingbirds. The beak of a swordbill is as long as its body. Male tooth-billed hummingbirds' beaks are thick, rigid, and hooked at the end. The weaponized adaptations of those hummingbird bills make them more fit for their environments. The birds use their beaks to fight off rivals for mates, thus improving their chances of passing their genes to future generations.

Our local Ruby-throated Hummingbirds don't have long or hooked beaks. But they can still be quite aggressive! This is especially true near hummingbird feeders or desirable flowering plants like trumpet creepers and lobelia.

## Tibetan singer and activist to perform on June 2 in Cold Spring

The Highlands Choral Society will present Tibetan singer and peace activist Loten Namling in a rare U.S. appearance, performing traditional Tibetan songs with the theme of Unconditional Love. The concert will take place on Sunday, June 2, at 3 p.m. at the Highlands Chapel, 216 Main St. in Cold Spring, Putnam County.

Loten has dedicated his entire life to preserving the Tibetan culture, primarily through performing traditional music at venues large and small across the globe, from the Berlin Music Festival to a tiny remote village in Nepal. In his own words, "I have never killed an ant, or a fly, but the world

**Respiration and Nutrition:** Cellular respiration is the process of getting energy from nutrients, specifically sugar. Unlike humans, whose bodies suffer ill-effects from high sugar consumption, the bodies of hummingbirds efficiently move sugar through their digestive and circulatory systems and into their muscle cells very quickly. As the tiny birds zip about, they're burning the sugar that they've eaten within the last hour. With all of their frenetic movements, it's not surprising to learn that their metabolism is 77 times faster than humans'.

In the human body, sugar is processed through a complex series of steps. Excess sugar is stored in the liver. Hormones regulate the absorption and release of sugar so that our bodies have a steady supply for our daily activities. In humans, elevated blood glucose can damage the cardiovascular system, kidneys, eyes, and nervous system.

**Aerodynamics:** Hummingbirds have the musculoskeletal system of birds, but fly like insects. They specialize in the most energy-expensive form of locomotion in nature: hovering. They can also perform aerial maneuvers, including 180 degree turns.

The birds rotate their wings in a figure-eight pattern. That movement pushes air forward, backward and downward, generating lift force on both the forward and back strokes of the wing. By adjusting the angle of its wings and tail, hummingbirds can hover in one spot, move forward or backward, or pivot to either side.

Researchers are inspired by hummingbirds' flight forms and agility. They are working to design aerial vehicles that mimic hummingbird movement. Some flying robots, such as drones, have been developed that can hover. Improvements are still necessary in terms of duration of flight and the amount of noise produced.

**Scientific Inquiry:** Hummingbirds are good research subjects. They will fly to feeders, undeterred by humans. They also fly well in wind tunnels and cages. The tiny birds are capable of learning. Scientists have speculated that, because they live on the edge in terms of their energy budget, they may require greater intelligence to remember the locations of food sources.

The next time you catch a glimpse of a hummingbird, take a moment to appreciate their awesomeness. They can teach us much about science. They are a

lot in a little package.

**TOWN OF PLEASANT VALLEY PROPOSED LOCAL LAW A OF 2024 A LOCAL LAW AMENDING CHAPTERS 20 AND 98 TO SPECIFY TRAINING AND ATTENDANCE REQUIREMENTS FOR MEMBERS OF THE PLANNING BOARD AND ZONING BOARD OF APPEALS, CHANGE THE NUMBER OF ZBA MEMBERS, AND SPECIFY USE OF ALTERNATE MEMBERS FOR BOTH BOARDS BE IT ENACTED** by the Town Board of the Town of Pleasant Valley as follows:

**SECTION 1.****TITLE.**

This Local Law shall be entitled "A Local Law Amending Chapters 20 and 98 to Specify Training and Attendance Requirements for Members of the Planning Board and Zoning Board of Appeals, Change the Number of ZBA Members, and Specify Use of Alternate Members for Both Boards".

**SECTION 2.****PURPOSE AND INTENT.**

A. The Town Board of the Town of Pleasant Valley appreciates the dedication and service of the members and alternate members of the Planning Board and Zoning Board of Appeals ("ZBA") and wishes to modify and clarify certain requirements and procedures to maximize the boards' effectiveness.

B. The Town Board finds that appropriate training and regular attendance of the ZBA and Planning Board members is essential to the proper functioning of said Boards.

The Legislature of the State of New York has recognized the importance of training and has established training and attendance requirements in its recent amendments to the ZBA and Planning Board statutes as contained in §§ 267 and 271 of the Town Law.

C. It is the purpose of this local law to ensure that ZBA and Planning Board members obtain appropriate training to enhance their ability to carry out their duties under applicable provisions of law and to pay the reasonable costs of such training as a Town charge. It is the further purpose of this article to establish minimum attendance requirements for such members at meetings to assist in the proper functioning of the Planning Board and the ZBA.

D. The Town Board also finds it appropri-

ate to modify the number of ZBA members to five to conform to Town Law § 267.

E. Finally, the Town Board finds that the functioning of the Planning Board and ZBA, and the Town's review of land use applications, would be best served by clarifying the role of alternate members of the Planning Board and ZBA. The Town Board deems it appropriate for alternate members to take part in board deliberations so that they are able to step in as voting members when needed to ensure business can be conducted.

**SECTION 3.**  
**AUTHORITY.**

This law is enacted pursuant to Section 10 of the Municipal Home Rule Law.

**SECTION 4.**  
**AMENDMENTS TO THE CODE.**

A. Chapter 20, "Planning Board", is hereby repealed and replaced as follows:

**Chapter 20: Planning Board and Zoning Board of Appeals****§ 20-1. Training and Attendance Requirements for Planning Board and Zoning Board of Appeals.**

A. Each member of the Planning Board shall be expected to review and familiarize himself/herself with the Town's Subdivision Regulations and those portions of the Zoning Law which relate to the powers and duties of the Planning Board, and Article 16 of the Town Law.

B. Each member of the Zoning Board of Appeals (ZBA) shall be expected to review and familiarize himself/ herself with those portions of the Zoning Law which relate to the powers and duties of the ZBA, and Article 16 of the Town Law.

C. The members of the Planning Board and ZBA shall be expected to conduct themselves in conformity with all rules and regulations that may be adopted by the Town Board and/or by the Planning Board or ZBA, as the case may be, for the conduct of meetings and public hearings of the respective Boards.

D. Each member of the Planning Board and ZBA shall complete, at a minimum, four hours of training each year designed to enable such member to more effectively carry out their duties. Any training received by a member in excess of four hours in any one year may be carried over by that member into

succeeding years in order to meet this training requirement, all in accordance with the provisions of Town Law §§ 267 and 271.

E. Any such training for Planning Board and ZBA members shall be approved by the Town Board and may include, but not be limited to, training provided by a municipality, regional or county office or commission, county planning, federation, state agency, statewide municipal association, college or other similar entity, and such training may be provided in a variety of formats including, but not limited to, electronic media, video, distance learning and traditional classroom training. The Town Board shall pay or reimburse the Board members for the reasonable cost of their four-hour training sessions.

F. To be eligible for a reappointment at the expiration of a Planning Board or Zoning Board of Appeals member's term, such member shall have completed the training as required by this article and by Town Law §§ 267 and 271.

G. The training provided by this law may be waived or modified by Resolution of the Town Board when, in the judgment of the Town Board, it is in the best interest of the Town to do so.

H. No decision of the Planning Board shall be voided or declared invalid because of a failure of a member to comply with the training or other requirements of this Resolution.

I. No member of the Planning Board or Zoning Board of Appeals may miss three regularly scheduled meetings of the Board during a calendar year, other than for a medical or other emergency or for any other just cause approved, in advance, by the Chair of the Planning Board. It is expected that Board members be on time and call the Chair or Secretary if he/she cannot attend a meeting.

J. The Town Board shall have the power to remove, after public hearing, for cause, any Planning Board or ZBA member. Cause for removal shall include, but shall not be limited to:

(1) Noncompliance with the minimum requirements relating to training and education as established in this article and/or by Town Law;

(2) Noncompliance with the meeting attendance requirements as established by this article;

(3) Failure to comply with the residency requirements as are set forth for Public Officers or in the Town Law;

(4) Failure to disclose a conflict of interest as required by the Town's Code of Ethics;

(5) Failure to comply with the applicable provisions of the Pleasant Valley Code of Ethics;

(6) Failure to comply with any rules or regulations as may be prescribed for the conduct of Board members by the Town Board, Planning Board or ZBA; and

(7) Such other and further cause as may be established by the Town Board by local law.

K. Prior to the conduct of any public hearing for the removal of a Planning Board or ZBA member for cause, the Town Board shall provide the Board member with a statement setting forth the alleged grounds for such removal at least 30 days prior to the conduct of the public hearing.

L. During the public hearing, the Town Board shall have the power to hear testimony and receive evidence presented by the Town Attorney, by the Chair of the applicable Board or by any other person in support of, or against, the grounds for such removal.

M. The Board member shall have the right to present witnesses and other evidence in defense of the removal action and the Town Board shall have the power to hear other witnesses and members of the public, and receive documentation and evidence relevant to the issue of the alleged cause for the Board member's removal.

N. The Town Board shall have the power to remove, after a public hearing, any member of the Planning Board or ZBA member for cause.

O. A copy of this article shall be supplied by the Town Clerk to each member of the Planning Board and ZBA.

P. In Chapter 98, "Zoning," section 98-92, "Planning Board organization," is repealed and replaced as follows:

**§ 98-92. Planning Board organization.**

A. Powers and Duties

(1) The Town Planning Board shall have and exercise the following powers and duties:

(a) To approve all plats of subdivision showing lots, blocks or sites, with or without streets or highways, within the Town.

(b) To pass upon and approve the development of plats already filed in the office of the Clerk of Dutchess County if such plats are entirely or partially undeveloped.

(c) To approve or disapprove changes in the lines of existing streets, highways or public areas shown on subdivision plats or maps filed in the County Clerk's office.

(2) The Planning Board may recommend to the Town Board regulations relating to any subject matter over which the Planning Board has jurisdiction pursuant to § 271 of the Town Law, or any other statute or under any local law or ordinance of the Town. Adoption of any such recommendations by the Town Board shall be by local law or ordinance.

(3) The Planning Board shall submit a report to the Town

attendance at required training sessions and to provide to the Planning Board and Zoning Board Secretary, as the case may be, certificates of attendance for completion or other proof of completion of training courses on an annual basis. The Planning Board and ZBA Secretary shall keep records of the attendance of each Board member at the required training courses and shall present, at the close of each calendar year, a list of each Board member's courses and credits earned in that year, together with any credits carried over from previous years, to the Town Clerk and to the Town Board.

N. The Planning Board and ZBA Secretaries shall also keep records of the attendance of Board members at meetings and shall provide attendance records to the Town Clerk and to the Town Board on a quarterly basis.

O. A copy of this

article shall be supplied by the Town Clerk to each member of the Planning Board and ZBA.

P. In Chapter 98, "Zoning," section 98-92, "Planning Board organization," is hereby maintained with seven members.

**§ 98-92. Planning Board organization.**

A. Powers and Duties

(1) The Town Planning Board shall have seven years with one term ending each year. One member shall be designated the Chairperson by the Town Board and shall serve as Chairperson at the pleasure of the Town Board.

(2) A person who is a member of the Town Board shall not be eligible for appointment to the Planning Board. However, no person shall be disqualified from serving as a member of the Planning Board by reason of serving as a member of a village or county planning board.

(3) If a vacancy shall occur otherwise than by expiration of term, the Town Board shall appoint a new member for the unexpired term.

(4) The Town Board shall have the power to remove, after a public hearing, any member of the Planning Board for cause.

(5) The Town Board shall have the power to remove, after a public hearing, any member of the Planning Board for cause.

(6) Alternate Members.

(a) Definitions. As used in this section, the following terms shall have the meanings indicated:

**ALTERNATE MEMBER** — An individual appointed by the Town Board available

for service when a regular member of the Planning Board must be absent or is unable to participate on an application or matter before the Board due to a conflict of interest or otherwise, as provided herein.

(b) Number and term of alternate members. The Town Board shall appoint, by resolution, two alternate members to the Planning Board for a term of two years, with their terms to expire on December 31 of the second year after the date of their appointment.

(c) Designation of an alternate member.

[1] The Chairperson of the Planning Board shall designate an alternate member to substitute for a member when such member is absent or is unable to participate on an application or matter before the Board. If there are two alternate members, they shall be designated for service on a rotating basis. When so designated, the alternate member shall possess all of the powers and responsibilities of such member of the Board. Such designation shall be entered into the minutes of the first meeting of the Planning Board at which the substitution is made.

[2] Provided that all other requirements of this section are satisfied, the designation of an alternate member to serve as a member may be made for a particular meeting or meetings, or for a specified period of time, but no event beyond the duration of the alternate member's appointment as an alternate member. The designation to substitute shall take place only when a regular Board member in whose place the alternate member shall act is absent or otherwise unable to serve as specified herein.

[3] Upon the return of an absent regular member or the resumption of the regular member's ability to serve, the alternate member shall automatically resume his/her status as an alternate member and shall no longer be allowed to vote on Board affairs. The alternate member shall remain eligible to substitute in the future for the same or other regular members, subject to the same requirements of eligibility set forth herein, including redesignation as an acting member of the Board.

[4] When an alternate member is not designated to serve as a member at a particular meeting, the alternate member may sit with the Board and may take part in discussion so that the alternate will be prepared if called upon to vote on an application at a future meeting.

(d) Duties and responsibilities of alternate members. All provisions of state law relating to the Planning Board member eligibility, vacancy in office, removal, compatibility of office and service on other boards, as well as any provisions of a local law/local ordinance relating to training, continuing education and attendance, shall also apply to alternate members.

**C. Planning Board Procedure.**

(1) Meetings of the Planning Board shall be held at the call of the Chairperson and at such other times as such Board may determine. Such Chairperson, or in his or her absence the Acting Chairperson, may administer oaths and compel the attendance of witnesses.

(2) The Planning Board shall have the power and authority to employ experts, clerks and a secretary, and to pay for their services, and to provide for such other expenses as may be necessary for the Planning Board to carry out its duties, not exceeding the appropriation made for such purposes.

(3) The Town Planning Board may adopt rules and regulations in respect to procedure before it and in respect to any subject matter over which it has jurisdiction under this chapter or any statute, after public hearing by such Board and subject to the approval of the Town Board.

C. In Chapter 98, "Zoning," section 98-95, "Establishment and powers of Zoning Board of Appeals," is repealed and replaced as follows:

**§ 98-95. Establishment and powers of Zoning Board of Appeals.**

A. Creation, appointment and organization.

(1) This chapter shall be administered by a Zoning Board of Appeals maintained in accordance with Article 16, § 267, of the Town Law.

(2) The Zoning Board of Appeals shall consist of five members appointed by the Town Board. The Town Board shall designate the Chair

and fix the terms of office of the members. The Town Board shall appoint a Secretary and shall prescribe rules for the conduct of its affairs.

(2.a) The Board shall transition from seven members to five as follows: For the year 2024, the Board shall consist of seven members. Beginning in January 2025, the board shall consist of five members. If there are more than five members whose terms extend into 2025, the members with the least time on the board shall be changed to alternates or removed from the Board to ensure a five-member Board.

**(3) Alternate Members.**

(a) Definitions. As used in this section, the following terms shall have the meanings indicated:

**ALTERNATE MEMBER** — An individual appointed by the Town Board available for service when a regular member of the Zoning Board of Appeals must be absent or is unable to participate on an application or matter before the Board due to a conflict of interest or otherwise, as provided herein.
**(b) Number and term of alternate members.**

The Town Board shall appoint, by resolution, two alternate members to the Zoning Board of Appeals for a term of two years, with their terms to expire on December 31 of the second year after the date of their appointment.

**(c) Designation of an alternate member.**

[1] The Chairperson of the Zoning Board of Appeals shall designate an alternate member to substitute for a member when such member is absent or is unable to participate on an application or matter before the Board. If there are two alternate members, they shall be designated for service on a rotating basis. When so designated, the alternate member shall possess all of the powers and responsibilities of such member of the Board. Such designation shall be entered into the minutes of the first meeting of the Zoning Board of Appeals at which the substitution is made.

[2] Provided that all other requirements of this section are satisfied, the designation of an alternate member to serve as a member may be made for a particular meeting or meetings, or for a specified period of time, but no event beyond the duration of the

alternate member's appointment as an alternate member. The designation to substitute shall take place only when a regular Board member in whose place the alternate member shall act is absent or otherwise unable to serve as specified herein.

[3] Upon the return of an absent regular member or the resumption of the regular member's ability to serve, the alternate member shall automatically resume his/her status as an alternate member and shall no longer be allowed to vote on Board affairs.

The alternate member shall remain eligible to substitute in the future for the same or other regular members, subject to the same requirements of eligibility set forth herein, including redesignation as an acting member of the Board.

[4] When an alternate member is not designated to serve as a member at a particular meeting, the alternate member may sit with the Board and may take part in discussion, so that the alternate will be prepared if called upon to vote on an application at a future meeting.

**(d) Duties and responsibilities of alternate members.**

All provisions of state law relating to the Zoning Board of Appeals member eligibility, vacancy in office, removal, compatibility of office and service on other boards, as well as any provisions of a local law/local ordinance relating to training, continuing education and attendance, shall also apply to alternate members.

**B. Powers.** The Zoning Board of Appeals shall have all the powers and duties prescribed by law and by this chapter, which are more particularly specified as follows:

(1) Interpretation. Upon appeal from a decision by the Zoning Administrator, to decide any question involving the interpretation of any provision of this chapter, including determination of the exact location of any district boundary if there is uncertainty with respect thereto.

(2) Special use permits. To issue special use permits when appropriate for any of the uses for which this chapter requires the obtaining of such permits from the Board of Appeals.

(3) Variances. A variance is permission granted by the Zoning Board of Appeals so

that property may be used in a manner not allowed by zoning. It is only the Zoning Board of Appeals that has the power to provide for such exceptions from the zoning. Since zoning is meant to implement the municipality's development objectives and protect the health, safety and general welfare of the people, there are strict rules governing when exceptions may be provided. In granting any variance, the Zoning Board of Appeals shall prescribe any conditions that it deems to be necessary or desirable.

(3.a) No variance from the strict application of any provision of this chapter shall be granted by the Zoning Board of Appeals unless it finds:

[1] That there are special circumstances or conditions, fully described in the findings of the Zoning Board of Appeals, applying to such land or buildings and not applying generally to land or buildings in the neighborhood, and that said circumstances or conditions are such that strict application of the provisions of this chapter would deprive the applicant of the reasonable use of such land or buildings.

[2] That, for reasons fully set forth in the findings of the Zoning Board of Appeals, the granting of the variance is necessary for the reasonable use of the land or building and that the variance as granted by the Zoning Board of Appeals is the minimum variance that will accomplish this purpose.

[3] That the granting of the variance will be in harmony with the general purpose and intent of this chapter and will not be injurious to the neighborhood or otherwise detrimental to the public welfare.

(3.b) Any variance which is not exercised within one year from the date of issuance or which has now been or hereafter remains unexercised for a continuous period of one year is hereby declared to be revoked without further hearing by the Zoning Board of Appeals.

(3.c) The regulations for the two types of variances are as follows:

[1] Use variances. [a] The Zoning Board of Appeals, upon appeal from the decision or determination of the Zoning Administrator, shall have the power to grant use variances, authorizing a use of land which otherwise

would not be allowed or would be prohibited by the terms of this chapter.

[b] No such use variance shall be granted by the Zoning Board of Appeals without a showing by the applicant that the applicable regulations and restrictions imposed by this chapter have caused unnecessary hardship. In order to prove such unnecessary hardship, the applicant shall demonstrate to the Zoning Board of Appeals compliance with each of the following criteria:

[b.i] That under the applicable regulations and restrictions imposed by this chapter, the applicant is deprived of all economic use and benefit from the property in question, which deprivation must be established by competent financial evidence.

[b.v] Whether the alleged difficulty was self-created, which consideration shall be relevant to the decision of the Zoning Board of Appeals but shall not necessarily preclude the granting of the area variance.

[c] The Zoning Board of Appeals, in the granting of an area variance, shall grant the minimum variance that it shall deem necessary and adequate and at the same time preserve and protect the character of the neighborhood and the health, safety and welfare of the community.

[b.iii] That the requested use variance, if granted, will not alter the essential character of the district or neighborhood.

[b.iv] That the alleged hardship has not been self-created.

[c] The Zoning Board of Appeals, in the granting of a use variance, shall grant the minimum variance that is deemed necessary and adequate to address the unnecessary hardship proven by the applicant and at the same time preserve and protect the character of the neighborhood and the health, safety and welfare of the community.

[2] Area variances.

[a] The Zoning Board of Appeals, upon appeal from the decision or determination of the Zoning Administrator, shall have the power to grant area variances from the area or dimensional requirements of this chapter as found in the Schedule of Area and Bulk Requirements.<sup>1</sup>

[b] In making its determination, the Zoning Board of Appeals shall take into consideration the benefit to the applicant if the area variance is granted, as weighed against the detriment to the health, safety and welfare of the neighborhood or community by such granting of variance.

In making such determination, the Zoning Board of Appeals shall also consider each of the following factors:

[b.i] Whether an undesirable change will be produced in the character of the

**Legal Notices**

neighborhood or a detriment to nearby properties will be created by the granting of the area variance.

[b.ii] Whether the benefit sought by the applicant can be achieved by some other method feasible for the applicant to pursue, other than an area variance.

[b.iii] Whether the requested area variance is substantial.

[b.iv] Whether granting of the proposed area variance will have an adverse effect or impact on the physical or environmental conditions in the neighborhood or zoning district.

[b.v] Whether the alleged difficulty was self-created, which consideration shall be relevant to the decision of the Zoning Board of Appeals but shall not necessarily preclude the granting of the area variance.

[c] The Zoning Board of Appeals, in the granting of an area variance, shall grant the minimum variance that it shall deem necessary and adequate and at the same time preserve and protect the character of the neighborhood and the health, safety and welfare of the community.

**SECTION 5. SUPERSESSION.**

It is the intent of the Town Board to supersede any provisions of the New York State Law to the extent that they may be inconsistent with the provisions of this local law, pursuant to the Town's supersession authority under Municipal Home Rule Law § 10. The Town Board acknowledges that the provisions for alternate members prescribed herein differ from those in Town Law §§ 267 and 271 and the Town Board exercises its authority to supersede those provisions.

**SECTION 6. SEVERABILITY.**

If any provision of this local law is held invalid for any reason by a court of competent jurisdiction, such decision shall not affect the validity of the remaining provisions of this local law.

**SECTION 7. EFFECTIVE DATE.**

This Local Law shall become effective immediately upon its filing in the Office of the New York State Department of State.
