A \$5.8 million road project is about to get underway in the New Hackensack hamlet section of the Town of Wappinger. The plan is to construct what officials are calling "a modern roundabout" at the triangular intersection of Route 376, New Hackensack Road and All Angels Hill Road. Road closure dates are All Angels Hills Road, May 31 – June 4; Route 376 June 6 - June 11. Officials suggest motorists use alternative routes during that time. All Angels Hill Road will be closed from its intersection with New Hackensack Road south approximately 500 feet, according to Town information. Route 376 will be closed from its intersection with New Hackensack south approximately 700 feet, stated town officials from Wappinger.

"Building back better starts with the needs of our local communities and this project, along with the recent announcement of the expansion of operational support buildings at nearby Hudson Valley Regional Airport, are great examples of the smart transportation infrastructure investments Gov. Hochul and the department are

A family's best friend

Andi Bettencourt has spent her career in the veterinary field. The Beacon resident learned about BluePath Service Dogs through a coworker who volunteered for the organization. That is how Penn, a three-year-old yellow Labrador, and BluePath Service Dog, came into her family's life. Hudson, her son, has been diagnosed as being on the autism spectrum.

"When Hudson came out of school to find me waiting with Penn, he calmly walked over, laid down in the grass next to Penn, and simply said, 'So this is my new brother?'" recalled Bettencourt.

BluePath Service Dogs, Inc. is a 501(c)(3) nonprofit founded. According to its website, it was founded in 2016 "to provide autism service dogs, offering safety, companionship, and opportunities for independence.'

'Penn has assisted Hudson in nearly every aspect of his life. We were essentially housebound, even before the pandemic, due to Hudson's tendency to run when he was upset or overwhelmed," remarked Bettencourt.

Bettencourt explained, "Despite his issues, he was always a

Local districts react to Texas school shooting

On May 24, an 18-year-old gunman opened fire at Robb Elementary School in Ulvade, Texas, killing 19 young students and two teachers. This tragedy occurred only 10 days after another 18-year-old killed 10 people at a Tops Friendly Market in Buffalo, N.Y.

Wappingers Central School District (WCSD) Superintendent Dr. Dwight Bonk said in a statement to the community, "While this tragic event occurred on the other side of our country, it resonates so close to home. There are so many similarities to what transpired today (May 24) to that which occurred at Sandy Hook Elementary School on December 14, 2012. Unfortunately, school shootings have become all too common but each time something like common, but each time something like this happens we feel the same sense of sorrow, anger, and disbelief. Our thoughts and prayers go out to the families of the victims of today's heinous act of violence and our secondary schools will be holding a moment of silence tomorrow (May 25) during their morning announcements."

Beacon City School District (BCSD) Superintendent Dr. Matthew Landahl posted on the district's website, "It is with deep sadness that I write to you about the school shooting in Texas only a few days after the racist mass shooting in a grocery store in Buffalo. I am reaching a point in my career where I struggle to find words. I grieve all of this sense-less violence and I pray for all of the victims and their families.

Landahl noted, "It is important to remind ourselves of what we do in our district regarding school safety. have solid emergency and safety plans and our school administrators and security director work closely with the Beacon Police Department and the Town of Fishkill to review these plans frequently. Our mental health professionals are available to speak with and provide assistance to students who want to talk more tomorrow and in the days moving forward."

Bonk also noted the security steps that the WCSD takes at its' schools.

This event reinforces the need for us all to be vigilant, and to ensure that best practices and protocols are in place at our schools each and every day. Please know that the safety and security of our students and staff remains our top priority. We will be reviewing our cur rent practices and protocols with our local law enforcement agencies, and with our security consultant to ensure that they are consistent with the current industry standards.'

Bonk said that counseling staff was available to meet with students who were experiencing any form of nxiety or duress due to the tragic incident in Texas.

making across New York State," said NYS Department of Transportation Commissioner Marie Therese Dominguez in a press release.

According to Town of Wappinger Supervisor Richard Thurston, "When I applied for the grant for this project my hopes were then and now that it would: address traffic delays and overall congestion at the challenging intersection; remedy certain drainage issues in the area and excessive inflow of soil and contaminated into the Wappinger Creek; improve New Hackensack business and quality of life for residents in the area; and enable commercial development at the airport."

Dutchess County legislators Lisa Paoloni (District 14) and Joseph Cavaccini (District 15) jointly stated in a release, "Our New Hackensack hamlet is being greatly improved by this redesign of Route 376, All Angels Hill, and New Hackensack roads. Improving traffic flows and enhancing the character of our

town with this new 'hamlet center' will certainly enhance the quality of life for the people of the Town of Wappinger."

Councilman Al Casella said in the release, "I hope the New York State solution will resolve the traffic and safety issues we see at the intersections on New Hackensack Road/Route 376 /All Angels Hill Road. We all want what's best for the Town. I urge residents to learn about roundabout etiquette."

Asked if he had any concerns about first responders getting through the area during construction, Thurston replied, "The NYSDOT procedures require the State's engineers and contractor to consult with local first responders."

Thurston noted that, according to the State DOT, there is no set date for the completion of the project. "The State has confirmed that when the detour is reopened, people will be driving on the new roundabout surface. What will need to be completed will be the curbing, sidewalk, park, etc. There is no date set for this work at this time."

"I would also encourage our families to contact their School Administration or Guidance Department if they have any immediate concerns about their child's safety at school "suggested Bonk

ty at school," suggested Bonk.
He added: "We must continue to work collaboratively as a school community to ensure a safe school environment for everyone!"

Landahl stated that if anyone needed resources to discuss the event with their children, there is a link on the BCSD website one can use

"A key message in this resource and in others is that children benefit from factual information, provided in an age-appropriate way, but none of us benefit from exposure to the repetition of disturbing images and headlines. This is advice I try to follow myself," stated the BCSD superintendent.

"We will continue to monitor the situation and make changes to our emergency plans as we learn more about what happened. We will work to be there for our children and for each other to provide support and kindness as we work through this together. If you have any concerns, please reach out to me or a school administrator," said Landahl.

County, state officials weigh in

"Our hearts ache and in, this moment of terror and anguish, we join in mournful prayer for those young lives, teachers and their families," Dutchess County Executive Marcus Molinaro said in a statement, "May God give them strength in their time of grief."

He added, "It is heartbreakingly clear we need action where our words have failed and consensus where contention has divided us. I believe we all have a role to play in finding solutions and rise to the challenge."

The county has made trauma teams and counseling services available for families, students and schools across Dutchess, he said.

"We must work harder to achieve peace, confront violence and keep our kids safe," said Molinaro.

Jean-Marie Niebuhr, LCSW-R, Deputy Commissioner and Director of Community Services for the Dutchess County Department of Behavioral and Community Health (DBCH), said, "No words exist to describe the events that occurred in Uvalde, Texas yesterday (May 24). The Department of Behavioral and Community Health would like to remind everyone that we have local resources to support everyone during this incredibly difficult time. The Dutchess County Stabilization Center located at 230

North Road in Poughkeepsie and the Dutchess County HELPLINE at 845-485-9700 provide 24-hour access to mental health professionals."

Niebuhr said, "It is normal to feel a wide range of emotions in the wake of tragedy, even if we were not directly impacted. Our sense of safety can feel compromised; we may feel sad, angry and confused. It is important that we are patient with one another and extend kindness and instill hope while we all grieve this senseless loss of life."

She reminds residents that Dutchess County offers a wide range of mental health resources to local school districts, including:

resources to local school districts, including:
- Stabilization Center – available 24/7 at 230 North Road, Poughkeepsie;

- HELPLINE (845-485-9700) – immediate phone or text link with mental health professionals and connection to services;

- Mobile Crisis Intervention Team (MCIT) – caring mental health professionals who can go directly to a person in crisis to help prevent a situation from getting worse, see what the person needs, and connect them to services that can help them right away; and

- Youth Mental Health First Aid training.
Additionally, in response to the shooting at Robb Elementary School, DBCH has been in communication with all school districts within Dutchess County and made trauma teams/counseling services available as needed, as well as reminders

about county services.

The County's Department of Emergency Response has been in touch with all local school districts to review and reinforce school safety plans, as well as the Dutchess County Sheriff's Office and other local agencies to support school resources officers. Residents are also encouraged to download and use the free Dutchess County HELPLINE mobile app, which is available for both Apple and Android devices through their respective app stores.

U.S. Sen. Kirsten Gillibrand issued the following statement:

"Less than two weeks since the Buffalo shooting, another community has been devastated by gun violence. My heart is with the victims, their loved ones and especially with the parents of these innocent children."

Gillibrand noted, "We are the only country in the world that tolerates mass shootings at our schools, stores and places of worship, a fact that is as horrific as it is heartbreaking. The American people must demand that all of our leaders act to stop these senseless killings and hold them accountable if they refuse to do so."

DAR to unveil historic marker commemorating Lafayette's visit to Fishkill

Join the Melzingah Chapter of the Daughters of the American Revolution and the Beacon Historical Society on Monday, June 6 for two special events about the Marquis de Lafayette and his farewell tour in 1824/25.

An unveiling of a historic marker commemorating General Lafayette's visit to Fishkill Landing in 1824 will be held at 2 p.m. on Red Flynn Drive in Beacon. A slide show presentation will be held at 7 p.m. at the Beacon High School Theater.

The evening program will be presented by Julien Icher, president of the Lafayette Trail, a nonprofit organization with the mission to document, map, and mark Revolutionary War Hero General Lafayette's footsteps during his Farewell Tour of the United States in 1824-1825. On September 19, 1824, General Lafayette stopped in Fishkill Landing where he was escorted to the DeWindt House to visit Caroline Smith, granddaughter of U.S. President John Adams. The organization aims to educate the public about the national significance of Lafayette's Tour and to promote a broader understanding of Lafayette's numerous contributions to American independence and national coherence in preparation for the 2024-2025 tour bicentennial celebrations.

social child and loved to go out and talk to people, but the risk became too great and, for his safety, we simply stayed home which had negative impact on his mood and self-esteem. With Penn, we are now able to go out and perform normal tasks such as going to the library, grocery store, or simply a walk down Main Street."


Recently, BluePath held its sixth annual walkathon at FDR State Park in Yorktown Heights, Westchester County.

"We've placed 34 autism service dogs with families, including 10 since our 2021 walk. These extraordinary dogs are keeping kids safe and allowing families to rejoin their communities," said BluePath cofounder and Vice President of Development Michelle Brier.

According to BluePath information, it receives no government funding and relies on the generosity of donors and volunteers to fulfill its mission.

"Our dogs keep children safe when traveling outside the home and make it possible for families to participate in activities together. They offer companionship, emotional support, help with mood regulation, and they empower children to be more independent. Reduced stress, improved sleeping routines, and more meaningful social interactions allow families to feel a renewed sense of hope," said Brier.

Bettencourt said her family has gone on even bigger outings -- such as the Bronx



Zoo and their first vacation, since welcoming Penn into their lives.

"When Hudson goes out, people are always approaching him to ask about his dog, which he loves and gives him the opportunity to build his social skills. It also alerts people to the fact that not all his behaviors and speech patterns will be those of a neurotypical child. It gives me peace of mind for those moments when he does get overwhelmed, that people will see the dog and give us the space we need to handle the situation and not be vocal with opinions about Hudson's behavior," Bettencourt said.

Asked what she would want other families to know about BluePath, Bettencourt replied, "I would want families of children with autism to know that BluePath Service Dogs make things possible. Whether you have extensive plans or simply want to walk down the street and know your child is safe, they can provide that safety and peace of mind."

Brier noted, "We're also expanding our Kids and Canines Learning Together Program, in which future service dogs spend time in schools and work with children in a variety of classroom environments. 1,000 students are impacted annually through this program, a number expected to increase in the coming year. Our professional staff has grown as we've matured and over 150 volunteers now support our mission, fulfilling the intensive roles of puppy raisers and fosters, and contributing as dog sitters, administrative and event volunteers."

Bettencourt thanked BluePath.

"In my experience, it is not often that the parent of a non-neurotypical child finds a group of people who not only accept their child for who they are but look for all the moments of joy and success. So often I find myself bogged down in negative behavior charts, CSE meetings, evaluations, and regressions that I forget to see the positives. Something as simple as sharing a photo of Hudson and Penn with BluePath reminds me of a good moment and allows me to take the time to cherish my amazing son and smile," said Bettencourt.

Hochul launches Prison Redevelopment Commission

Governor Kathy Hochul announced the launch of the Prison Redevelopment Commission, focused on reimagining closed prisons for innovative redevelopment opportunities across New York State. The announcement came on May 23. The 15-member panel, t was noted, is comprised of leading experts across real estate, community and economic development, criminal justice reform, and government. The panel will be led by Hope Knight, Commissioner, President and CEO of Empire State Development and Darren Walker, President at the Ford Foundation, according to the announcement.

In her 2022 State of the State address, Governor Hochul announced that she would form the commission to analyze prison redevelopment opportunities that serve the state's economic needs and recommend a clear and credible plan of action. The closures identified by Governor Hochul in the fall of 2022 are in addition to the more than 20 that have been closed over the last 15 years. The closures provide an opportunity to transform these facilities in more creative and productive ways, paving the way for opportunities to spur investment and job creation, according to the announcement.

The following facilities were officially closed in March: Ogdensburg Correctional Facility, Moriah Shock Incarceration Correctional Facility, Willard Drug Treatment Campus, Southport Correctional Facility, Downstate Correctional Facility and Rochester Correctional Facility.

According to the announcement from the Governor's Office, "The commission includes leadership from State agencies as well as foundations, regional leaders and stakeholders, and economic development experts who will be focused on developing an action plan to turn empty prisons, many of which were job centers in their rural communities, into opportunities for communities to thrive." The commission's first meeting was held on May 23.

The commission panel will convene throughout 2022 to engage in policy discus-

sions, hear presentations from industry experts, and identify areas for deeper analysis. The State and ESD will also engage with stakeholders representing each prison's region for local feedback and perspective on future uses for the facilities that meet the area's needs. Following this process, the commission will produce a public report, including recommendations for next steps.

Stamp Trotters of the Hudson Valley

You've decided to collect stamps, now where do you get them?

They once came ON the mail; that's seldom the case anymore. But if you are reading this, you're near a stamp club that meets twice monthly. One is an auction of members' extra material. Many of the lots are tailored to members' needs, so if we know a member needs a specific country, we'll accommodate that. At the business meeting, members are likely to bring albums or boxes of loose stamps for members to look at or purchase. These prices are lower than the auction prices. There's also an online club, SOR (stamporama.com), that combines auctions, approvals, and a discussion board, among other things.

Mystic Stamp Company (MysticStamp.com) offers stamps on approval (look before you buy). It's not the cheapest option, but they provide quality service and will tailor their offerings to your wants. The APS (stamps.org) maintains a list of stamp dealers you can search. Some dealers maintain websites; others by phone only.

EBay (eBay.com), HIP Stamp (HIPstamp.com), and Delcampe (delcampe.net) all have huge selections, with fairly easy search functions. They offer items at Auction, Buy It Now (BIN) and/or Make an Offer. Check each sites rules but usually in auctions you bid the amount you are willing to pay. With BIN, you pay the asked price. With Make an Offer, you make a lower offer that the seller can accept, refuse, or counter.

There are 3 stamp shops within 100 miles. Champion in NYC (Championstamp.com), Henry Gitner Philatelists in Middletown (hgitner.com), and AZUSA Collectibles in Clifton Park (azusacollectibles.com).

There are occasional bourses, or stamp shows, in NYC and the Albany area (http://www.albanypcc.com/event/stamp-show-1-3/). At this show there are 10-30 dealers who sell stamps, collections, albums, envelopes, and accessories. Tag along with a more experienced collector or ask the dealers for help; most are happy to show the ropes, if they're not too busy.

DCCHR 'devastated and outraged' by recent mass shootings

The following is a statement released by the Dutchess County Commission on Human Rights (DCCHR) on hate-based shootings in Buffalo, Dallas, and Laguna Woods targeting African-American and Asian-American communities.

To the Editor:

The Dutchess County Commission on Human Rights is devastated and outraged by the recent mass shootings in Buffalo, Dallas and Laguna Woods. Eleven people have been murdered, with more injured, in these racist and hate filled attacks. Occurring within days of one another these hate crimes appear to have specifically targeted people based upon the color of their skin. In Dallas, Texas, three Korean American businesses were targeted. In Laguna Woods, California, the Taiwanese Presbyterian Church was targeted. Eleven of the thirteen people shot in Buffalo were Black and the multitude of evidence left behind by the shooter leaves little doubt as to his hate-fueled motivation.

We mourn for the individuals lost this weekend, who will be denied the beauty of sunrises and sunsets, birthday celebrations and many joyous occasions with family and friends. We are united in our support as together we grieve the loss of lives with their families and community.

The Commission has documented numerous hate-based racist incidents and crimes locally in Dutchess County directed against our Asian-American and African-American communities. Members of our Asian-American communities have been spit on while walking down the street, been told to 'get away from me,' and received angry stares while standing in a grocery line 6 ft. apart. Our African-American community in

Gun violence is a public health crisis

Uvalde. Buffalo. Parkland. Newtown. Four communities forever changed by gun violence. Four communities representing a small fraction of gun violence in the United States, where more than 100 people are killed by guns every day. Four communities among the many who deserve action.

Gun violence in the United States is a public health crisis.

I witnessed firsthand the consequences of this crisis a decade ago when my community in Western Connecticut was shaken to its core by a senseless attack that took the lives of 20 young students and 6 educators at Sandy Hook Elementary School. Like so many others, I waited to see widespread action that would prevent this terrible tragedy from repeating itself. I was disappointed.

Now, it is time for the medical community and public officials around the country to take urgent action to address gun violence as the public health crisis it is.

There is no single solution to America's gun violence problem. To truly address this crisis, we need to look at its many causes, finding both big and small solutions that work together to create meaningful change.

Imagine if we addressed gun violence with the same level of urgency as COVID-19. We could bring together public officials, leaders in the medical and business communities, educators, and community and advocacy organizations to create a comprehensive plan to stop gun violence.

This work must start at the highest levels of government, with gun violence prevention. We cannot once again stand by without taking action to prevent the tragic event in Uvalde from repeating itself, like we did with Sandy Hook. As of 2017, gun violence officially replaced car accidents as the leading cause of death in children and adolescents. I call on Congress to take immediate action on violence prevention/gun reform. We owe it to the survivors and grieving families of gun violence to stop this terrible cycle.

As with any public health crisis, we need to invest in comprehensive research to examine the problem, identify root causes, and create a plan for treating and preventing it. I am heartened that last year, CDC director Dr. Rochelle Walensky reinforced the agency's focus on researching gun violence as a matter of public health.

As we focus on prevention, we must also acknowledge the impact of these tragedies on our individual and collective mental health, especially for children and adolescents. Just as students learn and practice how to react if a shooter enters their school, they should be encouraged to talk about these experiences with a trained professional. Healthcare providers should work with their partners in education to create these programs. At the same time, it is essential we take action to increase access to behavioral healthcare, so everyone—whether it's a survivor, a loved one, or an individual affected by news coverage—has ongoing access to the support they need.

Healthcare providers have a responsibility to support this crucial work, which will save lives and make the communities we serve healthier, safer places for our patients, neighbors and families. Our hospitals and medical practices are deeply rooted in the communities we serve. We can leverage this connection to assist with research around gun violence, in addition to implementing meaningful programs to help reduce gun violence. We can then bring our work at the local levels to collaborative conversations across the healthcare industry, coming together to develop strategies to address the crisis.

None of this work can be done in a vacuum, and we cannot change America's culture of gun violence overnight. We can, however, take an important first step by uniting to address this public health crisis.

Together, we can save lives.

Fishkill board hears drug crisis presentation

During the Fishkill Town Board meeting last month, a presentation on drug prevention was held. The presentation was put together by councilmen Brian Wrye and John Forman.

"It has been their (Wrye and Forman) determined effort to get the word out," said Sharon Herring, a local resident. Herring and her husband began the Matt Herring Foundation in honor and remembrance of their grandson, Matthew Herring, The Matt (Managing Addiction Through Teamwork) Herring Foundation helps "spread addiction awareness," according to its website, https://matt herringfoundation.org/.

Doug McHoul, a county legislator, whose district is in Fishkill, and a funeral home owner, said that the Herrings deserve credit for helping to bring the issue out in the open.

"My experience as a funeral director," he said, "is there's nothing worse than helping a family whose" relative was lost to drug addiction.

Joseph Chorba, a detective with the Town of Fishkill Police Department, talked of his experience as a K9 unit officer during his previous career experience. He said it is a "tough road" to see every day. Some of the drug overdoses, said Chorba, were not all related to heroin and fentanyl. Some were cause by mushroom and seven were from marijuana, he said. There were 63 overdoses from July 2020 to May 17, 2022 said Chorba. Eight were fatal. Ten were inside area hotels, he stated. A nine-month-old baby had to be saved by Narcan because of an overdose. The baby was saved by Narcan, he said.

Antony Tseng, with the Beacon Volunteer Ambulance Corps, said "The stigma is kind of what is hiding [this]."

Adam Harris, coordinator for the Dutchess County Drug Task Force, said he has spent 17 years in law enforcement. One of the biggest functions of the Drug Task Force, said Harris, is providing support to local police agencies. The task force works with the Dutchess County Medical Examiner's Office. He said in 2021 there were over 100 individuals who died of drug overdoses in the county. The task force's mission, said Harris, is to target middle and upper drug dealers.

Legislator Minority Leader Yvette Valdés Smith said she is grateful that this presentation was taking place.

"We don't have to be ashamed or hide someone's problem," said Valdés Smith.

Jean-Marie Niebuhr, LCSW-R Deputy Commissioner, Director of Community Services at Dutchess County Department of Behavioral and Community Health also made remarks.

Niebuhr noted that there is a focus on reaching people who are "on the street and in houses."

Drug addiction affects the young and old, professionals and homeless, she said. "Everyone is impacted by this," said Niebuhr.

She talked about the Dutchess County Stabilization Center, which is open 24 hours a day. It allows people to access support, regardless if one can pay.

The Dutchess County Stabilization Center is at 230 North Road in Poughkeepsie.



Is Yanks prospect Jasson Dominguez hot enough to be promoted to Renegades?

Jasson Dominguez, the prized prospect of the New York Yankees minor league system, has suddenly gotten hot down in the Low Class A farm team with the Tampa Tarpons.

But fans of the High A Hudson Valley Renegades are wondering, is Dominguez's hot streak of late enough to warrant a promotion up to Dutchess Stadium?

According to NJ.com, which covers the Yankees, Dominguez opened the first 20 games of the Low A season with just one home run and a .200 batting average.

Now the switch-hitting star from the Dominican Republic appears to be justifying the \$5.1 million bonus the Yankees paid him. In his last 14 games, Domingue is hitting 370 with four homers and 14 RBI, a tear that has raised his average from .209 to .271 and his on-base plus slugging percentage from .567 to .804.

Renegades look to second half

The Hudson Valley Renegades stole seven bases en route to an 8-4 win over the Rome Braves on Wednesday afternoon at Dutchess Stadium, as the team tries to climb back out of a major slump.

But at this point, at 18-22 overall and 9.5 games behind Aberdeen in the South Atlantic League North Division, Hudson Valley might be looking to the advantages of the new twist to the Class A schedule this year – a split season.

The league has adopted the two halves format – the division's first-place winner after the first 66 games advances right to the playoffs, and the season starts all over again for the final two-plus months with all teams back to a 0-0 record. That gives struggling teams – like the 'Gades – a chance to still make the postseason if they can win the division crown for the second half.

"I've been a part of that in the past down in Florida and it's an interesting concept," Renegades President Steve Gliner said. "At this level there's a lot of player movement, the roster changes, and sometimes teams get decimated by promotions and adding new players. So it's like a second chance." In the win over Rome, Aaron Palensky and Aldenis Sanchez each stole two bases, and Trey Sweeney, Eduardo Torrealba, Cooper Bowman all swiped one each.

The Renegades jumped in front in the bottom of the first against Rome starter Roddery Muñoz. Spencer Henson laced an RBI single to right field to give Hudson Valley a 1-0 lead.


Rome grabbed the lead in the top of the third, when Landon Stephens blasted a towering three-run homer to give the Braves a 4-1 lead.

But Hudson Valley responded with seven unanswered runs. In the bottom of the fifth, Eric Wagaman knocked an RBI single off Lisandro Santos (1-3) to cut the deficit to 4-3. In the following frame, Spencer Henson crushed a three-run homer to put the Renegades in front 6-4.

Henson reached base four times on the day, scoring three runs and driving in four.

In the bottom of the seventh, Wagaman lined a solo homer to left to extend the Hudson Valley lead to 7-4.

Trey Sweeney added an insurance run in the bottom of the eighth with an RBI single to make it 8-4 Renegades.

Gearing up for summer at the stadium

Every week, Hudson Valley Renegades President Steve Gliner sits down with reporter Rich Thomaselli to discuss the team in particular, and minor league baseball in general.

So as we speak on Thursday this week due to early holiday deadlines, we are on the cusp of the big Memorial Day Weekend – the so-called unofficial start of summer. What does this mean to you as we get closer to school being out and more people potentially filling Dutchess Stadium? When you had long-season teams you ran down in Florida, was it a sense of optimism?

Well, down in Florida is just meant it was getting hotter and more humid (laughs). But, yeah, it's the traditional kickoff to summer and you like to think that coming to a game is higher on

people's agenda and more top of mind. Now we're getting into the warmer weather, people have been cooped up, they're looking to get out and about, so I look at that as a great opportunity to tell people that we are out here. We've been playing and they don't have to wait until mid-June like when we were a short-season team for things to start.

You had mentioned last week about starting a new billboard advertising campaign. We've talked quite a bit this year about letting the Hudson Valley region know that after 20-plus years the Renegades are a full-season team now and actually started play in April. What else are you doing on the advertising front?

Well we've always had radio (ads) but this year we're doing more of a digital campaign. Advertising on TV these days is kind of hard because people have so



many choices, others have given up cable for streaming, that sort of thing. So we're doing more digital pieces throughout our market and reaching people that way. Our partner, 23Marketing, has a really good group and they are paying attention to the dynamic of what we're trying to do and what our fans need. We have a call with them every week and we make tweaks along the way and identify trends. It's important to be able to follow those trends.

You're in the midst of another home stand; have you gotten a chance to watch a game yet?

(Laughs) I still haven't. During the games I am still running around and doing things that just aren't related to what's going on on the field. When we're on the road, if we're playing at a place that has the live feed and I can stream it, I can watch. But I really haven't been able to hone in on what is happening on the field.

County to launch Veterans Treatment Courts

Dutchess County Executive Marc Molinaro announced the County is establishing, supporting and funding a veterans treatment court, with the support of County Court Judge Jessica Segal, City of Beacon Judge Gregory Johnson, the County Office of Probation and Community Corrections, and Mental Health America (MHA) Vet2Vet Program to adjudicate cases of offenses involving veterans, specifically those living with trauma, addiction or mental illness related to their service. The new veterans court is another example of the successful collaboration of agencies and experts within the criminal justice system who come together as the County's Criminal Justice Council to continuously improve system outcomes in Dutchess County. The New York State Office of Court Administration recently approved the County's proposal for the new courts, which will begin next week with a "soft launch" and will be fully operational by the fall.

Molinaro said, "Our veterans are our American heroes, and sadly many of them return from duty with mental scars that make their reintegration into their community difficult, often resulting in their entry into the criminal justice system. Dutchess County is proud to establish this veterans court to help divert these heroes away from incarceration and into the proper treatment programs that will support their recovery, diminish their chances of reoffending, and restore their connections to their community. We thank Judge Segal and Judge Johnson for their cooperation in helping us found this groundbreaking endeavor, which will have such a positive impact on so many local veterans and their families."

The veterans treatment court has two tracks — felony and misdemeanor. Felonies will be addressed in County

Court in Poughkeepsie under the jurisdiction of Hon. Segal. Judge Segal has been instrumental in working with County Probation and Community Corrections in making the veterans treatment court – the first of its kind in Dutchess County - possible. Misdemeanors will be handled in Beacon under the jurisdiction of Hon. Johnson, as an offshoot of the existing drug court. The new courts will serve as an alternative to incarceration, offering veterans treatment, structure and accountability, while also connecting them to the benefits their service has earned them. Veterans who repeatedly face such charges associated with addiction, homelessness and the like, will be eligible to participate in the new court.

Hon. Segal said, "The veterans court model is a team effort, comprised of local stakeholders interested in making a real impact in our veterans' lives. More than a guilty verdict, we are focused on rehabilitating these men and women who have defended our nation, giving them a second chance to turn their lives around and constructively contribute to their community. I look forward to the successful implementation of these new courts in Dutchess County and seeing the great benefit it will bring to our veterans."

First established in Buffalo in 2008 and replicated throughout the United States, the veterans treatment court model offers veterans facing misdemeanor drug cases with a veteran mentor, who engages with the veteran throughout the process, as well as veteran-specific treatment to address the underlying issues that caused them to offend. To ensure its effectiveness, the court requires a team of officials to work with the veteran and each other, including a representative from:

• the New York State Office of Court Administration;

- the Dutchess County Department of Behavioral and Community Health;
- the Dutchess County Office of Probation and Community Corrections;
- the Dutchess County District Attorney's Office;
- the Dutchess County Public Defender's Office; and
- a local veterans advocacy organization.

The Dutchess County veterans treatment courts will be facilitated by MHA's Vet2Vet program, which helps connect service members with fellow veterans to help them find the services and resources they need to heal, including support groups, social activities, assistance in finding housing or employment, advocacy for benefits, and others. Vet2Vet and the other partner agencies will keep working with veterans after treatment to keep them engaged and on track for continued, sustained recovery.

Vet2Vet program director Anthony Kavouras said, "Our Vet2Vet program works to give veterans the opportunity to help fellow service members on their transition back home. The veterans treatment court will be another tool we can use to help veterans who are struggling with issues related to addiction, mental health, or homelessness and are faced with legal ramifications of their actions. I am grateful to the County and the Justices for their support of this initiative and their commitment to supporting our local heroes."

The model also requires the veteran to make regular court appearances, have mandatory attendance at treatment sessions, and undergo random and frequent testing for drug and alcohol use. Veterans facing violent felony charges are not eligible for participation in the veterans treatment court.

Dutchess County Office of Probation

and Community Corrections Director and Chair of the Criminal Justice Council, Mary Ellen Still said, "Dutchess County remains committed to improving the criminal justice system. This collaboration will create another resource to make the system even more efficient and effective at helping those veterans who find themselves involved in it to receive the services and interventions they need to return to being successful members of society."

Dutchess County District Attorney William Grady said, "Our veterans have given so much to serve our country. Unfortunately, too many may find the transition home difficult as they process what they've experienced and learn how to 'turn off' the soldier to be a contributing member of their community. I am proud to support the veterans treatment court initiative and help these individuals get back on track to success."

Dutchess County Public Defender Tom Angell said, "The veterans treatment court will be a valuable resource to help our veteran clients, offering additional, veteran-specific treatments and alternatives to incarceration to increase the likelihood of achieving successful rehabilitation.

Adam Roche, Director of the Dutchess County Division of Veterans' Services, said, "Our veterans have served our country and we are here to serve them, particularly in times of need. The veterans treatment court will assist many local veterans in getting their lives in order following their service. I thank County Executive Molinaro, Judge Segal, Judge Johnson and the County's partners for recognizing the unique issues and needs of veterans. This court will have an immeasurable influence on our local heroes who have contributed so much to us all."

'Nonna's Pasta'

Every Italian Grandma has a special recipe.

The other day, my son Geno stopped home during a break at school and told me about an instructor of his, whose parents came from Italy. His instructor asked him about his background and where he came from. He explained that his father was Italian, his mother was practically raised Italian, and both his grandparents came from Italy. She asked him if he got the speech yet.

Speech? What speech? The speech where your father tells you that now when you are moving back home you have to help around the house and be a good son to your mother....

Geno was speechless. Because I did, in

fact, give him that speech the week before.
"How did you know?" he asked. His teacher replied, "Because both my parents came from Italy and that is the speech they gave me when I would come home

After the laughter died down, they started talking about growing up and what it was like when they were young.

The funny thing is that he has some very similar memories that I had when I was young. The most specific one is

"Nonna's Pasta."

Now, I know everyone has a story about a specific dish that only their grandmother made. That's the beauty of Nonna's Pasta. We all have one. I think that Italian grandmothers are all programmed to make their specific pasta dish as soon as their first grandchild is born. It's like a light goes on and their pantry is instantly filled with either elbow macaroni, rotini or Tubetini pasta and grated cheese, and butter suddenly is put in the door pocket in the refrigerator.

When my kids were little, Lisa and I would bring them to see their Nonna. Somehow, she always knew we were on our way, because a pot of water was on the fire ready to cook pasta. Mom always had rotini pasta in her cupboard. I swear she must have bought it by the case. She would get the pasta boiling then strain it and add extra virgin olive oil, butter, and grated Pecorino Romano cheese. I know this sounds like a simple dish, but Mom's always tasted better than mine. There was always that secret magical ingredient that only Nonna had. It must have been the love.

I can still picture my kids sitting at the

table with a huge bowl of pasta in front of them and a tablecloth tied around their neck so they wouldn't get dirty. Mouth full of pasta. Mom sitting between them with a dish towel in her hand, blowing on the pasta to cool it for them when they said it was too hot, making sure they finished every last mouthful of pasta before they could get up with a big smile on her face.

As soon as they finished, a cookie, or ice cream, or some candy, would instantly appear; things that we never had around the house when we were little, but Mom would always have for her grandchildren.

Growing up, my Nonna had this old cookie jar that sat on top of her refrigerator. There was always chocolate or cookies, or candy or some kind of sweet in it. I think it was magical because it seemed like it never emptied.

I love those memories. The funny thing, this time of year always seems to bring them to the surface. I hope that my grandchildren will have the same ones about my wife and I when they grow up.

Luigi's Nonna's Pasta **Ingredients**

• 1 lb. Rotini Pasta

- 1/4 cup Grated Pecorino Romano Cheese
- 3 tbsp. Butter
- 4 tbsp. Extra Virgin Olive oil
- 1/4 cup Peas
- 4 tbsp. Diced Prosciutto

Method

- Prepare a large pot of salted water and bring to a boil. Add your pasta and let cook for 7 minutes or until tender.
- In a Large frying pan, add prosciutto, peas, butter and olive oil. Once peas get warm, add the pasta and cheese.
- · Toss until fully mixed and serve with a hot crusty loaf of Italian bread.

Trout Fishing in America

Local creeks offer plentiful sport.

"They're jumping right out of the water!" I was just about to get on the lawn mower (finally) when Jesse called.

'Get down here with your pole, a couple of gold phoebes and a big plastic bag!"

'Where are you?" I asked. Of course, I can't tell you where he was, but five minutes later I was clambering down a rocky bank overlooking a roaring waterfall plunging into a deep hole.

Jesse wasn't kidding. On every cast he yanked a glistening trout up onto the bank.

Trout fishing is a big deal in the Hudson Valley. Of the 3,100 miles of streams and 300 lakes that the N.Y. State Department of Environmental Conservation stocks each year with 2.3 million catchable-size trout, eight stocked streams run through Dutchess County - Wappingers Creek, Sprout Creek, Roelif Jansen Kill, Webatuck Creek, Swamp River, Crum Elbow Creek, Fishkill Creek and Whaley Lake Brook. The D.E.C. Dumped 13,000 brown, brook and rainbow trout into Wappingers Creek alone this spring. Overlook Park Pond was stocked with 400 fish in preparation for the annual Family Fishing Day, which took place on May 1st this year.

More than a million New Yorkers hold fishing licenses. Anyone 16 years and older needs a license except on the free fishing weekend June 25-26.

Of all the different species of fish in our

lakes and ponds - sunfish, perch, bass, bullheads – the trout is my favorite. Of the three common species, brook trout is supposedly the tastiest, followed closely by rainbow and then brown trout. But they're all delicious, sauteed or pan fried with butter, thyme and lemon.

I fish with lures or bait. I just go out to the stream after work, when I need something for dinner.

Late summer is the best season for trout fishing, when the water is low and the fish congregate in deep holes, waiting for me to sneak up, poke my rod through the bushes, and slowly drop a hook baited with a half a night crawler. Before a trailer load of gasoline overturned on its banks, Sprout creek was my go-to stream after work. There were so many trout in there, that I once stopped my car on the bridge next to the LaGrange Town Hall, rolled down the window, and caught a trout without getting out of the car.

Just to see if it could be done. Sprout Creek is recovering from its environmental disaster of a few years ago, and the water is running clear once again.

"Real" fishermen don't use worms. They do something called "fly fishing," and believe it or not, they sometimes release all their fish back into the water. I've heard that on the Beaverkill Creek near Roscoe, N.Y., (the self-proclaimed trout capital of the world) you are

required to release your fish.

I visited Orvis Sandanona Shooting Grounds in Millbrook to check out the fly fishing angle. They have a nice pro shop open to the public, and a cafe, open 11 am -3 pm. Private fly casting instruction and fishing schools are available. Fly fishing has to do with using a tiny artificial lure that mimics the bugs the trout are feeding on. Part of the line is weighted so you can cast the flies a few dozen feet into the stream. Sounds like fun, but a little too aristocratic for me.

After a few minutes at our secret spot, Jesse and I had caught our limit (five each), keeping the nice rainbows and releasing



anything under ten inches. Then my 16-yearold granddaughter Ambika showed up.

"I saw your car parked along the creek," she said. "Can I try a cast?"

By that time, we had used up our gold phoebes, caught on rocks or high up in branches. Ambika tossed a white rooster tail into the current and immediately landed a gorgeous 20-inch rainbow trout.

That's what it's all about.







Hudson Line Breakneck station reopened

Metro-North Railroad, NYS Department of Transportation (NYSDOT), NYS Office of Parks, Recreation and Historic Preservation, NY-NJ Trail Conference, and Hudson Highlands Fjord Trail announced that the Hudson Line Breakneck station was reopened on Saturday, May 28 for weekend service. Memorial Day weekend, NY-NJ Trail Conference Trail Stewards will be staffing the popular Breakneck trailhead in Hudson Highlands State Park-Preserve to orient and assist visitors, who arrive by train, foot, or car. The Breakneck station has been closed since late 2019 and has since undergone a number of safety enhancements.

When the COVID pandemic hit in early 2020, the parking area was also closed and on-street parking limited to reduce crowds.

Safety enhancements were made to the Breakneck station over the past several months. These enhancements include an off-road trail that connects passengers to the southbound platform, a safety fence separating pedestrians from the railroad tracks, anti-trespass panels around the train platforms, and temporary wayfinding signage to assist visitors in easily accessing the hiking trails. These measures were funded by Hudson Highlands Fjord Trail and MTA funds secured by State Assemblywoman Sandy Galef of District 95 for Metro-North as well as in-kind services from NYSDOT and State Parks.

The physical improvements at the train station and trailhead are an interim step towards the planned comprehensive redesign

known as the Breakneck Connector. The Breakneck segment will mark the first mile of the planned 7.5-mile Hudson Highlands Fjord Trail linear park slated to go to construction at the end of 2022. When construction begins, the Breakneck station will again close until the completion of construction in 2025. Out-of-town visitors wishing to directly access the Breakneck and Wilkinson Trails are strongly encouraged to take the train and use the Breakneck station stop rather than negotiate the two-mile walk from the Cold Spring station or attempt to find parking on the side of the highway where spots are limited.

The Hudson Highlands Fjord Trail is envisioned as a linear park, spanning 7.5 miles along the Hudson River connecting

the Village of Cold Spring and the City of Beacon in New York State's Hudson Valley. Metro-North, NYSDOT, and NYS Parks are among the many partners working together to make the Fjord Trail a reality, including local municipalities, governmental agencies, community groups, and regional conservation organizations, such as project lead Scenic Hudson. The Metro-North Hudson Line includes three stations where visitors will be able to access the Fjord Trail directly once it is completed: Cold Spring, Beacon, and the Breakneck station.

Stony Kill to strengthen stewardship with grant

In an announcement from Governor Kathy Hochul, Stony Kill Foundation will be awarded a \$76,104 grant from the Environmental Protection Fund's Park and Trail Partnership Grants program to hire a Volunteer and Outreach Manager in support of their work stewarding Stony Kill Farm Environmental Education Center. Stony Kill Foundation Executive Director Erik Fyfe said, "The Park and Trail Partnership Grant will bring a big boost in our ability to engage volunteers, build partnerships, and care for the farm and its trails for everyone to enjoy."


