## Frustration mounts for Whaley Lake residents over damaged bridge from Ida



On September 2, 2021, the huge volume of water from the remnants of Hurricane Ida completely washed out the Lakeview Drive Bridge and road at Whaley Lake in the Town of Pawling, Holmes. Despite desperate efforts for help for nine months since, there is still no bridge or road at this site.

Frustration is mounting for a group of homeowners who live near the damaged Whaley Lake Bridge in Holmes, as time – and options – to repair the structure is running out.

The bridge, road and access on Lakeview Drive leading to the lake were all damaged last September when the remnants of Hurricane Ida reached the area and caused havoc.

But more than nine months later, the non-profit Shore Haven Civic Association – a group spun off from the

103-member Homeowner’s Association in Whaley Lake – has run into roadblock after roadblock from the federal level to the state to the county trying to secure help for repairs.

That includes the Federal Emergency Management Agency (FEMA) and the Small Business Association (SBA).

“They’re using us like a chip at a poker table,” said Aaron Cioppa, acting president of the Homeowners Association. “It’s been the most frustrating thing in the world.”

# No solution to Ida damage

Now it appears the only avenue for the Association is to raise the \$50,000-plus on its own through a GoFundMe page. So far, the group has received \$8,400 in donations. Visit <https://gofund.me/3fca1867>

“Dealing with the government has been a nightmare,” said another resident, Marilyn Bontempo.

Runoff water from the heavy storms dumped by Ida not only caused massive property flooding, but wiped out the bridge. The Association says that everything from delivery trucks to ambulances, fire and police responders are forced to turn away or try to navigate a tenuous situation caused by the damage.

Indeed, a timeline provided by Bontempo lays out in black and white just how frustrating the process has been.

• Met with Dutchess County Executive Marc Molinaro, Town of Pawling Supervisor James Schmitt and New York State Senator Sue Serino at the Whaley Lake Bridge site on Sept. 2, 2021, just days after the damage. The County could not help.

“That bridge is actually privately owned, so the County’s ability to assist is very limited,” a spokesperson for the County Executive’s office said in a statement provided last week to the Northern and Southern Dutchess News. “Our Department of Emergency Response did very actively advocate for FEMA assistance (either public assistance or individual assistance) and brought the FEMA review teams to the site on multiple occasions. It was determined it would not be eligible for FEMA public assistance and FEMA was working with the Homeowner’s Association about the possibility of Individual Assistance.”

• Per Schmitt’s suggestion, 24 residents filed for FEMA help on Nov. 23, 2021. It would be the first of two times the federal agency denied the Association’s application, despite letters from the local U.S. Postal Service, police, fire and first responders regarding the danger that the damaged bridge presented. FEMA said homeowners could still access their homes without the bridge.

“Yes, there are two access points. Depending on which side of the bridge you live, you can access your home and that’s why FEMA will not pay attention to us,” Bontempo said. “We put signs up saying that the bridge is out, but people still come down the road and have to back out. Even Royal Carting (garbage removal) has to now back down the road. It’s a dangerous situation.”

Schmitt, who did tell the Association he would waive permit fees if the group was able to find the funds to fix the bridge, did not return a request for comment.

• Then-HOA president Wendel Weber applied for an SBA loan also on Nov. 23. It was denied because the applicants did not show an ability to pay the loan back.

• In late December, the main water line was insulated by adding an additional outer pipe, insulation and covered with Item 4 to prevent freezing as a stop-gap measure.

• In February of this year, an application to Engineers without Borders was not selected. The Association also explored

local College Civil Engineering Programs for Community Outreach, but was told that their focus is on nonprofit parks and arts organizations.

• In May of this year, the Shore Haven Beach Path leading to the lake received in-kind services of five truckloads of fill and labor/equipment from one contractor as a start to improving safety.

The group has appealed to Dutchess County Legislator Edward Hauser, who pledged help in an email to Bontempo and Weber.

The Association also asked Schmitt to help with a grant, but the April email appeared to be too late for the May deadline.

“We have been working as hard as possible to assist in the grant for your bridge over the last 2 weeks. This grant is extremely involved and requires a lot of very involved, high-level work and expertise. As such, we reached out to our grant company for assistance and unfortunately they are unable to complete it in this short time frame. They also reached out to subcontractors they work with and who are unable to assist as well. We can-

not complete the grant ourselves due to the rigorous work involved - we don't have the time or staff to get it done before the May 4th deadline,” Schmitt replied to Bontempo’s husband, Richard Wilson. “As you know, we’ve reached out and advocated on your behalf to FEMA, the SBA, Dutchess County and Homeland Security (DHSES) many times and have tried everything to assist in fixing the bridge, and they again confirmed that this project is not an ideal candidate for funding through this grant. At this point, unfortunately, we’ve reached another dead end. We will continue to keep an eye out for any possible means of funding the bridge construction and apologize that this process has been so disappointing.”

It now appears the Homeowners Association is getting closer to the end game. “We’re already there,” said Giovanna Cioppa, Aaron’s wife, who is on the Association’s Bridge Committee. “It’s frustrating and disappointing, especially when all of us are taxpayers and you would think that taxpayers would get a reasonable amount of help in return.”

# Ceremony to dedicate 8-foot statue of last Wappinger sachem set for Saturday in Fishkill

A ceremony for the dedication of an 8-foot bronze statue of Daniel Nimham, the last sachem of the Wappinger, will be held on June 11, at 11 a.m. The ceremony will be held at the intersection of Route 52 and Route 82 in the Town of Fishkill.

Fishkill Town Supervisor Ozzy Albra recalled attending a town board meeting in 2012 and hearing the presentation by sculptor Michael Keropian. Keropian was making a proposal for the statue.

"I looked him (Nimham) up and saw there was a plaque. I said to myself 'this would be a good place (Route 52 and Route 82) in the future [for a statue]," recalled Albra.

It was 20 years ago, said, Keropian, that he moved to the town of Kent in Putnam County. That is where he learned about Nimham.

Keropian recalled making a proposal to another municipality regarding the statue of Nimham, but that did not go anywhere.

"Fortunately, Ozzy was [at the town board meeting]. I got a phone call when he was elected," said Keropian.


"Nimham had a very good relationship with the Brinckerhoff family. He was a frequent guest at the Brinckerhoff house. They worked hard to get the plaque dedicated to him in the 1930s," said Albra. The Brinckerhoff family was one of the prominent families from the area.

The location, at Route 52 and Route 82, is "perfect" said Keropian because wigwams were located in town of East Fishkill the hamlet of Wiccopee, in East Fishkill. The Wappinger women gave birth in the Fishkill Creek, added, Albra.

Sculpting Nimham's face, said Keropian, was "kind of intuitive from the beginning." Keropian said he tried to con-

tact Nimham's descendants, but they are numerous. Nimham, said Keropian, was Algonquin-speaking and from the Northeast.

"There hasn't been found, and probably won't be found, any depiction of what he looked like," stated Keropian about the chief.

Nimham fought against the British, said Keropian. Nimham and his son were some of the first veterans to die in the Battle of Kingsbridge. Nimham fought on the side of the colonists during the American Revolution. Nimham represents the Wappinger but, he also represents the American veteran, said Albra and Keropian.

The original plaque, dated 1937, is on the foundation of the new statue. There is

also a new plaque in the back of the statue. The foundation had imperial black granite that is originally from Africa but was shipped from Vermont.

Nimham was killed on Aug. 31, 1778 "defending the American cause," reads the 1937 plaque.

The plaque on the back of the statue notes the statue is a "tribute to the Wappinger Native Americans."

People are going to see the statue in many different ways, and "that's great," said Keropian.

The supervisor noted, "History matters, and you have to know where you're from. Our country was born from brave men like him"

"I think the residents should be proud to honor such an honorable man," said

### Symbolism in Bronze

The following are some of the symbolic items contained in the Daniel Nimham statue:

**Tree stump** – to show a life cut short; Nimham was only 52 when he was killed, and his son was younger.

**Deed or survey** – went to England three times to talk to the Lord of Trade, case was thrown out and Nimham decided to join the American cause

**Wolf** – historians know Nimham was part of the Wolf Clan, also represents union and loyalty

**Necklace** – two bear claws and central medallion is an oak which shows trunk (foundation) and branches that move away; he tried to keep his people together

**Musket** – Chareville musket that Nimham may or may not have used

**Feathers**- Nimham did not wear a full headdress according to historians, said Keropian

**Pouches** – one is like a pouch Keropian saw at Mount Gulian Historic Site in Beacon and the other represents the Hudson Valley and kept in Wappinger-style

**Knife, Belt, Moccasins** – Keeping with Northeaster Native Americans style, not necessarily Wappinger.

Albra. The statue, said Albra, will "help promote history," which the town board aims to do to help town tourism. "There is pride about living in the town of Fishkill, something that has been lacking for a long time."

The sculptor remarked, "Look at the statue. I put everything into representing who he was."

## Molinaro calls for PSC to hold Central Hudson to more accountability, transparency

*Editor's note: County Executive Marc Molinaro sent the following letter to New York State Public Service Commission Chairman and CEO Rory Christian requesting the Commission to seek greater accountability and transparency from Central Hudson Gas & Electric Corporation (CH) and New York State Electric & Gas Corporation (NYSEG),*

### Chairman Christian:

Pursuant to complaints related to new billing systems implemented by Central Hudson Gas & Electric

Corporation (CH) and New York State Electric & Gas Corporation (NYSEG), and in furtherance of consumer financial protections, I respectfully invoke your intervention on behalf of the two utility's more than 2.5 million customers to ensure full transparency and accountability during the investigations. To these ends, I implore the Public Service Commission (PSC) to:

1. suspend any current rate case and defer any future utility filings including any pending rate increases during the investigation period, and until all outstanding related customer disputes have been satisfied; and
2. suspend any current rate case and defer any future utility filings including any pending rate increases until a management and operations audit has been completed.

As you may know, a perfect storm has been brewing for two decades fueled by questionable federal and state policy decisions, some targeting our region, and the untimely and hastily closure of Indian Point—the result has been a deliberate incremental increase in electric and gas costs to the residents of our region conflated by legislated

supply side constrictions of electric and natural gas. This in and of itself has produced undue hardship on our residents, but the failure of the PSC to provide proper guidance and oversight as it relates to mandates such as the Community Distributed Generation Program and the implementation of the utilities' billing systems have placed thousands of residents in financial jeopardy. Instead of creating a reliable and sustainable system resilient to external factors, the system has been regulated for failure.

Nevertheless, the utilities cannot escape the responsibility for a flawed rollout of a new billing system and failure to effectively communicate with affected customers, but neither should those that regulate them.

Consequently, our residents, still vulnerable from a global pandemic, have lost faith in our gas and electric utilities on which they rely on more than ever, and lost faith in the institutions responsible for their oversight. Our residents find themselves reduced to having to make choices between energy and nutrition.

While the investigations and resolutions are paramount, in short order I call on the PSC to seek greater accountability and transparency from the utilities they regulate, but also look inward at the Department of Public Service (DPS) and New York State (NYS) for the same accountability and transparency.

My colleagues have called for greater transparency of the market prices and formulas the utilities use to determine consumer rates, and I support that effort, but I demand the same accountability and transparency apply to the cost of programs and policies mandated by the state which are embedded in the supply, delivery and miscellaneous charges. Utility bills prescribed by DPS and the NYS are difficult at best for customers to understand, and customers have the right to know a true cost breakdown of their energy as well as the efficacy and benefit of any mandated program or policy.

I appreciate your time and attention to this correspondence and stand ready to work with you and the state to ensure our residents and businesses receive the affordable, reliable and sustainable energy they need with full, not selective, accountability and transparency.

"I'm definitely very thankful for it," Jake told Southern Dutchess News about receiving the scholarship. He said he has learned about Steven over the past two years since the firefighter's death.

"This time of year, as so many kids are accumulating various scholarships for school in the fall, it struck me how many of those scholarships bear the names of people the kids who win them know little or nothing about," Chris Jodlowski, Jake's dad, wrote in a post. "I knew Steven Ziskind, so tonight (May 24) was a swirl of emotions. We are, of course, proud of Jake, his academic accomplishments, and his service to the fire district. At the same time, thinking of Steve and spending time with his family just a few days before the anniversary of his passing dredged up a difficult sadness I've felt all day..."

Polly Ziskind attended the scholarship presentation at the firehouse with her husband Martin "Marty" Ziskind.

"[T]hank you to the Wicoppee Fire Company and its members for supporting this scholarship," stated Polly Ziskind. "Steven would be smiling from ear to ear and blushing because of this attention. We realize how lucky he was to have such great friends in this organization and are grateful that they have been supportive of us during this very difficult times of our lives."

Jake was called "a deserving young man" by Polly Ziskind. She said he has a "bright future ahead of him."

Chris Jodlowski said that he was proud of Jake for earning the scholarship "based on his own accomplishments." Chris Jodlowski said Steven "was a smart and humble kid who didn't talk about himself much."

"I am, of course, biased. But I see in Jake so many of the things I loved so much about Steve. His quick wit and inviting smile. His

kindness and introspective nature," posted the elder Jodlowski.

A post was made to the Wicoppee Fire Company page. The post from the members of the fire company congratulated Jake and that he will "do great things." Marty, Polly and Adam, Steven's brother, were part of the committee that chose the recipient of the \$1,000 scholarship.

Chris Jodlowski said he thinks his son was "a pretty good choice" and is proud to have his son's name "associated with a tribute to someone I was so honored to know. The connection, to me, is a meaningful one."

## County sales tax cut on gas in effect

Effective June 1, Dutchess County cut and capped sales tax collection on gasoline with a change to its sales tax calculation for retail motor fuel and diesel motor fuel purchases, providing the maximum benefit for consumers allowed under state law.

The amount of county sales tax collected on each gallon of retail motor fuel is capped at 8 cents. Under the current sales tax methodology, consumers pay 3.75 percent county sales tax on their total motor fuel purchase, in addition to a myriad of other state and federally imposed taxes and fees.

Dutchess County Executive Marc Molinaro, together with Legislature Chairman Gregg Pulver, first proposed this cut and cap in March and the County Legislature adopted it in April; numerous other counties followed Dutchess County's lead in this effort to provide some relief to consumers. The earliest date it could go into effective under NYS law was June 1.

## Renegades take 4 of 6 from league-leading IronBirds

The Hudson Valley Renegades sent 12 batters to the plate in an eight-run seventh inning on Sunday, fueling an 11-5 come-from-behind road victory over the Aberdeen IronBirds.

With the win, the Renegades took four of six from the South Atlantic League North Division-leading IronBirds, who nonetheless still lead Hudson Valley by 9.5 games in the standings.

HV is now 24-26 overall in the first half of the season, which ends in less than three weeks.

Anthony Seigler sparked the rally and finished 2-for-3 with three walks, two RBIs and two runs scored in the series finale – the latter two coming within two separate seventh-inning at-bats.

In the top of the fourth, Hudson Valley mounted a two-out rally against Jake Prizina. Nelson singled, stole second, Aldenis Sanchez and Aaron Palensky both walked, and Eduardo Torrealba banded a

two-run single to give the Renegades a 3-1 lead.

Aberdeen rallied to take the lead against Nelson Alvarez. Donta' Williams lined an RBI single, and with two outs and runners at second and third, Alvarez (2-1) committed a throwing error allowing two runs to score and the IronBirds in front 4-3.

In the top of the seventh, the Renegades stormed back and put up an eight-spot to take control. Anthony Seigler led off the inning with a solo homer to left off Carson Carter (0-1) to tie the game at four. Later in the frame, Nelson drew a bases-loaded walk, scoring Sweeney from third with the go-ahead run.

Aberdeen called upon Xavier Moore and Hudson Valley greeted him with four consecutive two-out RBI singles to break it open. Palensky nailed a two-run single, Torrealba followed with his second RBI hit of the day, a Seigler line drive found outfield turf for his second RBI of the inning and Sweeney drove in one with a laser to center, growing the lead to 11-4.

Jhonatan Muñoz fired three strong innings of relief, allowing one run on four hits, striking out three and walking one, Carlos Gomez tossed two innings of one-run ball,

striking out two and walking none, and Nelvin Correa tossed a perfect ninth inning to secure the win.

Hudson Valley was set to begin a six-game series with the Jersey Shore BlueClaws on Tuesday, June 7, at Dutchess Stadium.





## Family fun parks closer to home

### Try Hershey Park, ZooAmerica and Adventure Playground!

Summer is almost here and it's time to start thinking of family fun.

Florida has succeeded in claiming the title of having the biggest and best-known amusement parks in the country. Originally opened in 1907 as a place for the employees of the Hershey Chocolate Company to relax with their families, it ultimately became a popular amusement park, open to the general population.

Located in Hershey Park, PA, the park has managed to retain its charming image of a small town and old-fashioned park. You can load the family into the car and arrive at the park approximately four hours later (or 2 "are we there yet" questions from the kids.)

For chocolate lovers like me, this beats out the Florida Mouse every time. The park has more than 60 modern rides and roller coasters. Hershey Park is considered as unique among most U.S. theme parks, because of Hershey's Chocolate World, featuring the famous "Hershey's Great American Chocolate Tour." The water park rides and Zoo America, a North American wildlife

park affiliated with Hershey, also help make the park a great destination for family theme park vacations.

#### ZooAmerica

I would normally not promote visiting a zoo. However, I do believe that it helps animals if humans are taught to respect all species and their habitats. Before deciding to add ZooAmerica to this article I called them and expressed my concerns.

Also located in Hershey Park, Pa., they advised that "At ZooAmerica, we believe it is our responsibility to protect, promote, and encourage the conservation of wildlife, natural resources, and habitats. We actively support conservation efforts through financial commitments and donations to the Conservation Grant Fund of the Association Of Zoos And Aquariums. We also work locally, involving ourselves in programs that benefit the species of our state, our country, our continent, and our world."

Many of the more than 200 animals that reside at ZooAmerica have suffered injuries or were orphaned and therefore can not be released back into the wild. This provides healing for the animals that need it and an opportunity for families to see and learn about animals they wouldn't otherwise have the chance to see animals such as a Spoonbill Platypus, a Vampire Bat, or an Ocelot.

They are situated on 11 acres of land and were mindful to propagate native plants and landscaping. It's a great opportunity to see non-native species, many of whom reside in the zoo due to injuries that no longer allow them to roam freely in their native territories. You'll know that your visit provides funds to help the animals in recuperation. Your kids will just know that they're having fun.


