The last sachem of the Wappinger, Daniel Nimham, has been honored with a statue at "The Arrowhead" at Route 82 and Route 52 in the Town of Fishkill. The dedication ceremony took place on the morning of June 11, with hundreds in attendance. The Red Storm Drum and Dance Troupe played ceremonial drums.

"We're interested in history all throughout the Hudson Valley," said Kevin Weber, an Irvington, Westchester County, resident. Weber is married to Constance Kehoe, president of Revolutionary Westchester 250.

"The statue's wonderful," remarked Webster, who saw the monument for the first time that day.

Laurie Scott, a resident of Fishkill, said

of the new Nimham statue, "I think it's beautiful. He was a very powerful leader." Scott wore a Daniel Nimham Pow Wow T-shirt. The pow wow used to take place in Kent, Putnam County.

"I just think that it's so great there's some recognition of him," said Scott. It was a "day for celebrating what was a long

## Dutchess sees redistricting changes

In the often confusing world of politics, the new re-drawn districts in New York have added more fodder to an already perplexing situation. On the local scene, many Dutchess County residents will find themselves in new districts for federal and state elections.

Adding further confusion, a special election has been called for the current Congressional District 19 due to the resignation of Antonio Delgado, who Gov. Kathy Hochul recently appointed as her lieutenant governor. The candidates, current Dutchess County Executive Marc Molinaro and current Ulster County Executive Pat Ryan, will face off in the special election, set Aug. 23. The winner will be sworn in around Sept 5-10 (depending on election certification) and serve until Dec. 31, 2022.

Also set Aug. 23 are primary elections. Josh Riley and Jamie Cheney are vying to be the Democratic candidate for the new District 19.

There are no primaries in the new District 18.

In the new District 17, Democrat Sean Patrick Maloney (currently the Congressman for District 18) will run against State Sen. Alessandra Biaggi, the Democrat who currently represents District 34. According to Ballotpedia, Charles Falciglia, William Faulkner, Michael Lawler and Jack Schrepel are running in the Republican primary for District 17.

As of Jan. 1, 2023, with the new maps will be in place, none of Dutchess County will be in the 19th District.

In the General Election in November, Molinaro will run against the victor of the Democratic primary (either Riley or Cheney) for the new District 19, and Ryan will run against Republican Colin Schmidt in the new District 18, which includes most of Dutchess County.

For the 41st State Senate District, Sue Serino (the current senator for District 41) will vie against Sen. Michelle Hinchey from Ulster County. (The final list of primary candidates was not available as this paper went to press.)

In the 39th Senate District, Republican Rob Rolison will run against the as-yet undetermined Democratic challenger (among the primary candidates is Julie Shiroishi).

Incumbent Jonathan Jacobs (AD105) is running. According to information on Ballotpedia, no Republican is currently listed. With 105th Assembly District incumbent Kieran Lalor not running for re-election, the race includes Democrat Jill Feldstein and Republican Anil Beephan Jr. AD106 Democratic incumbent Didi Barrett will run against the winner of the Republican primary between Brandan Gaylord and Dean Michael.

## Northern Dutchess Beekeepers lead vital educational workshop

Let's be honest. Your first reaction to seeing or hearing a bee in your vicinity is to get away, if not downright swatting it away.

And that's a perfectly natural response, especially for those who would suffer serious health issues if they were stung.

But while bees might seem like a nuisance, according to Encyclopedia Britannica, here's what would happen if there were no bees.

"If all of the world's bees died off, there would be major rippling effects throughout ecosystems. A number of plants, such as many of the bee orchids, would die off without human intervention. This would alter the composition of their habitats and affect the food webs they are part of and would likely trigger additional extinctions or declines of dependent organisms. Without bees, other plants would set fewer seeds and would have lower reproductive success. Beyond plants, many animals, such as the beautiful

time coming,” she remarked. “Some ranks of Americans we honor and hold as heroes,” said Town of Fishkill Supervisor Ozzy Albra.

He told of Nimham being “a warrior who laid down his life so all of us may live free.”

The national anthem was sung by Trevor Millies, a student at John Jay High School. Alicia Stardancer offered an Algonquin prayer.

Nimham was born in the waters of Fishkill Creek in 1726 near the hamlet of Wiccopee, according to information from town officials. The information stated that Nimham was a noted advocate for native land rights and traveled to England three times for enforcement of land treaties.

Albra said he received many emails about the recognition of Nimham, but only one handwritten letter. That letter writer was Fishkill resident William Veitinge, who spoke during the ceremony. Veitinge told of how he played ball in Van Cortlandt Park in the Bronx as a child. He said the statue is “a fitting tribute” to Nimham. “I am very proud to live in Fishkill,” said Veitinge.

Dutchess County Historian Will Taum said the ceremony “is a reminder” about history – that it is a process.

Supervisors of East Fishkill and Wappinger, Nicholas D’Alessandro and Richard Thurston, spoke about the historical aspect their towns had to the last sachem and Fishkill.

“Our two communities have a special bond,” said D’Alessandro. He said this statue of Nimham is teaching future lead-

ers what it is to be a leader—courage, leadership and honor.

“These are qualities we should all try and live our lives by,” remarked D’Alessandro.

Thurston said Nimham lived for the ideals of freedom and equality.

“He was a man for all times and all places,” said Thurston.

Dutchess County Legislator Douglas McHoul, whose district includes Fishkill, thanked the Fishkill town board members “for making Sachem Daniel Nimham a legend today.” Town board members thanked by town officials on the program were current members Louise Daniele, John Forman, Carmine Istvan and Brian Wrye and former members Jacqueline

Bardini, Kenya Gadsden, Ori Brachfeld and Joe Buono.

McHoul noted that the late Fishkill resident Todd Brinckerhoff was proud of his family’s connection to Nimham. In 1937, the first plaque that was placed at the arrowhead of Route 52 and Route 82 was bought by the Brinckerhoffs, said Albra.

Dr. Dwight Bonk, superintendent of the Wappingers Central School District, remarked that a part of the curriculum will be implemented with Nimham’s accomplishments, which was met with applause from those in attendance.

John Jay High School student Harshitha Talasila spoke of how Nimham, and his son, were killed during the Battle of Kingsbridge, in the Bronx, and fought for what they thought was important.

A poem written by Gil Tarbox was recited by his wife Penny Osborn.

“My husband honored all veterans. They were very important to him,” said Osborn.

Sculptor Mike Keropian spoke of this having been an idea in the making of the past 20 years. He said he hopes the sculpture will help people know about Nimham.

Keropian spoke about the different symbolism he added to the sculpture, such as a wolf to represent Nimham’s being from the Wolf Clan and the tree trunk to represent Nimham’s short life.

Keropian noted he met Albra in 2012 after Keropian first presented the idea to the town board. The idea came to fruition after Albra took office in 2020, said Keropian.

Independence Casting in Philadelphia cast the statue in bronze, he said. Robert Van Winkle Sculpture Installation spent a portion of last month installing the statue.

A member of the Mohican Veterans from Wisconsin said he was “proud” and “honored” to be at the ceremony.

## Julie Shiroishi announces candidacy for state senate

Stating that 2022 is not a time “for politics as usual,” Dutchess County Democratic Chair Julie Shiroishi has announced that she is running for the newly created 39th Senate District, which includes most of Dutchess and parts of Orange and Putnam Counties.

A resident of Beacon, where she lives with her husband and two children, Shiroishi is Chief of Staff for Assemblymember Jonathan Jacobson (D-104), and has previously worked in newspaper and book publishing. Like the 39th, Jacobson's district includes the cities of Beacon and Poughkeepsie, and the City and Town of Newburgh.

“When I first started volunteering to help local candidates, I never expected to become one myself,” said Shiroishi. “But 2022 is not a time for politics as usual. Every day, our communities live in fear of gun violence, both mass shootings like those in Buffalo and Uvalde and the rising number of shootings across the Hudson Valley—particularly in Poughkeepsie and Newburgh.

“Like every parent, I fear for all our children. The Supreme Court is threatening the reproductive rights of women, and empty words are not enough. We need action now,” she continued.

“We need to focus on building a sustainable economy in the Hudson Valley. That means investing in education, workforce development, and job training so all our young people can see their path to a good-paying job and a meaningful future.

“I have worked in the Legislature and know how state government operates, but I have also worked in the private sector. I know how to get things done and I will make Albany work for all of us here in the 39th Senate District,” Shiroishi concluded.

A graduate of the University of California at Berkeley, Shiroishi moved to Beacon in 2007 with her husband, Adam McKible, to raise their family and live near his parents (now deceased) in Newburgh.

## Brian D. Kelly appointed as deputy comptroller for Dutchess County

“I'm excited to welcome Brian to our team in the Comptroller's office. I have no doubt his varied Government experience, education, and work ethic will serve the Office of the Dutchess County Comptroller well,” said Comptroller Lois.

## County to offer free rabies clinic in Fishkill June 25

The Dutchess County Department of Behavioral & Community Health (DBCH) is again partnering with the Dutchess County SPCA to host a free rabies vaccine clinic for pets on June 25 at the Fishkill Town Hall, 807 Route 52, in Fishkill. The clinic will run from 8 a.m. to noon with free parking available. Registration is required, walk ins will not be accommodated. Registration is open and can be done by visiting the DCSPCA website at [dutchesscountyspca.as.me/RabiesClinic](http://dutchesscountyspca.as.me/RabiesClinic). Pre-registrations can also be made by calling the DCSPCA at 845-452-7722, ext. 425.

Conducted by the Dutchess County SPCA, this clinic will offer Dutchess County residents the opportunity to obtain rabies shots free of charge for their dogs, cats, and domestic ferrets 3 months of age and older. Proof of residency is required. Non-residents will be charged a fee of \$10 per pet vaccinated. All dogs must be on leash, and cats and domestic ferrets must be in carriers. Vaccinations will be good for three years for pets with proper proof of a prior immunization. For those without proof, the vaccination will be good for one year.

In New York State, rabies shots are required for all cats, dogs, and domestic ferrets by the age of four months. Animals must always remain up to date on rabies shots. Revaccination is required on a regular schedule to keep the animal properly immunized against the rabies virus. Owners can be fined up to \$200 if they

fail to get their pets vaccinated and keep them up to date.

If a pet is not up to date on its rabies vaccination and fights with a rabid or suspect-rabid animal, the pet must be promptly destroyed or placed in quarantine for six months to protect other animals and people in case the pet develops rabies. These mandates do not apply to a vaccinated pet in the same situation. In such cases, only a booster dose of rabies vaccine would be given within five days to treat the pet.

The Dutchess County Department of Behavioral and Community Health is available 24/7 to assist with any questions or concerns regarding potential rabies exposure to people or domestic animals. Pet owners should report to DCBH any incident in which their pet has been bitten by or has an open wound exposed to the saliva or nervous tissue of a domestic or wild animal. Staff will investigate and advise the pet owner of any necessary steps they should take to ensure the safety of their animal.

DBCH ask residents who see an animal acting strangely to contact their local police agency. ## 'Proven leaders,' more veterans should run for local offices

I hope you enjoyed a wonderful Memorial Day weekend, with plenty of quality time devoted to your friends and family. I was definitely busy myself, walking in parades and attending some very powerful services which remind us of the sacrifices our service men and women have made to safeguard our freedoms. For me, it was especially comforting to see so many young folks attending these Memorial Day events, because it's very important for future generations to remember the sacrifices of our heroes.

We all know Memorial Day marks the unofficial beginning of summer. But it also has become the starting point of a season of a completely different nature – of course, I'm talking about election season. Yes, like it or not, we will soon see bright patches of campaign signs popping up all over, asking us to consider this candidate or that candidate. And that season feels like it's coming even sooner this year, with the redistricting going on in New York State. As you know, I'm not a political person, although I do like to keep on top of the issues and I certainly do vote.

### Notes from the Town of Wappinger Supervisor

## Honoring Sachem Daniel Nimham

Last month, Supervisor Albra and the Town Board of the Town of Fishkill graciously extended birthday wishes to the Town of Wappinger: 147 years ago in 1875, the Town of Wappinger was created by the State of New York. Wappinger was incorporated out of land which had been part of the Town of Fishkill. And it is here that fate intervened for the Thurston family. It was on some of that land in former Fishkill to which one of my forefathers (in my direct lineage), Joseph Thurston, moved from Providence in the early 1700s. And, it was his son, Thomas, who married into the Montross family. The family burial site remains along the Sprout Creek in Wappinger.

But, in this column I do not want to talk about my family, but rather about a great Revolutionary War veteran, diplomat, leader, and hero - Sachem Daniel Nimham (the honorific word "Sachem", means the "Paramount Chief" of the Wappinger Tribe). The Town of Wappinger is proudly named for Sachem Nimham's people, who were then allies with the Mohican People to the North. As we can now see, history is not a single story, it isn't a timeline. It's an interconnected web, linking people, places, and times in ways we can scarcely begin to imagine. Most certainly, I could not have imagined this tie when I bought property in Wappinger one decade ago.

On June 11th, many of us joined together, at the Junction of Routes 82 and 52 in the Town of Fishkill, to honor Sachem Daniel Nimham and the dedication of his eight-foot bronze statue. The sacred site of the statute is located just a few yards from the historic Brinkerhoff House and historic site, and home of the East Fishkill Historic Society.

Chief Nimham was born nearly 300 years ago (in 1726) near the Fishkill ham-

let of Wiccopee. Daniel Nimham was also a noted advocate for indigenous Americans' land rights, and even petitioned the British government to regain lost Wappinger tribal lands. He lived for half a century before the ideals of freedom and equality were written into the Declaration of Independence. And yet those principles were not foreign to Sachem Nimham, he lived them throughout his life. He applied them in faithful service to General George Washington at Valley Forge. He exemplified them at the time of his death fighting the British to defend George Washington's rear flank, in 1778 in the Battle of Kingsbridge.

The Nimham statute is the amazing work of Hudson Valley artist and sculptor, Michael Keropian. I had the honor of talking with the sculptor, who committed to myself and Joey Cavaccini to reserve a smaller version for display in the Town of Wappinger. Stay tuned for plans for Phase 2 in the ongoing recognition of our indigenous Native American forefathers. Mr. Keropian spoke at the service, describing the symbolism reflected in the statute, including a survey scroll, traditional clothing garments, a musket, traditional belt and even a symbolic tree stump.

Other special elements of the Dedication Ceremony included: a combined color guard and gun salute; ceremonial drum performances by the Red Storm Drum and Dave Troop; Algonquin Prayer by Alicia Stardancer; singing of the national anthem by John Jay student Trevor Miles; a very special poem written by Gil Tarbox; and an inspiring speech by Wappingers Central School District (WCSD) Superintendent of Schools Dr. Dwight Bonk who announced a new curriculum dedicated to the history of our earliest indigenous settlers.

Values that Sachem Daniel Nimham best represents – courage, conviction and a thirst for justice and freedom – transcend time and place. Even though Sachem Nimham was born and died long ago, he was a man for all times and all places across the nation he helped to forge.

Thanks to the Town of Fishkill for bringing us together last Saturday to celebrate as an amazing community, and more importantly as Americans. We proudly stood together, each from diverse backgrounds and cultures, to join hands together on sacred grounds.

I hope that through this astonishing statue and sacred site, Sachem Daniel Nimham's growing legacy will serve as an eternal reminder of not only the values which make our area great, but the values that make our country great as well.

## Renegades gain key wins, close in on .500 mark

Propelled by a six-run outburst in the bottom of the seventh inning, the Hudson Valley Renegades took the series finale from the Jersey Shore BlueClaws by a score of 10-7 at Dutchess Stadium on Sunday afternoon.

Hudson Valley is a game away from the .500 mark at 28-29 overall, although the club is still 10 games out of first place in the South Atlantic League's North Division. Fortunately, the first half of the season ends in 10 days. First-half division champions automatically qualify for the playoffs, team records are reset to 0-0 after the first 66 games, and the second half of the season then begins with a new 66 games.

The BlueClaws took the lead in the top of the third against T.J. Sikkema when Rixon Wingrove brought in a run with a groundball to first. Spencer Henson threw home, but the throw was not in time to get Ethan Wilson and Jersey Shore took a 1-0 advantage.

Making his 10th career start, Sikkema finished with a career-high 3.1 innings pitched, allowing just one run on six hits, striking out four and not issuing a walk. The four strikeouts tied a career-high for the left-hander.

The Renegades struck back in the bottom of the third against Jersey Shore's Andrew Painter, with Aaron Palensky leading off the frame with a solo home run to left. After Hudson Valley loaded the bases with one out, Henson brought in a run with an infield single, and Tyler Hardman drew a bases-loaded walk to extend the lead to 3-1.

Jhonatan Muñoz allowed a two-run home run to Johan Rojas in the top of the fourth to tie the game. The BlueClaws added another against Muñoz in the fifth to go in front 4-3.

The Gades immediately tied the game in the bottom of the fifth against J.P. Woodward. Anthony Seigler drew a leadoff walk and scored on an Eric Wagaman double.

In the bottom of the sixth, the Renegades broke the game open after loading the bases with nobody out against Andrew Baker. Trey Sweeney delivered a two-run single to put the Renegades in front. Everson Pereira brought in another with a fielder's choice groundout. Saul Torres followed with an RBI triple and Wagaman crushed a two-run home run to extend the lead to 10-4.

The victory comes on the heels of a dazzling pitcher's duel less than 24 hours earlier when the Renegades slipped past the BlueClaws 1-0 on Saturday night.

Josue Panacual (2-0) turned in one of the best starts of his career, tossing a career-high seven shutout innings on the night. In just his second start in High-A, the right-hander scattered six hits – all singles – and didn't walk a batter while striking out nine to tie his career high.

Only one BlueClaw, Johan Rojas in the first, reached third base, and the team did not get another runner into scoring position until the seventh in Panacual's dominant outing.

Seigler led off the bottom of the fourth with a solo home run that was tucked just fair down the left field line. The blast was Seigler's third of the season with the

Renegades, and gave the club the only run it would need and the only run allowed by Jersey Shore starter Ben Brown in six innings. The right-hander allowed only two hits and struck out 11 as he matched wits with Panacual.

At a total time of an hour and 51 minutes, this was the fastest game of the season for Hudson Valley by 17 minutes. It was also the first time that the Renegades completed a

nine-inning game in under two hours since July 13, 2018 against West Virginia.

The contest was the first 1-0 win for the Renegades of the season, with their last coming almost exactly a year ago – June 10, 2021 at Brooklyn.

The Renegades will spend the next two weeks in North Carolina with games against Greensboro and then Winston-Salem

Locust Grove will be holding a Fairy House Hunt Saturdays and Sundays through June 26. Attendees can discover 30 fairy houses hidden among the flowers and trees at Locust Grove, 2683 South Rd., in Poughkeepsie. Admission is \$10 per person (children under 4 free admission).

"We love to get kids and families out into nature and into our gardens," said

Emily Ellison, Director of Public Programs for The Locust Grove Estate & Locust Lawn Farm. "And, we really appreciate the funds that Fairy House ticket sales and sponsorship bring in!"

Locust Grove is an independent not-for-profit museum, nature preserve, and education center. It was gifted to a foundation in 1975 by Annette Young, the longest resident of Locust Grove. Her family bought it from Telegraph inventor

Samuel Morse's family who used the Estate as a summer residence before them, remarked Ellison.

"We do not receive funding from the local, state, or federal governments. All proceeds from ticket sales and sponsorships of our public events help keep the Locust Grove gardens open free to the public since 1979," said Ellison.

Without fundraisers like Fairy House Hunt, Harvest Hunt in October, Holiday Hunt in December, Sunset Sensations (wine and food tastings every second Thursday of the month) wedding rentals, donations, membership, and volunteers, said Ellison, "we would not be able to keep our doors open every day from 10 a.m. to 5 p.m."

"The Fairy House Hunt was an idea first brought to in 2017 by staff members and volunteers who have marveled at its success and growth into a beloved annually recurring program ever since," said Ellison. That first year, there were only two dozen houses. The event, at that time, was held for only two days. "Generous volunteers handmake and re-assemble the houses each year. We are so grateful for their talents and kindness," Ellison stated. It was noted that upon entrance, each child is given a numbered "treasure map" to "find" each of the tiny handmade houses hidden among the flowers and trees.

"Last year Fairy House Hunt attracted over 1,200 visitors. This year we hope to see over 2,000!" said Ellison.

bee-eater birds, would lose their prey in the event of a die-off, and this would also impact natural systems and food webs. In terms of agriculture, the loss of bees would dramatically alter human food systems but would not likely lead to famine. Still, many fruits and vegetables are insect-pollinated and could not be grown at such a large scale, or so cheaply, without bees. Blueberries and cherries, for example, rely on honeybees for up to 90 percent of their pollination. Although hand-pollination is a possibility for most fruit and vegetable crops, it is incredibly labor-intensive and expensive."

Wow, right?

Well, that's why the members of the Northern Dutchess Beekeepers Club (NDBC) work so hard to not only nurture the bee population, but to educate the general public about their importance to the world.

To that end, NDBC members last week conducted a workshop at the Dutchess County Fairgrounds in Rhinebeck, led by Dr. Robyn Underwood, Apiculture Extension Educator for the state of Pennsylvania through Penn State University.

"It provided us with an opportunity to really dive into hives and learn best-practices and strategies that will equip us to care for our honeybees following an organic colony management system," said Roselyn Geuss, who along with Michael Lancto runs the NDBC and facilitated the workshop.

Instructors Tom Butzler and Steve Berne led the exploration and the up-close and personal examinations of the pests that seriously threaten the world's honeybees – especially the Varroa mite.

"It was fascinating to examine the anatomy of mites through compound microscopes and learn how they disrupt the normal development and health of bees. In addition, wax moth and hive beetle larvae were discussed and closely examined," Geuss said.

Underwood led the inspections of the bees' activities and health. Finding the queen and marking her with a bright colored dot of paint, using a marking pen on the thorax (back) for easier identification, was a first experience for some of the beekeepers.

These workshops are the result of a research project conducted to determine the impacts of colony management on honeybee health and productivity. The results of the project, nicknamed COMB (Conventional and Organic Management of Bees), are not yet published. However, the data showed that the organic management system had excellent over-wintering survival and the healthiest bees that made the most honey.

"Avoiding the use of synthetic chemicals and antibiotics in the hives, a requirement of an organic management system, is important to me and to other beekeepers," Underwood said.

"The research showed that they are not necessary for success. I hope these workshops will give beekeepers the confidence and skills needed to use this system and benefit from its results."

Underwood said one of the most rewarding aspects of the workshop was the unique opportunity to meet and spend considerable time with other beekeepers to share their beekeeping stories – triumphs, disappointments, and tips and tricks to improve the care and management of our colonies.

"Fellow beekeeper camaraderie and support for many of us are invaluable for our success as beekeepers," Underwood said.

Said Geuss: "We are so very grateful to Robyn, Tom, and Steve for offering this most unique, informative, and fun event in Rhinebeck. We believe all workshop participants hope PSU's Apiculture educators will return to offer us another inspirational honeybee educational workshop in the future."

The roundabout will be at the intersection of Patriot Way (formerly known as Auditorium Drive) and Route 52. This roundabout along with the John Jay Student Drop-off will help to alleviate traffic congestion on Route 52 and benefit the access to the John Jay High School, and to surrounding residential and commercial properties.

According to town officials, roundabouts are known to be safer than traffic light and stop sign-based intersections. The Insurance Institute for Highway Safety (IIHS) cites numerous reports that indicate big reductions in accidents, including one that found crashes involving injuries went down by up to 80 percent at sites where roundabouts were installed at intersections. There are also traffic flow benefits, which bring with them a reduction in emissions.

# Demolition of former YMCA building signals next step toward new YOU

Dutchess County Executive Marc Molinaro, City of Poughkeepsie Mayor Rob Rolison and members of the City's Common Council joined local stakeholders last week as demolition of the former YMCA building at 35 Montgomery Street began, the next step in the process of the development of a state-of-the-art Youth Opportunity Union (YOU), which will be built on the site and benefit children from throughout Dutchess County. The YOU will be a fixture for the County's "Path to Promise" initiative that employs strategic ways to ensure all young people in Dutchess County have the assets they need to realize their full potential as they grow into adults.

Molinaro said, "The YMCA had a profound, positive impact on our communities for decades, and Dutchess County's Youth Opportunity Union will build on that legacy of transforming the lives of young people. We will build a safe, structured space to offer essential educational services, childcare and recreation opportunities – addressing numerous needs for Dutchess County children and their families. We continue our journey toward the YOU, which will transform the lives of so many young people for generations to come." In July 2021, the County and City finalized a land agreement, whereby the County acquired the 35 Montgomery Street site from the City, and Molinaro committed to spend \$25 million for the YOU's design and construction; design is still ongoing. The YOU project has received great interest from a variety of organizations, including the nationally renowned Harlem Children's Zone; formal funding/donation solicitation, however, will not begin until design and cost estimates are finalized.

Jeh Vincent Johnson, a pioneering African-American architect who taught at Vassar College for 37 years, was a designer of the YMCA building, and Dutchess County will honor the facility's past, building on its legacy to help future generations of County young people.

The County selected MASS Design Group as the architect and project lead for the YOU, following a Request for Proposals and review by the Dutchess County Legislature's Architect/Engineer/Construction Management Consultant Selection Committee. MASS has engaged in a wide range of engagement events and listening sessions, both in-person and virtually, to gain valuable input from the community.

The County will continue to work with MASS and its other partners on the design plans throughout this year. Once construction estimate costs are determined, County Executive Molinaro will

request the County Legislature authorize \$15 million in bonding to complete the County's \$25 million commitment to the project, with the goal of construction beginning in 2023. The County has created a YOU Advisory Committee of community leaders who provide feedback on design plans and potential operational aspects of the YOU, and the County selected the YMCA of Kingston and Ulster County as the YOU's future operator.

To engage and involve youth in the project, the County also has worked with

The Art Effect and design firm Small Stuff on an inspiring initiative that will feature artwork on the temporary fencing surrounding the construction site, seen below. Local students created the art at workshops throughout Dutchess County, including the East Fishkill Community Library, Red Hook Community Center, Adriance Memorial Library in the City of Poughkeepsie, Tivoli Free Library and the North East Community Center in Millerton.

The City took ownership of the property in 2019 after the site had been dormant

for a decade.

"During our initial public meetings in 2019, community members made it abundantly clear they wanted this site to be used once again as a community hub, with a focus on youth," Mayor Rolison said. "I'm grateful the County has agreed to take on this project and is committed to creating an inclusive and safe space for our youth to learn and grow. Ongoing updates about the YOU are available at the-you.org, where residents can also provide feedback."

At the fleet's height in 1965, the U.S. Navy kept 189 military and merchant ships moored along this 3-mile stretch in rows of 10 ships wide. It was such an impressive sight that pull-offs were constructed along Route 9W so motorists could stop and ogle "The Mothball Fleet."

# Creative Living

## Building contractor woes in early 19th century Poughkeepsie

While we have experienced some remarkable swings in the weather this year, it is generally agreed that building season has begun in Dutchess County by June. The sounds of hammer and saws, along with trucks laden with building supplies rumbling down local roads becomes the background noise of the season.

In years when demand is high and the labor pool low, the building season is also characterized by frustration as clients compete for attention and a spot on the schedule. One might well be forgiven for thinking that this experience is a hallmark of our modern age, what with the explosion in demand for properties and improvements thereto. But the Dutchess County Ancient Documents Collection, consisting of the filings of the county courts from 1721-1889, reminds us that the challenge of completing residential projects is nothing new to local residents.

In March 1807, Poughkeepsie resident John Frear sued Charles H. Duncomb in the Dutchess County Court of Common Pleas for breach of contract. As related in the narration, preserved today as Ancient Document 29706, Duncomb had promised to “erect and build two certain buildings or dwelling houses” in the Town of Poughkeepsie. Modeled on the home of local resident Michael Verian, these new houses were to be “built adjoining each other” and to “be two stories in height,” a story larger than Verian’s house. Duncomb additionally agreed to build “two certain barns and two necessaries,” the equivalent of a detached garage and outhouse/toilet for each of the homes.

Frear’s housing project—effectively a duplex since the houses would have shared a wall—was roughly equivalent to the housing projects that any motorist can see when traveling around the city or town of Poughkeepsie today. Frear paid Duncomb \$2,200 for his building services. According to the US Inflation calculator at officialdata.org, that equates to \$60,000 today, which still seems like a deal. Despite the ease of finding such data on the internet, these estimations of relative value are seldom accurate with regards to the actual value. For 1802 Poughkeepsie, \$2,200 was a great deal of money.

The crux of the matter lay in a crucial point of terminology in the original contract: Frear expected Duncomb to construct these buildings “in a manner and form every way equal” to the quality of Michael Verian’s house. According to Frear, Duncomb’s craftsmanship was “so careless negligent slight and unworkmanlike...that the said two buildings...are of little value and scarcely fit for habitation.” Duncomb committed to the

building project

on May 1, 1802, nearly five years before Frear brought the suit against him, so time was certainly not against him on this project.

The first decade of the nineteenth century was a busy time for the development of Poughkeepsie, however. The municipality that we know today as the City of Poughkeepsie had only become incorporated as a village in 1799. Village government would not have a permanent physical home until Matthew Vassar’s reform party completed the village hall and market (now the Commissioner of Jurors Building on Main Street) in 1830, instead meeting in a variety of public spaces.

During the years when Duncomb worked on Frear’s project in the surrounding town, the village acquired a fire engine, dug wells to feed it and the growing population with water, and erected a market building. This focus on extending the infrastructure of civic life reflected the steady increase in the village’s population and its growing significance as a Hudson River port.

No doubt Duncomb and other builders had plenty of competing projects to keep them occupied.

Unfortunately, we do not have information on the ultimate resolution of the dispute between Frear and Duncomb. Frear had only paid Duncomb \$500 out of the original \$2,200 promised, with which Duncomb evidently built the two houses, barns, and out-houses of questionable quality. Despite having received buildings in exchange for his investment, Frear demanded the initial \$500 payment back. When Duncomb refused to return the money, Frear brought him to court.

There are no notes on the narration other than one brief entry stating that the document was officially filed on June 20, 1808. The absence of further notes may indicate that Duncomb settled with Frear out of court, which was a frequent approach to these sorts of suits then as now.

We will keep our eyes open for additional information on the case, which will be included in our next update to the Ancient Documents Search Portal. You can visit that portal and access over 60,000 pages of original court records for free at dutchessny.gov/ancientdocuments, courtesy of the Dutchess County Clerk’s Office and the New York State Archives.

In the meantime, if you find yourself struggling to locate a contractor or complete work on your property, bear in mind that you are participating in a centuries-old aspect of Dutchess County life.



There were times that English and Italian were mixed together in a sort of new dialect that we understood, but our relatives overseas did not. This didn't work out very well when we would visit Italy and we would try to hold conversations.

I remember when I was 7 years old, we went to Italy for the summer. My father and his two brothers would take turns going to Italy to visit their mother. So every three years we would pack up and go stay in my father's home town of Monte di Procida at the house he grew up in.

Monte di Procida as I remember was a small town with narrow cobblestone streets and stone building with a view of the Mediterranean no matter where you were. Driving in Italy was and probably still is an adventure. My father is not the best driver here in the States, so you can imagine what he was like in Italy. So, when he rented a car for our time in Italy, let's just say, Pop got the extra insurance. We scraped many stone

walls and, as such, our rental car looked like it had just gone through Afghanistan instead of our little town of Monte di Procida.

On most days, when not visiting relatives, we would go to the beach, usually Miliscola, then have a late lunch around 4 p.m., because everything in town would shut down for siesta between 1 and 3 p.m.

On one such occasion, we were eating at a small open air café near the beach. As was customary after dinner, my father would light a cigarette. Unfortunately, he didn't have any matches, so he sent me to get some. I went to front desk and asked for "matchediels" which, unbeknownst to me, is not an Italian word at all. It's not even the Italian dialect of our hometown. It is a hybrid word made of the word "matches" with an Italian ending to it, which I would find out later in life was fairly common for Italian Americans. The correct word is fiammiferi, which is a word that I had never heard of.

Anyway, the maître d' yelled at me, told me to get lost, cursed me out and kicked me in the butt, not knowing that I was eating there with my family. So I wandered out of the restaurant and spied a little store across the street. Now, drivers in Italy are notorious

for running down people, so I had to kind of jump and weave my way across the street of death, defying the devil himself. Out of breath after a few near misses, I made it across. I went in the store that I had spied and asked for "matchediels". He kicked me out of the store, cursed me out, and kicked me in the butt.

Now I was determined. I was on a quest. I went down to another store and asked for "matchediels." Once again, I was kicked out of the store, cursed out, and kicked in the butt.

Now I'm noticing a pattern. I may have been 7 years old and naive, but every kick in the butt I received was starting to wear on me, and I realized what I was saying was not being understood.

The next store I entered I didn't speak. I instead chose to point and grunt. This didn't work either, because they thought there was something wrong with me and they kicked me out anyway, again with the customary cursing and the ever-present kick in the butt. You see, I didn't realize it at the time, but apparently there was a problem with gypsies using kids to scam store owners, so they just assumed I was one of them.

My butt was getting sore from getting kicked so many times, and my spirits were low from being cursed out so many times, so I decided to go back to restaurant with my tail between my legs and no matches. Once again, I had to cross the street of death and dodging traffic laughing at the devil himself, in order to get back across the road.

When I went into the café, I had to sneak back in. If you remember, the maître d' kicked me out the first time I asked for "matchediels" and I wanted to avoid getting another cursing and another boot in the butt. After I snuck by the front desk, as I was walking back to our table, I spied a large bowl in the shape of an elephant with ... books of matches. I grabbed one and went back to the table, albeit a half-hour later.

When my father saw me, he asked where I was, so I told him the whole story complete with my harrowing cross of the street of

death. He was horrified, but proud that his son refused to give up before returning with a book of matches. There was a plate of hazelnut biscotti on the table with a small pot of espresso and a bottle of anisette. Pop handed me a biscotti and put his arm around me, as I sat next to him, and lit a cigarette.

Well, at least I knew I wasn't going to get kicked in the butt again.

### Hazelnut Biscotti Ingredients

- 6 whole eggs
- 4 cups all-purpose flour
- 2 cups white sugar
- 2 teaspoons baking powder
- 4 tablespoons Amaretto
- 3 teaspoons vanilla extract
- 2 cups chopped hazelnuts

### Method

- Mix dry ingredients in a large bowl. Mix the eggs and liquids in a separate bowl. Add liquids to the dry ingredients gradually, mixing until dough is stiff. Do not over-mix.
- Shape dough into two rectangles 4 inches wide by 12 inches long. Place on greased cookie sheet. Bake for 20 minutes at 350 degrees.
- Remove baked rectangles from oven and let stand until cool.
- Using sharp knife, slice the large cookie into 3/4-inch slices. Place back on the cookie sheet, on their side, and bake again for 15 minutes or until they are golden brown.
- Serve with Espresso and of course a bottle of Anisette.

# Salvia

These often overlooked members of the sage family have a lot going for them

Why don't more gardeners plant salvia? The annual red flowered salvia – Vista, Sentry, Red Hot Sally – there are dozens of varieties of the species *Salvia Splendens*, ranging in height from six inches to two feet tall, blooming all summer long and DEER DON'T EAT THEM! Perfect for large containers, beds or the back of a flower border.

Red salvia (there is also a purple variety of *salvia splendens*) is one of about 900 species of salvia known to gardeners. They're all in the sage family, with square stems and an unusual semi-tubular flower that is built to prevent self pollination. I'm not aware of any salvias that are native to New York, but don't let anyone tell you pollinators pass them by. Bees, especially bumblebees, and butterflies love salvia. Some of the long tubular flowered varieties like the hybrid "Wendy's Wish" are hummingbird magnets. Our native ruby throated hummingbirds seem to have learned that since bees can't probe all the way to the end of the blossom, Wendy's Wish has lots of nectar to spare.

Here are a few more of the most popular salvias for your garden:

- **Blue Salvia** (*salvia farinacea*) – an annual that survives into late October with spikes of blue blossoms; some varieties, like "evolution," are deep blue or purple, while the standard "Victoria" is a pleasing cornflower blue. Deer won't go near it, and neither will woodchucks, rabbits or most humans. The leaves smell like

cat urine.

- **Indigo Spires** – In 1979, a hybrid cross between two species of salvia was discovered at California's Huntington Gardens. One of the parents was the blue salvia *farinacea* and the other a salvia shrub native to Mexico. Over the last several years, varieties of indigo spires have been developed, including *Mystic Spires Blue* and *Rockin' the Blues* from Proven Winners.

- **Perennial Salvias** – Noted area horticulturalist Rebecca Curtis pointed out some of the more popular perennial salvias. Meadow Sage is the common name of the species *Salvia Pratensis*, which is a hardy perennial in the Hudson Valley. Closely related are the varieties of the species *Salvia Nemerosa*, which includes *May Night*, *Caradonna*, the dwarf "Marcus," and Proven Winner's *Violet Riot*. Rebecca swears that these perennials will bloom all season if they are trimmed or dead-headed after the first flush of blossoms fade in late June. Some varieties, especially *May Night*, can flop over in hot humid weather so may need to be staked. Perennial salvias prefer full sun and can tolerate drought and poor soil.

- **Garden Sage** – Rub your grilled chicken with sage, top off your summer cocktail with a sprig of pineapple sage, all members of the salvia/sage family. Pineapple sage grows huge in the garden, eventually throwing out enormous crimson blossoms swarmed by hummingbirds.

- **Russian Sage** – For some reason, botanists decided in 2017 to reclassify Russian Sage as a salvia, removing it from the genus *perovskia* and calling it *salvia yangi*. This is an extremely hardy perennial shrub with long panicles of sky blue blossoms. Lives forever in poor soils and is almost impossible to kill. Landscape designers love it. And you can

happily plant Russian Sage along a south wall or in the back of a garden, because it's not native to Russia!

# Bannerman Trust receives \$1,000 grant for development officer

The Bannerman Castle Trust, Inc. was awarded a \$100,000 matching grant from the Environmental Protection Fund's Park and Trail Partnership Grants program to hire a Development Officer to refine and implement the Trust's development activities and to identify and steward major gift donors and prospects. The Bannerman Castle Trust, Inc. will raise an additional \$25,000 in matching funds, for a total of \$125,000.

The grant is one of 30 awards totaling \$900,000 for organizations dedicated to the stewardship and promotion of New York's state parks and historic sites, trails and public lands. The grants will be matched with private and local funding and will support projects to strengthen Friends groups and enhance public access and recreational opportunities.

Friends groups—nonprofit organizations often made up entirely of volunteers—are essential to the stewardship and promotion of our state park system. These dedicated groups raise private funds for capital projects, perform maintenance tasks, provide educational program-

ming, and promote public use through hosting special events.

The Park and Trail Partnership Grants are administered by Parks & Trails New York, a statewide non-profit organization, in partnership with the NYS Office of Parks, Recreation, and Historic Preservation.

Parks & Trails New York Executive Director Robin Dropkin said, "With more and more people discovering the outdoors, and visitation to our parks, trails, and public lands soaring, the need for strong public/public partnerships has never been greater. The Park and Trail Partnership Grants help bolster the role of Friends groups in these vital partnerships."

The Bannerman Castle Trust, Inc. (BCT) is still a growing organization, although it entered its 30th year dedicated to the preservation of Bannerman Castle in 2022. The Trust's primary goals are to facilitate public access and to host educational and arts and culture programs at Bannerman Castle on Pollepel Island, all while striving to complete the stabiliza-

tion and adaptive reuse of the larger Castle structures.

"The grant award will allow us to hire a dedicated Development Officer so that we can pursue and secure funding to stabilize and repurpose the larger, historical structures on Bannerman Island as part of an outdoor amphitheater concept for theater and concert events. We're tremendously grateful to have been selected," BCT President Len Warner stated.

When the BCT was formed in 1993, many skeptics said that efforts to save Bannerman Castle and open it to the public were infeasible due to the degradation and damage experienced during the decades that the site was closed to the public. Since that time, BCT has had great successes - with the help and generosity of friends, supporters, the NYSOPRHP, and Parks & Trails NY - Pollepel Island opened as another destination within the Hudson Highlands State Park in 2004 to limited 'hard hat' tours. During the intervening years, the BCT partially stabilized the main castle tower with steel bracing

and focused repairs; rebuilt the roof and interior floors of the former Bannerman residence to create a museum and visitor center; restored the island's historic terraces, gardens, and trails; and installed public restrooms - creating one of the Hudson Valley's most exciting and unique heritage tourism destinations!

"A Development Officer will help the Bannerman Castle Trust, Inc. to go after and obtain funding for major capital improvement projects to rehabilitate the iconic Bannerman Castle warehouse structures. The framework we envision for the castle improvements is the development of an outdoor amphitheater concept, which would be constructed adjacent to the existing castle. My sincere thanks to New York State Parks, Parks and Trails New York, BCT's Board and Advisory Council, and the BCT staff and volunteers - Neil Caplan, Executive Director, BCT.
