Kinry Road students raise funds to help children in Ukraine

Wappingers Central School District Kinry Road Elementary School third graders Zoe Adams, Eva Carino and Savannah Schuka raised more than \$1,500 for UNICEF for the children of Ukraine. The three students collected change in buckets they decorated. Sunflowers, the national flower of Ukraine, were designed for the school students and faculty to write messages of support, which were placed in the school's lobby for a month.

"It makes me feel good and it has shown that anybody can do anything," said Eva when asked what she thought about what was accomplished by the fundraiser.

Savannah remarked, "I think we accomplished much more than we thought we could. I'm so proud of my friends and I and would like to thank all the students at Kinry Road."

"I think that we accomplished much more than we thought we would. I think it's amazing how much money we raised!" exclaimed Zoe.

Their parents are proud of the fundraising efforts the girls put forth for UNICEF.

Robin Adams, Zoe's mother, said, "I was (and am) so proud that she heard that there was a problem and decided that she wanted to do something to help."

Eva's mother, Nicole Carino, noted, "I was so proud of Eva and her friends for recognizing that others needed help and support and for wanting to do something about it. I was also very grateful to her teacher for embracing their idea from the start and giving them the opportunity to make the fundraiser a reality."

Danielle Schuka, Savannah's mother, remarked that she was "curious and convinced" that the girls' teacher, Michelle Murphy, spoke about the war in Ukraine

Artist Sabrina Crowley began a ThinkDIFFERENTLY mural on the building at 223 Main St. in Beacon on June 20. The mural, which was commissioned by Libby Funeral & Cremation Services in Beacon, is next to a mural which thanks veterans. That mural was commissioned in Nov. 2021 by Libby's.

"It's very simple. I think with the simplicity, you read all the words," stated Crowley. The words ThinkDIFFERENTLY are painted in yellow and blue, are encased in a large white circle. Around the logo are words, some of which include, "Help," "Advocate," "Love," "Include" and "Engage."

"Everyone walking by is asking 'Oh, did you do this one?'" said Crowley about the Veterans mural. Crowley talked about how a woman from Atlanta who saw Crowley painting, remarked to Crowley that her wish was that murals were on almost every building.

Annual reading set in Village of Fishkill

In the Village of Fishkill, the annual reading of the Declaration of Independence will take place. The reading is set for 11 a.m. on Monday, July 4 outside of Van Wyck Village Hall, 1095 Main St., in the village.

"I'm so excited for our Fourth of July ceremony at Village Hall. This will be my first time hosting this event as mayor, and I am so happy to be continuing this tradition," said Village of Fishkill Mayor Kathleen "Kathy" Martin.

"Not only is the reading of the Declaration of Independence a celebration of who we are as Americans, it is a way to keep our history alive," remarked the Martin.

Each year a guest reader is chosen to read the Declaration of Independence. This year, the guest reader will be Acting Dutchess County Sheriff Kirk Imperati.

"He was chosen because he epitomizes civil service, integrity, and complete dedication to the people of Dutchess County. I am looking forward to hearing Kirk read for us," remarked Martin.

The mayor added: "I would encourage anyone who has never attended this event to come! The reading of the Declaration of Independence is a wonderful way to honor the true meaning of the Fourth of July."

East Fishkill to host fireworks

In East Fishkill, the Town will be hosting its annual 4th of July celebration at 7 p.m. on July 1 (rain date is July 3).

As for what attendees can expect from the concert, East Fishkill Recreation Director Bill Green said there will be "great oldies music and a big fireworks show this year."

Adam & The Newhearts will be performing. This is Adam and the band's 34th straight year entertaining the crowd in East Fishkill, remarked Green.



"I saw this [large space] when I was doing that one (the Veterans mural). I was like 'you know this in another great big canvas,'" remarked Crowley.

Crowley said, "A lot of people walking by said, 'Oh, what's ThinkDIFFERENTLY?' A lot of people didn't know, she remarked.

"As a funeral director I too, have come in contact with many people and many families; we all act and grieve differently at these funeral and life events, that does not make any of us less than the next. Here at Libby Funeral Home in Beacon we, my staff and I, take great pride in serving each individual person at their level," said Joseph Schuka, Libby Funeral & Cremation Services.

Schuka recalled speaking with Dutchess County Executive Marc Molinaro when the 2021 mural was revealed for veterans.

As for the ThinkDIFFERENTLY campaign, Schuka said, Molinaro wants businesses and the community "to make them feel more welcome in places, and included in the workforces, and for businesses to support."

The mural caught the attention of one child, said Crowley. The little girl did not

want to leave, Crowley recalled. She stayed, with her mother, for 30 minutes watching Crowley work on the mural.

"This mural means a lot to me, too. I am a mom of a child with severe epilepsy. He has since passed, six years ago. I feel like people don't understand epilepsy, how hard it is for people to make that their new normal," Crowley said. Crowley's son, Joey, was two years old when he died.


"His (Joey) birthday was yesterday (June 20). That's when I started the mural," Crowley remarked. Since her son's passing, she has started the nonprofit Smiles From Joey, which donates adaptive equipment to families who cannot afford it or whose insurance companies will not pay for it.

"People sometimes don't recognize or understand everybody's got their own normal," said Crowley, who added she feels there is a reason and purpose she was commissioned to paint this mural.

Crowley still needed to add puzzle pieces to the artwork.

"Once the puzzle pieces go up, I think that there will be a connection to disabilities," said Crowley.

Crowley said she would be finished with the mural the afternoon of June 21.

First responders recognized by Dutchess County Emergency Medical Services Council

The Dutchess County Emergency Medical Services (EMS) Council recognized EMS providers, EMS agencies and local hospital staff on June 22 at the American Legion Post 429 in Rhinebeck. The annual awards highlight the important role of first responders and the services they provide to the community. Erin Downing, Public Safety Call Taker at the Dutchess County Department of Emergency Response 9-1-1 Call Center, was honored with the EMS Communications Specialist of the Year Award, which is given to an individual who has made significant contributions to the EMS community as a call receiving operator, dispatcher or call taker and has shown dedication, responsibility, professional behavior, and skill during communications.

Dutchess County Executive Marc Molinaro said, "Congratulations to this year's award recipients, especially our own, Erin Downing. Her professionalism, calm demeanor and compassion have helped numerous residents feel safer, calmer, and more in control during a very stressful time. The brave men and women who serve as first responders cannot be recognized often enough; we are grateful for their dedication to their community and Dutchess County."

In her role as a Public Safety Call Taker with Dutchess County, which she began in February 2021, Downing has taken numerous calls for individuals or whose family members were experiencing significant medical emergencies requiring her to talk the caller through administering CPR. Downing handled these sensitive calls with compassion, empathy and professionalism, remaining calm under pressure and providing essential information to her fellow dispatchers in a timely manner. She has also worked as a public safety dispatcher with a local police

agency since 2019.

Dutchess County Director of 9-1-1 Timothy Darcy said, "Despite her relatively short career, Erin handles every call with a consistent level of calm professionalism. Whether accidental 9-1-1 calls or serious issues, Erin ensures responders have all available information about the caller and the emergency and she makes sure the caller has been given appropriate instructions and reassurance before responders arrive on the scene."

Miles of Hope announces 2022 scholarships

The Miles of Hope Breast Cancer Foundation recently announced Scholarship awards to 10 Hudson Valley students.

"This is one of the most rewarding things we do," explained Executive Director, Pari Forood. "Each year, a committee made up of members of our Board, former and current teachers, and the two co-founders of the foundation get together to review applications and

read heartwarming essays from students whose lives have been impacted by breast cancer."

The Miles of Hope mission is to fund support services, education and outreach for people affected by breast cancer within the nine counties of the Hudson Valley. In 2022, the foundation received 24 applications from six counties – 10 students were awarded between \$1,250 and \$5,000 for their college/university expenses.

"We work with Guidance Counselors in 24 school districts to make sure that any student whose life has been affected by breast cancer has the opportunity to apply for this scholarship. The process is relatively easy. Students submit their grades, class rank, and volunteer activities as they relate to breast cancer, and an essay telling us how breast cancer has impacted their lives," Forood said.

The committee is made up of breast cancer survivors and people who have also been affected by the disease. The entire process takes a few months from receipt of the applications online, to assessing them. It is one of our most important programs along with helping people in treatment with their bills and

County has to do better in recognizing Juneteenth

To the Editor:

In 2021, Democratic legislators in Dutchess County proposed a resolution to make Juneteenth a county holiday. We believe Americans in every corner of the nation should share this opportunity to celebrate Emancipation, spend time with family and friends, and remember and reflect on the two-and-a-half-century struggle against slavery.

A quick search finds that many New York counties (among them Albany, Erie, Essex, Onondaga, Suffolk, and Ulster) have declared Juneteenth a holiday. But the chair of the Dutchess legislature rejected the bill (the 34th time he blocked consideration of a Democratic proposal). He informed us that the legislature could not "recommend employee contractual benefits" and observance could only be decided by "those who control the County holiday calendar"—the Executive.

Last week, County Executive Marcus Molinaro said he supports Juneteenth (though there is no record of him ever calling for a county holiday) but can't act "without a deci-

sion by the county legislature."

What a joke. Either these guys are too incompetent to understand their own official powers, or they don't want Juneteenth in Dutchess but don't want to say so. (If past experience is a guide, both will now hastily claim it was the unions' fault that employees did not get the holiday.)

Democratic legislators tried again last week, on the eve of Juneteenth, to urge Dutchess to join the nation, state, and other counties in recognizing Juneteenth but they were rebuffed again.

Dutchess has one of the largest African-American communities in the Hudson Valley as well as thousands of allies who care about the legacies of injustice. At a time when citizens are struggling with economic hardship and lack of services, here is one more sign of contempt. We deserve better.

From very small to very large - All part of Dutchess history

Among tens of thousands of items in the Dutchess County Historical Society's Collections, we examine two items at the opposite end of the spectrum in terms of size.

Among the smallest items is the one quarter of an inch wide piece of Italian glass shown in an accompanying photo, set in a ring. We know from a handwritten note that accompanied the 1962 gift to the historical society, that the small piece of glass was purchased in Venice in 1886 at the world-renowned glass center of Murano, likely by a member of the Storm or Van Wyck family of Dutchess County. It was embedded into a ring shortly after that in London.

The item is a gift of Mrs. William D. Rees whose Storm and Van Wyck ancestors settled in southern Dutchess County in the 18th century. Rees's collections gift included many items related to European travel. Other items include an 1849 passport of Cornelius Storm, and a book purchased in London more precisely around the time the glass was bought and embedded in a ring in 1886.

Called a Murrine, the glass is made from the tiniest of threads or straws of colored glass, assembled into a cane while molten hot. The glass is then sliced into small segments such as is shown here. The ring is designed so that you can look through the glass from either direction and see the image. The process is estimated to have originated 6,000 years ago in the Middle East.

Given the subject depicted, and the quality of the glassmaking (a crack developed later, perhaps in the setting of the glass in a ring), we know the piece was made by Jocomo Franchini in the 1870s. He was considered a master of this art who had revived the process after going dormant. He frequently depicted well known individuals

involved in the Risorgimento, or Italian "rising," the movement for Italian unification that resulted in the establishment of the Kingdom of Italy in 1861. Here he depicts a political leader of what was a larger movement of identity and culture, the statesman Count Cavour.

Franchini had an unfortunate later life as he was committed to (what was called in those days) an asylum for the insane. His constant work on the tiniest threads of glass is frequently described as the reason for his breakdown. Franchini was the son of renowned glassmaker Giovanni Battista Franchini, who also focused on tiny craftsmanship.

Structural beam

By contrast, among the largest items, we find a four-foot segment of a structural beam from the 18th century home of Henry Livingston, a home that was located along the Hudson River near the rural cemetery.

During the Revolutionary War, Dutchess County and the Hudson River were a major focus. George Washington called West Point, just to the south of the county on the river, the "key to the North American continent." The British saw a major strategic advantage in splitting New England from New York and the rest of the states. They were secure in Canada because it was a British colony. They had captured and occupied New York City. So, the goal was to approach from the north and south, meet in the middle, and occupy the river.

In a July 16, 1777 letter in our archives, we see that Henry Livingston wrote to a relative saying quite confidently that the British would never dare such a risky venture as coming up the river from the south as it would be "madness." It turns out Mr. Livingston was not a good forecaster.

The descent from the north failed.

But a tactical move to burn Kingston, then the state capital, and create as much havoc as possible on the way up and upon their return, was successful just a few months after that letter was written. In October of 1777, the British Navy managed to break through the chain across the Hudson at West Point and wreak havoc going as far as Red Hook.

They tried to burn as many homes, barns, ships, and stores of those not loyal to the King as possible, by coming on shore with torches. The burning of a barn in October would have been particularly costly because it contained the entire harvest of the prior year. It was not so much the barn, but its contents, that cost the patriots so dearly.

The British also lobbed cannonballs from afar. Henry Livingston was not spared. He kept the hole where the cannonball entered his home intentionally visible to visitors. A photograph of the

patched area of the wall of his house facing the river was featured in the 1919 DCHS Yearbook. A four-foot section of the beam was removed when the house was demolished in the early 20th century and given to DCHS.

The cannonball has ended up at the George Washington Headquarters Museum in Newburgh. We have been in touch with them to potentially arrange a reunion of the cannonball and the structural beam for the 250th anniversary of the American revolution in 2026. Stay tuned!

Renegades struggle to start second half of season

The Hudson Valley Renegades have had a tough start to the second half of the South Atlantic League minor league baseball season, dropping their third consecutive game on Sunday, 4-1, to the Winston-Salem Dash at Truist Stadium.

The Renegades finished their 12-game road trip by falling back under .500 overall at 34-35 and are now 0-3 in the second half of the season. After the first 66 games of the year, the division winners automatically qualify for the playoffs and the teams re-set their records back to 0-0, with the hopes that those who struggled will rebound.

Hudson Valley was set to return home on Tuesday to face the Brooklyn Cyclones to begin a six-game series.

In Winston-Salem, T.J. Sikkema allowed a run in the bottom of the first inning on an RBI single by Oscar Colas to give Winston-Salem a 1-0 lead. That was the only run allowed by the left-hander on the day in a career-high 3.2 innings.

The Renegades tied the score in the top of the third when Everson Pereira

blasted a solo home run to center off Andrew Dalquist. The round tripper was Pereira's seventh of the season and 21st in a Renegades uniform – one shy of Dan Grummitt's career franchise record of 22.

Leif Strom backed up Sikkema with 2.1 scoreless innings out of the bullpen, but in the bottom of the seventh the Dash took the lead against Nelvin Correa (0-2). Ben Norman singled and advanced to second on a wild pitch before scoring on a Duke Ellis single.

In the bottom of the eighth, Winston-Salem tacked on two insurance runs off Nelson Alvarez to expand its lead to 4-1.

Vince Vannelle set the Gades down 1-2-3 in the ninth to earn his fourth save of the year.

Aaron Palensky finished 2-for-3 with a double, and had five hits in the last two games of the series with the Dash. On the road trip, Palensky hit .370 (10-for-27) with three home runs and five RBIs. Palensky finished 3-for-4 with a home run and an RBI in a 6-3 loss to Winston-Salem on Saturday night.

Preparing for the second half and planning fan attractions

Your thoughts now that the first half of the season is over (the Renegades finished 34-32 in the first 66 games; teams re-set their records to 0-0 for the next 66).

I thought we played pretty well. We had a little bit of a rough spell for a bit there, but we finished well. We played real well at home and we're looking forward to the re-set and see what that brings. Hopefully Aberdeen isn't as hot in the second half (Aberdeen won the South Atlantic League's North Division in the first half and qualified for the playoffs).

How about on the business end?

From the business side of things, the weather is better, the fans are more famili-

iar with when and how often we play as a High Class A team now, and we have a good schedule coming up. Just this week we have three big fireworks show, including our biggest of the year on Sunday (July 3).

Halfway through this season, what is the update on the work that has to be done to Dutchess Stadium?

From a fan perspective, everything is in place. There's nothing to do this season. The player amenity upgrades that need to be happening will start in 2023. The existing clubhouse will be renovated, bullpens will be moved off the field, and the outfield wall is coming down (and will be padded). The batter's eye in centerfield needs to be resized. The current requirements say it needs to be 60 feet high and 30 feet across. The current clubhouse will become the permanent visitors' clubhouse, and the Renegades will get a new clubhouse by 2024.



Wow, that's a lot of work. Do you remember that first season in 1994 and what that clubhouse looked like? I'll forego my comments.

(Laughs) I sure do, it wasn't much to

look at. It was all trailers, but of course it was necessitated by the short turnaround to build the stadium. It took a few years before everything was completed down there. I remember it well, but it served its purpose. Everybody was patient with it. It was a good temporary fix.

Can you imagine trying to build that stadium today, having a final vote by the County Legislature in late March/early April and getting the thing built by mid-June to start that first season?

It wouldn't happen today. You can't even get construction materials right now in 71 days, let alone what was built back then. Anybody I tell about the vote to opening day timeline to get it built, people are fascinated. If you remember we didn't have a front gate. We had the seating bowl, the field and the bathrooms. It was pretty amazing. To this day, I look back at how that all came together and I am still amazed.

faith in Wagaman and assigned him back to Hudson Valley.

While he has struggled to hit consistently, with a .239 mark, the youngster has flashed his power. As of Sunday, June 26, Wagaman had eight home runs, 19 RBI and a respectable OPS (on-base percentage plus

slugging percentage) of .828.

"I was pretty upset at first," Wagaman told MyCentralJersey. "I mean, I was pretty upset the whole time. But, at the same time, I can't just like stop playing or stop trying to get better. I can't just sit here and do nothing. He called me in and was like, 'This sucks, but this is how it's going to be right now, just try and

keep your head up and wait for your turn.'"

The Yankees, and the Renegades, are pleased that Wagaman didn't throw in the towel mentally after the disappointing news.

"I've known 'Wags' now for a while, he's been in the organization for some time, and he's just a fantastic dude," Hudson Valley manager Tyson Blaser told the website.

"Good attitude, and he's ready to go at any point. He was excited to actually be down here. We had a conversation, and he was like, 'Hey, I'm excited to be here and to be able to play.' He's getting that opportunity, he's putting good at-bats together for us, and he's a veteran guy, so he's out here and he knows the role. He's setting a good example for some of these younger guys."

Notes from the Town of Wappinger Supervisor

Wappinger at a Crossroad Part III: The Issues and Opportunities of the 2010 Comprehensive Plan

I noted in Part I of this series that the Town of Wappinger adopted, in 2010, a Comprehensive Plan (the "Plan") reflecting "the hopes and expectations of the people of Wappinger".

The Plan proposed a framework for future regulation and development of the Town, while prioritizing the promotion and protection of the public health, safety and general welfare of our residents. And, it did much more. The Plan sought to balance those core elements with the competing needs of achieving sustainable economic growth and, most importantly, maintaining town services and infrastructure at an affordable level.

Commercial, infrastructure, and housing development is needed to minimize the tax impact on our residents.

Since 2010, the vision behind the Plan has been confirmed constantly. But, other factors have challenged our ability to make that vision a reality. The Plan's core issues remain as significant today as they were in 2010:

- i. A small and declining economic/commercial base;

- ii. The unavailability of affordable work force housing for our front line workers, our teachers, our store owners, the recruitment base for volunteer firefighters, and for our senior residents who want to continue to live in Wappinger; and

- iii. Growing threats to our dwindling farmland, our public open spaces, and our water sources, to name a few.

In Part II of this series, I identified several key Plan priorities that we must continue to address in the months ahead, including:

- Creating sustainable economic development and redevelopment along our commercial corridors and hamlet commercial districts (adding more car dealerships is not the solution);

- Protecting the sources of our public and private water supply,

- Closing non-compliant sewer plants and expanding the pipeline infrastructure for Town water and sewage;

- Mitigating against future flooding within the Town, not just along our creek and river corridors, but also orig-

inating from our oversaturated wetlands;

- Preserving and enhancing our public open spaces including our parks, Greenway trails, waterfront corridors;

- Addressing the growing need for housing for our working professionals (most especially our Covid heroes) and seniors, most of which housing needs to be within the economic reach of our residents;

- Enhancing our community's character by capitalizing on our unique combination of assets in order to sustain Wappinger as an attractive place in which to live; and

- Revision of Town Code provisions affecting the above identified priorities.

How can we maneuver the crossroads successfully? I envision a 9-point plan, the first four items are addressed in this article. I will cover the remaining five items in my concluding column on the Plan.

1. Prioritize commercial redevelopment along Route 9, most especially in order of urgency: (a) Alpine Commons (including work force housing and a "village within the village") where The Town cannot afford to lose the anchor BJ's; (b) Plant Depot site; and (c) Hannaford's Shopping Plaza, to begin with. And, based on Plan recommendations, work on hamlet development.

2. Adopt the Water Source Protection Plan ("WSPP") and Town Code Amendments being considered by The Town Board, including addressing the roadway salt issues. The final WSPP, to be addressed by the Board shortly, will make a number of recommendations.

3. Extending the Town's water and sewer lines: (a) South along Route 9 through a Municipal/County, State and Federal/Private sector consortium; (b) West along New Hackensack Road to the Village line (including the decommissioning of our Wildwood sewer plant); (c) North and South along Route 376 so as to decommission our Royal Ridge plant and to expand services generally in this area; and (d) within the Hamlet of Hughsonville. While these three locations are our top priorities,

they are not exclusive of other areas under evaluation. Plans are being finalized for the four initiatives. We will partner with the County and neighboring municipal agencies on these capital projects.

4. With respect to mitigating against future flooding within the Town, the final 9 Element Plan of the Wappinger Creek Intermunicipal Council, of which I am Chair, has been released. Our action plan will be established shortly. Now that the 9E Plan has been finalized, I plan to undertake a similar study for the Sprout Creek, with major goal and objectives to reduce flooding along the Creek and to enhance Town recreation areas along the Creek. Other aspects will be addressed in my next and concluding column.

Junior's Lounge in Hyde Park destroyed in tractor trailer accident

On June 20, a fully loaded tractor trailer crashed into Junior's Lounge on Salt Point Turnpike, killing the driver of the truck and destroying the popular bar.

According to the Town of Hyde Park Police Department, the lead agency, Dutchess County 911 dispatched Hyde Park Police to the scene around 10:41 a.m. on June 20 for a report of a two-car auto accident with a partial building collapse. Patrols found a 2020 Peterbilt tractor operated by Craig Allen Dickson, 33, of Hopewell Junction. The tractor, which had been pulling a fully loaded dump trailer, was partially through Junior's Lounge. The report stated that the building was heavily damaged and was being held up by the dump trailer.

The owner of Junior's Lounge, Louis C. Rossi, was inside the bar when it was struck. There was an upstairs tenant, Sarah Dempsey, sleeping in the front apartment. The crash caused her to be carried out of the building along with her bed, coming to a final rest on the top of the tractor trailer. Rescuers found her in rubble on top of the truck. She was transported to MidHudson Regional Hospital and treated for minor injuries.

The police report acknowledged that the events leading up to the crash are still being investigated, but investigators believe the driver of the tractor trailer was involved in a crash in the City of Poughkeepsie, at the intersection of Weed Street and Smith Street. The tractor trailer left the scene of that auto accident and continued east from Smith Street to Salt Point Turnpike. Witnesses reported the tractor trailer was driving erratically and went into the westbound lane of traffic several times on Salt Point Turnpike.

Just west of Junior's Lounge, the tractor trailer was involved in a collision with a 2021 Toyota Highlander operated by Kimberly C. Glatz of Hyde Park. The impact caused the Toyota to overturn and came to rest on the south shoulder of the roadway. According to the report, the Peterbilt appears to have over-corrected or was deflected from that crash and went off the south shoulder of the roadway and struck the building before coming to rest partially through the building.

Glatz was extricated from the vehicle and transported to Vassar Brothers Medical Center for evaluation. She did not suffer any major injuries.

Dickson, the driver of the tractor trailer, was pronounced deceased at the scene by the Dutchess County Medical Examiner's Officer.

The building was deemed to be unsafe by the Town of Hyde Park Building Department and was torn down by Amity Construction.

This incident is still actively being investigated by the Hyde Park Police Department, New York State Police Commercial Vehicle Unit, and the New York State Police Accident Reconstruction Investigators.

Anyone who has any other information or may have witnessed any erratic operation is asked to call the Hyde Park Police Department at (845) 229-9340.

The Hyde Park Police Department was assisted by the NYS Police Patrol, Bureau of Investigation, Forensic Investigation Unit, and Accident Reconstruction Unit; Dutchess County Sheriff's Office; Roosevelt Fire District; Arlington, LaGrange and City of Poughkeepsie Technical Rescue Team for building collapse special operations; Pleasant Valley Fire District; East Clinton Fire District's Rehab Unit; Northern Dutchess Paramedics EMS; Mobile Life Support; Empress Ambulance; Town of Hyde Park Building Department; Dutchess County Department of Emergency Response; Central Hudson; Brandl's Towing; Jim's Auto Body; Al's Garage; Amity Construction; and Thomas Gleason Inc.

Deer in the headlights

At this point the rain was coming down in buckets and there was thunder and lightning. Pop told me to get in the hole and get the pipe put back together because the apartments were without water. The deer looked right into the headlights and

Again, the deer looked into the headlights. I nodded my head and said I was OK. I looked at my hands and saw a burn mark in my palm and on the back of my hands. Pop said I had been blown out of the pit by a bolt of lightning.

I was in a bit of a fog. Everything was moving slowly. Pop kept asking me if I was OK. Slowly my wits came back and finally I told Pop I was good. He asked if I was sure.

Again, the deer looked into the headlights. I nodded my head and said I was OK. Pop looked me in the eyes and said, "OK, get back in the hole and finish the job."

As I said, Pop was very persuasive. So ... the deer looked into the headlights and ... I got back into the hole and finished the job. Did I mention it was my birthday? July 26th.

That night Mom made Vinny and me grilled chicken with lemon and mint with this pasta that was better than anything I had ever eaten. Maybe it was the hard work or maybe it was the deer in the headlights, but that was probably the best meal I ever had.

Ditalini with lemon, tomatoes and capers

Ingredients

- 1/4 cup extra virgin olive oil

- 3 cloves garlic, diced fine
- Large pinch crushed red pepper flakes
- 10 cherry tomatoes cut in half
- 3 teaspoons of capers
- 1/2 cup of Kalamata olives, roughly chopped
- 1 lb. ditalini
- Freshly ground black pepper
- 1/2 cup diced onions
- 1 lemon

Method

• Put a 10-inch skillet over medium-high heat. When the pan is hot, add the olive oil, onions garlic and red pepper flakes and cook for about 2 minutes. Carefully add the tomatoes, capers, and olives. Reduce the heat to medium low. Simmer until the tomatoes get warm and slightly cooked.

• Cook the ditalini in the boiling water until it's just tender. Drain the pasta and put it in a large bowl. Add the sauce and squeeze the lemon. Toss till mixed thoroughly. Taste and season well with salt and pepper. Serve hot, warm, or at room temperature. Great side dish with grilled chicken.

Hyde Park's July 4th Parade to celebrate beautification group



The Hyde Park's Independence Day Parade's theme for 2022 is "Keeping Hyde Park Beautiful." The parade is set for July 4.

More than 50 groups and organizations are slated to take part in Hyde Park's Independence Day Parade on Monday, July 4. This year's theme is "Keeping Hyde Park Beautiful," celebrating the 50th anniversary of the Hyde Park Visual Environment Committee (HPVEC). The parade steps off at 10 a.m. from Roosevelt Cinemas on Route 9 in Hyde Park and proceeds north to Town Hall.

The HPVEC will serve as the grand marshals. Committee Chairperson Cathy Lane said, "We'll be carrying a banner and hope to have a car behind us [displaying the HPVEC logo]."

Instead of tossing candy to spectators, "We're going to be giving out seed balls of *asclepias tuberosa* [a species of milkweed known as 'butterfly weed'] ... it's better behaved in a garden bed," Lane said. "You can plant them now, [but] they won't bloom the first year."

HPVEC is also celebrating a \$20,000 Learn, Play, Create grant they just received from Dutchess County to install

a sensory pollinator demonstration garden at Staatsburg Library that will include activities to nurture the sensory needs of children with special needs.

Incorporated in 1972, the organization's mission included increasing residential involvement in the local planning process and creating a defined vision for Hyde Park's future development. While the most "visual" sign of its impact in the community can be seen in spring when the daffodils bloom, and in the restoration of stonewalls along the town's commercial corridors, the HPVEC also focuses on architectural and historic neighborhood preservation, overall beautification, commercial and suburban development (including their affects on ground water) and commercial signage ordinances.

Hyde Park Recreation Leader Teresa Gasparaini said there will be floats from the Dutchess County SPCA, Rondout Savings Bank (also the parade sponsor), Boy Scout Troop 37, Knights of Columbus and New Deal Creative Arts Center, among others.

There will be performances by Dance Works Too, Leclerc's Martial Arts, Patriots Fife & Drum Corps and Saints of Swing.

"Brandl's will be there with their spectacle [of linked trucks] but will also bring a band on a flatbed truck," Gasparini said. "There's a lot of music this year, more than usual."

Multiple fire departments will also be in the parade, including Roosevelt, Hyde Park and Pleasant Valley.

"[The parade is] stocked with the best of the best!" she said.

Jean Anthony Epting, Volunteer Manager at Dutchess County SPCA, said, "We will have our Humane Law Enforcement Vehicle pulling a 20-foot trailer that will be decorated according to this year's theme. ... Weather permitting, we will have a dog on the float with a swimming pool, along with an abundance of fresh greenery mixed with some artificial flower displays. Large paintings of some of our shelter animals will also be displayed."

DCSPCA staff and volunteers will continue the floral theme by wearing flower prints, as well as flower crowns or hats with flowers.

"To keep 'Hyde Park Beautiful,' we will be sharing rolls of 'dog waste bags' with people along the route to help ensure people pick up after their pets," Anthony Epting added.

Trophies will be awarded at Town Hall at the conclusion of the parade. There are first-, second- and third-place trophies in the categories of Community Float, Commercial Float, Marching Unit, Fire Department and Performance.

After the parade, there is "usually a nice little gathering, people just hanging out," Gasparini said. "[Town of Hyde Park Historical Society President] Carney Rhinevault might be there cooling everyone off with his hose if it's a hot day." She recalled marching in the parade a few years back, on a particularly sweltering day, and Rhinevault – who lives near Town Hall – provided much-needed relief with a spray hose.

In addition to thanking Rondout Savings Bank for sponsoring the parade, Gasparini acknowledged the town's Recreation Commission for volunteering at so many community events, including the Independence Day Parade.


"They just donate so much time to their community," she said. "They live and work in the community."

Gasparini noted the excitement she sees in people attending Hyde Park Rec events lately.

"Everyone is so happy to be back out. People are joyful," she said.


