Municipalities to celebrate the 4th of July with variety of events

Municipalities across Dutchess County will celebrate America's 249th birthday over the July 4th weekend.

'Ben Franklin' to read in Fishkill

A reading of the Declaration of Independence will take place in the Village of Fishkill. The reading will occur at 11 a.m. on July 4th at Van Wyck Village Hall, 1095 Main St.

In 1899, there was "an informal" reading of the document at Van Wyck Hall, said Antonia "Toni" Houston, local history librarian at Blodgett Memorial Library.

Henry Du Bois Van Wyck, "the President (now called Mayor) of the Village of Fishkill, stated his desire that as long as the hall stood, he hoped that there would be a public meeting and reading," explained Houston. She continued, "There is no mention in the papers of the time of a reading happening in 1900, and in 1901 it was noted that the "day was celebrated in the usual manner," a day "quietly observed by most people, though the younger residents fired all the crackers they could get" from the Fishkill Weekly Times. Mr. Van Wyck had died in March of 1901, and his heirs, knowing of his patriotism, thought that it would be appropriate if the Declaration could be read each year from the steps of Van Wyck Hall, which he had gifted to the Village. Such was the beginnings of our annual reading." Attendees can bring chairs. Main St. will be closed to traffic during that time.

Houston noted, "It was long thought that this was a requirement of the gift, and by the time the error of this was discovered, sometime in the 1950's, the tradition was long established."

Everyone who comes loves the tradition remarked Houston. "Some talk about how they first came as children, or how they try

to come every year because it's become their own tradition." One can sign the guestbook after the ceremony and enjoy water and cupcakes courtesy of ShopRite, said Houston.

Village of Fishkill Mayor Kathy Martin said, "It is important for the Village of Fishkill to continue this tradition because it serves as a reminder of our history. Reading the Declaration aloud reinforces the principles of freedom, and also highlights the sacrifices made by our forefathers. The Fourth of July reading reminds us of the freedoms we enjoy as Americans, and the importance of protecting them."

Re-enactor Jack Sherry will be the reader at the annual event, sponsored this year by the Fishkill Historical Society.

Sherry will be portraying Benjamin Franklin, one of 56 delegates who signed the founding document.

Sherry has been portraying Franklin (who was a publisher, writer, scientist, diplomat and accomplished more during his life) since 2003 (and it is Doctor Franklin, "after all, I did not spend two years of my life in formal schooling for nothing you know," remarked Sherry as Franklin).

At 2 p.m., Sherry will be portraying Franklin at the Van Wyck Homestead Museum. He will be there "to explain how the original draft of the Declaration of Independence, as written by Thomas Jefferson, was changed by the delegates

Green Teen youth to host free farm stand in Beacon

Look for Green Teen Beacon youth at the free farm stand at the Beacon Recreation Center, in Beacon, beginning Thursday, July 3. They will be there on Thursdays, not Wednesdays as in previous years.

Emily Murnane, Green Teen Beacon 4-H Program Manager, said, the day has been changed to accommodate scheduling conflicts with those who are partnering with Green Teen.

"The response to the farm stand has been overwhelmingly positive," said Murnane of previous experience, who explained some patrons begin lining up more than 90 minutes before the stand opens. Patrons do not only come from the local area in Dutchess County but from Newburgh in Orange County as well, she noted.

"There is a warm community of regulars who have come to the market for years now. The start of the market each summer is met by community members and the neighborhood with much enthusiasm and joy, and the end of the market each fall is met with a lot of gratitude. In 2024, we served, on average, about 30 households every week. There is a great need in our community for accessible, healthy food and our market, meeting that need, is deeply appreciated by the folks who need it most," remarked Murnane.

What can patrons expect if they go? "Patrons can expect to see the week's harvest, freshly picked and washed from Green Teen's garden, arranged at the picnic tables in baskets and crates, creating a bountiful display. The market is staffed by Green Teen summer program participants - smiling local youth dressed in iconic green shirts who will assist patrons with selecting and bagging their produce. The Green Teen garden sits just steps away from the market, and patrons are welcome to take a step inside to see where their food has come from," she said.

One community member offered Green Teen the following statement via email, which Murnane shared: "I want to express gratitude for the cost-free vegetable stand. It has helped us stretch our grocery budget and the vegetables have been delicious. Looks like the teens helping have been having fun too."

Wappinger WWII veteran celebrates 100th birthday

Alexander W. Hubner Jr. ("Al"), a resident of the town of Wappinger, turned 100 years old on June 29. Al was born to Alexander Sr. and Helen Hubner in Brooklyn on June 29, 1925.

Members of Wappingers Veterans of Foreign Wars (VFW) Post 5913 and other local veterans and community members celebrated the birthday of the World War II veteran on Friday, June 27 at their Post.

Virgil Capollari, VFW Post 5913 Sr. Vice Commander, said Al was one who "helped pave the way to save the world" during World War II.

"There is no amount of debt that can be repaid," added Capollari, who along with other veterans presented Al with a watch in honor of his momentous birthday.

Al sat at a table with numerous cards from well-wishers for his birthday. He told of how he was drafted into the U.S. Army. He was 18 years old.

Al recalled how he was reassigned to Company C, 1st Battalion, 376th Infantry Regiment, 94th Infantry Division from the Army Specialized Training Program. He became fluent in German, however, and in 1944, he was sent to France. He was reassigned again – this time as an Intelligence Non-Commissioned Officer (NCO) in Headquarters Company, 1st Battalion, 376th Infantry.

According to the Friends of the National World War II Memorial, Al conducted intelligence patrols and prisoner interrogations across France, Germany, and Czechoslovakia. He earned three Bronze Stars, a Good Conduct Medal, a Combat Infantry Badge, the WWII Victory Medal and other decorations.

Al and his wife, Virginia (who died in 2024), were married on July 27, 1952. The couple, who were married for 72

years, have 4 children, Kurt (who was unable to make the celebration), Steven, Linda, and Andrew.

Steven told of how his grandparents moved from Wappingers Falls to Brooklyn, where his father was raised.

"An only child I was," stated Al. Asked about a favorite memory of growing up in Brooklyn, Al replied, "There are so many."

Al and Virginia moved to Wappingers Falls in the mid-1950s, where they raised their family. Al worked for IBM for almost 40 years. He served in IBM World Trade, which took him to Scotland, England, India, Japan, Argentina, and Brazil.

"It's a wonderful accomplishment. All the kids are happy that he's still here with us and we can continue to share these memories," remarked Steven, who noted he and his siblings are "very proud" of their father's service to the country during WWII.

Town of Wappinger Supervisor Joseph Cavaccini announced a proclamation proclaiming it "Al Hubner Jr. Day" in Wappinger. Cavaccini noted, "Al was the Grand Marshal" for the Town's 150th birthday celebration earlier this year. Al is also the longest-serving Odd Fellow in the community, added the supervisor.

Linda said of her father's 100th birthday that it is "a great milestone for a wonderful father," adding he was also a wonderful husband to her mother.

Andrew said of his dad, that he is "a wonderful father and role model." He continued, "It's been nothing but a pleasure to be his son."

STOP-DWI enforcement campaign runs July 3-6

Various law enforcement agencies in Dutchess County will take part in a targeted initiative to reduce impaired driving during the Independence Day holiday weekend, part of a statewide STOP-DWI High Visibility Engagement Campaign, from Thursday, July 3 through Sunday, July 6. Local police departments across New York State will work together and increase their presence as part of a unified campaign aimed at preventing alcohol-related crashes, injuries and fatalities during this time.

Dutchess County Executive Sue Serino said, "As we celebrate our nation's independence, it's important to protect the safety of those around us on our roadways. If you choose to drink this Fourth of July weekend, please plan ahead for a safe ride home. One careless decision can change lives forever."

Across the country, the Fourth of July ranks as the second-most dangerous holiday for drivers and passengers. Data from the National Highway Traffic Safety Administration shows that from 2019 to 2023, there were 2,653 traffic crash fatalities during the Fourth of July holiday period; in 2023 alone, 617 drivers lost their lives in traffic crashes during the

holiday period.

The July 4th Weekend enforcement campaign is part of a broader series of enforcement efforts organized by the New York State STOP-DWI Association, supported by the STOP-DWI Foundation through a grant from the Governor's Traffic Safety Committee. In addition to this upcoming initiative, similar statewide campaigns are held during other high-risk times of the year, including Super Bowl Sunday, St. Patrick's Day, Memorial Day, Labor Day, Halloween, Thanksgiving and the winter holiday season.

Although STOP-DWI programs throughout New York have helped decrease the number of alcohol- and drug-impaired driving deaths, too many lives are still cut short due to these preventable crashes. Public awareness campaigns like the July 4th weekend crackdown are designed to make an even greater impact by deterring impaired driving through strong visibility and outreach.

Drivers can help to make a difference by having a sober plan! Motorists can download the mobile app, "Have a Plan," and be able to find a safe ride home www.stopdwi.org/mobileapp.

to the Continental Congress," said Alexis Lynch, who is with the Fishkill Historical Society. "Thomas Jefferson kept the original document so that comparisons can be made. You will be amazed at what was removed!"

Sherry acknowledged that attendees "will discover why Ben did not write the Declaration of Independence and what changes he contributed to it." He also mentioned, "Ben was probably the most approachable of all the Founding Fathers."

A retired history teacher, Sherry said, "I enjoy teaching people about Franklin's life and times, especially the little details the history books leave out." He added, "One aspect of Ben's life that usually surprises people is that he never patented any of his inventions. Find out why by attending the reading and program on the Fourth of July."

The Van Wyck Homestead Museum is at 504 Route 9, in Fishkill.

"The event is free and open to all," noted Lynch, who suggested attendees bring lawn chairs, as the event is outside (weather permitting).

of the community."

In July, "[i]t is our hope to offer the first of many of our garden vegetables, including kale, collard greens, squash, zucchini, radishes, and garlic scapes. A selection of herbs will also be available. Later in the season we will also have tomatoes, cucumbers, peppers, and cantaloupe," stated Murnane.

Each season, Green Teen youth offer anonymous statements during exit surveys.

Murnane sent Southern Dutchess News three of those statements from Green Teen Beacon youth.

One statement was from "J," age 17, who commented, "Green Teen means community to me. We address the needs of the community and meet new people. We learn new things that turn out to be essential."

Sixteen-year-old "G" said, "Working at Green Teen made me realize it's not just about Green Teen, but for the rest

"Working at the free farm stand is my favorite part of the summer. I like helping the community that way and it feels fulfilling," offered "M," 15.

The farm stand will be at the Beacon Recreation Center, 23 West Center St., on Thursdays from 5-6 p.m. and is first come, first served.

Murnane said the teens hope to have the stand open through Oct. 30, depending upon what is available from the harvest.

"Donations to our programs allow us to buy uniforms for the youth, ingredients for cooking activities, and garden supplies," said Murnane.

Picture fun, music, food and family, plus lights, rides and cotton candy. Then, add the massive "Livestock Hill" plus gallons of lemonade fit for guzzling, and every food item you can think of – fried! Are you at the Dutchess County Fair?

On June 23, the New York State Department of Agriculture and Markets took to the Ulster County Fairgrounds to announce initiatives to fund local and youth participation for the 50 county fairs across the Empire State.

At last week's meeting, Agriculture Commissioner Richard Ball highlighted the two newest initiatives: the Transportation for Youth to Local and County Fairs Program and the Agricultural Fairgrounds Advertising, Promotion and Education Program. Both intend to increase interest and participation in local fairs, especially for younger and underserved demographics. The tradition of fairs in New York State is one that spans generations. Family summers spent, prize goldfish that miraculously live for years on end.

Said Commissioner Ball, "I'm excited to continue our support of county fairs, including a unique new program that helps bring more young people to experience the tradition of their local fair. I'm looking forward to seeing the impact that these programs have during the 2025 season."

Continued involvement from young folks in Future Farmers of America (FFA) and 4-H initiatives across Dutchess County shows a promising future of fairs in the local region. With state officials implementing campaigns to strengthen and support the efforts of local fairs and agricultural properties, the promo-

tion of county fairs will also be evolving across platforms.

The New York State Association of Agricultural Fairs also gives out \$10,000 in scholarships per year.

The Dutchess County Fair, a representative of the Mid-Hudson region, received the Advertising and Marketing Grant.

A total of \$1 million will be dedicated to spotlighting fairs across the state, in a full marketing campaign to direct attention to fairs in local hotspot regions. In a multimedia approach, radio, television, and other modes of advertising are set to highlight the summer campaign. The "Get Offline, Get Outside" as named by Gov. Kathy Hochul, approaches fairs as a mechanism for creating memories with the entire family, no tech necessary. It's an opportunity to learn about agriculture-based economies while spending a day within the local community.

There is another opportunity to explore outside one's county lines, too, while Dutchess County Fair visitors wait for our own fair, which runs August 19-24.

Included in the campaign is the NYS Fairs Passport Program, encouraging New Yorkers to stamp their way across the state's county fairs, with an enticing promise of pins and stamps aptly named "Ag Swag." Frequent fairgoers can be delighted by the fairs of distant and neighboring counties. All it takes is a willingness to venture outside the borders.

New York's county fair season kicks off way north in Allegany County on July 15 and will wind down in September on Long Island.

It took until 1919 for Anna Rozelle to become the first woman candidate in a contested election as Overseer of the Poor in the town of Clinton.

This July 4th marks the 249th anniversary of the founding of our country, and the run-up to the celebration of the 250th anniversary in twelve months. Dutchess County Historical Society (DCHS) recently revealed how it will tell this amazing story at "RevCon" at FDR Library & Museum, where local historical organizations gathered to share their plans with each other and the public. The narrative of "American Journeys" will be explored in DCHS' 2025 Yearbook and in published articles, programs and performances. We will feature what is unique about our location, and profile local persons who journeyed to embrace and realize the American promise and dream.

Our unique location

General George Washington described the military site at West Point specifically, and the mid-Hudson area in general, as the "key to the North American continent" during the Revolutionary War. The British plan was to approach by ship from the south where they occupied New York City – and by ship from the north where Canada was a British territory. In addition to cutting the north/south supply route, New England's six States would be separated from the other Seven.

Mountainous Putnam County was a natural, protective barrier. Strategic sites emerged just north of it on both sides of the Hudson. Poughkeepsie became the State capital and the Fishkill Supply depot was a major supply point between New England and the other States, and was just across the Hudson from where Washington set up headquarters at Newburgh.

HV resident Kyle Kirshner named 'Athlete of the Month' for June 2025 by NY ABLE



which remain in use today. "Poughkeepsie" is what European ears heard local Indigenous People refer to as a "reed covered lodge at the watering place," and the name stuck. Halfway between the cusp of the Atlantic to the south and the intersection of the west-bound Mohawk River to the north, Dutchess was a crossroads with the great Mahican civilization to the north, the Wappinger or Delaware to the south, the Schaticoke to the east, and Munsee to the west.

Daniel Nimham (1726-1776) was from the area we refer to today as Wicopee. He became a renowned military leader in service to the British in 1755 in King George's War, but chose to side with the patriots in the Revolutionary War. He served with distinction but was killed in a raid in 1776. Nimham was a fierce advocate for the return of lands he claimed were illegally taken, which included his traveling (albeit unsuccessfully) to England. The issue of land rights remains among the prominent issues of Indigenous People today.

The journeys of the traditional working class

As the population of the United States grew beyond anyone's expectations in its first century, the largest population group, the White Protestant working class, fought for an equal seat at the increasingly diverse American table by arguing (successfully) for the elimination of property requirements for voting and the abolition of imprisonment for debt before the Civil War. After that, their advocacy expanded the revolutionary changes brought by manufacturing and industry to include broader economic justice.

One of the leaders of the "Mechanics Movement" (mechanic referring to any working class job) was Rhinebeck's Nathan Darling, whose rise from abject poverty to personal financial and political success was launched through service in the military in the Florida Seminole Indian wars.

The journeys of Persons of Color

The resolution of the contradiction of

slavery in a country founded on the premise that all are created equal was resolved through what remains America's deadliest war. The US Civil War saw the deaths of 2% of its population, the equivalent of 7 million people today. The story of Northern Dutchess' Andrew Frazier is inspiring. He served with distinction in the Revolutionary War, earning a pension. Local descendants served in subsequent wars, including WW2.

The story of Andrew Frazier is told in schools using DCHS's booklet on the Rhinebeck post office murals to inspire contemporary expression by students (also shown).

The journeys of women

Dutchess County had the largest Quaker population outside of Philadelphia. In spite of a rapid drop in size after an internal schism in 1848, many local Quaker women took their faith's values that gave women an equal opportunity in education and other matters and took them to a broad national stage. Four out of five organizers of the 1848 Seneca Falls convention on women's rights were Quakers. The fight for equal suffrage was a long one. Anna Rozell became the first woman to win a competitive election when she won for Town of Clinton Overseer of the Poor in 1919 with a majority of 157 votes (416 to 259).

The generous 2025 Dutchess County "Rev250" grant to local historical societies, including DCHS, will allow us to share these amazing journals through a variety of ways like our Yearbook, programs, and performances. Great Summer reads for fans of the game




With long summer nights replacing school days, kids and adults alike need to continue working out those reading muscles. Though the Renegades didn't claim the first half league title, there are still plenty baseball titles fans can feast on this summer! These nonfiction baseball reads will steer one towards enjoying a ball game or a trip down memory lane. Sometimes, the cure to a heat wave is a cool page-turner.

1. Baseball in Dutchess County: When it was a Game (2000)

Baseball didn't begin in Dutchess County with the arrival of the Hudson Valley Renegades in 1994. Dutchess County native Joseph V. Poillucci was for decades the leading source on local history. In this work, he chronicles a century of baseball, from the players who traversed the Hudson River to compete and promoters who filled seats, to community clubs that set a competitive fire ablaze in many neighbors and fans. From 1859 - 1959, the baseball climate and conditions were mighty different than those of today's era, but the hometown love for ballplayers is still alive in Dutchess County. A century condensed in 720 pages, this book explores the roots of the county's pastime and a community's dedication to grow a game while keeping it close to the heart.

2. Chicken Soup for the Baseball Fan's Soul (2001)

The famous Chicken Soup series comes with cracking tales of hope, nostalgia, and love for the game, from Little League to the majors. Humanizing stories of giants like Roger Maris and Tommy Lasorda, plus musings of t-ball parents and the fond memories of kids whose dads took the time

to dust off the old glove after a day of work, still dressed in uniforms. Keep the tissues in sight for this read; the baseball-loving reader never knows when a memory will strike.

3. Why We Love Baseball - A History in 50 Moments (2025)

Joe Posnanski brings us the baseball book of the summer with accounts of electrifying plays and devastating defeats from the people who experienced them firsthand. Written through the eyes of fans, umpires, players, and other baseball faithful, this collection of essays hinges on the momentous feats caught not on camera, but

in memories. Written not only by the heroes but the witnesses. The defeated, and the blamed. If 50 isn't enough by the final page, pick up Posnanski's debut "The Baseball 100" for twice as many vignettes of figures in American baseball history!

4. Moneyball: The Art of Winning a Losing Game

How does a team replace a traded MVP, frankenstein a new one? No. We recreate him in the aggregate. No better time to revisit the glory days of the Oakland A's, who currently play home games in a minor league ballpark in Sacramento. Over twenty years before the great Athletics im-

sion of '24, there was Billy Beane. The multidimensional Beane, as portrayed by Brad Pitt in the "Moneyball" film, built his game-changing baseball maneuver on statistics, budgeting, and sheer market research. Though Oakland's bunch of misfits didn't go on to hoist the World Series trophy, this account of Beane's antics captures the spirit and science of moneyball as only author Michael Lewis can. Every off-field player who contributed to Beane's idea, down to the dream draft class of 2002. Dedicated to "Coach Fitz" Billy Fitzgerald, whom Lewis "can still hear him shouting at me."

Avina gains honors & continues to lead Renegades

There is one unwritten stat in Jace Avina's stat line: Robbery. In his young minor league career, his tendency to scale walls has led to a few stolen home runs, including one that landed the number one spot on SportsCenter's Top 10 Plays of the Week.

This season, Avina returned from injury in time for the May 17 giveaway, a bobblehead commemorating the viral grab. One thousand (and more!) approving nods for the 22-year-old, who cemented the Renegades' comeback win with a game-tying sacrifice fly.

Along with diving plays and well-timed free climbs, Avina has made leaps in the Hudson Valley lineup this season. One of just two outfielders batting from the right side, Avina hits .311 against right-handed pitchers.

When the South Atlantic Leagues Weekly awards dropped on April 27, Avina, alongside top pitcher Elmer Rodriguez-Cruz, showcased a Hudson Valley sweep. Hitting a monstrous 545/.643/.773 with seven RBI in a series win against the Asheville Tourists. Adding back-to-back three-hit games that week in North Carolina, Avina was in familiar territory.

Milwaukee drafted Avina out of Spanish Springs High School (NV) in 2021. He was the state's sixth overall

prospect and third-ranked outfielder.

With the Brew Crew's affiliate Carolina Mudcats, Avina hit a pair of home runs in his Single-A debut. Three launched over the fence in the first two games, and none came close to glancing into an outfield glove.

He showed Zebulon, N.C. a bit of juggling talent the following season. After Avina snagged a would-be walkoff home run, the ball threatened to drop to the left field grass upon his landing. A few bobbles, but a catch, and a Mudcats' win. Quite the knack for defying gravity.

New York caught wind of Avina in the second half of 2023, when he dropped his strikeout rate and put up a 1.097 on base plus slugging percentage (OPS) in 38 games.

Brewers beat writers with twinkling saucers for eyes had the organization's 28th prospect bookmarked for '24 when... The Yankees front office made its off-season move.

New York dealt outfielder Jake Bauers for two promising prospects in Avina and Brian Sánchez. Fans couldn't imagine a trade more than a bag of baseballs in Bauers, and were rewarded with the acrobatic Avina, who heated up in the second half of 2024.

Since June 2, Avina was sidelined once more. Returning this week, he again was a spark that the Renegades have desperately needed. Hitting coach Tom DeAngelis

Great performances are not enough as Renegades drop series to Wilmington

The Renegades dropped another series at Wilmington despite magnificent performances from Alexander Vargas and a franchise-record-setting grand slam by Josh Moylan.

In its second consecutive away series, Hudson Valley had little rebuttal for Wilmington's early-inning leads and late-game comebacks, dropping the series four games to two.

Hudson Valley was shut out twice in the series. In the 11-0 stomping on June 27, Hudson Valley was held to just four hits.

Moylan's homer set the Renegades single-season record for grand slams as a team, and we're only halfway through

the year!

In the series finale, Wilmington scored three early runs. The Hudson Valley negated two, but couldn't fully rally. Moylan cut the deficit with an RBI in the ninth, but it couldn't salvage the series split. The Renegades ended their extended road trip with a 4-3 loss, an overall 5-6 record, and a three-game losing streak.

Vargas recorded a hit in every game of the series, including a two-run home run in the Renegades' 10-3 win on June 25. He finished the series with 12 hits, three RBI, and a .288 batting average. Against the Blue Claws just a series ago, Vargas's average was .176.

In another 1-0 loss to open a series, the

Renegades weren't able to provide a big hit to break the shutout.

Under rainy conditions and an extended delay, the June 26 matchup was tabled for the following day. With two innings to make up in a quasi-double header, the game resumed in the fifth inning with a couple of goose eggs on the scoreboard. The Renegades jumped ahead with seventh inning RBI singles from Vargas and Tomas Frick, and kept the Blue Rocks at bay for their second win in Wilmington.

On June 28, Josh Grosz went 7.1 innings, but gave up four earned runs on seven hits. Despite the longevity that has become typical of Grosz's outings, the righthander was charged with his

sixth loss of the year. Wilmington posted a five-spot in the eighth inning en route to a 7-4 lead. Moylan's grand slam put the Renegades ahead 4-2, but they didn't score past the sixth. With just three outs to spare after the Blue Rocks' big comeback, Hudson Valley couldn't make up the lost ground.

The Renegades (42-31) return home for a home matchup with the Brooklyn Cyclones (53-22). They will play six at Heritage Financial, then ring in Independence Day with the firecracker spectacular. The Renegades need no Roman Candles or Cherry Bombs, but some rockets at the plate if they want to make up ground on the division leaders.

Elevate, educate, integrate - Dutchess Roots brings recreational cannabis to local area

"Weed like to meet you" read the signs around South Road Crossing in Poughkeepsie on June 28. The Dutchess Roots cannabis dispensary was celebrating its grand opening, but owners and Queen City natives Lisa and Scott Sweeney didn't just introduce themselves. Their goal is to elevate and educate everyone on the industry.

The area's first licensed dispensary to be built from the ground up, Dutchess Roots was a seedling in the Sweeneys' minds for four years. It became a reality with the decriminalization and legalization of recreational cannabis in 2021. In recent memory, the brick-and-mortar storefront was uninhabited concrete, then a construction site. Dutchess Roots is the first dispensary of its kind to be built from the ground up.

"Scott and I wanted to build something of our own," said Lisa. "We wanted to be in our community."

Customers and neighboring businesses came out to celebrate the first official day of a new era. Vendors hailed from far and wide to support Dutchess Roots commitment to accelerating the industry. Some traveled two hours south from Argyle, while others crossed the Hudson River from High Falls. Per NYS law, Dutchess Roots sells products made only in New York state, with a full wall dedicated to Hudson Valley farmers and their products.

The "typical" cannabis user does not exist. They are young and old, new parents

and medical patients - from fledgling business owners to recreational users of 40 years ago. For every consumer of cannabis, there is a duty to a responsible, educated use. As is the mantra of Dutchess Roots: elevate, educate, integrate.

The middle third takes form in a sort of "Dispensary 101." It includes informative material for all who pass through the Dutchess Roots doors that explains doses, mechanisms of cannabis, hemp, CBD and THC. A few areas are for consumers to document the products they liked, or those to avoid in the future. Thrown in - free of charge - the material teaches consumers about products as much as it allows an opportunity to learn about the people behind the Town of Poughkeepsie's newest business.

Dutchess Roots has partnered with the Dutchess Community College Foundation to give back to the college's Cannabis Retail Program. They will award a scholarship to a student, in hopes they continue growing and educating others within the industry.

"It goes both ways. We're investing back in the community, the community invests in us, and it's just this beautiful cycle," said Lisa.

Born from a lifetime in the hospitality industry, Dutchess Roots is woman-owned, women-led and fixing to shake up the Hudson Valley cannabis industry. It's just the beginning for a community whose dream grew from the pavement at 2615 South Road.

Williams performed with the DCC folks for a spell, then brought out his band of friends for a full-bodied set list to match each original blend of wine, four in total. Beginning with "African Blues", the Band of Friends added their flair to classic music covers, and showcased original compositions from "Moving Forward", Williams's sophomore album.

The night turned "Ritmo de Otono" (Rhythm of the Fall) to the sound of the summer, as couples, solo patrons, and families blended into one. No gap between generations, as '60s kids, infant fans enjoying in first summers on earth, enjoyed the tunes offered by Williams and the Friends.

The raindrops did come, but dampened none. While some in the audience rose from the lawn to dance between raindrops, others swayed beneath winery balconies. The Band of Friends musical director Dan Orlando, with whom Williams released the song "Perpetual Motion" last year, lent his vocals in the second act for original compositions and today's top pop tracks.

The past few concerts have gone on despite pouring rain and overcast concert conditions, the threat of thunder and lightning threatening to move the party inside. In the 2025 edition, no storms could dim the spirits raised by the community support, original melodies, and medleys.

Nineteen municipalities awarded mini-grant funding for Rev250

As the nation prepares to recognize Rev250, the upcoming 250th anniversary of the American Revolution in 2026, Dutchess County Government is supporting local programming and events through Destination Dutchess and in partnership with local historical societies to engage residents and visitors alike with stories of how the Revolution impacted Dutchess County – during the war and in the ensuing 250 years. Nineteen local municipal historical societies have been awarded a total of \$100,000 in mini-grant funding allocated by the Dutchess County Legislature in the 2025 Dutchess County Budget.

Will Truitt, Chairman of the Dutchess County Legislature said, "These projects preserve our past and inspire a deeper understanding of the values that shaped our nation and continue to guide our country today. My fellow legislators and I are proud to have supported the funding that will make these events possible."

Each of the County's 20 municipal historical societies were eligible for the grant, honoring their longstanding efforts to preserve local history and educate the public. A total of 23 projects, reviewed and recommended by a review committee, comprised of members from the County Executive's Office, County Legislature, County Clerk's Office and Dutchess BOCES funding, were awarded mini-grant funding. Projects range from lecture series and presentations to historical re-enactments and open houses at historic sites.

The 2025 Dutchess County Budget also provided funding support to Destination Dutchess for a series of experiential Rev250 community events. These events include this weekend's RevCon250 on Saturday, June 14, a free, family-friendly event at the Franklin D. Roosevelt President Library and Museum in Hyde Park with Revolutionary War reenactors showcasing camp life, uniforms and tactics.

Other events include the County's popular Tavern Trail which returns this summer with a focus on the American Revolution. The Tavern Trail is a unique collaboration that pairs local food and drink with engaging stories from Dutchess County Historian William P. Tatum III, this year spotlighting Dutchess County's role in the 1775 Real Time Revolution. Information about the four upcoming Tavern Trail events as well as other Rev250 events is available on Destination Dutchess' website.

Dutchess County Executive Sue Serino said, "The 250th anniversary of the American Revolution, Rev250, is more than a historic milestone. It's a powerful reminder of how everyday people with a shared hope, conviction and courage worked together to build something extraordinary: our collective American dream. It is a reminder that the values of justice, freedom and unity continue to shape who we are today – both in Dutchess County and in America – and our County is proud to support the recognition of this monumental milestone in our nation's journey."

Amenia Historical Society, Presentation on the Journal of Cadwallader Colden, Jr: A Tory Seeks Mercy from the Committee of Safety, \$1,350 – The event will take place on Saturday, Sept. at 2 p.m. at the Amenia Town Hall Auditorium.

Beacon Historical Society, Map of Fishkill Landing & Matteawan in the American Revolution, \$4,105 – Create an informative and colorful map identifying the diverse people, gathering places, military operations, artifacts and exhibitions, and other points of interest from the Revolution in the area now covered by the City of Beacon.

Clinton Historical Society, Quaker Meeting House Driving Tour, \$5,369 – In collaboration with the Hyde Park, LaGrange, Millbrook, Pawling and Stanford historical societies, the Crum Elbow, Creek, Oblong and Nine Partners meeting houses will host open house events on the first Sunday of each month through November.

Dover Historical Society, Old Upper Road Exhibit, \$4,236 – An exhibit launch event.

Dutchess County Historical Society, Rev250 Encore Edition, \$3,000 – The publication of 300 paper copies and online publication of a Dutchess County Historical Society "Encore Edition," including articles from previous editions of the Yearbook (dating back to 1914) on the topic of the Revolutionary War and its aftermath in Dutchess County.

Dutchess County Historical Society, Rev250 Traveling Banner Exhibit, \$2,700 – This traveling exhibit of two sets of six banners will describe Dutchess County people, places and events within the themes of Rev250: Unfinished Revolution, Power of Place, We the People, American Experiment and Doing History. The banners will also have a permanent place on the DCHS website.

Dutchess County Historical Society, Lafayette's American Journeys of Freedom performance, \$10,000 – This short play depicts the Sept. 16, 1824 visit of Marquis de Lafayette, hero of the Revolution, to Poughkeepsie, connecting Lafayette with local residents and events up to 1865. A live performance will be recorded and edited to create a 20-minute distributed to high-school history teachers and students, accompanied by a teaching aid booklet, and will be available on the DCHS website.

East Fishkill Historical Society, Rombout Colonial Days event, \$2,900 – This living history event, held Sept. 27-28 at the Brinckerhoff House Historic Site, is a collaboration between the communities of Beacon, East Fishkill, Fishkill, LaGrange and Wappinger in the former Rombout Precinct explains the state of

Dutchess County in 1775 by talks and demonstrations focused on the local inhabitants and their loyalties to the patriot cause or the King of England.

Fishkill Historical Society, Cemetery Crawl brochure, \$1,450 – A booklet and a website with information describing the colonial cemeteries in Fishkill, the residents of the time and their history. The tomb stones have unique carvings and sayings. Soldiers of the Revolutionary War and leaders of the Patriots are buried in these cemeteries. The program will be launched in August at the Van Wyck Homestead in Fishkill.

Fishkill Historical Society, The Fateful Hour performance, \$6,200 – This play is a re-enactment of the debates in 1788 between Federalists and Anti-Federalists in the New York State Delegation at the Poughkeepsie Court House with live performances for 11th-grade U.S. History students, as well as a recorded version that will be available online.

Historic Red Hook, Rev250 Speakers' Series, \$5,000 – A fall speaker series, running from September to November, at the Elmendorph Inn and available in a hybrid format with five presentations examining the Revolution's impact on Dutchess County and the evolving cultural landscape of the Hudson Valley before, during and after the war.

Historic Red Hook, Pamphlet on 250+ Years of Engaging Citizens, \$5,500 – This pamphlet, sent to every residence in the town of Red Hook, will chart the ways Red Hook residents have organized, advocated, and adapted to claim their rights and build their community through the story of the Elmendorph Inn.

LaGrange Historical Society, Rev250 Speakers' Series, \$4,469 – Two lectures by Dr. Paul Lockhart highlighting the American Revolution in Dutchess County with a focus on Baron von Steuben and his headquarters at Mount Gulian historic site, free and open to the public on July 23 at 6:30 pm at Mount Gulian in Fishkill and at the LaGrange Library on July 24 at 6 p.m.; both are free and open to the public.

LaGrange Historical Society, Freedom Day event, \$4,638 – The July 5 event at Freedom Park features a reading of the Declaration of Independence by a George Washington re-enactor; the winners of the Freedom Day essay contest reading their essays and receiving their awards; the launching of Knox's Cannonball Run, a virtual mission for fitness enthusiasts to walk along the 1775 Revolutionary War era Henry Knox trail; and a performance by the Young Colonials Fife and Drum Corps playing American Revolutionary songs.

Little Nine Partners Historical Society, Pine Plains: Spirit of the Revolution in a Small, Rural Town, \$9,475 – This free event, held at the historic Graham-Brush home on Sept. 6 from 10 a.m. to 4 p.m., will feature several performances, as well as a re-enactment and encampment by a local history class; cooking demonstrations; tours of the host site and a blacksmith demonstration.

Millbrook Historical Society, Quaker Meeting House Exhibit Banners, \$5,470 – The creation of four exhibit banners to complement each of the aforementioned Quaker meeting house open houses, highlighting the history of the community's Quaker population, their role

in the abolition and temperance movements, and their contributions to the economic and social life of Dutchess County.

Millbrook Historical Society, Dutchess County Quakers Speakers' Series, \$5,000 – Two lectures on Quaker life in Dutchess County will be presented at the Nine Partners Meeting House in Millbrook: Prof. Sarah Gronningsater will speak on June 29 from 2-3 p.m. on Quakers, Manumission, and Abolition; Prof. Carl Lounsbury will speak on July 27 from 2-3 p.m. on the architecture of the Nine Partners meeting house and how it reflected the local environment.

Pawling Historical Society, Virtual Exhibit: Washington in Pawling, a Quiet yet Crucial Chapter, \$9,745 – This immersive project brings to life the history of George Washington's stay in Pawling during the autumn of 1778. By recreating the historical context of Washington's campgrounds, visitors experience the challenges, decisions and pivotal moments of the Revolutionary War through the lens of Dutchess County.

Pleasant Valley Historical Society, How Transportation Transformed the Growth of Pleasant Valley exhibit, \$2,349 – An exhibit, scheduled for Aug. 10 at the Mill House Museum, will feature authentic antique cars and gas pump; a working model P&E railroad; a video, "How the Automobile Changed the Hudson Valley: A View Through Postcards;" and a display on the history of Dutchess Turnpike.

Poughkeepsie Public Library District Local History Room, Preparing for Revolution Big Read Project, \$2,500 – This program will help fund the Library District's annual Big Read program this year, which is focused on Rev250, more specifically the lead up to 1776 and the desire for American independence from Great Britain.

Rhinebeck Historical Society, Rhinebeck Walking Tour, \$2,478 – This walking tour will identify historic sites within the Village of Rhinebeck, especially those that have some bearing on Rhinebeck's role in the Revolutionary War to educate the public and to create a permanent record of the importance of these sites.

Stanford Historical Society, Rev 250 Speakers' Series, \$1,000 – Two free lectures by Prof. Dillon Streifeneder, held at the Stanford Free Library: The first is scheduled for July 18 and will examine how Revolutionary change occurred in relation to government institutions by looking at Northeastern Dutchess County between 1774 and 1777; the second, scheduled for Sept. 19, will look at how different Stanford looked in 1793 when it became an independent town, paying particular attention to changes in governing institutions and the relationship that inhabitants of the newly elected Town of Stanford had with county and state-level authorities.

Union Vale Historical Society, Rev250 Speaker Series, \$1,100 – A presentation at Tymor Park by Prof. Dillon Streifeneder about the revolutionary government in Dutchess and the impact of the Revolution on the home front. The talk will focus on Union Vale's natural environment - from Clove Spring to Fishkill Creek and the surrounding forests and countryside - shaped Revolutionary War events and informed settlements, migration, economic development and innovation.

Adults 25 to 55 can pursue EMS careers with new Reconnect program

Dutchess County Executive Sue Serino encourages adults looking for new career options to consider a career in EMS, and take advantage of State University of New York's (SUNY) new Reconnect program at no cost. The Reconnect program covers tuition, fees, books and supplies for adults between the ages of 25 and 55 who have not yet earned a college degree enroll in one of a dozen in-demand programs, including Dutchess Community College's (DCC) Emergency Medical Technician: Paramedic field of study. The tuition-free program begins with the Fall 2025 semester. Registration information is available on DCC's website.

The County Executive joined SUNY Chancellor John B. King Jr. and DCC President Peter Grant Jordan this morning to discuss the new SUNY Reconnect program at the college's Town of Poughkeepsie campus.

Dutchess County Executive Sue Serino said, "Dutchess County has long championed Emergency Medical Services as a critical and in-demand career path. We are excited to see that recognition reflected in the SUNY Reconnect initiative so local students can take advantage of this amazing opportunity. While New York State doesn't consider Emergency Medical Services (EMS) a mandated essential service, we in Dutchess County know how critical it is. We are grateful to have a local partner in DCC, which can help bolster recruitment and training for this important and vital career."

Strengthening EMS, including workforce recruitment and retention, has been a priority for County Executive Serino. Earlier this year, she was joined by the New York State County Executives' Association in urging Gov. Kathy Hochul to include EMT training in the new,

tuition-free program, explaining the inclusion would "remove a significant barrier to entry and help ensure that our communities have the life-saving personnel they need." One can read the letter online.

The County has been working to address the EMS workforce shortage by recruiting new talent and supporting current responders with resiliency training and peer support. Dutchess County worked closely with DCC's EMS Coordinator to better understand the student experience – surveying and meeting with students to learn more about their career goals and the barriers they face in completing certification or serving on an EMS squad. For many, the EMS program is a stepping-stone to careers in nursing, physician assistant programs, or medical schools, which means they often do not enter the workforce directly after completing the course.

To help reverse this trend, the County is actively promoting EMS as a career path: investing in marketing efforts like vehicle wraps and committing \$100,000 in new equipment for EMS training and education. In addition, Dutchess County is developing wrap-around services to help students overcome personal and financial obstacles and ensure they successfully complete the program and are prepared to serve.

Dutchess Community College President Peter Grant Jordan said, "Just like County Executive Serino, Dutchess Community College knows the crucial role Emergency Medical Technicians play in our community's health, safety and well-being. We at DCC are thrilled to play an active role in training the next generation of these life-saving professionals. Partnering with Dutchess County on this important initiative, including through the

SUNY Reconnect program and other efforts, strengthens our school's standing as a valuable community asset that has greatly impacted so many lives for decades."

Addressing the EMS workforce shortage is just one aspect of the County's multi-faceted effort to respond to EMS challenges. The County Executive's 2025 Budget included a historic \$2 million investment in EMS that includes contracted supplemental ambulance coverage, fly-car grant program and a public-awareness campaign to help residents

better understand when to call 911 for an ambulance and how to use EMS resources wisely.

The Emergency Medical Technician: Paramedic program is one of 12 high-demand associate degree programs offered at DCC, tuition-free, through the SUNY Reconnect program; others include Architectural Technology, Computer Science, Mental Health Assistant and Nursing. A full list of eligible degree programs, and additional SUNY Reconnect information, is available on DCC's website.

It's no big secret that almost half of the U.S. Agricultural workforce is undocumented (42% of crop workers, according to the U.S. Department of Agriculture). Since President Ronald Reagan signed the Immigration Reform and Control Act in 1986, it has been illegal for an employer to "knowingly" hire an unauthorized worker. Contrary to popular belief, and as a consequence of the law's wording, the vast majority of undocumented farm workers are "on the books" – receiving a paycheck, paying taxes and Social Security, and making at least minimum wage, in some cases much more.

I was recently recruited to be a member of an outfit called the Northeast Ag Labor Working Group, made up of stakeholders – farmers who rely on a stable supply of labor to produce locally grown food. The group brings together people from the dairy, vegetable, fruit and ornamental horticulture industries, all concerned about the current political climate as it affects the agricultural labor market.

As a member of New York Farm Bureau, I've spent way too much time advocating for a legal workforce, traveling to Washington to meet with legislators, going back to when Hillary Clinton was our senator. Back then, the big sticking point to granting any kind of amnesty to undocumented workers was that they "broke the law" by coming here in the first place. At one meeting with some legislators, I said I broke the law on my way to the meeting. I drove 68 miles an hour

on the New Jersey Turnpike. I was even an illegal worker myself, in London for a few months in 1970, working in a Heinz ketchup factory.

How did U.S. Agriculture get itself into this situation of relying on illegal workers? Our porous southern border is one contributing factor. These people just showed up, with credible documentation, willing to work. Employers were actually prohibited from discriminating, as long as the documents were properly filed and an I-9 (Employment Eligibility Verification) form filled out. And it isn't easy to find people who are willing to pick tomatoes all day.

But what about the H-2A visa program that allows U.S. employers to temporarily employ foreign workers in agricultural jobs? That program was originally set up to help with seasonal harvests, where a lot of labor was needed for a short period. It worked well and still works well for the apple industry. Charles Hurd from Hurd's Family Farm in Clintondale says his apple farm has employed H-2A workers since 1953, and has enjoyed a consistent and reliable legal workforce ever since. But other aspects of agriculture need workers on a more permanent basis.

On a Zoom meeting of our group, Paul Bleiberg of the National Milk Producers Federation was advocating for a three-year renewable visa, since the dairy industry works year-round. Brian Reeves, president of the N.Y. Vegetable Growers Association, points out that any "perma-

nent" H-2A workers should be allowed to go home to visit their family, not stuck on a farm for 365 days straight. One problem with H-2A is the cost. Employers must pay above minimum wage rates (currently \$18.83 per hour), provide free housing, and pay air fare.

Back when the program started in the 1950s, apples farmers in particular were flush with cash. My father remembered getting five dollars for a bushel when he paid workers 15 cents an hour. Nowadays farmers in New York State are up against the wall. I don't know how Charles Hurd does it, but he points out that if more farmers had bought into H-2A from the get-go, the program would by now be working more efficiently, even for dairy farmers. Right now it's a burden, especially for farmers who don't have on-site housing.

The Northeast Ag Labor Working Group is looking for a legal workforce,

with help from our legislators. I contacted the office of my congressman, Pat Ryan. He sent me this message:

"When I speak with farmers across the Hudson Valley, labor is often their top concern. Many producers in New York are already struggling to keep their doors open and their lights on. Having to contend with a bureaucratic, outdated agriculture immigration system makes it even harder. Washington owes it to America's farmers to deliver a reliable and legal workforce that is accessible and affordable. That's why I'm fighting for bipartisan reform in Congress. We have to be willing to attack the issue from every angle, and I remain committed to working with anyone to deliver for Hudson Valley farmers."

'Through Their Eyes' at Wappinger Town Hall highlights artists' abilities

Dominick Nasi is a 20-year-old photographer who is on the autism spectrum and hard of hearing. He recently took part in a very special art show, "Through Their Eyes," at the Wappinger Town Hall. There was a ribbon-cutting ceremony last month for the show.

The art show is for those who are "differently-abled," explained DawnMarie Nasi, Dominick's mother, who helped organize the show. There are 12 artists in the show, each of whom submitted approximately 4 pieces of art.

Dominick's photography "makes him feel relaxed" and gives him a sense of pride.

"He likes to take pictures of the skylines and animals," said DawnMarie.

Dominick, who participates in Special Olympics, plays basketball, softball, volleyball and track and field.

Dominick is "very proud" to have his work up and people enjoying his photos, it was stated.

Jessica Jenkins is an autistic artist who sells her art. The business is called Flappy Hands Creations.

"She was nonverbal until age 10. She feels her art helped her language to come out," said DawnMarie.

Jessica "felt so happy" to have people see her artwork and to have her art viewed "gives her a sense of accomplishment," it was stated.

One of the pieces of art Jessica submitted was of hydrangeas. So, for the celebration, Jessica wore a black dress with purple hydrangeas on it.

Another artist whose works will be available soon is Steven Pepe. Steven, it was noted, uses art to keep him focused and relaxed. The artwork, which is in a variety of mediums, also gives him a sense of pride, it was remarked.

"A feeling of accomplishment," is what artist Daniel O'Brien, who is on the

autism spectrum, said art offers him. His work highlights sea mammals. One can purchase Daniel's art.

Eric Orzell, who sometimes works alongside Daniel, draws animals he is knowledgeable about.

DawnMarie noted that Eric sells his work and donates some of the profit to organizations such as Special Olympics and The San Diego Zoo to help the animals.

Other artists whose artwork is in the show include Daniel Hagel, Uriah Riggs (Ry), Elon Walker, Robert Popolizio, Michael D'Ambroasio, Rachel Rose and Aiden Frustace.

DawnMarie thanked Town of Wappinger Supervisor Joseph Cavaccini, Wappinger Recreation Director Jessica Fulton, Dutchess County Legislator Lynne Miele-Versaci, County Legislator Rob Faust and Wappinger Councilman Al Casella for all of their support.

"It is truly inspiring to showcase the incredible creativity of neurodivergent artists and those with developmental disabilities here at Town Hall. This exhibition reminds us all that art knows no boundaries—every brushstroke and sculpture proudly speaks to the power of inclusion, and it's our privilege as a community to honor these unique voices," remarked Cavaccini. The artwork will continue to be up in town hall for the next few days.

Miele-Versace stated, "Dawn is an amazing person and helps the special needs community a lot. This time she was highlighting the differently-abled, she was showing what they can do and focusing on that instead of looking at what they can't do. I was honored to be a part of this event, and I am always grateful to support all of her endeavors. Having a few close friends with special needs children, some non-verbal, this is one of the things near and dear to my heart."

"When I began putting the show together, my idea behind it was to show our community just what individuals with

Art, sewing, story-telling inspire young entrepreneur

What originated as a doodle drawn in a high school economics class has grown into a thriving toy business. Rhinebeck resident Lyla Andrick has turned her classroom sketches into "Happy Dinosaur," a brand that captures hearts and imaginations with its playful characters and creative stories.

"Happy Dinosaur" was founded in 2020 as a way to raise money for frontline workers during the COVID-19 pandemic. Since then, it has grown to include five different dinosaur characters and plushes, as well as non-dinosaur characters and a dinosaur world inspired by real places.

When Andrick was a student at Rhinebeck High School, her economics teacher, Dan Lavazzo, noticed her dinosaur doodles and encouraged her to continue drawing and to create something three-dimensional. He allotted a section of his classroom whiteboard for her to draw on and even bought her a pack of whiteboard markers that she still has today.

Andrick said Lavazzo's small gesture made a huge impact on her journey. "It gave me this really big boost of confidence," Andrick said. "Someone is valuing my cartoons now. I don't feel like an illegal graffiti artist anymore."

Lavazzo said he shares Lyla's story with his classes every year to hopefully inspire more students to become young entrepre-

neurs or follow their creative passion.

"Students like Lyla remind me that my job matters," Lavazzo said. "In many ways, it validates all the education certifications, trials and tribulations that go into every single school year. The job gets harder every year, and passions and successes like Lyla's are necessary to fuel us."

Andrick draws all of the dinosaurs, maps, special characters and more to make the "Happy Dinosaur" world come to life. She also handmade every dinosaur for four years until her demand allowed her to scale.

"I am at the point now where I am really starting to grow," Andrick said. "I quit my job last summer and I'm really putting all of my effort full time into this company."

To create the dinosaurs, Andrick sources sustainable materials made from recycled water bottles. Her anti-pill fleece and recycled polyester filling create a soft and environmentally friendly plush. However, this makes her materials more expensive and harder to source. Andrick said the current tariffs are affecting her supply chain, stuffing and fabrics.

Andrick said she doodles all kinds of characters, but dinosaurs stood out as the ideal choice for her brand because of their unique ability to spark children's curiosity.

"When kids learn about imagination for the first time, it always connects to dinosaurs because they're the closest real

thing to fantasy because they actually existed," Andrick said. "Because we do not know everything about dinosaurs, kids start to wonder what dinosaurs could do. It's when their imagination really lights up."

While "Happy Dinosaur" can be for all ages, Andrick has worked with children to develop stories and personalities for each of her main dinosaur characters. She said she visited schools with her dinosaurs and let the kids' imaginations run wild as they crafted narratives for her dinosaurs.

"One thing I love about the stories is that they are all based off of real kids," Andrick said. "The kids love these stories. ... They were laughing and super collaborative."

The personalities and names of the dinosaurs are part of why "Happy Dinosaur" stands out and is special to children. Andrick said she has received notes from families and customers about all of the places her dinosaurs have been, including a popular choice of bringing Chill Dinosaur to the dentist. On the "Happy Dinosaur" website, there is a quiz where customers can learn which dinosaur character best fits their personality. The quiz creates an initial bond between the customer and the character because they see themselves in it.

The Happy Dinosaur characters also provide a greater message. Andrick wrote on her website that dinosaurs are just like people because they make mistakes and procrastinate, but they are also constantly evolving.

"We don't have villains in the Happy DinoStories because we don't want to place the blame for mistakes on someone else; it's just too easy to evade responsibility by making someone else the 'bad-guy,'" Andrick wrote. "By fixing their own problems, our dinosaurs can help kids and even young adults find the heroism in themselves. Solving a problem like a dinosaur requires a little forgiveness, a little creativ-

ity, and a lot of making mistakes."

When Andrick was first growing Happy Dinosaur, she was a student at the University of Connecticut on the pre-veterinarian track. Andrick said she was constantly forced to decide between her business and her academics. Being a successful business owner and creator while handling a full course load did not go well together.

Andrick said she took a break from school and spent a semester at home taking courses at Marist College while she decided what she wanted to do with her career. Eventually, Andrick combined her passions and studied Entrepreneurship in Animal Science Technology at the University of Connecticut.

Creating a growing and successful company as a young entrepreneur is rare. Andrick said she would advise other young entrepreneurs to pay attention to successful entrepreneurs and emulate their work. She also emphasized the importance of networking and how her connections have helped her grow.

"Schools need to protect and provide individual student expression," Lavazzo said. "Young entrepreneurs are a necessity. We like to think that they're a luxury. They're not. Economically speaking, young entrepreneurs are a necessity to a successful, growing, evolving economy."

"Happy Dinosaur" has been around for five years and has already expanded in many ways. For the fifth anniversary, Andrick added mini versions of her plush dinosaurs to her website to include a cheaper option for customers. Looking into the future, Andrick said she only sees her company continuing to grow.

"I would love to build a character franchise out of 'Happy Dinosaur,'" Andrick said. "Maybe four or five years from now, I want to see Happy Dinosaur become a new childhood household character."
