90-year-old Air Force veteran and late wife honored with Hometown Heroes banner

Hometown hero Evert Munning Jr. was honored, as well as his late wife, Catherine "Teeny" Munning, during a recent ceremony held at a local nursing facility in Putnam County. Evert and Teeny were both in the U.S. Air Force and lived in East Fishkill for many years after relocating from Patterson, Putnam County, said their daughter, Karen Raab.

According to Karen, Evert was a 1st Class Airman. He worked on data processing for the first IBM Mainframe. Teeny, who was promoted to colonel, as a bookkeeper, handled relocations, said Karen.

Evert, who was from Brooklyn, and Teeny, who was from the Bronx, first met in 1952, as the Korean War was happening. They joined the Air Force -- Teeny on Valentine's Day in 1952 and Evert on St. Patrick's Day in 1952, remarked their daughter.

"I couldn't ask for anything more. I'm lucky," said Evert, who is now 90, when he was presented with the Hometown Heroes banner.

Patriotic music was played during the ceremony, which began when those in attendance said the Pledge of Allegiance.

After joining the service, Evert and Teeny went off to boot camp. Teeny went to San Antonio, Texas for boot camp while Evert was in Rome, NY to complete his required boot camp. Teeny and Evert met in Alabama, on Montgomery Air Force Base, said Karen. Evert and Teeny were married on December 5, 1953.

Teeny gave birth to Pat, the couple's first child, while serving at the Montgomery Air Force Base in 1955. Four more children, Debi, Eddie, Karen and Gary, would complete Evert and

Teeny's family. The couple's youngest son, Gary, died in 2012.

Bill Meyer and Kevin Hines, from Manny Bacon VFW Post, offered words and presented the banners. It was stated that the banners will be posted in East Fishkill.

"They are just amazing parents that

served our country," said Karen.

Pat Ristaino, the couple's eldest daughter, said about the banner, "I think it's awesome." She added: "I think it's a wonderful gift for the family." She said her mom was "amazing." Teeny died in 2016.

Grand jury finds officers' actions in Feb. incident 'justified'

A grand jury has found that the actions of three Town of Fishkill police officers were justified in their use of deadly force in a Feb. 27 incident which occurred in the town, according to a press release from the Dutchess County District Attorney's Office.

"The Grand Jury found that the actions of Officers (Joseph) DePalma, (John) Hurtado, and Sgt. (Gerald) Coccozza were justified in their use of deadly physical force in this incident," states the release.

According to the release, on June 22, "The Grand Jury found sufficient evidence to charge Michael Becerril with two (2) counts of Criminal Possession of a Weapon in the Second Degree, Attempted Aggravated Assault Upon a Police Officer, and Menacing a Police Officer."

According to court documents, Becerril on Feb. 27 "knowingly possessed a loaded firearm... said possession not being in the defendant's home or place of business."

According to the court documents, Becerril is accused of intending to cause serious physical injury to a person whom he knows and reasonably should know to be a police officer engaged in the course of performing his official duties, namely Police Officer DiPalma. It accuses Becerril of attempting to cause injury to DiPalma by means of a deadly weapon, a Glock model 4, .45 caliber pistol.

The grand jury, according to the indictment, accuses Becerril of attempted aggravated assault upon a police officer, Sgt. Coccozza.

According to the Bill of Particulars, on Feb. 27 a phone call came into 911 for a dispatch to the Views Apartment Complex, on Rocky Glen Road for a domestic disturbance. According to the court document, Officers DiPalma, Hurtado and Coccozza responded in separate police vehicles. DiPalma, the first to arrive, according to the court document, and saw a male walking who matched the description given by 911. As DiPalma got out of his vehicle, Sgt. Coccozza arrived and approached the male subject. Officer Hurtado arrived and assisted in speaking to the male, while Sgt. Coccozza left to go to the apartment to speak to the woman who called into 911.



Rita Powers, with Rita Powers Casting Group, said, "The casting has blown up. I have over 600 submissions and counting! [I] Love Beacon and Dutchess!"

"DOCCS (Department of Corrections and Community Supervision) works cooperatively with the Office of General Services (OGS) and Empire State Development (ESD) to facilitate the re-use of the closed facilities," said Thomas Mailey, with DOCCS, via email.

Mailey noted that Gov. Kathy Hochul has convened a prison redevelopment commission. Downstate Correctional Facility was one of six prison in the state that was to be decommissioned, which was announced late in Nov. 2021. In March, DOCCS said the facility

was closed.

Dutchess County Executive Marc Molinaro said, "Film and TV production have certainly discovered what we have known all along, there is no place like Dutchess County! Our picturesque vistas, talented people, unique buildings, easily accessible transportation network and proximity to NYC and so many other reasons have all made Dutchess County a sought-after destination for movie, television and video production." Molinaro added: "It is thrilling to see the people and places of Dutchess County as we watch HBO series, Hallmark Channel productions and feature films on the big screen."

Mailey remarked, "DOCCS regularly works with news media outlets, as well as film production companies, providing backgrounds for movies and documentaries, where and when it can be done safely."

"It is no way meant to be an option for reuse, unless it is sold to a company, such as Broadway Stages, who purchased the former Arthur Kill Correctional facility in Staten Island," Mailey added.

Legislature committee votes down warning sign proposal at gun shops

The Dutchess County Legislature's Government Services and Administration Committee voted down a proposal by a 7-4-1 margin on Thursday, July 7 for a local law to implement the posting of warning signs anywhere a gun can be purchased within the County.

The proposed signs would have addressed the relationship between gun ownership and violence in the home.

The Democratic caucus introduced the legislation last month, asking for bipartisan support. Thursday night's vote prevented the proposal from coming to the floor at this past Monday's full board meeting.

"This law will fail to achieve its purported purpose and will spread dangerously misleading claims about suicide, and will harass legitimate gun dealers and Dutchess County residents at the same time. It will implicitly blame gun owners and gun sellers for raising the suicide rate, holding them responsible for suicide when the data shows otherwise," said Legislator Will Truitt of Hyde Park, majority leader.

Minority Leader Yvette Valdés Smith said, "This common sense gun safety measure would have protected the public by warning of the dangers associated with owning a firearm while simultaneously encouraging the use of our 24/7 Dutchess County HELPLINE. This law isn't about reducing firearm ownership, it is about education and

awareness and it could have saved lives."

Legislator Brennan Kearney (D-Rhinebeck) stated, "Dutchess County had the opportunity to become a leader in the public health movement by addressing gun violence danger through signage. I am disappointed that neither a single Republican legislator, nor a single Republican in County leadership would even consider this legislation."

Legislature Chairman Gregg Pulver said "Anyone who doesn't think that mental health is a big part of this problem is mistaken. That's why I'm proud that Dutchess County is taking the lead in New York State in sponsoring a Stabilization Center to help those with mental health struggles, and work toward preventing violence in the community. The Stabilization Center at 230 North Road, Poughkeepsie is a great example of such a facility, where people looking for help can find it."

The proposed sign, according to the Democratic Caucus would have read, "Access to a weapon or firearm in the home significantly increases the risk of suicide, homicide, death during domestic disputes and unintentional deaths to children, household members and others. If you or a loved one is experiencing distress and/or depression, call the Dutchess County Helpline at 845-485-9700 or the national suicide hotline at 988."

While speaking to the male, DiPalma and Hurtado, according to the Bill of Particulars, "heard screaming coming from the top of Rocky Glen Road, in a matter completely unconnected and unrelated to the original 911 call." The court papers continue, "When they turned, they saw defendant, Michael Becerril, with a knife in his hand, stabbing himself in the head area, and [a woman]... hanging on his arm, trying to stop him from stabbing himself."

According to court documents, Hurtado saw Becerril stabbing himself and yelled at him repeatedly to drop the knife, which Becerril did not. Hurtado deployed his taser, which according to documents, had no effect, and Becerril started to run toward Hurtado. Hurtado retreated backwards, according to court documents, and fell over the woman as Becerril charged at him. According to the Bill of Particulars, Becerril fell over, got right back up as started to charge at DiPalma who was coming up the hill towards him.

Officer DiPalma retreated and repeatedly commanded Becerril to stop and get on the ground, according to court documents. Becerril refused to comply and continued to charge Officer DiPalma who then discharged his duty weapon, a .45 caliber pistol, striking Becerril but not slowing him down. "Becerril continued to charge at Officer DiPalma and knocked Officer DiPalma to the ground and began to struggle to take Officer DiPalma's .45 caliber pistol from him, in an attempt to cause physical serious injury to Officer DiPalma. During the struggle, several more shots were discharged from Officer DiPalma's pistol. Officer Hurtado was able to get up and ran down the hill to where the struggle over Officer DiPalma's pistol was ongoing. Officer Hurtado fired one shot, but Becerril was able to take DiPalma's pistol and got up

with the pistol in hand."

According to court documents, Coccozza came around the top of the hill in his police vehicle, as Becerril now had the .45 caliber pistol. The woman was lying the road and DiPalma was on the ground, and Hurtado ran to him to put distance between Becerril, who was still armed. According to the Bill of Particulars, Becerril started to head up the hill toward Wade and Coccozza's vehicle, Coccozza exited his vehicle and commanded, repeatedly, to Becerril to drop the gun.

"Becerril refused to comply and continued to come toward Sgt. Coccozza on the driver side of his police vehicle. Becerril started to raise the gun with the intent to menace and use it unlawfully against Sgt. Coccozza. Sgt. Coccozza fired three rounds from his .45 caliber duty gun. Becerril fell to the ground by the driver's side door of the police vehicle and the gun dropped from his hand," reads the court document. "Becerril remained down only briefly, getting back up, this time unarmed, and continuing to come at Sgt. Coccozza saying, "you are going to have to kill me." Sgt. Coccozza continued to back away and holstered his duty gun as Becerril was now unarmed. Officer Hurtado ran to Sgt. Coccozza's location, and they both continued to back away from Becerril as he advanced. Becerril finally collapsed on the ground." A backup officer from the Village of Fishkill police department was able to cuff Becerril. EMS administered medical attention to Becerril and the woman, who was struck by gunfire during the incident.

Town of Fishkill Police Chief Keith Dworkin did not respond to an inquiry for comment. A lawyer for Becerril could not immediately be reached for comment.

According to the court document, after hearing testimony regarding the Feb. 27 incident, regarding the officers, the grand jury "finds insufficient legal evidence to warrant an Indictment against any person for any crime arising therefrom, and an Indictment is therefore: Not Found."

Assistant DA announces conviction of persistent felony offender

Chief Assistant District Attorney Matthew Weishaupt has announced the conviction and sentencing of Juan Andrades, 52, for the crimes of Attempted Rape in the First Degree, Attempted Rape in the Second Degree and Endangering the Welfare of a Child. The case was prosecuted by Bureau Chief Kristine Whelan and Senior Assistant District Attorney Lindsey Richards.

Andrades, who was a resident of the City of Beacon when he was arrested, was convicted of the above charges on April 4,

following a jury trial in Dutchess County Court before the Hon. Edward T. McLoughlin, according to the District Attorney's Office. Following the trial Andrades, who had six prior felony convictions and six prior misdemeanor convictions, was found to be a persistent felony offender. According to Weishaupt, Andrades was sentenced in Dutchess County Court on July 6 to a term of 22 years to life in state prison.

The defendant was represented by Anthony DeFazio.

The following is a statement put out by the The Dutchess County Commission on Human Rights on July 5 regarding its standing in solidarity with the LGBTQIA+ community.

The Dutchess County Commission on Human Rights stands in solidarity with the LGBTQIA+ community in the face of escalating attacks on each person's right to be who they are and love who they love. These range from efforts to eliminate and potentially criminalize life-affirming health care, exclude students from athletics, deny foster care and adoption of children, and ban literature with inclusive representation and topics, to the targeting of Pride celebrations with a real potential for violence. All of these actions run counter to the ideals and promise of this country – freedom and equality for all. And they are not only happening "somewhere else." The Commission has documented incidents locally that have targeted the LGBTQIA+ community, including but not limited to the destruction of Pride flags, the harassment of families and their allies, and the banning of literature that centers a person exploring their identity. Two former Renegades chosen for Futures Game

Two former players for the Hudson Valley Renegades – and one player with the potential to be assigned to the New York Yankees’ High Class A farm team in Dutchess County in the very near future – have been chosen to participate in the prestigious Futures Game on Saturday, July 16.

The Futures Game is held in conjunction with the annual Major League Baseball All-Star Game. The Futures Game showcases young talent that is expected to make the big leagues in short order. The game is on July 16 at Dodger Stadium in Los Angeles.

The Futures Game is set up much the same as the All-star game, American vs. National, although the game is only seven innings instead of the traditional nine. It will be broadcast live on the Peacock Network at 7 p.m.

Former Renegades Anthony Volpe and Ken Waldichuk, and potential

Renegade Jasson Dominguez, will represent the New York Yankees.

Volpe, a shortstop, plays with the Double-A team in Somerset, New Jersey after starting at Hudson Valley last year. Volpe is considered the No. 8 prospect in all of baseball out of thousands currently playing in the minor leagues. According to MLB Pipeline, Volpe is also considered the No. 1 prospect among all Yankee minor leaguers. After a slow start, Volpe is hitting .245 with 11 home runs and 44 RBI.

Waldichuk, a left-handed pitcher, is with the Yankees Triple-A team in Scranton-Wilkes Barre (Pa.). The lefty is currently 6-3 with a 2.44 ERA. He is the Yankees’ fifth-best prospect and No. 74 overall in Major League Baseball.

Dominguez is in Low Class A ball in Tampa. The highly regarded outfielder is New York’s third-best prospect and 40th best in baseball. He is hitting .267 with nine home runs and 35 RBI.

Eight is great as Renegades extend winning streak

The Hudson Valley Renegades finished off the first six-game series sweep in team history on Sunday afternoon as they defeated the Jersey Shore BlueClaws 9-6 in 11 innings. The Renegades have now won eight straight games.

HV is 45-37 overall and 10-5 in the second half of the season.

The BlueClaws took a 1-0 lead in the bottom of the first when Carlos De La Cruz and Rixon Wingrove hit back-to-back doubles against Josue Panacual.

The Renegades struck back with three in the top of the fourth against Ben Brown. Everson Pereira led off with a single and scored on an Anthony Seigler double. An error by D.J. relief, Sikkema (1-1) struck out a career-high 11 batters and allowed just one unearned run on two hits. The win was the lefty's first career victory, and 11 strikeouts are the most by a Renegades pitcher this season.

Hudson Valley tied the game at 4-4 in the top of the seventh on a Cooper Bowman RBI single, where the score would stay into extra innings.

In the 10th, the Renegades and BlueClaws traded runs to knot the score at 5-5, with Pat DeMarco delivering the Hudson Valley run with an RBI single off Carlos Francisco.

The Renegades exploded for four runs in the top of the 11th, with Trey Sweeney putting the team ahead for good with a two-run triple off Francisco (0-3). Bowman followed with an RBI double and scored on another Stewart error.

Ryan Miller allowed a run in the bottom of the 11th, but induced a game-ending double play from Baron Radcliff to complete the sweep.

The Renegades are back at Dutchess Stadium this week to host the Greenville Drive, the High-A affiliate of the Boston Red Sox.

drive at Dutchess Stadium, but we had a rainout that day, so we're doing the food drive this Sunday, July 17.


Who puts all this together for the Renegades?



Flock of Feathers, Stony Ground 4-H Clubs educate community

The Flock of Feathers and Stony Ground 4-H poultry clubs came together to inform the public about avian influenza recently. They set up an educational display outside the Tractor Supply in Wappingers Falls.

Avian influenza, or the HPAI virus, is a disease that mainly affects poultry like chickens and turkeys. The goal was to let those who have chickens know how to protect their chickens, as well as inform those who don't have chickens how to help in trying to halt the spread of this virus. There has not been a case of avian influenza in Dutchess County since February, so for now our birds are somewhat safe.

Due to efforts such as those described above, the spread of A.I. has been halted and restrictions regarding showing poultry at fairs in NY have been lifted! Come and visit our 4-H poultry clubs at the Dutchess County fair in August.

Showmanship Clinic

A total of 54 youth ages 5-18 attended the 4-H all-species showmanship clinic on June 20 at the Dutchess County Fairgrounds.

From a large and lively group of 4-H Cloverbuds (5-7 year olds) to four of our Flourishing Farmers members (youth with special needs), kids from a wide variety of backgrounds worked with goats, sheep, dairy and beef cattle, hogs, llamas and alpacas, poultry, rabbits and cavys, and horses.

Participants worked to improve their skills in showing their proj-

ect animals, learned how to show other species, and came together to share their passion and experiences with others. Sessions were led by senior 4-H'ers and 4-H alumni who volunteered their time as peer mentors. Local farmers and volunteers made this possible by donating their time and costs to bring animals for the program.

July 16 event in Amenia to reveal rich mosaic of rural life in early DC

The public is cordially invited to the gathering of descendants of Amenia's Bockee family (pronounced boh-KAY) at the historic Smithfield Church in Amenia on Saturday, July 16, at 2 p.m. It is offered as a live, in-person event only and includes refreshments and a display of historical items.

The Dutchess County Historical Society (DCHS) and Amenia Historical Society (AHS) co-host the event since both organizations have important collections related to the family.

The talk will be given by DCHS and AHS Trustee Betsy Strauss, DCHS Collections Chair & Trustee Melodye Moore, and DCHS Executive Director Bill Jeffway. There will be questions and an opportunity for discussion and refreshments in the historic church, a beautiful setting for historical items which rarely leave the protective confines of DCHS and AHS archives.

The period of time we will examine ranges from the late 17th century, when the Bockee family first purchased 350 acres in the area in 1698 (they actually built a home and settled around 1761) through to the end of the Civil War, and into the mid 20th century.

As talented, educated, community-oriented establishment figures with means, the family could have chosen to live in Poughkeepsie or New York City, and for certain periods of time, certain family members did. But essentially, over the centuries the family chose to live a rural life.

Those not familiar with the area or its history, may be surprised that any rural area could be at the intersection of major events like the Revolutionary War, the abolition of slavery, and the Civil War, or whose economy included lead mining and railroads.

Dutchess County life

This dynamic family gives us a rare view into the varied mosaic of Dutchess County life at the time. Stories include the situation of Indigenous Peoples. The area, in broad terms, was a border area with the Mohican to the north and the Wappinger to the south. Adjacent to the Bockee land in the early 1740s, there was a significant settlement of Moravian missionaries determined to convert Indigenous Peoples to Christianity. The story of its rise, and fall, tell us a lot about the challenges faced by Indigenous Peoples.

Women in the family were both determined to be well educated themselves,

and determined to educate others. Men in the family, through political elections and legislation, and through service in the Civil War, sought to advance the end of slavery in the United States. As was not uncommon at the time, the family advanced the abolition of slavery, but themselves enslaved men and women.

These intersections of politics, law, economics and social activity are physically manifested in the Federal Square, which we encourage attendees to visit after, along with a visit to the adjacent cemetery where family members are buried.

The highlights of the items on exhibition include the unveiling of the recently restored early 19th-century portraits of Abraham and Martha (Oakley) Bockee. The portraits were a recent gift to DCHS from Jean Oakley Winans Fisher in memory of Margaret Bockee Link. A successful fundraising drive allowed for their professional restoration. The wedding dress of Martha Bockee will be on display.

We will feature photographs of the Bockee family home taken from the landmark 1931 Dutchess County Doorways by Helen Wilkinson Reynolds and photographer Margaret DeMott Brown.

Attendees will also see the medical chest used by Dr. Jacob Bockee in the military hospital in New Orleans where he served with his wife and daughters. After the war, the active leadership of the family and family economy was taken

over by Catharine, who established a school for young ladies in Poughkeepsie. Of special interest is the beautiful satin quilt made by students of her students. Viewers will be able to admire the fine needlework, as well as the personal messages and names of students embroidered on each quilt square.

For those of us who still have not ventured out a lot given the pandemic and may hesitate, we believe a physical trip to the Smithfield Church is well worth the trip on the 16th.

During a 1926 DCHS pilgrimage for members that included a trip to the Smithfield Church and nearby Troutbeck estate, under the heading of "the value of local history" the philosopher and author Lewis Mumford spoke to the audience about what he saw as the power of being physically present in local history.

I paraphrase for brevity: "Local history touches on things that have happened on the spot, and local history becomes part of our life in a way that is not possible from if taken only from books and secondhand accounts. Things we can see and touch are the things that awaken our imagination."

Therefore, they are less likely to offer lower fares on those dates. You will often

get better rates if you can travel from, for example, Tuesday to Tuesday or Wednesday to Wednesday. Since the vast majority of people take a vacation week that includes either Saturday to Saturday or Sunday to Sunday the airports are likely to be less crowded. Also, you might find better rates for weekday flights.

You can also save money if you take a late afternoon flight. Later flights are less desirable as most travelers wish to arrive as early as possible.

I understand their eagerness to spend as much time on vacation, but it also often leaves weary travelers without access to their hotel room until late afternoon. The front desk will certainly hold your luggage until your room becomes available. Perhaps the best way to wind down from the long trip from home to island is to request a local cocktail and sip it on the beach as you watch the waves roll in.

You can also choose to adjust your vacation from the average of 7 nights to 6 nights or even 5 nights. That simple change to fit your budget likely would save hundreds of dollars. That reduction could also save on one or two days less for the cost of a pet sitter or a dog kennel, reduced parking at the airport, and more. The savings would start to add up.

You could choose to put the savings in a bank account or, you could upgrade your hotel room with a better view. But

maybe you don't need a room with a view. That would save even more money that could pay for one or two nice excursions to see the area. Also, why would you look at the view from your hotel window when you came all this way so you can sit on a beach?

Choosing non-inclusive resorts can save a lot of money. You will be more mindful of what you order from the menus and will be more likely to finish the meal for which you've paid. The All-inclusive resorts make the assumption that guests will eat and drink to excess and the package price charged will reflect that overpriced, hidden cost.

Indeed, there is a tremendous amount of food waste at All-Inclusive resorts due to overloading plates, and discarding excess food or food you don't like.

Often, it's more interesting to explore smaller establishments in the area around you. You'll meet local people, and are more likely to try local food prepared by locally-owned restaurants. Ask the locals for their favorite Wine and Spirits location. Ask for recommendations of their go-to lunch or dinner places and make sure that when you arrive at the eatery, you drop the name of who gave you the recommendation. Sometimes, knowing the friend of a friend gets you more congenial service. You're more likely to have an authentic experience that you will

Corn and Roasted Pepper Frittata Ingredients

- 3 teaspoons olive oil
- 2 tablespoons finely chopped onion
- 1 cup fresh corn kernels
- 1 roasted red pepper, cut into strips
- 4 eggs, lightly beaten
- Salt and pepper
- 4 ounces Mozzarella cheese, shredded

Method

Heat the oil and in a 10-inch skillet over medium heat. Add the onions and corn. Sauté for 2-3 minutes. Add the red pepper strips; cook for 1 minute.

Add the eggs, salt and pepper and Mozzarella. Cook over medium heat, stirring in order to blend all the ingredients, for 3-4 minutes until the edges start to dry. Place under the preheated broiler and cook for 2-3 minutes until lightly golden. Serve warm or at room temperature.
