Ex-Renegade Schlittler shines in MLB debut

Major League Baseball's home run leader Cal Raleigh has put the Seattle Mariners on high alert this week, but he may have met his match on July 9. Such a formidable opponent took the form of 24-year-old Cam Schlittler, who was donning Hudson Valley Renegade pinstripes just a year ago. The 2024 South Atlantic League Pitcher of the Year quickly arrived on the major league radars, showcasing a fastball that touched numbers the Yankees haven't seen all year.

Ahead with two strikes on Raleigh in the first inning, Schlittler's 99 mph offering landed just a bit high. The next pitch was nearly identical, and Raleigh was frozen. The ball was then scooped up by the Yankees starters, lining the dugout fence to watch the newest – and youngest – addition at work. Even if Raleigh is not this year's American League MVP, he will forever be linked Yankees history as Schlittler's first major league strikeout.

The U.S. men's national soccer team captain shared much more on July 8 as he hosted a soccer clinic at Wappinger's Martz Field. For decades, it has been the town's summer backdrop. Here, Adams once traversed cones and dreamed of a

soccer career at every chop and turn. Now known as the "Tyler Adams Soccer Pitch," the field will undergo a full refurbishment with no cost to the town or its players, from Scotts Lawn Service and Every Kid Sports.

The heat hardly simmered the excitement, as little ones with backpacks larger than their bodies stretched their hands to give Adams a high five, or a notebook to sign, before warming up. Smiles etched

Captain Kidd's Scavenger Hunt in Wappinger

Did you know a treasure hunt is happening in the Town of Wappinger? A treasure marker is hidden in a sea wall. The wall was "discovered" when Town of Wappinger Supervisor Joseph Cavaccini, along with members of his team, were looking at the progress made on the Chelsea Boat Ramp and Docks.

"It's a way to get people out to sites and educate them on these areas," said Cavaccini.

One had to register for Captain Kidd's Scavenger Hunt before June 27.

The first video clue released during the adventure was on the Town's website.

Released on July 7, Clue #1 stated: "Avast, me hearties, ye're near the mark, Where time sails back in this village park, With cabins and tales from days of yore, The past be waitin'—go start to explore!"

Gather yer crew, don yer tricorn, and set sail for glory! The first who solves it takes one step closer to the prize... but beware! Other pirates be on yer trail."

The clue was active from July 7 until July 13. Those who are participating, scanned the QR code or doc-

umented the spot. The next clues will continue to be released on the Town's Facebook page.

During this year, which is a year-long celebration of the Town's 150th anniversary, the goal is to have residents and nonresidents "discover places in town that maybe they might not have previously knew existed," said the supervisor.

According to a local legend, said Cavaccini, "Captain Kidd buried a treasure along the banks of Wappinger." The maintenance on the Chelsea Boat Ramp "allowed us to have the perfect setting for [this program]," said Cavaccini, who gave

credit to members of the Wappinger Recreation Department and former clerk Chris Masterson who originally began the program years ago.

Confidential Secretary to the Supervisor Kaitlyn Aboshanab, said the prizes are:

-1st place: Family 4-pack of tickets to Nickelodeon Universe at the American Dream

-2nd place: Winner's choice of a brand-new bike from Bikeway

-3rd place: Winner's choice of an All Angels Montessori program

"We want to make it fun for the kids," said Cavaccini.

The hunt runs until next month.





Government officials, community members hope to save Newburgh-Beacon Ferry service

"It has been determined that the ferry will not return to service," Evan Zucarelli, the MTA's acting senior vice president, stated about the Newburgh-Beacon Ferry service during the latest MTA Metro-North/Long Island Rail Road committee meeting.

Zucarelli stated, "Since January this year, ferry service between Beacon and Newburgh has been suspended and replaced by bus service due to critical dock infrastructure damage. The initial suspension was triggered by typical winter river icing."

He noted there was "significant damage" on the Beacon side of the dock and a "long-term solution" would be necessary.

There was a gathering of local community members and government officials who want the ferry service to remain was held at the Newburgh dock in Orange County last week.

The current shuttle bus replacement service will run through 2025. Next year, it was stated by Zucarelli, the "Newburgh-Beacon shuttle bus will become free." He also noted the MTA is "looking to expand shuttle frequency."

James O'Donnell, who was recommended by the Orange County Executive for the 23-member MTA board and casts one collective vote with the representatives of Dutchess County, Putnam County, and Rockland County, asked, "Why does the free bus service [begin] in 2026? Why not now?"

Justin R. Vonashek, MTA Metro-North President, stated officials will take a look at when the free shuttle service will begin.

One area resident commented he has "strong opposition" to the ferry service being discontinued. He said it supports residents without cars, and the MTA is punishing riders for what was under the MTA control – a very limited service. He suggested the MTA should "restore" service and "promote it effectively."

According to the MTA "ridership had been declining" - even after COVID 19.

Congressman Pat Ryan (18th Congressional District), stated in a letter to MTA CEO Janno Lieber, "The closure of the Newburgh-Beacon Ferry is yet another example of our Hudson Valley community paying into a NYC-centric system and get-

ting almost nothing in return." Ryan continued, "The MTA should be adding more transit options and lowering costs, not taking away the limited options we do have. The MTA discontinuing this ferry service is a reckless abandonment of the people it's supposed to serve, turning its back on our community while happily taking our tax dollars. Hudson Valley commuters deserve better than this betrayal of public trust and I'll fight like hell to get this service restored."

One Orange County resident commented that the ferry is a "crucial link" for commuters who work in New York City and live in Newburgh and stated the bus "is not an adequate solution. It takes twice as long."

Another resident of Newburgh stated the ferry "has been an invaluable service."

"At a time when congestion pricing and the MTA Payroll tax are already raising costs for families and small businesses, the MTA should be reinvesting in our communities, not pulling back. The Newburgh-Beacon Ferry provides not only reliable access to transit, but also an economic boost to the City of Newburgh and the entire region," stated NYS Senator Rob Rolison (39th Senate District).

Rolison stated to Southern Dutchess News, "The Ferry is more than a mode of transportation — it is a vital link for Hudson Valley residents who rely on it to cross the river, connect to Metro-North, and move through life with dignity and independence. Eliminating this service with little warning and no public input is a disservice to our region. I'm proud to be part of this bipartisan effort and we won't stop fighting until we get the ferry back and enhancements to it."

A meeting was held on the evening of July 8 to try to save the ferry at the dock in Newburgh, with Ryan and Rolison in attendance, along with local leaders. Assemblymember Jonathan Jacobson also spoke at the rally to save the ferry.

Jacobson (104th Assembly District) said in a statement to Southern Dutchess News on July 8, "I will be working with local residents and businesses to find a solution to the current situation."

Jacobson is on the Assembly's Corporations, Authorities and Commissions Committee, which oversees the MTA.

"Every year during budget hearings, the MTA comes before our committee and asks for money," said Jacobson on July 10 in a press release. "I will be making the case to save the ferry, both publicly and behind the scenes."

According to Jacobson, the first order of business is to ensure that there are working docks on both sides of the river. He is coordinating with Beacon officials to secure funding for the city's dock repairs, and also plans to work with local residents and businesses to "think outside the box" for weekend service.

"The MTA has a budget of more than \$20 billion. The agency claims that the ferry costs \$2.1 million annually to operate, which is a mere accounting error for them. The MTA can make this work," said Jacobson.

Neal Zuckerman, who was recommended by the Putnam County Executive for the 23-

member board, asked about exact numbers regarding the ferry.

Zuckerman stated, "it is counterintuitive" that expanding the [growth] at the waterfront and "not expanding numbers." He noted that "Beacon is like a dream" as what has happened to the area since Dia Beacon came and the extraordinary resurgence that occurred.

Last year, over the course of the year, ridership was averaging 62 riders per day on the ferry, down from well over 200, it was stated.

"It shows people are still using train but choosing to get there a different way," it was remarked.

According to the MTA website, the adult one-way ferry fare was \$1.75. Seniors (62 or older), people with disabilities, and Medicare recipients paid \$1 if they showed appropriate ID. Children 5 and under rode free, and a ticket cost for those age 6-11 was \$1.

on small faces, parents beamed, and whistles blew, signifying a rise of hope. It's all about the hope that any child could one day find themselves in Adams' position.

Here, children from the broader community, Town of Wappinger Recreation Summer Camp, and Wappinger United Soccer Club, saw where a dream could begin under their own two feet. On the same field where Adams learned his craft, the place he'll always return to, such a connection was forged for 220 young athletes.

"I hope that more young players continue to get involved in the sport of soccer, and that I can serve as a role model for any kid who dreams of playing professionally," said Adams. "If you can dream it, you can do it."

In growing soccer stateside ahead of hosting the 2026 FIFA World Cup, Adams advocates for natural green surfaces for athletic spaces, which promotes performance and lessens the chance of injury compared to artificial turf. That's the Scotts "Keep It Real" sports mission, according to Lance Melnichenko, director of Next Gen Lawncapes. Every field that the lawncare giant refurbishes is done with real handiwork. A commitment to real grass beneath bare feet and cleats is a commitment to safety and performance, especially in an underserved community.

When kids play on real green surfaces, especially in underserved communities, it can improve performance and avoid injuries - an opportunity to fall in love with a game, to breathe open air.

Soccer is known globally for being an accessible sport, with just two ingredients - a ball and some green grass, said Melnichenko. For Tyler Adams, both began in the Town of Wappinger and continue today. "When we were trying to figure out how to bring that knowledge of the partnership, we thought of somebody like Tyler," Melnichenko added.

Adams still signs soccer balls and jerseys for kids who hardly measure up to his waist, even in cleats. He visits with family, embraces old friends, and shouts out the contributions of everyone who got him on

this journey that saw him go from New York Red Bulls, to AFC Leeds and Bournemouth, and back to the USA's international stage. He carries those values with each stride on a soccer pitch. "I'm grateful to have grown up with so much support from my family and the wider community," said Adams. "It's really inspired me to try to give back as much as I can so that other young athletes can have a similar experience."

Adams also received autographs from those athletes in attendance. In line with soccer tradition, Every Kid Sports provided a pair jerseys for every young athlete to sign

for Adams. The exchange is only the surface of what the national nonprofit does for young, hopeful athletes.

For 15 years, Every Kid Sports has been entirely supported by donations in its mission to provide access to sports at no charge to families. It connects youth with sports that best fit their towns and communities, from lifesaving swim lessons to outdoor soccer clinics, said Eleana Fanaika, executive director of Every Kid Sports. Over 8,000 children have been allowed to participate this year in forty different sports across the country, all funded by donations.

In Wappinger, 220 smiles were made through donations, as Every Kid Sports runs entirely on donations. Instead of "Maybe next year," parents can say "yes" - yes to being outside, and to a day spent together. Without financial obstacles, children can find an outlet - a means of connection, not just with giants like Tyler Adams, but their peers, their communities.

There is no declaration or difficult conversation to apply a child for Every Kid Sports, just a discreet online application. The application is open for the next few weeks, said Fanaika, at everykidsports.org.

Like many Wappinger locals, Town Supervisor Joseph Cavaccini has known Adams' talent and character since the early days. Those days began at Wappinger United Soccer Club and are remembered by Ketcham High School administrators, past and present. But not once has Adams forgotten Wappinger. Not when the Premier League took him in for AFC Bournemouth, or when he willed USMNT to its third straight CONCACAF Nations League title in 2024. "From the time we were growing up to now, he has maintained his hometown roots," said Cavaccini. "It's something that we as a town are very grateful to him for, his contributions that are often very under the radar in this community."

The Tyler Adams Pitch will be renovated in September, as campers return to their school desks to count hours until practice. It will be resodded, revamped and readied for play. Every Kid Sports will continue its commitment to any season and sports for all.

If one team can grow from Martz Field, and another, and another, parents won't need to travel out of their county, or travel states away, to get their child on the pitch, said Fanaika. "When people know that our program is available, then we can help expand more kids into the sports."

Hochul issues letter to Dept. of Homeland Security regarding grant program funding

Editor's note: The following is a letter issued by Gov. Kathy Hochul urging the Department of Homeland Security to make funding available to state and local governments through the Federal Emergency Management Agency's (FEMA) Homeland Security Grant Program (HSGP) as has been done every year since 2002.

To Secretary Noem:

As Governor, my chief responsibility is ensuring the safety and security of New York State and all its residents. Not only does New York face the nation's most diverse threat landscape, but with numerous economic, governmental, and recreational assets, it remains the nation's top target for terrorism. In recent months, that threat has only grown given the ongoing conflicts in the Middle East, making it essential that the federal government, specifically, the U.S. Department of Homeland Security (DHS), ensure the availability of critical homeland security funding to states and local governments.

I am deeply troubled that DHS has yet to make funding available to states and local governments through the Federal Emergency Management Agency's (FEMA) Homeland Security Grant Program (HSGP) as it has every year since 2002.

On June 22, 2025, DHS issued a bulletin through the National Terrorism Advisory System notifying Americans of the heightened threat environment our nation faces due to our recent involvement in the ongoing conflict between the nations of Israel and Iran. As noted in the bulletin:

"...Low-level cyber attacks against US networks by pro-Iranian hacktivists are likely, and cyber actors affiliated with the Iranian government may conduct attacks against US networks. Iran also has a long-standing commitment to target US Government officials it views as responsible for the death of an Iranian military commander killed in January 2020. The likelihood of violent extremists in the Homeland independently mobilizing to violence in response to the conflict would likely increase if Iranian leadership issued a religious ruling calling for retaliatory violence against targets in the Homeland. Multiple recent Homeland terrorist attacks have been motivated by anti-Semitic or anti-Israel sentiment, and the ongoing Israel-Iran conflict could contribute to US-based individuals plotting additional attacks."

As home to the country's largest economic center, and the largest Jewish community outside of Israel, these threats put New York communities at a greater risk than perhaps any-

where else in the nation. Thankfully, since your agency's inception, New York and DHS have maintained a strong partnership to counter these threats. This partnership has been essential to ensure that the State and local governments and their public safety agencies have the funding and resources needed to prepare for, mitigate, prevent and withstand terrorist threats and targeted violence.

One core component of this partnership has been DHS' Homeland Security Grant Program (HSGP). In 2024, New York received \$219.9 million in HSGP funding, \$156.1 million of which was allocated through the Urban Area Security Initiative (UASI) for jurisdictions in the New York City Metro Area, principally the New York Police Department. In 2023, New York received \$244.7 million with \$173.9 million allocated through UASI.

HSGP provides states, local jurisdictions and their law enforcement, public safety, homeland security and emergency management officials with critical resources to further their preparedness and response capabilities. Without these resources, the heroic men and women who continuously put their lives on the line to protect their fellow Americans are unable to access state of the art training, the latest advancements in equipment and the ability to seamlessly share and analyze intelligence with each other - all essential components of counterterrorism efforts.

Furthermore, HSGP funding is vital to securing and maintaining critical infrastructure assets (transportation hubs, power grids, water systems, communication networks) which are top targets of nefarious actors, as well as to assist local law enforcement with border security via Operation Stonegarden. Through Operation Stonegarden, jurisdictions along international borders receive direct funding to not only enhance cooperation and coordination between federal, state, local and tribal law enforcement agencies, but to support joint operations. As a state with a 445-mile international border, security of this boundary is of the utmost importance to me. To that end, I have secured \$8 million in state funds, as well as dedicated State Police and other public safety resources to support this federal mission.

Any further delays in the availability of HSGP will degrade the capabilities of our nation to prevent terrorism and make us less safe at a time when the variety and severity of security threats continue to grow.

I urge you to release the FY2025 HSGP Notice of Funding Opportunity immediately and help ensure our nation remains ready and able to defend ourselves against anyone seeking to threaten our way of life.

Enough. I urge your office to halt this ferry shutdown immediately and demand a full public review. The MTA must stop treating the Hudson Valley like an ATM for New York City and start delivering real value to the communities it claims to serve.

The Big Beautiful Bill

To the Editor:

It has been reported that a large percentage of citizens don't know what is in the partisan bill that just passed, nor how they might be affected. It has three major areas of concern for most constituents.

First, the bill gives tax breaks to corporations and billionaires who DON'T need them and adds more than \$3.4 Trillion to the national debt, according to the CBO (Congressional Budget Office). Republicans who voted for the bill say it will result in unprecedented economic growth. This is the same trickle-down economic theory that has never benefited the lower and middle class. George H. W. Bush called it "voodoo economics." For the last 40 years it has only widened the wealth gap between the top 1% and the rest of the country. There is nothing in the bill to reverse that outcome.

Second, the bill pillages the national safety net, gutting healthcare and food assistance programs. By far, Medicaid is the program most affected, eliminating hundreds of billions of dollars of benefits and adding new eligibility requirements. The CBO estimates that over 11 million people will lose health insurance and which will cause several rural hospitals to close. People not on Medicaid will see their insurance premiums rise dramatically and have trouble finding care in nearby hospitals.

Finally, the bill increases spending from tens of millions to over \$75 Billion for additional ICE agents and new detention centers, according to reports. It appears the administration is intent on creating a police state in which undocumented immigrants, and even US citizens, are rounded up in mass raids and sent to detention centers (aka, concentration camps) or deported to foreign gulags.

By most accounts this is an extremely unpopular bill. The good news is that many of the provisions that affect the safety net don't take effect until after the 2026 midterm elections. So, there is still time to tell your Republican elected official to pass new legislation to reverse these effects. If not, they should be on notice that the only alternative is to vote them out.

To avoid disruption and risk, children and their families often retreat into the safer environments of their homes and experience significant social isolation as a result.

Non-profits with mission to serve food can apply for grants online through Aug. 5

Dutchess County Executive Sue Serino announced a new grant opportunity to support organizations throughout Dutchess County dedicated to feeding neighbors in need – be it serving warm meals to those facing homelessness. Eligible non-profit organizations can apply for these grants online, now through the August 5th application deadline.

Serino said, "Local organizations are out there every day making sure neighbors have food on the table, often with limited staff and resources. This funding is about helping them do what they do best: serve our community. By investing in their infrastructure, we're helping them reach more people and continue to be

there for those who rely on them most."

Eligible non-profit organizations are those with a 501(c)(3) designation whose primary mission is to serve food to those experiencing homelessness or provide food to those in need of food assistance, i.e., food pantries, within Dutchess County. Examples of eligible expenses include freezers; grab-and-go coolers; shelving/storage systems; food preparation and transport equipment; food packaging; Point of Sale (POS) systems and inventory management systems. Priority will be given to agencies that show a strong commitment to providing meals for individuals experiencing homelessness.

A total of \$100,000 was dedicated through a Dutchess County Legislature

amendment to the 2025 County Budget for 501(c)(3) non-profit organizations' operating infrastructure initiatives as part of the County's 2025 Agency Partner Grant (APG): Infrastructure program.

The County's Community Development Advisory Committee and the Department of Planning & Development's staff will review all APG: Infrastructure applications and send their recommendations to the County Executive for final approval.

Additional information, application instructions and guidance about the 2025 APG: Infrastructure program is available online. Applications will be accepted via an online portal through Aug. 5 at 3 p.m.; awards are expected to be

announced in early fall 2025.

These grants are the latest in Dutchess County's continuing efforts to address hunger and improve access to healthy food. In 2024, County Executive Serino established the Dutchess County Food Security Council to identify the scope, causes and barriers of food insecurity in Dutchess County while reducing food waste, expanding food access and recommending effective policy solutions.

'Click-to-Cancel' rule in effect July 14

New York Attorney General Letitia James reminded New Yorkers on July 8 that the Federal Trade Commission's (FTC) new "Click-to-Cancel" Rule will go into effect on July 14, making it easier for consumers to cancel subscriptions and other services that renew automatically. The rule requires companies to make cancellation at least as simple as enrollment and to allow consumers to cancel using the same method they used to sign up – either online, in person, or over the phone. When canceling a subscription online, the cancellation mechanism must be easy to find, and consumers cannot be forced to chat with an agent if they did not do so when they signed up.

"New Yorkers should never have to jump through hoops just to cancel an unwanted subscription," said James. "This new 'Click-to-Cancel' rule will protect consumers and ensure companies are operating fairly. I encourage anyone who has a difficult time canceling a subscription to report it to my office, and I will continue to make sure companies throughout our state are following the law."

In addition to requiring simple cancellation, the Click-to-Cancel Rule requires companies to make sure that people know what they are agreeing to before they sign up for a subscription that renews automatically. Companies must also make sure

that important information about the subscription is truthful, clear, and easy to find. Attorney General James encourages

New Yorkers who experience issues canceling a subscription to contact her office by filing a complaint online.



The Hudson Valley Renegades are shining brighter than Junebugs this month, capturing a season-high six game win streak from July 6-11.


After doubling his season home run total to eight in just two games, Jace Avina proved worthy of a promotion to AA-Somerset. Avina joins the Patriots staff along with South Atlantic League (SAL) strikeout leader Elmer Rodriguez-Cruz and Duncan Pastore. After dropping a single game to the Asheville Tourists, Hudson Valley enters the All-Star Break with 10 wins in its last 12 games. Renegades showed grit and determination, coming from behind thrice to prove victorious.

So Long - On June 8, all seven runs came via the long ball in a true embodiment of the Bronx Bombers. Jace Avina put the team on the board with a solo shot, then put them ahead with a three-run shot. After Sebastian Keane secured four straight outs in relief, the Renegades were still chasing the lead. With two on, two out in the bottom of the eighth, cue Josh Moylan. A much-needed three-run bomb to left center proved to be a timely game winner. Keane further put away all three Tourists in the ninth to earn his fifth win

of the season. And Alex Vargas continued his hitting streak. Nobody was more excited than James Cooper, who, upon Vargas reaching first, nearly threw his shortstop into the outfield with a celebratory thumping on the chest.

Deja Vu - Continuing his hot hitting and the Renegades' recent tear, Avina launched two more home runs that proved the difference maker, in a 4-1 win on July 10. Kyle Carr continued his month of dominance, allowing zero earned runs while striking out six in as many innings. Josh Moylan's seventh inning triple set up Anthony Hall for an RBI single and the insurance run.

Rehabber Michael Arias held it down over two hitless innings before Tony Rossi shut down the Tourists in another scoreless outing. Each team had just five hits, but the Renegades came up big when it mattered. Avina's solo equalizer erased a Tourists lead. He came up big again as Asheville threatened to score on a sac fly, throwing out Chase Jaworsky in a bang-bang play completed by Tomas Frick. In the fifth inning, it was Avina again, hitting his eighth homer of the season, after leaving Brooklyn with four last Sunday.

The Renegades earned this break. After a stretch of consistent .500 baseball, they found the very momentum that was needed to make a second-half surge. Now just one game behind Greensboro for the SAL North's top spot in the second half, Hudson Valley will return from the break with three games on the Jersey Shore.

High heat in the bullpen!

Reliever Tony Rossi proves versatility with Renegades

Pitcher Tony Rossi rose to Hudson Valley Renegades fame with a string of 15 scoreless outings, a consistent contributor to the team's league-lowest earned run average. Ahead of last week's series against the Asheville Tourists, North Carolina native Rossi has turned heads as a reliable, strike-throwing reliever since joining the roster in late April.

One of few professional ballplayers experienced at three different collegiate levels, Rossi's arsenal makes him a key component of the bullpen, whether a situation calls for a save or a one pitch, one out solution.

Since his call up to Hudson Valley in late April, Rossi leads the team in saves (4) and has quickly become a stalwart reliever.

On July 9, Rossi was tagged for the save with the Renegades ahead of the Asheville Tourists by three runs. Nine of 11 pitches were strikes, clocking a 97 mph heater on his way to the fourth save of his Renegades career. As a State College of Florida freshman, his heater sat around 88, developing to a nasty pitch through his redshirt senior year at the University of Charlotte. As he continues striking points off his ERA, which is down to 1.31, Rossi is one of the stars of the Renegades stacked bullpen. At the time of this writing, he has yet to allow a home run in his professional career.

Known at the University of Charlotte for that same reliability, he was the most-used arm in the bullpen in 2022. At University of West Florida, Rossi was a three-time Freshman of the Week, and earned all-conference honors as the best freshman arm in the Division-II Gulf

South Conference. He then transferred to State College of Florida, Manatee-Sarasota and had a remarkable sophomore year. In seven relief appearances in the COVID-shortened 2020 season, Rossi notched a 2-0 record and a 1.80 earned run average (ERA).

After sitting out the 2023 season as he recovered from an off-season Tommy John surgery, Rossi had a breakout junior campaign at the University of North Carolina at Charlotte.

And boy, did the Florida boy love pitching in North Carolina. He prevailed in his Charlotte debut with a win, and was the most-used arm in the bullpen in his first season, from debuting with a win to appearing in the CUSA elimination game. With 68 strikeouts over 44.0 innings, Rossi contributed a 13.91 strikeouts per nine innings. He was also the recipient of the Hugh McEniry Award as the university's standout male student-athlete in 2024.

While the 49ers celebrated a Conference USA title, Rossi was rehabbing, leading the dugout, and holding his teammates to the Charlotte standard. The following season, Rossi bounced back for 2024, in a big way. Ranked the No. 12 relief pitcher in the nation by D1baseball.com, the righthander's six saves led the 49er bullpen, and he got a win in his return from the injury. He was also named 49th on the publication's preseason list of Top 50 relievers. Rossi was effective at both ends of nine innings, with six saves to lead the bullpen, and a few starts on his way to winning four games.

Rossi became the seventh Charlotte alum to sign with the Yankees, joining as an undrafted free agent in 2024. Some New York fans think Tony should be

packing for the AA-Somerset Patriots. While Renegades faithful know time with their favorite hurlers is often fleeting, the

Renegades will be happy to have a little southern comfort in the bullpen to close the season.

Ex-Renegade Schlittler shines in MLB debut

And the final out of his debut, as Raleigh couldn't figure out the four-seam fastball.

In the sixth, Raleigh took a two-strike chance on Schlittler's offering, but still couldn't beat the heat. Seven strikeouts for Schlittler, backed by a thunderous ovation as manager Aaron Boone called the bullpen.

"You're just trying to go out there and do your job and put the team in a position to win. So I was happy to do that and then kind of just be able to relax a little bit after that," Schlittler told YES Network on the July 10 pre-game show.

Raleigh, a first-time All-Star this season, was held hitless by Schlittler, as was the case many times to begin his

career. But the switch-hitting Raleigh is having a breakout season after a top-10 finish in the A.L. home run race in 2024. He won his first career Gold Glove, as well as the A.L. Platinum Glove, awarded to the league's best defender. Just 28 years old, Raleigh debuted in 2021, and played for a week without his first big league hit. And though he grew up in North Carolina, Raleigh rooted for the Red Sox, as Cam Schlittler and his neighbors did in East Walpole, MA.

Before beginning his pro days in Hudson Valley, Schlittler stayed in Boston to play collegiately at Northeastern University.

Schlittler shot up the Yankees' farm system since being drafted in 2022, spending a month in the rookie league and at Single-A Tampa before landing

with the Renegades at the close of 2023. He spent nearly all of 2024 with Hudson Valley, amassing 108 strikeouts to lead the team. Ahead of the season, MLB Pipeline projected Schlittler as the Yankees' No. 14 prospect, and he found success in his first month in Scranton/Wilkes-Barre. In his first four starts, Schlittler held opponents to a .162 batting average.

The Yankees gave Schlittler a lead after his 12-pitch first inning, which ballooned to 6-2 by the end of his evening. In 5.1 innings, he allowed three runs, preserving the lead and his first career win. Four hits, including two home runs.

Anxious smiles and joyful tears mixed within the Schlittler crowd, who trekked to the Bronx from New England

to take in the debut. Some held homemade signs while others had arms outstretched in celebration, hardly able to stay seated. Others held each other, as parents John and Christine shared many embraces. John sometimes paused to adjust his Hudson Valley Renegades cap, take a few breaths, as tears of joy threatened to escape through one, two, then five solid innings.

While Schlittler doesn't have a sure shot in the Yanks' rotation, at least one more start after the All-Star Break is likely. "It's about getting ready for the next one, it's not about nailing anything down," said manager Aaron Boone to NY Post reporters. "He had a great debut [Wednesday]. We think he's got a chance to be a really good pitcher."

Women veterans can access a variety of healthcare services in county



If you close your eyes and think of the word "veteran," what comes to mind? Who do you envision as a veteran? Was she in a pilot in the cockpit of a fighter jet? Did she enlist after 9/11 and serve in Iraq or Afghanistan? Was your image of "veteran" even a woman?

Each year, the percentage of women serving our nation in the military has steadily increased. As of 2020, for example, nearly 75,000 women served in active duty in the United States Army, including nearly 17,000 officers.

Many female veterans, however, don't consider themselves veterans if they didn't serve in a combat zone; and our society hasn't always done a great job of recognizing and honoring their service. Let me be clear: The sacrifice that every veteran has made – be they male or female – should be equally respected and appreciated. Just like the men they served alongside, these brave, heroic female veterans deserve the same high-quality care when they return home; and they are fortunate to have a vital healthcare resource right here in Dutchess County.

Pharmacy services;

- Support from a Maternity Coordinator, along with infertility care services;
- Chiropractic care and pain management services;
- Support services for food and housing insecurity; and
- Care and services provided in collaboration with the VA's community medical partners.

If you're a female veteran, I hope this extensive menu of healthcare options is one you'll explore, should the need for care arise. Please don't let outdated misconceptions about what the VA offers (or doesn't offer) keep you from receiving the vital care you deserve and that you've earned through your service. The VA has made great strides in recent years to make its facilities more accessible and welcoming to the female veterans it serves every day, and I hope you'll see that thoughtful care firsthand.

Do you have a female veteran in your life – a wife, mother, daughter, sister, aunt, cousin, friend? These are all the

faces of the female veteran, and these are the all women who could benefit from the VA's extensive medical offerings, if they served our nation. Please share this column with them and let them know about the comprehensive medical services that they deserve and that are available to them locally through the VA.

In addition to its local medical centers at Castle Point and Montrose, the VA has an administrative office next to our own Dutchess County Office of Veterans Affairs office at the Veterans One Stop in Pleasant Valley; that office is staffed the last Thursday of every month. You can also always walk into our Veterans Affairs office here at 1335 Route 44 in Pleasant Valley, and we'd be happy to introduce you to the VA's helpful staff right next door.

"We are thrilled to open this great new feature at Bowdoin Park just in time for summer fun for the whole family," said Dutchess County Executive Sue Serino. "We asked residents to help pick which design was their favorite last year, and we listened! We are grateful to the dedicated team at Dutchess County Parks for bringing this exciting project to fruition and encourage park-enthusiasts all ages and abilities to come explore this new feature."

Over 1,400 people weighed in last year when County Executive Serino asked for feedback about two different accessible playground designs. Nearly 70 percent of survey participants chose a design from playground designer KOMPAN that highlighted Bowdoin Park's natural beauty and local wildlife.

The new playground includes over 8,000-square-feet of cushioned "pour and play" surface designed to represent a river, a stream, and land inspired by the park's rich natural history. Play structures continue the nature

theme with snapping turtle "springers," birds such as park-favorite eagles perched above the swings and other structures, and climbing towers that look like trees. Accessible features include adaptable swings, a universal carousel, sensory play features, and wheelchair accessible ramps on some structures. The playground also includes two shaded areas for wheelchair users or camp chairs.

A plan for future additions to the area's landscaping, such as benches and shade trees, is being developed by the Parks team.

Director of Parks Brian Coons said, "This playground is inspired by the natural beauty of Bowdoin Park – from the turtles in the pond to the eagles in the sky. We are proud to bring this new accessible playground option to families of all abilities to enjoy and are grateful to the County Executive and County Legislature for the continued support of our Parks programming."

Bowdoin Park is at 85 Sheafe Road in the Town of Poughkeepsie. The new playground is the latest in a series of ongoing improvements to Dutchess County Parks, including the opening of a sprayground water feature at Wilcox Memorial Park in Milan last summer.

County and City of Poughkeepsie at odds on YOU project, Oakley Street shelter

Following Dutchess County's decision to place the Youth Opportunity Union (YOU) on hold, the City of Poughkeepsie invited County Comptroller Dan Aymar-Blair to deliver the findings of his report on the YOU at the City's Common Council meeting on July 1.

This follows the Dutchess County administration's April 2024 decision to place the (YOU) project on hold and redirect millions in (American Rescue Plan Act (ARPA) funds. At the same time, the county recently chose to move forward with plans for a centralized homeless shelter on Oakley Street in the City of Poughkeepsie's 5th Ward. The county comptroller gave an overview of the fiscal impact of these decisions on the City of Poughkeepsie and the county's obligations under existing contracts.

On April 4, 2024, the YOU project—originally envisioned as a transformative youth and community center—was officially put "on hold" by the incoming administration of County Executive Sue Serino.

Just three months later, on July 19, 2024, the Dutchess County Legislature adopted Resolution No. 2024142, reallocating \$4,009,585 in unspent federal ARPA funding away from the YOU to general education initiatives. Currently, no further County appropriations have been made to support the completion of the YOU.

Said Mayor Yvonne Flowers, "The decision to prioritize a homeless shelter on Oakley Street, while leaving the Youth Opportunity Union project in limbo, sends the wrong message to our community. The YOU project represented an investment in our youth and the future of the City of Poughkeepsie. We are deeply

concerned about the long-term impact of the county's failure to meet its contractual obligations, especially since these commitments were made in response to the jail expansion in the City of Poughkeepsie. Nevertheless, the City is committed to continuing to advocate for the residents of our City and we will continue to work with the county to fulfill its commitment."

Dutchess County Legislature Chairman Will Truitt commented, "When this project was proposed to us, the County Legislature committed to allocate up to \$25 million towards its completion, which was to be matched by private fundraising efforts. This included \$10 million immediately allocated for demolition and remediation of the old, asbestos ridden building that sat on the site, in addition to design work to draw up project blueprints. The original project stalled when private fundraising did not come close to meeting the initial expectations that was promised to the Legislature. We remain committed to this project and we have been engaging with the new administration on finding the best path forward to ensure its success. At the same time, Dutchess County continues to invest in our youth through many avenues, including the recently awarded YOU Drop-In grants that awarded \$250,000 to community based, non-profits that serve youth in our community, more than half of which were directed to organizations within the City of Poughkeepsie."

As the county pushes forward plans for a centralized homeless shelter on Oakley Street, the City of Poughkeepsie is raising concerns about the failure to meet benchmarked obligations outlined in the Contract of Sale for the YOU site. The

comptroller's address called attention to what these broken financial and legal commitments mean for the City of Poughkeepsie and its residents

How to donate blood

Simply download the American Red Cross Blood Donor App, visit RedCrossBlood.org, call 1-800-RED CROSS (1-800-733-2767) or enable the Blood Donor Skill on any Alexa Echo device to make an appointment or for more information. All blood types are needed to ensure a reliable supply for patients. A blood donor card or driver's license or two other forms of identification are required at check-in. Individuals who are 17 years of age in most states (16 with parental consent where allowed by state law), weigh at least 110 pounds and are in generally good health may be eligible to donate blood. High school students and other donors 18 years of age and younger also have to meet certain height and weight requirements.

Blood and platelet donors can save time at their next donation by using RapidPass® to complete their pre-donation reading and health history questionnaire online, on the day of their donation, before arriving at the blood drive. To get started, follow the instructions at RedCrossBlood.org/RapidPass or use the Blood Donor App.

Duncan and Julia Brine are, according to me, the top landscape designers in the Hudson Valley. They work from their six-acre garden, called Garden Large, in Pawling, designing, contracting and supervising the installation of private gardens throughout New York, Connecticut and beyond. I first met Duncan at a garden writing seminar at the New York Botanical Garden (NYBG), where he excelled, and I, obviously, almost flunked out. Duncan went on to write a slew of popular gardening books and now teaches at NYBG.

Last Wednesday, Sue and I stopped by to visit Duncan and Julia, sipping Kombucha "Trilogy Blend" on their porch while Duncan regaled us with tales about his adventures, and his family – sons Kyle, the philosophy major who became a biologist, and Alden, a concert pianist looking for a paying gig. But Sue and I were there to talk about native grasses – "Graminoids," according to Kyle, the biologist. I've had a passion for graminoids ever since a stand of gorgeous Indiangrass populated my front yard meadow, creating a golden autumn pasture.

Duncan and Julia have been specializing in native shrubs and perennials since 1984 – "naturalistic gardening," they call it. Duncan pointed out the essential attrib-

utes of native grasses in the naturalistic landscape. Grass animates the landscape, stirring in the breeze. Grasses provide habitat for birds and insects. Native meadowlarks and bobolinks build their nests in the ground, hidden by the grass. Red-winged blackbirds nest a few feet up in tall grass. And grass can provide fall color and year-round interest, as their seed heads persist through the winter.

The Brine Garden plant list features 160 varieties of perennials and shrubs, including 15 graminoids, many native to Dutchess County:

- **Little Bluestem** – one of several native grasses, along with switchgrass and indiangrass, that make up the bulk of America's prairies. In the landscape, little bluestem forms a low clump of blue green foliage with tall golden seed heads in September. It is the primary food source for caterpillars of the tiny skipper butterflies. The Brines are sowing little blue stem as the primary grass in their latest installation.

- **Switch Grass** – this native is so lush and fast growing that it was touted as a possible fuel when oil prices were peaking in the 1970s. In the landscape, switchgrass can grow to eight feet, topped by a golden panicle. A good choice for rocky

or poor soils, especially during dry weather. It is a host plant for the pink streak moth and the skipper butterflies.

- **Common Rush (Juncus)** – native to wet areas in the Hudson Valley, used in the landscape for rain gardens, water gardens, or a "thriller" in combination container plantings. Corkscrew rush, with its, yes, corkscrew shaped foliage, is even grown as a houseplant.

- **Tufted Hair Grass** – this Hudson Valley native forms a cloud of seed heads for a unique garden accent.

- **Northern Sea Oats** – Duncan calls this one "charismatic," with seed heads that resemble grain oats. In fact, the seeds of sea oats can be ground into flour, if you're desperate. In the landscape, sea oats is not too tall, reseeds heavily, and is a terrific garden accent.



- **Miscanthus** – Duncan and Julia are not fanatical about using only natives in the landscape, if something else fits. Miscanthus can be invasive, but some varieties, like Giant Chinese Silver Grass, are sterile. These huge grasses are sometimes used in stand alone situations, where a strong accent is called for.

- **Bottle Brush Grass** – one of the few natives that thrives in shade and blooms in the spring. If you want to visit Garden Large, October 18 and 19, 1 – 5 pm, is listed in the Open Days directory of the Garden Conservancy. Julia assures me that Alden Brine will be performing classical piano tunes during the open house. And the graminoids should be in peak color.
