# Honoring a Beacon native

Army Staff Sergeant Bryan Faison died on June 17

A passion for photography, love of football and being at the beach with his wife and children is how Beacon native Bryan Faison, a staff sergeant in the U.S. Army, will be remembered. Faison's body was honorably transferred back to Beacon on July 11, after landing at John F. Kennedy International Airport in Queens. A service and burial, including military honors, took place on July 16 in Beacon.

The military service member, according to his obituary, died on June 17 in Brunei in Southeast Asia, while he was serving active duty. He was stationed in Hawaii, according to family members. The cause of his death

has not released, due to a pending autopsy, said his family.

"The Faison family has deep multi-generation roots in Beacon, and I was saddened to hear of SSGT Bryan Faison's passing. My condolences to the family," said City of Beacon Mayor Lee Kyriacou, via email.

"The Faison family is long-established in Beacon and it was an honor for me to pay tribute to SSGT Faison and his family," said Harold Delamater, who is the commander of the VFW Post 666 in Beacon. Members of the Veterans of Foreign War (VFW) Post 666, American Legion Post 203, Marine Corps League Det 861, Nam Knights MC, DAV

(Disabled American Veterans) and Guardian Revival "rendered honors and paid respect to a soldier whom most have never met," said Delamater.

According to responses and information about Faison that were answered by his sister, Dana-Sky Jevtic, and emailed to Southern Dutchess News by Libby Funeral Home on behalf of the family, Faison was a 74D, which is a chemical, biological, radiological and nuclear specialist (CBRN).

"They are trained to handle all types of weapons threats as well as decontaminate hazardous material spills or accidents within our own (as an example) hospitals

# Stanford Fire Dept. initiates area-wide effort for Ukraine

Ed Zick, president of the 9-11 Committee of the Town of Stanford Fire Department, and his fellow officers Evelyn Seipp and Duffy Layton, were shocked by the images they saw on television.

Not surprised, mind you. After all, the video coming in from half a world away after Russian invaded Ukraine on February 24 was going to be ghastly. It was war.

But what Zick, Seipp and Layton found just as disturbing was that their brethren – local fire departments in Ukraine, search and rescue teams, emergency medical services – were woefully understaffed and under-equipped.

"Right then I was like, we have to think about our fellow firefighters in Ukraine," Zick recalled. "So, the same committee that we had in the department that put together our 9/11 tribute (when the Fire Dept. places 3,000 flags in the ground on the hill in

Stanford to commemorate the fateful day), we asked them if we could do something."

What they are doing is extraordinary.

Zick, Seipp and Layton realized that the equipment that they have and that other departments in Dutchess, Ulster and Columbia counties have might be ready to be replaced by local standards, but is still outstanding enough to have a long shelf life and help their compatriots in Ukraine. So they have been spearheading a drive to collect as much equipment as they can to send overseas.

Through a contact who knows of a Ukrainian church in Ohio, they have been able to touch base with a fire department in Ukraine.

"Ed is the mastermind of all this. We all just play little roles in his big picture and he would never say that, but it's true," said Seipp, who is the president of the Stanford Fire Co. "I an just one of the moving parts."

where radiation from (X-ray), or medicines or fuels (chemicals), as well as biological or nuclear releases. His unit noticed he had a good eye and put his skill to good use. Bryan would photograph different events and even wrote articles for the Army," stated Jevtic. Bryan was previously stationed in Colorado, Springs.

Faison, the son of Sandra and Micheal Faison, was a 2004 graduate of Beacon High School. After high school, said his relative, Faison attended Northwestern University in Natchitoches, Louisiana. He then transferred to Florida A&M University in Florida. While matriculating there, he played baseball and studied communications. Faison, said his sister, got injured so he then transferred back home and earned a degree from Hudson Valley Community College.

Jevtic noted that Faison "was not participating in the exercises, he was sent by his unit to [Brunei to] take photos."

During his time serving in the Army, according to his obituary, the 36-yearold was awarded with the Army Commendation Medal with two Oak Leaf Clusters (ARCOMM with 2-OLC), Army Achievement Medal (AAM), Army Good Conduct Medal with two knots (AGCM 2nd award).

In a Facebook post last month, COL Josh Bookout, who was commander 3rd Infantry Brigade Combat Team, posted, "He was well-known throughout the squadron for doing what he loved; taking pictures and highlighting Raider Troopers."

"Bryan's dream growing up was to be a professional athlete. When he got injured, he had to refocus, and I believe that was when he fell in love with photography. Bryan faced a lot of hardship during this time. From losing scholarships, to losing his best friend. Those moments came close to breaking him, but I believe it made him a stronger man," Jevtic stated.

Faison enlisted in the Army in 2014, the same year he married the former Dalissa Muñoz. Jevtic said, "He wanted to build a future he could be proud of, he wanted to know his family would always be taken care of. He would have given her the world if he could. His other motivation was our brother Nakia Mima, Bryan always wanted to make him proud and following in his footsteps was a big way to show him how much he admired him.'

His sister recalled that Faison took a job in a nursing home so his grandmother would never be alone and that he would drive almost two hours to pick one up if one's car broke down.

"Bryan was a protector. He would never let anything happen to anyone who was around him," said Jevtic.

"SSGT Faison did his job honorably and he will not be forgotten," Delamater remarked.

Faison is survived by his wife Dalissa Muñoz Faison and his children, Nalani, Aleia and Kainoa. He is also survived by his mother Sandra Faison; his father Micheal Faison; brother Nakia Mima and sister-in-law Nicole Mima; his sister

Not true, Zick said. Seipp and Layton have helped coordinate the needs to get and pick up equipment from other departments around the area. That includes turnout gear, ropes, pick axes, bottles to filled with air when they arrive in Ukraine, firefighting clothing, stretchers, burn sheets, and so much

"Our big thing is always safety, safety, safety, and we were just so upset to see on the news that these firefighters were going to fight fires in street clothes," Seipp said. "We have been so overwhelmed by the generosity. We went over to Millbrook just today and picked up two truckloads of equip-

The process hasn't been without its roadblocks, however.

For one, Zick said he is dealing directly with the community fire department in a small town in Ukraine.

"We just didn't want to start collecting things and send over there through government channels," he said. "Not that we don't trust their government, but there is a war on. We prefer to find a way to send it directly to the fire department (in Ukraine).'

But that has been one of the roadblocks. While Arnoff Moving and Storage graciously donated storage space to house all the equipment, Zick still has to figure out how to ship it to Ukraine. To that end, there will be a



fundraiser during Stanford Community Day on Sepember 17 to help defray expenses. Zick and Seipp said they hope to start shipping some items as soon as the end of summer.

### DCSPCA seeks donations to defray parvo treatment costs

Six puppies ill with the highly contagious and deadly parvo virus were recently brought to the Dutchess County SPCA (DCSPCA). Sadly, five succumbed to the disease; and the lone survivor, a sweet little guy named Marley, has been fighting for his life and receiving around-theclock care.

Expenses associated with treatment for all six puppies have totaled around \$14,000, with the cost of Marley's care alone exceeding \$5,300. Donations are at https://bit.ly/DCSPCA Marley

DCSPCA Executive Director Lynne Meloccaro was happy to report last week that Marley's condition has improved.

"Marley is recovering--we think he will pull through!" said Meloccaro. "Our team worked very hard to give him the care he needs and we are ecstatic about his improvement."

Photo taken on July 12, which accompanies this article, show a decidedly perkier Marley displaying typical puppy playfulness and curiosity.

On June 24, DCSPCA posted an alert on its Facebook page, warning that a man and a woman were reported selling puppies in public places in Dutchess and Ulster counties.

"The puppies are ill-many have died of parvo which is highly contagious," the alert stated. "These puppies are in need of urgent veterinary care, and should not be purchased."

An investigation by the DCSPCA is currently under way.

"Never purchase a puppy from a stranger in any public space. Anyone selling animals this way is not making money because they have invested in these puppies' care," the alert continued. "Puppies will frequently have been taken from their mother too soon, will often have genetic or contagious conditions, and have never received veterinary care. The cost of care these sick animals will require far outweighs the cheap purchase price.

DCSPCA reported that some of the sick puppies were brought to the shelter by distraught owners. Two of them were rescued from a pond where they had been dumped.

"We did all we could for them, but sadly they were too far gone to be saved," the organization posted on its Facebook page.

According to the Cornell University

College of Veterinary Medicine's website, Canine Parvo Virus (CPV) "most often strikes in pups between six and 20 weeks old, but older animals are sometimes also affected." The disease is devastating in its damage, first attacking the lymph nodes before entering the bloodstream, all the while rapidly dividing. As the disease progresses, it impacts many of the body's systems, particularly targeting gastrointestinal tract.

"CPV is not always fatal, but when it does kill, death is as a result of either dehydration and shock, along with the effects of septic toxins produced by the intestinal bacteria roaming throughout the

bloodstream," notes the Cornell website.

Since the late 1970s, a vaccine to prevent parvo has been a routine part of a dog's veterinary visits.

On July 12, Meloccaro said, "We know that the puppy sellers have been spotted at Woodbury Commons recently, and we have received some very helpful tips from the public. It's difficult because we have to establish the couple's identities and they are moving around across counties, but we are closing in.'

### DCC signs agreement to make process easier for students to transfer to SUNY New Paltz

Leaders from SUNY New Paltz and Dutchess Community College (DCC) recently met to sign an articulation agreement that will streamline the process for

DCC students to transfer to New Paltz. Among other benefits, qualified DCC students will have their SUNY New Paltz application fees waived and will benefit from direct outreach and advising from New Paltz Enrollment Management staff to ensure a smooth transfer process.

The program deepens the long-established partnership between DCC and New Paltz with new ways for staff from the two institutions to partner on initiatives and events related to advising, career services and student life. Together, these services provide a steppingstone for DCC students, including those who applied to New Paltz after high school but were not admitted, to succeed in earning their associate degree, transferring seamlessly, and graduating on time with a four-year

"SUNY New Paltz has a longstanding relationship with Dutchess Community College, and we work hard to support the students we share and serve," said President Donald P. Christian, whose signing of this agreement was one of his final official actions before his retirement in July. "Transfer students are a sizable and important part of the New Paltz campus community – about half of our graduates who cross the stage each year came to us as transfers – and as our largest source transfers annually,

Community College is a critical partner in serving these students well as they pursue two- and four-year degrees."

"I'm honored to enter Dutchess Community College into this new agreement, which will further benefit our students, their families and our communities at large," said DCC President Peter Grant Jordan. "Anything we can do to accelerate their journeys to career success, without sacrificing the quality of their education or adding needless cost – is an advantage for our students, our institutions and the industries and communities which they join upon graduating."

The agreement between the two institutions expands the robust set of perks that students already receive when they transfer from one SUNY institution to another. It further streamlines the credit transfer experience for DCC students, both for the SUNY General Education Requirement and for major requirements at New Paltz.

This program will be available to DCC students who maintain a minimum GPA of 2.5, who are on track to earn their associate degree, and who fully satisfy New Paltz's admissions criteria after their degree is awarded by DCC.

### Clean Path NY schedules Beacon meetings on July 28

Clean Path NY will hold an open house for Dutchess and Putnam Counties on Thursday July 28 in Beacon to invite input, solicit feedback and share important information with residents, businesses, and other community stakeholders on the Clean Path NY transmission line.

Clean Path NY is a collaborative clean energy project of NYPA, Invenergy and energyRe. Upon completion, Clean Path NY is estimated to reduce greenhouse gas emissions from the statewide electric sector by 20-22 percent every year and avoid 49 million tons of CO2 emissions through 2040. The project represents an \$11 billion in-state investment that will create an estimated 8,300 in-state jobs and catalyze \$4.7 billion of in-state economic develop-

Two sessions are scheduled at the Memorial Building, 413 Main Street in Beacon. Session 1 is from 9-11 a.m. and Session 2 is from 5-7 p.m.

Clean Path NY is comprised of a 175mile state-of-the-art underground/underwater transmission line that will transport energy from new in-state solar and wind power and New York Power Authority's (NYPA) existing Blenheim-Gilboa pumped storage facility, increasing the Blenheim-Gilboa reliability of the transmission system and helping transition New York State to a clean energy economy. Together, these assets will help drive a significant reduction in the use of oil and gas-fired fossil fuel plants, and advance New York's transition to a zero-emission electricity sector

Route planning and environmental work is underway on the Clean Path NY transmission line route from Delaware County, in New York's Southern Tier economic development region, through the Mid-Hudson region to New York City. The state planning process ensures that the transmission line will follow the most optimal route, taking into account potential community impact and environmental stewardship. In particular, Clean Path NY's route will be designed specifically to minimize potential impacts to the Hudson River. The transmission line will be sited entirely underground or underwater and primarily in existing NYPA and DOT rights of way already used by transmission lines and roads, limiting impact to surrounding communities and environments and ensuring the line is resilient in

extreme weather.

Clean Path NY also includes more than 20 wind and solar energy generation projects spread across New York. The geographic and technological diversity of Clean Path NY's wind and solar generation maximizes the resiliency and reliability of the energy supply. Each wind and solar project will be independently permitted to facilitate public review and engagement, and will follow its own public information schedule to be announced

at a later date.

The project team is committed to working with communities and other stakeholders at every stage of development and all along the project route to ensure that local voices are sought and heard, for the wellbeing of communities and the pro-

ject's surrounding ecosystem. To date, the project team has held more than 200 meetings and received more than 600 letters of support and comments from working New Yorkers, elected officials, industry leaders, and advocates across the state.

### 'Greatest Generation' veterans have amazing stories to share

Recently I was notified that another World War II veteran in Dutchess County had died. His name was Edwin Joba. We belonged to the same church for some time, but I really got to know Ed after I returned from my walk across America in 2019. He was such an enthusiastic supporter of my mission to raise awareness for our heroes. He wasn't a large man, and he seemed even smaller with his walking cane and stooped back. But even though he was in his 90s, Ed always had a smile on his face. He always wanted to hear my stories -- but like all our World War II veterans, I knew Ed had even more amazing stories of his own.

Ed's upcoming funeral service reminds me that we are losing the last of our heroes from the Greatest Generation. It makes me very sad to think there will come a day when we won't have any World War II veterans among us. That's why it's so important for us to cherish the remaining members of the Greatest Generation, each and every day. Imagine all the stories, the knowledge, and the history we will lose when there are no longer members of that generation in our communities.

When I joined the Poughkeepsie VFW, the very first member I spoke with at the Post was a World War II veteran. His name was Stu Vidal, and he told me the story of his service in the South Pacific as he watched the Enola Gay take off from the island of Tinian, bound for Japan carrying the atomic bomb. As he told me his incredible story, I realized you can't find this sense of history in any school textbook. These veterans of World War II are the textbooks themselves, and when they are gone, the stories are gone as well. This is why the young folks of today need to have conversations with our older veterans, to better understand the world they live in now.

Stu Vidal passed in March 2020 at the amazing age of 103 years old. He was a father figure and a friend to so many here in Dutchess County. He had such an impact on our community in so many ways, and it's sobering to think there will come a time when someone will ask, "Who was Stu Vidal?" Keeping these stories alive should be a top priority for all of us.

The term "The Greatest Generation" comes from a 1998 book by Tom Brokaw where he profiled members of the generation who grew up in the Great Depression and fought in World War II and Korea. I can't think of a better name for this amazing group who sacrificed so much and rose to

the challenge of defeating the Axis powers; when we say they saved the world, this is not an exaggeration. Subsequent generations have met their own challenges, of course, but it was the Greatest Generation who definitely set the bar, and set that bar high. We owe these folks so much!

As an aside, Frank Buckles was the last American veteran of World War I, and he died back in 2011 at the incredible age of 110. Once Mr. Buckles had passed, our entire connection to that part of our history was lost forever. I shudder to think what we will lose when the last American veteran of World War II passes on.

Whenever we have the opportunity to talk with the World War II veterans in our lives, we must take it. ### Wappinger at a Crossroad: Part IV

I hope that you are enjoying your summer. Unfortunately, for many, it has started off somewhat depressingly. As your Supervisor, I am very bothered by the growing challenges that worry so many of you. But, as an eternal optimist, I believe that we need not remain stuck in the false security of the past, and can move forward. Remember, 'history is past.'

The future stability and growth of the US economy faces a very high risk. Consequently, our local economy and lifestyles are increasingly in jeop-

- A growing consumer demand and product/material shortages are increasing the prices for food, housing, and energy, thereby crimping your incomes. Inflation has reached 9.1% with no end in sight. This "walking" inflation is escalating, I fear, not just to a "galloping inflation," but the more

dreaded "hyper-inflation" - A declining population of young families, resulting in many issues including declining student enrollment in the Wappingers Central School District, e.g., a vacancy of 120 students in Myers Corner Elementary School alone;

Accelerating, higher health-care costs (predictions are for health-care cost growth of 2% above the rate of inflation) are threatening our personal family's health and welfare; and

A collapsing supply chain adds additional frustrations and risks by limiting or denying most purchasing options, e.g., our mothers and special needs children who are unable to find the all-essential baby formula.

Economists predict a long recession. I also lose sleep over this impending economic slowdown because I, and our seniors, lived through the disastrous, rapid inflation/major recession of the 1970s. I remember my parents worrying about their inability to provide for our family. Then, in 1974, our first President Bush declared inflation as Public Enemy #1 with his "WIN" campaign ("Whip Inflation Now"). We must now take similar decisive action by thinking out of the box because:

Our seniors, veterans, and many residents suffer from little, if any, discretionary income with no hope for cheaper housing into which to move.

Our young folks cannot rely on future income gains off-setting the projected inflationary increases. How can they raise a family let alone eventually retire in a stagnant Town of Wappinger of potentially declining local business, absence of affordable housing, and potentially rising taxes?

You, our local consumers, have lost savings by spending hundreds of thousands of additional dollars on food and energy over the past 12 months. More, not fewer, buying options and stocked shelves would help shave 1.5 percentage points off local inflation in the coming months. Yet, we risk losing even more shelves during the months ahead.

= The lack of a vibrant younger local work force (number-wise) blocks local economic growth and hollows-out the availability of volunteers for first responder services. Without local opportunities for more meaningful and productive jobs, we will not keep our

youth at home, and we will not attract to Wappinger more young couples and families.

The temporary population growth of the past two years may dissipate. Why, because there is neither any new major economic redevelopment in Wappinger nor new affordable housing for our workforce residents \$35,000 incomes between \$100,000.





### Renegades win series finale with 'Walk-Off'

Still hot and now in first place.

The Hudson Valley Renegades scored their first walk-off win of the season on Saturday night at Dutchess Stadium, dispatching the Greenville Drive 5-4 in 10 innings. The win gave the Renegades a 13-7 mark to start the second half of the season. Aberdeen, which won the first half, stands at 11-10.

The victory came ahead of Sunday's rainout, giving Hudson Valley an extra day off as minor league baseball, just as in the Major Leagues, went into a four-day All-Star Break.

With runners on second and third and no outs in the bottom of the 10th, Eric Wagaman lined a walk-off single to rightcenter off Robert Kwiatkowski to score Aaron Palensky with the winning run.

The Renegades took the lead in the bottom of the first when Wagaman doubled off the wall in left to chase home MLB rehabber Ben Rortvedt. Cooper Bowman added a solo home run in the third off Tyler Uberstine and James Nelson scored in the fourth when Aldenis Sanchez was caught in a pickle between second and third.

T.J. Sikkema turned in another spectacular outing for the Renegades, allowing two runs on only one hit and one walk in a career-high 5.1 innings. The southpaw

struck out 10 batters, giving him double-digit strikeouts in back-to-back appearances.

Greenville rallied to tie the game with three runs in the top of the sixth, and the Drive took a 4-3 lead in the eighth on a Gilberto Jimenez RBI double.

Down to their final strike for two consecutive batters, the Renegades rallied to tie the game in the bottom of the ninth when Cody Scroggins walked three and uncorked a wild pitch to score Sanchez with the tying run.

In the bottom of the 10th, Palensky pinch-ran for Rortvedt as the automatic runner and advanced to third on a Seigler single, setting the stage for Wagaman's heroics.

Sunday's game between the Renegades and the Drive was the last scheduled game this season between the two teams this year and will not be made up.

# Starting the second half strong and working to fill the stadium

Every week, Hudson Valley Renegades President Steve Gliner sits down with reporter Rich Thomaselli to discuss the team in particular, and minor league baseball in general.

Well we're at the All-Star Break, or the unofficial midway point of the season. Can you assess how the first half of the season has gone for the Renegades, on and off the field?

I think it's gone really well so far. I think we've played really well so far, especially now that we're in the second half of the season. We're in first place and I think how they break up the year into two seasons really gives some teams a new life. In the first half, we had that one team in our division, Aberdeen, that really ran away with it. But that's the great thing about the re-start.

You've gone through this type of split season when you were down in Florida.

You played the first 66 games of the year and then the records went back to 0-0 about a month ago for the next set of 66 games. Can you really see that switch in players and teams even though there's no "time off," per se, between the first half and second half?

It really is like a re-set and the players know this. Plus, a lot of parent teams are making adjustments and moving players around, so it many cases it's a completely different roster in the second half. You could have a team that was under .500 in the first half who suddenly has a great team in the second half. So you never really know, and that's part of the nature of minor league baseball. It can go either way.

Do you feel like you've communicated that to the fans who have known nothing but a short-season Single A team for 25-plus years?

Yes, we have standings available at



guest services right away when you come in. A lot of people do pick that up and we put it in our video boards as well. And plus, we always have Zolz (public address announcer Rick Zolzer) saying things like 'Your first place Renegades!' So that always helps.

From the attendance reports, you're really filling Dutchess Stadium.

The crowds have been really good. Historically, now is the time – right after school ends, early summer – that people come to see us. I still think it's going to take another season or two before our fans fully realize that we're a long-season Class A team that starts playing in April now instead of the middle of June. I mean, think about it. We were a short-season team for 20-something years. We didn't have any season at all in 2020 due to COVID. We started more than a month later than we would have, in May, last year because of COVID. So it kind of threw everybody off. Our goal coming out of June was to see the kinds of crowds that we traditionally have seen in our existence here, and I believe we are.

# Neurosurgeons perform first fluorescence-guided surgery for glioblastoma at Vassar Brothers Medical Center

Neurosurgeons Dr. David Penn and Dr. Adesh Tandon were the first to use an innovative technology to treat glioblastomas at Vassar Brothers Medical Center. At this time, Vassar Brothers Medical Center is the only hospital offering the neurosurgery technology in Dutchess County, New York. The fluorescence-guided surgery enables neurosurgeons to better visualize cancerous brain tumors, remove them more completely and improve patient outcomes.

Glioblastoma is an aggressive, fast growing type of brain cancer that does not have a cure. Glioblastoma is difficult to surgically remove because the tumor tissue invades the brain and looks similar to healthy tissue.

Glioblastoma surgery is also complex because removing too much brain tissue can greatly affect someone's neurological abilities; depending on the location of the tumor, it can affect cognitive function, eyesight, speech and mobility.

The fluorescence technology lights up the tumor tissue and clearly differentiates it from healthy tissue. Neurosurgeons can simultaneously stay in the safe resection zone while removing as much of the cancer as possible.

The median length of survival for someone with glioblastoma receiving standard of care treatment is 15 to 16

months. Surgery, chemotherapy and radiation therapy may help manage someone's symptoms and extend their life as much as possible. The more cancer that is removed through fluorescence-guided surgery, the greater chance of increasing the survival rate.

At Vassar Brothers Medical Center, neurosurgeons evaluate patients with glioblastomas to determine if fluorescence-guided surgery is right for them depending on the location and size of the tumor.

Patients are admitted to the hospital and ingest a solution three hours before surgery. Patients need to stay in the dark for 48 hours after ingesting the solution because one of the side effects is extreme skin sensitivity to UV light.

"The first fluorescence-guided surgery for glioblastoma could not have gone better. Kudos to our multispecialty teams for making an intricate process seamless," said Dr. Tandon, director of brain tumors at Vassar Brothers Medical Center. "The intensive care unit and transport teams kept the patient in the dark and covered until they were in the operating room. Then, the operating room team prepared in the dark and we operated in a low-light room."

"The first patient's tumor was in the part of their brain that controls facial

movement and speech. Without the fluorescence technology, we may not have been able to resect as much of the cancer without causing a problem to their facial function or ability to speak," said Dr. Penn

"The patient was able to go home from the hospital two days after surgery and they are doing well," said Dr. Tandon.

In addition to multispecialty care, patients have surgery and recover in the new, ultramodern Patient Pavilion at Vassar Brothers Medical Center.

Nuvance Health neurosurgeons are also

performing fluorescence-guided surgery for glioblastoma at Danbury Hospital in Connecticut.

While glioblastomas or GBMs are rare, they are the most common primary brain cancer. Symptoms vary depending on the size of the tumor and where it is located in the brain; common symptoms include headaches, seizures, nausea/vomiting, memory problems and declining normal function.



## Applications for new round of Learn, Play, Create grants now being accepted

in grant awards through the first round of more than \$362,000 in LPC awards in its 2022 Learn, Play, Create: Supporting early June, followed by more than Our Kids grant program last month, \$328,000 in awards later that month. Dutchess County is accepting applications for the second round of the 2022 program, which offers one-time grants awards to local non-profit organizations that serve children and families and were deprived of a year of fundraising or participation due to the COVID-19 pandemic. To be eligible for this second round of awards, organizations will need to demonstrate how their use of funds meets one or more domains of the County's Path to Promise, which ensures every child has access to the resources necessary to become successful young adults.

County Executive Marc Molinaro announced the Learn, Play, Create (LPC) grant program in June 2021 as part of his initiative to direct \$57 million in one-time funding allocated to Dutchess County through the Federal Government's American Rescue Plan (ARP) to areas the community has recognized as priorities; 147 projects received LPC funding in 2021. In the 2022 county budget, the County Legislature approved \$1 million in LPC grants, to be awarded in two

After announcing more than \$690,000 rounds; the County Executive announced

Approximately \$346,000 in LPC grants is available in this second round, with grants between \$2,500 and \$20,000 available to non-profit youth organizations that directly serve children, including teenagers and families and promote learning, arts enrichment and sports engagement. Application instructions and guidance will be available on the County's website, and applications can be submitted through an online portal thta began July 6.

Molinaro said, "Over the past year, countless children have benefited from the projects funded through Dutchess County's Learn, Play, Create program. This next round of LPC awards will positively impact even more local kids through our innovative Path to Promise, ensuring the projects funded will provide the critical assets young people will need to thrive along their journey to adulthood. Dutchess County is proud to advocate for our children and give them the best opportunity to thrive while fostering their development."

Dutchess County's Path To Promise focuses on six areas that encompass the major elements of a child's growth process, referred to as domains. These six

- Learning acquiring knowledge leading to the success of students in future college and career aspirations;
- Material Basics providing for the basic needs of youth and families, including housing support and food;
- Safety the feeling of being protected from danger, risk, or injury;
- Family/Social Relationships having pro-social bonds with family, peers, and other adults providing opportunities for emotional and spiritual growth and support;
- Mental Health opportunities to develop or support positive psychological and emotional well-being, including enrichment and leadership, and pro-social growth opportunities; and
- Physical Health ensuring access to quality health care, opportunities for positive body growth and development, as well as access to appropriate and quality responses to cases in which children get sick or hurt.

Examples of possible funding awards for this second round of 2022 LPC awards

· A tutoring program to help middle-

school students from low-income families in literacy, math, and science;

- Supplies for a youth mentoring program to foster positive adult and peer relationships;
- Instructions/lessons on how to care for and ride horses for youth living with mental illness
- Winter coats and/or food supplies for children in need:
- Supplies for an anti-bullying service or program in local schools;
- · A skills clinic for player development at no cost for participants; and
- Materials and/or supplies for an organization to market a "pop-up" educational event/program, such as back-toschool preparation or new skill development, such as computer coding.

Applications for this second round will be accepted through Aug. 4th at 4 p.m., and awards will be announced in autumn 2022; funding should be utilized within one year of the award. Neither organizations which received previous LPC funding nor school districts, private and religious schools including school-funded clubs and/or programs - and municipal-funded/sponsored departments or clubs are eligible for this round of LPC funding.

# Belongalong experience comes to Locust Grove in Poughkeepsie


Blue Man Group veteran to illustrate musical wooden boxes

Locust Grove's over 100-year-old historic majestic Maples, Beeches and Black Locust Trees will watch over the immersive Blongalong experience with Christopher Bowen on Sunday, July 24 from 1-3 p.m.

Locust Grove, the former summer home of Morse code inventor Samuel Morse, is a nature center, museum, education center and wedding/event venue located at 2683 South Road in Poughkeepsie.

Belongalong is a 12-person musical "instrument" created by musician, composer, performer and 30-year Blue Man Group veteran Christopher Bowen. He said Belongalong is 12 "wooden resonating boxes like blank canvases of sound, specially designed to give voice when held close to the participants' bodies. Invisibly connected and fully portable, they enable participants to engage through space in collaborative expression with each other and the environment."

As each person opens and closes their Belongalong box and brings it closer and further away from their chests, the sounds get louder and softer and changes. According to Bowen at Belongalong.com, "Belongalong...invites collaborative music-making and an expansion of the senses by connecting through sounds, images, and space. Belongalong is an experience that is as much about listening and opening up sonic space for others as it is about one's own expression"

# Talking turkey (burgers)

### A lighter version of the beefy classic

As summer and its heat continues so, too, does my desire to keep eating light. Last time I shared some favorite salad ideas, which I hope some of you tried. This time around I'm keeping it light even though I'm adding meat to the equation.

This recipe was inspired by something I had at a restaurant back in the '80s when I lived in Florida, and my take on it is something I eat pretty regularly. For me it just hits all the right marks; it's not too filling, yet satisfies. It's fresh and tasty. I love it and enjoy it year-round, but it's perfect for a summer dinner when a salad isn't quite enough.

A lighter version of the beloved burger, this one features ground turkey. Using ground dark meat keeps it from being dry, as does how you dress it. The way it was served at the restaurant was sans bun and so that's how I like it, though feel free to add bread if you prefer. Me, I tuck in with knife and fork.

Like so much of the summer fare I crave, it has few ingredients, so you taste everything in just the right balance. I can no longer remember the exact restaurant version – it's been decades and I've been making it this way for so long - but the gist is here: ground turkey, shredded lettuce, ripe tomato (which I forego if

they're not in season), cheese and ranch dressing. Other than salt and pepper, that's it. Quick, simple and simply delicious. Their version may well have added something to their turkey, but I keep it pure and simple. I pile the lettuce high, letting it spill onto the plate. It's more like a salad that way. And while you can, and I have, used a more nutritious lettuce than iceberg, this version makes it really light and brings me back to those balmy Florida nights.

### **JESSE BURGERS**

If you couldn't guess, the restaurant was called Jesse's; and living in Florida's heat for two years meant that I pretty much adopted my summer eating habits for all of that time. The restaurant has long since closed, but I will forever be grateful for inspiring this recipe.

### **INGREDIENTS**

1.5 lbs ground turkey, dark meat or a blend of white and dark

Shredded iceberg lettuce (about 3/4 head for 4 - I like to pile it on!)

4 slices large ripe tomato

Salt and pepper to taste

4 slices Swiss or muenster cheese

Ranch dressing (Thousand Island is good too)

### **METHOD**

Preheat oven to 350 degrees with oven rack positioned in the middle.

Form 2-4 patties of ground turkey and press the middles to make a slight depression, which prevents them from puffing up too much while they cook. (Ground turkey is pretty sticky, so it might help to rub a little olive oil onto your hands before you make the patties.) Season with salt and pepper.

Heat a cast iron skillet over mediumhigh heat for about 3 minutes. Add about 1 tablespoon of olive oil and swirl to coat the bottom of the skillet.

Lower heat to medium, place patties in skillet and cook undisturbed until juices start to pool on the top and bottom starts browning, 3-4 minutes. Flip and continue to cook another 3 minutes.

Transfer skillet to the preheated oven and cook about 7 minutes. Turn off oven. Add a slice of cheese to each burger and place skillet back in the oven just until cheese melts, 1 minute or less.

Transfer burgers to plates. Top each with a slice of tomato and a drizzle of Ranch dressing. Top with a mound of shredded lettuce and drizzle with more dressing. Serve immediately.

Makes 4 burgers

Before you ask, I've never tried these

on the grill. Turkey burgers aren't quite as rugged as their beefy counterparts, and my fear is I'll lose one through the grate. Probably unfounded, but then there's the idea of finishing them in the oven, which I like since it assures they're cooked thoroughly. Still, grilling would add a subtle smoky flavor, so I may have to give that a try someday.

Until then I'll keep loving them just the way I make them now, relishing their easy balance and lightness while fondly remembering those long ago days and nights spent in a never ending summer. Simpler times, my friends. SO much simpler! But then, that's what summertime is supposed to be all about. Enjoy!





# A tale of two gardens

Shakespeare is the inspiration behind both, but they're different as chalk and cheese.

News flash – there are two Huntington Gardens in southern California. Sue and I found that out the hard way. On a quick trip to Los Angeles for a wedding, we had a morning to spare. Naturally, a visit to the world famous Huntington Gardens was in order. After an hour-long journey south of Long Beach, Sue's phone announced "The destination is on your right. Arrived." We looked around.

Huntington Gardens apartment complex isn't even well landscaped. Turns out we should have punched in "The Huntington Library, Art Museum and Botanical Gardens." So off we went, back up I605 in the HOV lane. By the time we got to the "real" Huntington Gardens just east of Pasadena, we had just enough time to visit their Shakespeare Garden.

"That which we call a rose/by any other name would smell as sweet." William Shakespeare's famous quote is perhaps the best known of his dozens of floral and herbal references from his plays and sonnets. The point of a Shakespeare garden is to feature living examples of his verbiage, usually accompanied by placards explaining the quote:

• Holly – "heigh-ho, the holly! This life is most jolly." From "As You Like It," though not as familiar as the quotable "All the World's a Stage, and all the men and women merely players."

women merely players."

• Fern – "We have the receipt of fern seed. We walk invisible." From "Henry IV." Since ferns do not produce seed, what was Shakespeare getting at? Sue points out that it might involve humility.

• Grape - "The tartness of his face sours ripe grapes." From "Coriolanus." One of Shakespeare's oft-quoted insults. My favorite is "Thou cream-faced loon! Where gots't thou that goose look?" – Macbeth.

• Fruit – "The count is...civil as an orange, and something of that jealous complexion." This quote from "Much

Ado About Nothing" (the title itself is a popular quote) references the bitter orange trees that grew in England during Shakespeare's era, but were killed by the winter freeze of 1739.

• Weeds – "Fie on't, fie! Tis an unweeded garden that grows to seed; things rank and gross in nature." A sign at Huntington Gardens held this quote from Hamlet. The surrounding patch of weeds may or may not have been planted on purpose.

• Daisies, violets, pansies, rosemary – Ophelia's mad scene in "Hamlet" is a cascade of flower quotes and meanings, as the doomed heroine picks apart her bouquet: "rosemary for remembrance," "pansies for thoughts," "There's a daisy. I would give you some violets, but they withered all when my father died."

• And of course, Roses – "What's in a name? That which we call a rose/by any other name would smell as sweet," says Juliet to Romeo: It doesn't matter if her lover is from a rival family. One of 70 rose references in Shakespeare's plays and sonnets, including "Of all flowers methinks a rose best." from "The Two Noble Kinsmen."

Back home we visited the refurbished "Shakespeare Garden" at Vassar College, down behind Olmstead Hall. What's in a name, indeed. The garden itself doesn't seem to have much to do with Shakespeare. No signs with quotes; the varieties are not labeled, nor are the three statues of medieval-looking characters. We saw some daisies, lavender (referenced in "A Winter's Tale") and a few roses. The garden is quite lovely, though. A garden by any other name....

programs WVA has taken on is the Hometown Heroes Project, where now Town residents can see in all major roads.



# New Yorkers can sign up for monkeypox information texts

Gov. Kathy Hochul announced on July 14 a new SMS-text notification effort to deliver the latest monkeypox information directly to New Yorkers, this is the newest component of New York State's ongoing monkeypox response.

New Yorkers can sign up for text messages—which will include alerts about cases, symptoms, spread, and resources for testing and vaccination—by texting "MONKEYPOX" to 81336 or "MON-KEYPOXESP" for texts in Spanish. By providing a zip code, New Yorkers can also opt-in for location-based messages.

"We are building on our ongoing response efforts to bring the latest monkeypox information, tools and resources directly to New Yorkers," said Hochul. "As we continue to work with the federal government to press for more vaccines, I urge New Yorkers to sign-up for these important alerts and stay informed with monkeypox updates in your community."

The new SMS campaign is designed to alert New Yorkers to pertinent information about monkeypox, so they have protective public health facts and resources at their disposal. Messages will span information about how monkeypox presents and transmits, as well as what New

the text message campaign will be broadly distributed through social media, constituent engagement, community-based organizations, and the State's Excelsior Pass platform.

State Health Commissioner Dr. Mary T. Bassett said, "In public health, information is one of our most valuable tools. This innovative campaign, which provides texts in both English and Spanish, will help get education and resources directly to New Yorkers - expanding access to updates about monkeypox and availability of vaccines and care. I encourage everyone to sign-up for these alerts, and to stay up to date about the best ways we can all protect ourselves and mitigate spread in our communities.'

New York State continues to work closely with the Centers for Disease Control and Prevention's Monkeypox Response Team on vaccine distribution plans to ensure New York State receives its fair share of vaccine supply as soon they are available to protect New Yorkers, especially for those New Yorkers in communities with high transmission rates. Governor Hochul recently spoke with Dr. Ashish Jha and Dr. Raj Panjabi of the White House to secure additional vaccine doses to meet the needs of New Yorkers.

the New York State Department of Health (NYSDOH)'s ongoing public outreach on monkeypox, including efforts recently launching a paid, digital advertising campaign to get information to communities experiencing higher rates of monkeypox cases, including gay and bisexual men and other men who have sex with men.

NYSDOH's dedicated website, which stays updated with the latest information, has free, downloadable materials including a palm card, information card, handout, and posters available in both English and Spanish. NYSDOH has already distributed these resources to LGBTQ+ organizations, local county health departments, healthcare providers, and businesses. The posters will be on display at congregate settings statewide, including healthcare centers, mass transit hubs, parks, rest stops, restaurants, bars, and nightclubs.

In addition to public outreach, the New York State Department of Health continues to focus on distributing vaccines to communities. On July 12, NYSDOH announced its second allocation of the JYNNEOS vaccine from the federal government. This supply remains limited and New York State has been aggressively working with the federal government to

convey that more supply is urgently needed to meet the preventive needs for New York residents. Local county health departments that have received supply are administering the vaccine directly and establishing their own appointment processes. Working in partnership with counties, New Yorkers who sign-up for location-based alerts may receive alerts on vaccine availability, clinic locations, scheduling, and other monkeypox-related updates specific to their area.

NYSDOH, in partnership with the New York City Department of Health and Mental Hygiene (NYCDOHMH), recently hosted a Monkeypox Town Hall for community leaders led by State Health Commissioner Dr. Mary T. Bassett and City Health Commissioner Dr. Ashwin Vasan. New York City and other local municipalities have set up their own alert systems, and local residents should follow those updates as well. Working in partnership with community organizations and advocates, NYSDOH remains committed to continuing its outreach and maintaining a direct dialogue with New Yorkers, especially those most impacted by the current
