County honors East Fishkill Vietnam veteran posthumously

The late U.S. Navy Petty Officer Paul Davidson was honored posthumously during Dutchess County's latest "Honor-A-Veteran" Ceremony held at the Knights of Columbus St. Mary's Council #4065 in East Fishkill. The former East Fishkill resident was recognized on Thursday, July 17. During the ceremony, Davidson's family was presented with numerous awards and proclamations for his legacy of military service and volunteer work.

"This was amazing," Davidson's widow, Susan Davidson, said after the

ceremony. "I kept looking at his picture."

She said, "Paul would have been very humbled by it. Me – I'm bursting at the seams."

Paul was born to Jack and Elizabeth Davidson on July 23, 1948, in the Bronx. During the Vietnam War, it was stated, Davidson served on the destroyer, USS Robert H. McCard and then joined Operation Game Warden, Task Force 117 on a Patrol Boat River (PBR). There, from 1967-'68, he patrolled the Mekong Delta. He earned three Bronze Star Medals and the Presidential Unit Citation.

Masterson began her first night of "Taps," most evenings playing at the

Veterans of Foreign War Post 5913 in Wappingers Falls, on May 27.

"This nightly salute is leading up to ...August 14th—commemorating the day President Truman announced the end of WWII. It's also the 80th anniversary of that historic moment, which is why we're honoring it with 80 nights of remembrance," explained Masterson.

County honors East Fishkill Vietnam veteran posthumously

Davidson was a New York City cab driver, employed by Penn Central, and then a freight conductor for Conrail.

"It's great the families speak up and tell their stories so young people can hear them," said County Executive Sue Serino.

Davidson began the Disabled American Veterans (DAV) Transportation Program at Castle Point VA Medical Center campus in 1994. Three years later, he was awarded the DAV's national George H. Seal Memorial Award Honorable Mention for his service to veterans. He was also honored by being named Castle Point's Volunteer-of-the-Year.

"It's not just what Paul did, but how he lived," Serino told those gathered at the ceremony. "He stepped up," she said.

Davidson was a member of the Color Guard at the Veterans of Foreign Wars (VFW) Post 5913 in Wappingers Falls. He served as adjutant of the Beacon VFW Pvt. William B. Wilson Post 666.

Davidson was also a local volunteer. He gave his time by driving seniors to medical appointments for Friends of Seniors. He also volunteered his time as an Emergency Response Vehicle (ERV) driver for the local American Red Cross.

NYS Senator Rob Rolison (Senate District 39) said he met Davidson at the American Red Cross. "He didn't talk about his time in Vietnam. We talked about his time as an engineer for the railroad," stated Rolison.

Rolison presented Davidson's family with The New York State Liberty Medal, in honor of the Navy veteran.

"Paul's unwavering commitment to the people of our region, through his selfless volunteerism and dedication to improving the lives of others, epitomizes what the

Liberty Medal stands for," said Rolison during the ceremony. "When I worked with the Red Cross, Paul was one of our most dedicated volunteers and someone I counted as a friend. I was never aware of his distinguished military service because, like so many veterans, he didn't speak of it. It was a special privilege to recognize him today—not just for his quiet service to our country, but for the lasting difference he's made in our community."

NYS Assemblyman Anil Beepan Jr. said Davidson helped others "who serve us."

East Fishkill Town Supervisor Nick D'Alessandro said, "This is a wonderful event," and "we have to honor veterans for all they do."


Dutchess County Chairman Will Truitt, along with legislators Steve Caswell, Tony D'Aquanni, Rob Faust, Lynne Versaci, Wappinger Town Supervisor Joseph Cavaccini, Town of Fishkill Councilman John Forman and Dutchess County Court Judge Edward McLoughlin, were in attendance.

"When you look at what Paul went through, losing his friends and comrades, it's unimaginable," Truitt stated during his remarks. Davidson is "a hero," he said.

Dutchess County Office of Veterans Affairs Director Adam Roche remarked Davidson "returned home carrying invisible scars" but he showed "immense courage" and became "a beacon of hope" for others.

Members of the Dutchess County Honor-A-Veteran Committee, along with Serino and Roche, presented Davidson's family with a:

- U.S. flag flown in Dutchess County for 30 days in his memory;
- proclamations;
- Veterans Challenge Coin from the Dutchess County Honor-A-Veteran Committee;

Local resident Dani Masterson played "Taps" to honor Davidson.

Serino began the monthly series to recognize the lives and services of local veterans who have died. The inaugural ceremony was held earlier this year in April.

According to County officials, monthly "Honor-A-Veteran" ceremonies will continue through November. It was noted that future ceremonies will take place at 9 a.m.

on or about the third Thursday of each month.

The resolution regarding "Spirit of '45 Day" was passed by Congress in 2010. The resolution states: "Whereas on August 14, 1945, the people of the United States received word of the end of World War II; Whereas on that day, people in the United States and around the world greeted the news of the Allies' noble victory with joy-

ous celebration, humility, and spiritual reflection." It continues, "...the victory marked the culmination of an unprecedented national effort that defeated the forces of aggression, brought freedom to subjugated nations, and ended the horrors of the Holocaust..." It is noted, "Whereas more than 400,000 Americans gave their lives in service to their country during World War II."

Background on speakers

Jed Sunden

Previously, Jed was the founder of KP Media. The company was launched with the Kyiv Post when he was 24 years old in 1995. KP Media then grew into one of the leading magazine publishers and the largest consumer-facing internet company in Ukraine. Jed was involved in numerous political reform

projects focused on free press, anti-corruption and freedom of religion. Jed served as VP of the Jewish community of Kyiv under Chief Rabbi Bleich.

His presentation will focus on "Why the War in Ukraine still matters to America, the unabated horrors inflicted upon her people by Russia, and the work of the American-Ukraine PAC to support pro-Ukraine Democratic and Republican members of Congress to solidify the U.S.-Ukraine relationship."

Maria Genkin

Born and raised in Lviv, Maria moved to the U.S. to attend Cornell University. Maria started her professional career at Goldman Sachs where she worked in project and program management for the Investment Banking Division. She joined Razom as a board member in 2020. Maria established and led Razom's development team that grew into a Razom Relief program.

Romain Frugé

A veteran of Broadway, he created the role of Ethan Girard in the original Broadway production of "The Full Monty" and in the subsequent production on the West End in London. He played the title role in Floyd Collins at The Old Globe (San Diego), Goodman (Chicago), Prince (Phila.) and in Playwrights Horizons 2003 revival.

Mike Topp

women of the World War II generation who "created an array of organizations and institutions during the postwar era which helped to strengthen American democracy by promoting civic engagement, volunteerism, and service to community and country."

It also mentions that the members of the WWII generation "have inspired subsequent generations in the United States Armed Forces...[and] military and civilian alike, has provided a model of unity and community that serves as a source of inspiration for current and future generations of Americans to come together to work for the continued betterment of the United States and the world."

"We're getting people from all over. A former village resident, who lives in Texas now, stopped" one night, said Masterson. "She loved it," noted Masterson. There were also the two veterans who traveled from Ohio to hear "Taps" played in Wappingers Falls.

"Sounding "Taps" is the last nicest thing you can do for someone," stated Masterson.

One can see photos and the schedule, which is posted on Sundays with locations for that week, on Facebook at "Dani Masterson – 80 Nights of TAPS."

"It's been outstanding. As a valued member of the Auxiliary, Dani is breathing back life into a place that was

once very active," Virgil Capollari, VFW Post 5913 Sr. Vice Commander, said, about how Masterson's playing is also affecting the Post.

Cyndee Butler, president of the Auxiliary and widow of a Vietnam War-era veteran, said, "I love this" about the 80 nights of "Taps."

Also in attendance was Janice Dimock and dog, Bear. Masterson said Dimock had been in attendance, so far, 21 of the 49 nights.

Dimock explained her nephew, SPC Joseph "Joey" Dimock II, was Killed in Action in Afghanistan on July 10, 2010. Dimock was a 21-year-old Army Ranger who also served Iraq. He was from Wildwood, Ill.

According to the Associated Press, Dimock, was killed in "Salerno, Afghanistan, in a non-combat explosion at an ammunition holding facility during an inventory" and was assigned to Hunter Army Airfield in Georgia.

"The thing is, the military, they do so much for us," Dimock stated. If Dimock and Bear, can make it, they will go to the nightly playing of "Taps."

"Take a moment to appreciate all the work that has gone into holding this," said Capollari.

Hochul releases 'Master Plan for Aging' final report

Gov. Kathy Hochul recently released the final report for New York's first-ever Master Plan for Aging (MPA). The MPA Final Report contains more than 100 proposals directed toward all levels of government, the social sector and private enterprise, all with the aim of helping individuals age with dignity, independence and the support they need and deserve to thrive.

"Every New Yorker should be able to age with dignity and independence," Hochul said. "The Master Plan for Aging builds on our ongoing efforts to empower older adults and advance New York's status as an age-friendly state. I thank the hundreds of stakeholders, state agency staff and partners who worked to develop these proposals and look forward to reviewing the report."

The report's release was accompanied by a newly unveiled MPA website featuring the complete report and a sortable library of its 100-plus proposals, available in multiple languages at <https://planforaging.ny.gov/>.

The MPA advances goals outlined in the Governor's 2022 State of the State Address and Fiscal Year (FY) 2023 Executive Budget. It was formally established by Executive Order No. 23, signed in November 2022.

The Master Plan for Aging, led by the New York State Department of Health, the New York State Office for the Aging, and the New York State Department of State is the product of a collaborative effort with dozens of stakeholders inside and outside

of government.

New York has the fourth-largest population of older adults in the U.S., with 3.2 million individuals – about 16 percent of the population – over age 65. The state's population of those over the age of 60 is projected to grow to 5.3 million by 2030, with those over 80 years of age exceeding 1.2 million – growing faster than any other age group in some areas of the state. By 2030, older adults will make up 25 to 30 percent of the population in most New York counties.

New York State Department of Health Commissioner Dr. James McDonald said, "The Master Plan for Aging was created by New Yorkers, for New Yorkers, so we can age successfully and independently – on our terms – right here in New York."

New York State Office for the Aging Director Greg Olsen said, "The final Master Plan for Aging is a true triumph of collective problem-solving. Under the vision of Governor Hochul, the MPA has brought together hundreds of the brightest and most accomplished minds from diverse fields and sectors – all contributing their talent to create this historic roadmap for an age-friendly New York. The Master Plan for Aging outlines over 100 proposals, each holding the promise to make a real difference in the lives of individuals as they age. Just as importantly, this document assesses the potential challenges, opportunities and pathways for action on each proposal, making it both visionary and practical. I applaud Governor Hochul, our state agency part-

ners, the stakeholders and the public for their contributions to this historic outcome for older adults in New York State."

Nine 'pillars' cited in report

Hundreds of stakeholders participated in a process of MPA workgroups to develop the MPA Final Report proposals. Organized into eight subcommittees and over 34 workgroups, the stakeholders coalesced around nine overarching pillars, which were:

- Affordability of Basic Necessities
- Informal Caregiver and Workforce Support and Modernization of Community-Based Aging Network Service
- Modernization and Financial Sustainability of Healthcare, Residential Facilities and Community-Based Aging Network Service Providers
- Prevention, Wellness Promotion and Access
- Housing Access and Community Development
- Access to Services in and Engagement with Historically Underserved Communities
- Social Engagement of Older Adults
- Combatting Elder Abuse, Ageism, Ableism and Stigma
- Technology Access and Development

The 100-plus proposals presented in the MPA Final Report explore multiple approaches that address the built environment and infrastructure, transportation and transit, financing of care and services,

recruitment and retention of the long term care workforce, licensing and training, pilot initiatives that can bring together providers and community services, innovations in care and service delivery, public-private partnerships, and many more.

The MPA process is already having an impact. The FY 2026 Enacted State Budget includes \$45 million in additional funds to expand community-based aging services offered through area Agencies on Aging — a critical priority identified by the MPA. This funding will help to reduce waiting lists for services such as home-delivered meals, assistance from personal care aides for activities of daily living, transportation assistance, home adaptations, case management to assist with person-centered resources, and other community-based supports. Going forward, the MPA provides a range of strategies for state agencies, the Legislature, stakeholders and partners to consider as New York pursues policies, programs and collaborations that will benefit older adults and their families.

The MPA Final Report builds on the MPA Preliminary Report issued in August of 2023 and Interim Report issued in October of 2024.

The MPA Council, which is made up of New York State executive agencies, will continue to engage stakeholders from groups and communities across the State and coordinate efforts across state agencies to ensure that policy and programs supporting New York's aging population are moving forward.

Beephan opposes NYSEG's proposed utility rate hikes, calls on PSC to reject increases

Assemblyman Anil Beephan Jr. (R,C-East Fishkill) is strongly opposing New York State Electric and Gas Corporation's (NYSEG) proposed delivery rate increases for electricity and natural gas. In a formal letter submitted to the New York State Public Service Commission (PSC), Beephan called the proposed hikes "unacceptable" and urged the Commission to reject them.

NYSEG has filed Rate Case 25-E-0375, seeking to increase electric delivery rates by 23.7% and natural gas delivery rates by 33.5%, raising the average residential customer's bill by more than \$66 per month combined.

"These are not minor adjustments—this is a significant and painful increase on families, seniors, and small businesses

who are already feeling the weight of inflation and rising costs across the board," said Assemblyman Beephan. "This proposal is completely out of step with the economic realities facing my constituents."

NYSEG has cited the need to modernize aging infrastructure, expand capacity for new business, and meet state mandates. However, Beephan emphasized that any upgrades must not come at the expense of ratepayers.

"At a time when so many New Yorkers are trying to make ends meet, this kind of rate hike is not only unfair—it's unacceptable. I urge the PSC to reject this proposal and demand alternatives that protect the people we serve." Beephan wrote in his letter to the PSC.

Keating improves command to lower earned run average

Hailing from Omaha, Nebraska, corn-fed Matt Keating has been solid for the stellar bullpen this season. Keating enters 2025 with 40 High-A games under his belt, one of 10 returning pitchers to the Hudson Valley Lineup.

Often brought into assuage a bases-loaded jam or a couple runners on, Keating is a core relief pitcher, though he's built like a football player and once swiped bases like a shortstop.

In his native Nebraska, Keating found success at Lincoln's Southeast Community College (SCC) as a first-year player. He received National Junior College Athletic Association (NJCAA) All-American accolades as a hitter first, with a few pitching appearances.

A successful two-way player, Keating dominated on the mound for SCC. After a shortened 2020 season, Keating returned for his first full collegiate season. He received national attention, being named a NJCAA All-American with his offensive prowess. He stole 27 bases, hit .404, and drove in 62 runs, plus launched 19 home runs for the Storm.

That season, SCC was 24-6 in its conference, with a 25-3 home record. Keating still likes the home cooking, as he has walked just one batter at Heritage Financial Park compared to 13 in away games. His 2.31 earned run average is

nearly one full run lower at home, and Keating had a near-immaculate month of June. Keating fanned 13 in seven appearances, with an ERA of 1.64 over 11 innings.

With his second-year transfer to University of Southern California (USC) came increased focus on Keating's arm. Fewer plate appearances, more reps on the mound. He spent one year in the gold and cardinal. Keating fanned 44 batters for a 13.2 strikeout per 9 inning rate, the program's top of the season. He intended to transfer to the University of North Carolina after the 2022 season, but the Yankees scooped him in the ninth round, making him the 280th overall pick.

The righthander made a massive leap from 2023 to 2024, dropping batting average against (BAA) from .240 to .181 in 40 appearances. Ahead of the 2025 season, Keating added speed on the fastball, adjusting all four pitches in his arsenal. His curveball is liable to fool hitters, and his command improved on the splitter and slider. In 2025, hitters are sitting around .200 against Keating, with just one home run in 29.2 innings.

As the only Trojan selected by the Yankees in 2022, Keating looks to become the most successful USC draft pick in over a decade.

Renegades alums shine bright on the Major League level



The Hudson Valley Renegades have reached the All-Star Break, in the hunt for the second-half title. True to minor league methods, the team is playing a vastly different lineup from the Opening Day roster. Since becoming a Yankees affiliate in 2022, former Renegades have starred under the bright lights of the Bronx and beyond. Some earned a regular roster spot this season, or earned call-ups in the wake of injuries. Others have inherited a premature comparison to legends of the game.

Six straight days without Renegades baseball? What a fine time to check up on some former Hudson Valley heroes!

The New York Yankees feature five former Renegades on the regular roster, plus a few key bench players. Austin Wells, the 28th pick in the 2020 draft, wears the same number across his back as New York's everyday catcher. Homegrown shortstop Anthony Volpe holds the highest career slugging percentage (.587) in Hudson Valley history. After the Yankees' slide of June and July, Volpe was the topic of heavy conversation – is this 24-year-old a bust, or on the cusp of blooming? In the Yankees' return from the All-Star Break, Volpe had a career night on July 19, with two home runs and four RBI to help mount New York's 7-run comeback against the Atlanta Braves. While Volpe continues to make milestones, including his first career multi-homer game, his go-ahead Game 4 grand slam stands as New York's lone highlight of the 2024 World Series.

Viva El Marciano, Renegades alum of 2023! The Martian, Jasson Domínguez, touched down for good in the Yankees clubhouse, with key offensive contributions at the plate and in the outfield. The switch-hitting Domínguez saw early offensive struggles, but is showing improvement from the right side. Yankees fans continue to marvel at his silky lefty swing and propensity to take right-handed pitchers to the moon.

Some former Renegades are fan favorites in rival farm systems, like Carlos Nárvaez. The Boston Red Sox acquired the hard-swinging backup catcher for flamethrower RHP Elmer Rodriguez-Cruz this past December. Much like Renegades fans cheer the fortune that brought E.R.C. to the Valley, Red Sox Nation is pleased to have Nárvaez defending their home plate.

Other prospects have punched a ticket to this year's MiLB playoffs. Former first-round LHP TJ Sikkema was drafted alongside Volpe in 2019. In 2022, Sikkema appeared in 11 games for Hudson Valley, holding opponents to a measly .165 average. Sikkema now plays for the AA Chattanooga Lookouts. The Cincinnati Reds affiliate captured the first-half title in the South League, a year after going 45-90 on the season.

First-round draft picks C Anthony Siegler and SS Trey Sweeney proved MLB worthy for different franchises. Sweeney's development was less favorable than Volpe's, and

the organization dealt him to the Los Angeles Dodgers in the 2023 off-season. Hardly six months later, Sweeney was packing again, landing with the Detroit Tigers with whom he debuted in August 2024. Sweeney made his first Opening Day roster this season.

becoming a piece of the young core that looks to make another postseason run. Siegler made waves as a switch-hitter and pitcher as a high school prospect, ultimately selecting free agency from New York and signing with the Milwaukee Brewers this past offseason. Siegler held a .881 on base plus slugging percentage (OPS) in 63 games with Triple-A Nashville before getting the call to the Brew Crew on July 1.

Nobody is having a year quite like Spencer Jones, who in 2023 became the first Hudson Valley Renegade to be named to the All-Star Futures Game. Jones leads all minor league players in home runs (24). He's been having the best individual offensive season

across the 120 MiLB teams, including a 1.390 OPS. Now in Triple A-Scranton/Wilkes-Barre, Jones is hitting a monster .397, including a 4-5, 3 RBI performance on July 19.

Jones's success led the way for New York's top prospect George Lombard Jr., who began this season as a Renegade. A few months into his AA career, Lombard has rediscovered his power, contributing solid offensive performances and being named the Yankees' sole representative in the Futures Game.

Hailing from colleges, high schools, and countries across the world, Hudson Valley Renegades alumni find themselves on different, uncertain paths to the dream. That player may become a Hall of Famer. He could find a passion outside of baseball. Wherever he goes, thousands of fans will be in the Valley, cheering him on every minute of his career. Once a Renegade, always a Renegade.

Renegades swept in shortened 2-game series

After just spending just shy of a week away from the game, the Hudson Valley Renegades (14-9) were back in action for a beach trip, spending the weekend with a faceoff against the Jersey Shore BlueClaws (10-13).

Seeking to play spoiler in the second half, Jersey Shore had the Renegades salty from twin Friday and Saturday losses. Weather-induced poor field conditions postponed the Sunday matinee, holding the Renegades winless on the shore.

Hudson Valley never held a lead in this shortened series, returning to play after a week of inactivity for the All-Star festivities in Atlanta. They scored in two innings over the pair of games - a three-spot in

Friday's seventh inning, followed by one run on Saturday.

Cheers to the BlueClaws pitching staff. Gabriel Barbosa improved to 3-0 after five hitless innings on Friday. In the 9-3 Jersey Shore victory, Hudson Valley was held to just two hits, scoring three late runs off the bullpen. Griffin Herring was the losing pitcher, giving up two runs and striking out six in four innings. Each team left seven runners on base, but the BlueClaws had more opportunities to crack the game open. The sixth inning proved it.

In a six-run carouse around the bases, the BlueClaws added a handful (plus one) insurance run. Hudson Valley's three-run response in the following frame

hardly scratched the surface of the deepening deficit. A bases-loaded walk by Kiko Romero made it 8-1 Claws. An RBI single from Dillon Lewis, then a run crossed by a wild pitch. The BlueClaws scored their ninth run in the bottom half of the seventh, which stood as the final run of the game.

The man at the corner, 3B Josh Moylan, is on a hot streak. He extended his streak of reaching base safely to 20 games, a sign of offensive improvement after a sluggish start to the season. In Saturday's loss, Moylan was 2-2 with a triple and a walk. He scored the Renegades' lone run on an RBI ground-out by Manuel Palencia.

On Saturday, the Renegades debuted a

new identity in a clash of the Locals and the Bennys. An honorific of a traditional conflict in a beachfront town, Hudson Valley was the Bennys (see also: annoying, cliché-driven tourists). The hosting BlueClaws were the Locals. As is the case for many a feel-good teen beach movie, the hometown team prevailed again. The Renegades tied the game at one, but couldn't come back from the subsequent three-run deficit.

Up next, the Renegades return home against the Rome Emperors of the SAL South. In an interdivision matchup, Hudson Valley will see Rome for the first time all season. With a hot start to begin the second half, the Renegades are 8-1 at home.

Welcomed back home: Vassar-Warner Home introduces Vassar-Warner 'Home for the Day'

After months of fighting to maintain its position in the Dutchess County community, Vassar-Warner Home recently celebrated its reopening as Vassar-Warner "Home for the Day" – a social model adult day care program – with an official Dutchess County Regional Chamber of Commerce ribbon cutting.

The social model adult day care program – which operates Mondays through Fridays from 8 a.m. to 5 p.m. – provides personalized care to Hudson Valley seniors, tailoring its services to meet dietary restrictions, health concerns, interests and overall wellness.

The event included remarks from Vassar-Warner's Executive Director Ericka Von Salews, who highlighted the support of the organization's board of directors, particularly Board President Richard Schuster, staff, friends and family. New York State Senator Rob Rolison, Dutchess County Executive Sue Serino, New York State Assemblymember Jonathan Jacobson and Poughkeepsie City Administrator Joseph Donat were in attendance. Marcia Dunn, the program's first participant, was also introduced.

"I can't express enough thanks to everyone involved who has worked tire-

lessly to bring this vision to life and for those who have given us their unwavering support," said Von Salews. "This new endeavor will once again offer Hudson Valley seniors a safe haven, an environment designed to provide elders with the highest level of support, comfort and care."

Housed in an 1835 Greek Revival building, Vassar-Warner Home, which is on the National Register of Historic Places, began as the Dutchess Academy for Boys. In 1870, Jonathan Rowland Warner transformed the Academy into a refuge for elderly women, a vision he pursued with local church groups. Despite his passing, his legacy endured and the Old Ladies Home opened its doors to the first residents in 1871. By 1896, the Home faced high demand, prompting Smith Brothers cough drop manufacturer William W. Smith to fund an expansion to accommodate 27 new rooms. The Old Ladies Home merged with the Vassar Home for Aged Men, originally founded by Matthew Vassar Jr. and John Guy Vassar, and in 1974, became Vassar-Warner Home, which served as Dutchess County's sole nonprofit senior living facility for 153 years.

Mary Ann is survived by her daughters,



Exhibit at Dia: Beacon leads Upstate Art Weekend

When you think of art, you probably think of the Metropolitan Museum of Art, the Museum of Modern Art, or the Guggenheim in New York City. Art isn't limited to the city, and Upstate Art Weekend (UAW) is a great reminder to get out and see what the Hudson Valley has to offer.

Founded by Helen Toomer in 2020, UAW began with 23 participants and has since grown to over 155 this year. "Upstate Art Weekend is about community, collaboration, art, and the outdoors, which are essential to our well-being," says Toomer. "This event was created to shine a light on the incredible organizations in the region and to solidify lasting connections with those visiting and those discovering what lies in their neighborhoods."

This year, UAW kicked off with a presentation of Kishio Suga's works at Dia: Beacon. Kishio Suga is a Japanese artist whose work frequently incorporates industrial materials, including stone, cement, glass, rope, and wood. "In the 1960s Suga went to Tama Art University, which had a lot of artists interested in rethinking traditional mediums," says curator Matilde Guidelli-Guidi, "By the time he gradu-

ated in the late '60s, he had become kind of a key figure in what is known as the Mono-ha school of thought." Mono-ha is an art movement that can be translated as the School of Things, with a heavy focus on materials and their combination. A good example of this is the centerpiece of the Suga installation, Soft Concrete.

Soft Concrete is a fascinating work of art. It's comprised of a soft mound of concrete with four stone rectangles sunk in it. Suga also added machine oil to the concrete to help it stay soft. "In the early 70s Suga was working at a lot of construction sites and he used a lot of materials from those sites in his art," says Guidelli-Guidi. "He was trying to give attention to what the material is beyond our daily use case." Suga's focus on industrial materials is also evident in his other works, which range from piles of rope to stones placed at angles and held in place by metal wires. The installation contains a total of seven works of art by Suga.

The Kishio Suga exhibit is on display now at Dia: Beacon. Admission to Dia: is also free for all residents of the Hudson Valley on the last Sunday of each month.





A cosmopolitan plant

Plantain is the common name for the *Plantago* genus of plants. Their common name brings to mind the banana-looking fruit in the unrelated *Musa* genus. Linguists believe the shared moniker resulted from both being edible, similar to other foods that refer to multiple types, like pepper or biscuits.

Worldwide, 200 differing species of adaptable plantains grow in various habitats. Most are wind pollinated, producing up to 20,000 seeds per plant. About 35 *Plantago* species are native to North America. But in Dutchess County, you are more likely to encounter European varieties that arrived during the colonial period and have become naturalized.

A useful weed

Plantain leaves and seeds have been consumed as human food since prehistory. The plants have antimicrobial, anti-inflammatory, and antihistamine properties; they have been used to treat insect bites, rashes, and skin irritations, as well as coughs and intestinal upset. The *ovata* species of *Plantago* is instrumental in psyllium, found in Metamucil, which promotes bowel movements.

Fibers and dyes for textiles, as well as mucilage for glue, are also made from *Plantago*. As a weed in your lawn, the deep tap root which makes it nearly impossible to eradicate, is also the quality that allows the plant to loosen compacted soil and draw nutrients up into the range where other plants can use them. Plantain out-competes lawn grass, but it is a useful weed.


Can it be served in a martini glass?
In botany, "cosmopolitan" does not

describe a plant's elegantly simple fashion sense, nor its use as an ingredient in a vodka-cranberry drink. Plantains are cosmopolitan because they can be found in the Americas, Asia, Australia, New Zealand, Africa, and Europe. Also, in some of the finest yards in Stamford, Wappinger, and Pawling.

The two main types of *Plantago* in Dutchess County are Broadleaf Plantain (*Plantago major*) and Narrowleaf Plantain (*Plantago lanceolata*). These common weeds thrive in various conditions, including lawns, gardens, sidewalk cracks, along roadsides, and disturbed areas.

As its name indicates, Broadleaf Plantain has wide, oval leaves with a waxy surface and pronounced veins. It has small, white-petaled flowers. Its ability to regenerate from its crown and its resistance to many herbicides can make it difficult to control. Narrowleaf Plantain has lance-shaped leaves and can be identified by its distinctive flower heads. It is well adapted to dry, low-fertility soils, and can withstand mowing. Its long taproot makes it difficult to eradicate. Plantains emerge in winter or early spring and grow through fall until colder weather beats them back.

Chicken Wings Cacciatore Ingredients

12 chicken wings (2 lbs.)

1/4 c. olive or vegetable oil

1 lg. onion, chopped
1 med. size green pepper, sliced thin
1 clove garlic, minced
1 jar Coppola's Marinara Sauce
1/4 tsp. oregano
1 tsp. salt
1/4 tsp. basil
1/4 tsp. leaf rosemary
1/2 c. dry red wine
5 potatoes

Method

Preheat your oven to 350 degrees F.
