## American Legion members open historic time capsule from Hudson River Hospital

Dozens of people recently gathered inside the American Legion John Livingstone Post 1466 to see the opening of a time capsule. The time capsule was buried on the former Hudson River State Hospital property in Poughkeepsie. Also on the site is a veterans monument. The monument will be moved from the property and placed on the American Legion site.

"I'm all about history," said American Legion John Livingstone Post #1466 Vice Commander Craig Elderkin.

The monument has dimensions of 18 feet long, 3 feet wide and 8 1/2 feet high, said Elderkin.

Encapsulated in the time capsule that was in the monument is a World War II flag with more than 200 white stars for members of the hospital who served in the war.

There are also two gold stars to represent the two workers who gave their lives during the war.

Elderkin explained that there was a portion of the stone on the monument which had a "reddish tint" to it. A piece was taken out, he continued. So, what they discovered was a tin box – a time capsule.


## Celebrate the Howland Public Library and the 'jewel of Beacon'



# Flag unveiled

"We wanted to share the moment. We wanted everybody to see it," he said to those in attendance.

In October, to mark the 75th anniversary of the Post, a dedication of the veterans monument is planned, said Elderkin.

Vice Commander Colin Reilly had to use an electric tool to open the tin box. Inside the box that had been closed for decades, was the flag, with the stars and initials HRSH (for Hudson River State Hospital) on it.

Reilly took out a paper, which was dated November 3, 1951. The paper, The Poughkeepsie New Yorker, predicted snow for the Buffalo area.

Inside was a letter, which in part stated,

"an everlasting memorial to the employees of the hospital."

Elderkin, who is a Navy veteran, said, "It's amazing" about the items that were placed on a table for those in attendance to see.

Paul Bonfiglio, a Navy veteran who is a member of the Post, said about coming to the unveiling of the time capsule items, "I wanted to see what was in the box. It's awesome."

Reilly said, "It's amazing. [The flag] is way larger than I thought, considering what it was put in." He also noted about the tin box which was turned into a time capsule, "Anything built back then was built right."

are exposed is the best way to stay healthy and safe. We ask residents to remain vigilant about their personal hygiene and take the proper mitigation steps to protect their health. If a resident believes they have contracted monkeypox or are experiencing symptoms, they're urged to please contact their primary-care physician."

The Centers for Disease Control and Prevention (CDC) recommends residents take the following steps to prevent getting monkeypox:

- Do not touch the rash or scabs of a person with monkeypox;
- Avoid close, skin-to-skin contact with people with a rash that looks like monkeypox, or who may have been exposed to monkeypox;
- Do not kiss, hug, cuddle or have sex with someone with monkeypox or someone suspected or known to have been exposed;
- Do not share eating utensils or cups with a person with monkeypox or someone suspected or known to have been exposed;
- Do not handle or touch the bedding,

towels or clothing of a person with monkeypox or of someone suspected or known to have been exposed; and

- Wash your hands often with soap and water or use an alcohol-based hand sanitizer.

The CDC advises residents who become sick with monkeypox to:

- Isolate at home; and
- Stay in a separate room or area away from people or pets you live with, when possible, if they have an active rash or other symptoms.

New Yorkers who may have been exposed to monkeypox in areas with high levels of transmission may be eligible for the JYNNEOS vaccine, indicated for prevention of smallpox and monkeypox disease in adults 18 years of age and older determined to be at high risk for infection. Vaccine supply from the federal government is currently limited, and eligibility is expected to expand as supply increases. # Molinaro discusses county's Youth Center at national conference

Dutchess County Executive Marc Molinaro recently discussed the development and potential of the County's forthcoming countywide youth center, the Youth Opportunity Union (The YOU), and the County's Path to Promise initiative with attendees at the national A Gathering of Leaders: Power of Place conference, hosted by the William Julius Wilson Institute (WJWI) at Harlem Children's Zone (HCZ) in Washington, D.C.

In October 2021, a team of senior HCZ leaders, including President and CEO Geoffrey Canada and CEO Kwame Owusu-Kesse, visited Poughkeepsie, meeting with Molinaro, City of Poughkeepsie Mayor Rob Rolison and members of the Poughkeepsie Children's Cabinet and touring the future site of the YOU. Dutchess County, the City of Poughkeepsie and the Poughkeepsie City School District recently formalized a partnership with the HCZ through a Memorandum of Understanding (MOU) with a local collective impact organization, the Poughkeepsie Children's Cabinet, in which all three public institutions are key stakeholders.

Impressed by their visit to Poughkeepsie, HCZ leaders invited Molinaro to discuss the YOU as part of this afternoon's panel discussion, titled "Neighborhood-Based, Cradle-to-Career Work and the Public Sector," which convened public officials and individuals with experience working with the public sector discuss how to effectively partner with local governments to advance neighborhood-based, cradle-to-career work.

Molinaro said, "Dutchess County's innovative Youth Opportunity Union will transform the lives of countless children, countywide, for years to come. We are building a first-of-its-kind model for the Hudson Valley and New York State, one that can be replicated.

cated throughout the country. The Harlem Children's Zone and Geoffrey Canada, have been invaluable collaborators, offering Dutchess County their vast experience and resources to help ensure the YOU's success. I appreciate the HCZ's desire to see the YOU flourish, and I thank them for the opportunity to discuss the project with such an eclectic group of national leaders, all of whom share the same goal: seeing our future generations succeed."

The YOU will be a state-of-the-art youth facility for children and families throughout Dutchess County, which will serve as home to the Path to Promise initiative, to be built on the site of the former YMCA site, located at 35 Montgomery Street in the City of Poughkeepsie. The YOU project has received ample interest from a variety of organizations, including the nationally renowned HCZ. County Executive Molinaro has committed to spend \$25 million, including \$10 million from American Rescue Plan (ARP) funds, for the YOU's design and construction; design is still ongoing, and a major fundraising campaign will be undertaken to build off the County's initial investment.

The conference convenes hundreds of cross-sector leaders, practitioners, and policymakers to deepen HCZ's work to drive social and economic mobility, at scale, for the most vulnerable children and families in the country. Attendees include Blue Meridian Partners' Place Matters Investees and leaders in the field of place-based partnerships, philanthropic partners, and public sector leaders. Among other local stakeholders, Mayor Rolison, Poughkeepsie City School Board Member Dr. Felicia Watson, Dutchess County Assistant Commissioner for Youth Services Karmen Smallwood and Rob Watson, co-founder and advisor to the Poughkeepsie Children's Cabinet and Director for Partnerships and

Community Impact for EdRedesign Lab at Harvard Graduate School of Education, are among those attending the event.

Taking place over three days, A Gathering of Leaders: Power of Place conference has three main goals:

- Align on an understanding of the importance of community-based, cradle-to-career strategies and vulnerable neighborhoods in place-based partnership work;
- Foster a community of practice by celebrating progress, sharing what's working, highlighting innovations, and discussing challenges; and
- Provide clarity on ways WJWI and other key actors can help leaders accelerate our work.

## Joseph Franco named new fire chief in City of Poughkeepsie

City of Poughkeepsie Mayor Rob Rolison announced last week that Joseph Franco has been named the city's Fire Chief.

Franco, who has been serving as acting chief and has been with the city's Fire Department for 27 years, succeeds Mark Johnson, who retired earlier this year.

Franco oversees a 63-member staff that protects approximately 30,000 people in an area of just under 5 square miles. The department operates out of three fire stations and responds to almost 5,000 calls per year.

Before becoming the acting fire chief earlier this year, Franco served as Deputy Fire Chief and handled the day-to-day operations of Fire Department administration under the Fire Chief. He coordinated and performed fire inspection efforts as well as oversaw the material readiness of the Department to meet its

daily missions.

Before this, Franco served the Fire Department in various capacities, from Fire Alarm Dispatcher to Fire Lieutenant.

In addition to his career at the city's Fire Department, Franco is a retired United States Navy/Naval Reserve Operation Specialist Chief Petty Officer, having served from 1985 to 2006.

"Joe Franco brings a wealth of knowledge to the position of Fire Chief, having risen in the Fire Department ranks and serving in so many different capacities -- command, firefighting, building and code inspections, emergency care, and training, among them," said Mayor Rob Rolison. "His experience and knowledge of the community will be invaluable as he takes on this critically important public-safety role."

"It's an honor to be selected to serve as Fire Chief," said Franco. "I have dedicated much of my life to this department, and I feel we are well-positioned to serve the needs of city, to ensure their safety and the safety of the fire personnel."

It is extraordinary and a great example of ordinary people moved to act by the senseless brutality and violence inflicted hourly by Russia upon a peaceful neighbor. We've never been more proud to be members of this community. Thank you as well to the Northern & Southern Dutchess News and Beacon Free Press for continuing to run the blue and yellow WE STAND WITH UKRAINE & AMERICA banner atop the front pages. The West we live in is not only a place, but a commitment to decency and humanity which must be defended in order for its values to endure and prosper. The purpose of the Fire and Safety Advisory Board shall be to serve in a consultative capacity to the Dutchess County Legislature, the Standing Committees of the Legislature, and the principal heads of the County Departments, Commissions, and Agencies, in matters pertaining to the suppression, prevention, and relief from the ravage of fire and other disasters which may be the obligation of the Fire Service of the County. The board meets bimonthly, third Monday starting in January at 7:30 p.m.

### Fish and Wildlife Management Board (District 3)

Landowner Representative (alternate) – 2 Year Term

Must reside on rural lands that engage in production of agricultural commodities or forest products.

Sportsman (alternate) – 2 Year Term

Encourages the preservation and development of fish and wildlife resources on privately-owned lands and waters, and to improve public recreational access to these resources. This Board meets March, June, September, and December on the third Wednesday at 7 p.m.

### Mental Hygiene Board

Member – 4 Year Term

## Talented Dominguez has immediate impact

Having a heralded prospect on the baseball roster is old hat for Hudson Valley Renegades President Steve Gliner.

So when the New York Yankees announced last week that touted prospect Jasson Dominguez, a 19-year old phenom, was being promoted from Low Class A Tampa to High Class A Hudson Valley, well, let's just say it's not Gliner's first rodeo.

Gliner has logged more than 30 years in the business and has seen co-called "can't miss" prospects come through the ranks.

Rarely has he seen the amount of hype surrounding Jasson Dominguez, however.

The newest Renegade – Dominguez joined the team on Friday after being promoted by the New York Yankees from Single A Tampa to the High Class A Renegades – Dominguez has been labeled

as a five-tool player and the No. 3 prospect throughout the entire Yankees' system.

And he's only 19 years old.

"It's exciting," Gliner said. "To me it's something similar to the first time we had Josh Hamilton here in 1999 (when the Renegades were a farm team of the Tampa Rays.) Josh was young. He was also 19. But it's different at this level. Remember, we were a short-season, Low A team back then. Now we're High Class A and Jasson being here really speaks to his talent."

Dominguez joined them right after the All-Star Break. He started in both Friday night's loss and Saturday night's win over Wilmington. In two games with Hudson Valley he has four hits, including a home run, and two stolen bases. His homer was his 10th overall this season, and the steal was his 20th.

### Sweeney shines as Renegades stay atop division in 2nd half

The Hudson Valley Renegades fell to the Wilmington Blue Rocks 16-9 in finale of a short three-game series on Sunday at Frawley Stadium.

Hudson Valley is 48-41 overall and 14-9 in the second half of the season, still atop the North Division of the South Atlantic League.

tom of the frame off Sauer to take a 6-5 lead. After a Trey Sweeney double tied the game in the fourth, Wilmington pulled away with two runs off Charlie Ruegger (2-2).

The Blue Rocks broke the game open with four runs in the bottom of the fifth and three more in the bottom of the seventh against a combination of Carlos Gomez and Nelson Alvarez.

Hudson Valley chipped away with two runs in the sixth on a two-run single by Jasson Dominguez, and got a run in the ninth on Pat DeMarco's first home run of the season, but ultimately came up short.

Sweeney finished the game 3-for-4 with a home run, a double, two RBIs and two runs scored. Dominguez has now hit in all three games that he has played with the Renegades.

Hudson Valley pitchers allowed a new season-high in runs, and tied season highs in hits allowed (14), walks (10) and home runs allowed (4).

## GLINER'S KORNER!

### Handling the hype around young star Dominguez

*Every week, Hudson Valley Renegades President Steve Gliner sits down with reporter Rich Thomaselli to discuss the team in particular, and minor league baseball in general.*

**So let's talk about the big news. The Renegades getting a player like Jasson Dominguez is a big deal. Can you compare it to any previous player – like maybe Evan Longoria or Josh Hamilton – coming to play here?**

Well, remember I was here when the Renegades moved here (in 1994) and then I wasn't here for a big chunk of time before coming back (five years ago). But it's hard to imagine anybody as well-known as Jasson Dominguez coming here, especially given all the hype surrounding him and the fact that we're now a Yankees affiliate. I think that really adds to it, for sure.

#### **There's definitely been a lot of hype.**

Oh, absolutely. He's a five-tool player and there was talk as far back as last year of him coming to the Renegades. It reminds me a little bit of the hype of having (shortstop) Anthony Volpe with us last year. I think it's the same with Dominguez. And to me, the timing of this

is interesting. There's been so much talk of the Yankees swinging a trade for (Washington star outfielder) Juan Soto and people have speculated about the prospects the Yankees would give up to trade him, the conjecture out there is that nearly every great prospect we have on our roster right now has his name attached to a trade one way or another (laughs). So we'll have to see how it all plays out.

#### **You can pretty much gauge the hype though, can't you?**

For sure. People who haven't even been to one of our games this year want to come and see him play. We have seen interest peak on social media. We see it in our ticket sales for the upcoming week when we return home. Plus, being a Yankees affiliate and playing so close to Yankee Stadium is a big factor. We expect we'll have some New York City media up here, or they'll want some photos or video footage.

#### **Does that fall on you to handle?**

That really falls with the Yankees and the player development people. We make sure we give him all the support he needs and do as much as we can. Our role is



making sure he doesn't get too bombarded. You know as well as I do in situations like these with a young prospect everybody wants to get him to sign this and sign that, and be able to say they got his autograph when he was just 19 long before he made the Majors, that sort of thing. So we try to give him some extra

security so he can get back and forth to his car and just be able to catch his breath a little bit. We've had conversations with the Yankees about it.

**How do you deal with a situation like this, a star prospect coming in, someone who all the fans know or have read about?**

The same. We treat him the same as we do in caring for all our other players. That's just the right way to go about it. We know we have a great group of players, great coaches and a great support staff here. We want to make his transition to Hudson Valley as seamless as possible. I don't think anybody wants anything to be drastically different for one player no matter who it is.

#### **What has impressed you about him?**

Just the way he's handling everything for just being 19 years old. He's been learning to speak English and he's been making a great effort to listen to questions and try to answer in English. I mean, imagine you or I starting a new job in a new city and trying to do our best to fit in by learning the language as we go along. It's not easy, so I really am impressed and give him great credit for trying.

library first started as a subscription-only library for members." Lapis noted that it was \$2 a year for a member to borrow one book a week.

Lapis stated, "The city is thankful to the philanthropy of General Joseph and Eliza Howland, who in 1872, provided the funds for the building of the original library. The General hired his son-in-law Richard Morris Hunt to design the building which became a focal point of literature and culture for the past 150 years."

The Howland Public Library and the Howland Cultural Center's buildings 150th anniversary through a series of events will be celebrated.

"I am especially looking forward to sharing with everyone key people from the library's past that may be unknown to most but were crucial to the development of the library," said Kristen Salierno, who is the director for the Howland Public Library.

Earlier this week, local resident and historical society member Emily Murnane portrayed Eliza Howland, "who was a Civil War nurse, humanitarian, and historical writer whose acts of charity have benefited Beacon for more than a century," said Lapis.

Kraft stated that "In 1976, needing more space to serve our growing community the Howland Public Library moved to its current home at 313 Main Street. After the Library relocated, the original historic building was transformed into the Howland Cultural Center and has been serving as Beacon's cultural center for the arts since 1979." "But by the 1920s, membership dues alone were not enough to pay the bills. A proposal to the city council for an annual appropriation in exchange for free services to all the residents was rebuked. In 1927, a former resident left the bulk of his estate to the library, providing that it became a free institution. So, with funding from the city of Beacon, the library opened the doors to the public free of charge for the first time on January 2, 1929. Originally providing adult books, magazines, and newspapers, the library has changed direction over the years to serve young children and school age students as well," explained Lapis.

There will be numerous events which will allow local residents and visitors to celebrate this milestone and to learn the history behind the two iconic buildings in

Beacon.

Salierno said, "We are particularly excited to open our exhibit "Keeping the Books" in August as it will be the first exhibit in the library since the pandemic closure in 2020. The exhibit will celebrate the history of the library's commitment to the community through pictures, scrapbooks, and reproductions. One of the themes in our exhibit is how the library has transformed through the years to meet the needs of the community."

Other events being held by the library are:

- A limited-edition library card designed by local artist Donna Mikkelsen, which includes imagery from her exhibit "People Make it Happen." These will be available starting August 1st.

- For adults, a mini library kit contest. Community members 18+ are invited to pick up a mini-library kit to create their own book sanctuary. Return your completed diorama to be displayed at the library.

- On August 4th, an anniversary T-shirt giveaway. The shirt was designed by local teen Allen McKay.

- On August 5th, a celebration-themed story time at the library at 3 p.m.

- On Saturday, August 11th, the library's exhibit, "Keeping the Books, Highlights from Librarian Scrapbooks" will open. The exhibit features photographs and ephemera from Howland Library scrapbooks from 1872 through the 1970s.

Kraft noted, "In collaboration with the Howland Public Library and the Beacon Historical Society, artist and curator Donna Mikkelsen has put together a series of historical pictographs to tell the incredible story of what is now our city's free Public Library - it wasn't always that way!" Fellow artist and history fan, Jean-Marc Superville Sovak, will also participate.

It was mentioned by Kraft that among some of the other events will include displays and participation events at the Howland Public Library; an exhibit at the Beacon Historical Society; a lecture on the local works of Richard Morris Hunt and a performance event at the Howland Cultural Center.

"The three organizations have collaborated to present a two-month-long celebration with exhibits, performances, and programs for all ages. Please join us as we commemorate this milestone for the City of Beacon," said Kraft.

By performing these types of repairs, RTDC helps homeowners stay in their homes for as long as they wish.

The other day while working at the restaurant I saw an elderly woman who reminded me of my Nonna. She was taller woman, with gray hair probably set with Aquanet. She had that warm aura about her that made you feel safe. Oh, and she carried a purse about the size of a small suitcase.

That purse is what flooded my mind with memories of Nonna. She had everything you can imagine in that arm strapped suitcase: Tissues, aspirin, first aid kit, sewing kit, safety pins, gum, crackers, small bottle of olive oil, cough drops, rosary beads, toys, comb, brush, mini-bible, nail file, old wallet, sweater, hard candies, cookies, Brioschi, head of garlic, and of course the ever-present rain bonnet.

I'll never forget how heavy that arm strapped suitcase was. It must have been 20 pounds or so. She always held it in the crook of her arm with a coat of some sort on one side of it. I can picture that smile of hers when she looked at you. Almost a half laugh. She would come close to you and lightly smack you on the cheek, then

kiss you on the other cheek and squeeze your face.

I remember once when I was little someone tried to rob it from her. He ran up and tried to grab it from her. Nonna looked at him with fire in her eyes. That poor slob got hit so hard with that arm strapped suitcase he was almost knocked out cold. Once he realized he picked the wrong person, he started to run. But not quite fast enough for my Nonna, who was surprisingly quick. As he was running away my Nonna hit him again and again. I can vividly picture him trying to get away as he was getting socked and remember laughing so hard it hurt. My Nonna wanted to make sure he remembered her, so she kept hitting him. After he finally got away, Nonna turned around, straightened herself out and acted as if nothing had happened. She saw me laughing, came over and smacked me on the cheek as she was laughing to herself.

Nonna was tough. Enjoy the recipe of my favorite dessert she would make: Struffoli.

# Nonna's purse

Woe to those who would cross her!

### Nonna's Struffoli

#### Ingredients

2 cups of all-purpose flour  
1 packet vanilla powder  
pinch of salt  
1 teaspoon sugar  
1 tablespoon brandy  
3 large eggs + 1 egg yolk (slightly beaten)  
1 tablespoon grated orange zest  
2 tablespoons corn oil  
Corn oil for deep frying (about 2 cups)  
Honey (about 1 cup)  
Strips of orange zest  
Sprinkles

#### Method

In a large bowl, whisk together the flour, vanilla powder, salt and sugar.

In the middle of your dried mixture, make a well and add the eggs, brandy, grated orange zest and 2 tablespoons of oil. Blend the wet ingredients well with fingers.

Begin working the dry ingredients with your hands, into the wet and continue until a dough forms.

Lightly knead the dough (about 5 minutes) until it is uniform.

Let the dough rest covered in plastic wrap for about an hour.

Working with a small piece of dough at a time (golf ball size), roll it out into 1/2" diameter logs and cut into 1/2" pieces.

Heat the 2 cups of oil in a deep non-

stick pan until it reaches 350 degrees F.

Gently lower the cut pieces of dough into the oil. Keep moving them around in the oil so they cook on all sides. Note the dough will almost double in size as it fries.

Allow them to turn golden brown all over, then remove them from the oil with a slotted spatula and let them drain on a paper-towel lined pan.

Continue rolling, cutting, and frying the remainder of the dough (keep the unrolled dough covered in plastic wrap).

When all the dough has been fried, empty the remaining oil from the pot, gently wipe out with a paper towel and add the honey. Let the honey get heated till it is of a thinner consistency. Place all the struffoli and orange zest into the honey and stir until they are completely coated. Remove with a slotted spoon.

Place the struffoli on a serving dish and decorate with sprinkles.






DCSPCA thanked the public for the outpouring of donations toward Marley's medical care, which exceeded \$5,300. Five other puppies who came to the shelter sick with parvo did not survive; treatment for all six pups was around \$14,000.






