Stormville firefighter Totis awarded scholarship

Family, Wiccopée Fire Co. honors late volunteer Steven D. Ziskind

Steven D. Ziskind was a volunteer firefighter for the Wiccopée Fire Company. In 2020, he died from injuries he sustained in a motorcycle accident. In remembrance of Steven, the Steven D. Ziskind Memorial Scholarship was founded. The annual scholarship was awarded on July 23 to Sheila Totis, who is a volunteer firefighter with the Stormville Fire Company.

"I applied for the scholarship because as a mother of two neurodivergent children that require costly therapies and other things every little bit of money, I can receive towards furthering my education helps," Sheila recently said.

Sheila explained, "One of the members in Station 2 actually told me about the scholarship and she thought I would be a good candidate for the scholarship. I had missed the monthly meeting where they discussed the applications for the scholarship."



DC Fair 'ambassador' Veeder-Shave named Volunteer of the Year

On June 24, Meegan Veeder-Shave was named Dutchess County Fair Volunteer of the Year. Veeder-Shave has lived in Dutchess County her whole life and has been involved in 4-H programs since she was nine. She is a sewing teacher at Wappingers Junior High School and a mother of two daughters.

"I've never missed a Dutchess County Fair," Veeder-Shave said. "My parents have pictures of me in a backpack carrier with a little pink raincoat and rain coming off my nose, because we went rain or shine."

Veeder-Shave joined a 4-H club as soon as she was old enough. She was originally interested in the food and cooking aspects of 4-H. However, she got an injury playing soccer and her leg was in a cast for about a year. Veeder-Shave said even though the injury was heartbreaking at the time, it led her down the path she is on now.

"During that time, this teacher in high school took me under her wing and told me that I could be a really good seamstress, but I had to slow down and I had to pay attention to things," Veeder-Shave said. "That year that I was in a cast, all of my sewing skills took off and I was voraciously sewing and tailoring."

While she was injured, she made a sheepskin coat and competed in the National 4-H competition where she was awarded the New York State award for clothing construction. She got a free trip to Chicago and met some of the people from Simplicity and other popular sewing machine companies.

Veeder-Shave has continued to use her love of sewing and wool to educate others and give back to her community. She owns sheep that she brings to the Fair every year. One of her goals is to promote the beauty and durability of wool. Most of the items she sews or knits are made from wool including her quilts that made it to the Houston

body who might want to learn how to crochet or knit and draw people in to try something new."

The day before last year's Fair, Veeder-Shave cut off the end of her finger when she was loading the sheep to take them to the Fair. Even through the stitches and pain, she fulfilled all of her duties at the Fair. Veeder-Shave said she was grateful that she had her family to help her.

"4-H has been a big part of our family all along, and part of that's because my dad (Gary Veeder) back in '72 became a member of the Dutchess County Agricultural Society and he would just love to see his family join and help out as well," Veeder-Shave said. "I am grateful for my father for bringing me into the fair and I'm grateful for my family because this is truly a family affair."

Veeder-Shave's contributions to the Fair and its preparation no matter the circumstances led her to receive the Dutchess County Fair Volunteer of the Year award. Veeder-Shave said she plans to continue to work with the fair and 4-H for a long time.

"4-H is a fantastic program because you're working with kids for about 10 years so you get to see them grow, develop, get different skills and go on different paths," Veeder-Shave said. "I mean, I know that it really influenced what I did, I saw how much it influenced my kids and I see how much it influences other kids."

Sheriff Kirk Imperati announced that the next written exam for the position of Deputy Sheriff/police officer has been scheduled for Saturday, September 28.

The written exam is the first step for those wishing to begin a rewarding career in law enforcement. The Sheriff's Office is continually seeking qualified candidates and expects that there will be employment opportunities for those that successfully complete the hiring process, starting with the written exam. Once hired Deputy Sheriffs have practically unlimited opportunities within the Sheriff Office including (but not limited to) promotions to supervision or Detective ranks, the ability to join different Bureaus such as Special Operations or Training, and/or the chance to become part of numerous specialty units like Emergency Services, K9,

or Unmanned Aircraft Systems (drones). The aforesaid description of opportunities is merely a brief example, as there are many more paths that someone can take after they become part of the Sheriff's Office team.

Anyone who is interested in a career in law enforcement is strongly urged to take the written exam, and there is also a free test prep course offered for those who would like extra practice ahead of it. Sheriff's Office: Man arrested for violating order of protection while in jail

The Dutchess County Sheriff's Office reports the arrest of Nykiem McLean, 27 of Rhinebeck, in connection with an investigation at the Dutchess County Justice and Transition Center. McLean was incarcerated at the time of the incident and remains there at the time of this writing.

According to the Sheriff's Office, McLean is accused of violating an Order of Protection by contacting a protected

party. He was arrested on July 22 and has been charged with Aggravated Family Offense (felony) and Criminal Contempt 2nd degree (misdemeanor). McLean is scheduled to appear before the City of Poughkeepsie Court for arraignment on August 26.

Dutchess County in top 10 for best technology practices for 22nd year

Dutchess County is again in the nation's top ten for the best technology practices. The 2024 Digital Counties Survey, conducted by the Center for Digital Government (CDG) and the National Association of Counties (NACo), ranked Dutchess County 6th in the nation among mid-size county governments for efforts to enhance cybersecurity, streamline delivery of services and apply innovative technologies to county priorities. This work is led by the County's Office of Central and Information Services' (OCIS). Often a "behind-the-scenes" department, OCIS's preparedness and training was on full display last week when the CrowdStrike-related technology outage affected millions of Microsoft Windows users, including many in Dutchess County Government. OCIS helped ensure a quick recovery within hours, with little to no disruption of County operations and services for residents.

County Executive Sue Serino said, "We proudly congratulate our OCIS team for this much-deserved recognition. Team members know the importance of staying

aware of and planning for cyber-attacks and other threats to our systems. Their diligence helps ensure County data remains secure, preventing potentially costly interruptions to our daily operations and helping ensure we maintain the trust of residents and visitors alike."

While the recent CrowdStrike shutdown was not a cyber-attack, malicious actors capitalized on the incident, attempting to obtain login credentials from employees to gain access to systems. This highlights the importance of cybersecurity, as the cost of recovering from such breaches continues to increase. Such incidents can cost public sector entities millions of dollars in repairs, ransom payments and legal fees.

OCIS Acting Commissioner Stephen Oscarlece said, "Dutchess County OCIS continues to implement and update a wide array of technology services to be as secure, accessible and effective as possible. The recent technology outage, while not a direct cyber threat, was still a good

reminder of how important it is for our team to be prepared to respond quickly and efficiently to ensure our ability to provide essential services to fellow employees and residents alike. We are grateful for the continued recognition of our commitment and hard work."

Dutchess County conducts cybersecurity tabletop exercises and employee trainings each year to increase cybersecurity awareness and preparedness. OCIS also works to help increase local municipalities preparedness with its' annual Cyber Security Summit, held this past June at Marist College. The event included a panel discussion on artificial intelligence (AI) technology best practices and how cybercriminals are using the technology to target agencies and residents alike. OCIS also recently implemented trainings on the ethical use of generative artificial intelligence to enhance work processes and equipping staff to better support other agencies exploring AI options.

Dutchess County OCIS is not only a leader in cybersecurity, but also continues to provide innovative technology services, such as:

- New Online Zoning Map for the Department of Planning & Development, which enables users to select any of the County's 30 municipalities and view an interactive version of each community's zoning map or select a county-wide version that shows a big-picture view of permitted land uses; and

- Upgrades to the GIS Open Data Portal providing free and open access to numerous GIS datasets.

"The Digital Counties Survey illustrates how counties are on the cutting-edge, pursuing innovative approaches to serve our residents," said NACo Executive Director Matthew Chase. "Counties are thoughtfully adopting technologies like artificial intelligence and data platforms to enhance civic engagement, increase efficiency, and strengthen our communities today and for the future."





Renegades hope to rebound after tough week in Wilmington


The difficult start to the second half of the minor league baseball season continued for the Hudson Valley Renegades in last week's series at Wilmington.

The Renegades are now 13-16 in the second half of the season and in fifth place, 4.5 games behind league-leading Greensboro. They are at home this week for six games against Jersey Shore at Heritage Financial Park.

The Wilmington Blue Rocks used a three-run eighth inning to earn a come-from-behind victory over the Renegades 5-4 last Tuesday night at Frawley Stadium.

The Renegades took the lead early in the top of the first when Roc Riggio led off the game with a single against Riley Cornelio. Recently traded Jared Serna then ripped a home run to left to give Hudson Valley a 2-0 lead. It was his fifth long ball of the season at Frawley Stadium and sixth against the Blue Rocks. Serna finished 2-for-4 with a run scored, a double, his team-leading 13th home run and three RBI.

Baron Stuart had a strong start in his first appearance after the All-Star Break, throwing five shutout innings with five strikeouts and no walks issued. The right-hander allowed just three total baserunners after the first inning. Josh Moylan hit a solo homer in the fourth to extend the Renegades lead to 3-0, his fourth long ball of the season. But it was not to last. The Blue Rocks got on the board in the sixth against Hueson Morrill. A Phillip Glasser single, Jared McKenzie walk and Murphy Steely hit

by pitch loaded the bases with no outs. Maxwell Romero drove home Glasser and McKenzie with a single to cut the lead to 3-2. In the bottom of the eighth, Wilmington took the lead with three runs off Cole Ayers (2-4). Joe Naranjo hit a solo home run to cut the lead to 4-3. After a single by Romero, T.J. White

put Wilmington in front 5-4 with a two-run homer.

Hudson Valley dropped a 4-1 decision last Wednesday before bouncing back to win 5-2 on Thursday. Kyle Carr put together another strong start for Hudson Valley, allowing just one run on three hits in five innings while striking out six.

Including his five no-hit innings last Friday, the southpaw has thrown 10 innings of one-run ball with only three hits against him in his last two starts.

After the first two Wilmington batters of the game recorded hits, Carr retired 14 of the last 16 batters he faced. Yorlin Calderon struck out the side in a 1-2-3 ninth inning to earn his first Renegades save.

But it was back to the losing side on Friday night as the Renegades fell, 5-2. Jace Avina led off the game with a single and Jared Serna doubled to put runners at second and third. Two batters later, Antonio Gomez drove in Avina with an RBI single to give the Renegades a 1-0 lead. Wilmington answered with three runs in the bottom of the first against Blane Abeyta. Phillip Glasser led off with a double and came home to score after a throwing error on a Jared McKenzie sacrifice bunt attempt. A two-run homer by Maxwell Romero later in the inning made it 3-1 Blue Rocks. Murphy Steely hit a solo home run in the third to push the Wilmington advantage to 4-1.

Saturday wasn't any better, with a 2-1 loss. But Cam Schlittler was stellar for Hudson Valley, recording his fourth quality start of the season and second in his last three starts. The right-hander threw a career-high seven innings, allowing two runs (one earned) while inducing nine groundball outs.

The offense did come alive for the Renegades on Sunday in the series finale, as they notched nine hits in a 5-4 victory over Wilmington.

As the general manager, you probably knew this long before we did. But what is your reaction to the realignment for next year?


The only thing that we saw is that

Take survey on future of Schatz property in Poughkeepsie

'Pop-up' event set for August 6

Dutchess County is seeking community input regarding development of the former Schatz Federal Bearings Company property, a 20-acre site on Fairview Avenue in the Town of Poughkeepsie that spans into the City of Poughkeepsie. The County and its partners have established a "Revitalize Schatz" website, revitalizeschatz.com, where residents can learn about and take a survey regarding potential projects, including the housing, commercial, and amenity options for the site. There will also be a "pop-up" event on August 6 on the Marcus J. Molinaro Northside Line in Poughkeepsie from 10 a.m. to 1 p.m., where project coordinators will be available to talk about the project and hear ideas and comments.

County Executive Sue Serino said, "Dutchess County and our partners have a unique opportunity to transform the long-vacant Schatz property into an asset that can benefit its surrounding communities. We urge residents to engage with Dutchess County and our partners – either in person or online – to help guide the future of the site and make this project one in which we can all take pride."

The development of the site is part of a Brownfield Opportunity Area (BOA) Nomination Study the County and its partners – including RUPCO, a nonprofit organization focused on providing affordable housing and community develop-

ment services in the Hudson Valley, and Kearney Realty Co. – have launched. Under this New York State program, BOAs examine options for the reuse and redevelopment of a site with historical environmental contamination.

The former Schatz Federal Bearings Company produced bearings for the automotive industry for a large part of the 20th century, though the Fairview Avenue site was contaminated years ago and has long sat vacant. BOA participants receive state grant funding for a variety of planning work, including a site survey, building structural analysis, market analysis, environmental reports and community vision for the future of the site.

The former Schatz site lies between Parker Avenue to the south, Cedar Avenue to the north and the MJM Northside Line to the west. Public outreach will continue in the coming months to gather community input to help inform decisions regarding the types of housing, commercial and amenity options to pursue, as well as linkages to adjacent resources, such as MidHudson Regional Hospital, Marist College, the Walkway Over the Hudson, the MJM Northside Line Rail Trail and other developments underway, like Hudson Heritage and Scenic Hudson's Parker Avenue campus. An easy summer meal

Caprese chicken and no-bake yogurt pie for the hot days ahead

Here we are, midway through summer already. I know it isn't always fun cooking in hot weather, believe me. My kitchen is not a joy to be in this time of year. I like the challenge of meal planning but there have been plenty of days lately that I really struggled to come up with something different or that at least I hadn't already made in a while AND that wasn't heavy or heated up the kitchen. So I get it – the struggle is real, but we can do this! We've still got plenty of summer to get through, after all.

Yes, I was in a bit of a menu rut last week, feeling like I'd already exhausted my summer meal repertoire. Silly me! I was just hot and a little hangry. A big glass of iced tea, a sandwich and a good, long look at my grocery haul that week brought me back to my senses and soon I had a new idea to try out. Usually, I plan out my weekly menus as I look through the supermarket flyers, but even that wasn't inspiring me, so I bought what looked good and figured I'd just come up with something. Sure enough, once I looked at what I had and started prepping, I was quickly on a roll and, based on what I had to work with, I made something fresh and tasty. But as I said, I was on a roll and before I knew it, I made dessert too! When all was said and done it turned out to be a perfect

summer dinner.

The inspiration came in stages. For me, inspiration is often one part practicality and two parts creativity, as was the case here. First, I had chicken breasts I needed to use. I also had fresh mozzarella and basil because I had a craving and bought them without a plan. Last, but not at all least, I had my new favorite: on-the-vine cherry tomatoes from Aldi that I've been loving. They are so sweet and delicious with just-from-garden-like flavor. I can't get enough! I'd been tossing them in all kinds of salads and just snacking on them, but there they sat as I puzzled over what to make and it all came together in a flash!

I'm not sure what to call it – it's part caprese (after the classic salad) and bruschetta (because of the tomato topping) – but whatever you call it, it's delightful. As the components suggest, it's fresh and light, some of my favorite flavors of summer playing together in that beautiful way they have. To keep things light and in season, I served it simply with corn on the cob and called it a night, which was definitely the way to go, especially since there was dessert to save room for. So, if you're ready, here it is.

CAPRESE CHICKEN

Yup, that's what I went with because of the classic combination of tomato, basil

and fresh mozzarella. I had some of the tomato topping left over, which I happily ate with a spoon, but you could serve it over toasted bread for that bruschetta I alluded to earlier. Marinating the chicken may not be necessary, but that's what I did because I was grilling it and I wouldn't change a thing, even if cooked in a skillet. I served it with sweet corn and some garlic bread, which was just right.

INGREDIENTS

- 4 boneless, skinless chicken breasts
- 4-5 tablespoons extra-virgin olive oil
- Juice from 1 lemon, divided
- Salt and pepper (freshly ground is best), to taste
- 1 teaspoon dried oregano
- About 2 cups diced fresh, ripe tomatoes
- 2 cloves fresh garlic, minced
- Fresh chopped basil (I used 8-10 good-sized leaves)
- Fresh mozzarella, sliced (enough for the 4 chicken breasts)
- Freshly grated Parmesan

METHOD

Place chicken breasts between two pieces of plastic wrap and pound just to even out their thickness. (You can skip this step if you're using thin-sliced breasts.) Place in a large bowl or zip-top bag and set aside.

Make the marinade: In a small bowl, whisk together olive oil, half of the lemon juice, salt, pepper and oregano. Add to the chicken, toss and refrigerate for at least 30 minutes.

Meanwhile, in a medium bowl, combine tomatoes, garlic, basil and remaining lemon juice. Season with salt and pepper, stir and set aside.

Remove chicken from the bag or bowl and place on a preheated grill over medium-high heat. Discard any leftover marinade. Grill until internal temperature is 155 degrees, 5-7 minutes per side. NOTE: you'll know when it's time to flip when it doesn't stick to the grill.

Before removing from the grill, top each chicken breast with mozzarella and close the grill lid to melt the cheese, 2-3 minutes.

Transfer to plates and top with the fresh tomato mixture. Sprinkle with Parmesan and serve immediately.

asking? I whipped up a no-bake pie! It's a family favorite my mother makes that's cool and easy and comes together quickly because of the shortcut ingredients. It just needs time to set up in the freezer before serving so plan to make it at least 2 hours ahead.

NO-BAKE YOGURT PIE

You may think it's cheating to use whipped topping but with results this good you might forgive me. I have made it with homemade whipped cream but it doesn't set up as well. I've made my own graham cracker crust but there's no shame in using a pre-made version, as I did here to speed things up. You can mix fresh fruit into it, garnish the top with berries or whipped cream or just leave it plain. Remember, you'll need to give it time in the freezer to set but then keep it to the fridge.

INGREDIENTS

- 2 small containers fruit yogurt (I used Chobani 5.3oz Strawberry Greek yogurt)
- 1 container whipped topping (like Cool Whip)
- 1 graham cracker pie shell (premade is just fine)
- Fresh berries for garnish (optional)

METHOD


In a medium bowl, whisk together yogurt and whipped topping. Pour into pie shell and freeze 2-4 hours to set.

Remove from freezer, garnish with berries and serve. (You may want to let it sit out 15 minutes or so). Place any leftovers in the fridge.

And that, my friends, is one summery supper! From beginning to end it's fresh, light and flavorful. It's kind of a little celebration of what summer's all about and keeps the livin' easy as it should be this time of year. Enjoy!

A thousand miles of gardens

Three gardens in three states in three days

So many gardens. So little time. Sue and I had three days to visit three gardens in three different states. The idea was to look at new flowers for 2025, check out a historic garden and stop at a display garden and a trial garden.

First stop – Sonnenburg Gardens in Canandaigua, N.Y. As president of New York State Flower Industries, Sue set up a tour to go along with her annual meeting. Executive Director David Hutchings led us through the nine garden “rooms” covering 50 acres, and the 1887 mansion. Mary Clark Thompson and her husband Frederick Thompson, whose family founded Citibank in 1863, built their summer retreat in the beautiful city of Canandaigua on the north shore of Seneca Lake. Like many of the mansions and gardens from the late 18th century – think of Vanderbilt Mansion’s Italian garden – the property fell into disrepair until a group of dedicated volunteers started a restoration in the 1970s. The restoration is ongoing, and director Hutchings admitted that a lot of work still needs to be done. To my eyes, the garden was not worth the trip unless you happen to be touring the Finger Lakes. Better to visit the New York Botanical Garden, Longwood Gardens in Kennett Square, Pennsylvania, or even the fully restored Vanderbilt Italian garden. The mansion may have been well worth the trip, but -hey- it’s not a garden.

Second stop – a six-hour drive south to Monroeville, N.J., off exit 2 of the turnpike. Lucas Greenhouse is one of the biggest commercial growers in the world – 45 acres under cover. George and Louise Lucas supply independent garden centers all over the Northeast with pots and hanging baskets of flowers, hardy chrysanthemums and poinsettias. The Lucas operation is ten times the size of my greenhouse here in Poughkeepsie. I once asked Louise how they ended up so big and successful. “The good Lord,” she told me. Sue and I had come to see Lucas’ display garden of hundreds of annual

flowers – petunias, geraniums, million bells, coleus – many new varieties for 2025. We were looking for a red angelonia, but it hasn’t been invented yet. It takes a dozen or more years to breed a new flower. Exciting new varieties for 2025 include a multi-blossomed sunflower and a black angelonia. At one point I raved about “Petchua Supercal Premium Caramel Yellow” and told Sue we should try it out. “We’ve been growing it for years,” she told me.

Third stop – Penn State trial garden in Lancaster, PA. As opposed to the display garden at Lucas Greenhouse, Penn State University runs a trial garden, where different varieties of the same flower are grown side by side for comparison. You might see 20 red petunias, from several flower breeders. Sue is always looking for a true red, not a “scarlet” or a raspberry red. You can’t tell the true color from a catalog, you have to see it for real, which we do. We look for coleus that doesn’t bloom (the flowers are usually ugly) and verbena that does bloom in the heat of late July. Nemisia is notorious for fading away in the summer, but nemisia “scen-topia” was still in bloom, plus it has a delightful fragrance. Sue was searching for inspiration for her combination hanging baskets (we grow 30,000). Petunia “Tiara Blue,” and Salvia “Unplugged Red,” both new from Proven Winners, look good.

Evaluating hundreds of flowers is exciting but exhausting. The 1,000-mile round trip makes for a challenging three days. When we got back to work on Friday morning, everyone asked, “How was your vacation?” The following Wednesday, Sue and I take off to look at more new flowers, this time at Pleasant View Gardens in Concord, New Hampshire.




