BCSD, WCSD superintendents offer messages to students as new school year begins District leaders discuss improvements, communication

The Beacon City School District (BCSD) and Wappingers Central School District (WCSD) staff and administrations are welcoming students back this week. Beacon City School District Superintendent Dr. Matthew Landahl and Wappingers Central School District Superintendent Dr. Dwight Bonk answered questions from Southern Dutchess News about the upcoming 2023-2024 school year. The superintendents also offered their back-to-school messages for students and parents/guardians.

WCSD makes 'capital improvements to infrastructure' of 15 schools,

"During the course of the summer, the District had various summer school programs that involved nearly 1,000 of our 10,350 (K-12) students that proved to be very successful by providing additional and necessary academic intervention services and enrichment, as well as much needed emotional support for our students that will be beneficial in transitioning into the 2023-24 school year," said Bonk. "We are very grateful to the entire WCSD community for the support of our budget. The approval of the school budget has enabled the District to enhance our academic program and provide the necessary mental health and school safety support for a safe school environment, which allows our students the opportunity to reach their full potential."

The District has made necessary capital improvements to the infrastructure of its 15 school buildings and grounds, stated Bonk. "We continue our collaboration in the area of school safety and mental health services with Dutchess County

New COVID-19 variant detected in NYC wastewater

Last week, a new, closely monitored strain of COVID-19 was detected in New York City wastewater, according to the New York State Department of Health (NYS DOH), which conducts wastewater analysis across the state. Health officials say it's likely that the variant, BA.2.86, is circulating in the City.

Previous to its arrival in New York, BA.2.86 had been found in cases in Israel, Denmark, South Africa, Michigan and Virginia. It has been designated a Variant Under Monitoring (VUM) by the World Health Organization (WHO). It appears to be the most genetically different strain since the original Omicron variant, which is significant because mutations may allow the virus to evade prior immunity, the DOH said in a press release.

Reacting to reports of the new variant, along with an increase in reported cases and hospitalizations this summer, Gov. Kathy Hochul recently announced new steps the State of New York is taking to protect individuals from COVID-19.

"While New Yorkers might want to be done with COVID-19, COVID-19 isn't done with us," Hochul said. "...I strongly urge everyone to take appropriate precautions to protect themselves and their communities. To keep New Yorkers safe, my administration will continue to monitor this situation, share information on the new boosters as soon as it's available, and continue to make N-95 masks available statewide."

An updated COVID-19 vaccine tailored to guard against certain variants is expected to arrive in pharmacies and doctors' offices this Fall. Hochul encourages New Yorkers to monitor the CDC (<https://www.cdc.gov/>) and the DOH (<https://covid19vaccine.health.ny.gov/>) websites frequently for information on updated COVID-19 vaccine administration recommendations.

Hospitalizations low in Dutchess

In Dutchess County, the seven-day average of reported cases was up over 19 percent as of Aug. 28.

"As we've seen over the past few years, that while COVID is ever present, there are times when case numbers increase or spike. In recent weeks, there has been an increase in cases both nationally and locally," said Livia Santiago-Rosado, MD,

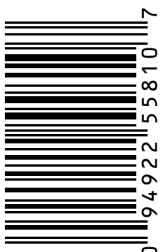


The Town of Poughkeepsie will be working with Habitat for Humanity of Dutchess County on a community service project to commemorate 9/11.

150 students complete requirements in Summer Youth Employment Program

More than 150 young participants with various backgrounds and interests on August 16 completed the Department of Community and Family Services' (DCFS) weeks-long Summer Youth Employment Program (SYEP), which empowers the youth and prepares them for success by providing invaluable real-world work experience and skill development, laying a strong foundation for their future careers. Wednesday's SYEP graduation was coordinated by the Dutchess County Workforce Investment Board (DCWIB) and held at Dutchess BOCES in Salt Point.

The annual SYEP provides qualified students, ages 14 to 20 and whose families qualify for Temporary Assistance for Needy Families (TANF), a 6-8 week-long course, which includes summer job placement, designed to help them prepare for future, permanent employment.

County Executive William F.X. O'Neil said, "Dutchess County can be immensely proud of today's graduates and the dedication they've shown throughout the Summer Youth Employment Program. These young people have demonstrated an eagerness to learn and the determination to excel in the professional world. As they move forward, they carry with them

the experience, knowledge and confidence that will undoubtedly propel them toward brighter futures."

Students who took part in the SYEP received job placements accompanied by mentorship – ranging in industry, skill level and geographic location – and worked an average of 20 hours per week at one of more than a dozen businesses throughout Dutchess County, including Discovery Children's Museum, Hidden Hollow Farm, Gennie's Soul Food Restaurant, Community Music Space and Taste Budd's Café. Training coincided with the students' employment throughout July and August, giving them the chance to learn skills, go back and apply those skills on the job, and then gather again to discuss which were successful. Through the WIB's partnerships with local businesses, organizations and government agencies, participants were immersed in a diverse range of industries, including technology, healthcare, hospitality and more – exposure which not only helped participants discover their passions, but also paved the way for potential career paths.

Training topics included:

- problem-solving;
- teamwork;
- verbal and non-verbal communication;
- stress management;
- fundamental fiscal management concepts; and
- goal setting and employment strategies.

DCWIB Executive Director Louise McLoughlin said, "The Dutchess County Workforce Investment Board proudly partners with the Department of Community & Family Services to offer this impactful program, which makes a difference in so many young people's lives. Wednesday's graduates have learned critical lifelong skills this summer, and we hope they'll continue to hone those skills as they prepare for their post-school life."

The SYEP offered participants more than just work experience. Wednesday's graduation, for example, included workshops and seminars designed to enhance essential skills, including communication, teamwork, problem-solving and financial literacy. Local business owners and experts in their respective fields led Wednesday's sessions, aimed to provide the young people with a holistic development experience, and County Executive O'Neil shared his personal story, detailing his journey from military service and success in the private sector to his leadership roles in County government.

Through their participation in the program, hard work and dedication, the graduates of the 2023 Dutchess County SYEP

are now better prepared to transition into higher education or the workforce. They have gained practical skills, expanded their networks and fostered a strong sense of responsibility and professionalism.

DCFS directed \$535,230 to the DCWIB for the 2023 Summer Youth Employment Program from the federally funded TANF program. SYEP's goal is for the young participants to enjoy a positive work experience while giving them an opportunity to be productive, explore career options and earn a certificate that confirms their readiness for entry-level work, as defined by employers across the country.

elementary schools throughout each school day, as well as School Resource Officers at Van Wyck Junior High School, Wappingers Junior High School, John Jay High School, and Roy C. Ketcham High School," he said. The superintendent continued, "The District has also secured a new and enhanced (VMS) Visitor Management System, which will be utilized at all of our buildings to continue to ensure that all visitors meet the safety criteria to do such. In the area of student mental health services, programmatic changes have been made to enhance services for all students."

The District has hired Wilson Castro, said Bonk, who previously served as an assistant principal at John Jay High School, as the new principal of Van Wyck Junior High School.

"Dr. Donna Moss will also serve as Interim Principal at Sheafe Road Elementary School to begin the school year. The District will begin the search for a principal in the early fall," he said.

Bonk noted, "Wappingers Central School District will continue to expand our regular curricular offerings, especial-

ly in the areas of career and technical education, and provide a myriad of extra-curricular programs for our students to become active participants in their school. We are also grateful for the support that we have received from our business community in establishing School-Business Partnerships, which have provided our students with pertinent career exploration experiences that have given them knowledge regarding the types of employment opportunities that are available in our region and the skills necessary to obtain them. In closing, we look forward to the return of our 10,350 students and a most productive and rewarding school year for all!"

"Parents and the community can expect increased communication and more opportunities for students in the district. We are implementing our new strategic plan this year and we are very excited to share updates on our progress with the community. We have planned for increased clubs and extracurricular opportunities for students this year and increased opportunities for parent and community engagement," said Landahl.

South Avenue Elementary School has a new principal, Kelly Amendola. Amendola, said Landahl, began a few weeks ago in the BCSD. "She was an assistant principal in Newburgh [Enlarged City School District] for the last three years and before that, she was a middle school science teacher in the Bronx for nine years. She is very excited to get this school year started!" he noted.

"My message to the students is to use this upcoming school year to make new friends and try new activities. The beginning of the school year is a great time to meet new people and sign up for new activities that are available to you. Every member of the school district can't wait to see you, get to know you, and help you learn and grow this year. Ask any of us if you need help with anything. Have a great year!" said Landahl.

'Bridges to Parks' hiking event set for September 9

The New York State Bridge Authority (NYSBA) and the New York State Office of Parks, Recreation and Historic Preservation (State Parks) have announced an upcoming "Bridges to Parks" hike event to showcase the connections between the Hudson Valley's bridges and nearby state parks and historic sites. The event will highlight the Mid-Hudson Bridge, Walkway Over the Hudson State Historic Park, and Franny Reese State Park, as well as the trails and views that connect them. Members of the public are welcome to register online on a first come, first served basis.

The event is scheduled for Sept. 9 at 9 a.m. and will kick off at Victor C. Waryas Park, a municipal park nestled along the City of Poughkeepsie waterfront between the Mid-Hudson Bridge and the Walkway Over the Hudson. Multiple guided hike options of varying difficulty will be offered, including a tour of the full Walkway Loop Trail and a hike into Franny Reese State Park. Participants are asked to indicate which hike they are interested in when they register on the website.

Registration can be completed by visiting <https://nysbridgeauthority.ticket-spice.com/bridgestoparks>.

State Parks Commissioner Erik Kulleseid said, "This celebration joins the Bridge Authority, our Friends groups, and many of our parks we share along the Hudson River. It's no coincidence that as we each mark milestones, we are looking back at what we've built and making newer, stronger connections. We hope that as people hike, they enjoy all the beauty of the Hudson Valley and return again and again."

Dr. Minosca Alcantara, Executive Director of NYSBA, said, "Our bridge crossings have long been connectors to the Hudson Valley's treasured recreational assets, starting with the opening of the Bear Mountain Bridge in 1924 and continuing to the present day with paths like the Walkway Loop Trail, which goes over the Mid-Hudson Bridge. NYSBA is proud to partner with our friends at State Parks in celebrating this legacy and our continued connections to the region's history and natural beauty."

The event is being held with support from the Friends of the Walkway Over the Hudson, the nonprofit partner for the Walkway, as well as Scenic Hudson, who maintains Franny Reese State Park.

Lori Robertson, Executive Director for Friends of Walkway Over the Hudson, said, "The Walkway Loop Trail, connecting Walkway Over the Hudson with the Mid-Hudson Bridge and its surrounding rail trails, is a true gem in the Hudson Valley. Showcasing amazing river views and linking several parks, the trail provides a unique place to exercise, explore, and connect with nature. We're proud to partner with New York State Parks and the New York State Bridge Authority on Bridges to Parks and to have our volunteer Ambassadors on hand to provide interesting facts and bits of history when hikers cross over the Walkway."

Seth McKee, Executive Director of The Scenic Hudson Land Trust, Inc., and Land Programs, said, "Scenic Hudson is delighted to partner with New York State Parks and the Bridge Authority to celebrate how the Mid-Hudson Bridge and Walkway Over the Hudson link so many parks and cultural sites on both sides of the spans. Perhaps most important, the bridges make it possible for Poughkeepsie residents without cars to access the trails at Franny Reese State Park, so all have an opportunity to enjoy the benefits of outdoor recreation and exploring nature."

Both New York State Parks and the Bridge Authority will be celebrating significant anniversaries over the coming year. State Parks will be celebrating the 100th anniversary of the creation of the State Council of Parks in 1924 and citizen approval of a \$15 million bond act to build and enlarge a network of State parks. Meanwhile, the Bridge Authority recently kicked off its "BMB100" centennial to celebrate 100 years since the opening of the Bear Mountain Bridge, a span constructed in part to connect with state parks in the lower Hudson Valley. Future installments for the "Bridges to Parks" series are being planned for 2024. Renegades are first-half champs, but fall to Blue Rocks to open series

By now it's clear that the Hudson Valley Renegades will have to settle for being the first half champions of the North Division of the South Atlantic League.

Because they are not winning the second half.

That much is clear after Hudson Valley dropped two of its first three games against the Wilmington Blue Rocks, including a 6-3 decision on Tuesday night at Frawley Stadium in the opener of the six-game series.

Heading into the weekend before the final series of the year at Heritage Financial Park begins Tuesday, Sept. 5, Hudson Valley was below the .500 mark for the second half of the season. The Blue Rocks scored all six runs in the first three innings against Justin Lange. After two walks and a fielder's choice began the first inning, Will Frizzell laced a double to right-center to score Viandel Pena and Yohandy Morales and give Wilmington a 2-0 lead. Lange (1-1) responded with a scoreless second before Wilmington plated four runs on four hits in the third. After Andrew Pinckney and Morales led off with back-to-back singles, Frizzell flew out to left field for the first out. Murphy Stehly then singled home Pinckney to make it 3-0 Blue Rocks. Daylen Lile tripled home a pair and Matt Suggs hit a sacrifice fly to score the final three runs of the inning and pad their advantage to 6-0 over Hudson Valley.

On Wednesday night, Aug. 30, the Renegades slugged their way to a 9-3 vic-

tory. Hudson Valley erupted for two runs on five hits in the second. Jake Bennett recorded the first two outs quickly before the next four batters singled with the last two hits from Cole Gabrielson and Rafael Flores scoring runs to place Hudson Valley ahead 2-0.

And on Thursday night, the final day of August, the Renegades lost 7-5. The Renegades offense threatened against Bryan Caceres in the top of the first inning. Anthony Hall, Jared Serna, and T.J. Rumfield strung together three straight singles to begin the contest before Caceres induced a double play and an inning-ending groundout to keep Hudson Valley off the board.

Wilmington took advantage and plated three runs in the bottom of the first against Yorlin Calderon. Daylen Lile walked and Andrew Pickney reached on an error, before Yohandy Morales laced a two-run double to center. Murphy Stehly later scored Morales on a fielder's choice to extend the Wilmington lead to 3-0. Only one of the three runs scored in the inning against Calderon were earned runs due to the error.

Hudson Valley responded with a three-run third against Caceres. Jared Wegner singled and advanced on a wild pitch from Caceres, before Hall drove him in to cut the Wilmington lead to 3-1. After Serna doubled to place runners on second and third, Rumfield plated them both with a two-run double to tie the game at 3-3.

Out of the bullpen, Luis Velasquez struck out four and allowed just one hit in 2.2 scoreless innings.

And to introduce Heritage Financial as our first naming rights partner was amazing.

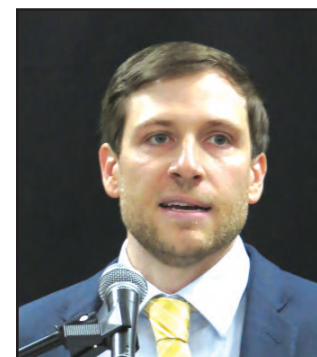
Do you and the staff feel like you accomplished everything you wanted to do this year?

New COVID-19 variant detected in NYC wastewater

FACEP, Commissioner of Dutchess County's Department of Behavioral and Community Health (DBCH). "Hospitalization numbers are a key indicator of the severity of cases. Fortunately, locally, hospitalizations remain low."

State Health Commissioner Dr. James McDonald said, "The Department of Health remains vigilant for changes to the virus that could further threaten our public health. We continue to monitor as new strains have emerged, with a particular focus on BA.2.86 ... Remember, COVID is now a treatable disease and tests are both easy and highly accurate. Antivirals such as Paxlovid are most effective when started within five days of the onset of symptoms."

Dr. Santiago-Rosado said, "Data continues to be tracked by New York State Department of Health (NYS DOH) and we provide those links on our County website at www.dutchessny.gov/coronavirus. New York's main data page is: <https://coronavirus.health.ny.gov/covid-19-data-new-york> which includes positive tests, by region and county, daily hospitalization and ICU totals, bed capacity, trend information, and much more."

The DOH recently contacted nursing home providers statewide to alert them of the increase in COVID-19 infections reported over the past several weeks, and to remind facilities of measures that can be taken to help reduce transmission among vulnerable populations.

As students begin to return to school for the next academic year, Hochul and DOH recommend that schools review current CDC school guidance for COVID-19 prevention and work with their local health department to implement effective and feasible public health measures.

"There has been no discussion of mask mandates from NYS DOH for schools or elsewhere," said Dr. Santiago-Rosado. "While some healthcare providers and facilities may opt to require masks in some circumstances, they are not mandated to do so. Schools will need to continue to report COVID cases for NYS DOH as they do with a full list of other communicable diseases."

If you have symptoms

All individuals who have symptoms of COVID-19 should immediately get tested. Symptoms can include fever or chills, cough, shortness of breath or difficulty

breathing, fatigue, muscle or body aches, headache, new loss of taste or smell, sore throat, congestion or runny nose, nausea or vomiting, or diarrhea.

If a test is positive, consult a health care provider about treatment, as it's important to begin treatment soon after the onset of symptoms to ensure the utmost effectiveness. Individuals who do not have a regular health care provider can find locations for treatment at <https://covid-19-therapeutics-locator-dhhs.hub.arcgis.com/>.

Those with COVID-19 should follow CDC guidance to avoid transmitting it to others, including isolating for five days after the onset of symptoms, as well as masking and avoiding contact with those who may be at higher risk of negative outcomes.

At-home tests are available at many local pharmacies statewide, and New York continues to make high-quality N-95 masks and test kits available to state and county officials by request. Contact the Dutchess County Department of Behavioral and Community Health at 845-486-3400 or healthinfo@dutchessny.gov for more information.

Individuals who have not yet been vaccinated or are behind on booster doses can find the current COVID-19 vaccine sites at <https://covid19vaccine.health.ny.gov/>.

Dr. Santiago-Rosado reminds us that NYS DOH's current guidance for preventing serious illness and spread of COVID-19 (as well as other illness) continues to be:

- Get vaccinated and boosted when eligible;
- Wash hands often with soap and water for at least 20 seconds;
- Avoid touching the eyes, nose, and mouth with unwashed hands;
- Avoid close contact with people who are sick;
- Cover coughs and sneezes;
- Clean frequently touched surfaces and objects;
- Stay home if you are sick;
- Consider wearing a mask to reduce your chance of exposure.

Eight-member Visitation Data Committee to assess work of Hudson Highlands Fjord Trail

Hudson Highlands Fjord Trail, Inc. (HHFT) announced the formation of an independent Visitation Data Committee. The eight-member committee includes Village of Nelsonville Mayor Chris Winward and Trustee Thomas Campanile; Village of Cold Spring residents James Labate and Henry Feldman; Town of Philipstown residents Mary Kate Ephraim and Jeffrey Robins; City of Beacon resident Sarah Mencher; and Town of Fishkill Assistant to the Supervisor Greg Totino.

The Visitation Data Committee will

review and assess the work of HHFT's visitation management and environmental review consultants to ensure that the traffic count and pedestrian visitation pattern data is adequate to determine the potential impacts of the Fjord Trail on local communities. The group will also have early review and discussion of visitation projections and the methodology used to determine them. Hudson Highlands Fjord Trail, Inc. will provide a stipend for the committee to hire an independent consultant to pro-

vide technical assistance to the committee in reviewing methodology and interpreting results.

"Advisory in nature, the Visitation Data Committee has an opportunity to proactively and meaningfully inform the data collection process and visitor projections to ensure that we are receiving robust analysis in keeping with established industry best practices," said HHFT Executive Director Amy Kacala.

Committee members, who are all volunteers, were appointed by the elected leader-

ship of each municipality. They are expected to keep their respective municipal boards informed of key decisions and developments throughout the process. All Visitation Data Committee meeting minutes will be made public.

A kickoff meeting of the Visitation Data Committee was held on August 18, at the Little Stony Point Volunteer Center, in Cold Spring. The committee's next task will be to identify and engage a consultant to provide them with technical expertise through a public Request for Proposal process.

Basements don't lie - they are time capsules of history

In 2005, Colombian singer and songwriter Shakira rocked the club dance scene with her new song based on a universal human truth: Hips don't lie. As strange as it may seem, there is a corollary to the pop sensation's song in the land of local history: Basements don't lie.

I first heard this statement from Town of Red Hook Historian and Old Window Whisperer Emily Majer years ago when discussing the perpetual problem of dating houses. For those who may not yet be aware, house histories are one of the most sought-after forms of the local history product, second only to genealogies.

Decoding the human history encapsulated in the older residences throughout America, and particularly in Dutchess County, is a complicated task. With the county itself turning 340 on November 1st of this year (she doesn't look a day over 225), sifting through the myriad alterations, updates, and renovations that befall many older homes can be an arduous task. But just like hips on a dance floor, basements unconsciously reveal much of the hidden history in older structures.

For an easy example of the stories that basements reveal, we can turn to the hamlet of Upper Red Hook in the town of Red

Hook, one of the oldest and least-altered rural communities in the county. At the intersection of what was once the Post Road and the Road to Salisbury, today's old Post Road North and Spring Lake Road, stands the Lyle House.

In a hamlet of old homes, it stands out, both because of its local perched high on the slope above the road and because of its gambrel roof, a classic old Dutch design. The current owner, Zachary Bayman, was kind enough to lead trustees from Historic Red Hook and myself on a tour of his beautiful home this past weekend. Other folks interested in enjoying their experience should keep their eyes open for the start of Historic Red Hook's annual online auction on November 1st: Zachary has kindly agreed to donate a house tour experience as one of the auction lots.

As one might expect from a home that has been around since approximately 1760 and is so renowned that it is featured in the 1930s Historic American Buildings Survey conducted by the federal government, the Lyle House has undergone some interior changes. Updates have included new finishes on several fireplaces, indoor plumbing, and the addition of a small chapel that now serves as the house's kitchen. If you want to know

more about that chapel story, stay tuned for the November auction. Since few people wish to live 1760s-style anymore, the updates do make sense, even though they serve to mask the exact age of the house's original construction. However, basements don't lie, so a trip down to the four-story house's lowest level was an eye-opening visit to a time almost three centuries gone.

Why don't basements lie? Emily Major could wax eloquent on that question and probably will if you join her and Germantown Historian Tom Shannon at Quittner Antiques in Germantown on

September 9th (check out @germantown-history on Instagram for more details). Emily has crawled through more basements, attics, eaves, and every other odd space in century houses throughout the Hudson Valley than anyone I know.

The general idea seems to be that while people of every era will invest whatever they can in making their houses more comfortable or fashionable, that urge stops at the basement level. With the

exception of modern finished basements (or Prohibition-era speakeasies), a homeowner does not usually bring guests to the house's lowest level. That's where you keep all of the unsightly stuff, like the foundation, the wall and floor framing that keeps the rest of the house standing, the mechanicals (furnace, central air conditioning if you are lucky), and all of those questionable yard sale buys and gifts from distant relations.

After a certain amount of time has passed, it is usually best not to mess around with the basement at all, for fear of altering the structural integrity of the rest of the house. At most, once the mechanicals are in and the boxes of questionable items are stuffed away, one might go down to add another lally column or flip the circuit breaker that tripped. Our natural reluctance to enter them turns basements into time capsules.

A trip down the narrow red stairs to the basement of the Lyle House is a walk through 260 years of history. Once down the stairs and standing on the finished floor (the project of a prior owner), a visitor can look up to see the massive framing joists that have held the building together since New York was a royal colony of the British Empire. Their size and finish is on par with the older timbers visible in Historic Red Hook's Elmendorph Inn. The floorboards visible between the framing members and floor joists are enviably wide and the saw marks upon them clearly demonstrate that these elements were the product of eighteenth-century saw pits rather than more modern circular cutters. Then there is the massive cooking hearth with the remains of the mouth of a beehive oven, which once provided bread for the residents.

That's right. In Dutchess County, it used to be fashionable to have your kitchen in the basement. But most tellingly of all are the two exterior doors. Aside from their massive size and their pintle-mounted pivots (which were pounded into the doorframe while almost red hot), there are the pancake hinges, which were a faux-pas on the architectural fashion front by 1780. But nobody of fashion would have entered the house through the basement, so the massive doors have hung in their original frames while successive generations of owners and occupants have enhanced the higher floors.

The centrality of basements as paragons of architectural truth will be a focal point of a presentation that I will deliver for the Clinton Historical Society on Friday, Sept. 8 at 7:30 p.m.

There is a house in the town that, for all intents and purposes, could pass as a 1920s colonial revival-influenced home, nestled along Meadowbrook Lane. A walk through its living space does turn up a few suggestions of an older vintage, but nothing truly irrefutable. Journey down to the basement, as every true student of old house lore must, and you quickly see a different view. Again, there are the framing timbers and floor joists: not nearly as massive as the 1760s Lyle House, but neither are they of the size and style of anything built since the 1860s. And then there is the basement door. It has the same style of old pancake hinges on a pintle mount as the Lyle House. Moreover, a past visitor, owner, or resident helpfully scrawled some graffiti on the door, as you can see in the image. Is there more evidence than this? Join us in person or by Zoom on September 8th to find out. Program details are available on the Clinton Historical Society's website at clintonhistoricalsociety.org. The next time you read a house history, or talk to an architectural historian, perhaps you might consider seeing what either has to say about the building's basement. It might have something more to say about the house than you would otherwise think.

Building Decarbonization Grants now available for municipalities, nonprofits

Building Decarbonization Grants now available for municipalities, nonprofits Partners for Climate Action (PCA), a local nonprofit, has announced a new grant program entitled "Building Decarbonization Grants" (BDG), which will assist municipalities and local nonprofits in the Hudson Valley that are reducing the carbon footprint of their buildings.

The Hudson Valley has some of the oldest building stock in the country, and the heating and cooling of buildings is the number one contributor of greenhouse gasses in NY State. Therefore, transitioning to renewable energy sources is crucial. Examples of this include municipalities and local non-

profits converting to heat pumps or geothermal, installing solar, upgrading to more green appliances, adding insulation, and switching out old windows. While there are state and federal programs to help with the costs of these upgrades, the pathway to securing these grants can be complicated...many of those come with hefty matches. Some of these grants from larger funders require engineering/design work, which costs money upfront. The new grant from Partners for Climate Action steps in to fill these gaps.

"We have been working closely with municipalities and non-profits through our other PCA programs, and we have been struck by how overwhelming the

Federal and State grant processes are. Just the other day, a volunteer we work with in Columbia County said her village board won't be pursuing any of these types of climate change projects because they require matching funds," explained Vanessa Bertozzi, who co-directs the BDG program.

The applications opened on Sept. 5 and the deadline is November 21. Municipalities and local nonprofits from the counties of Columbia, Dutchess, Greene, Putnam, Rensselaer, and Ulster are welcome to apply. Grants in the range of \$5,000 - \$100,000 will be distributed to selected applicants. Grantees will have a 1-year period to spend their grants.

"We feel the urgency of this moment

and want to see climate action, so we're offering this helping hand," said Paige Ruane, co-director of the BDG and one of the founders of PCA. "In addition to the money, we are also trying to make this process more human." As part of the BDG program, Ruane says they will host guest speakers, lead field trips to inspiring projects, and offer office hours where accepted applicants can bring questions.

PCA has put together a grant selection committee and charged them with a goal of deploying 40% of the grant funds to disadvantaged communities. Interested parties are encouraged to attend the optional info session or visit climateactionhv.org/decarb-grant for the application and more details.

Suspects flee after alleged larceny at Wappingers Falls store; leads to chase on I-84

A call of a larceny in progress at the Home Depot on Route 9 in Wappingers Falls led to a chase on the afternoon of August 29, according to information from Paul J. Italiano, Wappingers Falls Police Commissioner.

Italiano stated that three male subjects had filled garbage bags with electrical equipment totaling approximately \$1,800 and were attempting to flee the store when confronted by store loss prevention. While attempting to stop the individuals, one of the suspects assaulted the store employee, making this incident a robbery, said Italiano.

The suspects fled the scene in a gray Chevy sedan with Florida plates on Imperial Blvd. toward New Hackensack Road, where law enforcement attempted to stop them, said Italiano. The operator allegedly failed to comply and fled from the officer.

The vehicle continued through the Town of Poughkeepsie where it became involved in a minor accident with a motorcycle, according to the release. The vehicle continued to flee through the Town of Poughkeepsie, Town of Lagrange, south on

the Taconic State Parkway to Interstate 84. The vehicle then traveled East on Interstate 84 into Putnam County, stated Italiano.

The vehicle struck a second vehicle on Interstate 84 where due to damage to the right front became disabled between exit 61 and 62 (Route 311 & 312), said Italiano.

Three subjects were apprehended and the proceeds of the theft recovered. The subjects arrested were identified by the Wappingers Falls Police Department as:

- Trent A. Dance, 20, of Brooklyn
- William M. Harvin Jr., 24, of Brooklyn
- Mekhi R. Murphy, 25, of Brooklyn

According to Italiano, all subjects were charged with Robbery in the 2nd. Degree, Grand Larceny 3rd degree. In addition, Murphy was charged Criminal Conspiracy 5th degree, he added. Numerous vehicle and traffic charges were also charged against the driver.

Dance was remanded to Dutchess County Jail in lieu of \$50,000 bail; Murphy was remanded to Dutchess County Jail in lieu of \$25,000 bail and Harvin was released from Village Court, according to law enforcement

official. Dance also has numerous outstanding warrants in other jurisdictions, Italiano noted, and Murphy was issued in excess of 60 Traffic Summonses by multiple agencies.

"It was determined early on that these subjects were the same subjects involved in a Grand Larceny from Home Depot on August 21, 2023 whereby the subjects stole electrical equipment valued between \$5,500 and \$8,800. The subjects had the same MO whereby they entered the store, filled garbage bags with electrical equipment and fled in a gray Chevy with Florida Plates. The Wappingers Falls Police Department opened an investigation. At that time through numerous law enforcement intelligence connections, and the New York City Police Department, our Detective Sergeant was able to identify these suspects from Brooklyn New York. They were further identified as part of a violent organized street gang known as the "Rich Bosses," Italiano stated.

According to Italiano, the vehicle was

determined to be a rental vehicle that was rented using a fraudulent credit card and identity.

"It was determined that other agencies had similar incidents and that the Village of Port Chester Police also has pending charges," stated Italiano.

He went on to state, "Earlier this date, these same subjects committed a similar act in the Town of Ulster. The Town of Ulster Police also have pending charges in that incident."

The extensive investigation and previous research conducted by the Wappingers Falls Police Detective Sergeant resulted in the identification and case connection of this organized theft ring from Brooklyn operating in the Hudson Valley area. The investigation is continuing at this time, said Italiano.

Wappingers Falls Police were assisted by the New York State Police, Dutchess County Sheriff's Office, Dutchess County 911 Center, Putnam County 911 Center, Town of Poughkeepsie Police, Town of Kent Police, Village of Brewster Police and Home Depot Loss Prevention.

Meet the new boss

The new executive director of Cornell Cooperative Extension Dutchess County is off to a good start.



Mary Lou Carolan hit the ground running. On Monday, August 21, she started as the new executive director of Cornell Cooperative Extension, Dutchess County. By Thursday she had introduced herself to County Executive Bill O’Neil, (District 19) Congressman Marc Molinaro, Chair of the Legislature Gregg Pulver, President & CEO of Dutchess Tourism Melaine Rottkamp and me. In fact, I was a member of the search committee chaired by the amazing Lacie Reilly, president of the extension’s board of directors. We worked for years to find the perfect candidate, while the equally amazing Pat Claiborne served as interim executive director.

Cornell Cooperative Extension is a tax-exempt association with an educational mission in conjunction with Cornell University. The mission is to put knowledge to work in pursuit of economic vitality, ecological sustainability and social well being. If you can’t figure out what all that means, you are not alone. One of the biggest challenges facing the new executive director, in my opinion (and of course I have one), is to figure out how to communicate to county residents, and especially to the legislature and county executive, the importance of cooperative extension to the local community.

Cornell Cooperative Extension Dutchess County serves four program areas:

- Agriculture and horticulture;
- Environment and energy;

- Family and consumer education;
- 4H and youth development.

The horticulture hotline, master gardeners program, relatives as parents program, 4H clubs, and the Taste of New York store on the Taconic State Parkway, are all run by extension staff. Research at Cornell University is funneled to New York State residents through the cooperative extension system.

Mary Lou is eager to put all this knowledge to work for our community. Before arriving at extension, she spent her career with community-focused organizations. She loves discovering what a community needs and finding the services to meet these needs. After graduating from U.C. Santa Barbara with a degree in political science and earning a master of library science from Clarion University, Mary Lou spent 18 years in the library world, ending up as executive director of Newburgh Free Library, overseeing a six million dollar budget and managing 60 staff members. She lives in the Town of Newburgh with husband Dan, a daughter, stepson, stepdaughter and a rat terrier named Nikki. She has a garden, but without much soil on her two acres, it’s mostly a rock garden.

I asked Mary Lou how she can increase the visibility of extension in the eyes of the general public.

“By me being visible,” she replied. So far so good.

I found myself telling Marcanthony this story and he was cracking up because he realized the apple doesn't fall far from the tree. Anyway, enjoy this recipe for traditional Italian breakfast cookies. Ciao!

Traditional Italian Breakfast Cookies Ingredients

- 2 eggs
- 1/2 cup vegetable oil
- 1/2 cup milk
- 2 pinches of salt
- 1 tsp. vanilla
- 5 cups flour
- 1/2 cup sugar
- 4 tsp. baking powder
- 1/2 cup granulated sugar

Preparation

Pre-heat oven to 350 degrees F. Line 2 baking sheets with parchment paper.

Mix together flour, salt and baking powder.

In a medium bowl, beat together egg

and sugar until light and frothy (2-3 minutes). Add milk, oil and vanilla, beat well.

Add flour mixture a little at a time and mix with a wooden spoon (do not beat).

Remove to a lightly floured flat surface and knead gently until combined. Dough will be slightly sticky so don't over-flour.

Remove pieces of dough to form into oblong shapes about the size of your thumb. Roll each piece in granulated sugar and place on parchment paper lined baking sheets.

Bake for approximately 10-15 minutes. Let cool. Enjoy with espresso, cappuccino or coffee.

Town of Fishkill Bulk Clean-up Day set September 16

The Town of Fishkill will host the Town-wide bulk clean-up day on September 16, from 7 a.m. to 2 p.m. at Maurer/Geering Park, 1 Geering Way, Fishkill. Proof of residency will be required. No trucks such as U-Hauls, vans, utility trailers larger than the bed of a pick-up truck will be permitted into Maurer/Geering Park to dump their bulk debris. Only ordinary pickup trucks will be allowed.

Cleanup materials must be separated by wood, metals, and soft miscellaneous items. Construction debris will not be accepted.

The following items cannot be accepted due to landfill restriction: Engine oil, lawn and garden chemicals (such as fertilizer), insecticides, pesticides, poisons, brush, leaves, drain cleaning chemicals and other cleaning and caustic solvents, paint materials (such as latex or oil-based paints, turpentine,

shellacs, sealers, mineral spirits and other paint related materials), gasoline, kerosene, and other flammable liquids (including containers that were used for these products) aerosol cans and other pressurized tanks.

Tires will no longer be accepted at clean-up days. One may bring them to Royal Carting for a fee.

In addition:

An e-waste container will be provided. Contact royalcarting.com for accepted items.

A shredding truck will be available 8 a.m. – 2 p.m. Limit three file boxes or three kitchen garbage bags or the like, per household.
