A "Paw"rade. A car show and a "try-athon." Those are just some of the events and activities that will take place during "All for Fun and Fun for All," East Fishkill Community Day on Sept. 17, at the Hopewell Rec Grounds. A fireworks show will complete the day's activities. This year, beginning at noon, there will be a "Pre-play" Sensory-friendly Kid Zone, said Jessica Dickinson, recreation director for East Fishkill. It will be "a

low-key environment before the big crowd," remarked Dickinson. The sensory time will be in the bouncy house and activity area. An activity bracelet purchase is needed. The parade steps off at 2 p.m. from Trink Lane, down to Main St. to Church St. There will be trophies awarded for Best Float and Most Community Spirit Float. According to organizers, the judging will be based on creativity and originality.

"We worked at our planning this year," says event chairwoman Terri McCormick, "to try and keep it family-oriented and to bring as much kindness to the weekend as we can. Pleasant Valley is a community and we want to emphasize that truth." This year's Pleasant Valley Weekend will have much to offer that will be recognized by those who have attended countless PV Weekend events before. There will also be some significant changes, driven to some extent by the aftermath of the COVID period, as well as economic changes in the carnival and insurance industries. This year the mechanical rides from a carnival company will not be available as

the companies involved have been finding it nearly impossible to find staff to run the rides. Additionally, insurance and fuel costs have gone prohibitive due to the current inflation situation. This year Cady Field will be filled with what McCormick refers to as "an amazing collection of inflatable attractions" that will appeal to older kids as well as some specifically for the very young ones. The inflatable attractions are all being sourced locally in Pleasant Valley from the Yobak family, Beth and Nick of YoBounce. These inflatables are a far cry from the traditional children's party bounce houses. Nick Yobak said, "We're excited to do this -"

Local residents in London when Queen Elizabeth II's death announced

Maryann VonEgypt and her daughter, Sarah, arrived in London early in the morning on September 1. Sarah is in England for a year and will be attending The Royal Academy of Music for her master's degree. She is studying musical theatre, said Maryann. On September 8, it was announced that Queen Elizabeth II's seven-decade reign as monarch of the United Kingdom ended with her death. She was 96 years old. "It's very emotional and somber around here. I witnessed people crying at Buckingham Palace and [during] the gun salute," the East Fishkill resident remarked via email. "Sarah went immediately upon hearing of the Queen's passing to Buckingham Palace, and she was overcome with emotions. She has been fascinated with the Royal Family since her early teens. She loves watching "The Crown" and has great conversations with her aunt about it."



Annual fundraiser for 'a gem in the area' hospital set Sept. 18

The Maria Fareri Children's Hospital's 18th Annual Go the Distance Walk and Family Fun Day is set for September 18. Attendees will be in for a day of fun-filled activities to support pediatric care in the Hudson Valley. The day's activities begin at 9:30 a.m. with a one-mile walk around the Westchester Medical Center campus stepping off at 11 a.m. This event is Maria Fareri Children's Hospital's largest annual fundraiser.

Four former patients will be ambassadors of the event. One of the ambassadors is eight-year-old Trevor Roberts. Trevor and his family live in Stormville.

Trevor has been in the care of doctors, nurses and staff of Maria Fareri Children's Hospital since he was an infant.

Brett Roberts, Trevor's father, recently recalled during a phone interview how Trevor was born prematurely, at 35 weeks old.

Brett said that Trevor was transferred from another Westchester-based hospital, where he was born, to Maria Fareri Children's Hospital's Regional Neonatal Intensive Care Unit (NICU).

"He was admitted to the NICU immediately," said Brett.

According to information from Maria Fareri, at seven days old, Trevor was in of abdominal surgery.

Brett said it was "literally a life-saving operation."

At age one, Trevor "was diagnosed with retinoblastoma (eye cancer) in his left eye.

"The tumor caused him to have his left eye removed," explained Brett.

Trevor continues to have follow-up care with the doctors at Maria Fareri. He

recently had a check-up and "he's been status quo," said Brett. After his ophthalmologic surgery, Trevor has been in remission ever since, according to hospital information.

"To treat the worst, you need the best," said Brett. "It takes a special group of doctors, nurses, administrators, and support staff, and that is what is provided" at Maria Fareri.

This will be Trevor's first year as ambassador for this event, noted his father. Trevor has been an ambassador for the hospital before during other events, said Brett.

Participating in events like this and seeing Trevor as an ambassador, Brett said, "It is a reality check, not only for myself and his mother, but for Trevor. You see how [the children] deal with challenges they're dealt."

Asked why others should come and support the event, Brett replied, "Get out there and support children and their families and raise funds for the hospital and services they offer." Brett thanked all involved with the event.

As Brett said, Maria Fareri is "a gem in the area."

"One hopes to never need the services" but if one does, be glad it is there.

Chase Pultz and his family will be participating in this year's event as well. It was in June that Chase was hospitalized after a sinus infection. The sinus infection became so severe that his head became clogged because the drainage had nowhere to go and took over everything.

Dr. Jared Pisapia, a pediatric neurosurgeon at Maria Fareri Children's Hospital,

collaborated with Dr. Lianne DeSerres, a pediatric otolaryngologist at Maria Fareri Children's Hospital, for Chase's initial surgery.

"Chase is a very brave young man. His family was a constant source of support and never left his bedside. I and the rest of his care team at Maria Fareri Children's Hospital are so pleased to see that he has made a wonderful neurologic recovery," stated Dr. Pisapia.

It was noted that Dr. Sheila Nolan, Chief of Pediatric Infectious Diseases at Maria Fareri Children's Hospital, also played a key role in Chase's care.

Jeanine Geiser, Chase's mother, said, "We

are walking in the race to support a cause and Maria Fareri Child Life Services to help other children in need. Child Life Services was with us the entire time looking out for Chase and our family."

Town of Fishkill to host clean-up day Sept. 17

The Town of Fishkill will host its town-wide bulk clean-up day on September 17, from 7 a.m. to 2 p.m. at Maurer Geering Park, 1 Geering Way, Fishkill. Proof of residency will be required.

No trucks such as U-Hauls, vans, utility trailers larger than the bed of a pick-up truck will be permitted into Maurer Geering Park to dump their bulk debris. Only ordinary pickup trucks will be allowed.

Cleanup materials must be separated by wood, metals, and soft miscellaneous items. Construction debris will not be accepted.

The following items cannot be accepted due to landfill restriction: Engine oil, lawn and garden chemicals (such as fertilizer), insecticides, pesticides, poisons, brush, leaves, drain cleaning chemicals and other cleaning and caustic solvents,

paint materials (such as latex or oil based paints, turpentine, shellacs, sealers, mineral spirits and other paint related materials), gasoline, kerosene, and other flammable liquids (including containers that were used for these products) aerosol cans and other pressurized tanks.

Tires will no longer be accepted at clean-up days. You may bring them to Royal Carting for a fee.

In addition: An e-waste container will be provided. Contact royalcarting.com for accepted items.

A Shredding Truck will be available 9 a.m. – 1 p.m. Limit three file boxes or three kitchen garbage bags or the like, per household.

Bulk pickup in Village of Fishkill Sept. 20

The Village of Fishkill will provide a curbside bulk pickup for its residents on Tuesday, September 20. Please have any items for disposal at the curb the night of Monday, September 19.

The following items are examples of what will be accepted:

Metals: Bicycles, washing machines, dryers, lawnmowers, small appliances, metal bed frames, stoves.

* Any items that contain Freon must be Freon free and tagged i.e. refrigerators, freezers, dehumidifiers, air conditioners, etc.

Acceptable soft and fiber products: Cardboard games, clothes, lamps, cushions, plastic items, wood chairs, wood tables, mattresses, upholstered chairs, couches.

Not acceptable under any circumstance:

Paint materials, chemicals, tree limbs, engine oil, lawn/garden chemicals, cleaning chemicals, pressurized tanks, turpentine, shellac, sealers, drums, fuel containers, propane tanks, tree stumps/limbs, auto batteries, oil cans, railroad ties, construction debris, computer monitors.

Chabad of Poughkeepsie to host ribbon-cutting ceremony for new building September 18

The Chabad Center in Poughkeepsie will be celebrating a grand opening and ribbon-cutting ceremony for its new building on September 18. Hundreds of community members and rabbis, including elected officials and other public dignitaries, are expected to attend.

The grand event will begin at 4 p.m. with live music and several concurrent activities for children, including balloon sculpting and a hands-on workshop on making shofars, the ram's horns customarily blown on the upcoming Rosh Hashanah Jewish New Year holiday. A catered buffet will be served from a festive tent set up in the parking lot.

The new addition is centered on a sizable state-of-the-art sanctuary. That worship space is decorated with huge arched win-

dows inlaid with vistas of Rachel's Tomb and the Old City of Jerusalem, both sacred sites in Judaism. Additionally, the centrally-located ark on the traditional east wall—which stores the venerated Torah scrolls—is trimmed with translucent onyx and illuminated by dazzling LED backlights. The expansion also features a social hall complete with brand-new food prep area—plus a first-in-the-region Judaic library with books for everyone.

The Chabad Center, the local synagogue and outreach center of the global Chabad Jewish outreach movement, has serviced the regional Jewish community from its facilities at 63 Vassar Rd. in Poughkeepsie for more than three decades.

The Gala at Grinnell set for September 23

After a two-year COVID hiatus, the Gala at Grinnell is back. The event will be held on September 23 from 5:30-8 p.m. at the library. Tickets are on sale at the library (2642 E Main St, Wappingers Falls) for \$40 in advance and \$45 at the door. Tickets include hors d'oeuvres by Simply Gourmet and wine, beer and soda. This year there will be additional outside seating in the front and in the new covered pavilion.

Grinnell is the 6th oldest library in New York. In 1867, Irving Grinnell and Henry Saterlee established a Circulating Library and Reading Room on the corner of Market and East Main Streets. They charged a dollar a year for membership, and hired a local widow, Elizabeth Howarth, to take care of the books and clean the rooms. By 1880 the library was outgrowing its space and was in perpetual need of funds. The current library was then built in 1887.

In 2013, Grinnell became a Public Library District and the Friends of Grinnell – a 501c3 organization - was formed to help with fundraising. Besides the annual

Gala, the Friends are responsible for the beautiful gardens in the front of the library, the very popular museum passes available to our patrons, the furniture for seating during the many programs held outdoors, support for the Battle of the Books, the murals in the Children's Room and many other extras to help make Grinnell the special library that it always has been. The Friends meet on the first Thursday of the month and welcome new members.

Queen Elizabeth II became queen at the age of 25 in 1952. She was in Africa when she was informed of the death of her father, King George VI, by her husband, Prince Philip, Duke of Edinburgh.

"In speaking with some locals, even my Uber driver this morning, the Queen is all they know, and the prime minister is only a few days appointed. So, there is definitely some uncertainty going on," remarked Maryann.

Liz Truss, the new British prime minister, met with Queen Elizabeth on September 6. Truss took the oath of office at Balmoral Castle in Scotland,

where the Queen was staying.

On September 10, King Charles III was formally confirmed as the head of the British monarchy and held his first audience with Truss at Buckingham Palace.

"I never thought that I would have been in London for the Queen's passing. I was just taking my daughter to school and exploring London with her before she started classes. It's definitely something that I will never forget," said Maryann, who returned to America earlier this week.

The Queen's funeral is scheduled for September 19.

"One of our core missions at DBH is to identify talent and promote those within the organization to roles which can positively impact each club," said Peter Freund, CEO of

Diamond Baseball Holdings. "We are thrilled to elevate two rising stars in Tyson Jeffers to GM and Zach Betkowski to AGM to run the Renegades and continue to build on Steve's incredible legacy in MiLB."

Gliner expounded on his decision in his weekly Q&A, Gliner's Korner (see separate story).

Jeffers, a Mississippi native, began his career in minor league baseball 10 years ago in St. Paul, MN with the St. Paul Saints, current Triple-A affiliate of the Minnesota Twins. In his seven years with the Saints, Jeffers worked his way through the ranks starting as a ticket and corporate sales executive before becoming the Ticket Sales Manager, and eventually, the Director of Corporate Partnerships.

In 2015, Jeffers was part of opening a \$63 million, state-of-the-art ballpark stadium, CHS Field, leading to record setting sales and attendance numbers for the organization. In early 2020, Jefferson

Renegades suffer tough week, fail to make playoffs

One team just got hotter down the stretch.

That's what prevented the Hudson Valley Renegades minor league baseball team from making another appearance in the playoffs.

The Renegades played well down the stretch, but the Brooklyn Cyclones played better.

The Cyclones won for the 15th time in 18 games this past Friday and, coupled with the Renegades' 5-4 loss to the Wilmington Blue Rocks, the victory eliminated Hudson Valley from playoff contention on the season's final weekend.

Brooklyn captured the South Atlantic League's North Division second-half title by two-and-a-half games over the Renegades. The regular season ended on Saturday for all intents and purposes as the Renegades' final game of the year on Sunday was rained out.

On Saturday, the Renegades made a spirited effort and rallied for four runs in the top of the second inning against Blue

Rocks pitcher Michael Cuevas to take an early lead. Carlos Narvaez doubled and scored on a Ben Cowles triple. Aldenis Sanchez followed with an RBI double, and two batters later, Jasson Dominguez clobbered a two-run home run to make it 4-0 Hudson Valley.

Dominguez finished 2-for-4 with a home run, two RBIs and a run scored. The round tripper was his fourth with Hudson Valley, and his 13th overall on the season.

The Blue Rocks responded with two runs in the bottom of the second off Blane Abeyta. With one out and the bases loaded, Ricardo Mendez hit a ground ball to first that went off the glove of T.J. Rumfield, scoring Leandro Emiliani. A Cole Daily sacrifice fly plated Onix Vega to cut the lead to 4-2.

Wilmington took the lead in the bottom of the fourth when Viandel Pena lined a two-run triple to right off Abeyta (5-8) to tie the game at 4-4. Trevor Holloway came in and uncorked a wild pitch to plate Pena with the go-ahead run.

GLINER'S KORNER!

Reflecting on past and looking to the future

Every week, Hudson Valley Renegades President Steve Gliner sits down with reporter Rich Thomaselli to discuss the team in particular, and minor league baseball in general.

So, take us behind the scenes of your decision to step down from the Renegades and join the ownership group (see separate story).

About six weeks ago, I asked to speak with Peter (the CEO of the Diamond Baseball Holdings, owners of the Renegades) and really there's a few things that went into the whole end result. After 35 summers of living off a pocket schedule, I decided it would be nice to stay in the game and not be involved in the day-to-day. I came back here as Renegades President and 38 home games, then added the General Manager title and 66 home games. It was that, timed with the fact that we have two very deserving individuals on our staff ready for advancement. In my career, I had people

look out for me – Rip Rowan in Albany and Skip Weisman here. I look at the big picture and remember who took care of me and I want to do that for others and help them grow into their careers. (New Hudson Valley GM) Tyson Jeffers has been preparing for this for a long time. It's very similar to me; I was in baseball for 10 years before becoming a general manager.

You'll be staying in the Hudson Valley and overseeing the projects that need to be completed over the next two years at Dutchess Stadium. Tell us where that stands.

Well we are re-doing the clubhouse (to comply with Major League Baseball standards). The first phase of the project our organization starts basically in the next few weeks. I was part of a major project in Fort Myers where we basically took the stadium down to the studs. We're going to turn over the clubhouse to the visiting team and we will be in a temporary facility. The outfield wall is next, so we will



put padding on that. Both bullpens will be moved off the field and into a new facility, and we will enclose the batting cage.

Was it important to you to remain here in the Hudson Valley?

Yes, it was important to have everything in line. I mean, it could have been done remotely, but it would have involved a lot of travel. And it also helps to be here for the transition of leadership. I told them I am here as often as they need me or as little as they need me. Personally, I mean, my goodness, I leaned on Skip every day after becoming GM. But Tyson and I have worked side by side for two plus years and I knew what his career aspirations are. I've always considered myself a mentor and a teacher as well.

Will you have other responsibilities with Diamond Baseball Holdings besides the Renegades?

Not initially. I'm really going to focus on this project because it needs the full attention. We'll see as what happens as DBH grows and if any other opportunities come up.

multiple times for industry excellence, receiving numerous Golden Bobblehead Awards, as well as the Larry MacPhail Award

in 2019, awarded to the top promotional team in all of Minor League Baseball.

Gliner has had two stints with the Renegades throughout his 35 seasons in minor league baseball. He was part of the initial Renegades staff that started the team in January 1994. He became the Renegades Vice President/General Manager in October 1998 and was elevated to President/General Manager in September 2001. He remained in that role until he departed in September 2003 for the same role with the Fort Myers Miracle in the Florida State League, where he was also the Spring Training Coordinator for the Minnesota Twins.

In 2014 and 2015, he helped to oversee a complete renovation of Hammond Stadium at the CenturyLink Sports Complex. After 13 seasons in Fort Myers, Gliner returned to the Renegades in January 2017 as Team President and became President/General Manager in October 2018.

Gliner begins his new role with Diamond Baseball Holdings as a consultant to the Renegades, focusing on significant construction projects that will be taking place at Dutchess Stadium over the next two years. Among numerous accolades, Gliner was elected to the Florida State League Hall of Fame in 2019.

A Fair to Remember for 4-H club members

A total of 251 4-H youth entered 1,864 classes at the 2022 Dutchess County Fair. Dutchess has by far the strongest agricultural program of any county in the Southeast Region of NYS.

It is exciting that the dairy cattle program is flourishing with 34 youth entering a multitude of classes. Both dairy goats and hogs saw 32 individual entries, while 30 youth entered sheep showmanship. Poultry, rabbits, beef and llama/alpaca were also well represented.

The Dutchess County Youth Livestock Sale took place Saturday, Aug. 27. Thanks to generous buyers, bidding was competitive and a full catalogue of poultry, lambs, hogs, goats, and beef sold well. An addition to the sale this year, was the auction of a beautiful quilt stitched by long-time 4-H supporter Sandy Hicks, which raised \$1,500 for the 4-H Livestock Sale Scholarship Fund.

Entries in the 4-H Exhibit Hall were up over 2021 as youth took the opportunity to enter arts, science and craft projects. The quality was high; over 60 items were selected to progress to the NY State Fair. Approximately 15 percent of those received outstanding awards and the majority of exhibits were awarded blue ribbons. Professional Development and Leadership classes attracted 35 entries in activities such as Flag Bearer and junior evaluators who help judge Exhibit Hall

entries. In addition, nine youth worked in the cafeteria over six mornings, helping provide a home-cooked, affordable breakfast for those on the fairgrounds prior to the opening.



Hudson Valley Shakespeare Festival reveals new open-air theater design

The Hudson Valley Shakespeare Festival (HVSF) revealed images of the new open-air theater design for its permanent home in Garrison. The design concept has been submitted to the Philipstown Planning Board as part of the launch of the next phase of its environmental review process.

As an alternative to the Festival's existing white fabric tent, the new design consists of an open-air theater constructed using a palette of natural materials with the textures and muted colors of stone, slate and wood. Designed with sensitivity to the preservation of the area's scenic views, the proposed structure presents a thin ground-hugging profile and uses a floating timber framed roof whose shallow horizontal curves echo the ridge lines behind and around it.

HVSF's new home would be the first Leadership in Energy and Environmental Design (LEED) Platinum purpose-built theater in the country. Solar panels, rainwater capture, reduced embedded carbon and other design elements are designed to minimize climate impacts and better protect the theater from extreme weather and wear. The theater would sit in the midst of year-round vegetative screening and meadows ecologically restored from their long-time prior use as a golf course. The platinum designation is the highest level of LEED certification and

shows HVSF's strong commitment to sustainability.

In the filings made with the Planning Board, HVSF also proposed eliminating the new entrance to Snake Hill Road and bridge that would have been required as a consequence of the new entrance. The Festival's experience performing on the site this summer confirmed that the existing entrance on Snake Hill Road was sufficient and safe operating on a one-way only basis. "The bridge would have been a major expense for the Festival, and we are greatly relieved that it appears to be unnecessary," said Davis McCallum, artistic director of HVSF.

Our audiences this summer loved our new home," said McCallum. "We operated without any of the impacts or problems that some had feared. And now, with our new theater design, our project more fully reflects the unique character of this extraordinary place and extends the deep tradition of environmentalism in the Hudson Highlands. Philipstown has been our home for over three decades, and we are grateful for the broad and strong support of the community as we advance to the next stage of the SEQRA review process."

New flowers for 2023

Varieties will improve upon some favorite annuals

Bee Balm grows wild in the Hudson Valley. You can find it at Stanford Wildlife Preserve, and in open meadows just about everywhere. Bee Balm (Monarda) is a state-ly perennial wildflower topped with crowns of pink or red blossoms.

But wait! What is that white powder almost suffocating the plant? It turns out the bee balm is highly susceptible to a pathogen called powdery mildew, which also attacks phlox, cucumbers and zinnias.

I point to this example when anyone questions the need for new varieties of flowers or vegetables. Why do we need a yellow petunia when we already have yellow marigolds? Aren't plant breeders interested in appearance and durability at the expense of flavor and fragrance? And what are they doing inserting fish genes into strawberries?

Okay. Maybe some geneticists are going a little nutty. But consider the benefits of the powdery mildew resistant monarda "Jacob Cline," garden phlox "Omega," cucumber "Diva" or zinnia "Zesty."

Here are some of the newest flower varieties that will be available to gardeners in 2023:

• **Verbena Lascar Lava Orange** – This past August was possibly the hottest since sometime back in the Pleistocene era. I admit that as the climate heats up we'll have more to worry about than whether our verbena plants stop flowering. Verbenas traditionally go dormant in the heat of summer, but not the new Lascar

series, which blossomed nonstop in our garden (Sue and I receive samples of next year's varieties to trial). Lascar Lava Orange glows like it's on fire, and is also resistant to powdery mildew. From the breeders at Ball Floraplant.

• **Coleus Colorblaze Mini Me Watermelon** – Ever since legendary plant breeder Allan Armitage developed the coleus "Alabama Sunset," vegetative coleus has been taking the gardening world by storm. Thousands of new varieties are flooding the market, some popular only for their weird names – "Chocolate Covered Cherry," "Fishnet Stockings," "Dirty Martini," "Texas Parking Lot." Now along comes "Colorblaze Mini Me Watermelon" from Proven Winners. Interesting blazing cut-leaf foliage, with no ugly flower spikes. Coleus is cultivated for its colorful leaves, not its flowers.

• **New Guinea Impatiens "Rollercoaster Orange Shakin"** – New Guinea impatiens have come a long way since they were brought to our shores from the Solomon Islands in 1884. If you want to see just how far, visit Vassar Brothers Medical Center in Poughkeepsie for a stunning display across from the front entrance. The Dummen Orange Company has unveiled a line of new guineas with double flowers. Alright, plenty of other flowers have double blossoms – roses for example, but these new impatiens are worth the breeders' trouble. They grow

best in light shade. "Orange Shakin" is a brand new color in the series.

• **Nemesia Aromance Mulberry** – Nemesia is often overlooked as a garden or container flower because of its reputation for going out of bloom in the summer. Breeders had been selecting for summer bloom, but along the way, nemesia's delicate fragrance was overlooked. Now we have nemesia "Aromance Mulberry" from Proven Winners, a summer blooming nemesia with a powerful sweet fragrance. The best of both worlds.

• **Zesty Zinnias** – For centuries zinnias have graced gardens but were not always prized because of the ugly powdery mildew

that covered the leaves eventually. In 1999 the first mildew-resistant zinnia series, Profusion, was introduced by Sakata Seed Corporation. In 2017 along came a taller zinnia called Zesty, also mildew resistant, with large double flowers, from Pan Am Seed. For 2023 two new colors have been added - yellow and orange, real stand-outs in the trials Sue and I saw at the Botanic Garden at Cornell University.
