Attendees can take part in farm tours, a silent auction and listen to poet Cassandra D. Clarke. There will be local artisans, said Pam Porath, a member of the Poughkeepsie Farm Project Board of Directors.

"A lot of our fall crops have been harvested and in storage," noted Emily Eder, who is the farm director. Among some of the crops are fennel, sweet potatoes and green peppers, said Eder.

toes and green peppers, said Eder. Eder remarked, "It's a great opportunity to set the produce from the fields and is prepared by chefs and [it will be] a fun eating experience."

Larissa "LaLa A" Alvarado is the herbologist on the farm.

"I'm a root educator. I do the herbal workshops and in charge of the herbal culinary and medicinal herbs," explained Alvarado.

Some of the more than 70 herbs grown on the farm are tulsi, holy basil, lemongrass, lemon verbena and chamomile, said Alvarado.

"The feedback is that people love the workshops. They are very hands-on. We

End of an era – Cady family closes Masten Feed Store in Pleasant Valley

A long-standing landmark on the Pleasant Valley Main Street and, perhaps more importantly, a central example of Pleasant Valley's traditionally welcoming culture, the Cady Family's G. E. Masten Feed Store, closed this past Saturday, Oct. 15.

Owners Pam and Matt Cady made the announcement at the end of September, heralding the end of their family's 41 years in the agricultural support business. "You know," said Matt Cady, "there's been a feed store at this location since the late 1800s. We've kept it going since I was in grade school."

The Cadys note that the many aspects of a changing business climate - "the introduction of online suppliers, the change of individual shopping habits to more superstore/nationwide chains, the difficulty of finding employees, along with the increasing prices and difficulty in obtaining product has led us to make this decision."

Dutchess County has a rich history of producing local athletes who have gone on to professional careers in numerous sports, from baseball to football to basketball to boxing and more.

When it comes to soccer, however, Roy C. Ketcham High School graduate Tyler Adams might be one of the brightest of them all.

And he never forgot his roots.

The 23-year old star – who plays professionally for Leeds United in the English Premier League and, more importantly, is a member of the United States Men's National Team that will compete in the quadrennial World Cup in Qatar starting next month – was back home in the area this past weekend to help open two new mini soccer pitches at Pulaski Park in the City of Poughkeepsie.

The mini-pitches were made possible through a personal contribution from Adams, as well as contributions from the U.S. Soccer Foundation, Target, the City of Poughkeepsie and Dutchess County. Adams, his family, U.S. Soccer officials, City of Poughkeepsie Mayor Rob Rolison, and various officials from the city and the county were on hand for the opening ceremonies.

"Building two new mini-pitches in Pulaski Park is such a unique way to give back to the game and to the community where I first started," Adams said.

Adams rose to fame during his high school playing days, but his prodigious talent allowed him to become the youngest player ever drafted into the U.S.-based professional Major Soccer League with the New York Red Bulls.

Adams said he was thrilled to be able to contribute to the sport's further development, especially in the inner city.

"Through these pitches, more children in Poughkeepsie can learn values that they will take with them well beyond their playing careers – the same values that I learned through my support system," he said. "Thanks to my family's support and to all partners involved in this amazing process and creating an environment where kids

can blossom."

"We are pleased to see the opening of the mini-pitches, a collaborative project that went from concept to completion within a matter of months," Rolison said. "The mini-pitches

are part of a much broader, multimillion dollar initiative by the city to make upgrades to the park system, and it's fulfilling to see these projects getting completed for our residents to enjoy.'

The Pulaski Park project is part of more than 100 mini-pitches the U.S. Soccer Foundation and Target have installed together since 2018. The goal is to install 1,000 by 2026.

County awards more than \$200,000 in historical grant programs

Dutchess County Executive Marc Molinaro announced today \$205,000 in funding has been awarded for 16 local programs, as part of the County's Historical Sites & Museums Infrastructure grant program, which provides funding opportunities for local nonprofit historical societies and museums. The program supports local historical institutions through vital capital and operating infrastructure investments, ensuring the continued preservation of Dutchess County's unique heritage.

County Executive Molinaro said, 'Dutchess County's history tells our community's unique story and continues to resonate with us today - providing perspective on our past as we build toward our future. That's why it's so important to support various local organizations throughout the county that preserve our history. With these grants, Dutchess County's distinguished history will be safeguarded for future generations to glean knowledge and take inspira-tion from, as they inherit this great legacy."

Announced in June 2022, Dutchess County's Historical Sites & Museums Infrastructure grant program addressed critical capital and operating funding gaps that impact the preservation of local historic and cultural institutions.

One-time grants were available between \$5,000 and \$30,000 per institution, with capital infrastructure projects limited to facilities owned by a non-profit organization. To be eligible, facilities must be a separate structure, and funds cannot be used for improvements to a room used for or by historical societies within a facility owned by another entity.

Project Description: Purchase of archival supplies, hardware and software necessary to provide enhanced collaborative programming, exhibitions and audience engagement.

Project Description: Preservation and accessibility enhancements to several East Fishkill Historical Society structures including chimney repairs, a new roof and an ADA-accessible ramp.

Operations Manager at the Poughkeepsie Farm Project Lydia Hatfield said she started at the farm as a member of the Community Supported Agriculture (CSA).


"We're going to have some great entertainment," remarked Hatfield. There will be Ray & Friends Band, D.J. Wisdom, Middknight & Nico at the event to

Wappinger budget process has started

On October 3rd, I delivered to the Town Board my 2023 Tentative Budget. On October 11th, the Town Board began its budget review (the remaining budget planning dates are found at: www.townofwappingerny.com). Unfortunately, deteriorating U.S. economic conditions pose a major challenge to the Tentative Budget. Those assumed conditions include:

- Inflation will remain very high and likely to continue well into 2023;
- Increasing interest rates at least into early 2023. Interest rates will remain high throughout 2023;
- · Retail sales will continue to experience unusually higher costs because of inflation, rising interest rates, and worsening supply chain problems, etc.
- · The labor market will face greater pressures as inflation continues and recession looms. I fear unemployment significant growth during the months ahead; and
- · As a result of the above, household savings may be depleted at accelerating rates.

These conditions will place much heavier burdens on each of us, most especially our residents with limited, if any, discretionary spending capabilities because of rising costs of housing (especially mortgage rates), food, home heating resulting in depleted discretionary spending/ sav-

Because of these and other challenges, such as the NY State-mandated 2% tax levy cap for 2023, I prepared a conservative budget that keeps the 2023 tax rate basically flat year-to-year (in the Tentative Budget there is a very small decrease in the Village/Tons tax rates per \$1k of assessed property value).

But, because assessed home values increased in 2022 (in part due to COVIDinflated 2021 property values), actual tax payments may increase for many in 2023. Because of this likely increase for many, I have tried to keep 2023 tax rates flat.

The 2023 Tentative Budget is based on a number of considerations, including:

- · Limited Town departmental capital expenditures. We will discuss capital projects during a special Board meeting on Saturday, November 5th from 10 a.m. to noon at Town Hall. We may not be able to incur any significant capital expenses in 2023.
- · A sharp decrease in mortgage tax revenues over 2021 and 2022 levels.
- I projected sales tax revenues to be higher than the minimum-guarantee level built into our 2022 budget. But I believe that sales tax revenue projections may be too high and, therefore, they may need to
- Fully maxing out the 2% tax levy cap. No growth in Parkland Trust funds which have been used historically for improvements to our Town parks and park facilities. A limited drawdown may
- Significant growth in costs for medical coverage, insurance and pensions for

Town employees because of inflationary pressures.

- Growth in employee compensation at a level below the projected 2023 COLA.
- A \$750,000 drawdown of the Town's B Fund. Since we maintain a healthy B Fund, the drawdown will not weaken that fund balance. However, we cannot continue significant drawdowns of any fund balance in future years. If the Town Board were to reduce this drawdown without similar increases in revenues or operational cost reductions, then the tax levy rate may need to increase.
- No material revenue growth is projected for our principal operating fund the A Fund. There is no drawdown of the A Fund-fund balance.
- No change in Highway DB Fund revenues and no drawdown of the DB Fundfund balance. However, major winter storms may require some unplanned drawdown.
- No contingency funds reserved for any significant unanticipated costs.
- No use of the Federal ARPA-Covid funds beyond Sewer and Water infrastructure costs.
- No anticipated cost increases other than inflationary ones for our ambulance and police services. However, we may need to make upward adjustments.

While keeping tax rate growth down, below other neighboring communities, the most critical responsibility of our Town Board will be to ensure that we can provide continued services that meet local needs for the welfare, safety and security of our residents and businesses. All-thewhile, the Board will continue to focus on a fair, open, and responsive budget that incorporates greater efficiencies and costeffective programs.

During the remaining budget meetings/public hearing, the 4 other Town Board members will review my Tentative Budget and will likely make a number of adjustments as in past years.

Gala celebrates decade of I Am Beacon

County opens Housing Creation and Preservation Program process

The Dutchess County Department of Planning and Development last week opened its application process for the Housing Creation and Preservation (HCP) Program, an integral part of the newly established Dutchess County Housing Trust Fund (HTF), established to provide financial support for the creation of affordable housing distributed throughout the county.

Both private for-profit and non-profit developers are eligible to apply for funding through a competitive application process,

with approximately \$9 million available. Applications will be accepted via an online portal through Nov. 30th at 4 p.m.

This application round covers two eligible activities within the HCP Program:

•Housing Creation: The creation of new affordable rental housing via new construction, rehabilitation of existing housing stock, and adaptive reuse of nonresidential structures. Funded projects may be fully affordable or mixed-income; single-room occupancy rental housing is eligible under this category.

•Housing Preservation: Acquisition and/or rehabilitation of occupied, naturally-occurring affordable rental housing with income-eligible tenants to secure long-term affordability with applicable compliance periods.

Developments awarded HCP funds may also receive additional funding from other sources, including private financing / bank loans. Developments where other funding is committed will receive a higher priority. Tax credits and HCP funds may be used together.

The Dutchess County Housing Trust Fund requires that a minimum of 80% of a project's funding through the Housing Trust Fund be targeted to households with incomes up to 60% of the Area Median Income (AMI) for Dutchess County. The remainder of a project's funding may support units targeted to households with incomes up to 80% the County's AMI.

Once eligibility is determined, applications are reviewed jointly by Department of Planning and Development staff and the Dutchess County Housing Trust Fund's Project Review Committee (PRC), with a particular focus on project underwriting and overall compliance with program parameters.

The creation of the HTF is an outgrowth of the 2022 Dutchess County Housing Needs Assessment, released in April. Recognizing both the importance of safe, affordable housing and the challenges that many of our residents continue to face with regard to housing, Dutchess County has moved swiftly to set up the Housing Trust Fund and launch this first round of funding.

County Executive Marc Molinaro said 2022 Policies and Procedures.

"Countless communities throughout the nation, including Dutchess County, have faced housing availability and affordability challenges for a number of years. We know housing costs are outpacing incomes, and rental housing vacancy rates have been the lowest we've seen in over 40 years. In addition, the COVID-19 pandemic likely put additional strain on our market. We encourage developers looking to create affordable housing to apply for the Housing Creation and Preservation Program and help Dutchess County change local families' lives."

The HTF will provide a flexible and nimble funding source to aid in the implementation of a variety of affordable housing efforts throughout the County. The minimum amount of subsidy under the HCP is \$10,000 per unit, and the maximum is \$175,000 per unit.

Rental housing located in any Dutchess County municipality is eligible, but priority will be given to:


• Housing that helps a municipality meet its portion of the minimum recommended countywide Fair Share Distribution, outlined in the 2022 Dutchess County Housing Needs Assessment;

• Housing in communities or neighborhoods with limited affordable opportunities;

• Housing which is located in established or emerging town/village centers, along transit routes, and/or near employment and services including educational, recreational, health and municipal; and

• Housing that promotes greater choice of housing opportunities.

DBCH to host Monkeypox Vaccine Clinic Oct. 25 in East Fishkill

The Dutchess County Department of Behavioral & Community Health (DBCH) will be hosting an upcoming JYNNEOS/Monkeypox vaccine clinics for residents at the highest risk of monkeypox infection. Education, outreach and vaccinations have helped keep the number of reported monkeypox cases in Dutchess County very low, with no new cases reported since August 24th and no current active cases. An earlier clinic was held on Oct. 17th.

• October 25th from 1 to 4 p.m. Sloop Brewery 755 East Dr., Suite 106

East Fishkill

Residents must meet current eligibility criteria set by New York State to register for an appointment. According to the NYSDOH, those eligible for monkeypox vaccine at this clinic include:

- Individuals with recent monkeypox exposure to a suspected or confirmed case of monkeypox in the past 14 days.
- Those at high risk of recent exposure to monkeypox, including members of the gay, bisexual, transgender, and gender non-conforming community and other communities of men who have sex with men and who have engaged in intimate or skin-to-skin contact with others in the past 14 days in areas where monkeypox is spreading.

- Individuals who have had skin-to-skin contact with someone in a social network experiencing monkeypox activity, including men who have sex with men who meet partners through an online website, digital app, or social event, such as a bar or party.
- Any individual that may be at risk of future exposure to infection with monkey-pox, even though they are not at high risk of recent exposure to monkeypox.

The JYNNEOS monkeypox vaccine is given in a two-dose series, 28-35 days apart. Individuals are considered to be fully vaccinated two weeks after the second dose of vaccine

DBCH Commissioner Dr. Livia Santiago-Rosado said, "When monkeypox cases were initially being reported, our public health team got right to work educating the public about monkeypox and offering vaccinations to those at the highest risk. Thankfully those efforts have been successful as there no active cases in our community. We encourage everyone, particularly those in high-risk populations, to be mindful about monkeypox and consider vaccination if eligible."

The first case of monkeypox in Dutchess County was reported on July 21st. There have been a total of 10 cases, including the initial case, reported in Dutchess County, with no new reported cases since August 24th. DBCH Public Health Advisors worked in conjunction with local organizations and businesses, including Dutchess Pride, Sun River Health, Sloop Brewery in East Fishkill and the Roosevelt Bar in Beacon, on community outreach to inform and educate the public about Monkeypox and how to avoid spread. Several vaccination clinics have been held for eligible residents and to date more than 209 individuals have been vaccinated.

Monkeypox virus is part of the same family of viruses as variola virus, the virus that causes smallpox and is spread through close, physical contact between people and anyone can get it. However, based on the epidemiology, certain populations are being affected more than others, including men who have sex with men (MSM). The virus spreads through contact with an infected person's rash, or potentially through respiratory droplets from prolonged face to face contact. The virus may also spread through contact with objects that were used by an infected person (clothing, bedding or towels). Children aged 8 or under, and pregnant or immunocompromised individuals have a higher risk of severe illness or complications, but these are rare.

The Centers for Disease Control and Prevention (CDC) recommends residents take the following steps to prevent getting monkeypox:

- Do not touch the rash or scabs of a person with monkeypox;
- Avoid close, skin-to-skin contact with people with a rash that looks like monkey-pox, or who may have been exposed to monkeypox;
- Do not kiss, hug, cuddle or have sex with someone with monkeypox or someone suspected or known to have been exposed;
- Do not share eating utensils or cups with a person with monkeypox or someone suspected or known to have been exposed;
- Do not handle or touch the bedding, towels or clothing of a person with monkeypox or of someone suspected or known to have been exposed; and
- Wash your hands often with soap and water or use an alcohol-based hand sanitizer.

A person is considered contagious until all lesions have healed over with intact skin. The CDC advises those sick with monkey-pox to isolate at home and stay in separate from others and pets, when possible.



Hear about the 'Mothball Fleet' during historical society presentation Oct. 27

The Wappingers Historical Society (WHS) will host a talk entitled "Mothball Fleet on the Hudson," presented by local historian and author Anthony Musso. Musso will discuss the purpose and fate of the fabled "mothball fleet," which many locals referred to as "the ghost ships" which were anchored in the Hudson River from 1946-1971.

In 1946, the National Naval Defense Reserve Fleet was established and eight sites around the nation were selected to store ships from World War II, and keep them ready for action in the event of a national emergency. One of the locations chosen was the Hudson River. Hudson River Defense Reserve Fleet (also known as the Mothball Fleet) remained active at Jones Point, just south of the Bear Mountain Bridge, from 1946 through 1971.

At its peak, 189 vessels were anchored there, side-by-side in neatly arranged rows that spanned the river for several miles south. Attendees will learn about the origins of this fleet and what became of it.

Musso's presentation will take place on October 27th at 7 p.m. at the Town of Wappinger Town Hall, 20 Middlebush Road, Wappingers Falls. The presentation will begin immediately following a brief WHS business update. Wappingers Historical Society members and the general public are invited to attend. Light refreshments will be provided. It's been an eventful time.

Pam recalls that when they first opened up, she was almost alone in the store six days a week as her late husband, Don, was still working at his day job. "Men would come in to get something and ask if my husband or one of the men was around. I grew up on a farm, so I knew about all of the products, but some of them weren't quite ready to trust a petite woman."

"We used to have some fun with that," Matt recalled. "One of these guys would come in and dad would be there. He'd say 'I'm not sure'. . . and then ask Mom for the answer. After awhile, these folks came to understand that she knew a lot more than they ever expected. In fact, when we went into pet foods, she did all the research, so when somebody would come in and ask what they should give their pet - dog, cat, rabbit, gerbil, anything - she always knew what to tell them because she made sure she had the best things available and studied them to be certain. Nothing got in here unless she knew it was the best."

After 41 years of greeting the public six days a week with her infectious smile and all-but-encyclopedic knowledge of local agriculture, Pam is starting to think about what comes next.

"My daughter and I are going to visit our Amish friends in Pennsylvania, first," she said. "Then maybe I'll help out at the food pantry or the library. I want to keep seeing people as much as I can." She remarks that some of her female friends are promising regular luncheon gatherings as well.

Talking about their lifetime's experiences at the feed store, Pam and Matt recall people and events with a warm tone.

'The people were the most important part," said Pam. "We have had several generations of the same families coming in. A mom would bring in one of the little ones when she came in and now that little one is bringing in his or her own little ones. I've loved watching that."

'We've had a lot of memorable times and regular events that we always enjoyed," said Matt. "The 'flea dip' was kind of an annual thing. We'd put out a kiddie pool filled with the dip and folks would bring down their dogs. They'd stick 'em in the pool and then we'd hose them down and wipe them with towels. It was such a production that Donnie Traver and a couple of folks from the "River Bank Banjo Band" would come down to play for the afternoon. They called themselves the "Flea Dippers Band."

One year a guy showed up at the fire hall up the street driving a real covered Connestoga Wagon. As Matt recounts the tale, "It must have been in the mid-'90s. He said he was going from Maine to California. He was carrying his food and stuff along with some chickens and rabbits. The fire guys told him he could find food for the horses and for the other livestock down here. That was the only time we had a Connestoga Wagon parked out front. I always wondered if he made it to California."

Another favorite annual event has been the Photos with Santa Paws. Customers brought in their pets or maybe other livestock for a photo with Santa. "People always looked forward to this one," said Matt. "We will be working with the Salt Point Fire Company to continue the tradition.'

Likely the biggest annual event the store supported all of these years has been the Dutchess County Fair. Matt notes that his mom began at the Fair when she was 8 years old. "I showed a Hereford cow," Pam recalled, "It might have been one of Cal Smith's cows." Then there was the year she showed up competing at the same time as FDR, Jr. Pam appears to have won that one, too.

The Cady family is well known throughout the county for their commitment to community service, whether through the volunteer fire departments, Trees for Troops - the Christmas trees for service military service personnel program and other veterans related projects. They've also made sure their business was giving back, too.

"I'm a fire investigator for the county," said Matt. "I wanted to do some more, though. So, we've provided the food to feed the sheriff's departments fire investigative K9s." In recalling that service, Cady recites the names of each of the dogs with a warm smile. "Great dogs," he said.

For the Cady family, the Feed Business has always been less about commerce than it has been about the people involved. "It's the people I'll miss the most," said Pam. She and Matt finished their announcement with a thanks to the community. "We want to thank you for your continued support and loyalty over the years. It has meant the world to us to have been chosen by you to take care of your most precious pets and animals over the years. Thank you."

They mean it most sincerely and the community spent much of the past week coming through their door to return that thanks with sincerity.



Free Rabies Clinic at DCSPCA set for Oct. 23 in Hyde Park

The Dutchess County Department of Behavioral & Community Health (DBCH) is partnering with the Dutchess County SPCA to host a free rabies vaccination clinic for dogs, cats, and domestic ferrets three months of age and older on October 23, at the Dutchess County SPCA located at 636 Violet Ave in Hyde Park from 8 a.m. to noon. Pre-registration is required, and residents can register at DCSPCA.org or by calling the DCSPCA at 845-452-7722 extension 425.

There is no charge for Dutchess County residents; non-residents will be charged a fee of \$10 per pet vaccinated. All dogs must be on leash and cats and domestic ferrets must be in carriers. Vaccinations will be good for three years for pets with proper proof of prior immunization. For those without proof, the vaccination will be good for one year.

In New York State, rabies shots are required for all cats, dogs, and domestic ferrets by the age of four months. Revaccination is then required on a regular schedule to keep the animal properly immunized against the rabies virus. Owners can be fined up to \$200 if they fail to get their pets vaccinated and keep them up to date.

DBCH Commissioner Dr. Santiago-Rosado reminds pet owners of the importance of vaccinating all dogs, cats, and ferrets, even if they are considered "house pets" and remain indoors. If an animal has

not had a rabies vaccine or is not up to date on the rabies vaccine and interacts with a rabid or suspect-rabid animal, the pet must be either promptly euthanized or placed in quarantine for six months to protect other animals and people in case the pet develops rabies. These mandates do not apply for a vaccinated pet in the same situation. In such cases, only a booster dose of rabies vaccine would be given within five days to treat the pet.

DBCH is available 24/7 to assist with any questions or concerns regarding potential rabies exposure to people or domestic animals. Pet owners should report to DCBH any incident in which their pet has been bitten by or has an open wound exposed to the saliva or nervous tissue of a domestic or wild animal. Staff will investigate and advise the pet owner of any necessary steps they should take to ensure the safety of their animal.

Residents who see an animal acting strangely are advised to contact their local police agency. If a person has been bitten, or a domestic pet is bitten or is in contact, with any animal, they're to contact DBCH immediately at 845-486-3404 Monday through Friday 9 a.m. to 5 p.m., or 845-431-6465 on nights and weekends.

Cemetery tours, crawls highlight county history

While it seems like we are receiving all of our overdue summer rain at one time, the changing leaves signal that fall has once again returned to the Hudson Valley.

Amidst harvest festivals, apple picking and corn mazes, a bevy of local history bounty is up for offer as historical societies roll out their customary annual events. There is a special slate of programming on offer this month for the spooky season: Cemetery tours.

Dutchess County now offers residents an expansive menu of options for all tastes, ranging from self-guided scavenger hunts in burial grounds to fully costumed dramatic interpretations. Ranging in location from Hyde Park to Pine Plains, connoisseurs of the county's buried past have a month's worth of opportunities to explore the personages of Dutchess past.

Historic Red Hook, the rookie on the list, returns for a second year of the Cemetery Crawl. Introduced in October 2021, this program combines self-guided tours of five local burial grounds with a scavenger hunt to encourage locals and visitors alike to probe the stories behind the tombstones.

For those with a competitive spirit, the scavenger hunt sheets (available online from historicredhook.org/cemetery crawl and in-person at the Elmendorph Inn) present a series of clues and questions that challenge participants to find key data recorded on monuments in each cemetery. Scavenger hunt sheets are due on Friday, October 21. On October 30 at 1 p.m., contestants are invited to gather at the Elmendorph Inn for an awards event. For individuals and groups more interested in stories of the past, the program presents biographies of 59 individuals, ranging from Civil War generals to local bootleggers and arsonists. Read their biographies and check out their monuments while enjoying the splendid fall weather.

For people who prefer graveyard drama, there are three programs featuring costumed interpretation. The Pine Plains crew returns this year to Evergreen Cemetery on the north side of the town center, on Main Street, to explore a cast of real-life rural Dutchess characters.

Attendees will hear documented information, delivered in first person, from the lives of Isabel Knickerbocker Jordan, a 1930s nurse in northern Dutchess; French Chef Charles Virion; Isaac Phineas

Carman, Pine Plains Town Supervisor and Superintend of the Dutchess County Poorhouse; and World War One soldier Earl John Vosburgh, among many others. The Little Nine Partners Historical Society, the Pine Plains Free Library, and the Stissing Theatre Guild have collaborated to bring you this wonderful program. Tickets are available for multiple different showings on October 21 and 22 at evergreencemetery-tours2022eventbrite.com. While in the area, you can check out Dutch's Spirits, just outside of Pine Plains, to sample local Prohibition-era history along with modern distillery offerings. The town offers several excellent dining options and a wonderful coffee shop.

The Friends of Rhinebeck Cemetery have retained the services of Theatre on the Road, a local acting company, to provide attendees with a spookier experience still tied to local history. For the eight year running, six actors will portray historical denizens of Rhinebeck who are interred at the Rhinebeck Cemetery, which visitors can access through the Mill Road gates at 16 Mill Road.

Your guide, whom the website advises "may or may not be a ghost," will lead you on a walk during which you will encounter these stories and characters from across Rhinebeck's lengthy past. The cast of characters for this year's program is equal to the first class menu at the Beekman Arms. You will meet actors portraying such notables as US Vice President Levi P. Morton, renowned FDR-era artist Olin Dows, and inspired architect George Veitch, who designed the Rhinebeck Episcopal Church and Wyndclyffe. This tour is sure to delight and places you in one of the county's tourist hotspots for a great meal and shopping afterwards. Tours take place on October 22nd and 23rd at 3 PM, with a special accessible tour on October 22nd at 1:30 PM for mobility-challenged patrons. 



1812. The current chapel played host to the Roosevelts and their many influential guests, including European monarchs. Predictably, the cemetery features an equally illustrious, sometimes controversial, assembly of patrons. This year's characters include Captain Isaac Russell, a Revolutionary War veteran with close links to local notable Morgan Lewis (founder of Staatsburgh); Adelaid Roddy, an early 20th century theologian who died an untimely death; and Anna Roosevelt Halsted, FDR and ER's daughter and Kennedy presidential advisor. Tours run on October 15, 21 and 22 and last approximately an hour, rain or shine. Tickets and additional information are available online at stjameshydepark.org/graveyard-tours/ and stjamesgraveyardtours2022.eventbrite.com.

Focusing on authentic local experiences, these four cemetery programs offer something for every historical taste. Whether you are in the area to admire the leaves and gather some apples, or are a long-term resident looking to learn more about local history, you need to look no further. History is alive and hands-on in Dutchess County during the Spooky Season, thanks to our dedicated custodians of the local past.


Grilled Eggplant Parmagiana Ingredients

- 1 large eggplant peeled and sliced lengthwise approximately 1/4-inch thick
- 1 jar Coppola's Roasted Garlic sauce
- 4 plumb tomatoes sliced
- Extra-virgin olive oil, for brushing
- Salt
- 6 ounces Mozzarella cheese, thinly sliced

- Bake in the center of the oven for about 15 minutes, until bubbling and golden. Let stand for 10 minutes. Serve with crusty bread.


