## PSC cites 'apparent violations' by Central Hudson during investigation of WF explosion

The New York State Public Service Commission (PSC) ordered Central Hudson Gas & Electric Corporation on Oct. 16 to show why a civil enforcement proceeding should not begin and why civil penalties or other remedies should not be imposed by the Commission "for apparent violations relating to a gas-related explosion that occurred in Wappingers Falls." The gas-related explosion, in which multiple people were injured, occurred at 7 Brick Row on November 2, 2023. The utility has 30 days to provide a response. The Department of Public Service staff released a report describing the results of its preliminary investigation last week.

According to the report, Central Hudson in Nov. 2023 "was conducting natural gas distribution upgrades in the Wappingers Falls area as part of a distribution improve-

ment project. These gas system upgrades included excavating gas facilities located under roadways and walkways to replace steel gas pipelines with new plastic pipelines, as well as installing new service lines to ratepayer residences." During operations, states the press release, "Central Hudson contractors struck an unmarked natural gas service line, causing a natural gas leak. Minutes later, the residence at 7 Brick Row exploded, severely injuring multiple individuals."

The Department, which is the staff arm of the Commission, investigated. According to the release, the Department determined that there appears to be "sufficiently credible evidence indicating that Central Hudson had prior knowledge of the residence's active natural gas service line. The residence contained an active natural gas meter that had

important position. I have the utmost confidence in his ability and know he will work with the community and always put public safety first as we move the city forward."

Wilson is a graduate of Our Lady of Lourdes High School, attended Dutchess Community College where he studied business administration and holds a bachelor's degree in Public Affairs from Empire State University. He is a lifelong resident of the Poughkeepsie area.

While serving as Captain, Wilson was the lead department official who worked with the city's Procedure Justice Committee in the development of the

Police Department Police Reform & Modernization Collaborative in compliance with then-Governor Andrew Cuomo's Executive Order. The department established the Procedural Justice Committee to open up a dialogue with community members, and meetings are held monthly.

Wilson also was instrumental in re-writing of the department's policy manual.

Wilson volunteers for the City of Poughkeepsie Police Athletic League and Vassar Warner Home and is a board member for the McCann-Caven Golf Courses Inc.

"I am grateful for the opportunity to lead the department," said Wilson. "We

have an excellent staff of dedicated officers and support personnel, and I am proud of the progress we have made - and will continue to make -- to protect the city and keep both its residents and visitors safe. All policing is local, and I will continue to work with the community to identify and address their safety needs."

Over the last few years, the department has made significant investments in body cameras to provide more transparency about how officers operate in the field - and about the situations to which they respond. The department also enhanced its complaint process by improving accessibility and by developing a new easy-to-use online reporting tool. Forms can be

used to file civilian complaints and for commendations for the actions of officers.

The department has completed Procedural Justice training, which focuses on the way police interact with the public and emphasizes that treating people with dignity and respect and giving citizens a voice during encounters promotes community trust.

City Police also have undertaken implicit bias training, which addresses the automatic association people tend to make between groups of people and stereotypes about those groups.

The department also has developed new policies and is currently taking the necessary steps to be recognized as accredited through the State of New York.

## PSC cites 'apparent violations' by Central Hudson during investigation of WF explosion

been billed monthly. However, it appears that Central Hudson did not include this information in the project binder given to its utility locating contractors and construction contractors for the excavation project, and that the service line to the residence was not marked."

The release continues: "Thus, based on the information obtained thus far, Central Hudson's apparent failure to relay this information to its agents may have contributed to the explosion incident."

"The safety and wellbeing of our customers and communities will always be Central Hudson's top priority. We take our responsibility to provide safe and reliable service to our customers very seriously and have fully cooperated with the Department of Public Service as it conducted its investigation into the event in Wappingers Falls last year. We will continue to do so," Joseph Jenkins, spokesperson for Central Hudson, stated.

Wappingers Falls Mayor Kevin Huber said in a statement via email, "As mayor, I feel a sense of relief knowing that the Public Service Commission has taken formal action regarding the devastating gas explosion on Brick Row last November. It has been a long and difficult year for our community, and many lives have been changed forever by this tragic event."

"Utilities are required to provide safe and reliable service, and when they fail to provide this most basic protection, the Department and Commission will investigate and, where appropriate, take action," said Commission Chair Rory M. Christian in a press release. "Based upon staff's initial investigation, staff has identified information indicating that Central Hudson had knowledge of the residence's active natural gas service line, and that Central Hudson's contractors struck an unmarked natural gas service line, causing a natural gas leak that in turn led to an explosion. The Commission will start a process to receive the company's position, review the evidence, and determine whether or not any penalties or other remedies against Central Hudson are warranted."

Alleged violations by Central Hudson according to the report include:

- Central Hudson allegedly failed to provide safe and adequate service to customers residing at 7 Brick Row when Central Hudson's contractors and agents struck a

natural gas service line, thereby causing an explosion and physical injury to customers.

Central Hudson allegedly failed to provide safe and adequate service to customers residing at 5 Brick Row when Central Hudson's contractors and agents struck a natural gas service line, thereby causing an explosion and physical injury to customers.

- From October 13, 2023, to November 2, 2023, Central Hudson allegedly failed to adequately maintain the maps and/or records of its service lines of 4 Brick Row, wherein Central Hudson failed to include maps and/or records of 4 Brick Row in the Distribution Improvement Project records communicated to its utility locating contractor and construction contractors.

- From October 13, 2023, to November 2, 2023, Central Hudson allegedly failed to adequately make available its maps and/or records of its service lines of 7 Brick Row to its third-party contractors, wherein Central Hudson failed to include maps and/or records of 7 10 CASE 24-G-0483 Brick Row in the Distribution Improvement Project records communicated to its utility locating contractor and construction contractors.

- From October 13, 2023, to November 2, 2023, Central Hudson allegedly failed to adequately maintain the maps and/or records of its service lines of 4 Brick Row, wherein Central Hudson failed to include maps and/or records of 4 Brick Row in the Distribution Improvement Project records communicated to its utility locating contractor and construction contractors.

- From October 13, 2023, to November 2, 2023, Central Hudson allegedly failed to adequately make available its maps and/or records of its service lines of 7 Brick Row to its third-party contractors, wherein Central Hudson failed to include maps and/or records of 7 10 CASE 24-G-0483 Brick Row in the Distribution Improvement Project records communicated to its utility locating contractor and construction contractors.

- From October 13, 2023, to November 2, 2023, Central Hudson allegedly failed to adequately make available its maps and/or records of its service lines of 6 Brick Row to

its third-party contractors, wherein Central Hudson failed to include maps and/or records of 6 Brick Row in the Distribution Improvement Project records communicated to its utility locating contractor and construction contractors. This alleged failure caused Central Hudson's contractors performing excavation work to be unaware of 6 Brick Row's service line.

- From October 13, 2023, to November 2, 2023, Central Hudson allegedly failed to adequately make available its maps and/or records of its service lines of 4 Brick Row to its third-party contractors, wherein Central Hudson is alleged to have failed to include maps and/or records of 4 Brick Row in the Distribution Improvement Project records communicated to its utility locating contractor and construction contractors.

The report alleges "... Central Hudson's process for compiling a project binder, or 'DIP Book,' is unorganized and informal. The report states, 'From October 13, 2023, the date of the utility locating "mark out," to November 2, 2023, the date of excavation, Central Hudson had 20 days to remedy the information gaps in their project binder. The Department alleges that Central Hudson had these missing records within its custody and control, but failed to integrate that critical knowledge into its project plans for third-party contractors.'

Last week's order commenced a proceeding. "This initial order does not constitute final legal conclusions or factual findings by the Commission. The apparent violations are merely accusations. The company will

have an opportunity to respond to the Department staff's report and the apparent violations identified today (Oct. 16). Also, the Department may continue to review and investigate this incident," the release states.

"The assignment of a further investigation in seeking responsibility is a critical step forward, not only in understanding what happened but also in focusing on how we can help our residents recover. Not only does the Village need direction in its recovery, but its time also to help those residents move forward, get the assistance they need, and rebuild their lives. We are committed to supporting those affected and advocating for them," said Huber.

"We understand the impacts this incident had on the residents of Brick Row and the surrounding community and will continue to work closely with regulators and all other stakeholders to support everyone involved," said Jenkins.

"In terms of next steps, the Commission will review Central Hudson's response to determine whether to proceed with an enforcement process and whether to impose any financial penalties or other remedies against the company or its shareholders," was also stated in the release.

Jenkins remarked, "We will closely review the Commission's report and provide a comprehensive response to the allegations within the timeline requested by our regulators."

### **Dutchess County should hire a Zero Waste Management Consultant**

**To the Editor:**

Dutchess County burns all its trash in an incinerator at 96 Sand Dock Rd. near IBM, but incineration is a poor waste management option because it is polluting to the environment, unhealthy for residents and expensive for taxpayers. Solution: Dutchess should hire a Zero Waste Certified Consultant to help us transition to healthier and more sustainable materials management practices.

The Dutchess County incinerator is polluting our air and water. In 2019, the Tishman Environment and Design Center at The New School ranked our incinerator in the "dirty dozen" as one of the most polluting incinerators in the United States for emissions of mercury and carbon monoxide.

The incinerator emissions are bad for our lungs and unhealthy for our population. The American Lung Association estimates that 61% of Dutchess County residents are at high risk to air pollution. In 2023, Poughkeepsie was declared by the Asthma and

Finally, community education is important to raise awareness about domestic violence and promote prevention through workshops and outreach programs.

At Astor, we have the privilege of witnessing the incredible resilience and strength of our clients who have experienced domestic violence. Each journey is unique, but it is always inspiring to see clients begin to reclaim their sense of self and agency. Initially, many feel overwhelmed by fear and uncertainty, but with work they learn to set healthy boundaries, advocate for themselves, and make choices that prioritize their safety and well-being. Another key area of progress is in the development of healthy relationships. Clients often start by feeling distrustful or isolated, but as they heal, we've witnessed many begin to form supportive connections with friends, family, or community resources. These relationships can provide essential support and encouragement as they navigate their journey. Ultimately, the progress we witness is not just about overcoming past trauma; it's about cultivating resilience, hope, and a vision for a brighter future.

There is always hope and you are not alone. Please reach out to Astor Services or your local agency if you or a loved one is experiencing domestic violence.

For the Many applauds the Poughkeepsie Common Council for proposing changes to the city's zoning code that will increase the city's long-term housing stock by regulating short-term "vacation" rentals that are not occupied by their owners. These rentals take housing away from the people who live here in Poughkeepsie, turning our neighborhoods into unregulated hotels and driving up costs for renters and first-time home buyers. At a time when housing throughout the Hudson Valley has become both unaffordable and unavailable, we urge the Poughkeepsie Common Council to vote to include these regulations in the zoning code as soon as possible and prioritize homes for our community.

For the Many's Homes Are Not Hotels campaign has spent years advocating for greater restrictions on certain short-term rentals to stop the erosion of Poughkeepsie's housing stock and our community. The Homes Are Not Hotels language the Common Council has proposed including in the zoning code is a reasonable compromise that allows some vacation rentals, while ensuring that they do not exceed 0.5% of Poughkeepsie's housing stock and that hosts apply with the city, pay fees, and obey regulations.

We want visitors to experience the beauty of the Hudson Valley and welcome tourists to Poughkeepsie. But guest accommodations cannot be allowed to take away from the housing stock or push local residents out of their homes. For the Many will continue advocating for Homes Are Not Hotels across the region and we will be mobilizing our members in support of the proposed zoning code until the Common Council has taken this important action to address the housing crisis. We're hopeful that Hudson Valley municipalities will continue to pass strong short-term rental regulations to ensure everyone can afford to live here.

## Fatal crash on Taconic State Parkway

**East Fishkill resident arrested for alleged sale of cocaine, fentanyl**

The Dutchess County District Attorney's Office Drug Task Force reports an investigation into the sale of cocaine which also contained fentanyl in the Town of East Fishkill.

Dutchess County District Attorney's Office Drug Task Force Agents initiated an investigation after East Fishkill Police Department requested assistance with a drug investigation stemming from a fatal auto accident that occurred on Sept. 12. The driver and deceased party in that accident was found to be in possession of a white powder substance believed to be narcotics. DTF Agents field tested the substance determined to be both cocaine and fentanyl mixed together, according to law enforcement officials.

A subsequent investigation by Agents determined that the person who allegedly sold the cocaine mixed with fentanyl was Joseph M. Kundrat, 32. Agents arrested Kundrat on Sept. 30 after he turned himself into the Town of East Fishkill Police Department.

Kundrat was later arraigned in the Town of East Fishkill Justice Court and released

as required by New York State Law. The accident investigation remains under investigation by the Town of East Fishkill Police Department and more charges related to this case against Kundrat may be pending, according to officials. The Dutchess County Drug Task Force was assisted by the District Attorney's Office and the Town of East Fishkill Police Department with this investigation.

The Drug Task Force continues to warn members of the community that cocaine and other drugs are often contaminated or mixed with fentanyl and have been the source of numerous overdose deaths over the past several years in Dutchess County.

As with any criminal case, the charges described above are merely an accusation and those individuals named in this release are presumed innocent until proven guilty in a court of law.

## Dutchess County gains over \$3 million for public safety, criminal justice initiatives

Congressman Pat Ryan joined with Dutchess County District Attorney Anthony Parisi, Dutchess County Sheriff Kirk Imperati and Dutchess County Executive Sue Serino on Oct. 16 to announce that they have secured \$3,023,688 in federal funding to bolster public safety and criminal justice initiatives across Dutchess County.

This is in addition to the \$2,386,00 in federal Community Project Funding for Fiscal Year 2025 Congressman Ryan is fighting to secure for Dutchess County to create a state-of-the-art Analysis and Real Time Crime Intelligence Center and develop a consolidated two-way public safety radio system.

"Our local law enforcement officers are true public servants - grounded in the mission of keeping our neighbors safe around the clock. Their work isn't partisan, and neither is our work in supporting them with the resources they need" said Ryan. "I'm proud that only two months after we joined here in August to announce our shared vision for safer communities in Dutchess County, we're here again to announce over \$3 million in additional funding to keep criminals off the streets, to safeguard our communities from hate-fueled crimes, and to protect survivors of domestic violence and ensure they receive justice when their perpetrators are prosecuted. "I am proud to have helped secure over three million dollars in federal grants through the U.S. Department of Justice for the Dutchess County District Attorney's Office to undertake these critical projects. I will continue fighting to ensure that communities across New York have the resources they need to stay safe."

Sheriff Imperati said "On behalf of the men and women at the Sheriff's Office I am very thankful for the grant money that has been awarded and look forward to witnessing the positive effects it will have on law enforcement as a whole in Dutchess County. We anticipate that having this money available to enhance law enforcement efforts on numerous fronts, including the Real Time Crime Center at the Sheriff's Office, will greatly benefit our ability to continue prioritizing public safety for all residents of Dutchess County. The Dutchess County DA's Office secured the \$3,023,688 from United States Department of Justice (DOJ) grant programs

with the assistance of Congressman Ryan. The funding will be broken down to support the three following programs:

- \$1,000,000 from the DOJ's Matthew Shepard and James Byrd, Jr. Hate Crimes Program will fund the Dutchess County District Attorney's Office's collaborative initiative to address, mitigate, and prevent hate crime and increase victim reporting. This project focuses on the education on and prevention of hate crime through community outreach and partnerships, crime analytics and data collection, and targeted resource distribution to improve hate crime reporting. The District Attorney's Office will create two new positions- a Hate Crimes Analyst and an Assistant District Attorney - to aid in the education, prevention, and investigation of bias-related crimes, including those committed online.
- \$1,523,688 to bolster the capacity of DNA testing of evidence. This will allow for post-conviction evidence testing as well, ensuring that the perpetrator of a crime is correctly brought to justice. The funding will expand Dutchess County's Conviction Integrity Unit (CIU) by creating positions of Unit Chief, Assistant District Attorney and a full-time Investigator. The funding will help the CIU efficiently conduct thorough case reviews and investigations of violent felony convictions where a credible claim of actual innocence has been made; utilize DNA testing and analysis to provide conclusive evidence of innocence; and insights gleaned from CIU investigations will be applied to active prosecutions to help mitigate the risk of future wrongful convictions. This will ensure justice is finally and correctly served for the people of Dutchess County communities.
- \$500,000 from the DOJ's Enhancing Investigation and Prosecution of Domestic Violence, Dating Violence, Sexual Assault, and Stalking (EIP) Initiative will help expand and improve the Dutchess County DA's capacity to effectively investigate and/or prosecute domestic violence, dating violence, sexual assault, and stalking, and in so doing, support victim safety and autonomy, hold offenders accountable, and promote agency trust within the community. The EIP project by the Office of the Dutchess County District Attorney will partner with Family Services to provide supportive services to survivors. Funding will help in hiring a Senior Assistant District Attorney to prosecute domestic violence, dating violence, sexual assault, and stalking cases.



## County expands 2024 Composting Grant Program options

Dutchess County Division of Solid Waste Management is expanding the 2024 Composting Grant Program to offer additional options for local municipalities and public school districts to establish composting programs. The program offers the choice of applying for either a 50-percent matching grant to purchase and install an in-vessel aerobic composter or start-up funding to establish food waste drop-off sites.

Dutchess County Executive Serino said, "Dutchess County is proud to collaborate with our municipalities and local school districts on sensible composting programs to reduce food waste and keep our environment healthy for our children and their children. With additional options in the expanded program, municipalities and school districts can choose the option that best fits their community's needs. We look forward to many communities taking advantage of this great program!"

The first option is the purchase and installation of an in-vessel aerobic composter, which provides a controlled decomposition process to turn the organic materials into beneficial compost. The County will match 50 percent of purchase and installation, with funds up to

\$50,000 per project.

The second option is the establishment of a food waste drop-off site. Municipalities and school districts can apply for funds, up to \$20,000 per award, to initiate and establish food waste drop-off stations, where organic material is collected and hauled off-site to be composted.

The updated 2024 Composting Grant application instructions and guidance are now available on the County's Division of Solid Waste Management website; applications must be received by 3 p.m. on Nov. 7.

The Composting Grant Program is one of the County's latest initiatives in its continuing efforts to preserve a vibrant environment for future generations. Dutchess County was recently awarded New York State's highest Climate Smart Community distinction, for the County's continued climate action and environmental efforts.

# Book teaches ‘universal message’ of kindness

Students at St. Mary's School in Wappingers Falls recently had a special guest. Author Donna DiMaio Rooney, read sections from her book "Dani and the Day the Bully Changed Everything," a Mom's Choice Gold Award Winner.

"It's great for the children to meet someone who wrote the book," said Patricia Luzar, the principal of Saint Mary's, which has students in universal pre-K, pre-K3, kindergarten, and multi-grades.

"She has a great message and lesson behind it," Luzar remarked about Rooney, who traveled from her Connecticut home to read the book earlier this month.

"The bull purposely tripped him," read Rooney, who previously worked on the television show "Live with Regis and Kathie Lee" and at ABC News at "Good Morning America" with former anchor Diane Sawyer. Rooney continued reading, "They witnessed terrible, mean things."

The blurb on the back cover of the book reads: "When Dani witnesses a bullying of a popular boy on the school playground, her world is knocked upside down. Through a dream, Dani's beloved farm animals are presented with a similar problem where they find themselves bystanders to a vicious attack. They wrestle with how they can end the bullying and take back their farm, without becoming the next victim. There are many layers in this unpredictable story that recognize, teach and celebrate what makes each of us

unique. The main characters and surprise ending will stay in the heart and mind of the reader long after the story is told."

Rooney asked the first group of students, who were all in the universal pre-K program, "How would you feel?" Children's responses ranged from "sad" and "mad" to "scared" and "not happy."

Asked what the message of her book, which was written in 2016, was, Rooney, responded, "I think the universal message is kindness and then understanding about what kindness means and how kindness affects others."

Rooney, who has a son, and her husband is a special education teacher, said while writing the book she also included what the bully feels like to offer the bully's perspective. She noted that she also did a lot of research on the animals in the book.

"All these little things that make an animal unique were important to me," said Rooney.

"Dani is a well-written book that is fun, imaginative and insightful into the psychological struggles that children and young adolescents have with bullies. Set in a bucolic farm environment, school age kids who read this book will gain an understanding into how to deal with bullying. Highly recommended!" Daniel Kelleher, M.D., Board Certified in Adolescent & Child Psychiatry, said in a statement.

As for seeing the students' different reactions, Rooney said, "It's amazing." She added that she also included aspects in her


book for adults so they will be entertained while reading to their children.

The acquisition will be celebrated with a ribbon-cutting featuring guest speakers and dignitaries on Wednesday, Oct. 23. Both the Middletown and New Windsor locations now have new signage and interior paint themes to match Abilities First's blue-and-green branding. The transferred programs include the Middletown Education Center, serving ages 3-8 at 357 Mount Hope Road, and the Educational

Learning Experience serving ages 3-21 at 930 Raz Ave. in New Windsor. Each location employs about 50, all of whom were given offers to retain their positions. Each location serves approximately 90 students. The Middletown location has nine preschool classrooms and one school-age classroom; the New Windsor location has five preschool classrooms and five school-age classrooms. "We are extremely thankful for Abilities First's collaboration as well as its devotion to the young, vibrant lives these two programs serve," said Regina McKenney-Snead, Executive Director, ARCGHV. "Abilities First's investment during this transformation is really in peoples' lives. This acquisition will empower change and independence, both of which will advance quality of life and provide crucial support for families. Plaintiff Jeryes Freih ("Plaintiff"), by his attorneys Gordon Rees Scully Mansukhani, LLP, as and for his Verified Complaint, alleges as follows:

**NATURE OF ACTION**

1. Plaintiff has

commenced this action seeking a judgment: (i) pursuant to Real Property Actions and Proceedings Law ("RPAPL") Section 1951, to obtain a declaration that certain land use restrictions are unenforceable and to extinguish same because the restrictions are of no actual and substantial benefit to any persons who might seek enforcement; (ii) pursuant to RPAPL 1501, et seq., determining the restrictions are unenforceable, invalid, void, and of no force and effect and directing the Dutchess County Clerk to cancel of record the restrictions; (iii) pursuant to the Civil Practice Law and Rules ("CPLR") Section 3001 declaring the restrictions invalid or, in the alternative, do not prohibit development of the affected parcel; and (iv) granting such other and further relief as this Court deems just and proper.

**THE PARTIES**

2. Plaintiff owns the real property located in the Town of Beekman (the "Town") on the south side of Town Center Boulevard, and further identified on the County of Dutchess (the "County") Tax Map as Tax Grid No: 13220-6759-00-525438-0000 (the "Property"). A copy of the Quitclaim Deed (the "Deed") dated May 24, 2022, and recorded in the office of the Dutchess County Clerk on May 26, 2022, from the County conveying the Property to Plaintiff is annexed hereto as Exhibit A.

3. Upon information and belief, and at all relevant times herein, Defendant Marie Policare ("Policare") is an individual whose last known residence is located at 53-31 65th Place, Maspeth, New York 11378.

4. Policare is named herein as Plaintiff's predecessor-in-interest and as the covenantor and subsequent grantor whose conveyance by Warranty Deed with Full Covenants dated October 27, 1983, and recorded in the Office of the Dutchess County Clerk on March 20, 1984 in Liber 1628, Page 239, contained the entirety of the restrictive covenants (the "Restrictions" as described below) that are the subject of this action.

**JURISDICTION AND VENUE**

5. The Court has subject matter jurisdiction and may exercise personal jurisdiction over the Defendant in this

matter.  
6. Pursuant to CPLR § 504(2) and 507, Putnam County is the proper venue because it is the county in which the real property affected by a judgment herein is situated.

7. Pursuant to CPLR Section 301, venue is proper in this Court.

8. No prior application for this or any similar relief has been made to this or any other Court.

**FACTS COMMON TO ALL CLAIMS**

9. The Property is vacant, undeveloped land burdened by the Restrictions (as described below) that are the subject of this action.

10. The Property is situated in a Town Center ("TC") Zoning District which allows for the development of a mixed-use establishment or commercial complex as of right and the development of a multi-family apartment house or condominium by special permit. The Schedule of Area and Bulk Requirements for the TC Zoning District provides for a minimum lot area of 43,560 sq. ft. and allows a maximum of 12 residential units per acre. A copy of the Schedule of Area and Bulk Requirements for the Town is annexed hereto as Exhibit B.

11. Notably, the TC Zoning District does not permit the development of a single-family home. A copy of the Schedule of Permitted Uses for the Town is annexed hereto as Exhibit C.

12. Pursuant to a Decision and Judgment of the Dutchess County Supreme Court, on or about February 24, 2022, as a result of unpaid County, Town and School taxes for the levy year 2018 (the "Taxes"), the Property was deeded to the County (the "Judgment"). A copy of the Judgment (with the relevant List of Parcels, see page 1) is annexed hereto as Exhibit D.

13. Subsequently, in or about May 24, 2022 Plaintiff acquired title to the Property from the County, pursuant to the Deed. (See Ex. A.)

14. The Deed conveyed title of the Property to Plaintiff "[s]ubject to...any and existing restrictions, conditions and covenants [o]f record."

15. The Property, in its present state, as purchased by Plaintiff is, and has always been, vacant and undeveloped.

16. Accordingly, because the TC Zoning District allows for the

development of multi-family residential apartments Plaintiff purchased the Property for the purpose of developing the Property as a single 2-story structure to include four two-bedroom apartments (the "Project").

17. The Deed conveyed title of the Property to Plaintiff "[s]ubject to...any and existing restrictions, conditions and covenants [o]f record."

**The Covenants and Restrictions**

18. In or about October 27, 1983, Plaintiff's predecessors-in-interest, Ronald T. Policare and Marie Policare as tenants by the entirety, conveyed the Property to Marie Policare pursuant to a Warranty Deed with Full Covenants dated October 27, 1983, and recorded in the Office of the Dutchess County Clerk on February 6, 1986 in Liber 1697, Page 309 (the "Allan Deed"). The Allan Deed also contained the same Restrictions as in the Policare Deed.

19. Unbeknownst to Plaintiff at the time the County sold him the Property, the Property appears to be subject to certain conditions, covenants and restrictions which run with the land, set forth in the Policare Deed as follows:

1. No house, garage or other building shall be built or placed upon the above described premises which shall project or extend beyond a line running parallel to and at a distance of fifty (50) feet from the property line described above as bearing "South 43°25' East...300 feet".

2. No house, garage or other building shall be built or placed upon the above described premises which shall project or extend beyond a line running parallel to and at a distance of five (5) feet from the property line above described as bearing "South 40°00' West".

3. No basement or garage and no other structure not completely finished shall be used or occupied as a dwelling.

4. No structure of the type known as a mobile home or trailer shall be placed on or allowed to remain on the above described premises. The premises are or will be improved by a one or two family dwelling only. (Collectively, the "Restrictions").

20. Title to the Property was subsequently conveyed by Policare to Nasser M. Ali, pursuant to a Warranty Deed With Full Covenants dated December 13, 1983 and recorded in the Office

of the Dutchess County Clerk on March 20, 1984 in Liber 1628, Page 235 (the "Nasser Deed"). The Nasser Deed contained the same Restrictions as in the Policare Deed.

21. Title to the Property was then conveyed by Nasser M. Ali to Roger Allan pursuant to a Bargain and Sale Deed With Covenant Against Grantor's Acts acknowledged on January 8, 1986 and recorded in the Office of the Dutchess County Clerk on February 6, 1986 in Liber 1697, Page 309 (the "Allan Deed"). The Allan Deed also contained the same Restrictions as in the Policare Deed.

22. Title to the Property was then conveyed by Roger Allan to Hanan A. Ali pursuant to a Bargain and Sale Deed With Covenant Against Grantor's Acts dated January 11, 2008 and recorded in the Office of the Dutchess County Clerk on February 11, 2008 as Document Number: 022008928 (the "Hanan Deed"). The Hanan Deed also contained the same Restrictions as in the Policare Deed.

23. Hanan A. Ali as the owner of the Property failed to pay the Taxes and as a result, the Property was deeded to the County. See Exhibit D.

24. As noted above, Plaintiff acquired title to the Property from the County at a tax lien foreclosure sale pursuant to a Quitclaim Deed in or about May 24, 2022. See Exhibit A.

25. Because Plaintiff purchased the Property subject to a Quitclaim Deed, the Restrictions were first brought to Plaintiff's attention, only after the purchase of the Property and a title search was performed.

26. Plaintiff's free and unencumbered use of the Property is impaired by the Restrictions.

27. Here, because Defendant as the grantor who imposed the Restrictions has no ownership interest in the Property, the Restrictions are of no actual and substantial benefit to Defendant or any party claiming a benefit and/or seeking to enforce the Restrictions as enforcement of the Restrictions will result in great hardship for Plaintiff.

28. Due to changed conditions, i.e., the fact that: a) the Property was never developed pursuant to the Restrictions; b) a prior owner failed to main-

tain the Property's Taxes and the Property reverted to the County before Plaintiff took title; and c) the TC-Zoning District does not allow for the development a single-family residence, the purpose of the Restrictions are no longer capable of accomplishment.

29. Accordingly, the Restrictions have been waived or abandoned.

30. Plaintiff's intended use of the Property is lawful and in keeping with the current zoning of the Property. It would thus benefit the community as a whole.

31. The Restrictions provide no actual or substantial benefit to the Defendant or any party who would seek to enforce the Restrictions, but are extremely onerous to Plaintiff.

32. If the Restrictions were enforced, the Plaintiff would not be able to use the Property as intended.

33. The Restrictions are unenforceable as to the Property in that the Restrictions are of no actual and substantial benefit to any party, by reason of changed conditions and other causes, the purpose of the Restrictions is not capable of accomplishment, and for other reasons stated herein.

**AS AND FORA FIRST CAUSE OF ACTION:  
PURSUANT TO RPAPL 1951, DECLARE THE RESTRICTIVE COVENANT UNENFORCEABLE AND EXTINGUISH THE SAME**

34. Plaintiff repeats and re-alleges each and every allegation as set forth in paragraphs "1" through "33" as though set forth in full herein.

35. The policy of the law in New York is to favor the free and unobstructed use of realty and that covenants restricting the use of property will be strictly construed against those seeking to enforce them. See *Huggins v. Castle Estates, Inc.*, 36 N.Y.2d 427 (1975).

36. RPAPL § 1951 (1) provides the following, in relevant part: No restriction on the use of the land created at any time by covenant, promise or negative easement...shall be enforced by injunction...nor shall such restriction be declared or determined to be enforceable, if, at the time the enforceability of the restriction is brought in question, it appears that the restriction is of no actual

and substantial benefit to the persons seeking its enforcement or seeking a declaration or determination of its enforceability, either because the purpose of the restriction has already been accomplished or, by reason of changed conditions or other cause, its purpose is not capable of accomplishment, or for any other reason.

37. The Restrictions as aforesaid are of no actual and substantial benefit to Defendant or any party claiming a benefit and seeking to enforce the Restrictions as enforcement of the Restrictions will result in great hardship for Plaintiff.

38. The purported Restrictions, if enforced as written, would only serve to restrict Plaintiff's planned use for the Property, without actually or substantially benefitting the Defendant.

39. Upon information and belief, the purported Restrictions are unenforceable, in that they are of no actual or substantial benefit to the Defendant or any party seeking to enforce them, and as the purpose of the Restrictions cannot be accomplished today.

40. Plaintiff has no adequate remedy at law.

**WHEREFORE**, it is respectfully requested that the Court grant judgment to Plaintiff pursuant to RPAPL § 1951: a) declaring that the Restrictions are unenforceable as to the Property described in paragraph 2 of this Complaint and in Exhibit A annexed to this Complaint; further b) declaring that the Restrictions are completely extinguished as to the Property described in paragraph 2 of this Complaint and in Exhibit A annexed to this Complaint; c) directing the Dutchess County Clerk to cancel or record the Restrictions; and d) awarding Plaintiff such other and further relief this Court deems just and proper.



# Soul Cakes

A modern take on a time-honored seasonal treat

As someone who loves Halloween, seeing its resurgence as a major holiday delights me even though most people today don't know its rich history or truly understand where our traditions come from. I like to think that the thread of its beginnings in ancient times is still with us, having been woven into a tapestry that ties us to our ancestors in beautiful and mysterious ways. There's a certain magic to that, that casts its spell on us all whether we know it or not.

As an adult I love Halloween more than I did when I was young, though its magic wasn't lost on me then. Trick-or-treating was for me a mystical experience. More than the costumes or candy, just out walking on those crisp fall nights from house to house held me in thrall, and the cider and donuts waiting for us back home was almost the best part.

Looking back, I suppose it filled me with a wonder that I grew into, a hunger to know and understand more, to become someone or something bigger and better than I was, someone who somehow understood there was more to it. It was as if I was pulled back to something ancient and awesome. That's about the time I read Ray Bradbury's "Halloween Tree" for the first time, which changed and informed me with its gift of unlocking doors to times past and the stories they could tell. ple we could never meet yet somehow knew; times so different from our own but still familiar. I could see myself there and feel what they must have felt: fear, awe, wonder and an appreciation for living.

I think that's why this time of year has such a hold on me. I am transported back in time to the ancient Celts huddled around their bonfires in the otherwise threatening dark, the eerie forests and fog-blanketed hills of the Hudson Valley in the 1700s, villages where parents told children cautionary tales of witches and werewolves by firelight to keep them safe. How terrifying cold nights must have been when you had no idea what was lurking in the dark woods, and yet how comforting to have your rituals, many of which center around food, to offer a sense of protection and give strength.

Even today, we gather with those we hold dear around the table or fire for comfort and in celebration. Coming together over things that unite us is one of the best things humans do and its importance is unchanged over time.

The tradition of giving soul cakes from All Hallows Eve to All Souls Day has deep roots. The ancient Celts celebrated Samhain, or Summer's End, with fruits of the harvest and bonfires to ward off evil. Among their offerings were small cakes laden with fruit and nuts, which were both eaten and thrown on the fire in sacrifice. Once Catholicism took hold, the cakes

took on a different meaning. Across Medieval Great Britain they became known as Soul Cakes, each bearing a cross to denote them as alms, treats to be given to the poor and children, called soulers, who went from door to door, often in costumes, begging for them in exchange for singing hymns and saying prayers for those who had passed that their souls might be saved from Purgatory. One cake given was one soul saved.

The ingredients were simple and varied from region to region. More like scones than cake, they were made with warming spices and harvested fruits and nuts, usually by wealthier households who could afford to buy salvation and show their charity. Eventually only children would don costumes to blend in with the real spirits that prowled the night, and the practice became known as guising, which made its way to America with immigrants from the British Isles. By this time soul cakes were largely replaced with other sweets, but the tradition waned during World War II with the rationing of sugar. It came back after the war and by 1950 was called trick-or-treating with candy being handed out, the soul cakes little more than a memory. Maybe we should bring them back!

### SOUL CAKES

To honor the original spirit of these little, not-too-sweet scone-like cakes, I've adapted several recipes and included ingredients easily found here. Originally they would often have used hazelnuts, currants and foraged berries from the region. I used raisins, dried cherries, almonds and walnuts because that's what I had on hand, so use whatever you like. You will roll out the dough and will need a round biscuit cutter for these. And don't forget the cross on top!

### INGREDIENTS

- 1/2 cup milk (whole is best)
- 2 cups flour, sifted
- 1 teaspoon baking powder
- 1/2 teaspoon allspice
- 1/2 teaspoon cinnamon
- 1/4 teaspoon nutmeg
- 1/4 teaspoon ground ginger
- 1/2 teaspoon salt
- 1 stick (8 tablespoons) butter, softened
- 1/2 cup sugar (more for sprinkling on top)
- 2 egg yolks

1/2 cup raisins  
1/2 cup dried cherries  
1/2 cup chopped almonds, walnuts or hazelnuts

### METHOD

Place oven racks in the center position. Preheat oven to 400 degrees. Line baking sheets with parchment paper and set aside.

Warm milk in a small saucepan just to heat through. Don't let it boil.

In a large bowl, whisk together flour, baking powder, spices and salt.

In a separate large bowl, mix butter and sugar together. Add egg yolks and mix well.

Add the flour mixture, half at a time, and mix just to combine. The dough will be crumbly.

Pour in warm milk a little at a time, mixing after each addition until a soft dough forms. You may not need all of the milk. Add fruit and nuts and mix to combine.

Transfer dough to a lightly floured surface, knead gently and roll to 1/2-inch thick. Cut into circles with a 2-inch round biscuit or cookie cutter.

Place rounds on prepared baking sheets about 1-inch apart. Use a butter knife to make a deep cross on top of each, being careful not to cut all the way through. Sprinkle tops with sugar and bake until golden brown, 10-15 minutes. Makes about 18 cakes.

The All Hallows rituals practiced by our ancestors are still with us today in different forms, and though their significance may be largely lost to time, they are woven into our Halloween traditions. I hope that as you celebrate this special holiday, your love for it will now also include a mindful homage to its rich history and the roles our ancestors played, their respect and awe, fear and wonder, and that you'll have a wicked-good time. Happy Halloween!

# get growing!



Nobody robbed us. We didn't get lost. We didn't fall into a sink hole, get attacked by feral warthogs or stung by Amazonian hornets. Sue and I were on a cruise! After vacationing on our own for 50 years in 34 different countries, usually without detailed plans, we figured a 10 day cruise to Greek and Turkish islands would be a relaxing change of pace.

Relaxing? Ha! Exhausting was more to the point. To keep from getting bored, Sue and I had signed up for daily "excursions." The one we figured would give us some exercise – kayaking on the Mediterranean Sea – turned out to be the most relaxing day of the cruise. Every other day we clambered up miles of ancient paths and staircases, culminating in a trip to the Greek Island of Santorini, where 800 shiploads of tourists every season trudge through miles of souvenir shops and art galleries in order to take a photo of some white houses with blue domes and post it on Instagram.

In the Turkish city of Bodrum, we were herded into the Harem Carpet Factory, where owner Husohmettin gave us a lecture and demonstration about the Turkish silk industry. It turns out that Turkey is the third largest silk producing country, after China and India, exporting about four million dollars in silk rugs annually. Interesting facts:

- Silk was first produced in China more than 5,000 years ago.
- Sericulture, or silk production, began in Turkey in 552 AD. It turns out that the climate around the Black Sea is ideal for silkworms.
- Silk is produced by silkworm caterpillars; they feed exclusively on mulberry trees, spinning cocoons in hopes of emerging as a butterfly.
- Their hopes are dashed, as the cocoons are

boiled, killing the larvae inside. If they were allowed to chew their way out of the cocoons, the long silk fiber would be cut into pieces.

- Each cocoon, when unraveled, stretches into a mile of silk.
- One Turkish silk rug takes a single weaver 36 months to complete, using the silk from 18,000 cocoons!

• Since the advent of synthetic fibers like satin and nylon, the Turkish silk industry has taken a nosedive, but still more than 100 tons of cocoons are grown and unraveled every year.

• Silk is the strongest natural fabric, used to make parachutes before nylon came along.

The silk making and weaving demonstration, as interesting as it was, turned out to be a prologue to a high pressure Turkish rug sales presentation. First we were plied with cups of Raki, a strong brandy made from distilled grapes. Then dozens of silk rugs were rolled out by a sales force that made used car sales people look like wimps. When the audience balked at the \$15,000 prices, wool, then cotton, and finally polyester rugs went on display. When Sue and I pleaded that we had no room in our house for more rugs, they brought out smaller and smaller ones, until we were finally shown a piece of plastic the size of a handkerchief. Once we found the door, we managed to stumble into the night with all our cash intact.


But I'm being harsh. The ten day Istanbul to Athens cruise, on Oceania, was wonderful in the truest sense of the word. Sue and I might even go on another cruise, to get some exercise.




## Town of Fishkill departments show support Fridays by wearing pink in Oct.






