

Wappingers Falls will host its annual Holiday Tree Lighting and Parade on November 26. The festivities begin at 6 p.m. when the parade steps off. All are welcome to march in the parade. Line up is at 5:30 p.m. on Elm Street. Registration is not required. The tree lighting will follow.

There will be a DJ playing music. Refreshments for attendees. Santa will make his way to the event to hear the lists of children.

There is a rain date of Nov. 27.

#### Performances set for tree lighting in Beacon

The City of Beacon will be holding its 5th Annual Traditional Christmas Tree Lighting Ceremony on November 26, from 4–6 p.m., at Polhill Park, which is next to the Welcome Center (corner of Main Street and Route 9D/Wolcott Ave.) Attendees may stop by and receive an ornament kit. # Farms diversify to survive and thrive

But success also comes from reaching beyond the Hudson Valley and setting yourself apart on the larger stage.

Mark Adams, President Emeritus of the Dutchess/Putnam/Westchester Farm Bureau said, "Local farms compete in a world marketplace. We pay about the same price for fertilizer, supplies, equipment and maybe energy as farms in other states."

"But labor is much more expensive in New York. Local farms have adapted by switching from labor-intensive crops like vegetables, to grain and hay, which are harvested by machine, plus beef cattle."

"We keep farming as long as we can make enough money to have a decent life - a home, food, a car, and maybe go to the movies once in a while."

World market place? Stephen Van Tassell, owner of Uplands Farm, noted "We developed a cow family which we were able to market worldwide as a source of top genetics in the Holstein industry. The cow family ranked at the top of the breed for components, such as butterfat and protein, which is still a huge benefit in our current market, giving us a large advantage over the average milk price."

And now let's take a look at each farm, focusing on history, costs and income and the lure of farming.

**Uplands Farm – Stephen Van Tassell**

"Uplands farm was purchased in 1922 by my Great Grandfather, a New York City businessman with no farm knowledge or experience. He brought my adult grandfather here to help. My father Henry was born and farmed lifelong. The early days were a subsistence model that helped the family survive the Great

Depression. Over the decades, dairy became the focus as it remains today.

"I was born with a consuming desire to continue the dairy farm. I had the opportunity to breed and manage the herd to my desire. I married Jill and we chose to work solely on the farm with no off-farm jobs or support to raise our family in what I still feel was an idyllic lifestyle.

"The economic conditions during that period changed dramatically, including dismal margins due to low milk price and an increased requirement for cash/income to cover real estate taxes that went from

\$800 annually in the 1970s to near \$30,000 today. We also had a young and extended family to support.

"We have developed business relationships, which continue to help keep us viable. I consider myself one of the most fortunate people in the history of man. I wake every morning looking forward to the day ahead. I have never been hungry and I have been surrounded by some of the finest people around the world through a lifetime in the dairy business. Uplands Farm remains an important core to a diverse group of family and friends

and I hope it lasts forever."

**Clover Brooke Farm – Andrea Parent-Tibbets**

"As first generation farmers, my husband and I started our farming journey in 2016 with much to learn about farming and long-term sustainability as our goal. Our first major project was rebuilding the century old dairy farm that had not been managed for 30 years, prior to our purchase. Rebuilding infrastructure on the farm, clearing pastures, installing over 5,000 feet of fencing, repairing/rebuilding barns, building animal shelters and improving soil health for long-term grazing/crop production, while tackling most of the projects ourselves to save on outside labor costs, consumed all of our savings.

"We have learned that diversification is paramount to the survival of most businesses and farming is no different. We recognized we had to find ways to recover some of our costs to continue our projects that we had envisioned for the farm. We looked at ways to use the assets we had invested in (beautiful bucolic farm, friendly animals, past careers in education and finance) and decided to open our farm up to visitors.

"We jumped into social media at record speed, establishing our presence on an assortment of online platforms, networked to spread our name, collaborated with like-minded organizations, and developed a 'Virtual Farm Visit Experience' during COVID, which was picked up by national media.

"We raise llamas, alpacas, sheep and goats, producing luxurious yarns and other fiber products for sale. We also offer

## Wappinger board unanimously approves budget for 2023

At its November 14 meeting, the Wappinger Town Board unanimously approved a budget for 2023 that once again reduces tax rates per assessed value for town and village residents and businesses.

"Credit is due to our Board members, department heads, Comptroller Fredrick Awino, and all town employees for their collective efforts to hold down Town expenses in order to give our taxpayers a break at a time where we're all being hit by inflationary increases elsewhere," said Town Supervisor Dr. Richard Thurston in a press release. The Supervisor also expressed appreciation to the Board for "keeping the 2023 budget within the parameters of my initial tentative budget."

The town's overall tax levy, including special districts, will drop \$36,688 from last year's levy. The total levy for 2023 is \$8,680,877, compared to 2022's levy of \$8,717,565.

Total spending including special districts will be \$18,199,300 for 2023, compared with \$17,491,000 in 2022.

For Residents Inside the Village, Homestead Tax will drop from \$0.74 to \$0.71 per \$1000 of assessed value.

For Businesses Inside the Village, Non-Homestead Tax will decrease from \$1.45 to \$1.40 per \$1000 of assessed value.

For Town Residents Outside the Village, Homestead Tax declines from \$1.83 to \$1.81 per \$1000 of assessed value.

For Town Businesses Outside the Village, Non-Homestead Tax drops from \$3.60 to \$3.55 per \$1000 of assessed value.

The estimated fund balance in the General Funds (both A and B Funds) is \$6.02 million, while the town's Highway Fund (DB Fund) is at \$2.34 million.

"We're able to maintain our high levels of public services, including our police and highway services, our water and sewer services, and our various services offered at town hall, while adopting a conservative budget that reflects the will of our residents for less taxes," said Thurston. "This kind of fiscal stability gives us the flexibility for possible future capital projects, as well as the flexibility to meet any unexpected needs of our residents."

Councilman Al Casella of Ward Four said in the release, "This budget is fiscally sound and prudent. It keeps all essential services intact. The budget takes the Town Residents Outside the Village, Homestead tax rate from \$1.84 in 2022 to \$1.81 in 2023, so a 1.3% decrease and the Residents Inside the Village, Homestead tax rate goes from \$.74 to \$.71 or a 3.5% decrease. This budget adds additional funding for Sheriff Patrol/Vandalism, Disaster Preparedness, and Traffic Control/Safety. We also added funds to recreation for our playgrounds and ball parks, senior programs like the garden club and book club, our sports museum, and town personnel. We are in a strong financial position entering 2023 with excellent cash flow and a Double A + bond rating. I want to thank the Town Board for working together and putting this fiscally responsible budget in place for 2023."

## East Fishkill adopts 2023 budget, under tax cap

The budget for 2023 for the Town of East Fishkill 2023 was passed recently by the members of the East Fishkill Town Board.

East Fishkill Town Supervisor Nicholas D'Alessandro said, "We have added more to our fund balance and tax increase for 2023 is less than 2022's increase." He noted the 2023 budget is under the state tax cap.

"Taxes decreased and the average taxpayer will pay on average \$5-6/year increase or 0.4% increase," said D'Alessandro.

According to the Supervisor, the tax levy increased 0.4%.

The 2023 budget said D'Alessandro, has no cuts and no layoffs. "Actually, we are looking to hire two more police officers," he stated.

"East Fishkill has never exceeded the NYS tax cap and probably never will (as long as I'm supervisor). We have more in our fund balance than we ever have in East Fishkill history. The 2023 budget is very sound, we tried to have a zero increase but with inflation and other factors, we had to implement a very small increase," D'Alessandro remarked.

## Town of Fishkill board adopts budget for 2023 fiscal year

The Fishkill Town Board adopted the 2023 Budget on November 2. Town of Fishkill Supervisor Ozzy Albra presented the Tentative Budget to the board members to review on September 29.

According to Albra in his budget message, "Every department was asked to review their budget, prioritizing needs over wants and submit a responsible budget and capital plan. This was followed by a one-on-one meeting with each department head where every budget line was scrutinized and revised as necessary."

According to Sharon Mitchell, the comptroller for the town, there were several amendments to the Preliminary Budget, which was adopted as the 2023 budget.

The 2023 Adopted Budget is \$341,530 below the allowable levy limit (tax cap), according to Mitchell. The Town Homestead tax rate increases .66% or \$.015/\$1,000 to \$2.33 per \$1,000 taxable assessed value, said Mitchell. The Village Homestead tax rate increases 7.85% (\$.075/\$1,000) to \$1.03 per \$1,000 taxable assessed value.

Mitchell stated the Non-Homestead Town tax rate decreases 5.38% or -\$1.198/\$1,000 to \$3.49 per \$1,000 taxable assessed value and Village tax rate increases 1.53% or \$.022/\$1,000 to \$1.45 per \$1,000 taxable assessed value.

Before the vote to adopt the budget, a

public hearing was held.

In addition to town taxes, the town raises taxes through benefit assessment, for water sewer district, said the lawyer for the town. One could explain at the hearing why one was being charged too much or charged at all. "Now's the time to speak up," he said. No one spoke during this public hearing.

During the public hearing on the budget, a comment made was that the town officials should use the fund balance sparingly. "I would like the Town to keep its good financial standing that we have now," she said.

"We'll close the public hearing," said Albra.

Christian Harkins, who is the assessor for the Town, told the board members that he has not yet seen cracks in the Town's real estate market.

Proposed amendments to the budget were read.

It was stated that the amendments were not a criticism of the supervisor's budget.

A vote was taken to adopt the budget as amended.

"I am a no. I can't vote for any budget that defunds any part of the police budget and that's what this budget did tonight," said Albra. Council members Louise Daniele, John Forman, Carmine Istvan, Brian Wrye voted to adopt the budget.

The budget was adopted.

"The budget passes," said Albra.

The Dutchess County Historical Society's (DCHS) latest flagship exhibit, "Fertile Ground: The Hudson Valley Animal Paintings of Caroline Clowes," is on display at the Locust Grove Estate in Poughkeepsie through the end of December.

Potentially one of the foremost female artists of her day, Caroline Clowes was lost to history until a chance re-discovery several years ago.

"This is a truly historic exhibition. It is the first such assembly of the paintings of Caroline Clowes, the nationally acclaimed 19th century LaGrange artist whose reputation had been allowed to fade. Visitors will not only enjoy her paintings, but learn about the story of a woman of talent and persistence who succeeded in a male-dominated field," said Bill Jeffway, DCHS executive director.

### Budget Committee of Legislature amends, advances 2023 county budget

The Budget, Finance, and Personnel Committee meeting of the Dutchess County Legislature adopted amendments to the 2023 Executive Budget and approved by a 9-3 vote to advance the budget to the entire Legislature. A Public Hearing on the tentative budget will be held on December 5 at 7 p.m. and a vote of final adoption on December 8 at 7 p.m.

Budget amendments adopted include the following:

- \$500,000 in additional funding for the Municipal Investment Grant program in the Planning & Development Department, for \$1,000,000 total.

- \$200,000 in additional funding for the

Children's Service Cabinet in the DCFS-Youth Admin Department, for \$217,000 total.

- \$150,000 in additional funding for the Office of the Aging's community outreach, for \$246,500 total.

- \$4,000 in additional funding for the Dutchess County Behavioral & Community Health Department's Veterinary Services, for \$22,000 total.

- \$25,000 in additional funding for the Sheriff Department's SPCA program, for \$103,000 total.

- \$50,000 in additional funding for Emergency Response in the professional service program, for \$298,883 total.

## County to participate in Thanksgiving STOP-DWI enforcement campaign

Dutchess County Executive Marc Molinaro announced police agencies throughout Dutchess County will participate in a special enforcement effort to crack down on impaired driving to coincide with the national Thanksgiving holiday. The statewide STOP-DWI High Visibility Enforcement Campaign effort starts on Wednesday, Nov. 23rd and will end on Sunday, Nov. 27th.

The Dutchess County Sheriff's Office, New York State Police and municipal law enforcement agencies will collaborate across the state and will be out in force in this coordinated effort to reduce the number of alcohol-related injuries and deaths during this period.

The Thanksgiving holiday period is among the most active on U.S. roadways, with the American Automobile Association estimating some 55 million motorists traveled for the holiday in 2019,

the vast majority of whom drove to their destination. According to the National Safety Council, 29 percent of driving fatalities during the 2019 Thanksgiving holiday period involved an alcohol-impaired driver.

County Executive Molinaro said, "Thanksgiving unites loved ones from across the miles to celebrate all our blessings as Americans. While many of these joyous gatherings may include alcohol, it's incumbent on those imbibing to plan a safe ride home – both for their own safety and the safety of those with whom they share the road. There is no excuse for impaired driving, and as they do every day, the dedicated men and women of law enforcement will purge local roadways of inebriated motorists during the Thanksgiving weekend."

The Thanksgiving Engagement Campaign is one of many statewide

enforcement initiatives promoted by the New York State STOP-DWI Association with additional funding from the STOP-DWI Foundation with a grant from the Governor's Traffic Safety Committee. The Statewide STOP-DWI Crackdown Campaign also targets Super Bowl Sunday, Memorial Day weekend, 4th of July, Labor Day weekend, Halloween and national Holiday Season in December.

While STOP-DWI efforts across New York have led to significant reductions in the numbers of alcohol- and drug-related fatalities, still too many lives are being lost because of crashes caused by drunk or impaired drivers. Highly visible, highly publicized efforts like the STOP-DWI Crackdown Campaign aim to further reduce the incidence of drunk and impaired driving. Residents can make a difference with a sober plan by downloading the "Have a Plan" mobile app.

Llamaste Yoga and Lavender Loofahs and have partnered with Fearless Farmers, Inc. to offer Regenerative Farming classes for summer campers and elementary school groups. We welcome over 4,500 visitors a year to the farm who enjoy our many experiences, becoming an Agri-tourism destination for many looking to vacation in The Hudson Valley. "Farm on!"

#### **Hardeman Orchards – John Hardeman**

"I grew up on the farm I currently operate. My father managed it until he retired and then I managed it until I bought my own orchard. In the late 1990s, with Scenic Hudson's pilot program to purchase development rights to protect farmland, I was able to buy this farm. "I operated both orchards, which were about 100 acres in production, and then sold the remote orchard to reduce the debt load and focus on the home orchards. Over time as the dynamic of the apple industry changed (a slump in apple prices, government regulations, loss of local support businesses) the larger orchards got bigger and smaller ones diversified or closed.

"I scaled back the orchard to retail and

pick-your-own and started to make hay, grow some corn and lease out land to a neighbor to grow barley for the local malt/beer companies.

"I have recently started to use one of my barns as a seasonal music venue and for weddings as a way to supplement farm income.

"It has become more difficult to move a large amount of apples by retail. I rarely sell bushels, half bushels or even quarter bushels (the later being about 12 lbs.) of apples as peoples don't cook and bake as much as they used to and tend to buy a few apples at the supermarket. Also, the fruit choices at big stores has increased (years ago it was apples, citrus and bananas) due to global trade.

"I never started farming to get rich, but more as a lifestyle. I enjoy the seasonal diversity, working outside, the connection to the environment, planting and nurturing crops to production and supplying food to people."

#### **Hudson Valley Flower Farm – Shelley Wollert**

Wollert visited a U-Pick cut flower farm with friends (and sisters) Christina and Clarice Jensen in September of 2021. They were all so moved by the experience, they decided to start their own busi-

ness as a cut-flower growing collective, farming on their individual properties in Beekman, Beacon and Hillsdale and combining the fruits of their labor.

Wollert left her 10-year career as a technical project manager to spearhead the creation of Hudson Valley Flower Farm. While friends thought it was an unpredictable departure, Wollert's family has roots in farming all the way back to her grandmother in New Zealand, who was a "land girl" during WWII, growing local produce. Wollert also had a career as a children's music artist and actress, and brings her artistic sensibilities to her floral arrangements and handmade gifts.

"It's definitely been a challenge to balance investing in the farm vs. profits, especially since this was our first year and we had a lot of start-up costs. But I am optimistic that we have found an enthusiastic and appreciative market here in the Hudson Valley for local cut flowers that will continue to grow," said Wollert.

"This year was our first season at

Hudson Valley Flower Farm, so we are learning a lot about growing in a sustainable way - making sure to nourish the soil and our pollinators to maintain a balanced ecosystem. In planning for next season, we looked at which varieties of flowers did particularly well for us and we are also appealing to buyers. We are focused on growing more of what works in order to make the most of what we can produce on our parcels."

"Like so many people," said Wollert, "living through the pandemic has made me rethink just about everything. There was a reshuffling of priorities and a yearning more than ever to make beautiful things that spark human connection and happiness. Hudson Valley Flower Farm is that happy place for me."

## CCEDC provides key resources to help agricultural community

Cornell Cooperative Extension Dutchess County (CCEDC) offers the local agricultural community the resources that are needed in order to survive, which are especially important during tough economic times.

"Much of what we do is through one-on-one conversations as each operation has specific needs and challenges," said Jennifer Fimbrel, Dutchess County Agricultural Navigator.

She said the hot topics for 2022 were rising fertilizer costs, Highly Pathogenic Avian Influenza (HPAI), the lack of USDA slaughter facilities and start-up farms.

"I am asked at least twice a week about how a landowner can reduce their taxes through adding a farming venture or from new farmers looking to acquire farmland," she said. "CCEDC is part of the American Farmland Trust NY's Regional Navigator network. Through their website 'Farmland For A New Generation NY,' we are able to provide them with an entire network of farmers looking to farm. We also offer landowners information on how farm lease works here in the Hudson Valley, ventures that might work best on their soils and should they farm the land themselves or find a farmer to work the land independently."

Fimbrel said (HPAI) or bird flu has been, and continues to be an issue in NYS.

"By keeping not only commercial poultry producers informed about preventing HPAI in their flocks, but also home flocks, we only had one case in Dutchess County," she said. "HPAI is a real threat to those who depend on poultry for eggs, meat and breeding stock."

It isn't going away and we partner with our colleagues from around the state and NYS Agriculture and Markets for reporting and preventing HPAI in our domestic flocks."

Fertilizer costs were at an all-time high this past year and farmers were concerned how to best mitigate the risks of producing at higher costs or reducing yields on their products. "We discussed with individual farmers about the spring fertilizer costs, where costs might be cut and the ramifications on yields, giving them the tools they need to make decisions about their crops," said Fimbrel.

The lack of local slaughter facilities has been a constant discussion, according to Fimbrel. "We encouraged partnerships between farmers to ease travel time and keep the food system moving. Slaughterhouses are not an easy sell in many parts of the county and finding labor is even more difficult. The pieces aren't all there, but we have been working on it."

She said CCEDC's partnership with Dutchess County for the Ag Navigator program has again offered the "Farming in Dutchess" virtual series. Topics have been of interest to a variety of people, including school districts, municipal officials, farmers and landowners.

"We also work with municipal officials when they have questions about what qualifies as agriculture, building permit fees, zoning and Agriculture Valued Assessment," said Fimbrel. "Agriculture is not an easy business and we at CCEDC offer the resources to allow our famers to make the decisions that best suit their operations."

# Center of attention

**Let creativity be your guide when setting a festive holiday table**

Many of us are getting ready for the holidays and, for some, that means setting a festive table to welcome guests. Whether you plan to entertain with parties throughout the season or have family over for a traditional celebratory meal, your table is a great place to incorporate a feeling of welcome.

A common way to add a festive touch to your holiday table is with a centerpiece and candles, and flower arrangements are the perhaps the most common. And, while there's not a thing wrong with that, you may decide you want to try something different. Of course, the real star of the show should be the food you serve, which can be presented in ways to make it a centerpiece in its own right, but if you're looking for a little more, I've got some ideas.

Formal flower arrangements are lovely but can also be pricey and, at a time when our budgets might be limited, we might rather spend on the food and not flowers that won't last. You can still give your local florist business without breaking the bank and the result will be something of your own design that reflects your personality. Buy a few stems of cut flowers and greens, then add your own touches, which could be anything from fresh fruit and foraged greens to treasured trinkets you have around the house.

There's really no hard and fast rule here but there are a few things to keep in mind. Any arrangement in the center of the table should be low enough that people seated around it have an unobstructed view of everyone. Unlike the Vanderbilts and Astors, who were known to entertain with lavish and lofty arrangements, arbors and even vine-decked bird cages on their tables, we're trying to keep things more reasonable and

practical. And, let's face it, as impressive as towering candelabra with rose garlands or a fully decorated Christmas tree as centerpieces would be, we might actually want to see and talk to those around us.

Also, if using candles, be mindful of their placement, especially if you're using candles you'll actually light. (Flameless, battery-operated types don't pose as imminent a threat). Keep flames away from any dried flowers or anything that can get hot to the touch. You also want to be sure they're placed so no one has to reach over them for obvious reasons (yes, I've done it and singed myself passing the gravy!).

Another thing to consider when arranging – and this may seem obvious but in the throes of creativity it's easy to forget – is that food will actually need a place on the table, too. Be sure to leave comfortable space for serving dishes, plates and glasses. I say 'comfortable' because you'll want to be sure no one will feel crowded by your design or run the risk of knocking something over if they move or go to replace a serving dish.

I recently designed three centerpiece arrangements for Thanksgiving, with one easily adaptable for winter holidays, to illustrate how to put something together in very little time with little cost and still create warmth and welcome. I used a few purchased flowers and plants, but mostly used props I already had and went outside to forage in my yard and garden. You'd be surprised what you can find out there to use!

#### BOUNTIFUL

An arrangement in rich, fall colors that conveys the bountiful harvest we're all grateful for.

**FROM THE STORE:** apples, pears (golden Bosc and petite Seckel), grapes,

mixed nuts, cranberries, acorn squash and persimmon

**FROM YARD AND GARDEN:** rhododendron leaves, dried hydrangeas, Japanese red maple leaves, azalea twigs (a delightful discovery with its tiny leaves in green and tinged red)

I displayed them in mismatched tarnished silver pieces of varying heights, presenting all those gorgeous fall colors in a rusticly elegant way that shows them off as the jewels they are.

#### SIMPLE SAGE AND ORANGE

Sometimes I like to limit the color palette. One of my favorites is the combination of terra cotta orange, sage green and ivory.

**FROM THE STORE:** small lavender tree, eucalyptus branches, sugar (pie) pumpkins, gourds

**FROM YARD AND GARDEN:** rosemary sprigs, sage sprigs

For this simple study of natural textures and colors that complement I placed the lavender plant in a wooden berry basket and tucked brown paper excelsior in around the dirt and to hide the pot. Everything is set directly on the table, arranged to maximize their different colors, heights and textures.

#### FORAGED GREENS

I like the formal simplicity of this one, which I think is at once classic and inviting. Although technically a Thanksgiving centerpiece, it can easily transition to the winter holidays with a quick swap of the amber votives for red, a more Christmas-y linen tucked around the ferns and the addition of pine cones or holly.

**FROM THE STORE:** 2 potted Frosty Ferns (they look more like silvery-

tipped tiny evergreens than ferns), eucalyptus branches

**FROM YARD AND GARDEN:** white pine, rosemary sprigs, rose hips

Clean and classic. The focal point is a small wooden box with two fern plants nestled inside, a fall plaid linen napkin tucking them in. I placed vintage saucers to either side, a pillar candle centered on each, laid a "wreath" of fresh rosemary around the pillars and encircled each saucer with sprigs of fresh evergreen, eucalyptus with its sage green "berries" and red rose hips. For a warm glow, votives with tea lights did the trick.

Of course, if your table size is limited or if you just want to forego a non-edible centerpiece, you can always dress up that turkey platter and call it a delicious day! Some fruit and fresh herbs placed around that grand bird makes it shine before your guests even taste it – it won't take much to make it even more impressive than it already is!

One last thing I forgot to mention: please don't think you have to entertain to decorate your table! Do it for yourself! It's a time to celebrate the season and when we create a festive atmosphere inside our homes it can make the holidays that much more heartfelt and special. When we surround ourselves with beauty, bounty and love, well, that's no small thing. It's worth celebrating and cause to be thankful indeed. Happy Thanksgiving!

# A Tale of Two Senators

## High hopes for Dutchess County's newly elected State Senators

Dutchess County will be represented in Albany by two new state senators on January 1, 2023.

Our District 41, which included almost all of Dutchess County except Pawling and Poughquag, has been restructured into districts 39, which includes Poughkeepsie and points south, and 41, with Millbrook and points north.

Farmers in Dutchess County have been working with our current state Senator Sue Serino to protect agricultural interests statewide. I contacted both of our new senators to get a feel for how they might help New York farmers to stay competitive in the world marketplace, and how they can provide New York residents with fresh local food:

Rob Rolison, District 39 – I sat down with Senator-elect Rolison in his Poughkeepsie office. He has a long career in public service, from his days as a volunteer firefighter right after earning a criminal justice degree from Marist College, to his 26 years with the Town of Poughkeepsie police department (14 years as a detective), 12 years in the Dutchess County Legislature, including the chairmanship, and most recently as Mayor of the City of Poughkeepsie.

Rolison admits that his experience with agricultural issues is limited, but says he's "excited about knowing more about agriculture." As mayor, he "knows how important local food is," from working with food banks to helping with the Poughkeepsie Farmers Market at the Children's Museum.

Rolison is a Republican, and we all know how hard, if not impossible, it is for a Republican to get anything done in the Democrat-controlled legislature. Fortunately, the mayor and former chairman

of the Dutchess County Legislature has a long history of working with a diverse group of colleagues, from "both sides of the aisle." He hopes to forge relationships with his candidate attitude.

I asked our senator-elect what committees he's likely to join in Albany. Drawing from his strengths, he mentioned the Local Government, Education, and Crime and Corrections Committees, but after some pleading, promised "the Agriculture Committee could be one of them."

Michelle Hinchey, District 41 – I could not get an interview with Senator Hinchey on such short notice. She is currently representing District 46, and is the chair of the State Senate Agriculture Committee.

Hopefully she will continue in that role, so she can interact with our northern Dutchess County farmers.

Like her father before her, the late Congressman Maurice Hinchey, Senator Hinchey is a champion of the environment and working people. But it's no secret that some of the recently passed New York laws make it hard for our farmers to compete on the world stage – for example, the minimum wage and overtime laws, mandating overtime pay for farm workers after 40 hours per week.

In an interview with Hudson Valley One, Hinchey admits that "our farmers are struggling." So to keep them in business, she is offering tax credits and sponsored a bill, which passed the Senate, establishing procurement goals for New York State food products purchased by state agencies. She also sponsored (along with Didi Barrett in the Assembly) the Soil Health and Climate Resiliency Act, inspired by her alma mater, Cornell University. This will incentivize farmers to protect soil and sequester carbon.

Dutchess County farmers are looking forward to working with our new state senators to keep our farms growing and thriving.



## CIABATTA BREAD

Make the biga, also called sponge today, and tomorrow you can bake two loaves of this wonderful, somewhat tart, rustic Italian bread with a hearty crust.

For the Biga (sponge)

- 1/8 teaspoon active dry yeast
- 2 tablespoons warm water (110 degrees F/45 degrees C)
- 1/3 cup warm water
- 1 cup bread flour

For Bread:

- 1/2 teaspoon active dry yeast
- 2 tablespoons warm milk (110 degrees F/45 degrees C)
- 2/3 cup warm water
- 1 tablespoon olive oil
- 2 cups bread flour
- 1 1/2 teaspoons salt

1. To Make Sponge: In a small bowl stir together 1/8 teaspoon of the yeast and

the warm water and let stand 5 minutes, or until creamy. In a bowl stir together yeast mixture, 1/3 cup of the water, and 1cup of the bread flour. Stir 4 minutes, then cover bowl with plastic wrap. Let sponge stand at cool room temperature for at least 12 hours and up to 1 day.

2. To Make Bread: In a small bowl stir together yeast and milk and let stand 5 minutes, or until creamy. In bowl of a standing electric mixer fitted with dough hook blend together milk mixture, sponge, water, oil, and flour at low speed until flour is just moistened; add salt and mix until smooth and elastic, about 8 minutes. Scrape dough into an oiled bowl and cover with plastic wrap.

3. Let dough rise at room temperature until doubled in bulk, about 1 1/2 hours. (Dough will be sticky and full of air bubbles.) Turn dough out onto a well-floured work surface and cut in half. Transfer each half to a parchment sheet and form into an irregular oval about 9 inches long. Dimple loaves with floured fingers and dust tops with flour. Cover loaves with a dampened kitchen towel. Let loaves rise at room temperature until

almost doubled in bulk, 1 1/2 to 2 hours.

4. At least 45 minutes before baking ciabatta, put a baking stone on oven rack in lowest position in oven and preheat oven to 425 F (220 degrees C).

5. Transfer 1 loaf on its parchment to a rimless baking sheet with a long side of loaf parallel to far edge of baking sheet. Line up far edge of baking sheet with far edge of stone or tiles, and tilt baking sheet to slide loaf with parchment onto back half of stone or tiles. Transfer remaining loaf to front half of stone in a similar manner. Bake ciabatta loaves 20 minutes, or until pale golden. Cool loaves on a wire rack.






